Malaysia rejects forced resettlement of Palestinians

PUTRAJAYA: Malaysia has strongly rejected plans that could lead to the forced displacement of Palestinians, calling it a violation of international law and multiple United Nations (UN) resolutions, the Foreign Ministry said in a statement yesterday.

statement yesterday.

It said any unilateral attempt, direct or indirect, to undermine Palestinian self-determination is unacceptable and would only prolong the conflict.

"Malaysia continues to stand in solidarity

"Malaysia continues to stand in solidarity with the people of Palestine. The only viable path to lasting peace and stability in the Middle East is through the establishment of an independent and sovereign State of Palestine, based on pre-1967 borders, with East Jerusalem as its capital," it said.

Meanwhile, Foreign Minister Datuk Seri Mohamad Hasan said the announcement to expel the Palestinian people is regrettable

expel the Palestinian people is regrettable.

"The Palestinian people themselves have stated that they will not leave their homeland. Malaysia's support for Palestine is not temporary. We have long supported their struggle for an independent state, and so (this proposal) directly contradicts our longstanding position," he said in the Dewan Rakyat yesterday.

The ministry said Malaysia supports the resolution of the Extraordinary Arab-Islamic Summit on Nov 11, 2024 urging all nations that have yet to back the two-state solution for the State of Palestine and its full membership in the UN to do so.

Malaysia has also reaffirmed its commitment to diplomatic and multilateral efforts, including initiatives by the Global Alliance and The Hague Group, in pursuing a lasting peace based on establishing an independent and sovereign Palestinian state.

On Wednesday, international media reported that United States (US) President Donald Trump had suggested that Washington should "take over" Gaza and redevelop it, a proposal widely condemned as violating international law and disregarding Palestinian rights.

"The universal tariff policy and trade restrictions imposed on China, Mexico and Canada not only disrupt global supply chain stability but also directly impact Asean nations.

"Malaysia, as an export-dependent economy, cannot remain a mere observer. We must push Asean to act as a more integrated bloc to safeguard regional economic stability and avoid becoming victims of a trade war that

Doris Sophia added that the region must continue to uphold free trade and reject protectionist policies

protectionist policies.

She said Malaysia must not be overly reliant on the US and should strengthen ties with other global players such as the European Union (EU), China and BRICS nations to ensure economic stability.

Tanjong Karang MP Datuk Dr Zulkafperi Hanapi suggested that Malaysia explore new opportunities, particularly in manufacturing and technology, in light of global policy shifts.

technology, in light of global policy shifts.

"Overall, Trump's policies towards China, the EU and other nations should be viewed from a dual perspective.

"While there are challenges, there are also

new opportunities. Therefore, we must capitalise on these global policy changes"

on these global policy changes."

He said while the country should formulate plans to counter the negative impacts of Trump's policies, Malaysia must also continue attracting foreign investments and expanding its export potential, Bernama reported.

Datuk Seri Saifuddin Abdullah (PN-Indera Mahkota) said Perikatan Nasional is calling for a special Dewan Rakyat session under Standing Order 18(1) to discuss the Palestine issue, following Trump's announcement regarding the Gaza Strip.

He described Trump's move, along with his proposal to relocate Palestinians outside their territory, as a declaration of war against Muslims and all advacates of humanity.

KUALA LUMPUR: Various programmes have been planned for all segments of society, including rural communities, persons with disabilities, senior citizens and children, during Malaysia's Asean chairmanship this year, said the Foreign Ministry.

Among the planned initiatives are a campaign to promote locally made products and the Asean Plus Three Forum aimed at empowering rural women, it said in a written reply uploaded on the Parliament website.

It said the Asean Youth Summit, a special edition of the Malaysia International Halal Showcase and programmes for school students and higher education institutions are also set to take place.

"Malaysia's chairmanship will also focus on cooperation in addressing issues such as poverty, public health and social well-being, which will directly benefit not only urban populations but also rural communities and underprivileged groups. "Emphasis will be placed on leveraging

"Emphasis will be placed on leveraging advancements in science, technology and innovation as well as digital transformation and new technologies."

The ministry was responding to a question from Tan Sri Abdul Hadi Awang (PN-Marang) on how Malaysia's Asean chairmanship would benefit grassroots communities and indirectly aid the country's economic recovery.

The ministry said digital infrastructure development programmes would create opportunities, particularly for rural populations, to access better technological facilities and engage in remote learning.

New rules still under review for Muslims at events of other faiths

KUALA LUMPUR: Proposed guidelines for Muslims attending events at non-Muslim houses of worship are still under discussion by the authorities, said Minister in the Prime Minister's Department (Religious Affairs) Datuk Dr Mohd Na'im Mokhtar.

He said engagement sessions on the matter involved state Islamic religious councils, and the proposed guidelines would be comprehensively discussed during the 126th Meeting of the National Council for Islamic Religious Affairs Muzakarah Committee.

He added that the committee's decision

would be presented at the National Council for Islamic Religious Affairs meeting chaired by the Sultan of Perak, Sultan Nazrin.

Mohd Na'im urged all parties to refrain from creating misunderstandings or polemics concerning the guidelines, which could result in public unrest, as their purpose is to ensure that religious activities are conducted in an orderly manner and contribute to national harmony.

In a written reply uploaded on the Parliament website, Mohd Na'im said the government would introduce new guidelines for Muslims attending events at non-Muslim

houses of worship.

The guidelines include a requirement to obtain permission from religious authorities if the event involves Muslims, as well as ensuring that the event does not contain elements that could offend the sensitivities of Muslims.

Mohd Na'im said the guidelines were developed to promote harmonious social and cultural relations among Malaysia's diverse religious communities.

He said the guidelines would allow Muslims to attend celebrations or ceremonies of other

religions in a respectful manner, observe proper decorum and uphold the principles of Islamic faith.

Mohd Na'im added that once finalised, the guidelines would support government efforts to foster unity and mutual respect among the people, without raising concerns or misunderstandings from an Islamic perspective.

"İt will ensure that the participation of Muslims in these activities will not spark controversy or touch on the sensitivities of different religious groups." – Bernama

One-session school system nationwide within five years

KLUANG: The Education Ministry aims to complete the nationwide implementation of the one-session school system within five year according to minister Fadhlina Sidek.

She noted that, to date, more than 9,000 out of over 10,000 schools nationwide have adopted the one-session system, with the remaining schools yet to do so due to high student

"The development of education in this country is progressing very well and there are more than 9,000 schools that have already achieved the one-session school system," she said

Speaking at the Intan Minister's inversation: Education Instils Conversation: Education Instils Leadership, Shaping the Future Generation held at the National Institute Public Administration (Intan) thern Region yesterday, she highlighted the challenges affecting the system's full implementation.

Also present were Education Director-General Azman Adnan and Deputy Director-General of Public Services (Development) Datuk Anesee

Fadhlina said factors influencing the transition include the construction of new schools and the repair of dilapidated ones.

"The ministry also needs to consider several constraints, such as the location, premises and management of the schools themselves," she added. Bernama

RON97, RON95 and diesel prices unchanged

KUALA LUMPUR: The retail prices of RON97 and RON95 petrol across the country will remain unchanged at RM3.43 and RM2.05 per litre respectively from yesterday until 12 Feb.

The Finance Ministry, in a statement, announced that the retail price of diesel in the peninsula will remain at RM3.18 per litre, while in Sabah, Sarawak and Labuan, it will also be unchanged at RM2.15 per litre during the same

According to the ministry, the prices were set based on the weekly retail pricing of petroleum products using the Automatic Pricing Mechanism formula.

"The government will continue to monitor global crude oil price trends and take appropriate measures to ensure the continued welfare and well-being of the people," it stated. - Bernama

Transit homes for teen mothers not a long-term solution

PETALING IAYA: Of the 44,263 cases of teenage pregnancies recorded in Malaysia over the past five years 17,646 involved unmarried girls.

However, while having a transit home for them is a positive move, it is not a permanent solution, said Universiti Teknologi Mara Social and Policy Studies lecturer Prof Dr Yarina Ahmad. She was commenting on Dawn

Hope, the country's first transit home in Kuching, Sarawak, which offers protection, healthcare, mental health services, counselling and

parenting guidance for young girls.

"It is praiseworthy to have such a home, but it should not be a permanent solution. Efforts should instead focus on comprehensive sex education, parental guidance and community awareness.

"Providing such services at the home serves as a crucial support system, but real change requires a broader societal shift in education and awareness. If the number of cases continues to rise, will we keep building more transit homes? That

would indicate deeper social problems," she said.

Yarina stressed that ensuring the home is a safe and non-judgmental space for teenagers requires strict privacy protection and proper

She added that clear regulations She added that clear regulations must uphold residents' confidentiality and staff must receive specialised training to handle sensitive situations with care, focusing on supporting them.

"Societal stigma remains a major challenge, making teenage pregnancy a taboo subject. The strong culture of blame and shame often isolates pregnant girls, making it harder for them to seek help.
"To address this, education is key

not to normalise teenage pregnancy but to encourage understanding. If society refuses to help, where else can these girls go?" She also pointed out that schools

play a key role in early intervention by identifying cases and preventing escalation.

Students facing issues related to inappropriate sexual activity should safe reporting them to teachers to ensure proper guidance.

"In 2010, a politician suggested that teenage pregnancies could be resolved through marriage, but this is not a viable solution. Forcing individuals unprepared marriage could lead problems, which comprehensive sex education should be introduced early as a preventive measure."

Yarina noted that a transit home

can benefit parents who are unable to care for their pregnant children.

For teenagers, being surrounded by others in similar situations can provide emotional support and reduce feelings of icologies. reduce feelings of isolation.

Sarawak Women for Women

Society president Dr Angie Garet described the transit home as a support initiative that pregnant teens r comprehensive assistance comprehensive assistance, including counselling, parenting education and coping strategies to manage stress, mental health challenges and relationships.

"The home is set to begin

operations next month, and pregnant teens seeking refuge there will undergo an interview and screening by Pertubuhan Pergerakan Insan Sarawak, which

will manage the facility.

"It is specifically for those who have no one to care for them, and provides a safe space free of charge until they give birth, helping them transition into life after leaving the home," she said.

Garet emphasised that confidentiality is a priority to ensure the transit home remains a safe and non-judgmental space for pregnant

She highlighted that the long-term goal of the initiative is to support young mothers while also reducing cases of abandoned babies and baby dumping by providing a safe space for those in need.

Putrajaya, three states eradicate hardcore poverty **KUALA LUMPUR:** The *Madani* government's efforts to eliminate

hardcore poverty have made significant strides, with three states and one federal territory successfully recording zero cases last year.

According to the Economy Ministry, data from the National Poverty Data Bank up to Dec 31 shows that the Federal Territory of Putrajaya, Negeri Sembilan, Malacca and Perlis have achieved zero hardcore poverty, with 1.793 households nationwide still classified as hardcore poor.

"Currently, the Federal Territory of

Kuala Lumpur has the highest number of hardcore poor households, with 507, followed by Kedah with 314, Johor with 298, Selangor with 168 and Terengganu with 124," the ministry said in a written reply on the Parliament portal. – Bernama

MYCC probes 13 bid-rigging cartel cases involving RM2.3b

KUALA LUMPUR: The Malaysian Competition Commission (MyCC) is actively investigating 13 cases of alleged bid-rigging cartels involving 561 enterprises, with a total value of up to RM2.3 billion, the Dewan Rakyat was told yesterday.

Domestic Trade and Cost of Living Minister Datuk Armizan Mohd Ali disclosed that since the beginning of 2024, MyCC has been implementing a targeted strategy to strengthen enforcement against bid-rigging cartels, a long-standing form of cartel

He stressed efforts to curb such oractices were crucial to ensure they did not undermine the government's commitment to transparent procurement governance, in line with the Madani administration's goal of strengthening public service delivery.

"The actions taken against companies engaging in anti-competitive practices reflect the government's commitment to creating a healthy competitive ecosystem in the market.
"This will contribute to economic

This will contribute to economic growth, improve quality, provide

consumers with more choices and ensure reasonable pricing of goods and services," he said during a question-and-answer session at the Dewan Rakyat.

Armizan was responding to a question from William Leong Jee Keen (PH-Selayang) on the effectiveness of MyCC in enforcing the Competition Act 2010 (Act 712) and the number of investigations that have led to prosecutions convictions between 2014 and 2024.

Among the sectors implicated in bid-rigging are services, utilities,

construction, food and beverage, and information technology.

Armizan highlighted that since Act

712 came into effect, MyCC, as an independent and quasi-judicial body, has conducted investigations into 339 enterprises across various industries, including transport, manufacturing, food, services, education, insurance, agriculture and public procurement.

Findings from these investigations led MyCC to issue findings of violations under Section 40 of the Act, covering 14 cases involving 259

"A total of 257 enterprises were found to be involved in cartel activities, while two enterprises were found to have abused their monopoly position. These decisions have resulted in financial penalties amounting to RM571.5 million."

In response to a supplementary question from Leong on the steps taken to strengthen the Act, Armizan confirmed that the ministry is in the process of amending the legislation, particularly to streamline enforcement procedures and introduce a merger . control regime. – Bernama



Keeping interest in traditional Indian art forms alive

▶ Enthusiasts aim to make Silambam and Bharatanatyam more accessible to community as well as create awareness of cultural significance

PETALING JAYA: As of July 2024, ethnic Indians made up 6.5%, or 2.2 million, of Malaysia's multiracial and multicultural population, but traditional Indian practices have generally

However, two organisations have dedicated themselves to helping the community regain interest in their traditional art forms -

Silambam and Bharatanatyam.

Malaysia Silambam Association president Dr Suraess Muthusamy said interest in Silambam grew after its official inclusion in the Malaysian Games in 2020 but more needs to be

"Silambam is not just a martial art. It carries deep historical, spiritual, and cultural significance. By practising it, younger generations stay connected to their roots and

generations stay connected to their roots and keep traditions alive.

"Beyond self-defence, *Silambam* integrates Tamil philosophy, discipline, and physical fitness. We are making *Silambam* more accessible through school programmes, workshops, and competitions," he said.

Public interactions through storytelling, historical references, and lessons on ancient

historical references, and lessons on ancient warriors help students gain a appreciation for *Silambam*. deeper

Although the martial art has deep Indian roots, the association promotes it as an inclusive art form that anyone can learn, regardless of ethnicity.

"To combat the belief that traditional arts are outdated, we modernised training by incorporating fitness, sports elements, and self-defence techniques.

For 15-year-old Lenasshree Kamalakannan, her *Silambam* journey began at age six when her mother introduced her to it.

Lenasshree has spent over nine years training and transforming from a beginner to a gold medallist at the Asian Open Silambam Championship 2024 held in Doha, Qatar.

"Martial arts do not just shape the body but also the mind. The patience, focus, and

resilience I've learnt through Silambam have helped me in all areas of my life," she said, adding that she believes the martial art is a reflection of Indian culture, a heritage that must be preserved and passed on.

Lenasshree actively contributes by training her younger sisters, ensuring that they too

become part of this legacy.

"If we start young, we can build not just great fighters, but great individuals who carry our culture forward with pride," she said.

Mahavidya Dance Theatre founder and acclaimed dancer Sheela Raghavan has dedicated her life to teaching *Bharatanatyam* and preserving Indian culture through the classical dance form.

Over the years, she has seen fluctuations in student enrolment, especially due to challenges like the Covid-19 pandemic. However, while interest in this classical dance remains strong, Sheela noted that transport issues and financial constraints often impact student attendance.

"We offer free lessons as a non-profit organisation, but financial struggles can be a hurdle. One student, who was learning the dance for six years, faced difficulties due to a parent's illness. However, she kept practising on her own and we provided online classes to support her.

"Despite the dedication of our many students, awareness of *Bharatanatyam*'s cultural significance still needs to be strengthened, and one major barrier is their Tamil proficiency, which causes them to struggle to understand the deeper meanings within the dance."

Sheela believes *Bharatanatyam* plays a vital role in preserving Indian culture, especially in Malaysia, where the community is shrinking in

Beyond the performance, she said *Bharatanatyam* helps individuals develop a stronger sense of self-identity and well-being, which is crucial in today's fast-paced world.

"By staying connected to our roots and growing with time, we can keep our ancestors' spirit alive and inspire future generations. Just spint and and inspire turbe generators, just as importantly, I have always believed dance can unify the people and build their self-confidence and pride."

The Mahavidya Dance Theatre is unique in

Malaysia as Sheela teaches the Vazhuvoor style which is one of the four original styles of Bharatanatyam.

Her senior students are being trained to teach as they have vast experience, having performed in Singapore, Indonesia, Thailand and other countries.

'98 Sabah education projects approved for 13th M'sia Plan

KOTA KINABALU: Ninety-eight out of 108 projects submitted by the Sabah State Education Department to the Education Ministry have successfully passed the screening process for the 13th Malaysia Plan

Sabah department director Datuk Raisin Saidin said applications for the projects, including those for the replacement of dilapidated schools, were presented to the ministry in December last year.

"These approved projects will be presented to the Economy Ministry in May for budget approval, which will be announced during the tabling of the National Budget in October," he said while delivering the department New Year address at the Sekolah Jenis Kebangsaan (C) Chung Hwa hall on Wednesday. Raisin said under the 12th Malaysia Plan,

a total of 273 project applications were submitted, covering the construction of replacement schools, new schools, district education office buildings, building extensions, and land acquisition.

extensions, and land acquisition.

He said 214 of these projects, with values ranging from RM10 million to RM300 million, have been approved by the Economy Ministry.

However, to ensure the smooth progression of these projects, several challenges must be addressed promptly, particularly issues related to the status of school land sites and building safety. school land sites and building safety certification.

"To enhance long-term efforts in addressing the issue of dilapidated schools in Sabah, strong collaboration with relevant stakeholders is crucial," he added.

Simpang Ampat folk to face water cut

GEORGE TOWN: Some 4,000 Penang Water Supply Corporation consumers in the Simpang Ampat area on the mainland will experience a scheduled water supply disruption from today until tomorrow.

The corporation said in a statement that

the disruption is due to final pipe connection works involving a 300mm MS X 300mm MS pipe in Jalan Merak 5, Taman Merak, South Seberang Perai.

According to a statement on its official Facebook page, the water supply disruption will begin at 10pm today and is expected to last until 6am tomorrow, affecting 3,950 user accounts in Taman Idaman, Taman Tambun Jaya, Taman Merak, and Taman Merak Jaya.
The corporation advises affected users to

store sufficient water for use throughout the disruption period. – Bernama

Review electricity tariff hike implementation, govt urged

KUALA LUMPUR: Industry players and consumer associations have called on the government to carry out a comprehensive and thorough study on the method of implementing the electricity tariff hike and its potential impact on the public.

Those contacted by Bernama have voiced concerns that the electricity tariff hike might lead to higher prices of goods and services, affecting consumers.

Malaysian Budget and Business Hotel Association president Dr Sri Ganesh Michiel said hotel operators would have no option but to raise room prices to offset the higher operating costs resulting from an increase in the electricity

He said it would have an indirect effect on the B40 group, who mostly stayed in budget hotels when travelling for work or holidays

"Budget hotels mainly cater to the B40 group.
"When operating costs rise, room prices will

have to go up to cover those costs.

"It's the people who will be affected. If the

hotel doesn't increase prices, it will eventually close down due to losses," he said. Ganesh hoped that the government would help small and medium enterprises, such as budget hotels, by introducing a special incentive mechanism or special tariffs to lessen the impact of the tariff hike.

He also urged Tenaga Nasional Berhad to be

fair to budget hotel operators by imposing a commercial tax on short-term residential accommodation (STRA) service providers in the

"It's unfair that STRA uses house tariffs, enabling them to sell rooms at lower prices.

"On the other hand, licensed hotels that pay taxes have much higher operating costs.

"As a result, the only option is to raise prices to cover those costs," he said. Meanwhile, the Federation of Malaysian

Consumers Associations (Fomca) urged the government to plan and review any tariff adjustments or subsidy reforms more carefully to avoid sudden market shocks

Fomca chief executive officer Dr Saravanan

Thambirajah said the shift from blanket to targeted subsidies must be carried out in a clear. transparent and phased manner to avoid negative impacts, including higher inflation and increased costs for consumers.
"We call on the government to involve all

stakeholders, including consumer associations and industry players, to ensure that decisions on electricity tariffs are in line with the current economic situation and do not overly burden businesses and consumers.

"For long-term measures, we encourage consumers to switch to green energy, such as using solar panels, and to adopt energy conservation and efficiency practices," Saravanan said.

No-camping regulation sparks public debate

▶ While authorities cite environmental preservation issue, ban could result in tourists seeking alternative locations, affecting local economy: Academic

PETALING IAYA: The recent enforcement of a no-camping policy on Port Dickson beaches has ignited public debate about its implications on tourism and the local

While the Port Dickson Municipal Council emphasised environmental preservation, citing issues such as littering, improper waste disposal and habitat destruction caused by unregulated camping, tourism experts argued that the ban could deter tourists and harm local businesses.

Universiti Teknologi Mara tourism economics expert Prof Dr Mohd Hafiz Hanafiah said the outright prohibition prioritises environmental preservation at the

expense of tourism flexibility.

"Such strict bans may not strike the best Such strict bans may not strike the best balance. Other destinations have adopted regulated camping to allow for environmental preservation while still accommodating tourists," he said.

Hafiz warned that the policy could hurt Port Dickson's reputation as a family and budget-friendly beach destination.

"If the rule remains rigid, tourists may seek alternative locations with more relaxed

regulations.
"Malaysia risks losing its competitiveness

as a coastal tourism destination compared with neighbours like Thailand and Indonesia. Over time, this could shift economic benefits elsewhere.

Hafiz said local businesses, including food vendors, tent rental operators and accommodation providers are already feeling the pinch. The expected lower foot traffic from budget travellers due to the decision can impact sales and occupancy rates, causing

financial losses for local entrepreneurs.

He said backlash on social media, with some calling for a boycott of Port Dickson, further threatens its tourism appeal.

'Viral campaigns in today's digital era can

viral campaigns in today's digital era can significantly impact visitor numbers. This sentiment could push potential tourists to other destinations."

Hafiz suggested the authorities consider alternatives, such as designated camping zones with proper waste management and permit systems to balance tourism and sustainability.
YouTube channel FWFamily Camping

content creator Norshazwani Nasaruddin said the no-camping enforcement could discourage first-timers from experiencing outdoor activities.

"Without accessible and welcoming options such as beach camping, many might miss the chance to explore Malaysia's beautiful natural landscapes."

Norshazwani said there is a surge of interest in camping among Malaysians, which is fuelled by several factors, including social media.
"Platforms such as YouTube and

Instagram inspire more people to explore outdoor activities. Camping is also an affordable alternative to conventional vacations, especially for families on a budget."

She said the rise in affordable camping gear has made it easier for Malaysians to enjoy outdoor adventures without high costs, and that such affordability is the reason more families are now turning to camping as an alternative to expensive vacations. Norshazwani said camping allows families

to bond while connecting with nature, making it a popular choice.

As an active member of the Naturehike Outdoor Camping Malaysia community, she has witnessed the enthusiasm for camping

"It's one of the biggest camping communities in the country. We organise camp meets and share experiences, making camping a collective and supportive activity."

She also said the camping community

provides a sense of belonging. Being part of such a group allows enthusiasts to share knowledge, learn from one another, and make the experience more enriching.

However, she said with the ban at Port

Dickson, the camping community might also feel sidelined, especially since responsible campers often advocate sustainability, so engaging with such groups could help the authorities craft more balanced policies. She advised beginners to choose friendly

campsites with basic facilities and follow the "Leave No Trace" principle.

Johor cops bust 25 large-scale drug rings

JOHOR BAHRU: Johor police busted 25 large-scale drug trafficking syndicates with the arrest of 99 members and the seizure of various assets worth RM17.23 million last

State police chief Datuk M. Kumar said among the biggest successes of the Johor police contingent Narcotics Crime Investigation Department was the seizure of

drugs worth RM12.62 million.
The seizure was achieved through Ops Jaring 12 by busting an international drug trafficking syndicate involving the arrest of 14 foreigners on May 29.

He said the department had also conducted 21,093 raids involving the inspection of 46,878 individuals.

"A total of 25.065 individuals have been arrested for various drug-related offences, which is the third highest achievement in the country, with the seizure of 7.3 tonnes of drugs worth RM99.76 million.

The amount of the drugs seized can be used for 3,653,081 doses, he added.

"We are always committed and aggressive in carrying out continuous operations to

in carrying out continuous operations to eradicate drug smuggling and trafficking syndicates, especially in Johor."

Kumar said police are focusing on hotspots, including at Felda areas, private farms, fishermen jetties, people's housing projects, low-cost houses, bus and taxi terminals as well as addict haunts to curb drug abuse activities, through Ops Bleaching

and Ops Tapis conducted in each district.

"Following that, we succeeded in crippling a local drug trafficking syndicate through Ops Neting, with the largest seizure worth RM28.58 million and the arrest of seven syndicate members on Oct 15. "In addition, 739 individuals were arrested

for cases of repeat offences under Section 39C of the Dangerous Drugs Act 1952, while 139 individuals were arrested under the Special Preventive Measures provision of the Dangerous Drugs Act 1985," he said. The public can continue to channel information about illegal activities like drug

Ground crew staff killed in helicopter fire

KUALA LUMPUR: A ground crew staff was killed when a Bell 206 L4 helicopter caught fire while landing to refuel in Bentong, Pahang, yesterday

morning.
State Fire and Rescue Department public relations officer Zulfadli Zakaria confirmed the incident, adding that the helicopter pilot survived the fire.

The incident occurred near a hot spring pool along the old Kuala Lumpur-Bentong road.

The victim's body has been taken to Bentong Hospital for further procedures.

In a statement yesterday, the Pahang Fire and Rescue Department Operations Centre reported that upon receiving an emergency call, five personnel and an officer from the Bentong Fire and Rescue station were despatched, along with a Fire Rescue Tender vehicle, arriving at the scene at 10.52am.

"Witnesses said the helicopter lost control and overturned during the landing process. The ground crew member, an Indonesian engineer, was fatally injured by the helicopter rotor

blades," the statement read.

The pilot, also an Indonesian national, escaped unharmed.

Meanwhile, the Civil Aviation Authority of Malaysia confirmed that the ill-fated helicopter, Malaysia confirmed that the ill-fated helicopter, leased and operated by MHS Aviation Berhad, was conducting a work flight. "Further investigations will be carried out by the Air Accident Investigation Bureau under the

Transport Ministry, in accordance with Part XXVI of the Civil Aviation Regulations 2016," the statement added. - Bernama

Pensioner loses RM220,000 in scam

KUANTAN: A pensioner lost RM229,600 to a fraud syndicate scheme in which the perpetrators impersonated representatives of the Health Ministry and a police officer. State police chief Datuk Seri Yahaya Othman

said the 58-year-old man received a call from an individual claiming to be a representative from

The caller informed the victim that he had taken an extra supply of medication in November last year.

The individual then transferred the victim to

an "Inspector Hakim", who told the victim that he was involved in two criminal activities.

The victim was subsequently instructed to transfer all his savings to one account for audit and investigation purposes, and further ordered to leave his ATM card in a small box on a garbage bin opposite a convenience store in Pekan, claiming it was for the police to collect.

The victim only realised he had been duped the following day when he visited the bank and found 85 unauthorised transactions.

S'pore readies to counter manipulation during polls

SINGAPORE: The city-state will use its Foreign Interference (Countermeasures) Act 2021 (Fica) to address manipulation of social media algorithms by foreign actors to affect the country's political

Minister of State for Home Affairs Sun Xueling told Parliament on Wednesday that provisions under the Act may be used to act against algorithmically driven online foreign interference, particularly hostile information campaigns driven by foreign actors to influence elections.

"If algorithms are deliberately manipulated by foreign persons or entities, including social media companies, to affect our domestic politics, that would constitute foreign interference.

"The government will engage with social media companies ahead of the general election to remind them of the general election to remind them of the need to comply with applicable laws, especially those concerning foreign interference," she said in response to questions from Jurong GRC Member of Parliament Dr Tan Wu Meng. According to the Home Affairs Ministry website, under Fica, directions can be issued to an internet intermediary, such as a social media service to take

such as a social media service, to take down their content, or suspend or disable the account, such that the content is not viewable by end-users in Singapore, Non-compliance with such

directions is an offence.
Sun said the Protection from Online Falsehoods and Manipulation Act 2019 (Pofma) could be used to address falsehoods on online platforms during the election period.

Under the Act, the government may

issue directions requiring the publication of correct facts.

Under the law, the returning officer can direct social media platforms to disable access to or remove any online election advertising that violates these

China rolls out red carpet for Thai prime minister

Thai Prime Minister Paetongtarn Shinawatra in Beijing yesterday, as the two countries eye closer ties amid growing global uncertainties.

Paetongtarn is on an official visit to China, marking her first visit to

Beijing since taking office in August. The four-day visit coincides with the 50th anniversary of China-Thailand diplomatic relations, which are overshadowed by issues such as online fraud and safety concerns.

The recent high-profile case of Chinese actor Wang Xing, who went to Thailand for what he thought was an acting job but was abducted and later rescued from a scam centre in Myanmar, has sparked heated discussion in China about crossborder telecom scams.

Thailand, concerned about the impact on its vital tourism sector. has sought to allay safety concerns among Chinese, who constitute the largest group of visitors to the

On Tuesday, the Thai government said it would cut electricity supply to some border areas with Myanmar to curb illegal scam centres.

Southeast Asia, especially border towns in Thailand, Myanmar and Laos, has become a hub for online fraud, according to the United Nations, which savs hundreds of thousands of people have been trafficked to work in scam centres.

The talks between Xi and

Paetongtarn come as Beijing is navigating a trade war with the United States, triggered by President Donald Trump's 10% tariffs on all Chinese imports.

Thai Commerce Minister Pichai Naripthaphan said in November the country had a good balance between the US and China and expects to benefit from the trade war as Thai exports to the US would increase because the US would cut imports from China. - Reuters

Philippine VP impeachment trial 'likely' in June

MANILA: The impeachment trial of Philippine Vice-President Sara Duterte would likely take place after mid-term elections in May and could be decided by a new group of lawmakers, the Senate president said yesterday.

Whether the trial moves forward in a special session, when the Senate reconvenes on June 2, or even later, is now up to the country's 24 sitting senators, Francis Escudero told a press briefing, without offering a timeline for the

Duterte was impeached by the House of Representatives on Wednesday for "violation of the constitution, betrayal of public Allegations include financial fraud, assassination plot against president and links to drug war murders

trust, graft and corruption and other high crimes".

If convicted, she will be removed from the vice-presidency and barred from public office.

"Her Senate trial, however, will likely extend into the 20th Congress. That's almost a sure thing now, Escudero told reporters yesterday.

"The start date will depend on the rules we approve. But I feel the

trial has to take place when the Senate is in session. The impeachment court does not have a separate life."

He went on to explain that even if the trial begins on the watch of current senators, it could be taken over the finish line by the incoming

President Ferdinand Marcos

the move to impeach, could also legally call for a special session, although senators would have to accede to that in a vote.

Wednesday's impeachment vote, which drew ayes from 215 of the body's 306 members, spelled out allegations, including financial fraud, an assassination plot against Marcos and ties to "drug war" murders in Davao.

Speaking at a concurrent press conference yesterday, House Deputy Majority Leader Lorenz Defensor agreed the trial "may cross over to the next Congress' whose members will be determined by elections on May 12 and begin

their terms in late July.
"We leave it up to the Senate as a separate body and as an impartial body to adjudicate how they will proceed with the impeachment

Duterte, who has yet to publicly comment on her impeachment, was widely tipped to succeed her father Rodrigo as president in 2022 elections but stepped aside to back Marcos and later ran for vice-president on his ticket.

But the alliance has since imploded. In November, she delivered an expletive-laden speech saying she had ordered someone to kill Marcos if she herself was assassinated.

She later denied that her comments constituted a death threat, saying she had only been expressing "consternation" with the administration's failures.

The alleged assassination threat was among a raft of allegations included in three separate complaints filed against Duterte in December.

She was already the subject of a House investigation into her spending habits. – AFP

US health programmes in Indonesia put on hold, says minister

health Indonesia's partnerships with the US Agency for International Development (Usaid) are on hold and it remains unclear whether they will be permanently suspended.

The United States is considering merging Usaid, Washington's primary humanitarian agency, into the State Department in a major revamp that would shrink its workforce and align its spending with President Donald

Trump's "America First" policy.

A freeze on foreign aid for Indonesia could strain the Asian country's efforts to fight against HIV

and tuberculosis (TB).
"That is on hold. Not stopped," said Health Minister Budi Gunadi Sadikin. referring to its projects with Usaid.

Usaid has invested US\$800 million (RM3.5 billion) in Indonesia since 2020, the US embassy said. 2020, the US empassy The Southeast Asian country's projects with the agency have involved HIV and tuberculosis.

Budi said Indonesia also receives drugs from the Global Fund to Fight AIDS, Tuberculosis and Malaria, which counts Washington as its biggest donor.

The US embassy in Jakarta and Usaid did not respond to requests for

Indonesia has seen TB cases spike in the past few years, with the Health Ministry estimating more than one million cases in 2023, versus around 820,000 in 2020.

Non-profit group Indonesia's Strategic Development Initiatives health analyst Olivia Herlinda said the Usaid pause would

her initial said the Usaid pause would have a big impact. "The impact is huge because Usaid supports many health issues in Indonesia, including maternal and child health, TB and HIV," she said.

Separately, Budi said Indonesia will provide a free health screening for its citizens from Monday, with a budget of about 3 trillion rupiah (RM816 million) to prevent early deaths. The initial target for the screening is 220

million people this year.

Top causes of death in the world's fourth most populous nation include stroke, heart disease and TB, data from the World Health Organisation showed. - Reuters





Uproar over mistreatment of Indian deportees

Opposition Congress party demands discussion in parliament

AMRITSAR: Indian opposition lawmakers questioned Prime Minister Narendra Modi's government and demanded a discussion in parliament yesterday over what they said was ill-treatment of 104 Indian immigrants

deported by the US.

A US military plane carrying the immigrants landed on Wednesday in Amritsar, Punjab state, part of President

Donald Trump's immigration agenda.

The deportation came a week before
Trump is expected to meet Indian Prime
Minister Narendra Modi in Washington.

All immigrants, barring children, were handcuffed during the flight, *The Times of India* and the *Indian Express* newspapers reported, quoting unnamed officials in Punjab who said they had spoken to the

deportees.

The deportees underwent hours of scrutiny at Amritsar airport before police escorted them out in small groups in police vehicles.

Reuters was unable to speak to the immigrants.

Some of them were flown on a regular flight to Ahmedabad in Gujarat state yesterday, closer to their homes, said a police official, who did not want to be identified as he was not authorised to speak to the media. They were escorted out of the Ahmedabad

airport by security personnel, according to a witness. Most of the others are from Punjab or the neighbouring state of Haryana, police

"Reports have surfaced of these individuals being shackled and treated in a degrading manner during their deportation process, raising serious concerns about their human dignity and rights," opposition Congress party lawmaker Gaurav Gogoi said in a notice to the secretary-general of the lower house of parliament.

In a separate notice by another Congress

party lawmaker, Manickam Tagore urged Indian Foreign Minister S. Jaishankar to make an immediate statement in parliament

clarifying the Modi government's stand and steps taken to address the issue.

The Indian Foreign Ministry and the US embassy did not immediately respond to requests for comment.

Both houses of parliament were adjourned vesterday as opposition lawmakers shouted slogans demanding a government response.

Migration has been among the key issues discussed by India and the US since Trump assumed office last month, and is also expected to come up during Trump's talks with Modi.

Although Indian immigrants have been deported by previous US administrations, it was the first time Washington used a military aircraft to do so. It was also the farthest destination for such flights using a military aircraft.

administration increasingly turned to the military to help carry out its immigration agenda, using military aircraft to deport migrants and opening military bases to house them.

New Delhi has said it will take back such

illegal immigrants after verifying their details. The US is India's largest trading partner and the two countries are forging deeper strategic ties as they look to counter China. India is also keen to work with the US to make it easier for its citizens to get skilled workers

Seoul ministries block DeepSeek over security risks

SEOUL: South Korea's Industry Ministry has temporarily blocked employee access to Chinese artificial intelligence startup DeepSeek due to security concerns, a ministry official said on Wednesday, as the government

urges caution on generative Al services.

The government issued a notice on Tuesday calling for ministries and agencies to exercise caution about using Al services including DeepSeek and ChatGPT at work, officials said.
State-run Korea Hydro & Nuclear Power said

it had blocked use of Al services including DeepSeek earlier this month.

The Defence Ministry has also blocked access to DeepSeek on its computers that are

for military use, officials said yesterday.

The Foreign Ministry has restricted access to DeepSeek in computers that connect to external networks, Yonhap News Agency said. The ministry said it cannot confirm specific

DeepSeek did not immediately respond to an emailed request for comment. It was not immediately clear if the ministries

had taken any actions against ChatGPT.

The ban makes South Korea the latest

government to warn about or place restrictions on DeepSeek.

Australia and Taiwan have banned DeepSeek this week from all government devices over concerns that the Chinese artificial intelligence startup poses security

Italy's data protection authority ordered DeepSeek in January to block its chatbot in the country after the Chinese startup failed to address the regulator's concerns over its

privacy policy.

Some other governments in Europe, the US and India are also examining implications of using DeepSeek.

Korea's information watchdog plans to ask DeepSeek about how the personal information of users is managed.

DeepSeek's launch of its latest AI models last month sent shockwaves through the tech world. The company says its models are on par with or better than products developed in the United States and are produced at a fraction of

South Korean chat app operator Kakao Corp has told its employees to refrain from using DeepSeek due to security fears, a spokesperson said on Wednesday, a day after the company announced its partnership with

Korean tech companies are now more careful about using generative Al. SK Hynix , a maker of Al chips, has restricted access to generative AI services, and allowed limited use when necessary, a spokesperson said.

Naver, a major South Korean web portal, said it had asked employees not to use generative AI services that store data outside the company. – Reuters

Instal bird detection cameras, South Korean airports told

SEOUL: South Korean authorities said yesterday all airports across the country will be ordered to install bird detection cameras and radars after

the Jeju Air crash that left 179 people dead.
The Boeing 737-800 was flying from Thailand to Muan in South Korea on Dec 29 carrying 181 passengers and crew when it belly-landed at Muan airport and exploded in a fireball after slamming into a concrete barrier.

The pilot had warned of a bird strike before pulling out of a first landing attempt. The plane crashed on its second attempt when the landing gear did not emerge.

South Korean and US investigators are still

investigating the cause of the crash.

The new plans were announced as part of a

special safety inspection of airports along with a survey of facilities that attract birds.

"All airports will be equipped with at least one thermal imaging camera," said the Land Ministry in a statement, adding that they aim to begin the rollout next year.

Mobile sonic devices will also be used to deal with "medium and large-sized birds".

"Bird detection radars will be installed at all

airports to enhance early detection of distant birds and improve response capabilities for aircraft," the ministry said.

The radar will detect the size of the bird and

its movement paths, and this information will be relayed to air traffic controllers.

Ministry officials said they will "establish legal basis" to relocate facilities that attract birds – such as food waste treatment facilities and orchards – away from airports, and impose new distance restrictions on new facilities.

The priority is to establish comprehensive reform measures on aviation safety to prevent the recurrence of aircraft accidents," said Deputy Minister for Civil Aviation Joo Jong-wan. – AFP

Licensed rifles found at mass shooting site

OREBRO: Swedish police found several rifles in the adult education centre in Orebro where a gunman killed 11 people and wounded several others this week in the country's deadliest mass

shooting.
Police believe the suspected killer – identified by a Reuters source and Swedish media as Rickard Andersson, a 35-year-old unemployed

recluse – acted alone.
"We have found several weapons in the school. They are so-called long guns, rifles," a police spokesperson said yesterday.

"They are licensed guns and can be linked to the suspected perpetrator."

The attack occurred on Tuesday at the Risbergska adult education centre in Orebro, a city of more than 100,000 people about 200km west of Stockholm.

Swedish authorities have said there was no

evidence that the shooter, whose body was discovered at the scene, had "ideological

The police have not confirmed the name of the suspect and the number of wounded remains unclear, two days after the attack at the school, which offers adult courses and Swedish language classes for immigrants.

Kremlin fires space agency boss

MOSCOW: The Kremlin yesterday removed the head of Russia's space agency after a tenure of less than three years that was scarred by the failure of Russia's first mission to the moon in 47 years.

The Kremlin said Yuri Borisov, who had

headed Roscosmos since July 2022, had been relieved of his post.

He was replaced by Deputy Transport Minister Dmitry Bakanov, who before joining the government had been in charge of a satellite company.

Ever since Soviet cosmonaut Yuri Gagarin became the first man to go into space in 1961, Russia has prided itself as a leading power in space exploration.

But its ambitions suffered a massive blow in August 2023 when its uncrewed Luna-25 mission smashed into the surface of the moon while attempting to land.
Borisov, despite that failure, had laid

out ambitious plans as Russia prepares to launch its own orbital space station.

The new project will replace the ageing International Space Station (ISS) where Russia has collaborated with the United States even after relations were plunged into crisis because of the war in Ukraine

Last year Borisov approved a schedule under which the first two modules of the new Russian station would launch in 2027. Russia has said it plans to maintain a

continuous crewed presence in space and conduct scientific, economic and securityrelated projects that were not possible in the Russian segment of the ISS.

World powers are competing not only to explore space but also potentially to deploy weapons.

Borisov, the outgoing boss, formerly served as a deputy defence minister under Sergei Shoigu. – Reuter

CHINA NAMES SENIOR ENVOY FOR EUROPE

ENVOY FOR EUROPE
BEIJING: China named its former ambassador to France, Lu Shaye, as Special Representative for European Affairs. Lu, 60, will promote dialogue and cooperation with Europe and "contribute to the stable and healthy development of China-EU relations", said Foreign Ministry spokesperson Guo Jiakun. Lu replaces Wu Hongbo, 72, who was appointed to the role in 2019 when it was first created. The veteran French-speaking diplomat veteran French-speaking diplomat previously served as ambassador to Canada and Senegal. – Reuters

RUSSIA KICKS OUT LE MONDE JOURNALIST

MOSCOW: Russia said it had withdrawn accreditation from *Le Monde's* Moscow correspondent due to Paris' refusal to issue a visa to a Russian reporter, leaving the paper without a correspondent here for the first time since the 1950s. Foreign Ministry spokeswoman Maria Zakharova said Moscow had taken retaliatory measures after warnings to Paris over its refusal to give a visa to the Russian journalist. *Le Monde* criticised what it said was the "covert expulsion of its journalist". - Reuters

CHILDREN AMONG FIVE DEAD IN SHIPWRECK

SAN JOSE: A boat carrying 17 migrants heading for the United States sank off Nicaragua, leaving at least five people dead, including two children. A Nicaraguan army spokesperson said the vessel had left the Colombian island of San Andres on Tuesday with migrants from India, Iran, Egypt and Vietnam on board. The boat capsized near the Corn Islands off Nicaragua's Caribbean coast. Two Egyptian children were among the dead. – AFP

Israeli army told to prepare 'voluntary departure' plan

Forced or coerced displacement a war crime

TEL AVIV: Israel's defence minister ordered the army yesterday to prepare a plan to allow the "voluntary departure" of residents from Gaza, after US President Donald Trump drew widespread condemnation for announcing

plans to take over the strip.

Defence Minister Israel Katz hailed Trump's announcement that the United States would aim to take control of Gaza, resettle the more than 2 million Palestinians and transform the territory into the "Riviera of the Middle East

"Gaza residents should be allowed the freedom to leave and emigrate, as is the norm around the world," Katz said on X.

Katz said his plan would include exit options via land crossings, as well as special arrangements for departure by sea and air.

Displacement of Palestinians is one of the

most sensitive and explosive issues in the Middle East. Forced or coerced displacement of a population under military occupation is a war crime, banned under the 1949 Geneva Conventions.

Israeli strikes which killed tens of thousands of people over the past 16 months have forced

Palestinians to repeatedly move around within

Gaza, seeking safety.

But many say they will never leave the enclave because they fear permanent displacement, like the "Nakba," or catastrophe, when hundreds of thousands were dispossessed from homes in the war at the birth

of the state of Israel in 1948.

Many were driven out or fled to Gaza, the West Bank and neighbouring Arab states including to Jordan, Syria and Lebanon, where their descendants still live in refugee camps.

Katz said countries who have opposed

Israel's military operations in Gaza should take in the Palestinians.

"Countries like Spain, Ireland, Norway, and others, which have levelled accusations against Israel, are legally obligated to allow any Gaza resident to enter their territories," he said

Their hypocrisy will be exposed if they refuse to do so. There are countries like Canada, which has a structured immigration programme, that have previously expressed a willingness to accept Gaza residents."
His remarks drew quick criticism from Spainish Foreign Minister Jose Manuel Albares.

"Gazans' land is Gaza and Gaza must be part of the future Palestinian state," Albares said in an interview with Spanish radio station RNE.

Katz accused Hamas of holding Palestinians hostage in Gaza, preventing their departure and

extorting money from them through the humanitarian aid system. He did not elaborate.

Trump's announcement, which has sparked anger around the Middle East, came as Israel and Hamas were expected to begin talks on the second round of a fragile ceasefire plan to end

almost 16 months of fighting in Gaza.

Trump drew rebukes on Wednesday over his plan for Gaza from world powers Russia, China and Germany, which said it would foster "new suffering and new hatred".

Egypt and other Arab nations strongly oppose any attempt to push Palestinians over the border. They fear any mass movement would further undermine prospects for a "two-state solution" - the idea of creating a state of Palestine next to Israel – and leave Arab nations dealing with the consequences.

Regional heavyweight Saudi Arabia rejected the proposal outright and Jordan's King Abdullah said he rejected any attempts to annex land and displace Palestinians.

Iran's Foreign Ministry said Trump's plan was part of Israel's attempt to "completely wipe out the Palestinian people". Israeli Prime Minister Benjamin Netanyahu

said he did not believe Trump suggested sending US troops to fight Hamas, or that Washington would finance rebuilding efforts.

Hamas said Trump's proposal "ridiculous and absurd". - Reuters

West Bank healthcare in dire state, says report

GENEVA: The healthcare system in the occupied West Bank has been in "a state of perpetual emergency" since October 2023, Doctors Without Borders (MSF) said in a new report published yesterday.

"A dramatic escalation in violence, marked by

prolonged military incursions and stricter movement restrictions ... have severely hindered access to essential services, particularly healthcare, exacerbating already dire living

conditions for many Palestinians," it said.
"The West Bank has seen a dramatic escalation in violence, marked by prolonged military incursions and stricter movement restrictions," it said.

The report examined "the attacks and the obstructions of healthcare in a context of what has been described by the ICJ (International Criminal Court) as segregation and apartheid" and revealed "a pattern of systematic emergency healthcare delivery".

The Palestinian Health Ministry says Israeli troops and settlers have killed at least 884 Palestinians in the West Bank since the Gaza war

Over the same period, at least 32 Israelis have been killed in Palestinian attacks or during Israeli military raids in the territory.

Preventing Palestinians from accessing

healthcare was "part of a wider system of collective punishment imposed by Israel, under the guise of its crackdown on armed men", MSF

"The already-strained Palestinian healthcare system in the West Bank has been further weakened since October 2023 and is facing significant budget constraints," it said.

Nearly half of essential medications are out of

stock and health workers have not been paid in

a year, the report said, adding that "most clinics and hospitals are running at significantly reduced levels".

"Access to healthcare is severely impeded by sprawling system of checkpoints and adblocks that obstruct ambulance ambulance roadblocks movements, compounded by the escalation of violent military raids involving the use of disproportionate tactics".

This is compounded by "frequent attacks on

medical personnel and facilities ... hospitals and healthcare structures are often encircled by military forces, with troops sometimes occupying the buildings, compounding the risks

to both patients and staff."

Violence from settlers often exacerbates these dire conditions, it said.

MSF called on Israel to stop its "disproportionate use of force" in the West Bank.

A young child's brain is not yet capable of

understanding perspectives beyond his own. This is why anger directed at children can be

damaging.

When a parent screams, children are not when a parent screams, condens are not able to process the situation rationally and think: "My parent may be angry, but this is not my fault." Instead, children will immediately feel that they are to blame. If this message is reinforced consistently in the home, the child's reinforced consistently in the home, the child's sense of self-worth can deteriorate.

A child who grows up in a loving environment will understand that they are valuable and loved, even when they make mistakes.

In contrast, children raised in an environment of anger and harshness may begin to see themselves as a mistake - feeling unlovable and without value.

Almost every parent loses their temper at some point. Fortunately, children can bounce back from occasional outbursts. However, frequent anger can be damaging.

Protecting pensioners: Call for justice and dignity



AS chairman of Mailis Gagasan Malaysia, I earnestly call upon Prime Minister Datuk Seri Anwar Ibrahim to intervene and withdraw the government's appeal against the High Court's ruling on pension adjustments.

This appeal not only undermines the principle of legitimate expectation but also disregards the moral and legal obligations owed to retired civil servants who have dedicated their lives to public service.

The government's failure to honour its

commitments to pensioners is a stark betrayal of trust and a violation of the nation's core values.

The principle of legitimate expectation, a cornerstone of administrative law, ensures that individuals can rely on promises made by the government.

In this case, judicial decisions have repeatedly affirmed the rights of pensioners fair adjustments under the Pensions

to fair adjustments under the Pensions Adjustment Act 1980. By appealing the High Court's ruling, the government is defying legal precedent and perpetuating systemic injustice against those who have served the nation with unwavering dedication.

Legal battle

In January 2024, Aminah Ahmad, a former Foreign Ministry staff member, filed a judicial review application on behalf of herself and 56 other government pensioners. They sought an injunction to compel the government to expedite pension adjustments based on the formula outlined in Sections 3 and 6 of the Pensions Adjustment Act 1980, prior to its 2013 amendments.

Additionally, they demanded payment of

arrears within 14 days and a declaration that non-payment constitutes a breach of the Federal Constitution. This legal action followed the

Federal Court's landmark ruling in June 2023, which declared the 2013 amendments to the Pensions Adjustment Act void.

The court found that the amendments were detrimental to pensioners and violated Article 147 of the Federal Constitution,

147 of the Federal Constitution, which safeguards pension rights. Under the old system, a pensioner's pension was adjusted based on the current salary of civil servants in that grade, ensuring that retirees' benefits remained aligned with the cost of thing and commits conditions. living and economic conditions

However, the 2013 amendments replaced this equitable system with a flat rate annual increase significantly eroding the financial

security of pensioners.

Despite this clear judicial directive, the government's decision on Jan 23, 2025 to appeal the High Court's ruling is legally untenable and morally indefensible.

Glaring double standard

The government's stance reveals a troubling double standard. While retired judges have received pension adjustments based on their final salaries, other civil

servants continue to be denied the same consideration.

In January 2022, 35 retired judges, including several senior figures, successfully sued the government for failing to adequately increase their pensions and benefits since 2015. They secured not only the correct adjustments but also arrears amounting to

RM200.000. This disparity highlights systemic inequity as ex-judges who retired before July 2015 have received their due while other retirees remain neglected.

Moral imperative Beyond the legal arguments, the government's appeal disregards the financial hardships faced by

With the rising cost of living, delayed pension adjustments will exacerbate the economic strain on former civil servants, many of whom depend solely on their pensions for survival.

The shift from a salary linked adjustment system to a flat 2% annual increase under the 2013 amendments has left pensioners struggling to cope with inflation and escalating living expenses. Denying them their rightful entitlements is not only unjust but also inhumane.

Mobilising for justice

In response to this injustice, a coalition of government pensioners is mobilising to demand accountability.

Thousands of affected individuals plan to gather at Dataran Merdeka in Kuala Lumpur on April 19, calling on the government to implement the High Court's ruling and honour rightful

pension adjustments. This rally underscores the stration among retirees v growing frustration who

Such a gathering could be avoided if the government heeds the call to withdraw its appeal and treats pensioners with the dignity and respect they deserve.

Call to action

I reiterate my call for the government to withdraw its appeal and uphold the rights of pensioners. This is not merely a legal obligation but a moral imperative that reflects the nation's commitment to justice, dignity and respect for its citizens.

I also urge civil society organisations to stand in solidarity with retirees, amplifying their voices and ensuring their contributions are acknowledged.

The government must recognise that respecting pensioners' rights is not just about fulfilling legal obligations; it is about affirming the values of compassion, fairness and gratitude that define a just society.

By withdrawing the appeal and implementing the High Court's ruling, the administration can demonstrate its administration can demonstrate its commitment to these principles and uphold its credibility as a responsible government.

Rising medical inflation cause of insurance premium hike: Amir Hamzah

KUALA LUMPUR: The continuous rise in medical inflation has led to an increase in the claims rate for medical and health insurance and takaful (MHIT), Deputy Finance Minister Datuk Seri Amir Hamzah Azizan said.

He said Bank Negara Malaysia (BNM) has taken several interim measures to curb the impact of rising MHIT premiums on policyholders, which took effect on lan 15

The interim measures include the distribution of premium adjustments due to medical claims inflation over a period of at least three years until the end of 2026, and a one-year delay in premium adjustments due to medical claims inflation for policyholders aged 60 and above who are covered under the minimum plan for the MHIT products purchased. "Additionally, policyholders whose

"Additionally, policyholders whose policies have expired in 2024 due to the premium reset can contact their respective life insurers and family takaful operators to request their policies be reactivated based on the adjusted premiums," he said during the question-and-answer session in the Dewan Rakvat vesterday.

in the Dewan Rakyat yesterday.

Amir Hamzah was responding to a question from Lim Guan Eng (PH-Bagan) regarding the profits of life insurance companies since 2018 and the resolution of the controversy over premium increases for medical insurance, which have surged by as much as 70%, as well as steps to prevent arbitrary hikes in private healthcare costs.

Through the interim measures, 80% of policyholders are expected to face annual premium adjustments of less than 10% due to medical claims inflation, he said. – Bernama

Trump tariff hikes — minimal impact on Malaysia for now

KUALA LUMPUR: The risk of negative impact on semiconductor export performance to the United States following the implementation of tariff hikes by US President Donald Trump is seen as minimal for the time being, said the Ministry of Investment, Trade and Industry (Miti).

Minister Tengku Datuk Seri Zafrul Abdul Aziz said this is because Malaysia was excluded from the recent tariff increase imposed on several countries

imposed on several countries.

"Additionally, investment records show that investments from the US remain strong, as the country is among the largest investors, totalling RM5.1 billion in the third quarter of 2024," he said during Minister's Question Time in the Dewan Rakyat yesterday.

Tengku Zafrul was responding to Datuk Ku Abd Rahman Ku Ismail (PN-Kubang Pasu), who asked Miti to outline the government's steps in addressing geopolitical issues and global trade uncertainties, particularly the possibility of tariff increases that would affect Malaysia's exports, especially to the US.

The minister said Malaysia

The minister said Malaysia signed a memorandum of cooperation on semiconductor supply chain resilience with the US on May 10, 2022. This agreement, he added, reflects the ongoing commitment of We're excluded from recent duty increases imposed on several countries and investments from US remain strong: Tengku Zafrul

both countries to ensure a strong and resilient semiconductor supply chain and strengthen economic and strategic ties between Malaysia and the US.

"Therefore, the ministry is confident that existing investors from the US will remain in Malaysia and continue to grow to strengthen their global supply chain," he said.

Malaysia's third-largest trading
partner in 2024, with a trading volume
of RM324.9 billion, accounting for
11.3% of Malaysia's total trade.
"Exports to the United States
amounted to RM198.6 billion,

"Exports to the United States amounted to RM198.6 billion, equivalent to 13.2% of Malaysia's total exports, while imports from the United States reached RM126.3 billion, equivalent to 9.2% of Malaysia's total imports. In terms of investment, the US is among the largest investors, and so far, Malaysia has become the preferred investment destination for more than 600 American companies."

In this regard, Tengku Zafrul said, the government is proactively

trying to maintain and strengthen the good and dynamic bilateral trade and investment relations with the US to avoid tariff increases such as those imposed on China, Canada, and Mexico. The government will ensure that

The government will ensure that Malaysia remains a reliable trading and investment partner for all its partners, including the US. "This includes through a conductive and investor-friendly investment ecosystem, effective export control regulations and strategic trade management, as well as compliance with international standards that reassure investors," he said.

On a another issue, Tengku Zafrul said the rise of different types of artificial intelligence (AI) technologies such as DeepSeek can reduce Malaysia's reliance on a single product.

single product.

The emergence of diverse AI technologies also enables Malaysia to become a neutral centre for AI companies from the west as well as those from the east, such as China, be edded.

"Although this more efficient (type of) AI technology reduces the need for large data centres, its lower cost is expected to drive more widespread use, driving demand for data centre services," Tengku Zafrul said when responding to Datuk Seri Wee Jeck Seng's (BN-Tanjung Piai) question on the impact of the rise of new AI technologies from China on data centre investors in Johor.

Tengku Zafrul said increasing AI efficiency does not reduce demand for data centres. Instead, they may increase AI use, stimulating investment concerning data. "The semiconductor supply chain will be diversified. If we look at Johor, Penang and Kedah, these strategic locations for AI infrastructure and data centres will not be affected."

Hence, the next step is to ensure that Malaysia's data centres have the cutting edge by introducing more enticing green investment incentives.

"We want to further encourage the AI and digital workforce and raise Malaysia's competitiveness as an AI processing centre by attracting more investment from AI companies, not only from the west but also from other countries. We also need to maintain diplomatic relations with the United States (US) and China to ensure our position as a neutral technology investment hub," Tengku Zafrul said. – Bernama

NAIO Lab expected to create over 450 high-skilled AI engineering jobs

KUALA LUMPUR: Northern Solar Holdings Bhd is setting its sights on expansion following its listing on the ACE Market of Bursa Malaysia, with plans to establish branches in Penang and Johor Bahru.

Managing director Lew Shoong Kai (pic) said the expansion is expected to be concluded within the next 12 months, strengthening its presence in Malaysia's growing solar energy sector.

The solar renewable energy

specialist, which focuses on engi-neering, procurement, construction, and commissioning (EPCC) of solar systems, renewable energy generation, and operations and maintenance (O&M), is targeting a 20% growth in its rooftop solar segment, which offers the

highest profit margins.

Lew said Northern Solar ranks among Malaysia's top 10 rooftop solar

players, though precise market share data is limited due to policy-driven regu-

The company currently has a tender book of 380 projects, which includes industrial parks and residential developments. Northern Solar will actively work on converting these tenders into secured contracts," he said in a press conference following the

company's listing yesterday.

Lew said the company is currently examining its participation in the Large Scale Solar 5 (LSS 5)

programme.
"We are currently conducting an in-depth analysis. Based on the study of all LSS 5 schemes, the first phase is expected to involve a capacity of two gigawatts, making it a strategic step

"The government has extended



this initiative to LSS 5+, with an additional two gigawatts. The estimated project value over the next three years is between US\$15 billion and US\$20 billion (RM66.5 billion and RM87 billion)," he added

noted that China's oversupply of solar modules has lowered material costs,

benefiting Northern Solar's procurement strategy. "The US import tariff hike on Chinese solar panels does not affect the company, as

it sources directly from China," he said. While competition in the solar EPCC business has intensified, Lew remains optimistic, noting that project values and demand have increased proportionally, particularly with the extension of the Net Energy Metering Scheme and the lifting of

the self-consumption limit.

Northern Solar debuted on the ACE Market at 90 sen, a 42.86% (IPO) price of 63 sen per share. Lew said the IPO marks a major

milestone and positions the company for further expansion. "This listing is a strong vote of confidence from the market. With the funds raised, we are

market. With the funds raised, we are committed to scaling up operations and capitalising on Malaysia's growing demand for renewable energy."

Northern Solar raised RM42.4 million from the IPO. A total of RM3.2 million (7.4%) from the proceeds will be used to company the company of the proceeds will be

used to set up a new corporate office.

The company plans to allocate RM29.2 million (68.8%) of the proceeds to finance the expansion of its photovoltaic (PV) solar system business. The remaining funds will be used to repay bank borrowings amounting to RM5.5 million (13%) and to cover estimated listing expenses of RM4.6 million (10.8%).

Services PPI maintains upward trend with 0.5% increase in Q4'24

PUTRAJAYA: The services producer price index (SPPI) continued its upward trend, rising by 0.5% in the fourth quarter of 2024 (Q4'24), as compared to 0.3% in the previous quarter, reflecting a rise in services sector pricing.

The Chief Statistician Malaysia Datuk Seri Dr Mohd Uzir Mahidin said: "The arts, entertainment & recreation index increased by 6.1% as compared to a 5.4% rise in the previous quarter, driven by other entertainment & recreation activities (1.9%). Meanwhile, the accommodation and food beverage service activities index continued to increase by 3.1% continued to increase by 3.1% (Q3'24: 2.4%), supported by increases in restaurants and mobile food service activities (3.4%) and beverage service activities (3.2%) indices. The education index rose by 0.8%, maintaining the same pace as in quarter, due to previous (1.7%) secondary education

Additionally, both health and professional indices saw an incline of 0.4%."

Conversely, he added the transportation index posted a decrease of 2.4% (Q3'24: -2%), mainly due to the air passenger transportation index (-9.5%)

transportation index (-9.5%). Similarly, he said the real estate activities index recorded a slight decrease of 0.2%, while the information & communication index edged down by 0.1%, influenced by a decline in the wireless telecommunications activities (-0.2%).


"On a quarter-on-quarter basis, SPPI increased by 0.3%, as compared to 0.1% in the third quarter of 2024. This was driven by increases in accommodation and food & beverage service activities (1.1%) and arts, entertainment & recreation (0.9%) indices. Additionally, both professional and health indices saw a modest rise of 0.2% while the education

index edged up by 0.1%. Meanwhile, information & communication and real estate activities indices remained unchanged. However, the transportation index experienced a decline of 0.6%," said Mohd Uzir.

He also summarised that the SPPI posted a marginal increase of 0.7% in 2024, as compared to a 2.1% rise in 2023.

The increase was primarily driven by the arts, entertainment & recreation index (6.7%), followed by accommodation and food & beverage service activities (2.6%) and education (0.8%) indices.

Other subsectors that recorded an increase included health and real estate indices, both rising by 0.3%, while the professional index rose by 0.2%. In contrast, the transportation index declined by 1.4%, whereas the information & communication index remained unchanged.



KLCCP posts solid fourth-quarter results

KUALA LUMPUR: KLCCP Stapled Group delivered a strong performance in quarter four 2024 (Q4'24), with higher revenue of RM459.1 million from RM442.6 million in quarter four of the previous year.

Profit Before Tax (PBT) (including fair value adjustments) rose from RM470.4 million to RM476.4 million for the quarter ended Dec 31, 2024. The PBT growth was further enhanced by a notable RM234.7 million fair value gain, attributed to the increased market value for the retail asset.

Building on this solid performance, the group in a statement announced a dividend of 17.1 sen per stapled security for the quarter, bringing the total dividend for the year to 44.5 sen per stapled security, a 9.9% increase from 2023.

Suria KLCC and the retail podium of Menara 3 Petronas – representing the retail segment – recorded higher revenue of RM139.6 million compared to RM137.1 million in the previous quarter, while PBT stood at RM107.7 million, reflecting a 3.5% increase from the same quarter last year.

This improved performance is primarily due to higher base rent from an upward revision in rental rates for existing and new tenants, along with improved occupancy of 99% compared to 97%.

The hotel segment, represented

by Mandarin Oriental Kuala Lumpur, saw its revenue rise to RM67.9 million from RM65.2 million in quarter four 2023 with PBT of RM5.4 million, driven by the robust growth in group stays and banqueting events. Group stays grew to 28%, up from 17% in quarter four 2023 and the banqueting revenue hit a record high since the hotel's opening. The hotel's Revenue Per Available Room (RevPar) for the quarter saw a 3.7% increase compared to 2023.

The office segment, comprising the Petronas Twin Towers, Menara 3 Petronas, Menara ExxonMobil, and Menara Dayabumi, recorded a revenue of RM146.3 million compared to RM146.5 million in Q4'23, while PBT rose to RM120.1 million from RM114.5 million in the same quarter last year.

The group's improved performance was supported by the strong results in

the management services segment with revenue reaching RM125.5 million and PBT at RM24 million, driven by higher maintenance service activities undertaken.

activities undertaken.

KLCCP Stapled Group closed the financial year 2024 with a robust performance, achieving a record RM1.7 billion in revenue - the highest since its listing in 2013, underscoring its strong market performance and strategic focus. 

Malaysia to become important fresh durian exporter to China: BMI

KUALA LUMPUR: Malaysia is expected to become an important exporter of fresh durian to China following an agreement cemented last year between the two countries, said BMI in a statement.

BMI, a unit of Fitch Solutions, said yesterday the agreement signed in June 2024 allowed Malaysia to export fresh durian into China.

It said that before this, Malaysia only exported frozen pulp and whole frozen

fruits.

Citing data from the International Trade Center, BMI said Malaysian fresh durian exports to China totalled US\$4 million (RM17.7 million) in August, September, and October 2024.

"We forecast continued strong demand for durian fruit from China and therefore expect investment in the sector to increase over the short to medium term while highlighting risks associated with overreliance on one import market." BMI opined that Malaysia and

Vietnam are expected to give Thailand a "run for their money", with both countries experiencing significant growth in durian exports.

"Over recent years, exports of durian fruit have become an increasingly important source of export revenue for producing countries in the (Southeast

Asian) region.

"We expect growing competition in the durian market, with significant growth in exports from Vietnam and Malaysia, which we expect will

increasingly challenge Thailand's status as the largest global exporter," it said.
Thailand is currently the world's largest exporter of fresh "king of fruits", accounting for 63.8% of all exports between 2013 and 2023.
"Thailand's during exports have

"Thailand's durian exports have grown at a compound annual growth rate (CAGR) of 22.8% over the past ten years and 8.6% over the past five years, indicative of the strong momentum in the industry," said BMI.

Therefore, it expects market concentration to decrease in the near term with growth in production and exports from alternative markets

BMI unit also pointed out that the increasing significance of durian production in Vietnam has also posed a risk to the country's coffee industry.

To date, Vietnam is the world's leading producer of robusta coffee beans.

"To the downside, some farmers choose to plant durians instead of coffee. To the upside, increased intercropping can increase farm resilience," BMI said. - Bernama

'Gamuda order book could hit RM41b with water deal

KUALA LUMPUR: Gamuda Bhd's participation in the Sungai Perak Raw Water Transfer Scheme (SPRWTS) development project could potentially bump up Gamuda's outstanding order book by about 11% to RM41.1 billion.

In a research note yesterday, CIMB Securities Sdn Bhd said the expectation is well within Gamuda's end-2025 target of RM40 billion to RM45 billion.

It said participation in the SPRWTS project would account for 20% of the research house's forecast for the financial year 2026 new order book assumptions for

"Additionally, we believe that the group is well-positioned to secure water-related infrastructure

works worth RM3 billion to RM4 works worth RM3 billion to RM4 billion for the Ulu Padas Hydroelectric Dam by end-Feb 2025, having already clinched a 75% share in the construction of the 188 megawatt (MW) Ulu Padas hydroelectric power plant (with the remaining 25% held by Conlay Construction)," it said.

CIMB Securities also highlighted that aside from addressing the region's domestic water supply needs, the SPRWTS project is expected to support development within the Kerian Integrated Green Industrial Park and enhance irrigation in the district upon its completion by 2029.

"Additionally, our channel checks indicate that the SPRWTS channel will eventually be expanded to facilitate the supply of treated water to Penang.

"Penang needs a second major

water resource (apart from Sg Muda), especially within the fastgrowing southern Seberang Prai region. This aligns with the Penang

Water Supply Initiative 2050." CIMB estimated that the project

could cost up to RM4 billion. In terms of its projected capacity, up to 1,500 megalitres (mld) of water could be extracted from Sungai Perak to meet the daily water requirements of northern Perak and Penang.

"As a kev rakvat-centric initiative under Budget 2025, we believe that Gamuda will emerge as the main contender contender to undertake construction works for the SPRWTS, while Perak Water Board, the sole service licensee for the state's water supply management, is expected to manage the water facility when it is completed." CIMB Securities added

Meanwhile, on the funding of the project, CIMB Securities said that the Ministry of Finance's wholly owned entity, Pengurusan Aset Air Bhd, which financed the 80 mld Kerian Water Supply Scheme in Perak, is likely to be roped in to fund the project.

It maintained its "buy" rating on Gamuda with an unchanged target price of RM6. – Bernama

AmInvestment Bank projects strong growth for technology sector

KUALA LUMPUR: Malaysia's technology sector is projected to see a strong 58% year-on-year (y-o-y) earnings growth for the fourth quarter of 2024, with an quarter-on-quarter growth,

87% quarter-on-quarter growth, according to consensus estimates.

In a research note yesterday, Amlnvestment Bank Bhd highlighted that the risk-reward outlook for Malaysian technology sub-segments is most favourable for equipment makers, given their reasonable earnings estimates, recovering order

books, and ongoing supply chain relocation activities.

It noted that estimates for

equipment makers are particularly

"Order books for equipment makers have stabilised and in certain cases, resumed an upward growth trajectory.

'With certainty following the United States elections, customer capital expenditure plans have resumed. We expect this segment to benefit from tariff-driven supply chain relocation activities, supporting our 'buy' calls on Vitrox Corporation Bhd and Greatech Technology Bhd," it said. In comparison, the bank pointed

out that earnings expectations for electronics manufacturing services, outsourced semiconductor assembly and test (OSAT), and precision engineering firms are much higher.

"Concerns over export controls, have raised the risks of stockpiling, casting doubt on demand sustainability.

"OSAT companies also dependent on smartphone shipments, where artificial intelligence (AI) features have yet to boost revenues. For example, in its first quarter 2025 results, Apple Inc reported a one per cent y-o-y decline in iPhone revenues."

AmInvestment Bank maintained "overweight" rating on Malaysia's technology sector.

"While expectations for the sector remain high, we believe there is value within the sector, given its relatively low weighting in investor portfolios and positive long-term structural prospects.

"As the AI and data centre trade unwinds, interest could eventually return to the sector as investors seek to rebalance their portfolio," it added.

Their top picks are Vitrox (buy, target price (TP): RM4.75) and VS Industry Bhd (buy, TP: RM1.45), based on preference for stocks with a clear strategy and long-term vision and earnings certainty. – Bernama

The manufacturing sector accounted for S\$11.1 billion of the FAI commitments, led by investments in semiconductors and biomedical manufacturing, while total business expenditure investment was driven by investment in headquarters and professional services.

China's box office hits record, spending jumps during Lunar New Year

SHANGHAI: China's box office raked in record takings over the Lunar New Year holiday while domestic spending jumped, data showed, marking a bright showing for Chinese policymakers as they work to spur domestic

demand.

The Chinese film market took in 9.5 billion yuan (RM5.7 billion) over the eight-day Lunar New Year period that ended on Tuesday, 18.8% higher than the same period last year, as moviegoers flocked to cinemas to watch movies such as *Nezha 2*, data from ticketing platform Maoyan showed.

The box office figure surpassed last year's record of eight billion yuan for the same

eight-day period. A total of 187 million tickets were sold, also

a record, during the Lunar New Year period.

Domestic travel spending hit 677 billion yuan, up 7% compared with the previous year, while the number of domestic trips rose 5.9% to 501 million, China's Ministry of Culture and

Tourism reported.

State-owned news agency Xinhua said multiple indicators, including total expenditure, reached record highs.

The ministry did not give a breakdown of The ministry did not give a breakdown of the tourism spending per trip but, according to Reuters calculations based on the data, average spending per trip during the holiday this year reached 1,351 yuan, up from last year's 1,335

However, data from air travel platform VariFlight revealed a mixed trend in flight activity.

While the number of domestic passenger flights dipped by 0.7% compared with the same period last year, international and regional routes saw a surge, with passenger flights increasing by 21.4% compared with

Swiggy reports wider loss as competition fuels expenses surge

MUMBAI: India's Swiggy reported a wider quarterly loss on Wednesday, as the online platform poured money into its quick commerce business to compete with rivals Zomato and Zepto.

The company reported a consolidated loss of 7.99 billion rupees (RM405 million) for the third quarter ended Dec 31, compared to a loss of 5.74 billion rupees a year earlier.

Companies such as Swiggy and Zomato are doubling down on quick commerce, aiming to deliver goods ranging from groceries o electronics in 10 minutes or less, by opening more warehouses or so-called "dark stores" to fulfil such Zomato, which owns Blinkit, plans to double its warehouse count to 2,000 by the end of 2025, while Swiggy has plans to close the financial year with twice as many fulfilment centres for its

Instamart business from 523 a year ago.
Swiggy's quarterly expenses jumped about
32% to 48.98 billion rupees.
"Instamart growth ramp-up continues amidst

significant investments to expand the (quick delivery) market," the firm said in a press release. The company added 96 new dark stores in

e quarter, bringing its total to 705.

The rapid expansion in quick commerce and steady food delivery demand led to its revenue climbing about 31% to 39.93 billion rupees

Food delivery revenue grew 24%, while quick commerce revenue more than doubled.

Instamart's gross order value – the total

Nomura doubles Q3 profit on revived markets

TOKYO: Nomura Holdings doubled quarterly profit, helped by a surge in trading revenue and deals advisory fees as Japan's top brokerage and investment bank pushes ahead with its strategy of diversifying revenue streams and cutting

costs to boost growth.

Nomura posted its seventh consecutive quarter of income growth in the three months ended December as its wholesale division, made up of investment banking and global markets units, reinforced its comeback after several years of underperformance.

Income in the October-December period was its highest since the first quarter of 2020, coming in at ¥101.44 billion (RM2.9 billion) compared with ¥50.55 billion a year earlier.

"We are seeing the results of our medium to long-term strategy by growing our stable revenues and diversifying our revenue streams, while effectively controlling costs and capital," Nomura CEO Kentaro Okada said in a statement.

"This reinforces our confidence in our

current direction".

The results underline Nomura's dominant position among Japanese securities firms this year as it widens the

income gap with its competitors.
Smaller rivals Daiwa Securities and Mizuho Securities last week posted robust quarterly income growth of 64% and 340% respectively, but still trail Nomura's profit over the quarter by a factor of more than two.

The global markets unit clocked a 39% rise in net revenue compared to the same period in the previous year on growth in all overseas regions, and especially in equity

overseas regions, and especially in equity derivatives products in the Americas.

The unit's performance indicates customers outside Japan were undeterred by a bond trading scandal that saw Nomura temporarily stripped of its status as a primary dealer of government bonds and fined ¥21.8 million by Japan's securities watchdog last year securities watchdog last year.

Nomura won several major cross-border M&A advisory deals while its equity capital markets business captured fees from companies' disposals of their cross shareholdings and IPOs of Japan firms such

The wealth management division booked a slight drop in revenue on fewer Japanese stock and bond transactions, but pre-tax income grew 2% on the previous quarter and 45% on the previous year thanks to cost-cutting initiatives. –



NEW YORK: Walt Disney sharply outperformed Wall Street's quarterly earnings estimates on Wednesday, with results buoyed by the strong holiday box office performance of animated sequel *Moana 2* and higher profits at the

company's streaming business.

The strength in entertainment helped offset a decline at Disney's domestic theme parks, which were impacted by hurricanes Helene and Milton in Florida.

The parks-led Experiences group also incurred US\$75 million (RM332 million) in expenses associated with the December launch of the Disney Treasure cruise ship.

Disney reported a 44% jump in adjusted per-share earnings of US\$1.76 for the quarter that ended in December, exceeding the US\$1.45 per share earnings consensus estimate of 24 analysts surveyed by LSEG. Revenue for the quarter rose 5% to US\$24.69 billion, slightly ahead of analysts' projections of US\$24.62 billion.

Operating income rose 31% from a year.

Operating income rose 31% from a year earlier to US\$5.1 billion.
"Overall, this quarter proved to be a strong

start to the fiscal year, and we remain confident in our strategy for continued growth," Disney

CEO Bob Iger said in a statement.

Looking ahead, Disney forecast "high single digit" adjusted earnings-per-share growth in fiscal 2025 compared with the prior year and an increase of approximately US\$875 million in operating income at the streaming entertainment unit. entertainment unit.

The company said it would incur US\$50 million in costs associated with exiting its Venu Sports joint venture with Warner Bros Discovery and Fox.

Streaming service sheds one million subscribers following price increase

The media firms abandoned their plans for sports streaming service in January, after it ran into substantial legal opposition.

Operating income at Disney's Entertainment unit, which includes film, television and streaming, increased to US\$1.7 billion in the quarter, nearly double the results from a year earlier, thanks in part to the strong performance

of Moana 2.

The animated sequel topped US\$1 billion in box office proceeds over the Martin Luther King Jr Day weekend in January, becoming the fourth Walt Disney Animation film to reach that financial milestone.

Disney's traditional television business continued to erode.

Subscribers for the company's flagship streaming video service, Disney+, slipped 1%

from the prior quarter to 124.6 million.

The company had warned of a modest drop in subscribers because of a price increase that took effect in October.

It also forecast a modest decline in Disneysubscribers in the second quarter, compared to the first.

Disney+, Hulu and ESPN+ produced an operating profit of US\$293 million in the quarter, marking the third straight quarter of profitability and a turnaround from the year-ago loss of US\$138 million.

includes consumer products and the cruise line, as well as parks, operating income was roughly flat at US\$3.1 billion.

Profit declined 5% at domestic parks because the hurricanes and cruise ship costs,

Vestas 2024 profit soars, fanned by record orders for wind turbines

COPENHAGEN: Vestas, the world's biggest wind energy company, said on Wednesday its net profit soared sixfold in 2024 as it logged a record number of orders for its turbines.

The Danish group's after-tax profit jumped from €77 million in 2023 to €499 million (RM2.3 billion) last year.

Revenue grew 12% to €17.3 billion.
"Vestas continued its positive trajectory in 2024 and achieved its outlook for the year," chief

executive Henrik Andersen said in a statement. He added that "the year didn't evolve as

expected" but "Vestas leaves 2024 stronger than we entered it" thanks to all-time high orders and an "extraordinary turnaround" in its power

The value of its order backlog reached €68.4 billion last year, representing 21.7 gigawatts of onshore wind power and 7.5 GW of offshore

Vestas is banking on growth in offshore wind. The company secured its first offshore wind project in the United States last year and saw expansions in Europe along with the emergence of new markets such as Japan and South Korea. Vestas is forecast revenue of between €18

billion and €20 billion in 2025.

Uber tops revenue estimates

SAN FRANCISCO: Uber Technologies surpassed market expectations for fourth-quarter revenue on Wednesday, as more people used the ride-hailing platform for office commutes and its delivery business benefited from strong holiday-season demand.

But the company joined a chorus of US technology firms in warning that a strong dollar would weigh on current-quarter results, and forecast quarterly bookings largely below Wall Street estimates.

Already the dominant ride-hailing service in North America, Uber has been trying to convince investors that it has more room for growth by attracting more businesses and teens to its platform, as well as expanding to less saturated markets.

Uber's business-focused service reported a 50% surge in bookings for the last three months of 2024, thanks to return-to-office mandates, while Uber for Teens posted a similar jump, and is now

available in about 50 countries.

Overall, the company's ride-hailing revenue jumped 25% and delivery revenue rose 21%, both above estimates.

Its total revenue of US\$11.96 billion surpassed analysts' average estimate of US\$11.77 billion, according to data compiled by LSEG.

compiled by LSEG.
Gross bookings of US\$44.2 billion
were also higher than expectations, while
net profit totalled US\$6.88 billion,
buoyed by a US\$6.4 billion benefit from a tax valuation release.

CEO Dara Khosrowshahi said Uber planned to drive growth in 2025 by offering customers better rates, in part by slowing hikes in insurance charges, a major expense for ride-hailing firms. - Reuters

Estee Lauder to cut 7,000 jobs

NEW YORK: Estee Lauder forecast thirdquarter profit well below estimates, citing persistent weak demand at airports and travel destinations such as Korea and China, while also expanding its restructuring plan

while also explaining is restricting plant to include up to 7,000 job cuts.

Estee Lauder expects to take restructuring and other charges of between US\$1.2 billion and US\$1.6 billion.

The company estimates a net reduction of 5,800 to 7,000 jobs by the end of fiscal 2026 as part of an expanded plan to help the cosmetics giant return to sales growth and restore a solid double-digit adjusted

operating margin over the next few years.
As of June 30, 2024, the New York-based company had about 62,000 employees worldwide.

Estee Lauder said the plan aims to "manage external volatility, such as potential tariff increases globally".

"For the third quarter, we expect

On the broader market, gainers led decliners 485 to 391, while 511 counters were unchanged, 914 untraded and 12 suspended. Turnover advanced to 2.93 billion units valued at RM2.1 billion

versus 2.86 billion units worth RM2.32 billion on Wednesday. Rakuten Trade Sdn Bhd equity research vice-president Thong Pak Leng said the key regional indices were also upbeat, thanks to strong buying in technology and electric vehicle stocks.



Fixed 2% EPF for foreign workers seen as positive for plantations

KUALA LUMPUR: The fixed 2% EPF contribution for foreign workers is positive for the plantation sector.

RHB Research said that while this would negatively impact earnings, the research firm's estimates indicate that the extent would not be substantial.

"Recently, the government proposed a fixed mandatory 2% EPF contribution for foreign workers, which is lower than the initial proposed figure of 12%.

"There are no details yet on the implementation timeline, which is expected to be discussed at the Cabinet level this week – although we believe this will be implemented in phases.

also note that there was no segregation (regarding this new percentage) between foreign workers under new or existing

contracts," the bank-backed research firm said.

RHB Research said that assuming the latest 2% EPF contribution applies to both existing and new contracts, the research firm is positive about this development as the rate will be lower than the statutory rate of 12% for both employees and

As such, foreign workers would take home RM1.666 (2%, or RM34 per month) based on the revised RM1,700 minimum wage. RHB Research noted that plantation companies would also

need to pay an additional cost of at least RM34 per month for each worker, assuming a minimum wage of RM1,700.

"We believe the proposed contribution would be some relief to planters as it is much lower than the previously mentioned 12% contribution.

"While there would be a slight negative impact on earnings, the impact is not that significant." RHB Research said.

Ringgit slips against dollar as US seeks lower Treasury yields

THE ringgit turned lower against the US dollar at the close yesterday amid improved demand for the greenback following the US administration seeking ways to reduce the 10-year US Treasury yield rather than bringing down the Fed Fund Rate, said an analyst.

At 6pm, the ringgit eased to 4.4320/4385 against the US dollar

from Wednesday's close of 4200/4260.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid also believed that risk appetite among traders and investors remained guarded in light of the US tariff and geopolitical measures, especially concerning Gaza, where US President Donald Trump mentioned his desire to take over Palestinian soil.

"How this would translate into global peace remains unsure, but it certainly would elevate the geopolitical temperature in the Middle East," he added.

Meanwhile, the ringgit was traded mostly higher against other maior currencies

It fell against the Japanese yen to 2.9036/9080 from 2.8930/8972 on Wednesday, rose against the euro to 4.5920/5987 from 4.5990/6053, and appreciated against the British pound to 5.5090/5171 from 5.5321/5396.

The local note was mixed against Asean currencies. It was slightly higher against the Singapore dollar to

3.2742/2793 from 3.2746/2792 and increased against the Thai baht to 13.1175/1433 from 13.1602/1844.

The ringgit was little changed against the Indonesian rupiah to 271.2/271.7 from 271.2/271.8 and fell against the Philippine peso to 7.62/7.63 from Wednesday's close of 7.61/7.63. – Bernama

GAMUDA has signed an exclusive arrangement with Perbadanan Kemajuan Negeri Perak (PKNPk) to develop infrastructure that addresses the issue of critical water storage in north Perak. This scheme involves facilitating the transfer of raw water from Sungai Perak to Bukit Merah, and developing the requisite infrastructure for treated water distribution, ensuring long-term water

sustainability for the region.

PKNPk and GAM will jointly manage all components of this development including overseeing the design, civil and structural engineering, utilities, risk mitigation and the implementation of local workforce and technology training programmes. We foresee minimal execution risks due to GAM's track record in water projects – namely the Sungai Selangor Water Supply Scheme Phase 3, including the water treatment plants in Rasa and Bukit Badong together with the Stormwater Management and Road Tunnel (SMART). Note that GAM is currently involved in the Sungai Rasau Water Supply Scheme Stage 1 and the EPCC contract of the Ulu Padas Hydroelectric project. These projects have a cumulative value of at least RM6 billion.

All in, we envisage Gamuda as an emerging key water infrastructure player in Malaysia – putting it in a strategic position to clinch other water-related projects. Some of the projects include the Selangor state government's proposal to build an the Selangor state government's proposal to build an underground tunnel system to manage rain overflow from Kuala Lumpur to prevent flooding (estimated at RM6 billion) and Stage 2 of Sungai Rasau Water Supply Scheme (estimated at RM2 billion).
Gamuda's earnings are underpinned by construction orders

and property sales.



Steel Hawk, via its subsidiaries has three core business segments, namely: i) EPCC services for chemical injection skids and facilities improvement/maintenance of topside O&G facilities: ii) installation & maintenance of oilfield equipment; and iii) supply of oilfield equipment. EPCC services was its largest segment in 9M24, representing 83.1% to its revenue, followed by installation & maintenance (12.4%) and supply of oilfield eauipment (4.6%).

While we had indicated that there could be possible reduction to Petronas' capex which could affect OGSE companies, in the PAO report released on Jan 28, 2025, the downstream onshore, plant turnaround is expected to see more activities. This would imply that Steel Hawk could benefit from this. On Nov 12, 2024, Steel Hawk was appointed as a panel contractor by Petronas in providing construction & modification works (CWM) as and when required for 5 packages across key regions in Malaysia for 3+1+1 years. These packages entail 27 of Petronas's Downstream Operating Plant Units. This may be Steel Hawk's biggest job win since its inception and the group should be recognising meaningful contributions from this major development beginning Q1'25 onwards. – *Maybank* Investment Bank, Feb 6

While the current hot streak may calm down in the coming months, experts and industry insiders expect volatility will remain the watchword, giving little visibility for producers — two-thirds of whom farm parcels of less than one hectare.

Meteoric riseThe price of arabica beans listed in New York surged by 90% last year, smashing on Dec 10, 2024 a record dating from 1977 — US\$3.48 (RM15.40) per pound. Robusta prices have seen similar growth, though prices are lower for the less premium coffee variety.

Fears of poor harvests after droughts in key producers Brazil and Vietnam, the biggest and second-biggest sources of the beans, respectively, fuelled the price hike.

Demand has outstripped supply for several years now, prompting a flurry of speculative buying that further drove up market prices.

"And then you have the disruption of the

Climate threats

Arabica beans, grown at higher altitudes, are at greater risk from climate change since only a few countries, notably Brazil, can move farms further uphill as the world gets hotter.

Robusta can thrive in a wider range of growing conditions but is less prized by consumers. In the 2024–2025 growing season, around 175 million bags are expected to be produced (56% arabica and 44% robusta),

Small producers, big processors

Despite the recent price surge, millions of growers cultivating coffee on small farms still

live in poverty in developing countries.

They have little leeway to set prices in a global commodity market dominated by a handful of multinational processors and distributors

Even fair trade programmes to guarantee a living wage affect just 5% of the market — 80% of the world's coffee is bought by heavyweight brokerage firms.

Experts said wild price shifts in recent years make ensuring better prices for growers, many of whom are in developing countries, even more urgent.

A sharp drop in prices could lead growers to abandon their plants, jeopardising their future revenues, said French food cooperative Ethiquable representative Nicolas Eberhart.

In October 2024, the Group of Seven nations endorsed a Global Coffee Sustainability and Resilience Fund aimed at spurring private investments to improve productivity and get more money into growers'

YD'S presence in Malaysia is stronger than ever with multiple options in their lineup for buyers. From electric hatchbacks to sedans and SUVs, they have it all.

Recently, Sime Motors, the official distributor of BYD vehicles in Malaysia, marked a milestone by expanding its comprehensive aftersales network to 21 service centres nationwide.

BYD announced a surge in sales for 2024, reflecting its growing dominance in both domestic and international markets. The company reported a 41.3% year-on-year increase, selling 4,272,145 vehicles compared to 3,024,417 units in 2023.

The LED headlights, daytime running lights


The LED headlights, daytime running lights and LED tail lights enhance its appearance and are meticulously designed with intricate details that come alive at night.

The Seal Performance and the Tesla Model 3 share similar dimensions, but with some notable differences.

Measuring 4,800mm in length with a 2,920mm wheelbase, the Seal Performance is 80mm longer and has a 45mm longer wheelbase than the Tesla Model 3, which measures 4,720mm in length with a 2,875mm wheelbase.

This slightly larger footprint contributes to better rear legroom in the Seal. In terms of cargo capacity, the Seal offers a 400-litre boot and a 50-litre frunk, while the Tesla Model 3 provides a slightly larger 425-litre boot and a more spacious 88-litre frunk.

Although the Seal's narrow boot opening might pose challenges for loading bulkier items, it still offers a practical amount of storage.

Interior: A tech sanctuary

Inside, the Seal Performance exudes luxury and innovation. The cabin is wrapped in premium leather, with ventilated and heated seats ensuring comfort in all conditions.

The centrepiece is the 15.6-inch rotating touchscreen, which adds a futuristic flair to the infotainment system.

Whether in portrait or landscape mode, the display is crisp and responsive, offering seamless access to navigation, entertainment, and vehicle settings.

10.25-inch digital instrument cluster provides all essential driving information at a glance, while a 12-speaker Dynaudio sound system delivers crystal-clear audio.

Dual-zone climate control with a PM2.5 air filtration system ensures a fresh and comfortable environment.

However, the climate controls are rather annoying as they can only be accessed through the touchscreen which is an inconvenience. Simple things such as knobs and vent controls

should just be left the traditional way.
On the plus side, there are physical buttons for your preferred drive mode and volume control and the crystal gear shifter adds a touch of finesse



It also comes with wireless charging pads along with wired Apple CarPlay and wireless Android Auto connectivity which is easy to connect to so there are no complications for the less tech-savvy users.

The panoramic roof has UV-resistant glass and does a commendable job of keeping the cabin cool. We were driving around Sepang under the noon sun and did not really feel the heat.

Performance: Unleashing electrified furv

At the core of the BYD Seal Performance lies its dual-motor, all-wheel-drive system, which generates an impressive 523hp and 670Nm of

This setup shoots the car from 0 to 100kph in a mere 3.8 seconds, a figure that rivals some of the most iconic performance cars on the

The instant torque delivery from the electric otors ensures that every press of the







accelerator is met with a surge of adrenaline, making overtaking and highway merging an absolute breeze. Despite its substantial 2,185kg weight, the Seal Performance feels remarkably

The suspension is finely tuned to balance comfort and dynamic handling, allowing the car to glide over imperfections while remaining

composed during spirited driving.

However, the regenerative braking system, while efficient, lacks the immediate feedback of traditional setups, requiring a slight adjustment in driving style.

However, there is an issue about the "Performance" variant that bugs me; a 180kph electronic speed limiter. Yes, we know it is to preserve the battery life but shouldn't a

performance variant have a higher speed limit?
This was a little frustrating as we were being overtaken by other cars which do not cost as much as the Seal Performace.

Range and charging: Power without compromise

Equipped with an 82.5 kWh BYD Blade battery, the Seal Performance offers a 520km WLTP-rated range, ensuring that it's exhilarating performance doesn't come at the cost of practicality.

Charging is equally impressive. A 7kW AC charger fully replenishes the battery in 15.2 hours, while a 150 kW DC fast charger can take the battery from 10% to 80% in just 37 minutes, making long-distance travel a stress-free affair.

We travelled from Bamboo Hills KL to Putrajaya then to Sepang where we did at least eight rounds of a gymkhana challenge, then headed back to Bamboo Hills, all this with one charge! We still had 14% of battery remaining, which to me, is quite impressive

Safety: Confidence on the road

The Seal Performance is packed with

advanced safety features, including nine airbags for comprehensive protection and a suite of driver-assistance systems such as adaptive cruise control, automatic emergency braking, and lane-keeping assist. A 360° camera provides a bird's-eye view for easier manoeuvring.

These features are not as sensitive as other EVs out there, so it does not "take over" your steering wheel but rather helps you keep your car in the lane. If you feel like a certain feature is not what

you need, you can simply turn it off through the touchscreen.
Priced at RM203,300, the BYD Seal

Performance AWD is a game-changer in the premium EV segment.

It combines jaw-dropping acceleration, a luxurious interior, and a design that's both striking and functional.

While there are minor drawbacks, this is an exceptional package. For those seeking an electric vehicle that delivers heart-pounding performance without sacrificing everyday usability, the BYD Seal Performance is a compelling choice. It's not just a car – it's a statement

FALIAN qualifier Mattia Bellucci stunned former world No. 1 Daniil Medvedev in three tough sets yesterday to reach the Rotterdam ATP quarterfinals.

The 23-year-old left-hander, playing on a career-high ranking of 92, came through 6-3, 6-7

(6-8), 6-3 to record a first win over a top 10

"It was a three-hour match and I really enjoyed every moment of it. I really tried to do the best I could. I'm pretty tired but I'm happy," said Bellucci.

"I was going for the serve and volley which is not something I'm used to doing but it worked pretty good today."

Bellucci sprung a surprise on Medvedev by winning the first set and it did not take long for tensions to flare up during the closely-fought encounter.

Serving to draw level at five games each in the second set, Bellucci was put on the back foot when Medvedev rushed to the net in a bid to



NOVAK DJOKOVIC has been told that he "should have hit his opponent" during a controversial incident at the 2020 US Open.

The world No. 6 was famously defaulted from the tournament when he swiped a ball away in frustration and unintentionally struck a lineswoman.

The episode has been dragged up in

recent days after an altercation between Zizou Bergs and Cristian Garin at the Davis Cup, which saw Garin and Chile disqualified after Bergs barged into him.

There was drama at the Davis Cup over the weekend as Belgium faced Chile in a qualifier tie.

When Bergs broke to serve for the match against Garin, he charged past the net to head to his bench in celebration but floored his opponent in the process.

Garin was knocked down by Bergs and refused to continue playing, calling on the umpire to disqualify his opponent. The Belgian only received a code violation, and Garin continued to protest the official's call. Garin received a warning for his tirade

but carried on. He received a point penalty and a game penalty, which gave Bergs a 6-3, 4-6, 7-5 victory and meant the tie went to

The incident has sparked debate in the tennis world, with many drawing similarities to Djokovic's controversial altercation at the US Ópen more than four years ago.

During a fourth-round match in 2020 Djokovic grew annoyed after going a break down to Pablo Carreno Busta. He slammed a ball towards the back of the court but it struck a lineswoman and he was defaulted on the spot.

Former world No. 1 Andy Roddick has now suggested that Djokovic wouldn't have been disqualified if he hit his opponent instead.

"I will say, had Bergs done it to an umpire, he'd have been gone. But apparently you can do it to another player and it's fine," the American said on his Served podcast, discussing the Davis Cup debacle.

Co-presenter Jon Wertheim added: "If Novak Djokovic taps a ball and it happens to hit a lineswoman and he says, 'listen, I didn't intend anything. It doesn't really matter what his intent is."

Roddick replied: "Yeah, he should've just hit the opponent.

The 2003 US Open champion isn't the only player who believes there is a grey area around the disqualification rules. Former world No. 16 Nikoloz Basilashvili recently suggested that Djokovic would have received a harsher punishment in Bergs'

"If Novak had done this, he would have been disqualified for life. WTF," he wrote on social media. – Express Newspapers

THE WM Phoenix Open doesn't hold "signature event" status on the PGA Tour these days, but the event that dubs itself "The People's Open" is more populist than exclusive anyway.

Besides, tour stars don't need added monetary incentive to be persuaded to come to TPC Scottsdale.

Twenty-nine of the top 50 in the world rankings, including World No. 1 Scottie Scheffler and fan favourite Justin Thomas, will be on hand for this week's PGA Tour stop that begins today in Scottsdale Arizona

Scottsdale, Arizona.
Famed for its raucous crowds and the par-3
16th Stadium Hole, TPC Scottsdale is a favourite
stop for many on tour thanks to its character.

"I can't believe this is the 11th time I've played in the tournament. I didn't know that was possible," cracked Thomas, 31.

"It's fun, the couple times being able to get myself in contention on Sunday and play in those last couple groups. The energy is very high. Yeah, it's a place that I look forward to coming every year."

Canada's Nick Taylor won on the second hole of a playoff against Charley Hoffman last year. Before that, Scheffler had gone back-to-back in

2022 and 2023.

The field also features Japan's Hideki Matsuyama, who went back-to-back at the Phoenix Open in 2016 and 2017 and kicked off the 2025 season with a victory at The Sentry.

Former US Open champion Wyndham Clark and up-and-comers Sahith Theegala and Tom Kim of South Korea are others to watch. The most intriguing storyline of the week may

The most intriguing storyline of the week may have nothing to do with beer-soaked fans or the names at the top of the leaderboard.

Florida State golfer Luke Clanton is one point away from earning full tour status via the PGA Tour University accelerated pathway.

If he makes the cut at the Phoenix Open, where he's playing on a sponsor exemption, he'd reach 20 points and would qualify for his tour card.

Clanton has already made eight cuts on tour, seven last year.

"It's been a lot of preparation over the last

"It's been a lot of preparation over the last couple months for this," Clanton said. "It's been amazing.

"Every single PGA Tour event you play you've got a lot of people watching you, and you just kind of have to stay in your zone and do what you need to do."—Field Level Media

US Open first major to create LIV exemption

THE USGA has created an exemption category for LIV Golf players to compete in the US Open, making the tournament the first of golf's four majors to introduce a formal pathway for golfers on the Saudibacked circuit, it said yesterday.

One spot in the 156-player field for the June 12-15 US Open in Oakmont, Pennsylvania will be awarded to a golfer who is not otherwise exempt and in the top three of the LIV Golf Individual Standings as of May 19.

The access will increase to two players for next year's US Open at Shinnecock Hills in Southampton, New York, with leading LIV Golf players from the final 2025 individual standings and the May 18, 2026 list gaining entry.

In both cases, the spots are for players not already exempt and among the top three in the standings.

"The USGA continues to evaluate the pathways that exist to ensure those playing their best have the opportunity to compete in our national championship," said John Bodenhamer, USGA chief championships officer

"Consistent with our historical approach, we continuously evaluate talent levels on professional tours and in amateur events, which has led us to add a new exemption category."

category."

While LIV Golf players had been eligible to play in golf's majors, there had previously been no direct pathway for them into the blue-riband events, which meant qualification was more difficult for those without previously existing exemptions.

But last June the USGA said it would consider creating a direct route into the US Open for well-performing LIV Golf players in a bid to ensure the world's best players compete against each other.

The announcement yesterday was applauded by LIV Golf.

"Every golf fan in the world longs to see the greatest players in the world competing on golf's biggest stages at the majors," LIV Golf CEO Scott O'Neil said in a statement.

"LIV Golf is committed to working hand in hand with golf's governing bodies to elevate the sport in all corners of the world." – Reuters

Time flies when he's having fun

ORLD NO. 1 Scottie Scheffler acknowledges the passage of time can play tricks on the mind, like this week's return to Scottsdale, Arizona, for the WM Phoenix Open.

Scheffler has won this tournament twice, including his first PGA Tour victory in February 2022.

birth of his son.


"I can't really remember a lot of what life was like before Bennett came, and it feels like he's been with us for forever, but he's only 9 months old." Scheffler said.
