## M'sia must boost readiness amid economic uncertainty

### Anwar urges vigilance as US market nosedives while tariffs pose risks to trade and livelihoods

PUTRAJAYA: Malaysia needs to enhance its preparedness in the face of global economic uncertainties, including the US market crash which has led to trillions in losses, said Prime Minister Datuk Seri Anwar Ibrahim.

He noted that while the country's eco-nomic fundamentals remain solid with encouraging figures, unexpected develop-ments - particularly tariff issues and trade

ties with the US - demand urgent attention.
"Our export value to the US is significant. Semiconductor exports alone may reach US\$100 billion, accounting for 65% of the country's total semiconductor production. Trade and investment ties with the US remain among the highest," he said during a staff meeting at the Prime Minister's Department yesterday.

We must therefore consider all possibilities. We do not want any economic policy that ultimately harms the people, affects jobs or impacts livelihoods," he added.

Anwar said a meeting will be held tomorrow, coordinated by Investment, Trade and Industry Minister Tengku Datuk Seri Zafrul Tengku Abdul Aziz, together with Asean counterparts to align their positions on the US tariff issue.

On April 2, US President Donald Trump announced new tariffs impacting Asean nations, including a 10% base rate effective April 5 and an additional "reciprocal tariff"

starting tomorrow, Bernama reported.

Among the hardest hit were Cambodia with 49%, Laos with 48%, Vietnam with 46% and Myanmar with 44%, while Thailand recorded 36%, Indonesia 32%, Brunei and Malaysia 24% each, the Philippines 17% and Singapore 10%.

Anwar also underlined the need for the entire government machinery to improve efficiency, uphold work ethics and practise prudent spending to navigate current economic challenges.

"The decline in the stock market, commodities and trade in the US is among the worst in recent history. Reports indicate losses of up to US\$4 trillion in the markets. This certainly affects their decisions and we hope it can be negotiated more constructively," he said.

He also reminded civil service leaders not to take the government's reform agenda

lightly.

"There are still reports of negligence, and abuse of power. leakages, corruption and abuse of power. Department and ministry heads must remain vigilant as our mission is to strengthen the nation and ensure Malaysia

continues to grow in stature."

Also present were ministers in the Prime Minister's Department Datuk Seri Azalina Othman Said (Law and Institutional Reform) and Datuk Mohd Naim Mokhtar (Religious Affairs), as well as Chief Secretary to the Government Tan Sri Shamsul Azri Abu Bakar and Public Service Department director-general Tan Sri Wan Ahmad Dahlan Abdul Aziz.

## Asean must form united stance on tariffs: Anwar

**PUTRAJAYA:** Malaysia and other Asean countries must come together to form a united stance on the tariffs recently announced by the US to ensure upcoming negotiations rest on a solid foundation, said Prime Minister Datuk

Seri Anwar Ibrahim.

He noted that although the announcement by US President Donald Trump was made on questionable grounds. Asean should not take the matter lightly, especially amid a volatile global economic and political climate.

"Yesterday, I elaborated at length on the decision made by the special committee handling the US tariffs, which was attended by the entire Cabinet.

"We cannot take this lightly. It is quite unusual as the country that once championed free trade and helped establish the World Trade Organisation and the General Agreement on Tariffs and Trade – wealthy nations such as the US - is now taking a different approach.

"This is what I mean by 'post-normal times',

when political and economic policies are implemented unexpectedly, including tariff decisions based on very weak grounds," he said during a staff meeting at the Prime Minister's Department yesterday.
Deputy prime ministers Datuk Seri Ahmad

Zahid Hamidi and Datuk Seri Fadillah Yusof were also present.

Anwar described the method used by the US administration to determine the tariffs as flawed, noting that some remote islands were included, "even though they are only inhabited by penguins".

Nevertheless, he said the Malaysian government has opted for a moderate approach as there is still room for discussion and negotiation, and certain exceptions must be identified in detail.

"My task, along with the Foreign Ministry and relevant ministers, is to contact our friends in Asean so each country can state its position but at the same time, we move forward as a

"We must stand firm together as Asean, with a population of 640 million and an economic strength among the top globally. This region is also considered one of the safest

and fastest-growing in the world," he said. Anwar added that he had the opportunity to discuss the matter with Indonesian President Prabowo Subianto during a Hari Raya Aidilfitri gathering, where they also touched on issues concerning Gaza and Myanmar.

"I also had a lengthy discussion with the Vietnamese prime minister and, before that, contacted the leaders of the Philippines, Brunei, Laos and Thailand to coordinate our

"With this approach, we want Asean to present a unified front - demonstrating agreement and building a stronger foundation for future negotiations," he said.

On April 2, Trump announced a series of new tariffs targeting several Asean nations, significantly raising import duties on key utheast Ásian trading partners. – Bernama

## 'Prevent exploitation by tackling issues effectively

PUTRAJAYA: Prime Minister Datuk Seri Anwar Ibrahim has reminded all parties, including civil servants, to address national issues effectively to prevent them from being exploited irresponsible individuals.

He emphasised that ongoing matters must be handled properly and warned against sensationalising issues raised on social media for personal or political gain.

"We are sometimes dragged into issues, especially those circulating on social media or the media, which thrive on sensationalism. As a result, small matters that could be resolved calmly are blown out of proportion.

"It's as if war is about to break out - the temple issue, the balloon (seller) issue - when, in fact, these can be managed with care. That's why I suggest we should not leave room for exploitation," he said during the monthly staff assembly at the Prime Minister's Department yesterday

Anwar stressed that certain individuals continue to exploit sensitive matters without considering the public interest, often politicising

issues unnecessarily.
"Some people act without thinking. They disregard the public interest. For them, everything must be politicised and punished," he

Referring to the recent relocation of the Sri Pathrakaliamman Temple in the capital, Anwar

ratinakaliaminah temple in the Capital, Anwai said the Madani government had resolved the issue peacefully and respectfully, showing consideration for all communities.
"Our country is diverse, with people of various races and religions. Islam is the religion of the Federation and its strength is undisputed. Our decisions must be grounded in clear Our decisions must be grounded in clear principles," he added.

The temple dispute near Jalan Masjid India Kuala Lumpur, was resolved when the temple management agreed to relocate to a new site.

Anwar also reminded all ministries and government departments to remain vigilant on issues involving integrity, corruption and abuse

of power.
"Don't take it lightly or ignore it. There are still reports of negligence, leakages and corruption. That is why leadership across departments and ministries must remain alert. We aim to protect the people and elevate the nation," he said.

He assured that the *Madani* government remains committed to leading the country effectively and restoring Malaysia's standing

## PM, minister to discuss ways to help home owners

**KUALA LUMPUR:** Housing and Local Government Minister Nga Kor Ming will meet Prime Minister Datuk Seri Anwar Ibrahim today to discuss the best formula to help homeowners affected by the fire tragedy in Putra Heights.

"An announcement will be made when

the matter has been decided," he told a press conference after delivering a keynote address at the 14th Affordable Housing

Project Conference yesterday.

Commenting on his absence at the incident site and relief centre, which had drawn criticism from certain quarters. Nga said such remarks did not warrant attention as his priority was to ensure comprehensive

assistance for those affected.
"We don't need to entertain such criticisms. What truly matters is resolving the issues faced by the people. To date we can see that all ministries have mobilised aid to support the victims.

"DAP has raised funds and given 100% to them. Everyone is helping. I am focused on providing a total solution." – Bernama

## 109 developers blacklisted for non-compliance

KUALA LUMPUR: The Housing and Local Government Ministry has blacklisted 109 property developers for failing to comply with the set regulations, said minister Nga Kor Ming.

He said the move is part of the ministry continuous effort to protect the interest of home buyers.

"The move sends a clear message that we

will not tolerate non-compliance. We are taking strict measures to protect the hard-earned money of home buyers and ensure they receive the homes they rightfully deserve.

"The safety of house buyers remains one of the ministry's top priorities. Developers must adhere to the regulations to ensure that the projects are completed on time and meet the required standards."

He spoke to reporters vesterday after his keynote address at the 14th Annual Affordable Housing Projects Conference.

Nga said the offences committed by errant developers included failing to submit to authorities their development status and audit reports, balance sheets, and profit and loss statements.

He warned that blacklisted developers are not eligible to apply for new licences until they settle the outstanding fines.

Nga also advised home buyers to check

developers' licence status at teduh.kpkt.gov.my before making financial purchase properties.

## Local authority ordered to check project said to be near gas pipeline

**SEREMBAN:** The Seremban City Council has been instructed to look into a video circulating on social media about a new housing project allegedly being built near a gas pipeline in Sendayan.

Arul said the city council was told to check whether the construction had encroached on reserve land.

"I have informed the city council and developer to review the project site. There is a Gas Malaysia pipeline signage at the location, indicating

that it is a connection pipe to the

## S'gor govt grants RM7 million rental aid to affected residents

SHAH ALAM: The Selango government has allocated RM7.35 million for six months of rental assistance to 613 households affected by the gas pipeline explosion in Putra

Selangor Menteri Besar Datuk Seri Amirudin Shari announced that each household will receive RM2,000 per month to help ease the financial bur-den caused by the tragic incident.

"The decision for rental assistance, instead of temporary shelters, was made to give affected families the flexibility to choose where they wish to live," he told a press conference at the state secretariat office yesterday.

"Initially, we considered offering temporary housing, but some families expressed concerns that the locations

were too far."

The Gombak MP said the affected residents could opt to rent Airbnb units near Putra Heights, with the company offering two months of free rental to further ease their burden.
The 613 displaced households will

also receive financial aid backed by the federal and Selangor governments, and Petronas

Amirudin confirmed that the final list of home owners, including room

renters residing in damaged units, was verified by the state government on Sunday.

"For home owners whose properties were completely destroyed, Petronas will provide RM5,000, which will be dis-tributed by the state government. Additionally, another RM5,000 will come from the federal government, bringing the total compensation to RM10,000.

"For partially damaged properties,

including tenant-occupied units, RM5,000 will be provided - RM2,500 from Petronas and RM2,500 from the federal government.

Amirudin said the estimated total damage to residences affected by the blaze is RM65.4 million. He said inspections were carried out on 437 homes, which were classified as either completely destroyed, partially damaged, or affected but not burnt.

He added among them, 81

homes were completely destroyed with structural damage exceeding 40%, 81 were partially damaged and 57 were affected but not burnt, while

218 houses were not affected.

Amirudin praised enforcement agencies for their swift response in containing the blaze, estimating that their actions helped save RM285.9 million worth of assets and proper-

ties.
"The evaluation of destruction affecting public infrastructure and surrounding areas is still ongoing."

The inspection radius has been

extended from 290 square metres to 325 square metres to ensure a thor-

ough assessment.
"To date, 151 houses have been declared safe, allowing owners and residents to return home. However, some homes may have minor damage, and owners will need to bear the cost of repairs."

Amirudin also addressed con-cerns about students affected by the disaster, revealing that only 20% of affected students in the morning session attended school yesterday, despite transport services despite transport services being provided.

The gas pipeline explosion on

April 1 sent flames over 30 metres high, with temperatures soaring to 1,000 degrees Celsius, severely damaging homes and infrastruc-

A total of 1,254 people were affected. The explosion also left a massive crater measuring 9.8 metres deep and 21-by-24 metres wide.

## Electricity supply unaffected by gas explosion

**PETALING JAYA:** The Energy Commission has reassured the public that the electricity supply across Peninsular Malaysia remains unaffected following the gas pipeline tragedy.

In a statement vesterday, the commission said the incident had caused a disruption in gas supply to four major power stations in the Klang Valley, including the Connaught Bridge Power Station, Pulau Indah Power Station, Sultan Salahuddin Abdul Aziz Power Station

(KEV) and Putrajaya Power Station. "Efforts to mitigate the impact of the disruption are already in place, including optimising the operation of existing power stations and preparing standby power stations to continuity in electricity

commission is closely monitoring the situation and will

engage with affected users to address their concerns while emphasising the importance of energy conservation during this period," read the statement.

It also stated that the commission is working with several entities, such as the Grid System Operator, Single Buyer, Gas Malaysia Berhad, independent power producers, Petronas and TNB Fuel Sdn Bhd, to monitor the gas and electricity supply situation in Peninsular Malaysia.

This includes assessing the impact of the gas supply disruption, mitigation measures, interim plans and considering various scenarios

until normalcy is restored.

"The gas supply in Peninsular Malaysia has been disrupted in several areas in the central zone, including Shah Alam, Klang, Serdang, Puchong, Batu Tiga and Kapar, and several areas in the northern zone.

"Affected users have started receiving notices of restrictions from their respective suppliers, effective until April 20," it said.

The commission also said the gas supply is available in limited quantities, with priority given to critical services, such as hospitals and electricity generation, as well as measures to stabilise the gas pipeline pressure.

"It will hold sessions with affected users soon. We urge all users to prioritise safety and practise energy conservation to collectively manage the impact for the wellbeing of everyone," the statement added.



## 'Not many blast victims traumatised'

Daily counselling sessions for 253 reveal less than 1% seriously affected by Putra Heights disaster: Minister

**KUALA LUMPUR:** A total of 253 victims of the gas pipeline fire in Putra Heights, Subang Jaya here last week, have received counselling assistance at the One-Stop Social Support Centre set up at the temporary relief centre.

Women, Family and Community Development Minister Datuk Seri Nancy Shukri said reports from the daily counselling sessions conducted by 10 counsellors found that only a small number of the victims experienced seri-

'Not that many victims suffered serious trauma. In terms of percentage, it is probably less than one per cent.

"Most of these victims just want to leave the relief centre, and have someone to talk and share their problems with. The counselling session not only provide emotional support,"

She said among the urgent items needed were mobile phones, air purifiers for autistic children, nursing bras for mothers, balms or ointments for headaches, and disposable dia-

Foundation," she added.

## Ordeal fails to dampen schoolchildren's spirit

**KUALA LUMPUR:** The fire and gas pipeline explosion in Putra Heights that shocked the nation last Tuesday has not dampened the spirits of the affected school-going children as they resumed the school session following the Aidilfitri holidays.

Fifteen-year-old Alysya Hanni Shahir was up as early as 6am to get ready for school, expressing excitement to return to class despite currently staying at the relief centre at the Putra Heights Mosque since the incident occurred

"I'm happy because I get to go back to school. Not everything at our house was destroyed, but I can't go home yet to get my

clothes.

"My house is now a restricted zone, so I can't retrieve anything. But it's okay, even without a uniform, I can still attend school," she said with a smile

Sharing her enthusiasm is 16-year-old Mohd Aidil Ashraf Mohd Nizam, who looked forward to returning to school, especially with transport

"I'm excited to go to school. Luckily I have sports clothes to wear to school," said the

Sekolah Menengah Kebangsaan (SMK) USJ 8

Meanwhile, Haslina Nordin, 39, a mother of three, expressed sorrow over how the explosion has upended her family's daily

"I never imagined something like this would happen. I'm usually the one who sends my children to school, and I pass through that area where the fire happens every single day. Sometimes, I go through there five or six times

"But today, my children went to school in a van. That's what breaks my heart," she said at the relief centre at the Putra Heights Mosque.

To transport 76 students affected by the gas pipeline fire, five Rapid KL On-Demand vans have been mobilised from two temporary relief centres to 19 schools around the Subang Jaya

Of the total, 42 are primary school pupils,

and 34 are secondary school students.

Rapid Bus Head of Central Region Khairul
Azhar Hamidulah told Bernama yesterday
morning that the company had made early
arrangements with the district education office

and local authorities to ensure a smooth student transportation process.

"Of that number, 60 are in the morning session, while16 are in the afternoon session,"

The initiative is a collaborative effort of Yayasan Islam Darul Ehsan, the Petaling Perdana education office, the Social Welfare

Department and Prasarana Malaysia Berhad.
Meanwhile, the foundation's general
manager Nur Mohd Razali Abdullah said the transport assistance will be provided for two weeks, depending on the needs and current

He said the vans would transport students within a 7km radius to and from their schools and the relief centres.

"We remain committed to ensuring the welfare of affected students. All forms of assistance will be provided in stages to ensure that they can continue their schooling comfortably."

He said the foundation, a Selangor Islamic Religious Council subsidiary, distributed supplies, including uniforms, bags, shoes, and stationery, to 194 displaced students on Friday.

## Recovery efforts ongoing at 'around zero'

KUALA LUMPUR: Restoration efforts are underway in the area devastated by last week's gas pipeline fire and explosion in Putra Heights, Subang Jaya,

with continued support pouring in for the victims.

Work to drain stagnant water from the crater at the incident site – known as 'ground zero' – continued yesterday following rainfall over the past few days.

Subang Jaya district police chief ACP Wan Azlan Wan Mamat said the water level at the site rose slightly due to overnight rain. Fire and Rescue Department director-general Datuk Nor Hisham Mohammad said two water

pump trucks are on standby at the scene to remove stagnant water if needed.

As of 11am yesterday, 374 victims from 98 families remained in the relief centre at the Putra Heights Mosque.

The Petronas gas pipeline inferno that occurred at 8.10am last Tuesday produced flames over 30m high with temperatures reaching 1,000 degrees Celsius and took nearly eight hours to be extinguished.

According to the latest data, 218 of the 437 homes assessed have been declared safe while 219 sustained varying levels of damage.

The Health Ministry said 38 of the 146 injured are still receiving treatment – 18 at government hospitals and 20 at private facilities. No fatalities have been reported. – Bernama

## Adaptation plan ready by next year

**KUALA LUMPUR:** Malaysia aims to complete its National Adaptation Plan (MyNap) by next focusing on both mitigation and adaptation strategies.

## **Textile waste poses serious** threat to environment

Some fibres take up to 200 years to decompose and release greenhouse gas that accelerates climate change: Academic

PETALING JAYA: Malaysia produces an alarming 195,300 tonnes of textile waste each year, much of which ends up in landfills.

year, much of which ends up in landfills.

Experts have warned that this growing issue accelerates climate change and environmental pollution as synthetic fabrics may take decades to decompose.

Universiti Teknologi Mara Textile and Apparel Programme School of Industrial Technology senior lecturer Dr Najua Tulos explained that textile waste contributes to environmental pollution, with the decomposition time of textiles in decomposition time of textiles in landfills varying up to 200 years depending on the material composition and environmental conditions.

"Common textile fibres, such as cotton (natural fibre), may take between three months and five years to decompose. Synthetic fibre, such as polyester, which is derived from petroleum, is notably resistant to decomposition, taking between 20 and 200 years to break down in landfill environments.

"Factors such as moisture, temperature and oxygen levels affect the process

of decomposition."

She said decomposing synthetic textiles release methane, a greenhouse gas that accelerates climate change.

She added that textile waste contains

harmful chemicals, including dyes, heavy metals and microplastics.

metals and microplastics.

"When discarded clothing decomposes, the chemicals leach into the soil and groundwater, affecting agriculture and drinking water sources. For instance, the Klang River has been found to have high levels of industrial pollutants, some of which originate from textile and garment factories.

"Many clothes today are made from synthetic fibres, such as nylon and acrylic, which shed microplastics when washed. In Malaysia, rivers such as the Gombak River

Malaysia, rivers such as the Gombak River and the Klang River transport these microplastics to the ocean, harming

some textile waste is openly burned, releasing toxic gases that worsen air pollution.

This is a common issue at illegal dumpsites in Kuala Lumpur and Johor, where waste is burned to reduce volume.

She also said Malaysia imports large amounts of cheap fast fashion, with many

garments discarded after only a few uses.
"Textile production has a huge environmental impact. Making one cotton t-shirt requires 2,700 litres of water, which is the same amount a person drinks in 2.5 years. The demand for new clothes also contributes to deforestation, water shortages and

pollution from garment factories."

She stressed that a circular economy is key to managing textile waste in Malaysia as recycling, reusing and upcycling textiles, along with supporting sustainable fashion and secondhand markets, could cut waste, reduce environmental harm and promote a greener future.

With government support and consumer participation, a circular fashion economy could become a reality, benefitting the environment and the economy, she added.

"Raising awareness on sustainable consumption is essential. Thrifting and upcycling help shift consumer mindsets from

fast fashion to conscious consumption. People become more aware of the impact of

reopie become indee aware of the impact of their purchasing decisions, leading to more responsible shopping habits." Najua said Malaysia should adopt a combination of regulations, incentives and awareness programmes to address textile

awareness programmes to address textule waste effectively.

She said implementing Extended Producer Responsibility would require fashion brands to manage the disposal of their products by collecting, recycling or upcycling used textiles, similar to the European Union model in which companies fund waste collection and recycling programmes.

"Nationwide textile recycling centres

should be established by installing collection bins in public areas, malls and residential zones while improving infrastructure for

zones while improving infrastructure for sorting and repurposing textiles.

"Introducing a fast fashion tax on retailers would discourage overproduction and overconsumption, with the revenue funding recycling programmes and sustainability initiatives, as seen in France."

She encouraged a nationwide "Repair, Reuse and Thrift" campaign to educate Malaysians on the environmental impact of textile waste and promote sustainable habits.

## Grasp on Islamic inheritance law vital

Several mechanisms can be planned in advance, such as wills, gifts and trusteeship: Lecturer

KUALA LUMPUR: A lack of awareness on Islamic inheritance laws is often cited as a primary reason for mismanagement of inheritance among Muslims in Malaysia.

The oversight frequently leads to disputes among heirs, with some cases escalating to court proceedings or causing irreparable damage to family relationships.

Universiti Sains Islam Malaysia Faculty of

Syariah and Law senior lecturer Zahari Mahad Musa said inheritance management is a fundamental process should understand. that all Muslims

"Assets, whether movable properties, such as vehicles, furniture and gold, or immovable properties, such as land, that hold value under Islamic law during one's lifetime and remain in one's possession upon death are classified as inheritance and must be distributed accordingly."

He said the failure of individuals or families to manage their assets before death is not only a loss but also complicates the process of inheri-

tance distribution for heirs.

"Perhaps we often see only immediate fam-

remaps we other see only infinite that almi-ity members receiving the inheritance because they are closest to the deceased. "However, understanding inheritance laws, including the principles of faraid (Islamic inheritance law), provides detailed guidance on eligible heirs entitled to a share after an individ-ual's passing"

ual's passing."

He pointed out that inheritance manage ment for individuals without children or those who are unmarried requires careful attention as

siblings are eligible to inherit in such cases. Zahari emphasised the importance of

Muslims acquiring knowledge of faraid to prevent conflicts and disputes within families. He said several mechanisms for distributing

inheritance can be planned in advance, such as wills (wasiat), gifts (hibah) and trusteeship (pemegang amanah).

He noted that the application of these

mechanisms, as recommended in Islam, depends on specific circumstances.

He also said appointing a trustee is a prudent step for Muslims to prevent inheritance disputes.

Through this mechanism, the asset owner appoints a trustee who will carry out their

responsibilities to fulfil the owner's wishes after their death.

"If surviving family members can manage the inheritance independently, no conflicts a likely to arise.

Zahari also recommended that Muslims document their assets and list their heirs to

facilitate inheritance management.

Assoc Prof Dr Adzidah Yaakob, also from Universiti Sains Islam Malaysia, said heirs can utilise the authority of the Syariah Court to resolve conflicts related to inheritance distri-

She noted that the Svariah Court has clear authority to resolve disputes over inheritance management based on Islamic law and the established principles of syariah.

"In cases of disputes over wills, the parties involved can apply to the Syariah Court to determine the validity of the will," she said, adding that a will only takes effect after the death of its author.

"Although verbal wills are permitted in Islam, it is recommended to make wills in written and clear form to serve as proof of the deceased's intentions," she added.

By leveraging the provisions of existing laws, justice can be achieved, resolving disputes

related to the deceased's inheritance.

She also emphasised the importance of Muslims gaining a deeper understanding of inheritance laws in the country, Bernama reported.

"The current laws are adequate to ensure fair management and distribution of inheritance. However, disputes and selfish behaviour often arise due to a lack of understanding of inheritance procedures or laws."

She said courses on inheritance law are offered by various organisations, including mosques and NGOs.

## Shaken and spooked

### Bangkok residents seek quake-proof homes

BANGKOK: Shaken hours earlier by a massive earthquake, Phatsakon Kaewkla's terror was magnified when he came home to find gaping cracks in the walls of his 22nd-floor Bangkok apartment.

Feeling unsafe in the building damaged by the biggest tremors to hit the capital in genera-tions, the 23-year-old Thai decided to stay away for two days until experts gave the highrise the all-clear.

The sales coordinator is now one of many Bangkok residents wondering if they should seek safer housing in a city where hundreds of residential buildings were damaged by the 7.7-magnitude quake that struck neighbouring Myanmar on March 28.

The owners of Phatsakon's condominium assured him that engineers had checked every part of the building and concluded it was hab-

But he is still spooked about the cracks. "I feel a little bit scared. And also my mum

told me to move out," he said.

Over 1,000km away from the epicentre, the

Thai capital - its skyline dotted with hundreds of towers and glinting high-rises - virtually never experiences such tremors.

Bangkok-based real estate consultant Owen Zhu, 40, said the impact on his sector

had been "significant".

"People seem to have realised that living in high-rise buildings might carry greater risks when it comes to earthquake resistance compared with two-storey or low-rise structures," the Chinese property expert said.

The earthquake prompted a flurry of enquiries from residents looking to relocate in the past week, he says, due to widespread "fear and anxiety" of living far above ground.

Yigit Buyukergun from Turkiye was at home in Bangkok with his wife when the quake struck. After it subsided, they emerged from under a table to inspect the damage on their 22nd-floor flat.

"Everywhere is cracked, especially in the corridor," the 25-year-old said.

Despite Buyukergun's safety concerns, the owners of the block seemed unfazed.

They say it is "100% safe, but I don't believe

A large number of studio apartments in Bangkok's sprawling residential projects are rented out on annual leases requiring a two-month deposit.

Most condos do not permit short-term

rentals for security reasons, and only hotels may lease for under 30 days.

Zhu says tenants and property owners often disagree over the habitability of quake-dam-aged apartments, with disputes becoming more common.

There is "a gap in perception and judgement between the two parties", he said.

"The landlord sees the unit as safe, while the tenant feels it's unsafe and insists on moving out and getting their deposit back.

ing out and getting their deposit back.

Earthquake safety standards for buildings in Thailand were "not particularly strict" before the disaster and not something property-seeking clients specifically asked about, Thu said

Heightening anxiety since the quake was the shocking total collapse of a 30-storey con-struction in Bangkok that trapped dozens of workers, most of whom remain unaccounted for over a week later.

City authorities are now investigating whether substandard building materials had been used in its construction.

Zhu says more of his clients are now opting for low-rises.

For house hunters still considering highrises, they often require that the property sustained "minimal or no damage during the recent earthquake, or at least was not severely

He believes property prices will grow in the long-term as demand for safer buildings drives the adoption of costly seismic resistance meas-ures, adding that "the bar for Thailand's real estate sector has been raised".

But for Buyukergun, talk of improving building regulations is not enough to calm his fears about the uncontrollable factors of geo-

logy.

While the prevalence of earthquakes in his home country of Turkey made him feel uneasy, he had not expected to feel the same

way about Thailand.
"Thailand is safe," he recalled thinking

"That's why I couldn't believe (the) earth-quake (happened)." - AFP

The State Department last week approved sale of F-16 fighter jets to the Philippines; though F-16 fighter jets to the Philippines, though Manila said the deal was "still in the negotiation phase". – AFP

## WIKIPEDIA OPERATOR APPEALS INDIAN COURT ORDER

NEW DELHI: The operator of online encyclopedia Wikipedia has challenged a court order to remove statements deemed court order to remove statements deemed defamatory from its page on a domestic news website. Last week's Delhi High Court ruling came after Indian news agency ANI sued the US platform last year, citing a Wikipedia description that it faced criticism for being a government "propaganda tool" and sought removal of such statements. Wikipedia's operator, Wikimedia, has sought an appeal before a larger panel of judges of the same court, said two sources, who sought anonymity as they are not authorised to speak to the media. Wikimedia did not respond to email messages to seek comment. The Wikimedia Foundation is the second major tech platform, following X, to become embroiled in Indian court battles over orders to take down content in recent years. X is separately contesting government orders to block some posts about Indian farmers' protests in 2021. – Reuters

SYDNEY: Australia's Liberal Party abandoned yesterday a plan to force government workers to return to the office full-time, as incumbent Labor gained in polls ahead of a incumbent Labor gained in polls ahead of a May 3 election. Working from home emerged as an election battleground last month after the Liberal Party said it would bar hundreds of thousands of government employees from doing so, in a bid to boost productivity. The policy was seized upon by Labor which claimed it would increase commuting costs in a campaign that has been dominated by cost of living concerns. "We've made a mistake in relation to the been dominated by Cost or Iving Concerns. "We've made a mistake in relation to the policy. We apologise for that. And we've dealt with it," said Liberal leader Peter Dutton. Prime Minister Anthony Albanese said: "Dutton wants to undermine work rights and in particular doesn't understand modern families." – Reuters

## Sara Duterte back home after month with father

**MANILA:** Impeached Philippine Vice-President Sara Duterte has returned home after nearly a month at her father's side in The Hague, where he is facing a charge of crimes against humanity, her communications team said

"My job here is done," she told reporters ahead of her departure, saying former Philippine president Rodrigo Duterte's legal team was now set and she had filed the "last document" needed at the International Criminal Court.

The vice-president said the family no longer intends to seek financial aid to pay for her father's defence. "If we need to (sell) things to support our financial needs, we will do that.

Rodrigo Duterte was arrested on March 11 and whisked away the same day to the Netherlands-based tribunal to face charges tied to his drug war, in which thousands of mostly poor men were killed.

Daughter Sara followed him to The Hague immediately after and had been coordinating his legal affairs and acting as his mouthpiece holding a number of press conferences outside the court building.

She landed at Manila's international airport

Sunday night, according communications team.

The vice-president returns as her family's PDP Laban party is lagging in polls ahead of May mid-term elections that will determine 12 Senate seats and thousands of smaller positions across the archipelago nation of 117

## **Boeing faces new civil trial**

### Litigation to last two weeks

**NEW YORK:** Boeing is poised to face a jury trial over the fatal 2019 crash of an Ethiopian Airlines 737 MAX plane, the first civil case related to the

disaster to reach court. The Chicago trial, expected to last two weeks, was to feature two plaintiffs who lost family members in

But one of the complaints was resolved in an out-of-court settlement late on Sunday, a judicial source told AFP, in line with most earlier litigants.

Barring another last-minute set-

tlement, the trial will begin with the selection of an eight-person jury.

"We have had some discussion

that may continue throughout the day and the ensuing days," Robert Clifford, who represents relatives of several crash victims, told the US District court on Wednesday at a

pre-trial hearing.

A deal could also be struck even while the trial is underway.

The Boeing plane crashed on March 10, 2019, just six minutes after takeoff from Addis Ababa on its way to Kenya, killing all 157 people on board.

Relatives of 155 of the victims had sued Boeing between April 2019 and March 2021 for wrongful death, negligence and other charges.

As of late last month, there were 18 complaints still open against Boeing, said a source familiar with the case.

Sunday's deal meant that a further

three cases had been settled since then, judicial sources said.

This week's Chicago litigation will

now examine only the case of

Canadian Darcy Belanger. Belanger, 46, who lived in Belanger, Colorado, was a founding member of environmental NGO, the Parvati Foundation, and also worked in construction. He had been visiting Nairobi for a UN conference.

US Judge Jorge Alonso has split the Boeing lawsuits into groups of five or six plaintiffs, annulling a potential trial if all the suits settle.

In November, the aviation giant reached a last-minute agreement with the family of a woman killed in the crash.

The Ethiopian Airlines disaster followed another fatal crash involv-ing a MAX plane – that of a Lion Air jet that crashed in Indonesia in October 2018, killing all 189 people on board.

plaintiffs have been confidential.

The US manufacturer has "accepted responsibility for the MAX" crashes publicly and in civil litigation because the design of the MCAS ... contributed to these events," a Boeing lawyer said during an October hearing.

The MCAS Characteristics Augmentation System) flight stabilising software was implicated in both the Ethiopian

Was implicated in both the Europhan Airlines and Lion Air crashes. The disasters led to congressional hearings, with irate lawmakers demanding answers, and to leadership shake-ups at the aviation company. The entire 737 MAX fleet was grounded for more than 20 months. Boeing later revised the MCAS

programme under scrutiny from the

Federal Aviation Administration, which ultimately cleared the jets to resume service in November 2020. The Chicago trial comes as Boeing

also faces a potential criminal trial in June in Texas over the MAX.

That trial follows on from a January 2021 deferred prosecution agreement between Boeing and the US Justice Department over the two MAX crashes.

In May 2024, the Justice Department notified the court that Boeing had violated terms of the accord. That came after a January 2024 incident in which an Alaska Airlines 737 MAX was forced to make an emergency landing when a panel blew out mid-flight.

US District Judge Reed O'Connor last month ordered a jury trial from June 23 after earlier throwing out a proposed settlement between Boeing and the Justice Department, - AFP

## Carney, Poilievre face off nationally and locally

**OTTAWA:** In a quaint restaurant on the outskirts of Canada's capital, Sandra McCormack spent a recent morning talking politics with friends in an area that is suddenly in the political

The area's neighbouring electoral districts – Carleton and Nepean – are starkly different: Carleton is largely rural, picturesque and dotted with small farms, while Nepean is a suburban Ottawa neighbourhood, packed with strip malls and single family homes.

But the districts have something in common ahead of Canada's April 28 election – one of

them will elect the next prime minister.
The Liberal Party leader, Prime Minister Mark Carney, is running in Nepean, while Conservative leader Pierre Poilievre is the

candidate for Carleton.
Poilievre has represented Carleton in parliament since 2004.

Over breakfast in Carleton's Manotick area, the 77-year-old McCormack recalled the first campaign of the Tory leader, known locally as just Pierre. "He looked like a 15-year-old," she said. Poilievre, now 45, became the Conservative

leader in 2022, after Canada's last election.

He built support through 2023 and 2024 attacking former prime minister Justin Trudeau and, at the start of this year, polls indicated he would lead the Tories back into power after a decade in opposition.

But Trudeau's departure in favour of Carney and the uncertainty gripping Canada brought on by President Donald Trump's trade war and annexation threats have upended the race.

Most polls give Carney a lead.
"We normally talk about hockey, but everybody's talking about politics nowadays because there's an important election going on," McCormack said.

A two-lane road divides Carleton from Carney's Nepean district. There are blue Poilievre signs on one side and red Carney placards on the other.

Carney, who replaced Trudeau on March 14,

has never served in parliament or held elected office. It wasn't clear which district Carney would contest until days before he called the

The 60-year-old spent the early part of his career in global financial capitals as an investment banker with Goldman Sachs. He then led the Bank of Canada and Bank of England.

But despite his scant local ties, voters said Carney's economic experience is attractive.

## **Unification Church** appeals Japan court ruling

TOKYO: The Unification Church said yesterday it had appealed a Japanese court's decision to strip the sect of official recognition, in the wake of the assassination of ex-premier Shinzo Abe.

The Tokyo District Court issued a

dissolution order last month for the Japanese chapter of the Unification Church, saying it had caused "unprecedented damage" society.

The church, which was founded in South Korea, is accused of pressuring members to

make large donations.

It has also been blamed for child neglect among its members, although it has denied

any wrongdoing.

Church official Tokushige Kondo told reporters that an appeal had been lodged yesterday with the Tokyo High Court.
The order "is not acceptable", he said.
Former prime minister Abe was shot dead

on the campaign trail in 2022, allegedly by a man who resented the Unification Church.

The alleged assassin is 44-year-old Tetsuya Yamagami whose family reportedly went bankrupt after his mother donated around ¥100 million (RM4.47 million at the time) to the sect.

Investigations after Abe's murder revealed close ties between the church and many conservative ruling-party lawmakers, leading to the resignation of four ministers.

The government sought permission from the courts in 2023 to have the group legally disbanded.

The court order, once enacted, will remove the church's tax-exempt status while branding the organisation a harmful entity, experts say.

However, the group, officially the Family Federation for World Peace and Unification, will still be able to continue religious practices.

Lawyers warn the church could transfer its financial assets elsewhere, partly due to a lack

of legislation to return money to victims.

The church rose to global prominence in the 1970s and 80s after its founding in 1954, becoming famous for mass weddings often held in stadiums.

Japan has long been a financial hub for the church, which has told members they must atone for the wartime occupation of Korea and sell expensive items to obtain forgiveness from sins. - AFP

### Hundredfold increase in chemicals found in UK harbours

increased by 100-fold in the waters of two south coast harbours which are

home to sites of special scientific interest, according to a new study.

Researchers from three universities have analysed the waters of Chichester and Langstone harbours and found 105 pharmaceuticals, peticides and illenal drugs including pesticides and illegal drugs, including

an insecticide used as flea treatment.

And the environmental scientists found that some of the chemicals increased by over 100-fold following rainy days which led to combined sewer overflows (CSOs) into the harbours which are on the border of Hampshire and West Sussex.

The team, made up of researchers from Brunel University, London, University of Portsmouth and Imperial College London, says that it is worried about the impact on the local wildlife in the area.

Dr Thomas Miller, from Brunel University, said: "CSO discharges were an obvious source of chemical pollution in these waters.

"Our study found that some chemicals increased by over 100-fold in water after these discharges, making them a high risk to aquatic wildlife'

The study, carried out with the help of the Clean Harbours Partnership and published in the

examined 339 water samples which revealed 67 pharmaceuticals, 29 pesticides and nine recreational

It comes after the Environment Agency revealed that storm overflows spilled sewage into England's rivers, lakes and coasts for new highs of more than 3.61 million hours last year.
The researchers found that

The researchers found that seaweed soaked up more chemicals than shellfish and the insecticide imidacloprid, used as pet flea treatment, created the highest risk based on levels found in surface

Dr Leon Barron, from Imperial

College London, said: "Out of so many chemicals detected, the presence of pet tick and flea treatments in the

harbours was especially concerning.
"We urgently need to reassess the
practice of blanket preventive reatment of our dogs and cats to help bring the risk down.

The team also found the presence 1,3-diphenylguanidine, which is used in rubber production and which they say could indicate pollution from tyre-wear particles and road run-off. Lead author Jasmin Uhlhorn, a PhD

student from Brunel University, said: "The research underscores the complexity of chemical mixtures present in transitional and coastal water systems, highlighting the need for more comprehensive monitoring to investigate their sources, including

the impacts of CSO discharges.

"While studies on chemical pollution in these environments are limited, the findings suggest that the true risks of chemical mixtures may be underestimated, particularly marine species."

Professor Alex Ford, from the University of Portsmouth's Institute of Marine Sciences, said: "The impact of these contaminants are yet to be fully understood, but it's clear from our data that they increase substantially under storm events which discharge untreated sewage." - Bernama

## Journalist killed in Israeli strike

### Aircraft hit a tent used by local media

GAZA: A Palestinian journalist was killed vesterday and nine others were wounded, some critically, when an Israeli airstrike hit a tent used by local media in southern Gaza, medics and the local journalists' union said.

Footage showed people trying to douse flames from a fire in the tent, inside the compound of the Nasser Hospital in Khan Younis, yesterday.

Reuters was able to verify the video from the position, layout and design of nearby buildings and tents. The date could be verified by media

reports and corroborating videos.

Other footage posted on social media but not verified by Reuters appeared to show the tent had been burned to the ground, along with the

furniture and equipment inside it.
Images appearing to show a journalist in flames, and another person trying to rescue him, were widely shared.

Israeli authorities did not immediately respond to a request for comA second Palestinian was also

killed in the attack, Gaza medics said.

Later, dozens of journalists and relatives took part in the funeral of the dead journalist, Helmy al-Faqawi. Colleagues carried his white-shrouded body on a medical stretcher with his blue flak jacket placed on top.

"We will continue to deliver the

message and convey the truth to the whole world. This is our humanitarian duty," said fellow journalist Abd Shaath, who added that they were woken by the strike to find the nearby tent of their colleagues on fire.

Faqawi's death raised the number of journalists killed by Israel's campaign in Gaza to more than 210 since October 2023, according to the Palestinian Journalists Syndicate.

In total, local health authorities said Israeli military strikes had killed

said israeli filmitary strikes had killed at least 10 Palestinians across the Gaza Strip yesterday.

More than 50,000 Palestinians have been killed by the Israeli offensive in Gaza, Palestinian officials say.

Israel began its offensive after thousands of gunmen attacked communities in southern Israel on Oct 7, 2023, killing 1,200 people and abducting 251 as hostages. – Reuters

## Iran-backed militias in Iraq ready to disarm

BAGHDAD: Several Iranian-backed militia groups in Iraq are prepared to disarm for the first time to avert the threat of an escalating conflict with the US, said 10 senior commanders and Iraqi officials.

The move to defuse tensions follows repeated warnings issued privately by US officials to the Iraqi government since Trump took power in January, according to the sources who include six local commanders of four major militias.

The officials told Baghdad that unless it acted to disband the

uniess it acted to disband the militias operating on its soil, America could target the groups with airstrikes, the people said. Izzat al-Shahbndar, a senior Shi'ite politician close to Iraq's governing alliance, said discussions between Prime Minister. between Prime Minister Mohammed Shia al-Sudani and several militial leaders were "very advanced", and the groups were inclined to comply with US calls for disarmament.

The factions are not acting stubbornly or insisting

continuing in their current form," he said, adding that the groups were "fully aware" they could be targeted by the US.

The six militia commanders interviewed in Baghdad and a southern province, who requested anonymity to discuss the sensitive situation, are from the Kataib Hezbollah, Nujabaa, Kataib Sayyed al-Shuhada and Ansarullah al-Awfivaa groups.

"Trump is ready to take the war with us to worse levels, we know that, and we want to avoid such a bad scenario," said a commander of Kataib Hezbollah, the most powerful Shi'ite militia, who spoke from behind a face mask and sunglasses. The commanders said their main

ally and patron, Iran's elite Revolutionary Guards (IRGC) military force, had given them its blessing to take whatever decisions they deemed necessary to avoid being drawn into a potentially ruinous conflict with the United States and

The militias are part of the Islamic Resistance in Iraq, an umbrella

group of about 10 hardline Shi'ite armed factions that collectively command about 50,000 fighters and arsenals that include long-range missiles and anti-aircraft weapons, according to two security officials who monitor militias' activities.

The resistance group, a key pillar of Iran's network of regional proxy forces, have claimed responsibility for dozens of missile and drone attacks on Israel and US forces in Iraq and Syria since the Gaza war erupted

about 18 months ago. Farhad Alaaeldin, Sudani's Farhad Alaaeldin, Sudani's foreign affair adviser, told Reuters in response to queries about disarmament talks that the prime minister was committed to ensuring all weapons in Iraq were under state control through "constructive dialogue with various national

The two Iraqi security officials said Sudani was pressing for disarmament from all the militias of the Islamic Resistance in Iraq, which declare their allegiance to Iran's IRGC or Quds Force rather than to Baghdad.

Some groups have already evacuated headquarters and reduced their presences in major cities including Mosul and Anbar since mid-January for fear of being hit by air attacks according to officials and

commanders.

Many commanders have also stepped up their security measures in that time, changing their mobile phones, vehicles and abodes more frequently, they said.

The US State Department said it

continued to urge Baghdad to rein in the militias. "These forces must respond to Iraq's commander-inchief and not to Iran," it added.

An American official, speaking on the condition of anonymity, cautioned that there had been instances in the past when the militias had ceased their attacks because of US pressure, and was sceptical any disarmament would be

long-term.

The IRGC declined to comment for this article while the Iranian and Israeli foreign ministries didn't respond to queries. - Reuters

## **UAE** presses Palestinian cause

**DUBAI:** The United Arab Emirates foreign minister on Sunday pressed the need for a ceasefire in the Gaza conflict during a rare visit by Israeli counterpart Gideon Saar, an official statement said.

The UAE and Israel established relations in 2020 as part of the US-brokered Abraham Accords. But there has been little bilateral contact since October 2023.

Sheikh Abdullah bin Zayed Al Nahyan, the UAE deputy prime minister and foreign minister, and Saar discussed "the worsening humanitarian crisis in the Gaza Strip" and efforts to reach a ceasefire, said a UAE Foreign Ministry statement.

"Sheikh Abdullah stressed the priority of

working towards a ceasefire and the release of hostages," it said of the meeting.
"He reiterated the urgent need to advance a serious political horizon for the resumption of negotiations to achieve a comprehensive peace based on the twostate solution"

Saar said on X: "We discussed regional issues, as well as furthering bilateral relations. There are major challenges but there are partners for a better future of cooperation and stability." – AFP Voices of Reason



## Shine a light with traditions

NCE Chinese New Year had passed, I found myself glancing at my calendar and realised that the fasting month, Ramadan, was fast approaching on March 2.

This reminded me of a tradition I uphold every year: giving a box of dates to all my Muslim colleagues at the Faculty of Hospitality and Tourism, Berjaya University College.

Dates are a staple during Ramadan and I made sure to buy a box for them, wishing them a blessed and fulfilling fasting month. Upon receiving the dates, they expressed their appreciation, though I could see a hint of exhaustion in their eyes from the long hours of fasting.

Nonetheless, there was a sense of contentment as fasting during this holy month brings a deep sense of spiritual connection and purpose.

During Ramadan, I took part in the Berjaya University and Berjaya TVET College photography competition, which ran from March 1 to 30. The theme of the competition was to capture the spirit of Ramadan and Hari Raya, showcasing the beauty and vibrancy of Malaysia's urban landscape.

I decided to focus on the Ramadan landscape, particularly the traditional pelita panjut. Having always been fascinated by the sight of pelita decorations in shopping malls, I did some research to learn more about this tradition, only to discover that it is slowly feding in the prodom period.

fading in the modern era.

The *pelita panjut*, also known as the traditional bamboo lamp, has deep cultural significance, particularly in rural Malaysia.

In the past, these lamps were lit during the seven-night festival at the end of *Ramadan* to illuminate the way for villagers who were going to the mosque for *tahajjud* (the midnight prayers) during the last 10 nights of *Ramadan*. At that time, there were few sources of light and the flickering flame of the *panjut* served as a beacon of hope and spiritual guidance.

It is a common misconception that *pelita panjut* is linked to the *Laylat al-Qadr* ("The Night of Power").

In the present day, the practice of lighting the *pelita* is not as widespread as it once was. Modern technologies have introduced plastic lamps and colourful LED lights but there are still a few communities that honour the original tradition.

Efforts to preserve the *pelita panjut* tradition are evident through annual competitions and events, which bring together the community to celebrate and showcase these beautiful, handcrafted lamps.

Historically, as dusk approached on the night of Hari Raya Aidilfitri, Malaysian villages would come alive with the warm glow of *pelita panjut*, lining the streets and decorating homes.

lining the streets and decorating homes.
These lamps, often made from bamboo and filled with kerosene or diesel, produced a steady flame that illuminated the night. Their intricate designs featured traditional Malay patterns, many of which held deep cultural meanings, symbolising prosperity, unity and the spirit of Eid.

The pélita is not just a simple lamp. It is a symbol of art, faith and community spirit. The wicks are soaked in kerosene, allowing the lamps to burn brightly throughout the night while the designs often reflect the identity of the community, with some taking the form of national landmarks, religious symbols or symbolic Malay motifs.

The preparation of the *pelita panjut* also promotes a sense of unity and cooperation. Weeks before Hari Raya, the villagers would gather to carve and arrange the hambon poles

arrange the bamboo poles.

The men would handle the carving while the women and children joined in to decorate and hang the lamps. This collective effort not only brought the community together but also strengthened the bonds among family members and neighbours.

However, as the years passed, this once-vibrant tradition has seen a decline. Younger generations, particularly those living in urban areas, have become accustomed to modern

LED lights and decorations that twinkle, and they rarely participate in the gotong-

part of Ramadan preparations.

The elderly in the villages are now the only ones upholding these customs as the younger generation are often too busy to return to their villages in time to take part in this cherished tradition.

royong activities that were once a central

For those who grew up in the village, the *Pelita Panjut* evokes nostalgia and fond memories. The warm, flickering light of the lamps not only illuminated the streets but also the hearts of relatives returning home to celebrate Aidilfitri.

Some recall running around the streets under the *pelita* or sitting together with loved ones, enjoying the delicious Aidlifitri food while gazing at the flickering lights.

As technology continues to advance at a rapid pace, the *pelita panjut* may seem outdated to some. Modern decorations, with their bright LED lights, are certainly more convenient and energy-efficient but they lack the cultural depth and sense of community that the *pelita* represents.

The pelitu penjut is more than just a decoration; it is a cultural heritage, a symbol of simplicity, creativity and togetherness that should be preserved for future generations.

The question that remains is whether the *pelita* will continue to shine brightly in the future. With the rising cost of materials and the decreasing participation of the younger generation, this beautiful tradition may one day fade into obscurity.

It is up to us to decide whether we want to keep this tradition alive and pass it down to future generations, ensuring that the *pelita panjut* continues to shine as a beacon of unity and cultural pride.

## Moving beyond rote learning

HE Malaysian education system stands at a crossroads. For years, parents, teachers, students and experts have called for change, highlighting overcrowded and heavy curricula, restrictive language policies and an assessment system that lacks engagement with the realities students face today.

assessment system that tacks engagement with the realities students face today.

One pressing issue we often hear about is the overloaded syllabi in subjects that do little to nurture creative and critical thinking.

This is often overshadowed by an

This is often overshadowed by an obsession with testing students' higher-order thinking skills via rote memorisation at the expense of fostering a strong foundational understanding and connecting knowledge to the real world in fun and meaningful ways.

Students instead are expected to absorb heavy content with little time for engagement and enjoyment, which only stifles curiosity and creativity.

and creativity.

Rather than sticking to a rigid, top-down approach, we should involve students, parents and educators in creating curricula that are more responsive to their needs and interests.

When learning is dynamic, students are encouraged to think critically, ask questions and see learning as more than just a means to score good grades. It is time that our students' rich and diverse intelligence be recognised by our education system, and to do this, our education system must move beyond the "one-size-fits-all" approach.

"one-size-fits-all" approach.

Language policies also need to reflect the needs of the students. Though there is an option to teach mathematics and science in English, many students are blocked by quotas or face other barriers that leave them learning critical subjects in Malay, regardless of their chills and matters of English.

skills and mastery of English.

In an era where students increasingly interact with English-language content through digital platforms, this inflexibility holds them back.

holds them back.

We need policies that allow language flexibility, ensuring students can effectively learn in ways that reflect their real-world exposure to both Malay and English. Malay language education could also benefit from a shift away from rigid technical focus. Presently, students experience Malay as a heavy, rules-based subject that often feels disconnected from their daily lives.

This approach fails to instil genuine

This approach tails to instil genuine appreciation or fluency, making language learning feel like a technical chore rather

than an asset. Instead, Malay language classes should emphasise real-life usage, creativity and relevance to the students' world, igniting their interest and creating lifelong connections to the language.

connections to the language.
Keeping up with AI (artificial intelligence) certainly requires radical rethinking of what education and success mean. The benefits of AI must be reaped for teacher training, support and contents that meet students' individual needs and talents.

Teachers must be guided and given the freedom to explore the technologies that are properly and responsibly regulated, and should no longer be burdened administratively in an ecosystem that is intensely KPI-driven, at the risk of inducing a box-ticking mentality over genuine engagement with students.

Malaysian education has reached a point

Malaysian education has reached a point where surface-level adjustments are no longer enough. We need a comprehensive transformation that prioritises inclusivity, flexibility and meaningful engagement. An education system is not just a series of policies; it is a foundation for our society's future

Real change means shifting from merely teaching students to truly "educating" our children - nurturing not only knowledge but a lifelong love of learning, compassion and connection. Finally, our education system must be

safeguarded from political shifts. Reform should not be tied to the agendas of each new administration but should instead be led by dedicated, passionate educators who prioritise the long-term interests of our children.

Based on this understanding, we need leaders who are committed to creating a stable and lasting education system that serves the needs of our students.

# Protectionist policy or negotiation tactic?

**MALAYSIA** has been hit with a 24% US reciprocal tariff, effective from April 9, following an announcement by President Donald Trump on April 3.

Industry players and others are understandably worried about the potential negative impacts on bilateral trade and supply chain shocks, which could drive up costs for businesses and spill over to consumers.

consumers.

What has been the response so far? A retaliatory tariff has already been ruled out by the Investment, Trade and Industry Ministry.

The ministry, alongside other government agencies and diplomatic network, has been said to be actively engaging in continuous communication with US representatives locally in Malaysia and key stakeholders in Washington, DC, to explore pragmatic solutions moving forward.

Globally, there has been a sense of uncertainty around the rationality of the calculation framework underlying these reciprocal tariffs proposed by the Trump 2.0 administration.

Industry analysts generally agree that tariffs are calculated using a specific formula: first, divide a country's trade surplus with the US (based on 2024 US Census Bureau data) by its total exports. Then, take that figure and divide it by two to arrive at a discounted rate.

There are certain "hardcoded" exceptions, resulting in a baseline 10% tariff for a handful of countries. However, this move may not be just a protectionist economic policy; it could also be a calculated negotiation tactic.

also be a calculated negotiation tactic.
In this context, it may serve as a strategic, albeit unconventional, way to test trading partners' reactions, assess their dependence on the market and position the US for more favourable trade deals.

Overall, this approach mirrors an aggressive business negotiation strategy, where initial pressure is applied to extract better terms later.

From another perspective, this approach

From another perspective, this approach also appears to be the US's method of evaluating global trade as it prepares to establish new supply chains and trade routes. It also serves as a preemptive signal, indicating which stakeholders the Trump 2.0 administration views as valuable, potentially veriful or expendable.

useful or expendable.
Given the volatility and unpredictability of Trump's approaches, we must consider broader contingency plans. This includes paying sufficient attention to exports that have currently been excluded from the tariff discussion, such as semiconductors, which now represent a significant portion of our medium- to high-value exports.

What is in store for these items? The Malaysian administration should consider developing a contingency response plan to protect its domestic industry's interests while maintaining strong bilateral trade.

This response plan, which should be diplomatic and mutually beneficial, would help soften shocks that may arise from a surprise sanction that could catch us off-guard.

Nevertheless, we should remain optimistic that our historically strong ties and continued dialogue will continue to sustain our mutually beneficial and valuable bilateral trade.

## Calls for full disclosure on Putra Heights gas explosion



WHAT went wrong? This is the question that will remain uppermost in the minds of most people, especially the affected victims, following the devastating explosion in Putra Heights recently that destroyed hundreds of homes and traumatised scores of people.

traumatised scores of people.

The authorities – particularly the rescue teams, law enforcers and other government departments as well as the private sector and individuals – quickly swung into action to help, rescuing victims and their homes, and providing much-needed relief.

This was the true Malaysian spirit in action. In times of crisis, we all come together – royalty, politicians and individuals – regardless of our inherent or acquired differences.

The incident is a stark reminder of the potential dangers associated with critical infrastructure and the need for robust safety

This tragedy highlights several crucial lessons that must be learned to prevent similar incidents from happening in the future.

Rigorous safety protocols and regular maintenance are essential for critical infrastructure, especially gas pipelines.

The proximity of the pipeline to residential areas raises concerns about the adequacy of zoning regulations and the potential impact on future development projects.

Public involvement in decision-making processes related to infrastructure projects can help build trust and ensure that community concerns are addressed.

The Putra Heights explosion also highlights the need for effective and clear emergency response protocols, disaster-relief strategies and comprehensive disaster preparedness plans.

The Welfare Department should take the

The Welfare Department should take the lead in managing spontaneous donations and assistance offered by companies, NGOs and individuals.

Beyond the immediate physical damage, the Putra Heights explosion has had a profound impact on the emotional well-being of those impacted.

Some of them have expressed reluctance to return to their original abodes. The recovery process for these individuals is likely to be lengthy and complex.

Support programmes should be available to assist with rebuilding homes, accessing financial resources and addressing long-term health needs.

We must leave no stone unturned in our efforts to determine the cause of the explosion. All parties concerned, including Petronas, must conduct a thorough investigation, which will necessarily take time.

Most importantly, once the investigation is completed, the findings must be made public – without reservation, coverups or sugarcoating.

It must be the truth, the whole truth and nothing but the truth. Only then can we learn the necessary lessons to prevent similar tragedies from occurring in the future.

URUL Azila Azmi, a member of the Orang Asli (indigenous) community in Lenggong Perak, only com-pleted her education up to primary level due to the remoteness of her village in Air Bah, Kenering, but she still had dreams of working and transforming her life.

That opportunity came in the form of a one-year training pro-gramme at the Vocational Training Opportunity Centre (VTOC) which she signed up to join in KL. The principal of VTOC had visited Nurul's village to promote the programme to young unemployed girls, in the hope of improving their lives and providing them with an income.

are offered free due to sponsorship from various organisations. More than 2,000 young girls have gradu-ated since the various programmes were started in 1998, offering them an opportunity for a better life, through a

profession.



## **US** measures a wake-up call for Asean: **Business council** exec director

KUALA LUMPUR: With global trade tensions escalating, most notably the United States' recent tariff hikes, Southeast Asia finds itself at a critical inflection point.

EU-Asean Business Council executive director Chris Humphrey said the region is no longer just a growth engine, but it is becoming a strategic necessity for economies and institutions seeking stability, openness and diversified partnerships.

"European institutions are clearly paying more attention to Southeast Asia. In this environment, your old friends may not be as reliable. Protectionism is rising, and if you are looking for growth and like-minded partners, Asean stands out," he told SunBiz after a media briefing on cigarettes and alternative nicotine products use, behaviour

and attitudes yesterday.

He said the wave of US tariffs has underscored the fragility of existing trade dependencies. It has accelerated the global with the tariffs that the same transfer of the sa shift towards supply chain diversification, a trend that could benefit Asean if the bloc can position itself more cohesively.

"This should be a wake-up call for Asean.
We need to stop being passive and start
acting like a truly integrated economic bloc."
Despite its solid fundamentals – growing

middle class, urbanisation and consistent 5% gross domestic product growth – Asean risks missing the moment unless it fast-tracks regional agreements and infrastructure, Humphrey said.

Significant progress on the Asean Trade in Goods Agreement upgrade, the Digital Economy Framework Agreement and a post-2025 vision could set the stage for a truly unified market and production base," he

Humphrey said Malaysia has already made notable moves, especially in semiconductors, in response to global concerns over supply concentration in Northeast Asia.

"The government's push for more local semiconductor manufacturing has been widely welcomed, but competition is fierce. Everyone in the region is chasing the same opportunities. Malaysia must keep climbing the value chain – beyond agriculture and tradi-tional manufacturing – to stay competitive."

As US tariffs threaten to further fracture global trade, Humphrey said, Asean's future will depend less on external forces and more on how quickly it can align internally. "The region's outlook is bright – but with

stronger unity, it could be transformational. Humphrey said Southeast Asia loses an estimated US\$30 billion (RM141 billion) annually to illicit trade, spanning tobacco, alcohol, pharmaceuticals and even counterfeit car parts.

In Malaysia alone, he said, illicit tobacco remains a persistent issue, with about half of all cigarettes sold in the country coming from illegal sources. "Malaysia's illicit tobacco market is around 50%. While the trend is slowly declining, it is still alarmingly high."

Much of the illicit tobacco entering Malaysia and the Philippines is produced legally in licensed factories outside the countries, often within Southeast Asia, before being smuggled in, making enforcement efforts more complex, he noted. - by AIMIE SHAZRIE

## Average M'sian import tariff on US goods is 5.6%, not 47%

KUALA LUMPUR: The average Malaysian import tariff on goods from the United States is only 5.6%, not 47% as claimed by the US administration, said Investment, Trade and Industry Minister Tengku Datuk Seri Zafrul Tengku Abdul

He said Malaysia does not agree with the basis used to calculate the 24% retaliatory tariff on its exports to the US, and is seeking clarifica-

tion on the methodology.

"As we understand it, the US tariffs are not a direct reflection of what we impose on them, but rather a response to trade surpluses. Malaysia recorded a trade surplus of U\$\$25 billion (RM111.8 billion) with the US. Other countries like Vietnam which also have high surpluses were hit with higher tariffs, while Singapore, which has a trade deficit with the US, faces only a 10% retaliatory tariff.

"Malaysia remains fully committed to finding a solution that maintains market access, attracts sustained foreign investment, and

supports the well-being of our workers and businesses. As such, for now, Malaysia will not take any retaliatory action," he told reporters in a press conference on the US tar-iffs at Menara Miti yesterday. Tengku Zafrul said the govern-

ment will review its 2025 approved investment growth target of 5% in light of the new tariffs, which could directly impact Malaysia's economic performance this year and potentially beyond.

"From an investment stand-

point, early feedback from both foreign and domestic investors sug-gests it is still too soon to assess the full impact on their operations. especially with the tariffs taking effect on April 9. Some investors have indicated that their supply chains will be affected - particularly in contract manufacturing - while some Malaysian firms are already

slowing expansion plans, cutting costs and shifting focus to market diversification

"While certain Malaysian exports may become more competitive compared to countries facing higher tariffs, weaker global demand as a result of the tariff measures could still drive down overall export value. Also, if more investors move to Malaysia due to our lower tariff rate, that could fur-ther widen our trade surplus with the US - which is exactly what triggered these retaliatory tariffs in the

first place. It's clearly not a long-term solution."

He said Malaysia is intensifying its trade diplomacy efforts following the US's recent imposition of sweeping retaliatory tariffs on a range of global exporters, a move that could have ripple effects on Malaysian industries and the

broader economy. He announced that strategic engagement with US authorities is being accelerated to mitigate the impact and safeguard key national

While Malaysia has not been spared - with exports to the US subject to a reciprocal tariff of 24% – the Ministry of Investment, Trade and Industry (Miti) views the situation with cautious optimism, Tengku Zafrul said.

"The rate, although not insignificant, is considerably lower than the tariffs slapped on neighbouring countries such as Cambodia (49%), Laos (48%), Vietnam (46%) and even economic powerhouse China (34%). The relatively moderate tariff imposed on Malaysia provides room for maneuvering through pro-active diplomatic channels."

Tengku Zafrul said Miti believes the current window offers an opportunity to position Malaysia as a stable and reliable trade partner amid broader regional disruptions.

"At the forefront of Miti's diplomatic push is a focus on securing exemptions and maintaining open trade cor-ridors in high-impact sectors. These include semiconductors, phar-maceuticals, energy products, aero-space components, and critical miner-als – all of which have been excluded from the latest round of US tariffs."

Tengku Zafrul said the fallout from the tariffs, however, remains a concern. While Malaysian exporters may gain an edge over costlier regional competitors, the overall disruption to trade flows could still have a negative impact on gross domestic products job creation and investment inflows

"Sectors heavily reliant on the US market must prepare for potential contraction in demand," he stressed.

In parallel with its diplomatic engagements, Tengku Zafrul said, Miti is also strengthening domestic policy tools to deal with secondary effects of the tariffs.

"A key concern is the possibility of Malaysia becoming a dumping ground for products from countries that possible and the control of the cont that now face reduced access to the US market. Miti is prepared to activate trade remedies, including anti-dumping and safeguard measures, to protect local industries," he added.

Finance Minister II Datuk Seri Amir Hamzah Azizan said this underscored the urgency for Asean member states to strengthen resilience, enhance collaboration and progress further along the path

of regional economic integration.
"While we remain committed to international trade, fostering stronger intra-Asean collaboration will pave the way for a more self-reliant and resilient Asean community," he said in his opening remarks at the Asean Investors Roundtable: Unlocking Opportunities to Advance Asean

Climate Initiatives here yesterday.

The roundtable was held in conjunction with the four-day 12th Asean Finance Ministers and Central Bank Governors Meeting (AFMGM) and related meetings, which began

## Palm oil sector to see minimal impact from 24% US tariff

BY HAYATUN RAZAK

PUTRAJAYA: Malaysia's palm oil industry is expected to only see minimal impact on the 24% tariff imposed by the United States due to a lower rate compared to competitors and limited exports to the US, according to the Malaysian Palm Oil Board (MPOB).

MPOB director-general Datuk Dr Ahmad Parveez Ghulam Kadir said Malaysia is still the cheapest option among the top exporters.

"Other major producers are being taxed even more, Indonesia faces a 32% tariff and Thailand 36%. In that sense, we have the advantage," he said at a press conference in conjunction with the signing of a memorandum of agreement yesterday between MPOB and SumiSaujana TCM Chemicals to commercialise palm-based polyol. He added that the US accounts for only

about 10% of Malaysia's palm oil exports, mainly for niche industrial uses rather than general cooking.

"The volume is quite small, but it's still an important market. The US, especially, continues to need palm oil for specific sectors like confectionery. It's not used like in other countries for everyday cooking, so it serves a niche market. The demand should remain, as it

doesn't directly compete with other oils."

But the tariff may initially affect Malaysia due to possible supply chain disruptions, Ahmad Parveez said. "The final influence will be on their own consumers because it will impact the final product. The product will have to be paid by the consumers in the future."

However, he said the US tariff will not become a major issue in the long run.

Ahmad Parveez highlighted ongoing challenges from the European Union Deforestation-Free Regulation and the Energy Directive II .

"For us, we are diversifying our palm oil – not only for commodity oil but also for other high-value applications," he said. He added that the ministry, together with

MPOB, is not focused on any single country.

"We try to diversify and ensure our palm oil is accepted globally. We're exploring other markets. Last year, for example, our exports to the Philippines increased quite drastically.

So, Ahmad Parveez, said, if there is any hurdle in the US or Europe, it wants to make sure that our good relationship with all the consumer countries is always strong. "There are many large markets out there. If you compare 2024 versus 2023, actually our export has been

increasing by around 70% last year."
As Malaysia is chairing Asean this year, he said, the country has an opportunity to strengthen regional trade ties. "And I hope that with Malaysia leading Asean, we will see increased exports to our Asean neighbours, who are much closer to us."

## SumiSaujana Group ventures into specialty chemicals industry

PUTRAJAYA: SumiSaujana Group, a Petronas licensed manufacturer specialising in the formulation, manufacturing and supply of drilling fluid chemicals, and production and refinery chemicals for the upstream, midstream, and downstream segments in the oil and gas industry, is branching into the specialty chemicals industry.

The group has signed a licensing and commercialisation agreement with the Malaysian Palm Oil Board (MPOB) to produce and sell three types of palm-based chemicals palm-based intermediates, palm-based polyols and bio-based polyester polyols.

executive Norazlam Norbi said the palm-based chemicals are renewable alternatives to petroleum-based chemicals mainly used in polyurethane production, which supports industries such as automotive, construction, adhesives, coatings, and more.

"The global market for polyurethane alone is worth over US\$86 billion (RM384.72 billion), and palm-based intermediates are valued at US\$17 billion. This shows huge potential for Malaysia's palm oil innovations to tap into these markets," he said at the signing of a memorandum of agreement, which includes licensing and ommercialisation, between the company and

MPOB yesterday.
At a press conference later, Norazlam said the first product launch could happen as soon as late 2025, while full rollout of all three technologies is targeted within a year from now. "We expect one of the products can be commercialised within six months, and all three should be commercialised within a year, working closely with MPOB."

Norazlam said no major new investment is needed because they have already started expanding their plant in anticipation of this

A new production line called "Trade Three" was commissioned in late December 2024, which gives them the infrastructure needed to support this new venture.

"Depending on further R&D with MPOB, we won't need much more investment to begin

production," Noralzam said. MPOB director-general Datuk Dr Ahmad Parveez Ghulam Kadir said this collaboration would provide the industry players with the opportunity to explore the potential of MPOB's innovative technologies and contribute to the growth of a more sustainable and competitive chemical industry at the global level. - by HAYATUN RAZAK

## Foreign investors pull RM31b from Asian markets

### South Korea and India experience heaviest selling pressure

KUALA LUMPUR: Foreign investors returned to net sellers last week across eight Asian markets, reversing their single-week buying streak, recording a heavy net outflow of US\$7.12 billion (RM31.68 billion), with South Korea and India

experiencing the heaviest selling pressure.

According to MIDF Amanah Investment
Bank Bhd's Fund Flow Report for the weekend ended April 4, South Korea saw a US\$4.44 billion net outflow, nearly 20 times higher than the previous week's outflow and extending its streak of foreign withdrawals to two weeks.

The investment bank said this was due to the political upheaval in South Korea, triggered by the Constitutional Court's impeachment of President Yoon Suk Yeol, coupled with new US tariffs, which led to heightened uncertainty and foreign investor withdrawals.

It said South Korea faced tariffs as high as

26%, exacerbating fears of a global trade war and negatively impacting investor sentiment towards South Korean markets.

"India recorded the second highest net for-

eign outflows in the region with withdrawals amounting to US\$1.21 billion, marking yet another turnaround after a single-week streak of

"On April 2, 2025, US President Donald Trump announced a 10% baseline tariff on all imports, with higher reciprocal tariffs for specific countries, including a 27% tariff on Indian goods, effective April 9, 2025," it added.

MIDF Amanah said Taiwan also experienced a significant outflow for the sixth straight week at US\$814.6 million, driven by a 32% reciprocal tariff on Taiwanese imports, which raised concerns

among investors about its export competitiveness, particularly in sectors heavily reliant on the

It said Vietnam and Thailand were slapped with reciprocal tariffs of 46% and 36%, respectively, effective April 9, 2025.

"Meanwhile, Vietnam recorded its ninth con-

secutive week of outflows, totaling US\$345 million, more than four times higher than the previous week, and Thailand also extended its foreign withdrawal streak to a sixth week, with US\$202.4 million in outflows," it added.

However, the Philippines recorded the lowest outflow out of the markets we monitor, extending to a two-week selling streak with a modest net foreign outflow of US\$14.9 million, while Indonesian markets did not record any fund flows last week as markets were shut due to the Hari Raya Aidilfitri celebrations, which extended throughout the week, it said.

Foreign investors extended their selling streak on Bursa Malaysia for the 24th consecutive week, registering a net outflow of RM426.6 million, lower than the net outflow of RM1.15 billion recorded in the previous week, aided by markets being closed for two days due to the Hari Raya

MIDF Amanah said local institutions continued to provide a buffer against foreign selling, posting their 24th straight week of net buying with inflows amounting to RM369.1 million.

"Meanwhile, local retail investors returned to net buyers, ending their single-week selling streak with an inflow of RM57.5 million.

"The average daily trading volume saw a broad-based decrease. Foreign investor and local institution participation plunged by 11.7% and 28.8%, respectively, while local retail saw an increase of 2.2%," it said. – Bernama

## Investors brace for margin calls in global market rout

### Some hedge funds offload all stocks, brokers say more selling coming

**HONG KONG:** Some hedge funds say they are offloading all or most of their holdings of stocks as US President Donald Trump's trade war wipes out trillions of dollars of market value and forces them to curtail trading using

In the three trading days following Trump's announcement of broad reciprocal tariffs on almost all countries, stock markets across the world have plummeted, and bonds have become both a haven and a bet on rate cuts by the Federal Reserve, turning on their head market assumptions before Trump took office.

The selloff on Wall Street has been vicious as investors that bet on US exceptionalism and economic might stampede out of its markets. The benchmark S&P 500 index fell 10.5%

over two days and lost about US\$5 trillion (RM22 trillion) in market value.

China's CSI300 blue-chip index fell more than 5% yesterday, while the pan-European STOXX index is down nearly 12% from its March 3 all-time closing high and is cin correction territory.

correction territory.

William Xin, chairman of hedge fund Spring Mountain Pu Jiang Investment Management based in Shanghai, said he had liquidated all of his stock positions as the current geopolitical landscape is messy, and the risk of a global recession is rising.

The macro picture is getting very chaotic, and I cannot see the future clearly at all," said Xin, who sold his China and Hong Kong-listed shares last Thursday, ahead of a public holiday

Hedge funds that pursue a long-short equity strategy have been particularly hard-hit as market volatility metrics surged, brokers said.

J.P. Morgan analysts estimated net leverage, which refers to borrowing, by hedge funds fell between 5% and 6% last week over the previous one, and that net hedge fund leverage could be around the lowest since late

The bank said volatility targeting portfolios had between US\$25 billion and US\$30 billion in equities to sell in the coming days, as they

unwind positions to reduce risk.

Levered exchange-traded funds (ETFs) had an additional UA\$23 billion to sell to rebalance into Friday's close, mostly tech stocks, it said.

Hedge funds typically use margin accounts in which they borrow cash from prime brokers to trade markets

When the value of holdings in an investor's margin account falls below the broker's required deposit, brokers can call on an investor to top up the account with cash or to sell those stocks or bonds.

That rush for cash has seen even gold,

typically a safe asset during crises, fall sharply since Trump's "Liberation Day" tariffs were unveiled on April 2.

"In market selloffs like this, panic and forced selling via margin calls can dominate for a while," said David Seif, chief economist for developed markets at Nomura in New York.

"That's not to say that it isn't based on a

very real negative event, which is these tariffs. But I think the ensuing selloff can take on a life

Bob Zhang, managing partner of Pine Street Capital, a Beijing-based hedge fund, said he has cut net exposure to Chinese stocks

to 25% now from 100% in January. He has also added some hedges on the

stock index to protect against downside risk.

"The volatility in China might just be starting, as positions are very crowded, and some people are trying to catch a falling knife."

Chinese investors are somewhat less likely to be affected by margin calls as the market had risen a lot earlier this year, yet the country is also the target of the biggest Trump tariffs.

The Hong Kong tech sub-index is down more than 27% in a month and back to levels at the start of the year.

China faces fresh US tariffs of more than 50%, and it responded in kind on Friday by slapping extra levies on U.S. imports.

"Too many uncertainties around, and

everyone is de-grossing given the elevated market volatility" said a portfolio manager at a

US multi-strategy fund based in Hong Kong.
"I think we are just in the middle of this selloff. This position unwinding usually will be sequentially affected from one hedge fund to

## China pledges to remain 'safe and promising land' for foreign investment

BEIJING: A top Chinese official has vowed to BEUING: A top Chinese official has vowed to protect US firms and pledged his country will remain a "promising land" for foreign investment, Beijing said yesterday, after it slapped 34 percent tariffs on US imports.

China retaliated last week against levies at the same level announced by US President Donald Trump on what he called "liberation

It also imposed export controls on seven rare earth elements, including gadolinium – commonly used in magnetic resonance imaging – and yttrium, which is used in imaging – and yttri consumer electronics.

Vice-Commerce Minister Ling Ji told a panel of US company representatives on Sunday that the tariffs "firmly protect the legitimate rights and interests of enterprises, including American companies", his ministry said.

Those levies – which come into effect on

Those levies – Which come into effect on Thursday – "are aimed at bringing the United States back onto the right track of the multilateral trade system", he told the representatives, including of GE Healthcare and Medit Medtronic.

"The root cause of the tariff issue lies in the United States", Ling said.

He urged the firms to "take pragmatic actions to jointly maintain the stability of global supply chains and promote mutual cooperation and win-win outcomes".

The United States exported US\$144.6 billion (RM648 billion) in goods to China in 2024, much less than the US\$439.7 billion it imported, Commerce Department data shows.

Among its exports, key sectors include electrical and electronic equipment and various fuels, alongside oilseed and grains. - AFP

## Indonesia to 'intervene aggressively' when markets reopen

JAKARTA: Indonesia's central bank said yesterday it would "intervene aggressively" in domestic foreign exchange markets when they reopen today for the first time since new US tariffs were announced.

Markets in Southeast Asia's largest economy

markets in southeast Asia singest economy have been closed since March 28 for public holidays, and trading will resume today. Before the break, the rupiah had already been under pressure, dropping to its lowest levels since the 1998 financial crisis.

Bank Indonesia said in a statement the intervention would come in the spot and non-deliverable forward markets, as well as in secondary bond markets, adding that it had already intervened offshore in Asia, European and New York markets.

"Bank Indonesia's series of measures are aimed at stabilising the rupiah exchange rate and maintaining the confidence of market participants and investors in Indonesia."

It also said it will optimise rupiah liquidity instruments to ensure adequate liquidity in the money market and with domestic banks

## Asia credit starts to wobble as pain spreads

**SINGAPORE:** Credit markets turned shaky in Asia yesterday, with the cost of insuring against corporate and sovereign default higher as recession fears rippled across financial markets.

US equity futures were down nearly 4% by mid-session in Asia and selling in credit came as equity markets from Hong Kong to Sydney were crumbling.

"It's not just the equity market," said Simon Ward, head of debt capital markets for Australasia at Mizuho in Sydney.

"We've seen credit spreads gap wider materially and we're also hearing various fund flows going the other way as well, as people try to get into cash or other commodities."

He said the debt market would probably

enter a "wait and see" mode, with deals on pause as volatility has spiked.

The spread or difference in yield between US Treasuries and the Ice BOFA index of US investment grade debt has widened about 20 basis points since Trump's tariff announcements and for high-yield US debt it has widened about

### Greenback's role as No.1 reserve currency called into doubt

LONDON: In times of market panio investors tend to rush to the safety of the dollar, but when stocks swooned in response to US tariffs last week, they ran away from it. Investors say it is a sign that the greenback's global

standing may be eroding.

The dollar, for decades a safe haven, last Thursday fell about 1.7% in its biggest daily drop since November 2022, after President Donald Trump imposed tariffs on imports at levels not seen since the early 1900s.

Stock markets also tanked, as tar-

iffs ignited recession worries. In interviews and p interviews and published markets commentaries, many investors and analysts pointed to the Trump administration for the anomaly.

Its protectionist policies, upending of the global economic order in place since World War II, and a growing US debt pile have been chipping away at

the dollar's appeal, they say.

Left unchecked, a crisis of confidence in the dollar could also undermine its position as the world's reserve currency, they added.

"What we're seeing today is a further indication that the structure and nature of the US dollar's relationship to global markets has changed," said Thierry Wizman, global foreign exchange and rates strategist at Macquarie in New York.
"There's an underlying basis for

this, which is the changing role of the US in the world."

Any erosion of the dollar's standing as a safe-haven is bad news for investors and policymakers - at

least in the near term.

For investors, who have piled trillions of dollars into buoyant US markets in recent decades, a sharp dollar fall could result in higher interest rates for longer.

That is because price pressures at home could make it harder for the

Federal Reserve to cut rates.
At the same time, a rapid At the same time, a rapid strengthening of currencies against the dollar is a headache for other central banks navigating a weaker economic outlook, as it makes their exports more expensive and potentially harder for them to revive growth. The euro, for example, just had its best day against the greenback in more than two years.

The recent depreciation in the dollar showed that concerns about the currency's status had "left footprints in financial markets already", Sweden's central bank

"If (the dollar's status) would change, that would be a big change for the world economy ... and would basically create a mess," he told Reuters afterwards. "I really do not hope the US goes there."

Even so, the reversal in its fortunes is remarkable. Going into the year, investors had expected Trump tariffs to boost the dollar, as they believed his policies would spur growth. So while investors expected tariffs

to be inflationary, the consensus was it would hurt economies abroad more while leading to higher rates at home, strengthening the currency.

That turned out to be wrong.

His tariffs are so sweeping that investors now fear the US will be hurt the most by them as prices rise at home and growth slows. Several investment banks have raised the probabilities they give of a US recession.

"The three pillars of support that helped the dollar (were) US exceptionalism, high interest rates, and strong portfolio flows. All three have been severely weakened and potentially reversed as a result of the deluge of tariff announcements," said Paresh Upadhyaya, director of fixed income and currency strategy at European asset manager Amundi. Earlier this week, Deutsche Bank

warned of the risk of a crisis of confidence in the US currency, while bond giant Pimco said it had turned more cautious on the dollar.

Satori Insights founder Matt King aid outflows from the US would likely continue.

"It has the potential to run significantly further, partly because of the magnitude of the long only (US equity and dollar) positions that have been built up over an extended period," he said, and the likelihood of this driving a sustained cycle of self-reinforcing losses.

As a result, the future of a currency often referred to as "King Dollar" for its strength and dominance in global forex markets suddenly looks uncer tain.- Reuters

### India sees no hit to projected growth from US tariffs

NEW DELHI: India may still meet its 6.3%-6.8% growth projection for the 2025/26 fiscal year that started on April 1 despite global disruptions from new US tariffs, if oil prices stay below US\$70 per barrel, government officials said, even as many private economists lowered their forecasts.

Economists, including at Goldman Sachs, have lowered India's growth estimates by 20-40 basis points to 6.1% for the current 2025/26 financial year, citing the impact of the global tariffs imposed by US President Donald Trump.
A 26% tariff on Indian imports,

with even higher levies on other countries like China, has escalated global trade tensions, with major stock indices plunging in Asia yesterday. India's diamond industry, which

ships more than a third of its exports to the US, is expected to be among the worst hit sectors, putting thousands of iobs at risk.

Discussions are underway with ministries and exporters' associations to assess the fallout, the officials said. The Finance Ministry has already

received four to five proposals from the Commerce Ministry to support export industries, including an extension of interest subsidy scheme, aid for diversification, and increased bank credit, a second official said.
"We are still studying the impact

of tariff hikes on the export sectors and the decision could be taken at the appropriate time," the official

A third Finance Ministry official, however, said the tariffs would not weigh heavily on India's key fiscal parameters for the 2025/26 year.

"We have already made provisions in the budget for duty remission schemes to help exporters and are open to doing more," the official said.

The officials spoke on condition of anonymity as they were not

authorised to speak to the media.
India's Finance Ministry did not immediately respond to an e-mailed request for comment.

India does not plan to retaliate against Trump's tariffs as officials try to negotiate a resolution,

## Shell lowers first-quarter LNG production outlook

Shell lowered first-quarter liquefied natural gas (LNG) production outlook in a trading update yesterday, citing the impact of bad weather in Australia, before it publishes results on May 2.

The British company guided for LNG output to reach between 6.4 million and 6.8 million metric tons, down from a previous forecast of 6.6 million to 7.2 million tons.

It produced 7.1 million tons of LNG in the fourth quarter of last year. The downward revision was

because of cyclones and unplanned maintenance in Australia, the company said, adding that its gas division trading results are expected to be in line with the previous

Shell said in February that it had to postpone some loading from its

Prelude floating LNG facility in Western Australia because of challenging weather conditions.

Shell also said it expects to book a US\$100 million (RM448 million) exploration write-off in the quarter.

A spokesperson declined to give more detail.

In its marketing business, Shell expects results in the quarter to be dented by a lower contribution from its speciality products and services business, which includes low-carbon energy solutions for the aviation and

marine industries among others.
The company also narrowed its overall oil and gas output forecast to between 1.79 million and 1.89 million barrels of oil equivalent per day (boed) in the first quarter, down from a previous projection of 1.75 million to 1.95 million boed. - Reuters

## China would have agreed to TikTok deal if not for levies: Trump

WASHINGTON: US President Donald Trump said on Sunday that China would have agreed to a deal on the sale of TikTok if it were not for the tariffs imposed by Washington on Beijing last week.

Trump on Friday extended the deadline for TikTok to find a non-Chinese buyer or face a ban in the United States allowing 75 more days to find a solution a day after imposing additional 34% duties on all Chinese imports.

"The report is that we had a deal, pretty much for TikTok, not a deal, but pretty close, and then China changed the deal because of tariffs. If J gave a little cut in tariffs, they'd approve that deal in 15 minutes, which shows you the power of tariffs," Trump told

reporters aboard Air Force One.

The hugely popular video-sharing app, which has more than 170 million American users, is under threat from a US law passed last year that orders TikTok to split from its Chinese owner ByteDance or get shut down in the Únited States.

Trump had insisted his administration was near a deal to find a buyer for TikTok and keep it from had insisted shutting down that would involve multiple investors, but gave few details

ByteDance, while confirming that it was in talks with the US government towards finding a solution, warned that there remained "key matters" to solve.

"An agreement has not been executed" and whatever was decided would be "subject to approval under Chinese law", the firm added. - AFP



### KJTS lands 20-year Thai chilled water plant improvement deal

KUALA LUMPUR: KJTS Group Bhd, a provider of cooling energy management solutions, announced that its Thai subsidiary KJTN Engineering Co Ltd has been selected by Central Hua Hin Beach Resort Co Ltd (CHBR) to undertake a chilled water plant improvement project under a Finance, Retrofit, Operation Maintenance, and Transfer (ROT) scheme at the Centara Grand Beach Resort & Villas Hua Hin in Thailand.

The Centara Grand Beach Resort & Villas Hua Hin, a five-sta heritage hotel originally opened in the early 1920s, is owned and operated by CHBR, a member of Central Group.

The 20-year letter of award underscores the group's growing presence in Thailand's hospitality infrastructure sector and marks the third engagement between KJTN Engineering and the Central

Group, one of Thailand's largest conglomerates.

Under the terms of the ROT with CHBR, KJTN Engineering will finance and execute the retrofit works in two phases, amounting to THB210 million (RM27.31 million). Upon completion, the company will provide long-term chilled water supply and comprehensive operations and maintenance services to the resort. The first phase of retrofit works is scheduled to be completed by May 31, 2026. followed by the second phase 24 months later. Chilled water supply and O&M services will commence from June 1, 2026 through to May

KJTN Engineering will receive a fixed monthly fee beginning at THB1.46 million upon completion of phase one, increasing to THB1.56 million upon phase two completion. This is in addition to a variable fee based on the volume of chilled water supplied. Over the 20-year LOA term, the fixed component alone is expected to generate a total of THB372 million in recurring revenue for the group.

## Ringgit, other Asian currencies weaken as trade tensions rise

**THE** ringgit closed lower against the US dollar yesterday, mirroring the broader trend across Asian currencies amid

ongoing concerns over escalating trade tensions.

At 6pm, the ringgit decreased to 4.4775/4840 against the

greenback from last Friday's close of 4.4335/4400. SPI Asset Management managing director Stephen Innes said the situation was further exacerbated by China's 34 per cent

the situation was further exacerbated by Chinas 34 per cent retaliatory tariff response to the US.

"The ringgit is notably weaker today, dragged lower alongside the rest of Asian currencies as US President Donald Trump's tariff barrage has now fully morphed into a front-page trade war, due to China's 34% rétaliatory response," he told Bernama.

On April 2, Trump announced an additional 34% tariff on all Chinese goods imported into the US, and Beijing retaliated with

reciprocal 34% tariff on US goods shortly thereafter. The ringgit was traded mostly lower against major currencies. It slid against the Japanese yen to 3.0655/0704 from 3.0294/0340 and down against the euro to 4.9100/9172 from 4.8706/8778, however it increased against the British pound to

5.7491/7575 from 5.7591/7676 yesterday. However, the local note was mostly higher against Asean

It gained versus the Thai baht to 12.9128/9408 from 12.9589/9847 and inched up against the Indonesian rupiah at 266.1/266.6 from 266.2/266.7.



#### Relative performance of the KLPRP against the FBM KLCI since Jan 2024




ADMITTEDLY, given the sector's outperformance over the past two years, investors heavily took profit on the property sector when market sentiment turned bearish during the last few months. However, we reiterate that most developers derive their earnings mainly from the local market, and the past data centre (DC)-related transactions and land deals with global tech giants

have been secured and/or completed.

Domestic developers announced a few major deals in Q1'25 that should boost market confidence, in our view. These include:
i) Sunway's development project at the Bukit Chagar Rapid
Transit System (RTS) Station and long-term lease with DB
Schenker, ii) UEM Sunrise's (UEMS) collaboration with Singaporebased GuocoLand to develop an industrial park in Gerbang Nusajaya, and iii) Eco World Development Group's (ECW MK, NR) land disposal to a foreign solar part manufacturer in Senai as well sal and sales and long-term lease with a global tech player for a Selangor DC facility. Therefore, these very much indicated that Malaysia is still well positioned to capture data centre investments while Iskandar Malaysia continues to be a destination for foreign direct investments (FDIs) under the Johor-Singapore Special Economic Zone (JS-SEZ).

Aggregate property sales for FY24 grew by 3% YoY. This is the fourth consecutive year that aggregate sales numbers have stayed above the RM20 billion mark, indicating that most developers have been able to sustain their strong sales since 2021. For FY25, we expect 3-5% growth in property sales, driven mainly by both the industrial and residential segments. - RHB Research, April 7

HARTALEGA's Q3'25 revenue increased by 13% QoQ mainly due to a 12% OoO increase in sales volume to 7.6 billion pcs. This was due to higher inflow of orders from the frontloading activities by US customers. Utilisation rate dropped to 86% in Q3'25 from 90% in Q2'25 due to a total 15% added capacity from the new NGC1.5 plant, bringing total annual capacity to 37 billion pieces. Meanwhile, ASPs improved 3% QoQ to US\$22/1k pcs. PBT improved 26% YoY due to higher non-operating income and

recovery of the USD against MYR. Hartalega's sales volume is expected to decline by 15–20% QoQ in Q4'25, reflecting a softer order replenishment following frontloading activities by US customers. We understand that US buyers are still drawing down existing inventories, with a more meaningful recovery in order flow anticipated by June 2025, keeping near-term volumes under pressure. Meanwhile, ASPs continue to trend lower, with the Group currently pricing at US\$19/1k pcs for the US market and US\$17/1k pcs for non-US markets customers, 14% decline from Dec 2024 levels, reflecting sustained pricing pressure across key export markets.

Hartalega is currently operating at a utilisation rate of 60-65% based on 37 billion pcs annual capacity. To better align its operations with current demand levels, the group plans to reduce its workforce by 13%, bringing the headcount down to approximately 7,000 employees by 1H'26. We believe this workforce adjustment is part of Hartalega's strategy to optimise operational efficiency and maintain cost control in a more subdued market environment

IN February 2025, UEMS entered into a MoU with Singaporebased Guocoland to develop selected parcels of land in Gerbang Nusajaya into an industrial park. Although a detailed agreement has yet to be signed, management indicated that the conversion of industrial re-zoning is already completed, and the final approval from the local authority should be obtained by June 2025. Infrastructure construction and earthwork for the industrial park are expected to start soon, and hence the industrial park should be ready to be marketed in 2027. While Guocoland is known for its premium commercial and residential developments in Singapore, the company has a strong clientele from Hong Kong and China to cross-sell this industrial park project to regional manufacturers/corporates.

UEMS achieved RM1.42 billion worth of property sales in 2024. For 2025, management has set a sales target of RM1.05 billion on the back of RM2 billion worth of new launches. While Subiaco in Perth would be the main project given its GDV of RM1.5 billion, the launches in Malaysia are predominantly in Iskandar Malaysia – Estuari and Aspira Hills with a combined GDV of RM437 million. The only new project in the Klang Valley is the landed homes in Serene Heights (GDV: RM78 million). UEMS only has RM98 million (at cost) worth of unsold inventory available for sale. We believe the Iskandar Malaysia region will still be a major

sales driver by geographical area given the incentives under the Johor-Singapore Special Economic Zone and visibility of the upcoming completion of the Rapid Transit System in end-2026.

This is more than a promising start as Netflix calculates the audience ratings of new shows over the first 91 days of release. The mini-series, therefore, has a good chance of climbing even higher in



## Helping parents promote better digital habits for teens

**TIK TOK** recently introduced new features to enhance family safety and help teens develop balanced digital habits, allowing parents and caretakers to now view and adjust more than 15 safety, well-being and privacy features for their teens through TikTok.

First introduced in 2020, TikTok's Family Pairing feature allows parents to link their accounts with their teens, improving parental oversight and control over their experience of the app.

Building on its existing features such as screen time limits and privacy controls, TikTok's latest updates have been constructed with feedback and guidance from

families and experts.
TikTok also introduced the Time Away feature, allowing caregivers to block access to the app during specified periods, such as family time, school hours or bedtime.

With this feature, parents are now able to set recurring schedules to limit their use and grant extra time at their discretion, using a passcode set by the parent or guardian.

This additional feature builds

upon TikTok's default screen time restrictions, in which all users under 18 are automatically set to a 60-minute daily limit unless

adjusted by a parent or guardian.

Another significant update that improves parental oversight is the ability to see who their teen follows, who follows them and which accounts their teen has blocked.

With this increased visibility, parents will be better aware and equipped to manage their teens'

TikTok also introduced a winddown feature for users under 16. If a teen remains active on TikTok after 10pm, their For You feed will be interrupted by recurring full-screen reminders with calming music and prompts that become increasingly harder to dismiss,

encouraging them to log off.

This feature promotes mindful screen time habits and future updates will introduce guided meditation exercises to improve

relaxation and sleep quality.

The app has already disabled nighttime push notifications for teens to reduce digital distractions before bed.Parents can now re-enable TikTok's STEM feed if

their teen has turned it off. First launched in the US and Europe last year, this dedicated Science, Technology, Engineering and Math (STEM) feed helps teens discover a variety of inspiring and educational content across the platform.



and self-worth online. What parents see as excessive screen time, teens view as essential to their social lives. Hence, this makes it difficult for parents to understand their child's deep emotional connection to the digital world. Psychologist Erik Erikson's theory of psychosocial development explains this well. Adolescence is a fundamental phase in which individuals develop their identity and self-concept. During this stage, adolescents explore their independence and begin negotiating their rights, including privacy, participation and self-expression.

Naturally, this causes conflict as parents impose boundaries while teens push for autonomy, often clashing over digital usage. Therefore, without effective engagement strategies, this gap can lead to further disengagement and strained family relationships.



Traditional parenting such as strict monitoring or outright banning of

devices often backfire, pushing teens to become more secretive about their online activities. Rather than engaging in power struggles, parents can take proactive steps to develop a healthier and more balanced approach to digital engagement. One of the strategies start with shifting the

mindset from a policing approach to a partnership approach.

With a partnership approach, parents can establish open and non-judgmental communication, whereby they begin to engage in honest conversations with their teens. This approach is probably unfamiliar in some households, especially among Asian families, where being emotionally vulnerable may not be a common practice. However, it is important to recognise the value of establishing this type of engagement with children. Instead of focusing on rules and regulations, parents can talk about values, risks and boundaries in the digital world.

When children understand their parents' concerns and the potential risks that the digital world may bring to them, they are more likely to comply to a digital family agreement. Together, parents and children can create guidelines that balance independence with safety.

This collaborative approach fosters mutual respect and accountability. By involving children in setting these boundaries, parents increase the likelihood of the rules being respected and followed.
Additionally, parents should model healthy digital habits themselves to reinforce these agreements.

Finally, having something in common is a crucial element in creating a strong bond within families. One way to strengthen bonds is by learning about technology together. Instead of seeing the digital world as a threat, families can explore its positive side such as learning new apps, sharing funny videos or even having conversations about digital trends and challenges.
This not only builds a common

ground but also helps parents better

understand their children's online world.

#### Trust as foundation

Ultimately, the most effective parental tool is not surveillance, but trust. Open communication and emotional communication create an environment in which adolescents willingly seek parental guidance rather than hiding their online activities.

By shifting from control to

collaboration, parents can better protect their children from the digital risks while empowering them to navigate the digital world responsibly and independently.

## Besna raises bar in progressive metal stakes

**MOST** genres typically have talent concentrated from certain countries. The K-pop and J-pop empires for obvious reasons are built on acts that are native speakers of Korean and Japanese. Country and Western has its ground zero in the deep south of the US. Hip hop, R&B, soul and urban sounds are largely dominated by artistes from the US and UK. EDM and its attendant subgenres are heavily populated by European deejays and

One genre that has spread its tentacles far and wide is heavy metal as well as its many offshoots. Be it death, black, grind, industrial or even glam, the genre has global appeal and genuinely good acts emerge from the unlikeliest of places. Even before the Great Internet Revolution

that made these sounds available at a click of a mouse, outfits such as Sepultura, Sarcofago and closer to home, Cromok were proving genuinely good metal need not always come

from the US or Europe.

This makes following metal in the internet age a pretty wonderful and exciting time, as ality sounds are emerging from all corners of the globe and gaining recognition thanks to streaming platforms and much wider reach of specialist publications such as *Terroriser*, *Loudwire* and *Metal Hammer*.

One band to catch the attention of the

global metal community is Besna. Formed in 2017, the quartet hail from Bratislava, Slovakia.

With a template that borrows heavily from past masters of occult black metal Absu, the Slovakian outfit has added a touch of atmospheric gloom to update the sound.

Opening track Zmraka Sa, off the second LP Krasno, is ambitious in its scope and follows Blood Incantation in incorporating progressive elements in the song. Without sacrificing any impact, the song is an epic journey in heaviness with Besna further adding driving hardcore punk beats for cranium-crushing momentum.

Hranice is absolute aural adventure as Besna pulls out all the tricks in making the tune stand out - complex time signatures, mid-tempo interludes and effective use of

female vocals. It all packs quite a wallop and much can be said for most of this record.

Labelling itself "post-black / progressive metal", Besna touches on topics such as ecology and societal issues. But, that does not really matter unless the listener is proficient in Slovakian. What is pertinent is the band's innate ability to craft songs that are engaging with its super-dense arrangements as well as its ability to induce bouts of serious headbanging. There is nary a dull moment, even when the band head off in Porcupine Tree directions. It is all very tastefully stitched together making this album very worthwhile half an hour. - by R. BALA







#### Djokovic motivated but keeping expectations low

NOVAK DJOKOVIC said reaching his first final of the 2025 season at the Miami Open helped him find the motivation to continue quest for more titles as the 37-year-old looks to win his 100th ATP trophy during the clay season.

The 24-times Grand Slam champion has not won a title on the men's tour since his ATP Finals triumph during an extraordinary 2023 although he bagged the Olympic gold medal during the Paris Games at Roland Garros last

Djokovic's bid to join Jimmy Connors (109) and Roger Federer (103) as the only three men in the professional era to claim 100 or more ATP trophies ended in a defeat by Jakub Mensik last week but the Serb said he was spurred on by his level in Miami.

"There's no doubt it has become more difficult throughout my career but the performances in Miami, when I'm playing that way, it gives me more inspiration to keep going," Djokovic told reporters in Monte Carlo.

"Obviously when you start losing early you have more questions and inner voices, which are bringing doubts about whether you should keep going. "I'm glad in Miami I found that joy on the

court and performance levels, so let's see if I can carry that into clay. It's a different surface and I've not had much time to get used to this tournament so my expectations aren't that

## Max proves point at Suzuka

... but weary of McLaren ahead of Bahrain race

CHAMPION Verstappen exploded the idea that McLaren might absolutely dominate the Formula One season with victory at the Japanese Grand Prix at the weekend, but the Dutchman was by no means certain he would be able to repeat the feat

Verstappen steered his Red Bull to a pole-toflag victory for an unprecedented fourth year in a row at Suzuka on Sunday, continuing his love affair with the home circuit of his team's engine providers Honda.

The four-times world champion delighted with his weekend in Japan, highlighted by the brilliant qualifying lap that snatched pole position away from McLaren's Lando Norris, but cautious about what it meant for the remaining

"I think we know our limitations," he said. "So we just have to try and run against that limitation as much as we can. But yeah, it's still not fixed.

"So this is hopefully going to be fixed soon, but I cannot give you a timeline on that. It's just about trying to find that limit, which is really sensitive for us at the moment."

Team principal Christian Horner was clear about what the Suzuka win, coming after dominant wins for McLaren in Australia and China, meant for Red Bull.

'Max, without any debate, is the best driver in

the world currently," he said.
"I think for the drivers' championship, Max is, what, one point behind now? So for us, all prior-

"The constructors is going to be harder, but it's a long year, and you never give up, and I think there's no better tonic or motivator than win-

ning."

After three races, Red Bull are a hefty 50 points behind McLaren in the constructors' championship and Verstappen does indeed trail Norris by a single point in the drivers' standings heading to this week's race in Bahrain.

McLaren team principal Andrea Stella was equally clear that he wants both titles and, convinced that the best cars in Formula One are in his garage, was satisfied with second for Norris and third for Oscar

A cool track and very lit-

tle tyre degradation meant qualifying position was crucial at Suzuka with Ferrari's Lewis Hamilton, who was seventh, the only driver in the top 10 finishers managing to overtake during

The Bahrain heat is likely to offer very different conditions but Piastri warned he and Norris would need to be wary of Mercedes and Ferrari as well as Red Bull in the Gulf kingdom, the home of McLaren's owners.

"I think we have a small advantage, but I think

## **Cool Harman clinches Texas Open**

BRIAN HARMAN kept steady in the wind as he held on to his three-shot lead to win the PGA Tour Texas Open in San Antonio yesterday.

The former British Open

champion had a late wobble, with back-to-back bogeys on the 15th and 16th but his closest challenger Andrew Novak was

unable to take advantage.

Novak left birdie putts on the 16th and 17th short and Harman maintained his calm to make par on the final two holes and finish with a 3-over 75 on a day when

many struggled with conditions. It was the 38-year-old American's first tournament win since triumphing in the 2023 Open Championship at Royal Liverpool.

Harman had grabbed the lead during the second round when he shot a 6-under 66.

### Razif expects Aaron-Wooi Yik to roar back at BAC

ESPITE a string of lacklustre performances recently, 2022 men's doubles world champions Aaron Chia-Soh Wooi Yik are seen as having the potential to roar back into form at the 2025 Badminton Asia Championships (BAC) in China starting today.

This confidence was expressed by national badminton legend Datuk Razif Sidek, based on the relatively easy path awaiting the sixth seeds at the tournament, which will be held at the Ningbo Olympic Sports Centre Gymnasium until Sunday.

"Based on Aaron-Wooi Yik's draw at BAC 2025, I think it's only from the quarterfinals onwards that it gets tough. It's not impossible; they can definitely succeed as long as they stay serious and give 100% focus.

"In terms of experience, there's no issue They have beaten other top world pairs, including those from China and Indonesia.

"Moreover, they are not carrying any worrying injuries that could prevent them from performing this time," he told *Bernama*.

The world No. 6 pair had previously been

hampered by injuries to Aaron, which saw them exit in the first round of two recent tournaments – the 2025 Orleans Masters in France and the 2025 All England Championships last month.

Aaron-Wooi Yik will open their BAC 2025 campaign against an unseeded Japanese pair, Kenya Mitsuhashi-Hiroki Okamura, with the head-to-head record favouring the Malaysians 3-0.

They are then expected to face a lesser-known Indian pair, Hariharan Amsakarunan-Ruban Kumar Rethinasabapathi, before encountering a real test in the quarterfinals should the third seeds from Indonesia, Fajar Alfian-Muhammad Rian Ardianto, progress to that stage

Commenting on the chances of the world No. 2 pair, Goh Sze Fei-Nur Izzuddin Rumsani, Razif, who once clinched the BAC title in 1992 alongside his brother, Datuk Seri Jalani Sidek, said they are expected to face a stern test following a tough draw at the tournament, which offers a total prize pool of US\$500,000 (RM2.2m).

Sze Fei-Nur Izzuddin, who are the top seeds,

will face 2021 world champions from Japan, Takuro Hoki-Yugo Kobayashi, in the first round, with the Japanese pair having won three of their four previous encounters.

Also accompanying Aaron-Wooi Yik and Sze Fei-Nur Izzuddin in the men's doubles campaign are eighth seeds Man Wei Chong-Tee Kai Wun and the duo of Wan Arif Wan Junaidi-Yap Roy King.

Roy King.

Meanwhile, Razif hopes the country's top women's doubles pair, Pearly Tan-M. Thinaah, can fully focus on their opening match against South Korea's Kim Hye Jeong-Kong Hee Yong and put in a convincing campaign despite being overshadowed by off-court issues.

Recently, the media reported that the future of Pearly-Thinaah is in doubt, as they have yet to sign a new contract with the Badminton Association of Malaysia after their previous one ended in January. It was also reported that they are "planning" to leave the national body.

At the same time, Razif hopes to see at least one Malaysian mixed doubles pair reach the semifinals, following the recent split of Chen Tang Jie-Toh Ee Wei. - Bernama

miss the Canada leg due to strict visa regulations and a lengthy application process. Ken Nee revealed that the association ran out of time to secure

association ran out of time to secure Maccartney Harold a visa for Canada, which means only Pandelela and her team manager will make the trip. In Guadalajara, Pandelela miss-

In Guadalajara, Pandelela missed out on a place in the women's 10m platform final after finishing 13th in the preliminary round last Friday.

## Alia unfazed by lack of world recognition

VETERAN national shooter Alia Sazana Azahari is unperturbed that the Asian record she set in the women's 25m pistol event at the 2025 Asian Rifle/Pistol Cup in Bangkok last February was not recognised as a world record.

The 33-year-old athlete said she accepted

The 33-year-old athlete said she accepted the International Shooting Sport Federation's (ISSF) decision with an open heart, as the tournament did not feature professional shooters from around the world.

"It's justified because we were at the Asian Cup, where only Asian countries competed, so to consider it a world record wouldn't be legitimate since we weren't up against the rest of the world.

"I've accepted and fully understand the

decision. But Alhamdulillah, the Asian countries still recognise the record," she said when met recently.

Earlier, National Shooting Association of Malaysia executive secretary Major (Rtd) Jasni Shaari said the association would not appeal to the ISSF to have the record recognised as a world mark.

"We have to go by the rules and won't appeal," Jasni had said.

Alia captured gold in the event when she registered 44 hits out of 50 targets, surpassing the previous Asian record of 41 hits set by South Korean shooter Yang Jiin at the 2024 Asian Shooting Championships in Jakarta.

Silver went to South Korean shooter Lee

Siyoon with 32 while Singapore's Teh Xiu Yi took bronze on 28.

The world record of 42 was set by South Korea's Kim Ye-ji at the World Championships in Baku last year.

Alia described her experience at the event as one of the most meaningful moments of her 13-year career with the national team, and she is now shifting focus to winning gold at the 2025 SEA Games in Bangkok this December.

"It's not just about the medal or the record though of course, it's one of the biggest achievements of my life. But the conditions I experienced during that final were completely unexpected. It's something I'll never forget," she said. – Bernama

"In the second half we made chances and could've made up for it, but we lacked time. In the last 25 mins it was clear that we could score a third. "We have a whole week until West Ham.

Everyone needs to be aware that the only way we win is through a constant effort and 90 minutes of hard work.

"It's not often we concede three goals let alone

in one game or 15 minutes. We could have prevented it.

"We scored a good goal but apart from that the

"We scored a good goal but apart from that the second half performance was much more what we are like

"Conceding three goals like we did is not of the standards of Liverpool. We were creating chance after chance after chance (towards the end).

"In the end we lacked time to make up for the three mistakes we made in the first half."

Another rarity that went against Slot and Liverpool was the poor performance of Mohamed Salah

He blazed over the bar from close range to go without a goal in his last four matches, but the head coach insists that Salah will return to form

"Maybe he should see it as a compliment (that people are talking about it) because his numbers were not normal (when he was scoring)," Slot said.

"The good thing about Mo is he knows what kind of player he is. Mo will show up again, I don't worry about that."

The win sees Fulham bounce back from their FA Cup quarterfinal exit to Crystal Palace last month and their 1-0 midweek defeat at Arsenal as they move up to eighth in the table.

"It was a great three points for us, I believe we deserved it," manager Marco Silva said.

"Our first half was at a good level and after a good goal from Mac Allister, we had to be strong, be clever, make some tactical fouls and the reaction was great.

"It was a game where we knew we had to be at a high tempo

a high tempo.
"After the last nine days it was important to give something back against a team that is going to be the Premier League champions," he added. – The Independent/Expreee Newspapers
