# Sultan calls for stronger border security, Sg Golok buffer zone

KOTA BHARU: The Sultan of Kelantan Sultan Muhammad V has voiced serious concern over security along the Malaysia-Thailand border, urging swift action to construct a wall and establish a buffer zone in the Sungai Golok area.

Delivering his royal address at the opening of the third term of the 15th Kelantan State Legislative Assembly yesterday, the Sultan called for the proposal to be finalised without

called for the proposal to be mailsed without further delay.

He also highlighted the pressing need to resolve Kelantan's recurring flood problems, stressing the urgency of advancing all phases of the integrated river basin projects for Sungai Kelantan and Sungai Golok.

"Priority must be given to the construction

"Priority must be given to the construction of the Lebir Dam, as it is crucial in addressing

Kelantan's flood challenges," he said.
Turning to agriculture, Sultan Muhammad
V urged all relevant government agencies,
departments and companies to stay focused
on their core responsibilities while stepping up efforts to safeguard food security for the state and nation, reported Bernama.

"I strongly encourage both the government and public to explore and cultivate highpotential crops, such as coconut and durian, as viable income sources in the agricultural

In line with the Kelantan Agricultural Development Enactment (2022), he called for the immediate establishment of a produce collection centre in Lojing to avoid missing out on key opportunities for revenue, investment, and economic growth.

On urban development, the Sultan pressed local authorities to ensure that towns across Kelantan remain clean, attractive and well managed.

"I would like to express my sincere appreciation to the National Landscape Department for its strong collaboration with the Kota Bharu Municipal Council Islamic City in successfully implementing the landscape

project in Kota Bharu town.

"For example, the East Coast Rail Link project is set to bring strategic value to the state, particularly through the establishment of a cargo-oriented development zone in Pasir Puteh and a transit-oriented hub in the emerging township of Tunjong.
"Beyond enhancing Kelantan's transport

#### No Cabinet shake-up despite losses in PKR polls: PM

PUTRAJAYA: Prime Minister Datuk Seri Anwar Ibrahim has firmly stated that PKR's internal elections have no bearing on the federal administration, brushing aside speculation of a Cabinet reshuffle.

"This is a matter of party leadership and the process went smoothly. If there are any concerns or confusion, they can be addressed within the party framework.
"The elections proceeded well, and we'll hold

a special meeting this Wednesday. Again, this is strictly party business.

"There's no question of it affecting the state or federal governments. Everything is running as usual and smoothly."

Anwar, who is also PKR president, stressed that Cabinet positions are based on performance, not party politics.

"I assess them based on their work – not political manoeuvring," he told reporters at the Higher Education Ministry Hari Raya Aidilfitri

Also present were Higher Education Minister Datuk Seri Dr Zambry Abdul Kadir, his deputy Datuk Mustapha Sakmud, Chief Secretary to the Government Tan Sri Shamsul Azri Abu Bakar, and Public Service director-general Tan Sri Wan

Ahmad Dahlan Abdul Aziz.
The PKR divisional elections, which concluded on Sunday, saw several members of Anwar's administration losing their party posts.

One of them was Natural Resources and Environmental Sustainability Minister and PKR vice-president Nik Nazmi Nik Ahmad, who lost the Setiawangsa division chief post to actordirector Datuk Afdlin Shauki. Afdlin garnered 631 votes to Nik Nazmi's 563.

Youth and Sports Deputy Minister Adam Adli Abd Halim also failed in his bid to become Hang Tuah Jaya's deputy division chief, receiving 791

votes against Zamzizul Nordin's 1,905.

On Sunday, Energy Transition and Water Transformation Deputy Minister Akmal Nasrullah Mohd Nasir lost the Johor Bahru division chief post to Johor PKR Youth chief Mohamad Taufig Ismail, who secured 709 votes to Akmal's 587

## Zahid, Gibran discuss regional concerns

JAKARTA: Deputy Prime Minister Datuk Seri Di Ahmad Zahid Hamidi paid a courtesy call on Indonesia's Vice-President Gibran Rakabuming Raka yesterday, during which they discussed several important issues, including halal matters, labour concerns, the welfare of fishermen regional developments and the situation in Palestine.

Ahmad Zahid's productive 45-minute meeting with Gibran at the Vice-Presidential Palace in Central Jakarta was also attended by Agriculture and Food Security Minister Datuk Seri Mohamad Sabu and Malaysia's Ambassador to Indonesia Datuk Syed Mohamad Hasrin Tengku

Regarding halal matters, the two leaders discussed opportunities for collaboration in the US\$1.3 trillion halal sector, as well as challenges that could be tackled jointly. These included the mutual recognition of halal certificates issued by the Department of Islamic Development Malaysia and the Indonesian Ulema Council.
"We will coordinate and engage in detailed

discussions not only regarding the production of halal products but also on marketing strategies," he said at a press conference after the meeting. The two countries also agreed to enhance the

process of sending workers from Indonesia to Malaysia through the One Channel System and to address the management of fishermen who encroach territorial waters, as outlined in a memorandum of understanding signed in 2012.

## Home-based classes OK during Asean summits: Minister

KEPALA BATAS: The Education Ministry is ready to implement the home-based teaching and learning (PdPR) approach during the Asean summits in May and October to help ease traffic congestion and to ensure the summits proceed smoothly.

Minister Fadhlina Sidek said the ministry is

currently in the process of identifying the schools that will be affected.

"There is no issue. The matter has been thoroughly discussed within the ministry," she told reporters after attending the symbolic ceremony of wearing the *Jalur Gemilang* badge at Sekolah Menengah Kebangsaan Datuk Haji Ahmad Badawi yesterday.

She was responding to a proposal by Foreign

Minister Datuk Seri Mohamad Hasan to implement work-from-home and PdPR arrangements during the summits – a proposal that will be brought to the Cabinet for consideration.

Mohamad reportedly said the proposal stemmed from the challenges and inconveniences faced by the public, particularly in Kuala Lumpur and Putrajaya, due to road closures during the recent state visit of Chinese President Xi Jinping to

In a separate event, Fadhlina also announced that the ministry is retraining more than 100,000 teachers nationwide in digital pedagogy and 21st-century teaching tools, in alignment with the Asean Work Plan on Education (2021-2025).

She said the initiative, which focuses on enhancing teachers' professional development, is being carried out in collaboration with Google for Education, the United Nations Educational Scientific and Cultural Organisation (Unesco) and local universities.

"Malaysia recognises that the education sector must shift from passive knowledge transmission to active skills cultivation, creativity, critical thinking and lifelong learning. We are at a crossroads. The choice is between marginal adaptation and bold transformation. Malaysia is choosing the latter.

"The Asean Work Plan on Education (2021-2025) lays out a robust framework for cooperation and Malaysia is fully aligned with its vision," she said in her speech at the Empowering Education Summit 2025: Shaping Asean's Future Through Skills and Innovation.

Fadhlina said Malaysia is enhancing the

between the Technical

Vocational Education and Training (TVET) sector and industry through the National TVET Empowerment Agenda, allowing public and private sectors to jointly create modular, industry-

relevant training programmes.

She added that the ministry is also expanding Science, Technology, Engineering and Mathematics (STEM) efforts, such as #MySTEMAmbassadors and STEM4ALL, for rural and underprivileged students. "In 2024, more than 200,000 students took part

in STEM boot camps and robotics competitions, ut digital equity remains a challenge

To tackle this, the ministry is setting up hybrid solar-powered classrooms and satellite internet in 180 schools across Sabah and Sarawak to bring

innovation to all areas and reduce inequality. Fadhlina said while Malaysia's bilingual system already includes Bahasa Melayu and English, the ministry is now adding elective languages such as Mandarin, Tamil and Asean languages such as Thai,

"Asean's strength lies in its cultural, linguistic and traditional diversity. To harness this, we must prepare our youth to be multilingual, adaptable and culturally competent."- Bernama

# Call for legislation to protect ageing population

Severe shortage of geriatric care, rising elderly abandonment highlight urgent need for legal safeguards: **Expert**

PETALING JAYA: As Malaysia's elderly population continues to grow rapidly, experts are urging the government to introduce a Senior Citizen Act, warning that older adults remain vulnerable under a healthcare system already strained by a severe shortage of geriatric specialists.

Universiti Putra Malaysia's Malaysian Research Institute on Ageing director Assoc Prof Dr Rahimah Ibrahim said the absence of comprehensive legislation has led to weak accountability and increasing

vulnerability among the elderly. Rahimah highlighted the critical shortage of geriatricians as one of the

"As of 2024, there are only 60 such specialists nationwide. With Malaysia projected to have 5.49 million elderly citizens by 2030, we would need at least 549 geriatricians to meet the ideal

ratio of one per 10,000 seniors.
"Currently, we're producing just eight geriatricians a year. That will only bring the total to 108 by 2030, far below what's needed," she said.

She explained that Malaysia's ageing population faces a range of challenges, including limited access to healthcare, weakening family support structures and increasing financial insecurity.

Noting a rise in elderly abandonment cases at hospitals and care homes, Rahimah said such incidents are often the result of urban migration, dual-income household pressures and the erosion of

traditional family support systems.
She also referenced Employees
Provident Fund data from October

2024, which showed that only 36% of active members met the Basic Savings threshold of RM240,000 by age 55, raising concerns about retirees' ability to support themselves.

Universiti Teknologi Mara senior

lecturer Dr Nur Amalina Aziz echoed these concerns, observing that elderly individuals are increasingly being left at hospitals and welfare homes,

"When contacted, these families are often unreachable. Abandonment is frequently due to a lack of family support, financial hardship, strained relationships or disputes," she explained.

Amalina, who also researches issues affecting older persons, stressed the urgent need for legislation that explicitly protects senior citizens from

neglect and abuse.
"The law must include clear obligations, mandatory reporting procedures and definitions of abuse, neglect and abandonment.

"It should also provide emergency shelters, professional medical support,

a dedicated helpline and a one-stop agency for the protection of older persons," she noted.

She pointed out that although Malaysia introduced the National Policy for Older Persons in 1995 and revised it in 2011, there is still no specific law prioritising the needs of senior citizens.

"Many rural areas lack proper

facilities. Attention and resources remain concentrated in urban zones, leaving many older underserved and at risk.

"The rights of the elderly are often

generalised in existing policies, without tailored approaches to address their unique needs," she added. Amalina highlighted Japan and

Singapore as models in addressing the challenges of an ageing population.

"Iapan's Elder Abuse Prevention Act and Employment Stabilisation Act help prevent mistreatment and promote job opportunities for older individuals.

"Singapore introduced the Vulnerable Adults Act in 2018 to

protect those, especially seniors, who are physically or mentally unable to care for themselves.

"Both countries go beyond welfare. They focus on freedom from abuse, financial security and access to lifelong learning and opportunities."

She emphasised that older Malaysians are not a burden and should be empowered to live independently, remain active and feel included in society.

"Older people have given so much to the country, yet many now feel unsafe and unsupported at home.

"Family and community support are key to preventing elder abandonment, but families need proper training to care for their ageing loved ones," she said.

With the right knowledge, they can give better, more respectful care. Many elderly victims stay silent due to poor health or fear of losing their career, which is why public awareness and reporting

# Only 10% of former teachers claimed provident fund

KUALA LUMPUR: Only 10% of former teachers who contributed to the Teachers Provident Fund (TPF) between 1962 and 1972 have come forward to retrieve their unclaimed money from the Accountant-General's

Department (AGD) as of April 2025. Tun Hussein Onn Teachers' Foundation chief executive officer Zahiruddin Mohammad Hanif said this figure represents 185 former teachers or their heirs who have made claims.

As a result, the unclaimed funds under the Unified Teachers Service (UTS) scheme have decreased to RM11.7 million from RM13.58 million in 2018.

"Since the announcement in 2018 not many heirs have come forward. Out of 1,910 contributors, 1,725 have yet to make a claim. So far, fewer than 200 individuals have come forward, which is only about 10%. "The contributors

teachers who served between 1962 and 1972. They are not recipients of government pensions," he told Bernama. Zahiruddin dismissed recent claims

circulating online that the unclaimed TPF contributions of former UTS teachers have reached RM135 million. He explained that contributions

categorised as unclaimed funds remain with the AGD and may still be retrieved at any time.

Commenting on the delay in claims, he noted that many families

contributed to the TPF and outdated contact information has made it for the foundation to reach them.

"It's not that the families are intentionally delaying, but many simply don't know. The addresses we have are outdated, so notification letters are often returned. Without current contact details, we have no way of locating the contributors," he added.

Zahiruddin said the foundation will issue another media statement soon to encourage eligible next of kin to come forward and claim the funds.

He explained that contributors or their next of kin may initiate claims at the AGD which will verify their status

Eligible individuals may check their status at egumis.anm.gov.my or contact the foundation at 03-8890

He stressed that the verification process is important to prevent misuse or fraudulent claims, and emphasised that the foundation has not appointed any third parties or agents to manage the claims

"The list of contributors can be checked via a link uploaded on (the foundation's) official channels. That's the only authorised way to verify

"We've decided not to publish the names in media releases to prevent any risk of exploitation." – Bernama

# **Push for data-driven reforms** ahead of internet speed hike

Expert urges MCMC to address digital divide, improve transparency as 10Mbps minimum standard approaches

PETALING JAYA: As the government prepares to raise the Mandatory Standards on Quality of Service (MSQoS) for internet speeds to 10Mbps next year, the Malaysian Communications and Multimedia Commission (MCMC) has been urged to adopt a more transparent, data-driven approach to monitoring internet quality.

Sunway University wireless communication specialist Prof Dr Rosdiadee Nordin warned that the current benchmark is far from adequate in an era of rapid digital expansion.

He noted that with the internet now regarded as the "fourth utility" – an essential service all Malaysians depend on – it is time for the MCMC to adopt a data-driven strategy to thoroughly

investigate and validate public complaints.
"With data analytics and machine learning now integral to our daily lives, we have entered an era of data-driven decision-making rather than process-driven decision-making.

"Another consideration is to move towards an open platform for monitoring that encourages transparency, especially directly from the subscribers or the public," he added.

According to MCMC, by November 2024 it had audited 4,172 locations (3,988 for 4G and 184 for 5G) based on complaints and received data, identifying 551 instances of non-compliance across 275 4G sites and 19 5G sites

Rosdiadee explained that while the current minimum requirement of 7.5Mbps may suffice for basic smartphone app usage, it often results in a diminished user experience.
"Our drive test in Sunway City found that one

major telco failed to meet the minimum speed for file downloads, while two others only slightly

"In terms of mobile video streaming, over half of the collected data shows that cellular network subscribers can only achieve an average speed of 3Mbps, just enough for basic HD quality streaming on YouTube at 720p video resolution.

"Imagine the findings if we conducted a

similar data collection in suburban and rural areas, which could potentially reveal even lower data rates.

As Malaysia moves towards a digital economy, Rosdiadee highlighted that the current MSQoS sets a minimum 5G download speed of 100Mbps.

However, with many countries already achieving over 200Mbps, which he believes is now the global standard, he urged the telco industry to rethink how it designs and deploys new 5G towers to help Malaysia leapfrog beyond 10Mbps, which is still viewed as a "safe

"The telco equipment and network configurations should be optimised to ensure we can at least keep pace in coverage and data rates with our neighbours in Singapore and Thailand.

"Malaysia is still using the 5G non-standalone network based on 3GPP Release 15, which, although outdated, can deliver speeds above 10Mbps. However, the country has yet to fully adopt the more advanced 5G-Advanced technology (Release 18), which serves as a bridge between current 5G and the future 6G network."

He warned that if certain communities continue to be left behind in digital connectivity, the country risks deepening the

digital divide, leading to knowledge gaps, limited job opportunities and worsening

income inequality.

Future generations from these underserved areas could face educational setbacks, despite the increasing availability of digital learning resources.

"This is reflected in our research in two locations, including the urban poor community in Desa Mentari, where economic hardship limits internet literacy and exposes vulnerable groups to online threats, and the remote indigenous settlement in Tasik Chini, Pahang –

both highlighting serious digital exclusion."
Rosdiadee also urged telecommunications companies to regularly update the MCMC with reports on coverage and data rates, and to plan ahead to manage traffic and anticipate subscriber growth before congestion occurs.

On April 13, Communications Minister

Datuk Fahmi Fadzil revealed that based on a drive test conducted by MCMC on March 5, many areas still fail to meet the MSQoS, which currently requires a minimum speed of 7.5Mbps - set to increase to 10Mbps next year.

MCMC has reportedly directed all telcos in the country to proactively resolve internet access issues on a monthly, state-by-state basis, rather than waiting for customers to lodge complaints before taking action.

## Ministry vows action over Segaliud river pollution

SANDAKAN: The Natural Resources and Environmental Sustainability Ministry (NRES) is taking seriously the issue of pollution in the Segaliud river in Sabah, the main source of treated water for more than 320,000 residents in the district.

In a statement, the NRES said Deputy

Minister Datuk Seri Huang Tiong Sii attended an engagement and dialogue session with residents and government agency representatives on Sunday to discuss the matter.

According to an investigation by the Department of Environment (DOE), all palm oil mills operating around Segaliud river were found to comply with effluent emission standards under the Environmental Quality Act (AKAS) 1974.

The ministry said both NRES and the DOE have taken proactive steps by conducting continuous monitoring to ensure the water quality in Segaliud river remains safe and preserved for local residents.

It also warned that strict action would be taken against any premises found polluting the environment, in line with the amended AKAS 1974, which came into effect on July 7, 2024.

The amendment provides for fines

ranging from RM5,000 to RM10 million and mandatory imprisonment of up to five years.

In line with the Malaysia Madani concept, the ministry emphasised that river sustainability is a shared responsibility requiring close cooperation between the government, private sector and the public.
"With the collaboration and commitment

of all parties, the ministry is confident that river conservation efforts can be carried out effectively for the sake of environmental sustainability for future generations," it added – Bernama

## MCMC to roll out cyber safety initiative in schools

ALOR GAJAH: The Malaysian Communications and Multimedia Commission (MCMC), in collaboration with the Malacca state education department, is coordinating the Internet Safety Campaign, which is expected to begin next month.

Science, Technology, Innovation and Digital Communication state executive councillor Datuk Fairul Nizam Roslan said the campaign would involve over 300 primary and secondary schools in Malacca to raise awareness of online safety and cyber threats. educate students about

"Today, even primary school students have access to social media, making them vulnerable to online dangers such as cyberbullying, paedophilia and scams," he said.

He added that the state is awaiting further instructions from MCMC at the federal level before proceeding with the campaign, which could begin as early as next month or by June at the latest.

He was speaking during the Rembia Aidilfitri

open house on Sunday.

The campaign will also form part of the Wakil
Rakyat Untuk Rakyat programme, aimed at

increasing public awareness of cybercrime risks. Fairul Nizam explained that the initiative complements existing efforts, including the Online Gambling, Fraud and Cybercrime Task Force, which is already active in schools with support from the police, Bank Negara, MCMC and the Department of Information.

"The internet safety campaign adds a new target group – schoolchildren under 13," he added. – Bernama

# Penang LRT Mutiara Line powers ahead on schedule

PUTRAJAYA: The Penang Light Rail Transit (LRT) Mutiara Line project remains on track and is progressing according to schedule, according to roject owner Mass Rapid Transit Corp Sdn Bhd (MRT Corp).

In a statement issued on April 21, MRT Corp reported solid progress over the past three months, with a key milestone being the recent approval of advance works under Section 20A of the Town and Country Planning Act 1976, granted on April 15.

"MRT Corp has also made significant headway in the land acquisition process, securing access to 86 plots to date and completing the gazettement under Section 8 of the Land Acquisition Act 1960.

"This progress, achieved ahead of the original

October 2025 target, represents a major milestone in keeping the project on schedule," the company stated.

MRT Corp noted that SRS Consortium Sdn Bhd, the appointed main civil contractor for Package 1, is currently working to meet several post-award conditions outlined in the contract.

The official Notice to Proceed (NTP) will only be issued once all post-award conditions have been satisfactorily fulfilled.

"As the design-and-build contractor for

Package 1, SRS must finalise the designs and construction drawings for the civil structures within the project scope after receiving the NTP.

"Another critical pre-construction task is the relocation of utilities, which must be completed any station or viaduct-related construction can begin," it added.

# Penang govt urged to resolve land crisis of animal shelter

#### Looming eviction could force dogs under care of NGO back onto streets: Animal association

PETALING IAYA: The Persatuan Haiwan Terbiar Malaysia (SAFM) has urged the state government to step in and resolve the land crisis threatening the future of the Penang

threatening the future of the Penang Animal Welfare Society (4PAWS) shelter in Teluk Bahang.

The non-profit shelter recently revealed via Facebook that the landowner intends to sell the property and has given the organisation until the end of next month to decide whether it can buy the land for RM2.2 million.

SAFM president Kalaivanan Ravichandran warned that with over 700 dogs in 4PAWS's care, the looming eviction poses a critical risk, potentially forcing the animals back onto the streets.

It has issued an urgent appeal, calling on Penang Chief Minister Chow Kon Yeow to immediately allocate permanent land to secure the shelter's future.

"Without government intervention, the fate of the rescued animals remains uncertain. These dogs are not just numbers - they are lives that have been saved from the streets and deserve safe, permanent homes.

"The state government must act now to prevent further harm to these

animals," said Kalaivanan.

He expressed concern that the shelter's closure would disrupt the lives of the dogs that rely on 4PAWS

for daily care and protection.

"The issue of land insecurity is not unique to 4PAWS. As urbanisation accelerates, many animal shelters across Malaysia are being displaced to make way for development.

He stressed that the lack of long-term land security is a growing challenge for animal welfare NGOs, many of which are struggling to provide care for the country's rising

stray population.
SAFM is calling for a dedicated support framework for such organisations, and urging state and federal governments to o sustainable, long-term land shelter solutions.

"Without stable premises, shelters face constant threats of eviction, which limit their ability to continue rescuing and caring for animals," said Kalaiyanan

SAFM has extended a call to other NGOs, the public and corporate players to unite in a collective appeal to the state government.

Kalaivanan said immediate action is essential to avoid forcing hundreds of animals back onto the streets.
"A swift and decisive intervention

from the Penang government is critical to ensure a permanent solution for 4PAWS.

"It is not only about the welfare of the animals; it is about reducing public nuisance and managing stray

populations more effectively." SAFM highlighted the key role that

corporate support could play.

Companies are encouraged to integrate animal welfare into their corporate social responsibility strategies, helping shelters sustain

operations and rescue efforts.
SAFM is also urging Malaysians to step forward, whether through donations, volunteering or advocacy, to support shelters in continuing their

essential mission.

"The role of the community is crucial in ensuring these animals get the protection and care they deserve," said Kalaivanan.

4PAWS founder Barbara Janssen voiced concern over the shelter's

"There are few locations that could accommodate the number of dogs we house. The heartbreaking reality is that we may be forced to release some or even all of them back onto the streets.

Despite fundraising efforts, the shelter has only managed to raise RM60,000 through public donations. "This has been our home for 15

years. Relocating would be extremely difficult. Our fate lies in the hands of the community."

# 35,000 crashes on East Coast Expressway since 2004

KUANTAN: A total of 730 people have lost their lives in road collisions on the East Coast Expressway Phase 1 since it opened in 2004, the Pahang Legislative Assembly heard yesterday.

State Works, Transport and Health Committee chairman Datuk Razali Kassim revealed that the fatalities were part of 35,551 crashes recorded on the expressway up to December last year.

"There are no locations on the

expressway categorised as blackspots

there are several areas where crashes occur frequently. Improvement measures have been taken to reduce the risk of collisions at such locations, including at Km238.7 (westbound) and Km87 (westbound)."

He was responding to Datuk Wong Tat Chee (appointed assemblyman), who had asked for the number of crashes and fatalities recorded along the expressway route within Pahang since its opening, as well as collision-prone hotspots.

Razali said the Malaysian Highway Authority carries out annual analyses to identify crash-prone locations through the Highway Road Accident Analysis and Database System, enabling appropriate mitigation measures to be implemented to help reduce risks at those sites.

effectiveness will mitigation measures monitored to ensure the crash rate can be reduced."

He said AFA Prime Berhad, the

company responsible for operation and maintenance of the expressway, would continue to ensure the safety and comfort of highway users.

He also said measures that will continue to be implemented by AFA Prime include road safety audits, safety campaigns and advocacy sessions with users, as well as ensuring that information and public announcements are delivered quickly and clearly. - Bernama

## Sabah Customs seizes over 70kg drugs worth RM2.4m

KOTA KINARALU: The Customs Department foiled a drug smuggling attempt and seized more than 70kg of various drugs valued at over RM2.4 million between Jan 3 and

Acting Sabah Customs assistant director-general Saidin Jalaluddin said the latest seizure was made on March 28, involving four unmarked packages

at Mas Kargo in Kota Kinabalu. "Checks found that the packages are believed to contain methamphetamine, weighing 71.71kg estimated to be RM2,295,008."

He said the team also seized a package at Pos Aviation Kota Kinabalu on March 1.

"The package contained items suspected to be ketamine, weighing 434g and estimated to be worth RM86,800."

He said in an operation conducted

from Jan 31 to February 28, four packages were seized at Mas Kargo.

"The packages are believed to contain 15.35kg of *ganja*, worth RM47,606.70," he said, adding that the cases are being investigated under Section 39B of the Dangerous Drugs Act 1952. – Bernama

# **Business flaunts traditional calligraphy**

Owner produces each piece by hand, does not rely on digital sketch or template

KUALA LUMPUR: A request from a friend to create a wedding banner using traditional calligraphic or *khat* lettering became the starting point for Yusairah Hazrami, 29, to expand a business that she has been building

What makes this mother of three's work captivating is that every banner she produces is entirely handwritten. making each piece uniquely artistic and rich in aesthetic value.

"I first learned khat while studying at a religious school in Shah Alam (in Selangor), where I had the chance to attend special calligraphy classes taught by an *ustaz* (religious teacher) from Yayasan Restu, a well-known institution in the field of calligraphy," she told Bernama.

When she first took up calligraphy, she used to write short phrases, such as "Assalamualaikum" or the names of customers, on items such as canvas bags, bookmarks and pencil cases, which she sold online.

Her talent began to gain wider attention when videos of her work were widely spread from her TikTok account @yusbuatkhat with the hashtag #bannerjawi, leading to a surge in demand for her surge in deman handwritten banners.

Yusairah, who also works as a part-time teacher at a private religious school, uses calico fabric as the base for her banners, with all writing done freehand using black acrylic paint and three brushes of different sizes. She does not rely on any digital sketch or template.

"When I first started (doing calligraphy), I would do pencil outlines but over time my became so familiar with the flow of the script that I do it straightaway with the brush, letting my creativity guide me.

"Should I make a mistake, I patch it up with a piece of fabric if it is a small error. In the case of a major error, I replace the entire banner," she said, adding that she can complete between eight and 10 banners a day, depending on the length of the text and the complexity of the calligraphy requested by the client.

To meet the growing demand for

the help of two homemakers to assist with adding patterns and decorations, ensuring the overall layout and design are balanced.

Despite having to juggle her banner business teaching responsibilities, she remains committed to delivering every order on schedule, Bernama reported.

"I hope more people, especially the younger generation, would learn to appreciate the art of *khat* writing as it represents our cultural identity and heritage. I want to make this art feel contemporary and relevant

## Makeup artist shares transformations online

KUALA LUMPUR: At first glance, the elaborate special effects (SFX) makeup created by Suzana Abdullah could easily be mistaken for the work

of a professional artist, but the Johor native is entirely self-taught. Driven by a lifelong interest in drawing and makeup, Suzana, a content creator in her 40s, shares her striking transformations on social media.

"I have loved drawing since I was little. Back then, it was on paper. Now, I draw on faces.

"I would watch SFX makeup tutorials by TikTokers, then try creating my own looks," she told Bernama

With no formal training, she

honed her skills entirely through online resources.

She uses tools such as liquid latex, clay, prosthetic glue and contact lenses to create eerie, fantastical and sci-fi-inspired effects.

One of her recent projects, which was shared on her TikTok account @nanajer, drew attention for its

surreal, doll-like appearance.

To achieve the look, she spent more than three hours covering her entire face, including her nose, with fine thread.

"My biggest challenge was breathing as my nose was completely covered and the thread had a strong odour.

"I had to breathe through

my mouth the entire time," said Suzana, who was intrigued by the idea of experimenting with a doll-inspired concept.

Despite the time and precision involved, she finds the creative process enjoyable and therapeutic.

For another project, she explored dramatic blood effects, although the content could not be fully shared online due to platform guidelines that flagged it as sensitive.

# Pope Francis, first Latin American pontiff, dies at 88

#### Leaves legacy of humanity, justice, human fraternity

VATICAN CITY: Pope Francis, the first Latin American leader of the Roman Catholic Church, has died, the Vatican said yesterday, ending an often turbulent reign marked by division and tension as he sought to overhaul the hidebound institution. He was 88, and had survived a

serious bout of double pneumonia.
"Dear brothers and sisters, it is

bear bround sadness I must announce the death of our Holy Father Francis," Cardinal Kevin Farrell announced on the Vatican's TV channel. "At 7.35 this morning the Bishop of Rome, Francis, returned to the house of the Father.'

Francis' death comes a day after the pope had made his first prolonged public appearance since being discharged on March 23 from a

38-day hospital stay for pneumonia.

On Easter Sunday, Francis had entered St Peter's Square in a popemobile shortly after mid-day, greeting cheering crowds. He had also offered a special blessing for the first time since Christmas.

Leaders across the world were reacting to the pope's death with praise for his efforts to reform the church and offering condolences to the world's 1.4 billion Catholics. "He inspired millions, far beyond

the Catholic Church, with his humility and love so pure for the less fortunate," said European Commission President Ursula von

Jose Ramos-Horta, the president of East Timor, where Francis had visited in September last year as part of the longest foreign trip of his papacy, said the pope "leaves behind a profound legacy of humanity, of justice, of human fraternity". Jorge Mario Bergoglio was elected pope on March 13, 2013, surprising many church watchers who had seen

the Argentine cleric, known for his concern for the poor, as an outsider.

He sought to project simplicity into the grand role and never took possession of the ornate papal

apartments in the Apostolic Palace used by his predecessors, saying he preferred to live in a community

setting for his "psychological health."

He inherited a church under attack over a child sex abuse scandal and torn by infighting in the Vatican bureaucracy, and was elected with a clear mandate to restore order.

But as his papacy progressed, he faced fierce criticism from conservatives, who accused him of trashing cherished traditions. He also drew the ire of progressives, who felt he should have done much more to reshape the 2,000-year-old church.

While he struggled with internal dissent, Francis became a global superstar, drawing huge crowds on his many foreign travels as he tirelessly promoted interfaith dialogue and peace, taking the side of the marginalised, such as migrants.

Francis appointed nearly 80% of the cardinal electors who will choose the next pope, increasing the possibility that his successor will continue his progressive policies, despite the strong pushback from traditionalists. - Reuters

# A voice for compassion and peace

VATICAN CITY: During his 12 years as head of the Catholic Church, Pope Francis was a voice for compassion and peace, reformed the Vatican government and took action against clerical child abuse.

Here are some of his main

#### Battle against sex abuse

Dealing with the scourge of sexual abuse by clergy and its cover-up was one of the biggest challenges for Pope

Francis when he took office in 2013.

A 2018 trip to Chile proved a turning point. Francis initially defended a Chilean bishop against allegations he covered up the crimes of an elderly priest, demanding that the accuracy show proof of his quilt the accusers show proof of his guilt.

He later admitted making "grave mistakes" in the case – a first for a pope. He summoned all of Chile's bishops to the Vatican, after which

they all submitted their resignations.

Later that year, he stripped the cardinal title from abusive US cleric Theodore McCarrick, and in 2019

removed his status as a priest.
Also in 2019, he held an unprecedented summit that heard from victims, where he promised an "all-out battle" against clerical abuse.

Concrete changes followed, from

opening up Vatican archives to lay courts to making it compulsory to report suspicions of abuse and any attempts to cover it up to authorities.

However, anything said in the confessional box remains sacrosanct – and activists say he did not do

One campaigner, Anne Barrett Doyle, told AFP last year that the reforms had been "superficial".

"Structurally, they retain all the elements of cover-up: lack of transparency, lack of external oversight, lack of mandatory severe sanctions," she said.

#### Diplomacy

Francis travelled widely, making 47 trips overseas that gave priority to what he called the "peripheries", countries with small or marginalised Catholic commu-

nities.

He regularly called for peace in hotspots such as Sudan, Gaza and Ukraine, and promoted dialogue with

other faiths, particularly Islam.
The Vatican operates behind the scenes in many countries, with diplomatic successes including mediating the rapprochement between the United States and Cuba

In 2018, the Vatican agreed a

historic but also controversial deal with Beijing over the appointment of bishops in China. But the pope's calls for peace in

Ukraine failed to have any visible impact. Francis sparked outrage from Kyiv last year after praising those in the country who had the "courage to raise the white flag and negotiate".

His calls for an end to fighting in the Middle East fell flat and he drew criticism from Israel after condemning strikes on Gaza as "cruelty"

#### Compassion, social justice

He sought to forge a more open Church, particularly towards divorced, married and other members.

approach traditionalists, in particular his decision to authorise blessings of same-sex couples in some cases. The Vatican was forced to clarify its position after an outcry in Africa and the United States.

The son of Italian immigrants to Argentina, Francis strongly defended the rights of migrants, including criticising US President Donald Trump's plans for mass deportations.

Francis was also a vocal campaigner for the environment. In his groundbreaking 2015 encyclical, he urged the world to act quickly to

tackle environmental issues.

#### Reform

From decentralising power and increas-ing transparency to providing greater roles for lay people and women, Francis implemented fundamental reforms of the Roman Curia, the central government of the Holy See.

The reforms were consolidated in a 2022 constitution that reorganised the Vatican's dicasteries, or ministries.

Francis took aim at the murky finances of the Vatican, creating a secretariat for the economy in 2014, clamping down on corruption and stepping up scrutiny of investments and the Vatican Bank, which led to the

closure of 5,000 accounts. He also revolutionised the Synod, a Catholic discussion body, by involving lay members including women. Since 2021 it has looked at the future of the Church, but key decisions, such as allowing women to become deacons, were not due until later this year.

In his institutional reforms, again, Francis faced strong opposition, with some critics accusing him of "tyrannical" behaviour. – ĀFP





# Cyberscam 'cancer' spreading globally

#### Crisis at inflection point, says UN report

BANGKOK: Asian crime syndicates behind the multibillion-dollar cyberscam industry are expanding globally including to South America and Africa, as raids in Southeast Asia fail to contain their activities, the United Nations said in a report yesterday.

Criminal networks that emerged in

Southeast Asia in recent years, opening sprawling compounds housing tens of thousands of workers, many trafficked and forced to scam victims around the world, have evolved into a sophisticated global industry, the United Nations Office on Drugs and Crime (UNODC) said.

Even as Southeast Asian governments have intensified a crackdown, syndicates have moved within and beyond the region, the agency said, adding that a "potentially irreversible spillover has taken place ... leaving criminal groups free to pick, choose, and move... as needed". "It spreads like a cancer," said John Wojcik, a regional analyst for UNODC. "Authorities treat it

in one area, but the roots never disappear; they

Conservative estimates indicate there are

hundreds of large-scale scam farms around the world generating tens of billions of dollars in annual profits, the UNODC said. The agency called on countries to work together and intensify efforts to disrupt the gangs' financing. "The regional cyberfraud industry ... has cutnaced other transational crimes given that

outpaced other transnational crimes, given that it is easily scalable and able to reach millions of potential victims online, with no need to move or traffic illicit goods across borders," said

The United States alone reported more than US\$5.6 billion (RM24.3 billion) in losses to cryptocurrency scams in 2023, including more than US\$4 million in pig-butchering scams or romance scams designed to extort money from often elderly and vulnerable people.

In recent months, authorities from China, In recent months, authorities from China, where many of the gangs originate, Thailand and Myanmar have led a crackdown on scam operations in lawless areas of the Thai-Myanmar border, with Thailand cutting power, fuel and internet supply to areas housing scam compounds.

compounds.

But syndicates have adapted, shifting operations between "the most remote, vulnerable, and underprepared parts of Southeast Asia", especially in Laos, Myanmar, and Cambodia, and beyond, exploiting jurisdictions with weak governance and high rates of corruption, the UNODC said.

Raids in parts of Cambodia where the industry is most visible "led to significant expansion in more remote locations," including the country's western Koh Kong province, as well as areas bordering Thailand and Vietnam, the UN agency said.

New sites also continue to be developed in Myanmar, it added.

Syndicates have expanded into South America, the UN agency said, seeking to enhance money laundering and underground banking partnerships with South American drug cartels.

They are increasingly establishing operations in Africa, including in Zambia, Angola, and Namibia, and in Eastern Europe including Georgia, the agency said.

including Georgia, the agency said.
Gangs have also rapidly diversified their workforce, recruiting people from dozens of nationalities, according to the agency, reflecting how the industry scams targets across the globe and has sought to evade anti-trafficking efforts.

Citizens of more than 50 countries – from Brazil to Nigeria, Sri Lanka and Uzbekistan – were rescued during recent crackdowns on the Thai-Myanmar border.

The international community is at a "critical inflection point", the UNODC said, urging that failure to address the problem would have "unprecedented consequences for Southeast Asia that reverberate globally". – Reuters

#### Vietnam tycoon has financial fraud life sentence reduced

**HANOI:** Vietnamese real estate tycoon Truong My Lan has had her life sentence for financial fraud and money laundering reduced to 30 years on appeal, in part due to the recovery of stolen funds, state media outlets reported yesterday.

Lan, the chairwoman of real estate

developer Van Thinh Phat Holdings Group, still faces execution, however, after being sentenced to death in another case last year for her role in a US\$12 billion (RM52.65 billion) fraud case, Vietnam's largest on record. She lost her appeal in that case in December.

The *Dan Tri* newspaper said that in her appeal in the second case yesterday, the jury found Lan had many mitigating circumstances and had shown repentance, so the court reduced the life sentence to a fixed

"The court determined that the amount of money recovered and expected to be recovered was very large," the report said Lan's lawyers did not immediately respond

to a request for comment. Lan was found guilty in October of obtaining property by fraud, money laundering and illegal crossborder money transfers.

She was accused of illegally transferring

US\$4.5 billion into and out of Vietnam and laundering 445 trillion dong (RM79.4 billion), while her companies were accused of illegally raising over 30 trillion dong from issuing bonds to investors - Reuters

# Missiles add bite to US, Philippines drills

MANILA: The Philippine and US militaries yesterday kicked off three weeks of joint exercises that will simulate a "full-scale battle scenario", as the two allies seek to deter to Beijing's ambitions in the South China Sea.

Around 17,000 troops are expected to take part in the annual *Balikatan*, or "shoulder to shoulder" drills, which for the first time will include an integrated air and missile defence simulation to be attended by President Ferdinand Marcos.

Sophisticated US weapons including the

Sophisticated US weapons including the highly mobile" NMESIS anti-ship missile system will also be deployed, including near a crucial chokepoint in the waters separating the northern Philippines from self-ruled Taiwan.

"We will demonstrate not just our will to uphold our mutual defence treaty in existence since 1951 but our matchless capability to do so," US Marine Corps Lieutenant General James Glynn said yesterday at the *Balikatan* opening ceremony in Manila.

"Nothing builds bonds more quickly than

shared adversity," he said, without specifying a common threat.
Philippines Major General Francisco Lorenzo

said the exercises would reinforce the country's ability to address "contemporary security

The Philippines has been engaged in months of confrontations with Beijing over disputed areas of the South China Sea.

It has steadily deepened defence cooperation with treaty ally the United States since Marcos took office in 2022 and began pushing back on China's sweeping claims to the crucial waterway.

During a recent visit to Manila, US Defence Secretary Pete Hegseth said Washington was "doubling down" on the alliance.
"Deterrence is necessary around the world,

but specifically in this region, in your country considering the threats," he said in late March.

While the bulk of visiting forces involved in Balikatan will be from the United States, countries including Australia and Japan are sending smaller contingents.

Last year's Balikatan featured tests of the US Typhon mid-range missile system, which was left

behind following the exercises.

The Philippine Army subsequently said it was planning to acquire the Typhon, sparking

arnings from China of a regional "arms race".

Chief of Staff Romeo Brawner last month said the Philippines was indeed looking to upgrade its arsenal.

"We are looking at acquiring more missile systems to complete the integration of our air and missile defence," he told New Delhi's Raisina Dialogue, adding more warships and fighter jets

were also being sought.

On April 2, the United States said it had approved the possible sale of US\$5.58 billion (RM24.48 billion) in long-coveted F-16 fighter jets to the Philippines, though Manila said the deal was "still in the negotiation phase".

A week later, the Philippines took possession of the first of two corvette-class warships with "advanced weapons and radar systems' acquired from Hyundai Heavy Industries.

Given the Philippines' proximity to Taiwan, Manila's cooperation would be crucial in the event of any US conflict with China.

On April 1, as Chinese ships and warplanes surrounded the island in a simulated blockade, Brawner said his country would "inevitably" be involved should the democracy be invaded.

While Manila later said Brawner's comments were primarily referencing efforts to retrieve Filipino workers in Taiwan, its Enhanced Defence Cooperation Agreement with Washington gives US forces access to nine bases in the country.

Two of those are located in Luzon's northernmost Cagayan province, which will host live-fire drills during Balikatan this year. – AFP

#### Yoon back in court for criminal trial

SEOUL: Former president Yoon Suk Yeol appeared in court yesterday for the second hearing of his criminal trial to defend himself

against insurrection charges over his short-lived declaration of martial law. Yoon was formally stripped of office earlier this month, after being impeached and suspended by lawmakers over his Dec 3 attempt to subvert civilian rule, which saw armed soldiers deployed to parliament.

He became South Korea's first sitting head of state to be arrested in January in connection with the criminal case against him, although he was later released on

procedural grounds.

During the first day of his criminal trial last week, the ex-president defended himself in court, speaking for more than 90 minutes,

denying that he had committed insurrection.
If found guilty, Yoon would become the third South Korean president to be found guilty of insurrection, after two military leaders in connection with a 1979 coup.

For charges of insurrection, Yoon could be sentenced to life in prison or the maximum

penalty: the death sentence.
But it is highly unlikely that sentence would be carried out. South Korea has had an unofficial moratorium on executions since

Separately, last week police attempted to raid Yoon's former presidential office and his security detail as part of a probe into "alleged obstruction of an arrest warrant execution' but failed after presidential security denied them permission to enter the residence.

Yoon spent weeks holed up in his compound in January, protected by members of the Presidential Security Service. His guards had installed barbed wire and

barricades at the residence, forcing hundreds of police officers and investigators to use ladders and scale perimeter walls to reach the

main building.

#### Pentagon chief shares sensitive info again

**WASHINGTON:** US Defence Secretary Pete Hegseth shared details of a March attack on Yemen in a message group that included his wife, brother and personal lawyer, a source familiar with the matter told Reuters on Sunday.

The revelations of a second Signal chat raise more questions about Hegseth's use of an unclassified messaging system to share highly sensitive security details and come at a particularly delicate moment for him, with senior officials ousted from the Pentagon last week as part of an internal leak investigation.

ln the second chat, Hegseth shared details of the attack similar to those revealed last month by *The Atlantic* magazine after its editor-in-chief, Jeffrey Goldberg, was included in a separate chat on the Signal app by mistake, in an embarrassing incident involving all of President Donald Trump's most senior national security officials.

The person familiar with the matter,

who was speaking on condition of anonymity, said the second chat included about a dozen people and was created during his confirmation process to discuss administrative issues.

The chat included details of the schedule of the airstrikes, the person

Hegseth's wife, Jennifer, a former Fox News producer, has attended sensitive meetings with foreign military counterparts, according to images the Pentagon has publicly posted.

Democratic lawmakers said Hegseth could no longer stay in his job. – Reuters

#### **GUNMEN ATTACK POWER PLANT SITE**

SANTIAGO: Gunmen attacked a Chinese-owned hydroelectric plant under construction in Chile plant under construction in Chile on Sunday, setting fire to dozens of trucks and heavy earth-moving equipment. The Rucalhue power plant is being built by Rucalhue International Water and Electric Corporation, and is projected to cost U\$\;550\] million (RM1.5\) billion). It is being built along the Biobio, one of Chile's main rivers, and is opposed by indigenous people who say it will harm the environment. The attackers burned 45 trucks and five pieces of earth-moving equipment, he said. earth-moving equipment, he said. Two security guards were wounded in the attack on the site, which is 550km south of Santiago.

#### **WOMEN PROTESTERS TORCH MINE**

BISSAU: Women protesters in Guinea-Bissau on Sunday attacked a Chinese-run site in the northwest of the country mining zircon, setting fire to equipment, the interior minister said. One protester said they had acted after the authorities failed to act on their complaints that the activity was damaging farms and ruining the environment. Several women and a village leader were arrested following the protest at Nhiquin, near the resort town of Valera not near use resort town or valera not far from the border with Senegal. Protester Aissato Cadjaf said: "We told them we didn't want sand extracted without our consent. All our rice fields are destroyed. There are no more fish in the river near the site." – AFP

# 'Medic killings were summary executions'

#### Gaza civil defence agency rejects Israeli military report

GAZA CITY: Gaza's civil defence agency yesterday accused the Israeli military of carrying out "summary executions" in the killing of 15 rescue workers last month rejecting the findings of an internal investigation by the army.

The medics and other rescue

workers were killed when responding to distress calls near Gaza's southern city of Rafah early on March 23, days into Israel's renewed military offensive.

Among those killed were eight

Red Crescent staff members, six from the Gaza civil defence rescue agency and one employee of UNRWA, the UN agency for Palestinian refugees, according to the UN humanitarian agency OCHA and Palestinian rescuers.

"The video filmed by one of the

paramedics proves that the Israeli occupation's narrative is false and occupation's narrative is false and demonstrates that it carried out summary executions," said Mohammed Al-Mughair, a civil defence official.

He accused Israel of seeking to "circumvent" its obligations under international law.

Following the shooting, the Red Crescent released a recovered from the phone of one of the victims. It does not show executions, but contradicts the forward by the Israeli military.

The video shows clearly that the

The video shows clearly that the ambulances were travelling with sirens, flashing lights and headlights on. The military had claimed the ambulances were travelling "suspiciously" and without lights.

The incident drew international condempation including concerns

condemnation, including concern about war crimes from UN human rights commissioner Volker Turk.

An Israeli military investigation

report released on Sunday "found no evidence to support claims of execution" or "indiscriminate fire" by its troops, but admitted to operational failures and said it was firing a field commander.

It said six of those killed were

militants, revising an earlier claim

that nine of the men were fighters.

The dead, who were buried in sand by Israeli forces, were only recovered several days after the attack from what the UN human rights agency OCHA described as a

"mass grave".

The Palestine Red Crescent
Society denounced the report as "full of lies".

"It is invalid and unacceptable,

as it justifies the killing and shifts responsibility to a personal error in responsibility to a personal error in the field command when the truth is quite different," said Red Crescent spokesperson Nebal Farsakh. The Israeli investigation said

there were three shooting incidents

Here were three shooting incidents in the area on that day.

In the first, soldiers shot at what they believed to be a Hamas vehicle.

In the second, around an hour later, troops fired "on suspects emerging from a fire truck and ambulances", the military said.

The investigation determined that the fire in the first two incidents resulted from an "operational misunderstanding by the troops".

In the third incident, the troops fired at a UN vehicle "due to operational errors in breach of regulations", the military said. - AFP

# Russia, Ukraine accuse each other of violating truce

KYIV: Russia launched missiles and drones targeting Ukraine early yesterday, waking up Kyiv and the eastern half of the country, hours after the one-day Easter ceasefire declared by Russian President Vladimir Putin came to an end.

There were no immediate reports of injuries or major damages from the attacks, regional Ukrainian officials said on social media.

Ukraine's air force said Russia launched 96 drones and three missiles in overnight attacks targeting Ukraine, causing damage in the Kharkiv, Dnipropetrovsk and

Cherkasy regions.

Air defence units shot down 42 Russian drones and another 47 drones were redirected by electronic warfare.

Both Kyiv and Moscow had accused each other of thousands of attacks that violated the truce that the Kremlin indicated on Sunday would not be extended.

Washington said it would welcome an extension of the truce, and President Volodymyr Zelenskiy reiterated several times Ukraine's willingness to pause strikes for 30 days in the war.

But Putin. who launched Russia's invasion of Ukraine in February 2022 and who ordered on Saturday the halt in all military activity along the front line until midnight Sunday, did not give orders to extend it.

"There were no other commands," TASS cited Kremlin spokesman Dmitry Peskov as saying when asked whether the ceasefire could be prolonged.

Zelenskiy said early yesterday that his forces were instructed to continue to mirror the Russian army's actions.

"The nature of Ukraine's actions will remain symmetrical: ceasefire will be met with ceasefire, and Russian strikes will be met with our own in defence. Actions always speak louder than words," he said. Russia's Voronezh region that

borders Ukraine was also under air raid alerts for two hours overnight, and the borders regions of Kursk and parts of Belgorod were briefly under missile threat as well, regional officials said.

Officials said.
While there were no air raid alerts
in Ukraine on Sunday, Ukrainian
forces reported nearly 3,000
violations of Russia's own ceasefire with the heaviest attacks and shelling seen along the Pokrovsk part of the frontline, Zelenskiy said. Russia's Defence Ministry said on

Sunday that Ukrainian forces had shot at Russian positions 444 times and said it had counted more than 900 Ukrainian drone attacks, saying also that there were deaths and

injuries among civilians.
Reuters could not independently verify the battlefield reports.

# nersive learning

'N today's rapidly evolving world, knowledge acquisition is no longer about passive absorption, it is about active engagement, critical thinking and application.

Yet, many educational practices remain anchored in traditional content delivery, assuming that information alone equates to learning. The reality, however, is far more complex.

Consider the experience of many educators – a well-planned lesson, rich in content and structure - met with disengaged students of bored expressions, distracted minds and a lack of meaningful interaction.

This disconnect is not due to a

lack of effort from educators or interest from students but rather a fundamental misalignment between how information is taught and how it is best absorbed

is best absorbed.

A growing number of educators worldwide are shifting their pedagogical approaches to embrace methodologies that foster immersive learning experiences.

One such approach is Dorothy Heathcote's Mantle of the Expert, which positions students as active participants rather than passive recipients. This technique reimagines traditional teaching by placing learners in real-world or fictional scenarios where they take on expert roles, engaging deeply with

content in a way that fosters critical thinking and problem solving.

I first encountered the Mantle of the Expert in 2008, during a pivotal career transition. What was meant to be a dream job, blending my love for the arts and education, soon became

a challenging experience.

Despite my passion and well-prepared lessons, I found myself grappling with disengaged students. No matter how structured or detailed my plans were, something wasn't clicking. The disconnect was clear: I was teaching but they weren't truly learning.

Determined to bridge this gap, I delved deeper into alternative pedagogical approaches - and discovered the Mantle of the Expert.

The concept immediately resonated.

I began reworking my lessons, moving away from rigid dependence on ready-made texts and scripts, most of which were rooted in Western contexts, and instead turned to more relatable, local narratives. I started posing scenarios, asking questions and inviting students to imagine, create and dream.

The impact was especially profound in my writing classes. By encouraging students to approach their work from their own perspectives - as experts of their own experiences - their writing transformed. What emerged were pieces that were deeply original, personal and culturally grounded. students were not just completing assignments - they were owning their stories.

This approach is not limited to the arts. For instance, in a US secondary school, educators applied the Mantle of the Expert to Russian literature studies. Instead of merely reading Pushkin, Gogol, Tolstoy and Chekhov, students were immersed in 19th-century Russia, assuming roles as serfs, navigating societal hierarchies and debating ethical This dilemmas. role-play dilemmas. This role-play transformed the learning experience, cultivating empathy and a nuanced understanding of historical and literary contexts, skills that extend far beyond the classroom.

Closer to home, this method

can be seamlessly integrated across disciplines. Imagine first-year law students stepping into the role of practising lawyers, analysing cases in a gamified environment or honing their advocacy skills in a virtual reality moot court.

Picture biology students using HoloLens to explore human anatomy and navigate real-world medical scenarios, simulating the decisionmaking processes of experienced professionals.

By shifting the focus from teaching content to experiential discovery,

educators empower students to engage, analyse and innovate, skills are crucial in an era information is readily available but critical thinking remains paramount.

While textbooks, theories and structured instruction remain foundational, they should serve as tools for exploration rather than rigid directives. The future of education lies not in delivering more content but in creating environments where students take ownership of their learning.

If we are serious about developing the next generation of thinkers, problem-solvers and leaders, we must rethink how we view our students, not as passive learners but as experts in the making.

Prasarana had shared a statement that the advertisement had adhered to these standards before its release. Yet, the uproar due to the misrepresented image forced them to retract the ad to maintain harmony.

This incident starkly illustrates the formidable influence and inherent risks of social media in shaping public perception. A context-deprived image can eclipse the full narrative, leading to widespread misconceptions and unwarranted outrage.

Such scenarios underscore the critical need for robust media literacy among the populace. Without the skills to critically assess and interpret media content, individuals are more susceptible to accepting and propagating misinformation, with or

without malicious intent. This not only distorts public discourse but also poses significant challenges to social cohesion and informed decision-making. # **Legal coverage of Putra Heights blast**

#### COMMENT by Dr Wilson Tay Tze Vern

HE recent gas pipeline explosion at Putra Heights on April 1 has raised pressing legal questions Malaysia's preparedness, accountability structures regulatory safeguards

regulatory safeguards when industrial disasters occur. With over 227 houses and 365 vehicles affected, and 87 homes reportedly written off as total losses, victims now face a long, complex journey towards compensation and recovery.

#### Gaps in protection

is commonly assumed that meowners can recover an recover through homeowners compensation insurance policies. However, this is only possible if adequate home fire insurance has been purchased heforehand

While fire insurance is generally a prerequisite for mortgaged homes, owners of older and fully paid-off properties may have little or no coverage, leaving them solely responsible for any losses.

Even where fire insurance exists, it typically covers only structural damage and fixed fittings. High-value movable items such as laptops, mobile devices and entertainment systems, are often uninsured and may be excluded from coverage. Items of sentimental value are irreplaceable. Moreover, long-term depreciation of property due to adverse publicity is generally not compensable. For vehicles, owners who opted

only for basic third-party insurance - common for older vehicles, notorcycles and commercial vehicles – are unlikely to be covered for fire-related damages. This potentially leaves many without financial recourse.

The explosion and subsequent

suspension of gas transmission in the area also disrupted operations at about 200 nearby factories, including food manufacturers and metal processing facilities. In legal terms, these are examples of "pure economic loss" - financial losses not arising from injury or physical damage but from the indirect consequences of the incident.

Under current Malaysian law, such losses are generally non-

such losses are generally non-recoverable.

In the 2018 Federal Court decision of Tenaga Nasional Berhad v Batu Kemas Industri & Anor, it was clarified that even where negligence is established, damages for pure economic loss may not be recoverable.

This significantly restricts legal remedies for the affected industries and raises questions about whether existing laws adequately reflect the economic interdependencies of modern industrial zones.
Public scrutiny has turned to the

roles played by the pipeline owner, the Energy Commission, and the

local authority.

Several key statutes govern the responsibilities of these parties, including the Gas Supply Act 1993 (Act 501) (as amended in 2016), the Gas Supply Regulations 1997 [P.U.(A) 287], the Energy Commission Act 2001 (Act 610) and the Street Designee and Building the Street, Drainage and Building Act 1974 (Act 133).

As the licensed gas transporter

in the affected area, the pipeline owner is responsible for the safety and maintenance of gas installations under Parts III and VI of the 1997 Regulations.

To date, there is no indication if

the pipeline owner failed in these

responsibilities.

The Energy Commission's duties are outlined in Section 4(1) of Act

501, including the mandate "to protect the public from dangers arising from the distribution of gas through pipelines" [Section 4 (1)(f)]. Meanwhile, the local authority's responsibilities under Act 133 include the reported issuance of a

include the reported issuance of a permit for excavation works in the rea prior to the incident.

However, statutory immunities complicate any imposition of liability. The Energy Commission is protected from certain legal actions under Section 37 of Act 501 while the local authority is protected under Section 95(2) of Act 133 as explained by the 2006 Federal Court case of Majlis Perbandaran Ampang Jaya v Steven Phoa Cheng Loon. These protections may limit the availability of legal recourse against

the public authorities involved.
While contractor negligence

remains a possibility, it must be emphasised that legal liability cannot be determined until investigations are complete.

Even if such negligence is established, questions remain about whether the contractor would have the financial resources or insurance coverage to compensate victims on this scale. This underscores the importance of mandatory liability insurance and stringent regulatory controls for high-risk works near critical infrastructure.

#### Resilient legal framework

The federal government, alongside the Selangor state government and the pipeline owner, have extended commendable *ex gratia* financial assistance to the victims.

Nonetheless, it is also important

that stronger legal protections are developed to address the aftermath of similar industrial tragedies in the future.

The Putra Heights explosion is a sobering reminder that as Malaysia advances its infrastructure and industrial capacity, our legal and regulatory systems must keep pace. Strengthening protections, closing insurance gaps and ensuring accountability are no longer optional - they are essential to safeguarding lives and livelihoods.

This is exactly where the problem lies.

Many people don't know who they want to be. They scroll through social media, absorbing endless highlight reels of success and perfection and end up blindly following what is popular.

accordingly, chances are you will start
meeting those expectations. It is not
magic; it is psychology.

Some may say: "Isn't this just
pretending?" Well, no. Pretending is
putting on a false front for others. "Faking

pretending: Well, No. Tretending is putting on a false front for others. "Faking it till you make it" is about putting yourself through the process of growth. Compare it to social media, where

many people are actually pretending. They post filtered versions of their lives, carefully curating an image they want others to see but the problem is they aren't living it and they aren't growing into that person, they are just crafting an illusion.

That is not what we are doing here What I'm talking about is consciously stepping into a role, taking small, consistent actions every day and allowing yourself to become what you set out to be. There is a huge difference.
The tricky part is not trying to start;

it is staying the course. Sticking to your path when things get hard, when self-doubt creeps in and when results don't show up immediately – that is the test.

My next question on anthropology was then directed to another close friend, Dinesh Nair, a UK Chevening scholar, who completed his Masters Social Anthropology University of Manchester in 2023.

Dinesh feels passionately about anthropology as a degree to be pursued by students, seeking seeking answers to their cultural identity and also pursuing a career in a multicultural and diverse society such as Malaysia.

"Many of the challenges facing Malaysian institutions - whether in education, corporate culture, or governance - are not just policy or strategy problems, but cultural and social ones.

"I am an active advocate of applied anthropology, which is used to solve real world problems and achieve organisational goals," said Dinesh.

Do you think students should be encouraged anthropology?

Yes, students should be encouraged to take up anthropology. There is a common misconception that anthropology is primarily about studying communities, particularly indigenous tribes. In fact many do not realise that anthropology has evolved far beyond this traditional

The versatility of the degree is one of its most valuable features. For example, the growing demand for corporate anthropologists highlights the value of anthropological methods – such as participant observation and ethnographic research addressing challenges that range behaviour to enhancing data analysis driving organisational transformation.

The same can be said about medical anthropologists, whose insights into patients' perceptions of illness, associated stigma and resistance to treatment are increasingly sought after globally to transform healthcare.

Another compelling reason for students to view anthropology as a possible course is the skills it cultivates. Firstly through rigorous training, students learn to set aside deeply held beliefs, biases and preconceived notions, enabling them to uncover authentic insights about a community and organisation.

This goes to the very heart of anthropology, which is to understand people on their own terms, without letting personal assumptions judgements cloud their analysis.

Secondly, students learn to think holistically, by taking into account historical, socio-cultural, political and economic contexts. This allows for the development of solutions that are sustainable, cultura appropriate and ethnically sound.

Why do you think it is so important to consider human behaviour now? Anthropology wants to analyse what Anthropologists can uncover belief systems, values and social norms

Today is the age of data overload. and automation, so human insight is a rare and valued skill.

Global tech players, including Microsoft which is one of the largest recruiters of anthropologists, are beginning to realise that while data may expose what people do, anthropology reveals why - offering the depth needed for strategic, informed decision making.

What do you personally find so

fascinating about anthropology? What fascinates me most about the subject can be summed up: It makes the familiar strange and the strange familiar.

It gives us the tools to step outside of our own world views and immerse ourselves in the perspective of others. It trains us to avoid tunnel vision. Ideas that seemed strange or distant begin to reveal their logic, reminding us that ideas which may appear foreign to us can be meaningful to another.

This shift in perspective is what out-of-the-box enables truly thinking, whether applied in a remote community research setting or in a Fortune 500 corporate boardroom.

# JS-SEZ set to strengthen Asean supply chain resilience

IOHOR BAHRU: The Johor-Singapore Special Economic Zone (JS-SEZ) is set to enhance Asean's supply chain efficiency and resilience, said Investment, Trade and Industry Minister Tengku Datuk Seri Zafrul Abdul Aziz.

Additionally, he said, the proposed establishment of an Asean Industrial Park within the JS-SEZ will contribute towards improving regional economic integration and attracting high-value investments.

He believed that the proposed industrial park aligns with the aspiration to enhance supply chain

efficiency and resilience.
"Ultimately, we want the JS-SEZ to be more than just a bilateral framework – it is a value proposition for the whole of Asean," he said in his keynote address at the JS-SEZ Joint Business and Investment Forum yesterday.

The two-day event, themed "JS-SEZ: Bridging Economies, Strengthening Supply Chains", is organised by the Ministry of Investment, Trade and Industry (Miti) in collaboration with Singapore's Ministry of Trade and Industry and the Johor state government.

According to Tengku Zafrul, the federal government supports the proposed regulatory sandbox to be located at Ibrahim Technopolis and Ladang Air Manis in Kulai.

He said the initiative will be instrumental in unlocking new waves of sustainable, high-value investments that benefit both local stakeholders and international partners.

In the meantime, Tengku Zafrul said the heart of the Malaysia-Singapore relationship lies in the fact that the two countries are at

tact that the two countries are at their best when working together.

"Malaysia was Singapore's second largest trading partner, while Singapore was Malaysia's largest export destination and second largest trading partner globally in 2024.

"Our trade in 2024 was a robust

US\$86.69 billion (RM382.3 billion), driven by electrical and electronics products, petroleum products, machinery, equipment and parts, agricultural, optical and scientific

equipment," he added.

Tengku Zafrul noted that
Malaysia is fully committed to securing a favourable resolution securing a lavourable resolution that preserves vital market access and supply chains, attracts continued foreign investment, and supports the well-being of its workers and businesses.

He stressed that alongside Asean colleagues, Malaysia will not colleagues, Malaysia will not introduce retaliatory tariffs against the United States.

"From Asean's perspective, retaliation is counterproductive. Rather, the region seeks to engage constructively with the US in a forwardlooking manner to strengthen economic ties and address shared challenges," he said.

Domestically, Tengku Zafrul said, the Malaysian government sait, the Malaysian government recognises the challenges the tariffs pose to workers, manufacturers and businesses. "We must and will find a mutually acceptable, fair and equitable solution to this issue, both bilaterally and multilaterally."

Johor Menteri Besar Datuk Onn

Hafiz Ghazi said the Johor state government is mooting the esta-blishment of an Asean Industrial Park within the JS-SEZ. The industrial park is envisioned to be especially geared towards the Regional Comprehensive

Economic Partnership (RCEP).

"It will aim to attract strategic investments from RCEP member countries by focusing on high-value sectors such as advanced manufacturing, green technology and the digital economy," he said in his welcoming remarks at the forum.

He said the industrial park will drive technology transfer, boost competitiveness and diversify

supply chains across Asean.
"We also hope that it will offer customised incentives such as tax breaks, simplified talent mobility and temporary relaxation of fund repatriation rules to make the industrial park attractive to foreign investors. The aim is to stimulate economic growth and job creation in the JS-SEZ and promote the region as a preferred destination for

RCEP-related investment."
Onn Hafiz said JS-SEZ has spurred Johor investments. New approved investments reached RM27.4 billion in the first quarter of this year compared with RM48.5 billion in 2024.

"(This is) a powerful early signal of the momentum behind JS-SEZ. In fact, for April 2025, there is another RM23 billion worth of projects in the pipeline," he said.

"We have streamlined our invest-

ment processes via the Invest Malaysia Facilitation Centre-Johor (IMFC-J). With the Johor super lane, we have introduced a fast-track mechanism that significantly reduces bureaucratic delays for priority investments," Onn Hafiz said.

Since its launch in February this year, the IMFC-J has handled 252 investment enquiries with 42 high-impact projects now under accelerated processing, he said. "What took 24 months from

briefing to operations is achievable in just 13 to 14 months, a time-saving of almost 10 months. This is not just about efficiency. It is a clear signal to investors: Johor is serious, responsive and ready," he said. - Bernama

On Friday, the Department of Statistics Malaysia expected Malaysia's economy to grow by 4.4% in the first quarter of 2025 based on advance estimates, easing from a 5% expansion in the previous quarter, backed by domestic activities and steady

will be released on May 16. CGS International opined that there is considerable strength in the domestic economy in 2025, following the government's efforts in labour reforms, such as wage hikes in tandem with low inflation.

Meanwhile, Kenanga Investment Bank Bhd has maintained its 2025 GDP growth forecast at 4.8%. "The actual Q1 2025 GDP may

beat the Department of Statistics Malaysia's advance estimate.

# Foreign investors extend net selling on Asian markets

Net outlow of US\$3.84 billion for week ended April 18, with only the Philippines and India posting gains among markets tracked: MIDF report

KUALA LUMPUR: Foreign investors extended their net selling in Asian markets for a third consecutive week, with a substantial net outflow of US\$3.84 billion (RM17 billion).

According to MIDF Amanah Investment Bank Bhd's Fund Flow Report for the week ended April 18, 2025, only the Philippines and India registered net foreign inflows among the markets tracked.

All other countries posted outflows, with Taiwan experiencing the steepest foreign

India led regional inflows with US\$990.4 million, reversing a two-week streak of net selling. The return of investor confidence was attributed to easing inflation and a resilient domestic growth outlook.

"Consumer Price Index inflation fell to a 67-month low of 3.34% in March 2025, mainly due to food price deflation, while rural demand is expected to remain buoyant amid

forecasts of a normal monsoon.
"Although Fitch trimmed India's GDP forecast to 6.4% on trade war risks, the Reserve Bank of India maintains a 6.5% growth target," the report said.

MIDF Amanah also noted progress in

country considering the removal of import duties on ethane and liquefied petroleum gas to enhance energy security and strengthen bilateral ties.

The Philippines ended a three-week selling streak with a modest net inflow of US\$6.5 million.

Indonesia, meanwhile, saw a net outflow of US\$1.26 billion, its second consecutive week

of foreign selling. Indonesia's palm oil sector is calling on the government to reduce export taxes and levies in response to reciprocal tariffs of 32% imposed by the US, which are expected to lower farm-gate prices by up to 3%, the report

In Korea, foreign investors extended their net selling for a fourth week, with outflows totalling US\$1 billion. The government has announced a US\$8.6 billion supplementary budget to support sectors hit by US tariffs, notably autos and semiconductors.

notably autos and semiconductors.

Vietnam posted US\$185.8 million in outflows, marking its 11th straight week of foreign selling. While President Xi Jinping's recent visit to Hanoi resulted in over 40

cooperation agreements, Vietnam steered clear of publicly aligning with China's anti-US

Thailand recorded US\$26.9 million in net outflows, its 8th straight week of foreign selling. The Bank of Thailand warned that US tariffs could reduce GDP growth by up to one percentage point, with the full impact likely to be felt in the second half of the year.

On the domestic front, foreign net selling on Bursa Malaysia eased to RM330.5 million, sharply lower than the RM1.97 billion recorded the previous week.

Foreign investors were net sellers every trading day except Friday, which saw a net inflow of RM39.9 million. The largest outflow occurred on Wednesday at RM153.6 million, while other days ranged between RM16.2 million and RM120.6 million.

Friday's inflow followed five consecutive days of outflows. The sectors that saw net foreign inflows were telecommunications and media (RM119.5 million), consumer products and services (RM34.4 million), and property (RM2.45 million).

The top three sectors with the highest net foreign outflows were financial services (RM96.6 million), technology (RM87 million), and construction (RM80.8 million).

Local institutions continued to support the market, recording their 26th consecutive week of net buying, with inflows of RM356.2 million. Local retail investors turned net sellers with

outflows of RM25.7 million, reversing a two-week buying trend. - Bernama

The trust is scheduled to be listed with an initial fund size of 1.6 million units, of which 560,000 offer units will be made available to retail and institutional investors.

"The proposed offering comprises a retail tranche of up to 254.65 million offer units and an institutional offering of at least 305.34 million offer units," it said in a statement yesterday.

The listing will be underpinned by the

Paradigm REIT said the assets are being disposed of by the respective vendors for a total consideration of RM2.44 billion.

# **Presidential** frontrunner vows to address 'Korea Discount'

SEOUL: South Korea's leading presidential candidate Lee Jae-myung pledged yesterday to revive legislation to curb abuses by controlling shareholders, as part of a plan to boost the stock market and eliminate the so-called "Korea Discount".

The liberal candidate announced his pledge to double the value of the country's main stock index, in an effort to woo the country's 14 million retail

investors, widely known as "ants".

"I will end the 'Korea Discount' era and open the 'Korea Premium' era," said Lee, who is leading opinion polls for the presidential election in June

The 'Korea Discount' refers to the lower valuations that South Korean companies typically trade on relative to their global peers partly due to the dominance of family-owned conglomerates, which have been criticised for putting their interests ahead of other shareholders. South Korea's Parliament, controlled

by the liberal Democratic Party formerly led by Lee, passed a revision of the Commercial Act in March that expanded the fiduciary duty of board members to include protecting the interests of minority shareholders.

But acting President Han Duck-soo vetoed the legislation, which he said could impede management's decision-making and create unnecessary confusion

The country's business lobby groups also raised objections.

South Korea last year proposed a programme to boost the value of listed companies through voluntary measures, such as setting out their own plans to improve shareholder value.

The initiative has been criticised for being too weak, with analysts and investors say amending the Commercial Act would be a more effective way of improving corporate governance and tackling the Korea Discount.

Lee also promised to set out a roadmap for South Korea's domestic stock market to secure developed market status from global index provider Morgan Stanley Capital International (MSCI).

South Korea last month lifted a five year ban on short-selling, which MSCI had cited as a factor hindering foreign access. Lee, who was an active stock investor

in the past, also vowed to crack down on stock price manipulation.

South Korea's KOSPI index has been

pressured by political instability stemming from the impeachment of President Yoon

Suk Yeol, as well as US tariffs.

On Sunday, Lee won a landslide victory in the second round of primaries of the Democratic Party, which plans to pick its presidential candidate on April 27.

His popularity rating for the presidential election is over 50%, against 12% for conservative frontrunner Kim Moon-soo, according to a Realmeter poll. - Reuters

# Beijing warns nations against 'appeasing' Washington

US pressures trading partners to freeze out China, report says

**BEIJING:** China yesterday accused Washington of abusing tariffs and warned countries against striking a broader economic deal with the United States at its expense, ratcheting up its rhetoric in a spiralling trade war between the

world's two biggest economies.

Beijing will firmly oppose any party striking a deal at China's expense and "will take countermeasures in a resolute and reciprocal manner", its Commerce Ministry said.

The ministry was responding to a Bloomberg report, citing sources familiar with the matter, that the Trump administration is preparing to pressure nations seeking tariff reductions or exemptions from the US to curb trade with China, including imposing monetary sanctions.

President Donald Trump paused the sweeping tariffs he announced on dozens of countries on April 2 except those on China, singling out the world's second largest economy for the biggest levies.

In a series of moves, Washington

imports to 145%, prompting Beijing to slap retaliatory duties of 125% on US goods, effectively erecting trade embargoes against each other. Last week, China signalled that

own across-the-board rates would not rise further.

"The US has abused tariffs on all trading partners under the banner of so-called 'equivalence', while also forcing all parties to start so-called 'reciprocal tariffs' negotiations with them," the ministry spokesman said.

China is determined and capable of safeguarding its own rights and interests, and is willing to strengthen solidarity with all parties, the ministry said.

"The fact is, nobody wants to pick a side," said Bo Zhengyuan, partner at China-based policy consultancy Plenum.

"If countries have high reliance on China in terms of investment, industrial infrastructure, technology know-how and consumption, I don't think they'll be buying into US demands. Many Southeast Asian

countries belong to this category."
Pursuing a hardline stance,
Beijing will this week convene an
informal United Nations Security Council meeting to accuse Washington of bullying and "casting a shadow over the global efforts for peace and development" weaponising tariffs.

Representative Jamieson Greer said nearly 50 countries have approached him to discuss the steep additional tariffs imposed by Trump.
Several bilateral talks on tariffs

have taken place since, with Japan considering raising soybean and rice imports as part of its talks with America while Indonesia is planning to increase US food and commodities imports and reduce

orders from other nations.

Trump's tariff policies have rattled financial markets as investors fear a severe disruption in world trade could tip the global economy into recession.

China stocks inched higher esterday, showing little reaction to the Commerce Ministry comments, though investors have generally remained cautious on Chinese assets due to the rising growth risks.

The Trump administration also has been trying to curb Beijing's progress in developing advanced semiconductor chips which it says could be used for military purposes, and last week imposed port fees on China-built vessels to limit China's

dominance in shipbuilding.
AI chip giant Nvidia said last
week it would take US\$5.5 billion in charges due to the administration's curbs on AI chip exports.

China President Xi Jinping visited three Southeast Asian countries last week in a move to bolster regional

week in a move to bosser regional ties, calling on trade partners to oppose unilateral bullying. Beijing has said it is "tearing down walls" and expanding its circle of trading partners amid the

trade row.

The stakes are high for Southeast Asian nations caught in the crossfire of the Sino-US tariff war, particularly given Asean's huge two-way trade with both China and the United

Economic ministers from Thailand and Indonesia are currently in the United States,

seeking trade negotiations. Six countries in Southeast Asia were hit with tariffs ranging from 32% to 49%, threatening trade-reliant economies that have benefited from investment from levies imposed on Beijing by Trump in his first term.

Asean is China's largest trading partner, with total trade value reaching US\$234 billion in the first quarter of 2025, China's customs agency said last week.

Trade between Asean and the US totalled around \$476.8 billion in 2024, according to US figures, making Washington the regional bloc's fourth-largest trading partner. "There are no winners in trade

wars and tariff wars," Xi said in an article published in Vietnamese media, without mentioning the United States. - Reuters

## Japan to voice concern over American trade deal inconsistency

TOKYO: Japanese Prime Minister Shigeru Ishiba said yesterday Tokyo has no plan to terminate a trade deal struck with the US in 2019, but will keep voicing "grave concern" over inconsistency between the deal and President Donald Trump's latest automobile tariffs.

During Trump's first term as president, the United States and Japan signed a bilateral trade deal in 2019 that cut tariffs on American

farm goods, Japanese machine tools and other products while staving off the threat of higher US car duties

Although the agreement did not cover automobile trade, then Japanese Prime Minister Shinzo Abe

said he had received assurances from Trump that the US would not impose 'Section 232" national security tariffs on Japanese car imports.

"Between President Trump and I, myself, this has been firmly confirmed that no further, additional tariffs will imposed," Abe had told reporters.

Japan, however, was not exempted from Trump's latest 25% tariff slapped

on all automobile imports in the US.
"Japan has grave concern over the consistency" with regards to the latest US automobile tariffs and the 2019 bilateral trade deal," Ishiba said

"We will continue to convey our stance (to the US) from this standpoint," he said, although he said Japan has no plan to terminate the 2019 agreement altogether.

Japan's top trade negotiator, Ryosei Akazawa, visited Washington last week to kick off bilateral trade talks with the US. – Reuters



## Tariff worries spur record overseas demand for Japanese govt bonds

TOKYO: The longest-dated Japanese government bonds attracted record foreign demand last month as money shifted out of American debt in search of other safe havens as President Donald Trump's aggressive tariffs sparked concerns of a US recession.

Overseas investors scooped up some ¥2.18 trillion (RM67.7 billion) of JGBs with maturities of more than 10 years in March, figures released by the Japan Securities Dealers Association showed yesterday, the largest amount since the data series started in April

Trump ramped up levies over the course of last month, including a 25% tariff on cars and parts, in the runup to his April 2 announcement of sweeping duties that sent global markets into a broad tailspin.

At the same time, local insurers shed record ¥645.8 billion of super-long JGBs in the month as they adjusted portfolios at the end of Japan's fiscal year, said Shoki Omori, chief desk strategist at Mizuho Securities.

Waning bets for near-term interest rate hikes by the Bank of Japan due to the uncertain global trade environment also made it easier for foreign investors to buy JGBs, Omori said.

The 30-year JGB yield stood at 2.76% yesterday, after a four-week period when it was whipsawed by tariff headlines, plunging to the lowest

since October at 2.195% on April 7, and then catapulting to a two-decade peak at 2.845% a week later.

Over the course of March, the 30-year yield rose some 17 basis points to 2.52%, hitting a then-19-year peak of 2.63% mid-month before starting their descent as market volatility escalated. - Reuters

# Seoul finds increase in 'Made in Korea' breaches

#### Some firms use false country-of-origin markings to bypass Trump's tariffs

SEOUL: South Korea has found increased attempts to disguise foreign products as Korean exports, primarily from China, to avoid US President Donald Trump's sweeping tariffs,

its customs agency said yesterday.

The Korea Customs Service said it has found 29.5 billion won (RM91 million) worth of violations related to country of origin from the first quarter, with US-bound shipments accounting for 97% of the total, after a special probe last month.

That compared to a total of 34.8 billion won worth of violations for all of 2024, among which US-bound shipments accounted for

Trump, who took office in January, has imposed significant tariffs on various products and countries, including those on China that

began to rise from February.

"There was a rise in disguised export attempts during Trump's first presidency and we expect there to be a similar trend," said Lee Kwang-woo, investigation planning director at

Anticipating increased risks, authorities conducted the latest investigation preemptively

to prevent illegal exports.

They have already found signs of such attempts to avoid Trump's tariffs from the first

quarter, Lee said during a media briefing.

South Korean customs officials held a meeting with US officials yesterday to discuss

joint investigation efforts.

South Korean officials have said there could be a rise in attempts by foreign companies, such as those in neighbouring China, to use South Korea, which is a major US ally and has a free-trade pact, as a bypass to

avoid tariffs and regulations.

Trump slapped 25% tariffs on South Korea this month, among a new set of sweeping levies, which were later suspended for three months.

after back-and-forth retaliatory actions, which economists say have severed trade between the world's two biggest economies.

Monday's findings include 3.3 billion won worth of cathode materials used for batteries, imported from China and shipped to the US with South Korea falsely marked as the country of origin, to avoid already high tariffs in January even before Trump's tariffs took

# Gold hits record high, dollar falls to three-year low

NEW YORK: Gold scaled a record peak yesterday, spurred by concerns over global economic growth amid the US-China trade war, while a weaker dollar further boosted the rally. Spot gold advanced 1.9% to US\$3,391.02 an

ounce as of 0641 GMT (2.41pm in Malaysia) after hitting a record high of US\$3,391.62 earlier in the session.
US gold futures firmed 2.2% to US\$3,402.80.

The dollar index hit a three-year low, making gold more attractive for other currency holders.

"Fundamentally, markets are pricing in heightened geopolitical risks, driven by US tariff tensions and stagflation concerns, while resilient central bank demand offers an added tailwind for prices as well," said IG market

us President Donald Trump announced "reciprocal tariffs" on dozens of countries on April 2, and while his administration paused levies for some countries, it has ratcheted its trade battle with China.

Meanwhile, Trump launched a series of attacks against Federal Reserve chairman Jerome Powell, with his team evaluating whether they could fire Powell.

## JD.com calls out anti-competitive pressures on food delivery couriers

SHANGHAI: Chinese e-commerce giant JD.com highlighted anti-competitive pressures on food delivery couriers in a social media post yesterday, alleging that other platforms were coercing

couriers to avoid working with JD Takeaway.

JD Takeaway began onboarding restaurants in February with promises of "zero commissions all year round", marking its entrance into China's highly competitive food delivery space and threatening to disrupt the market share of leading players who rely on scale for success in

this low-margin sector.

In the post on JD.com's official Weixin In the post on JU.com's official weixin account, addressed to couriers working with JD Takeaway, the company said it was aware of pressures on them to not accept orders from JD.com and that it sympathised with their plight

of being forced to choose between platforms.

JD.com did not name competing platforms in

China's food delivery sector has long been dominated by giant Meituan, with Alibaba-owned Ele.me the second-largest player in the country based on market share.

Meituan and Ele.me did not immediately

reply to an e-mailed request for comment on JD.com's post.

However, Meituan, in a post on its Weixin

account, said it had punished one of its drivers for falsely claiming he had been banned by Meituan for taking orders from other platforms, describing the driver's claim as "pure fabrication".

JD.com has promised to provide sufficient orders to couriers banned by other platforms to

ensure they can maintain their income level. It also said it would double its recruitment aim for full-time riders to 100,000 from 50,000 in the next three months.

JD.com is the first platform to offer its full-time riders direct labour contracts, making them eligible to collect full insurance benefits. – Reuters

## Second Boeing jet starts return from China, tracker shows

SEOUL: A second Boeing jet intended for use by a Chinese airline was heading back to the US yesterday, flight tracking data showed, in what appears to be another victim of the tit-for-tat appears to be afformer within or the term at the bilateral traffs launched by President Donald Trump in his global trade offensive.

The 737 MAX 8 landed in the US territory of

Guam yesterday, after leaving Boeing's Zhoushan completion centre near Shanghai, data from flight tracking website AirNav Radar showed.

Guam is one of the stops such flights make on the 8,000km journey across the Pacific between Boeing's US production hub in Seattle and the Zhoushan completion centre, where planes are ferried by Boeing for final work and delivery to a Chinese carrier.

On Sunday a 737 MAX painted with the livery for

China's Xiamen Airlines made the return journey from Zhoushan and landed at Seattle's Boeing Field

It is not clear which party made the decision for the two aircraft to return to the US.

Trump this month raised baseline tariffs on Chinese imports to 145%. In retaliation, China has imposed a 125% tariff on US goods.

A Chinese airline taking delivery of a Boeing jet could be crippled by the tariffs, given that a new 737 MAX has a market value of around US\$55 million, according to IBA, an aviation consultancy.

The plane flew from Seattle to Zhoushan just under a month ago.

The return of the 737 MAX jets, Boeing's best-selling model, is the latest sign of disruption to new aircraft deliveries from a breakdown in the rospace industry's decades-old duty-free status.

Confusion over changing tariffs could leave many aircraft deliveries in limbo, with some airline CEOs saying they would defer delivery of planes rather than pay duties, analysts say. - Reuters

JAKARTA: Indonesia reported yesterday a US\$4.33 billion (RM19 billion) trade surplus in March, more than expected and the widest in four months as shipments beat estimates on strong palm oil and nickel exports as well as a rush to beat the start date for US tariffs

A Reuters poll of analysts had expected a surplus of US\$2.64 billion

The March surplus was the largest since November 2024, according to

Exports from the resource-rich country have rebounded from lows reached after the end of a commodity boom in 2022, but shipments could soon be affected by a dimming global growth outlook due to the trade war

sparked by US tariffs.

Among the countries that US
President Donald Trump targeted for
tariffs above 10%, Indonesia was hit with a 32% levy, which has been

paused for 90 days. Several Indonesian ministers have been in Washington since last week to try to negotiate a deal to avoid the tariffs, presenting a proposal that includes buying more American products to reduce the trade gap with

Exports rose 3.16% on an annual basis in March to US\$23.25 billion, official data showed yesterday, compared with a 3.4% fall expected by economists polled by Reuters.

## Thai Q1 rice exports fall 30% annually

BANGKOK: Thailand's rice exports fell 30% annually in the first quarter of this year to 2.1 million metric tonnes, an industry association said yesterday.

The decline was due to countries delaying buying decisions and India resuming rice exports, Thai Rice Exporters Association honorary president Chookiat Ophaswongse told reporters.

Full-year exports could fall below the forecast of 7.5 million tonnes, he said, but exporters were seeing more US orders after a 90-day pause on the imposition of

steep new tariffs.

Exports in the second quarter

would be similar to the first three months of the year, he said. The tariff of 36% imposed on Southeast Asia's second-largest economy is among the higher rates imposed by US President Donald Trump's administration.

A delegation led by Finance Minister Pichai Chunhavajira will meet US officials in Washington this week to seek lower tariffs.

Thailand is the world's second-largest rice exporter, but could lose that title if tariffs were higher than 10%, Chookiat said.

Last year Thailand shipped 9 94 million tonnes of rice, with the US being its third-largest market by volume. – Reuters

#### LG Energy Solution pulls out of Indonesian EV battery investment

JAKARTA: South Korea's LG Energy Solution (LGES) has formally withdrawn from a 142 trillion rupiah (RM37 billion) project in electric vehicle (EV) battery making in Indonesia, the company said yesterday.

LGES and the Indonesian

government signed a deal on the so-called Indonesia Grand Package project in late 2020, which include investments across the EV battery supply chain.

"Taking into account various

factors, including market conditions we have agreed to formally withdraw from the Indonesia GP (Grand Package) project," LGES said in a statement.

"However, we will continue to explore various avenues of collaboration with the Indonesian government, centring on the Indonesia battery joint venture, HLI Green Power," it added.

HLI Green Power is a joint venture led by LGES and Hyundai Motor Group.
The company

last inaugurated Indonesia's first battery cell production plant for EVs with annual capacity of 10 Gigawatt hours of battery cells.

The Investment Ministry as well as state companies Aneka Tambang and Indonesia Battery Corporation which had planned to partner with LGES for the project, did not respond to requests for comment. - Reuters

# Vietnam to finalise restructuring plan for lender SCB

HANOI: Vietnam's central bank is finalising a report, based on a plan from an unspecified investor, to restructure ailing Saigon Joint Stock Commercial Bank, the lender at the centre of the country's biggest financial fraud on record, local media reported.

Last month, Reuters reported that Vietnam developer Sun Group had proposed a rescue plan for SCB, which entailed the full reimbursement within 15 years of nearly US\$26 billion (RM114 billion) the central bank has pumped into SCB since October 2022 after a run on its deposits.

The State Bank of Vietnam has drafted a report about the rescue plan prepared by the unspecified investor, the Finance Ministry's Dau Tu newspaper reported during the weekend.

The draft is subject to changes

after opinions from relevant state bodies, the paper said, giving no details on use, its submission. details on the plan or a timeframe for

reported Reuters has reported that Sun Group had been appointed by the central bank to prepare the restructuring plan for SCB.

The central bank, SCB and Sun Group did not immediately reply to requests for comment.

The State Bank of Vietnam placed SCB under its supervision to stem a orun on the bank sparked by the October 2022 arrest of real estate tycoon Truong My Lan, who was later sentenced to death over her role in siphoning off from SCB the equivalent of billions of dollars in loans to shell companies she controlled.

a separate trial over money laundering and the illegal issuance of corporate bonds, Lan yesterday had an additional life sentence reduced to 30 years on appeal, according to state media.

SCB has been using cash injections from the central bank to cover cash withdrawals since October 2022, Reuters has reported.

The central bank and government have repeatedly sought help for SCB from the private sector, specifically calling on foreign investors, according to state media, despite restrictions such as a 30% cap on combined foreign ownership of Vietnamese

## Keppel gets nearly S\$2 billion in capital commitments for its funds

## FBM KLCI ends flat, losers beat gainers on broader market

BURSA Malaysia's benchmark index closed flat to settle at slightly below the 1,500-mark yesterday as investors balanced persistent global uncertainties with signs of underlying domestic resilience, said an analyst.
At 5pm, the FBM KLCI inched up 0.07 of-a-point to 1,499.47

compared to Friday's close of 1,499.40.

The benchmark index opened 2.68 points higher at an intraday high of 1,502.08 and hit an intraday low of 1,494.27 during the early afternoon session.

In the broader market, decliners outpaced gainers 512 to 308, while 463 counters were unchanged, 1,142 untraded, and 39 others suspended.

Turnover dwindled to 1.53 billion units valued at RM1.19 billion against Friday's 1.69 billion units valued at RM1.24 billion. UOB Kay Hian Wealth Advisors Sdn Bhd head of investment



#### Local banks remain attractive despite trade tensions: HLIB

**KUALA LUMPUR:** Hong Leong Investment Bank Bhd (HLIB) said Malaysian banks are expected to be among the more attractive sectors for investors seeking refuge from US President Donald

The investment bank said the sector's robust dividend yield of 5% presents a compelling carry proposition, offering a natural

cushion against capital downside and providing an effective price floor amid market volatility. "Moreover, valuations remain undemanding while the sector's earnings outlook is fairly resilient," it said in a note yesterday.

The bank cut its 2025 GDP forecast for Malaysia to 4% from 4.9%, and flagged that Bank Negara Malaysia may reduce the

overnight policy rate (OPR) by 25 basis points to 2.75% in the second half of 2025 to support growth.

While banks typically face margin compression following an OPR cut, HLIB said the impact may be more limited compared to past unexpected reductions.

"This is primarily because banks are likely to take a more proactive stance in anticipation of easing by shortening fixed deposit (FD) tenures to allow quicker repricing at lower cost, and moderating FD growth to avoid overexposure ahead of

"Also, we expect pricey campaign FD rates to moderate more substantially within six to nine months post-OPR cut, as banks capitalise on the opportunity to stretch their net interest margin (NIM) expansion," it said.

Still, HLIB estimates that every 25 basis point policy rate cut would compress sector NIM by 5.0 to 6.0 basis points. – Bernama

#### Ringgit nears six-month high on weak sentiment over US assets

**THE** ringgit jumped to its highest level in almost six months, against the US dollar at the close yesterday, touching the 4.36-

against the OS dollar at the close yesterday, touching the 4.56-level amid concerns over ongoing tariff tension.

At 6pm, the ringgit surged to 4.3670/3735 against the greenback, compared to last Friday's close of 4.4100/4175.

Previously on Oct 28, 2024, the ringgit hit a high of

4.3605/3640 against the greenback.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid said the ringgit continues to gain strength against the greenback amidst heightened uncertainties over tariff issues.

"It appears that inconsistencies in policymaking as well as antagonising their allies have led to weak sentiments over US assets.

"In some sense, the current predicament has resulted in the acceleration in the de-dollarisation trend as reflected in the decline in foreign holdings of US treasury bonds and subsequently lower US treasury yields," he told Bernama.

Meanwhile, the ringgit traded mostly lower against a basket major currencies.

It weakened against the Japanese ven to 3.1046/1095 from 3.0971/1028 at last Friday's close, eased against the euro to 5.0408/0483 from 5.0133/0218 but was slightly higher against the British pound to 5.8513/8601 from 5.8516/8616

The local note performed mostly higher against Asean currencies

The ringgit firmed against the Singapore dollar to 3.3515/3570 from 3.3562/3601 at last Friday's close, and appreciated against the Indonesian rupiah to 259.8/260.3 compared with 261.2/261.8 previously

**AMMB'S** relatively large exposure to the trade and manufacturing sectors potentially leaves it more exposed to US tariff-induced uncertainties, while recent M&A news flow – while unconfirmed presently – may also weigh on its share price. The stock has risen by >30% since the start of 2024, and we do not expect a similar performance in 2025. As such, we think it is a good time to take some chips off the table, for now.

RHB Economics has turned more cautious on the global macroeconomic outlook. In the base case (55% assigned probability), the US universal tariffs rise by another 10% to total 20% in 2H25, while a bad case (40% probability) sees the return of reciprocal tariffs being implemented in 2H25 at similar or higher to the rates introduced on April 2. Consequently, Malaysia's GDP growth projection has been lowered to 4.5% from 5%, with the of risks tilted towards a 3.5-4% print if tensions ramp up further. The trade and manufacturing sectors are expected to face increasing challenges but, for now, our Overnight Policy Rate (OPR) forecast remains at 3%.

Based on our channel checks, AMMB has a comparatively large share of trade-related loans (e.g. bills, trust receipts) and manufacturing loans vs the rest of the sector, which poses risks to AMMB's loan growth, should trade and manufacturing activity slow down. Working capital loan demand could also decrease in tandem with softer general economic activities. On the non-II side, investment banking, stockbroking and wealth fees could all be impacted by the challenging market environment, but these could be mitigated by enhanced trading and investment opportunities.

**WE** promote Hong Leong Bank as a key defensive pick for the following reasons: i) The group's domestic- and household-centric portfolio with stable asset quality insulates it from a potential trade downturn; ii) near-15-year low valuations means the downside risks are capped. In our view, downside risks are mostly second order, and are largely in relation to associate Bank of Chengdu (BOCD) and the wider China

HLBK's domestic and household-heavy lending portfolio, along with its solid asset quality, place it in a safer position to weather through the US tariff uncertainties. We also expect NIM to stay resilient, given the banking group's smaller regional exposure. In our view, the main earnings risk for HLBK stems from associate contributions, where BOCD faces NIM pressure amid a monetary policy easing cycle. In fact, the Bloomberg consensus' estimate for BOCD's FY25 (Dec) PATMI has been cut by 5% since the turn of the year. More broadly, should China's GDP growth be lower-than-expected (RHB Economics' bear case assumes that China's GDP growth will decelerate to <3%), negative sentiment could weigh on HLBK's share price, in our

HLBK's valuations have de-rated over the past two years despite its ROEs having held up well. In fact, its current P/BV of 0.98x is near the 15-year low of 0.94x recorded during the Covid-19 pandemic. If the P/BV retreats further to that level, the resultant share price of RM18.80 would imply a 4% downside to the current level, i.e. not that substantial

**SDG** is collaborating with Eco World and Negeri Sembilan state investment arm NS Corp to develop a 1,195-acre industrial park. The park is to be developed within Parcel C of Malaysia Vision Valley 2.0 (MVV2.0) at Bukit Pelandok, Negeri Sembilan. This area, owned by SDG under its Bukit Pelandok Estate, is currently planted with oil palm. According to its latest annual report, SDG's landbank in the state has an average net book value or NBV of RM0.21/sq ft. The new park carries an estimated GDV of RM2.95 billion, and aims to attract local and foreign investments.

To be developed over nine years, the park will feature industrial lots, ready-built factories, and commercial properties that cater for high-growth sectors like aerospace, E&E, and logistics. Strategically near the Kuala Lumpur International Airport, major highways, and seaports - it provides excellent connectivity and logistical advantages that support business growth.

Eco World will be appointed as the development manager and will pay RM572.76 million to acquire the land from SDG – translating to an ASP of RM11/sq ft. A special purpose vehicle (SPV) will be set up for the development. Eco World will own 55% of this SPV while SDG will hold a 30% stake via its SD Guthrie Land Ventures unit. The remaining 15% will be held by NS Corp, acting as the state's coordinator and custodian for MVV2.0.

The RM11/sq ft selling price is reasonable, in our view, with ecent transactions in the area in the RM8-12/sq ft range. Assuming the RM0.21/sq ft book value applies consistently for all land in Negeri Sembilan, SDG will stand to gain at least RM560 million from the land disposal (ex-taxes).



#### Verstappen bites his tongue

MAX VERSTAPPEN bit his tonque to stay out of trouble after clearly disagreeing with Formula One stewards over a costly Saudi Arabian Grand Prix penalty yesterday. Red Bull's four times world champion started on pole and finished second, 2.8 seconds behind McLaren's winner Oscar Piastri, after getting a five second penalty for a first corner incident. Team principal Christian Horner said the penalty was very harsh, producing a photograph for reporters to back up his argument. "I don't know where Max was supposed to go at that first corner. We've lost the race by 2.8 seconds, so it's tough," he said. Verstappen was reluctant to talk about it. "The problem is that I cannot share my problem is that I cannot share my opinion about it because I might get penalised also, so it's better not to speak about it." Asked later whether he felt frustrated at not feeling able to speak out, he said: "It's just the world we live in. You can't share your opinion because it's not appreciated apparently, or people can't handle the full truth."

#### Fourth was the best I could do: Norris

LANDO NORRIS said there was nothing more he could do after finishing fourth in yesterday's Saudi Arabian Grand Prix and losing his Formula One championship lead to winning McLaren teammate Oscar Piastri. Norris paid the price for a crash in qualifying that left him 10th on the starting grid and although helped by two of the cars ahead of him crashing out on lap one, he finished off the podium for the first time this season. "Nothing more I could do. The Ferrari was quick, Max was quick as well and clearly we did not have as much of an advantage," Norris told reporters. "If anything you would say Max was the quickest car out there today, which means we have some work to do. Clearly that was not an easy race."

## Rune stuns Alcaraz in Barcelona

**HOLGER RUNE** denied red-hot favourite Carlos Alcaraz a third Barcelona Open trophy when he stunned the Spaniard 7 6(6), 6-2 in the final yesterday to lift his first title in two years.

Alcaraz had won the tournament in

2022 and 2023 but the top seed seemed to be struggling with an injury midway through the match, allowing Rune to capitalise and win his first trophy since

Alcaraz saved two more set points in

the tiebreak as Rune began to dictate points once again and the Dane finally converted his fifth set point when the

top seed's return went long.
"When he broke me, I think I got
more into the match and I played more of my tennis. It was a big battle in the first set," Rune added.

"I know how it feels to lose this kind of first set, it was super important to win it and gain the momentum. So I'm so proud of myself."

Alcaraz took a 2-1 lead in the second set before he took a medical timeout to deal with what seemed like an issue with his thigh muscle or groin. He did not fare any better on his return as Rune elevated his game. - AFP



Devils frustrate Amorir

We lack a lot of things, says United manager after defeat to Wolves

UBEN AMORIM admitted Manchester United "lack a lot" as their ongoing struggles in front of goal saw them return to earth with a bump in yesterday's Premier League defeat at home to Wolves

Three days on from the dramatic 5-4 Europa League quarterfinal comeback win against Lyon, the rotated Red Devils' positive performance counted for nothing due to their futility in the final third.

Out-of-sorts Rasmus Hojlund and his teammates were unable to find the net at Old Trafford, where substitute Pablo Sarabia's freekick secured a 1-0 triumph as Wolves won five consecutive top-flight matches for the first time since 1970.

Amorim, by contrast, has only won six of his 22 League matches since taking charge in November and his frustration was palpable after United's 15th loss of the season – a club record in the Premier League era.

"If you look at the game, we were the better team but in the end it doesn't matter," the head coach said.

"If we don't score goals, nothing matters because in the end it is the result that counts, especially in these kinds of

"We create a lot of chances, we controlled the game. We blocked some good players from the opponent and then one set-piece changes the game and that's it. It's really frustrating to end the game like this.

"We say to the fans the truth - that we lack a lot of things in our team, that we miss chances, that if we don't score goals we are not going to win.

"We have a lot to do and to focus on in improving the

team step by step and understanding that until the end of the League it's going to be like this and then we need to do something.

Europa League semifinal opponents Athletic Bilbao will not be overly concerned by United right now, especially with striker Hojlund having scored just once in 28 games.

Asked if he could take him out of the spotlight, even with Joshua Zirkzee's season-ending injury, Amorim said: "No. I think if you look at the games, we have several players that miss big chances, not just Rasmus.

"But of course, Rasmus, the aim is to score goals because he's a striker, but it's a team

thing. I already said that. "Our team should score more goals and it's not just Rasmus missing chances.

"The only way I know is to work on him, show him the videos. Like you said, he needs to score a goal - he will not score if he is out (of the team) so I try to manage that during games. But he needs to score one. Maybe that's all a striker needs."

Wolves moved level on 38 points with 14th-placed United as Vitor Pereira oversaw the club's first double in this fixture since 1979-80.

'Today was not the best game that we played," he said. "But it was a game with a true spirit.

"The players inside the pitch, outside the pitch, because the players that came from the bench came to help the team.

"Sometimes if we don't play in our level, we must win with our hearts, with our souls, with our spirit and that's what happened today. And in the right moment, when we had the chance. boom, we won the game. The Independent

Maresca could have been expected to join the jubilant celebrations on the pitch after the west London derby success.

Yet the former Leicester boss was quick to disappear to the dressing room, insisting he was not making a point to the fans, but merely letting the players take their moment in the spotlight

"It was a moment for the players. They deserved to share that moment with the fans. That's the reason I left the pitch," he said. "I celebrated when we scored the second goal and they gave me a yellow card"

Maresca was targeted for abuse by frustrated fans during recent home matches, including Friday's Uefa Conference League quarterfinal second leg defeat to Legia Warsaw – which did not stop their progress to the last four – and the previous Sunday's home draw with lowly lpswich.

The atmosphere has soured as the Blues' bright

start to the season has given way to mixed results and a style of play that has failed to excited supporters.

However, Pedro's winner changed the picture in the Champions League race, with Chelsea now in fifth place, two points behind third-placed Newcastle with five games left.

"The goal from Pedro doesn't change my view of the season," said Maresca. "This season we've spent

all season in the Champions League spots.
"I was quite positive at 1-0 down because I think the team was creating chances. Sometimes you also have to be a little bit lucky. I think Tyrique's goal gave us energy, an extra boost, but the team was performing well." - AFP

## Chong Wei tells shuttlers to walk the talk

NATIONAL badminton legend Datuk Lee Chong Wei stresses that shuttlers must prove their capabilities on the court first before demanding lucrative salaries.

Commenting on claims that a handful of shuttlers are asking for lucrative salaries from the Badminton Association of Malaysia (BAM), Chong Wei said this would not be a big problem if the players perform at a level that translates to

"I'm not saying shuttlers cannot ask for high salaries, can... but what is important is that they must first prove it (in terms of performance). They must be committed and contribute to the

"These days I always say that our shuttlers are pampered but if they are committed, no matter how much (salary) they ask for, the association will try to assist," he said when met at the Ministry of Youth and Sports Aidilfitri Open House 2025 celebration at the Axiata Arena in Bukit Jalil vesterday.

Chong Wei, 42, said problems arise when players who have yet to reach a certain level in careers start making unreasonable demands.

"Some have yet to reach a high level but are already asking for a high salary. When they don't get it, they say they will turn professional," he said.

The three-time Olympic silver medallist,

however, hopes that the new leaders set to helm BAM will review the issue of players' salaries and make positive changes.

Meanwhile, Chong Wei expressed his amazement at the determination and drive of national track cyclist Datuk Mohd Azizulhasni Awang, who has decided to quit the national team and ride as a professional.

Chong Wei, who is a committee member of the Road to Gold (RTF) programme, said he fully supported the decision made by the 2020 Tokyo Olympic Games silver medallist.
"We hope he will win more gold medals (in

upcoming championships)," added the three-time world championships runner-up. – Bernama

But boss Arne Slot, who is on the verge of delivering title success in his first season in charge at Anfield, said his player's commitment to the club cannot be questioned.


