

PETALING JAYA: Ties between Malaysia and Kosovo took a major leap yesterday with the opening of Kosovo's first embassy in Kuala Lumpur, an event Prime Minister Datuk Seri Anwar Ibrahim described as "a significant milestone" bilateral relations.

Anwar said the move marked a new era of cooperation and engagement between the two

The embassy, officially launched at 6pm yesterday, is expected to strengthen strategic partnerships across multiple sectors, including investment. education culture and tourism.

"This will certainly facilitate greater collaboration across various sectors and of course includes the

halal industry.

"Malaysia's halal certification is internationally recognised, and will not only ease the export of our products but also support Kosovo in promoting its own exports to Muslim-majority markets," said Anwar at a joint media conference with Kosovo President Dr Viosa

Osmani Sadriu.

The president said having the embassy in Malaysia marked a new chapter built on shared values and

Osmani is in Malavsia for a fourday visit. She arrived on Thursday and was accorded a formal welcome ceremony at the Perdana Putra Complex in Putrajaya yesterday.

Anwar also hosted an official luncheon in her honour at the Seri

Perdana Complex.

He stressed the importance of boosting economic ties between the two nations, adding that Kosovo's connections with the European Union could open doors for broader connection.

"We can tap into Kosovo's strengths and its strong ties with the EU. I look forward to deeper engagements beyond just technical cooperation under the Malaysian Technical Cooperation Programme.

"Please be assured, President, we do not see this as a routine diplomatic move. Malaysia is a true friend, and we are fully committed to this relationship."

The leaders discussed a range of international issues, particularly those involving sovereignty, human rights and peace.

We had candid conversations about global issues. Both our nations believe deeply in the principles of independence, the protection of human rights and respect for human dignity," said Anwar.

He said shared concerns include

the situation in Palestine and broader efforts towards global peace.

He added that Malaysia admires the resilience of the Kosovan people

following the hardships of the 1990s. "Malaysians, as many of you know, followed closely the events in Bosnia and Herzegovina and in Kosovo. When Tun Abdullah Ahmad

Badawi was prime minister, he took an early and courageous step in recognising the independent Republic of Kosovo."

Malaysia was among the first

countries to do so after Kosovo declared independence in 2008. Diplomatic relations were formally established on March 18, 2011, according to the Foreign Ministry.

Osmani thanked Malaysia for its

unwavering support during Kosovo's toughest times in 1999 and its early recognition of independence in 2008, calling the country "more than a friend – a true partner."

In 2024, total bilateral trade reached RM28.55 million, with Malaysian exports amounting to RM25.92 million and imports RM2.63 million. Key exports include palm oil, electrical and electronic products and manufactured goods. while imports mainly comprised raw materials and semi-precious stones.

# Anwar conferred highest civilian honour

### Malaysia's **World Press** Freedom ranking **improves**

KUALA LUMPUR: Malaysia has improved its standing in the 2025 World Press Freedom Index, rising 19 spots to 88th place, according to the latest assessment by Reporters assessment by Without Borders.

The country recorded a score of 56.09 this year, marking a rebound from 2024, when it dropped to 107th with a score of 52.07.

Within the Asean region, Malaysia holds the secondhighest position, trailing just behind neighbouring Thailand, which ranks 85th.

Malaysia ranks higher than Brunei (97th), the Philippines (116th), Singapore (123rd), Indonesia (127th), Laos (150th), Cambodia (161st), Myanmar

(169th) and Vietnam (173rd). The World Press Freedom Index evaluates the state of media freedom in 180 countries by examining key indicators, including the political environment, legal safeguards, editorial independence, transparency and the safety of journalists. – Bernama

# Seberang Jaya Hospital becomes northern region cardiology centre

**BUTTERWORTH:** Seberang Hospital has been named northern region's main referral centre for cardiology and paediatric cardiothoracic care following a RM371

million expansion.

Health Minister Datuk Seri Dr Dzulkefly Ahmad said the nine-storey

extension, managed by the Public Works Department, would ease congestion at the Penang General Hospital, Bernama reported.

This will play an important role in decongesting other facilities in the region," he said after the handing over ceremony yesterday. Works Minister

Datuk Seri Alexander Nanta Linggi was also present.

The new block raises capacity to

729 beds and 11 operating theatres, with phased operations starting from May 5. It has subspecialties including paediatric cardiology and rehabilitative medicine.

Dzulkefly also unveiled 17 new healthcare projects worth RM9.42 million under Rolling Plan 5 of the 12th Malaysia Plan.

Another 19 projects totalling RM155 million are in progress, bringing total state healthcare investments to RM165 million.

### PWD to carry out 66 new healthcare projects under 12MP

**BUTTERWORTH:** The Public Works Department (PWD) is implementing 66 new construction projects for the Health Ministry under the Fifth Rolling Plan of the 12th Malaysia Plan (12MP), with a

total allocation of RM2.4 billion.

Works Minister Datuk Seri Alexander Nanta Linggi said PWD, through its Health Works Branch, has also been entrusted with 170 healthcare facility projects nationwide valued at RM16.47 billion.

"These include 62 projects in the pre construction (planning) phase estimated at RM4.05 billion, 64 projects currently under construction worth RM7.88 billion and 44 completed projects in the post-construction phase involving RM4.54 billion," he said during the handover ceremony of the Multi-Storey Block Construction Project at Seberang Jaya Hospital yesterday.

Health Minister Datuk Seri Dr Dzulkefly Ahmad was also present at the

Nanta noted that from the Ninth Malaysia Plan to the 12MP, 12 projects valued at RM1.31 billion have been implemented in Penang under the Works Ministry.
In Penang, the pre-construction phase

involves five projects estimated at RM139 million while the construction phase comprises five projects worth RM781

Two completed projects fall under the post-construction phase, with combined cost of RM396 million.

Commenting on the Seberang Jaya Hospital development, he said PWD was assigned the project in 2016 under a RM371 million design-and-build contract.
The nine-storey block includes a 77%

increase in bed capacity – from 413 to 729 – along with new roads and parking facilities built on the hospital's existing field, spanning 1.32ha. – Bernama

### New naval vessels to boost maritime defence

**SUBANG:** The Royal Malaysian Navy's (RMN) capability to safeguard national waters will be significantly strengthened with the procurement of five littoral combat ships (LCS) and three littoral mission ships (LMS) scheduled to begin next year, according to Deputy Defence Minister Adly Zahari.

He said construction progress for both

classes of vessels was satisfactory, with the first LCS expected to be delivered in August next year and the LMS fleet by

# Mandatory medicine price display hailed as consumer win

KUALA LUMPUR: The implementation of mandatory medicine price displays at private healthcare facilities and community pharmacies effective May 1, has been welcomed as a step forward in strengthening consumer rights and promoting informed healthcare decisions.

National Consumer Action Council deputy president (international policy and strategy) Masrudi Abdul Rahman said the policy would allow consumers to compare prices and manage their healthcare budgets

particular medicine or supplement is necessary or simply part of a trend," he told Bernama.

The requirement is enforced under the Price Control and Anti-Profiteering (Price Labelling for Medicines) Order 2025, introduced under the Price Control and Anti-Profiteering Act 2011.

It applies to all medicines for human use, including controlled substances, prescription and non-prescription drugs, traditional medicines, health supplements and

extemporaneous preparations.

Public health policy researcher
Dr Lim Chee Han from the People's Health Forum said a 2022 Medicine Price Monitoring study conducted by the Health Ministry found that high medical costs and medicine prices were primarily due to a lack of price transparency.

Patients often learn the price of their medicines only after receiving the bill, which is unfair. This practice has become normalised in the medical sector. "According to the study, price mark-ups could reach as high as 200% - a key factor behind high medical costs, which is unacceptable."

He expressed hope that the introduction of the medicine price transparency mechanism would help curb excessive pricing by enabling consumers to make better-informed comparisons.

Meanwhile, several consumer organisations issued a joint statement praising the new law as a critical move towards addressing long-standing issues of price opacity and wide price variation in

the healthcare sector.

They stressed that the mechanism should not be mistaken for price control.

"It is the fundamental right of a

consumer to be informed, to be heard, to choose and to be safe with the goods which they consume. Medicines are an essential good where there is information asymmetry in their provision and consumption."

The statement was jointly issued by the Consumers Association of Penang, Federation of Malaysian Consumers Associations, Persatuan Pengguna Luar Bandar dan Ekologi Malaysia, Teras Pengupayaan Melayu and Persatuan Keselamatan Pengguna Kuala Lumpur.

They noted that the price display mechanism addresses the consumer's or patient's right to be informed about the product being purchased.

"This policy focuses solely on the pricing of medicines, not on the fees or income of healthcare professionals such as doctors."

"Doctors' earnings relate to consultation fees, operational costs and remuneration, which are separate financial considerations and fall under different ministries and policy frameworks," the organisations added.

# **Public welcomes full disclosure of pricing**

KUALA LUMPUR: The mandatory display of medicine prices at private clinics and hospitals has been welcomed by consumers who view the move as a sign of the government's commitment to ensure transparency in healthcare. Many Malaysians see the

initiative as empowering them to make informed purchasing decisions based on clear pricing – a fundamental consumer right.

Civil servant Norsyaliza Rosli, 48, from Kedah, hailed the move as timely and necessary.

"When the government enforced this action, private facilities can no longer manipulate the prices of medicine arbitrarily because they know that stern action will be taken against them. As consumers, we have the right to choose, so this is something we should support," she told Bernama.

Government retiree Mohd Yasin Zamri, 67, from Pendang, said the initiative would help the less

rtunate make comparisons before buying medicine.

"Sometimes, when buying medicines, prices differ on different days. It's as if they are manipulating the prices. This is not right because everyone has the right to know the actual price of the medicine purchased. If there is a discrepancy, we can report it to the authorities.

Yesterday, the Health Ministry and the Domestic Trade and Cost of Living Ministry issued a joint statement announcing that the Medicine Price Labelling Initiative at private healthcare facilities and community pharmacies, effective May 1, aligns with the Madani government's commitment to

greater price transparency under the Medicine Price Transparency Mechanism (MKHU). The initiative is aimed at empowering consumers to make informed choices by allowing them to compare and select the best prices for their medication needs.

In Sarawak, 47-year-old civil servant Asrina Kartini Sulaiman echoed this sentiment, particularly for low-income households.

"For example, if the buyers have a low income, surely they have to budget and choose an affordable option. Medicines are getting more expensive, so when we display the prices, we can decide whether or not to buy them, or continue checking prices elsewhere."

Negeri Sembilan Consumers Association chairman Khairuddin Yunus also praised the mechanism as consumer-friendly, offering patients the flexibility to either purchase medicines at the clinic, or opt for a prescription, and buy them

opt for a prescription, and buy them at more affordable prices from pharmacies.

"If you buy from the pharmacy, you'll know the price of the medicines. But if you buy them from private clinics, you often don't and, like it or not, you just have to pay. This new mechanism is welcomed

because consumers now know the cost of the services provided."

Meanwhile, some pharmacies have already begun implementing

the policy voluntarily.

Siti Sarah Romli, a resident pharmacist at Taman Ara Jaya Azam Pharmacy in Tasek Gelugor, Penang, said they started preparing for the rollout in February by compiling a list of medicines and their prices in digital form for customer reference.

"When we first heard about the implementation of the MKHU, we started compiling the list of medicines and their prices. When it came into effect today, we were ready, although some details still need to be updated to meet the government's guidelines."

While supportive of the initiative, Siti Sarah hopes for more structured engagement with private community pharmacies to ensure a balanced and practical implementation.



# Malaysia hotspot for rich property investors from China

Nation now ranks fourth behind Thailand, Australia and Canada as major destination for affluent Chinese buyers of homes priced from RM22 million, says academician

PETALING JAYA: Malaysia's luxury property market is attracting interest from Chinese high-net-worth individuals, with momentum expected to accelerate into 2025 and beyond.

The country now ranks fourth, behind

Thailand, Australia and Canada, as a major destination for affluent Chinese buyers seeking upscale homes priced from RM22 million and above.

Universiti Teknologi Malaysia Property Economics and Finance associate professor Dr Muhammad Najib Razali said Malaysia's solid economic fundamentals, including steady GDP growth, robust domestic consumption dynamic services sector, make it an

increasingly appealing investment haven.

"Infrastructure development is another major driver supporting the optimistic outlook. Projects like the Tun Razak Exchange, set to be Southeast Asia's next financial hub, and ongoing upgrades to transport networks and urban amenities are transforming Kual Lumpur into a more competitive global city.'

He said the proposed high-speed rail link to Singapore, once finalised, would significantly enhance regional integration and boost demand in Kuala Lumpur and southern Johor. Muhammad Najib said Malaysia's luxury real estate offers some of the best value in Asia.

"In Kuala Lumpur, luxury condos average between RM1,900 and RM3,800 per sq ft, with the most premium developments reaching RM5,700, still considerably lower than in cities like Singapore or Hong Kong." For example, RM4.75 million can secure a

1,500 to 2,000sq ft property in Kuala Lumpur as opposed to a 400 to 500sq ft one in Hong Kong. He said the country's strong education

sector is another major pull factor.
"With over 44,000 Chinese students

currently enrolled in Malaysian institutions families often invest in property near education hubs such as Mont Kiara and Subang Jaya.

These buyers see real estate not only as housing but also as a long-term asset tied to accessible, globally-recognised education."

He said demand is particularly high in prime locations such as Kuala Lumpur City Centre, Bangsar, Bukit Damansara and Kenny Hills where luxury condos, villas and gated communities match the expectations of international buyers.

Muhammad Najib said property agents

specialising in the luxury segment have reported not only rising enquiry volumes but also higher conversion rates, with more enquiries turning into purchases.

"In fact, we're seeing group viewings, multiple families or investor circles travelling together, making swift decisions when properties tick all the boxes."

High-rise condominiums and serviced residences have emerged as firm favourites among wealthy Chinese.

He said while Kuala Lumpur remains the primary focus, interest is also growing in Johor Bahru, especially in large-scale projects like

Forest City.

"They view Malaysia's luxury property market as a 'buy low now, appreciate later' opportunity. The country's global profile is rising with megaprojects, and the value proposition here is hard to beat compared with other Asian cities."

He said government incentives have also helped fuel interest, particularly the Malaysia My Second Home (MM2H) programme, which despite tighter conditions, continues to

which despite tighter conditions, continues to offer long-term residency.

"Malaysia's property ownership laws are relatively foreigner-friendly. Freehold titles are available in many projects, unlike in Thailand or Indonesia, where rules are more restrictive.

"Although the revised MM2H requirements, such as a RM40,000 monthly income and RM1 million fixed deposit, initially deterred some, they've since positioned Malaysia as a premium option for serious investors seeking a stable second home."

He said the briefing would include key details such as the time and location to profess the *ihram* intent, adding that TH has set up help counters at its Medina office, offering information on haj and umrah rituals.

### Ministry to distribute grants to unions beginning May 12

KUALA LUMPUR: The Human Resources Ministry will begin disbursing the Union Affairs Development Grant from May 12 to enable trade unions to carry out various programmes, including training initiatives to strengthen their respective organisations, said Human Resources Deputy Minister Datuk Seri Abdul Rahman

He said the total grant allocation has been increased to RM10 million this year compared with RM5.8 million last year.

"With this increased allocation, we can expand the support or increase the amount each union receives. This time, it involves 551 unions. Previously, we provided between RM20,000 and RM50,000 depending on the size of the union," he said after the 2025 Labour Day Celebration and Cuepacs Gathering held

Also present were Public Service Department director-general Tan Sri Wan Ahmad Dahlan Abdul Aziz, Cuepacs president Datuk Dr Adnan Mat and Deputy Inspector-General of Police Datuk Seri Ayob Khan Mydin Pitchay.

Abdul Rahman said he and Human Resources Minister Steven Sim would take turns presenting the grants, starting in Sabah.

Earlier, Abdul Rahman highlighted that the ministry is committed to strengthening policies and worker protection rights, adding that eight labour-related laws had been drafted and

amended since last year.
"All these Acts have now been passed in Parliament, marking a significant milestone for the country in reinforcing worker rights, including the amendments to the Sabah and Sarawak Labour Ordinances." – Bernama

# Amendments to Sabah, Sarawak labour ordinances take effect

PUTRAJAYA: The Sabah Labour Ordinance (Amendment) Act 2025 and the Sarawak Labour Ordinance (Amendment) Act 2025 came into force on May 1, with the exception of Section IVA, which specifically addresses the minimum standards for employee housing, accommodation and facilities.

The official date for the enforcement of the

Acts was gazetted on April 28, according to a statement from the Human Resources Ministry.

"These amendments are significant as for the first time since the formation of Malaysia, labour laws have been successfully standardised across Peninsular Malaysia, Sabah and Sarawak.

The standardisation includes three key legislations, namely the Employment Act 1955 [Act 265], the Minimum Standards of Housing, Accommodation and Facilities for Workers Act 1990 [Act 446] and the Children and Young Persons (Employment) Act 1966 [Act 350]," said

The ministry said the amendments are a priority and demonstrate the government's commitment to ensuring that the rights and welfare of workers are standardised across Peninsular Malaysia, Sabah and Sarawak.

"The amendments to both ordinances are aimed at fulfilling Malaysia's obligations towards the compliance of the country's labour laws with international labour standards, specifically the International Labour Organisation Declaration on Fundamental Principles and Rights at Work

The amendments are to improve Malaysia's image, thereby attracting more investors, especially from abroad.

Key changes include an expansion of coverage, which now applies to all workers regardless of their salary or job type, extending beyond the previous limit of RM2,500 per

Additionally, the amendments introduce several important improvements for workers, including an increase in maternity leave from 60 days to 98 days, the introduction of seven days of paternity leave for fathers and a reduction in the standard workweek from 48 hours to 45

The amendments also introduce new provisions on flexible working arrangements, workplace discrimination complaints, forced labour complaints, sexual harassment and worker housing, accommodation and facilities, adapting provisions from the Minimum

Standards of Housing, Accommodation and Facilities for Workers Act 1990 (Act 446).

The ministry said the gazettement of the Acts includes two orders under the Sabah Labour Ordinance (Amendment) Act 2025, namely the Employment Order (Exemption) (Revocation) Order 2025 and the Employment Order (Amendment of First Schedule) Order 2025.

Additionally, one order under the Sarawak Labour Ordinance (Amendment) Act 2025 – the Employment Order (Exemption) (Revocation)
Order 2025 – also took effect on May 1.

"The ministry is confident that the amendments to both ordinances will have a significant positive impact on the welfare and rights of workers in Sabah and Sarawak, and will further enhance Malaysia's international reputation," the statement added. - Bernama

# Call to stem toxic online slang usage

#### Association urges govt action as racial code words fuel division on social media

PETALING JAYA: The Malaysian Cyber Consumer Association (MCCA) has voiced concern over the growing trend of online ethnic labelling among Malaysians, warning that such toxic behaviour is

eroding national unity and mutual

The association was referring to a recent trend on social media in which individuals are being categorised as "Type M", "Type I" and "Type I" – terms widely believed to correspond to the country's three major ethnic groups: Malay, Chipsec and Indian

major etninic groups: Maiay, Chinese and Indian. Speaking to *theSun*, MCCA president Siraj Jalil said this divisive behaviour is being driven by certain groups attempting to provoke others, often under the guise of using seemingly non-provocative language.
"Terms such as 'Type M,' 'Type C'

and 'Type I' aren't inherently offensive, but we all understand what they imply and who the intended targets are.

"These groups are trying to shape a narrative, but in a way that avoids being judged as violating the

sensitive 3R issues - royalty, religion

and race."
Siraj noted that such comments frequently surface when news relates to a particular ethnic group.

"For instance, when news broke about an illegal temple, certain individuals would comment about 'Type I'. Similarly, when illegal farming is discussed, some netizens target 'Type C' and when family-related issues arise, the term 'Type M' is often used."

He added that the Malay language allows for satire to be used subtly as a vehicle for criticism, often with the expectation that the underlying message will be understood by the intended audience.

"Those who take it with an open mind may not react strongly, but others may respond aggressively to

the provocation."

Siraj stressed that it is the responsibility of the government, particularly the National Unity Ministry, to create platforms where sensitive topics can be addressed in a constructive and meaningful

He emphasised that the ministry must involve individuals who resonate with each ethnic group

and can effectively communicate their concerns to ensure all communities feel represented in the

"First, we need to address the root cause of why these issues keep recurring on social media.

"I'm not saying such programmes don't exist, but the government must create more opportunities for these discussions to take place."

# Malaysians speak out against racist labels

PETALING JAYA: The growing trend of tagging individuals on social media with labels such as "Type M", "Type C" and "Type I" is raising alarm across Malaysia.

Critics warn that the practice not only oversimplifies identities but also reinforces racial stereotypes, fosters division and undermines efforts to build an inclusive and respectful digital environment.

As the trend spreads, public pressure is mounting on authorities to take action before it causes further

harm to national unity.
Operations manager Boon Ming Choon, 46, from Johor Bahru, told theSun he had noticed the trend gaining traction online for some time.

"Initially, I didn't quite grasp it but as it persisted, the message these groups were trying to send became

He believes the public also has a role to play in addressing the issue.
"Of course this trend shouldn't

continue. Personally, I wouldn't hesitate to call out any of my friends if they took part in it online."

For Muhammad Afiq Muktar, a 30-year-old executive based in Sungai Petani, such labels can be a doubleedged sword.

euged sword.

While he acknowledged that racial identifiers can honour Malaysia's multicultural heritage, their misuse, especially in online discourse, is fuelling division.

help us appreciate our cultural history and traditions, creating opportunities to celebrate diversity and strengthen generational ties.

"But when racial labelling becomes overused or weaponised, as we see now with race being referred to as a 'type', it risks hardening stereotypes and prejudice."

He stressed that in a pluralistic society such as Malaysia, reducing people to racial shorthand can block genuine dialogue and mutual

genuine dialogue and mutual understanding. "If we only see someone through the lens of race, without acknowledging their values or background, it leads to

more fragmentation."

Private sector employee Sakthi Ganesh, 32, said he hopes the Malaysian Communications and Multimedia Commission will begin monitoring and blocking accounts

that post racially charged content.

"It's truly disheartening. I think those who make these comments likely haven't had meaningful interactions with people of other races, which has shaped their current mindset.

"If someone makes a mistake, it shouldn't be immediately linked to their race. That's a very sensitive issue Remarks like these can deeply wound those who come across them." – by Ikhwan Zulkaflee

# Understanding the Gen Z psyche

Zoomer workforce akin to sophisticated tech that yields tremendous outcomes only if handled properly

KUALA LUMPUR: Generation Z (Gen Z), also known as Zoomers, may be the youngest in the workforce, but they are already reshaping workplace culture and are no longer motivated solely by job security or prestigious titles, according to a talent management expert.

Padiberas Nasional Bhd (Bernas) Group

head of talent S. Prakash said Gen Z. the first true digital natives born between the late 1990s and early 2010s, are not merely looking for jobs but for purpose-driven roles that reflect their values and lifestyle expectations.

He said Gen Z individuals are focused on social impact, mental wellness and continuous self-development, priorities that are prompting employers to redefine what work feels like, not just what it pays, and to embrace the idea of "living, not just working".

In contrast to their predecessors Gen X and Millennials, Gen Z are often perceived as outspoken and emotionally sensitive, sometimes labelled as "crybabies", yet they are more inclined to pursue meaningful work and flexible opportunities over job security or climbing traditional corporate ladders.

Despite the stereotypes, Gen Z are already a significant part of the workforce and is rewriting

the rules of engagement at work.

Having 15 years of experience in talent management and human resources, Prakash observed that Gen Z thrive under leaders who provide guidance, not control, and would not hesitate to walk away from organisations that do not align with their values.

"One of the most common questions Gen Z asks during interviews is: 'What development resources and support will I receive in this role'? They want to know what comes next, not just in five years, but what their next assignment will

be after onboarding.
"When their ideas are rejected, they don't just accept it. They want a dialogue and expect thoughtful alternatives. They expect a

that supports growth workplace their continuously and managers who coach, not command, check regularly and create space for them to contribute meaningfully."

Prakash, who has expertise in organisational development and change management, said Gen Z workers choose flexibility, whether it's remote work, flexible hours or autonomy in completing tasks, and dislike micromanaged.

He said while Zoomers are sometimes misunderstood as anti-social or averse to pressure, they are in fact responsive to authentic engagement and constructive feedback when

delivered with empathy and respect.

"The ideal leadership style for Gen Z is

purpose-driven communication, coachingoriented support and trust-based empowerment. Gen Z don't wait for companies evolve. They are entrepreneurial and not afraid to carve their own path with new ventures," he added.

Meanwhile, National Organisation of Skilled Workers president Mohammad Rizan Hassan said he disagrees with claims that Gen Z are problematic workers, adding that they have potential to do well if properly trained, guided

and given space to shine.

"Actually, it's not that they are the problem, but the way we understand them needs to change. Gen Z want a meaningful approach to work, transparent communication and the opportunity to actively contribute.

"They do not easily submit to an unfair or old-school system. We need to foster 'youth-adult partnership' in the workplace, listen to

and respect one another."

Mohammad Rizan said today's youths are generally more conscious about work-life balance and mental well-being, valuing personal time, family and emotional health over rigid work structures, Bernama reported.

"This is not a weakness. Rather, it reflects a generation that wants to live a healthier and more productive life. They tend to choose companies that respect rest time, have a healthy work culture and time flexibility."

He said the outlook of Zoomers has been shaped by rising living costs and the erosion of long-term job security, especially after witnessing how the so-called 'stable jobs' of their parents sometimes failed to provide lasting protection.

### Thailand reports first anthrax death in decades

BANGKOK: Thailand has reported its first anthrax-related death in decades with two infections nationwide, prompting a public health alert after authorities identified hundreds potentially exposed to the deadly bacteria, officials said on Thursday.

A 53-year-old man in Mukdahan province in northeastern Thailand died on Wednesday after contracting anthrax, the government said, with a second case confirmed in the same province and three suspected cases under investigation.

Authorities have identified at least 638 people as being potentially exposed after eating raw meat.

Among them, 36 had participated

in butchering livestock while the rest had consumed raw or undercooked

beef, health officials said.

All are receiving antibiotics and being monitored as part of being monitored containment measures.

The Livestock Department is overseeing containment efforts in the affected area, including a 5km quarantine zone around the infection site, the Agriculture Ministry said.

There are plans to vaccinate 1,222 cattle, although no animals have

shown signs of illness, it added.

Thailand last reported human anthrax cases in 2017 when two people were infected without fatalities. In 2000, 15 cases were recorded, also without deaths.

Wednesday's death is the first anthrax fatality in Thailand since 1994 and follows a rise in regional infections. Laos reported 129 anthrax infections last year, including one death, while Vietnam confirmed 13 cases in May 2023. – Reuters

### Man held for allegedly ramming car into pupils

**OSAKA:** A 28-year-old man was arrested on Thursday in Osaka for allegedly ramming his car into a group of elementary school pupils, injuring seven

children, police said. The suspect, identified as Yuki Yazawa, was detained on charges of attempted murder, Kyodo news agency reported.

"I was sick of everything. I tried to run over and kill the elementary school pupils," Yazawa reportedly told investigators.

The children were walking home after

school when the incident occurred. All seven were sent to the hospital and are conscious, according to police.
Osaka's educational committee said

the victims included four boys and one girl in the second grade, and two boys in the third grade.

The pupils had been heading home after lunch following a shortened school day. - Bernama-Kyodo

# South Korea ex-PM launches presidential bid

SEOUL: South Korean former prime minister Han Duck-soo announced his bid for the presidency yesterday, joining the race in a snap election triggered by the impeachment of ex-president Yoon Suk Yeol.

The June 3 vote will decide who

replaces Yoon, who was impeached and removed from office over his declaration of martial law in December that sank South Korea into political turmoil.

Political instability in the country intensified on Thursday after a retrial ordered for a presidential front-runner over alleged election law violations and government figures resigned,

including Han.

"For the future of the Republic of Korea, a country I deeply love, and for all of us, I have decided to do what I can," Han said in a televised speech yesterday.

Han took over as the country's acting president after Yoon was impeached in December. The 75-year-old career bureaucrat

is expected to team up with Yoon's People Power Party to launch a unified conservative campaign against liberal front-runner Lee Jae-myung.

"I have dedicated my life to serving on the front lines of economic development as a proud public servant of the Republic of Korea," he said, pledging that he would address the ongoing crisis in trade involving Washington's tariffs.

He also vowed to amend the Constitution to shorten the presidential term.

Han's announcement comes a day after the country's highest court overturned a ruling that found Lee

guilty of making false statements during a previous campaign, potentially harming his chances of running in the election next month.

On the same day, Finance Minister Choi Sang-mok, set to replace Han as acting president, stepped down as opposition lawmakers voted on his impeachment over alleged involvement in the martial law incident, among others.

The impeachment process was

suspended after his resignation.

### Thai tycoon jailed for golf course land fraud

**BANGKOK:** A Thai court has jailed a billionaire businessman for 24 years after expanding his luxury golf resort into a nature reserve, local media said.

Anti-graft prosecutors filed a case in 2021 accusing metal magnate Prayudh Mahagitsiri of colluding with officials to obtain land deeds to extend his Mountain Creek Golf Resort and Residences.

The 360ha, 27-hole resort in Nakhon Ratchasima province, bills itself as "a sensory multiplex for those with lofty desires".

But authorities said 29ha added to the development fall within areas protected by conservation laws.

The Central Criminal Court for Corruption and Misconduct on Thursday found 79-year-old Prayudh guilty of multiple charges, including bribery and land encroachment, local media outlets said.

He was sentenced to 24 years

alongside 10 defendants, including his daughter, who was handed a 12-year jail term.

Prayudh is filing for an appeal, reports said.

He has an estimated net worth of US\$2.6 billion (RM11 billion), according to Forbes.

Golf is a major Thai tourism draw, particularly among enthusiasts from Europe, Japan and South Korea.

The sport is often criticised by environmental campaigners because it converts tracts of wilderness into pruned grass greens intensive watering. – AFP requiring

# **US marks May Day with** anti-Trump rallies

Protests organised by network of left-leaning activist groups, held in more than 1,000 locations

WASHINGTON: Demonstrators across the United States gathered on Thursday for May Day rallies against US President Donald Trump, protesting his administration's policies and attempts to push the limits of presidential power.

The protests were organised by a loose network of left-leaning activist groups, which said the rallies were taking place in more than

Hundreds to thousands of protesters gathered in many of the nation's largest cities, from New York to Chicago to Los Angeles, while a number of smaller towns also had demonstrators turn out in their streets.

"We believe that the ultra wealthy are trying to take over the country and suppress the working and middle class," Shane Riddle told AFP outside the White House in Washington.

The 54-year-old, who works for an education union in the eastern state of Virginia, fears the United States "could turn into an authoritarian type of government if our citizens do not stand up to this president and his billionaire allies".

Rallies held across the capital brought together hundreds of people, with similar turnouts in New York, while several thousand demonstrators congregated in Los Angeles, AFP photographers on the scene observed.

Houston, Sampson Texas, activist denounced the Bernard semant sampson denounced the administration's rapid deportation of undocumented immigrants, defending migrants as the people who "work in your restaurants or the people that built your homes".

The protests come as Democratic elected officials struggled to find an effective strategy against Trump's far-reaching shakeup, and with fairly minimal mass mobilisation by opposition protesters.

"I feel like I have not heard anything from the party at all," 22-year-old student Izabela Cabrera told AFP in Washington.

"Clearly, the American people are angry and we are trying to fight for change. But I do not think the Democratic Party is really grasping at that right now."

The chief organiser of the protests was the

group 50501. Its name is meant to represent 50 protests in 50 states and one movement. It has been behind previous calls to demonstrate.

A rally in Philadelphia organised by America's largest union federation AFL-CIO was headlined

Bernie Sanders, who has been touring the country for weeks to mobilise opposition.

The demonstration, titled "For the Workers, Not the Billionaires", alluded in part to the exceedingly wealthy individuals in Trump's administration, including Tesla and SpaceX boss Elon Musk, who heads the so-called Department of Government Efficiency cost-cutting effort.

"Today in America, one man. Flon Musk

"Today in America, one man, Elon Musk, owns more wealth than the bottom 52% of American households," said Sanders.

At May Day rallies across the globe, from

France to the Philippines, anti-Trump themes were also visible.

May Day, which is celebrated in many countries as International Workers' Day, is not a public holiday in the United States, which marks Labour Day in September. - AFP

#### **AMERICA NOMINATES NEW AMBASSADOR TO UN**

WASHINGTON: US President Donald Trump on Thursday said he was nominating National Security Adviser Mike Waltz to become the US ambassador to the United Nations, in the first major government reshuffle since taking office for a second term, the German news agency (dpa) reported. This comes following media reports suggesting that Waltz would be sacked from his post after he was involved in sacked from his post after ne was involved in the leaking of confidential information on US military strikes in Yemen in a group chat on the encrypted messaging app Signal. "I am pleased to announce that I will be nominating Mike Waltz to be the next US Ambassador to the United Nations," Trump wrote on Truth Social. "From his time in wrote on Truth Social. "From his time in uniform on the battlefield, in Congress and as my National Security adviser, Waltz has worked hard to put our nation's interests first. I know he will do the same in his new role." Secretary of State Marco Rubio will serve as national security adviser "in the interim", Trump said. – Bernama-dpa

#### THREE SERIOUSLY INJURED IN **AUSTRALIA HELICOPTER CRASH**

MCLBOURNE: Three people have been seriously injured after a helicopter crashed into the water off the coast of Victoria in southeastern Australia, German Press Agency (dpa) reported. Victoria police said yesterday the aircraft went down shortly after 10am (0000 GMT) at Point Lonsdale, a coastal town on the Bellarine Peninsula, about 10Mp couthwest of Mulburge "MID about 100km southwest of Melbourne. "All three people managed to make it to shore and were located by passersby, who contacted emergency services," police said in a statement. A man and a woman were airlifted to the hospital with serious injuries. A second man, who also suffered serious injuries, was taken to hospital by land, police said. "The exact circumstances surrounding the incident have yet to be determined. The Australian Transport Safety Bureau will investigate the crash with assistance from police," it added. – Bernama-dpa

# Supreme Court slams presidential attacks on judges

WASHINGTON: US Supreme Court justice Ketanji Brown Jackson said on Thursday attacks by Republican President Donald Trump and his allies on judges were "not random" and seemed "designed to intimidate the judiciary".

US chief justice John Roberts rebuked Trump in March for urging the impeachment of a federal judge, laying bare tensions between the country's executive and the judiciary as Trump's sweeping assertions of power encountered judicial obstacles.

"The attacks are not random. They seem

designed to intimidate those of us who serve in

this critical capacity," said Jackson at a judges'

conference in Puerto Rico.
Federal judges have said the Trump administration has failed to comply with court orders regarding foreign aid, federal spending

and the firing of government workers.

The administration disputes the claim that it has defied judges but has been critical of orders and judges that have blocked

"The threats and harassment are attacks on our democracy, on our system of government. And they ultimately risk undermining our Constitution and the rule of law," said Jackson. An appointee of former Democratic president Joe Biden, Jackson did not mention

Trump by name but spoke about "the elephant in the room".

Her comments were cited in media reports from *Politico* and the *New York Times*, with *Politico* noting that her comments received a

standing ovation.

The combative atmosphere under the Trump administration has raised concerns among legal experts of a potential constitutional crisis. – Reuters

### Order to cut funding to news outlets

WASHINGTON: US President Donald Trump has signed an executive order that aims to cut funding to news outlets NPR and PBS, the White House said, marking his latest attempt to use federal funding as leverage against institutions that he does not view favourably.

The order instructs the Corporation for Public Broadcasting (CPB), which distributes funding to PBS and NPR stations, to "cease direct funding" to them, according to the order's text that was released by the White House on Thursday. "The CPB Board shall cancel existing direct

funding to the maximum extent allowed by law and shall decline to provide future funding," the order said.

order said.

NPR and PBS have said Trump's effort to cut their funding would disrupt essential media service and have a "devastating impact" on Americans who rely on them for credible local and national news, including during emergency situations.

The Trump administration has labelled multiple institutions in academia and the media industry, including Harvard University and Columbia University, as being leftist, Marxist, biased and woke, and threatened funding cuts.

Human rights advocates have raised concerns over free speech and academic freedom.

The CPB sued the White House on Monday

after Trump sought to fire three of its five board members. The non-profit corporation was created by Congress in 1967 and provides funding for more than 1,500 locally managed public radio and TV stations.

Several media outlets have reported that the White House plans to ask Congress to rescind US\$1.1 billion (RM4.72 billion) in funding for the CPB, with the amount being two years' worth of funding. - Reuters

### Truck spills metal shards across Australian highway

SYDNEY: A truck spilled 750kg of sharp metal debris across one of Australia's busiest highways yesterday, authorities said, forcing city-bound lanes to close, damaging hundreds of vehicles and sparking traffic chaos.

New South Wales police said the incident occurred on the M1 Pacific Motorway in the early hours of the morning, leaving over 300 vehicles with tyre damage.

The M1, which is a freight and commuter route that runs north of Sydney, remains partially shut as emergency services clear the debris, using magnets and working to "hoover up the highway"

Highway Patrol Howard Collins said it would be "more than

several hours" until the motorway could reopen.
"It is not just a case of getting a road
sweeper out or guys and girls with brooms. We
are using some magnetic devices. We are removing embedded metal in the highway itself. This takes a long time."

He said the truck had travelled over 30km before the spillage was detected.

"Around 300 vehicles have been impacted. maybe more, by what we now know was 750kg of metal debris that was spilled from the back of a truck, which spread this debris for over 30km,

State Roads Minister Jenny Aitchison said

the situation was "unprecedented".

"We are working with all the resources of the government and the private sector to do the clean-up," she said.

The truck driver, a 46-year-old man, is

cooperating with inquiries, police said.

NJ Ashton, the haulage company that owns

the truck involved, apologised for the incident and said it was helping with clean-up efforts. "We are taking full responsibility for what has happened and are sorry for any damage and disruption that has been caused," it said in

a statement on its website.
"We still do not fully understand how this

occurred." - Reuters

# **Ship carrying** activists, aid attacked

VALLETTA: A ship carrying humanitarian aid and activists heading for Gaza was bombed by drones while in international waters off Malta on Friday, said

international NGO The Freedom Flotilla Coalition. It uploaded video footage showing a fire on one of its ships but did not indicate who could have been responsible for the attack.

There was also no immediate indication whether anyone had been hurt.
"The drone attack appears to

have specifically targeted the ship's generator and the vessel is at risk of sinking with 30 international human rights activists on board," it said in a social media post.

The ship issued an SOS distress call after being hit 31.5km east of Malta, to which Cyprus responded dispatching a vessel, it said.

The coalition is campaigning to end Israel's blockade of

Israel's offensive on enclave has killed more than 52,000, according to Palestinian health officials

Another coalition ship on a similar mission to Gaza in 2010 was stopped and boarded by Israeli troops, and nine activists

Other ships have similarly been stopped and boarded, without loss of life. - Reuters

# Air strikes launched in Damascus over Druze violence

#### Spiritual leader condemns 'genocidal campaign' against community

DAMASCUS: Israel's military said yesterday it launched air strikes near the presidential palace in Damascus after the country's defence minister threatened intervention if Syrian authorities

intervention it Syrian authorities failed to protect the Druze minority. Syrian Druze spiritual leader Sheikh Hikmat al-Hijri has condemned the "genocidal campaign" against his community. The violence poses a serious

challenge to Islamist authorities in Svria, who ousted longtime ruler Bashar al-Assad in December.

attacked Israel has since hundreds of Syrian military sites and yesterday announced that its "fighter jets struck adjacent to the area of the palace" in Damascus.

Sheikh Hikmat called immediate Thursday for intervention by "international forces to maintain peace and "international prevent the continuation of these

crimes."

The Druze killings come after a wave of massacres in March in Syria's Alawite heartland on the Mediterranean coast, in which security forces and allied groups killed more than 1,700 civilians, mostly from Assad's Alawite community, according to the Syrian Observatory for Human Rights.

Minister Svrian Foreign Asaad al-Shaibani on Thursday called for "national unity" as "the solid foundation for any process of stability or revival".

"Any call for external intervention, under any pretext or external slogan, only leads to further deterioration and division." Israel sees the new forces in Syria

as extremists and has warned them to protect the Druze minority, with Defence Minister Israel Katz saying his country would otherwise respond "with significant force". Israel carried out strikes near Damascus on Wednesday and has

sent troops into the demilitarised buffer zone that used to separate Israeli and Syrian forces on the Golan Heights.

Two wounded Syrian Druze have been evacuated to northern

Israel for treatment, according to the Israeli military.

At a meeting of Druze leaders, elders and armed groups in the city of Sweida, the community agreed that it was "an inseparable part of the unified Syrian homeland", a spokesperson said. The Syrian Observatory for

Human Rights said the fighting this week involved security forces, allied

week involved sectinal violes, ained fighters and local Druze groups.

The Britain-based monitor, which relies on a network of sources in Syria, said the 102 death toll included 30 government loyalists, 21 Druze fighters and 10 civilians, including Sahnaya's former mayor. including Sahnaya's former mayor Husam Warwar.

In the southern Druze heartland province of Sweida, it said 40 Druze gunmen were killed, including 35 in an "ambush" on the Sweida-Damascus road

on Wednesday.

The monitor told AFP that the fighters were killed "by forces affiliated with the ministries of interior and defence, and gunmen associated with them".

Truces were reached on Tuesday in Jaramana and a day later in Sahnaya. The Syrian government announced that it was deploying forces in Sahnaya to ensure security and accused "outlaw groups" of instigating clashes. - AFP

# Israel claims missile launched from Yemen intercepted

**JERUSALEM:** The Israeli military said yesterday it intercepted a missile fired from Yemen, where Houthing rebels recently claimed responsibility for a

missile launch that targeted Israel. Yemen's Iran-backed Houthi rebels have not claimed responsibility for the launch yesterday but said on Sunday they had launched a "hypersonic missile" at the Nevatim air base in Israel's Negev desert.

The Houthis are part of Iran's "axis

of resistance" against Israel and the United States, portraying themselves as defenders of Palestinians in the

They have launched repeated missile and drone attacks on Israel and merchant shipping in the Red Sea and the Gulf of Aden, prompting retaliatory air strikes by Israel, Britain and the United States against

Houthi targets.
Since US President Donald Trump

took office in January, the US air campaign has intensified, with almost daily strikes for more than a month. Houthi-controlled media said this

week US strikes on the movement's stronghold of Saada killed at least 68 people, all Africans being held at a "centre for illegal migrants". – AFP



# Optimax sets sights on expansion

Eyecare specialist to scale up operations in Cambodia, Vietnam and Indonesia, boost foreign patient revenue contribution

LUMPUR: Optimax KUALA Holdings Bhd aims to double its foreign patient revenue contribution to 20% by end-2025 as it scales up outreach in Cambodia, Indonesia, and Vietnam

Indonesia, and Vietnam.

CEO Sandy Tan Sing Yee shared that the group's Cambodian operations, launched in May 2024, are already self-sustaining.
"Our doctors only fly in twice a

month, but the numbers are quite good. Now our foreign revenue stands at about 10% overall," she told *SunBiz* in an interview

Tan said there is a trust gap in Cambodian healthcare, which Optimax is addressing with high standards and modern facilities.

"To be honest, many Cambo-dians lack confidence in their local healthcare system. That is why air ambulance services are why air ambulance services are effective there. For instance, patients experiencing a heart attack frequently opt for direct flights to Bangkok or Singapore for their medical treatment, characteristics. for their medical treatment," she

She added that Optimax's entry into the Cambodian market has received strong response due

to its modern facilities and adherence to international stan-

dards.
"When we first started as an eye centre, we built an operating theater that meets Joint Commission International standards. This practice ensures that patients feel confident and reassured when coming in for surgery," she

According to Tan, Optimax currently holds an estimated 50% share of Cambodia's private eye care sector and is the sole Malaysian eye care provider there

"Our patients are not just from Phnom Penh, but also from the outskirts, who come to see us."

Tan said the group is exploring expansion beyond Phnom Penh, potentially into Siem Reap or

other parts of Cambodia.

"Once our operating theatre reaches full utilisation and operates seven days a week, then

we will proceed," she said.

At the same time, Optimax is ramping up roadshows and digital outreach in Indonesia and Vietnam to attract more inter-

"We are going all out. In fact, we recently held a roadshow in Jakarta and managed to secure

Malaysia," Tan said.
At the same time, Optimax plans to maintain a consistent presence in Indonesia and Vietnam, with annual roadshows and marketing activities.

"Some of our team members are currently in Jakarta. We are building up more agents and strengthening our marketing team. We are actively running roadshows, events, radio campaigns, and digital marketing not just to promote our services in Malaysia but also to raise awareness overseas," Tan said.

"At the end of the day, we are in the service line. If we continue investing in international marketing, our foreign patient base will grow significantly," she added. On the domestic front, Tan noted

that Optimax is already well-established in Malaysia.

"Before the MCO, we were a 100% Malaysian-based company. I would say 99% of our patients were locals, with maybe just 1–2% being foreign patients, mainly from Medan due to our Penang presence.

"But today, that has changed. We now see many more foreign patients not just Indonesians and Cambodians, but also those from China and Brunei. Medical tourism in Malaysia is definitely booming," she

said.

On Malaysia's appeal as a medical tourism hub, Tan said the country offers high-quality care and facilities that rival the region's best. "Our OTs (operating theatres) are built to extremely high standards. MOH (Ministry of Health) has done a fantastic job setting those requirements."

Tan is optimistic about Optimax's new revenue streams, particularly its foray into aesthetic services.

"Our aesthetic clinic at Atrium Mall, which began operations in May last year, has shown promising numbers. Although still new, we have seen strong walk-in traffic and expect the centre to contribute solid revenue

going forward," she said. Meanwhile, Optimax is streng-thening its position in the myopic control sector to address rising short-sightedness rates among children in Southeast Asia.

"We are converting most centres without operating theaters i myopic control centres," said Tan. Alongside refractive surgery and

cataract treatment, my control is now a standard offering across all 24 Optimax centres. Tan said the prevalence of myopia in Southeast Asia is alarmingly high, largely due to lifestyle and academic pressures. "Whether it is in Singapore, Malaysia, Vietnam or Indonesia, we

see the same trend, and that has contributed to Southeast Asia having the highest rates of myopia globally."

Tan said the rate of myopia in Asia is significantly higher than in Western countries, with recent studies indicating that up to 70% of next

generation in the region may be affected. "It's a big difference compared to America. Our myopia rates are much higher. If you look at the latest data, it's very alarming."

She added that the region's

growing reliance on digital tools is compounding the issue.

The group is collaborating with MOH and the Ministry of Education to

conduct school-based eye screenings.
"We've already developed the Optimax app so parents can monitor their child's condition annually. We are doing this across our network, Tan said.

The programme is rapidly expanding.
"We started with 10 to 20 kids, but now we have 20,000 children coming in for annual checkups. This shows the growing awareness and de-mand," said and

Tan.

# SD Guthrie delivers first tariff-free palm oil shipment to UK under CPTPP

KUALA LUMPUR: SD Guthrie Bhd delivered its first-ever tariff-free ship-ment of Roundtable on Sustainable Palm Oil-certified sustainable palm oil (CSPO) to the United Kingdom under the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP).

In a statement yesterday, the company announced that its SD Guthrie International Liverpool Refinery received 8,000 tonnes of fully traceable and segregated CSPO. The cargo was shipped aboard *Dolphin 19* from Kunak Port, Sabah on Feb 19.

The CSPO had undergone stringent

testing to ensure low levels of mineral oil saturated hydrocarbons and mineral oil

aromatic hydrocarbons, it added. "The CPTPP is a free trade agreement initially signed in 2018 by 11 Pacific Rim countries, including Malaysia. The agreement removes most tariffs while promoting economic integration and maintaining strong labour and environmental protections among its member

"With the UK's official membership in

the CPTPP taking effect on Dec 15, 2024, tariffs on crude palm oil and its derivatives imported from Malaysia into the UK have been eliminated. Previously, these tariffs ranged from 2% to 10%," it

said in the statement.

SD Guthrie group managing director Datuk Mohamad Helmy Othman Basha said the shipment highlighted not only the strength of the Malaysia–UK trade relations but also the company's strong commit-ment to ensure quality, trace-ability and security of sustainable palm oil

supply to customers in the UK.

For over a decade, SD Guthrie's
Liverpool refinery has been the
company's gateway for CSPO to enter the UK market, supplying approximately 50% to 55% of domestic palm oil demand

Its refined products are widely used for deep-frying in fish-and-chip shops across the country and as key ingredients in the production of many popular brands of biscuits, baked goods and British confectionery favourites. -

# Reach Ten to expand fibre link to Miri, Sibu and Bintulu

Sarawak telecommunication services provider to expand network to 767km from 217km that covers Kuching and Samarahan currently

KUALA LUMPUR: Sarawak-based telecommunication services provider Reach Ten Holdings Bhd is set to expand its fibre optic duct infrastructure in the state to Miri, Sibu and Bintulu over the next three years, tripling its fibre footprint to 767km from 217km currently.

Managing director Leo Chin said the company took about 14 to 15 years to build the first 217km of fibre optic duct in Kuching and

"With the IPO proceeds, we will be able to expand beyond Kuching to Sibu, Miri and Bintulu within three years for another 550km of duct infrastructure.

"That is the scale we are referring to. Instead

of spending another 14 or 15 years, this time we just need three; we can triple the distance we have," Chin said at a press conference following the company's listing ceremony yesterday. He said new towers will be located in urbanised areas such as Miri, Sibu and Bintulu,

which are key commercial and manufacturing hubs, to meet the growing demand for highspeed connectivity.

"These efforts will cater to the immediate connectivity needs and lay the foundation for Sarawak's smart city initiatives, including intelligent traffic systems and digital services,"

Chin said Reach Ten's market share in Sarawak's fibre and tower segments is below 1%, but it sees strong growth potential.

"We believe that in three to five years, the fibre business will pick up strongly because we are spending RM60 million over the next three years to expand outside Kuching. So, naturally, we expect to generate significant revenue from

we expect to generate significant revenue from that segment," he said.

Currently, 90% of Reach Ten's revenue comes from its satellite segment, which it expects to remain its core business.

"We have to accept the fact that we are operating in Sarawak, with the big landmass and also the challenging terrain; satellite services are still the preferred choice when you talk about providing services to the under-served communities."

Founded in 2005, Reach Ten provides

connectivity solutions in Sarawak for businesses, government bodies and the telecommunications industry, with a focus on infra-structure expansion and technological inno-

Reach Ten has been involved in major government-led digital initiatives, including Jendela, Smart and Saluran, ensuring secure, high-speed connectivity throughout the state.

"As Sarawak continues its journey towards becoming a digital economy leader, Reach Ten remains committed to providing the infrastructure and technology necessary for the state's transformation," Chin said.

Reach Ten shares opened at 52 sen each, the same as its IPO price.

The company raised RM104 million from its public issue of 200 million new shares. The listing also includes an offer for sale of 100

million existing shares to selected investors by way of private placement.

Of the total proceeds, RM60 million (57.7%) is allocated to expand its existing fibre optic communication network infrastructure in Kuching and to establish new fibre optic communication network infrastructure in Miri.

### MGS, GII yields seen stable ahead of BNM policy meeting next week

**PETALING JAYA:** Local bond yields are expected to remain anchored ahead of the Bank Negara Malaysia's (BNM) Monetary Policy Committee meeting next week, in which the Overnight Policy Rate is expected to be held at 3%.

Kenanga Investment Bank Bhd (Kenanga IB) said it will closely monitor the May 5 parliamentary sitting for updates on Malaysia's economic growth outlook and

the government's response to US tariffs.
"Externally, the upcoming US FOMC meeting may influence sentiment – any dovish tilt could push local yields lower, Kenanga IB said.

Malaysian Government Securities (MGS) and Government Investment Issues (GII) vields edged lower this week, declining between 0.8 and 4.6 basis points (bps).

The 10-year MGS eased by 2.0 bps to 3.651%, while the 10-year GII fell 4.2 bps to 3.637%.

Key drivers were due to the improved investor sentiment following renewed optimism over US-China trade discussions, which supported the rally in Malaysian

Kenanga IB said weakness in the US economy also put downward pressure on

"Domestically, robust trade and strengthening bilateral ties with countries such as the Maldives, Japan, Italy, and Vietnam set a positive investment tone.

The favourable terms of trade update for March further supported foreign interest in local debt," Kenanga IB said.

Touching on the local currency, the investement bank said the ringgit once again exceeded expectations, st thening towards the 4.32/US\$1 level. streng-

Kenanga IB said the local note's resilience appears underpinned by Malaysia's relative macroeconomic stability and BNM's consistent policy stance. It also noted that the US dollar gained some support from tariff exemptions on auto parts and a marginally weaker euro.

Meanwhile, the US dollar drew strength from improved geopolitical sentiment, including revived US-China trade talks and a US-Ukraine deal on critical minerals.

"Domestically, BNM is expected to hold its ground, but any downward revision to Malaysia's growth outlook may attract attention," Kenanga IB said.

It expects the ringgit to trade within the 4.30–4.35/US\$1 range over the coming week, with markets remaining cautious amid ongoing US economic uncertainty and evolving tariff dynamics. Positive outcomes from the special parliamentary sitting on May 5 could lend

additional support to the ringgit, it added.

### Apple braces for trade tensions, cuts stock buyback

SAN FRANCISCO: Apple on Thursday trimmed its share buyback program by US\$10 billion (RM43 billion), with CEO Tim Cook telling analysts that tariffs could add about US\$900 million in costs this quarter as the iPhone maker shifts its vast supply chain to minimize the impact of President Donald Trump's trade war. Cook said Apple's planned US\$500

billion investment in the US will cover both capital spending and operating costs as it expands server and chip production with partners. In addition, he outlined how Apple has started to build up a stockpile of products so that the majority of its devices sold in the US this quarter will not come from China.

Taken together, analysts said the moves showed one of the most profitable companies in the history of business battening its hatches as it moves into uncharted waters.

"We were expecting to see more buybacks. Knowing the company, this indicates that Tim Cook is hoarding cash for difficult times," said Thomas Monteiro, senior analyst at Investing.com. "While that's not exactly a problem in itself, it certainly suggests that the company is not as certain about its near-term future as it was in previous quarters."

as it was in previous quarters."

Apple shares were down 4.3% after the company released quarterly results. So far, the trade war has not been a problem for Apple's sales, with Cook saying the company did not see consumers rushing to stock up on Apple items.

He said the majority of iPhones sold in the US in the current quarter will come from India, and that most iPads, Macs and Apple Watches will come from Vietnam. Cook said that the vast majority of Apple products for markets outside

the US will continue to come from China.
"We have a complex supply chain.
There's always risk in the supply chain,"
he said. "What we learned some time ago was that having everything in one location had too much risk with it."

Cook also signalled that Apple's efforts to spend more in the US will come with real costs to Apple's balance sheet. He said the company already sources 19 billion chips from a dozen US states and will be expanding its own facilities.

Apple also said it will increase its cash

dividend by 4% to 26 cents per share and that its board has authorised an additional US\$100 billion for its stock buyback program, down US\$10 billion from the same time last year. – Reuters

# **US blacklist on China** carries errors, outdated info

**HONG KONG:** Doris Au, a seller of door locks and hardware in Hong Kong for 25 years, received a letter from her bank, DBS Group, last June stating that her business account would be closed. The bank gave little explanation but subsequently froze the account, killing her business with international suppliers, she said. Au discovered after searching online that another firm with a similar name was added to the US trade blacklist in October 2023 for "providing support to Russia's military and/or defense industrial base." The entry identified two addresses, one of which was Au's warehouse.

"We are not that company. It's totally a mistake," Au told Reuters in her warehouse stacked with locks, hinges and sliding-door kits from well-known brands. Au's predicament captures the challenge facing the administration of US President Donald Trump as it ramps up limits on China's access to American technology by adding dozens of Chinese firms to its Review finds over a quarter of listed Chinese and Hong Kong firms had wrong names and old contact data

A Reuters review of almost 100 Chinese and Hong Kong companies added to the US entity list in 2023 and 2024 found more than a quarter, or 26 entries, contained erroneous details, such as incorrect names and addresses and outdated information.

For each listed entity, Reuters visited at least one address identified by the US to determine whether the blacklisted firms were still there. Businesses at those locations included a beauty salon, a tutoring firm, a massage parlour and a counselling centre.

At one site in Shenzhen, Reuters

found weed-covered remnants of a factory locals said was demolished years earlier

Yet Reuters also found evidence of trade in restricted items by some entities, aided by loopholes, paper companies and networks of freight forwarders and shipping agents, illustrating challenge access to sensitive containing technology The entity list, established in

1997, has become an increasingly important tool for the US to limit technology transfers to Russia and China, including semiconductors, that might undermine US security. It is managed by the Bureau of Industry and Security (BIS), a Commerce Department

Five former US officials said it's hard to fix identity mistakes or update the entity list, partly because the agency lacks staff. One called BIS

"woefully under-resourced."

Many listed entities are front
companies, said Matthew Borman,
who until March was a senior BIS
official overseeing US export

controls, including those targeting China and Russia.

"The challenge is that they can move to a different address with a

move to a different audices while a different name," he said.

BIS and the Commerce Department didn't respond to detailed questions about errors on the trade blacklist and any actions to rectify them.

Singapore-based DBS declined to comment on Au's case. In its letter to Au, DBS didn't mention the entity list but said it had reviewed her business account and found "activity/information that is not consistent with your account

The Biden administration aimed to block tech transfers aiding Russia's war in Ukraine, adding hundreds of entities—many tied to China—to curb access. The list also targets China's advances in AI, military upgrades, and quantum tech.

That trend is continuing under Trump. US Commerce Secretary Howard Lutnick said in March that China must be prevented from getting US chips, noting the success of Chinese AI startup DeepSeek. He said the US would bring export controls into future trade deals. The Commerce Department has claimed some success from its export controls in stemming chip flows to Russia via Hong Kong and China. But they don't catch everything. Ukraine's KSE Institute think tank

found 76% of all common high priority items likely to be procured by Russia for its weapons programs, including semiconductors, radar and communications gear, were routed through China and Hong Kong in 2023.

Russian customs records show 20 of the 92 entity-listed companies visited by Reuters were exporting restricted items to Russia in December 2023, the most recent month for which a complete dataset was available. Those items, including semiconductors, were valued at US\$7.5 million (RM32 million). - Reuters



# Tariff-induced uncertainty seen curbing US job growth in April

WASHINGTON: US job growth likely slowed in April amid heightened economic uncertainty because of President Donald Trump's aggressive tariff policy, though companies continued to hoard workers, keeping the labour market humming for now.

The Labour Department's closely watched employment report on Friday is, however, likely to be dismissed as backward-looking and probably will not offer a clear pulse of the economy after GDP contracted in the first quarter under the weight of a deluge of imports as businesses tried to get ahead of tariffs.

Trump's April 2 "Liberation Day" tariff announcement ushered in sweeping duties on most imports from the US' trade partners, including raising duties on Chinese goods to 145%, sparking a trade war with Beijing and tightening financial conditions. Trump later delayed higher reciprocal tariffs for 90 days, which economists said was essentially a pause on the whole economy as it left businesses in a state of paralysis and risked a recession if there was no clarity soon.

"This is a situation where the air in the balloon is slowly dissipating out," said Brian Bethune, an economics professor at Boston College. "There's a certain amount of labour hoarding that's going on despite the uncertainty across so many different dimensions, on the anticipation that somehow there will be some clarity in terms of direction of policy."

Nonfarm payrolls likely increased by 130,000 jobs last month after rising by 228,000 in March, a Reuters survey of economists showed. Estimates ranged from 25,000 to 195,000 jobs added. Part of the anticipated step-down in payrolls would be due to the fading boost from warmer weather.

The pace of job gains would be pre than the 100,000 that economists say are needed to keep up growth in the working-age population. The unemployment rate is forecast to have been unchanged at 4.2% last month. While the labour market continues to show resilience amid a reluctance by employers to let go of workers after struggling to find labour during and after the Covid-19 pandemic, accumulating. warning signs

Business sentiment continues to plummet, which economists expect will at some point give way to layoffs. Already, airlines have pulled their 2025 financial forecasts, citing uncertainty over spending on nonessential travel

because of tariffs.

General Motors cut its 2025 profit forecast on Thursday and said it expected a \$4-5 billion (RM17-22 billion) tariff hit.

China has ordered its airlines not to take further deliveries of Boeing planes while Ryanair, Europe's largest low-cost carrier, on Thursday threatened to cancel orders for hundreds of Boeing aircraft if the tariff war leads to materially higher prices.

Amid the uncertainty, the Federal Reserve is expected to keep its benchmark overnight interest rate in the 4.25-4.5% range next week.

Economists expect companies will reduce hours before resorting to layoffs. The average workweek has been steadily declining since 2023 and held steady at 34.2 hours in March.

"How much can the labour market

absorb and handle this uncertainty that the administration has injected into the economy?" asked Martha Gimbel, executive director of the Budget Lab at Yale. "American businesses are resilient, and there's a lot that they can overcome, but they can't overcome everything, and at some point the policy environment is going to really start to bite."

The Trump administration's unprecedented and often chaotic campaign spearheaded by tech billionaire Elon Musk's Department of Government Efficiency, or DOGE, to drastically shrink the federal government through mass layoffs and deep funding cuts is adding to the rising labour market risks.

Some of the spending cuts have affected schools and medical research.



# Gold in spotlight, outshines better-value assets

Precious metal now trades at more than three standard deviations above long-term trend

LONDON: Gold is having a golden moment as investors fret about runaway prices and the stability of the US dollar. Adjusted for inflation, gold has risen above its previous peak in early 1980, after which its value declined in nominal terms for nearly two decades. The precious metal now trades at more than three standard deviations above its long-term trend. Although gold has retained its purchasing power over several millennia, it has proven a relatively poor hedge against inflation over the shorter term. After a 25% increase this year, it has never looked more expensive, both in real terms and relative to other commodities.

Anter a 25% increase tins year, it has never looked more expensive, both in real terms and relative to other commodities.

"The real price of gold," writes Campbell Harvey of Research Affiliates, "resembles a price-earnings ratio for equities. Very high P/Es are often followed by low expected returns. Gold's historical record suggests a similar pattern." Since 1975, investors who acquired gold at elevated prices lost money over the following decade. Conversely, buying gold when it was relatively cheap delivered positive inflation-adjusted returns.

inflation-adjusted returns.

Today its price is far out of line with several other commodities. Over the past half-century an ounce of gold has, on average, cost 21 times the price of a barrel of oil. Today, the gold/oil ratio is above 50 times – its highest-ever level apart from a brief moment in 2020. Gold also looks expensive relative to silver. Since 1975, on average, you could exchange 60 ounces of silver

for an ounce of gold. Today, gold is worth around 100 times more than its cheaper cousin.

There's another precious metal that looks even less expensive. Platinum may not have the allure of gold but is much harder to find. Global production is mostly concentrated in deep mines located in a small region of southern Africa. Platinum has been on a roller-coaster in recent years. In the first decade of the century, the metal was caught up in the mining supercycle when it boomed and then crashed. Mine production was interrupted during the pandemic after which platinum climbed above US\$1,200 (RM5,174) an ounce in the spring of 2021. Since then, it's fallen below US\$1,000. In real terms, platinum currently trades roughly 25% below its 50-year average.

Since 1900, the price of platinum has proved

Since 1900, the price of platinum has proved stable relative to gold, according to Bryan Taylor, chief economist at Finaeon (formerly Global Financial Data). Over the past 50 years, the ratio of gold to platinum has on average been about par. Since 2015, however, gold has pushed ahead and now trades at three times the price of platinum. Relative to gold, platinum has never been so cheap.

The significance of these comparisons is a matter of judgment. After all, gold is considered by many to be an alternative to unstable paper currencies. Although silver and platinum are officially designated monetary metals they lack the strong brand of their yellow rival.

Successive US presidents have threatened to undermine the current international monetary system dominated by the US dollar. After the US and its allies froze Russia's foreign exchange reserves in 2022, China and other central banks stepped up their purchases of gold. On several earlier occasions when international monetary regimes collapsed, gold underwent a paradigm shift

For instance, when the gold standard

collapsed in the early 1930s, its official price was raised from US\$20.67 per ounce to US\$35. After the post-war Bretton Woods system of fixed exchange rates crumbled in the late 1960s, gold became extremely volatile but settled at a higher average price, in real terms. Looking further back in history, the demonetisation of silver in Western industrial economies during the second half of the 19th century permanently lowered the market value of silver relative to gold.

Gold may be in the early stages of yet another paradigm shift. Furthermore, while the yellow metal benefits from economic uncertainty, industrial commodities are vulnerable to a global downturn. At the start of the pandemic in 2020 oil futures briefly turned negative. Around half of the annual production of silver goes to industrial applications, while three-quarters of platinum demand comes from industrial users. If the global economy turns down these commodities will surely take a hit.

There's another threat to consider. So-called platinum group metals, which include palladium and rhodium, are prized for their ability to withstand high temperatures. Around 44% of platinum production is used in auto catalytic converters that reduce pollution produced by internal combustion engines. Government targets to end the sale of traditional motor vehicles threaten the long-term demand for oil and for platinum and its related metals, which are not used in battery powered electric vehicles.

powered electric vehicles.

The recent parabolic price movement suggests that gold could be in a bubble. Speculators may continue to make money in the short run. But investors seeking to protect their wealth over the long run should look elsewhere. Relative to gold, oil and silver look extremely cheap. Platinum might be said to be in an anti-bubble. – Reuters

# Air India faces US\$600m hit from Pakistan airspace ban, seeks help

NEW DELHI: Air India expects to face around US\$600 million (RM2.6 billion) in additional costs if a ban from Pakistan's airspace lasts for a year, and has asked the federal government to compensate it for the hit, a company letter seen by Reuters shows. Indian airlines are bracing for higher fuel costs and longer journey times after Pakistan shut its airspace to the country's carriers in a tit-for-tat retaliation following an attack on tourists in Kashmir last week.

Air India on April 27 asked the Indian government for a "subsidy model" proportionate to the economic hit, estimating a loss of more than 50 billion Indian rupees (RM2.55 billion) for each year the ban lasts, according to a letter sent by the airline to the Civil Aviation Ministry seen by Reuters.

"Subsidy for affected international flights is a good, verifiable and fair option ... the subsidy can be removed when the situation improves," the letter said.

"The impact on Air India is maximum due to airspace closure, due to additional fuel burn, additional crew."

Air India declined to comment. India's Civil Aviation Ministry did not immediately respond to a request for comment.

to a request for comment.

Air India's letter was sent after the government asked its executives to assess the impact of the airspace ban on Indian carriers, said a source with direct knowledge of the matter.

The Indian government is considering options to reduce the hit to the airline industry from the closure of Pakistan's airspace, three other people familiar with the matter said.

One of the sources said Indian carriers met

One of the sources said Indian carriers met with the Civil Aviation Ministry to work on possible solutions, including flying over difficult terrain closer to China, and some tax exemptions.

It also requested government approval to carry extra pilots on US and Canada routes due to longer flight times. – Reuters

# US ends China duty exemption but collection uncertainty remains

WASHINGTON: The Trump administration ended US duty-free access for low-value shipments from China and Hong Kong on Friday, removing the "de minimis" exemptions availed of by Shein, Temu and other e-commerce firms as well as

traffickers of fentanyl and other illicit goods.

The action restores an executive order from President Donald Trump in February that was quickly suspended due to a lack of screening procedures for sub-US\$800 (RM3,449) shipments that sparked chaos at airports and caused millions of packages to pile up.

US Customs and Border Protection (CBP) has "a massive task at hand" but is ready to handle the enforcement and collection of Trump's tariffs on small Chinese shipments, a spokesman for the agency said.

"We are prepared and equipped to carry out enhanced package screening and enforce orders effectively as outlined" in Trump's executive order ending de minimis treatment for China, the spokesperson added.

The new procedures should not affect passenger wait times at airports and ports of entry, the spokesman said. The packages are handled in the cargo section of airports, even when they arrive in the bellies of passenger

Under CBP's latest guidance, shipments from China and Hong Kong regardless of size will now be subject to Trump's new tariffs of 145% plus any prior duties, except for products such as smartphones which were excluded last month. These will largely be handled by express shippers such as FedEx, United Parcel Service or DHL,

which have their own cargo handling facilities.

Items valued at up to US\$800 and sent from China via postal services are treated differently. They are now subject to a tax of 120% of the package's value or a flat fee of US\$100 per package – an amount that rises to US\$200 in June.

The US Postal Service said it would not be involved in any duty collections. Instead a USPS spokesman said airlines and vessel operators would need to work with shippers and Chinese postal authorities to pay the import taxes and show proof before the goods are transported out of China or Hong Kong.

out of China or Hong Kong.
Although de minimis is a Latin term referring

to matters of little importance, low-value shipments from China to the US reached an estimated US\$5.1 billion in 2024, according to US Census Bureau data. That made it the seventh-largest US import category from China, behind video game consoles, but just ahead of computer meditors.

computer monitors.

Shippers were bracing for more package chaos, and some questioned whether airlines were prepared to handle duty collection from China Post and Hongkong Post.

"We have the same worry about bottlenecks," said Kate Muth, executive director of the International Mailers Advisory Group (IMAG), whose members include Amazon.com, eBay and divisions of United Parcel Service, FedEx and

"I don't think we're ready for the change because we're still awaiting some clarification around the rules," including how to define Chinese origin for goods that are shipped from other countries, Muth said.

A late change in the CBP's guidance took away a major complication for shippers, but created a potential new hurdle to enforcement as CBP temporarily suspended a rule that would have required formal customs entry for all shipments valued at over US\$250 containing goods that are also subject to punitive tariffs.

goods that are also subject to punitive tariffs.

Formal customs entry, normally associated with larger, containerized cargo, requires full 10-digit tariff codes for all items, advance electronic transmission of entry data and a bond to cover for customs liability.

for customs liability.

And it would have applied to many other countries now subject to US tariffs imposed by Trump, creating a potential new crush of administrative paperwork for shippers.

Instead, the suspension allows the use of

Instead, the suspension allows the use of informal entry procedures for shipments from China and Hong Kong valued at up to US\$800 and up to US\$2,500 from elsewhere, requiring no tariff codes and a less detailed contents description.

Trump ended the de minimis exemption for China largely because it was being used for largely unscreened low-value shipments containing fentanyl precursor chemicals into the US, a phenomenon documented in a Reuters series about fentanyl. – Reuters

# Power of accountability

OFTEN find myself lamenting about poor customer service in Malaysia. During a recent conversation, a friend pointed out what she saw as a key issue: a lack of accountability.

Key ISSUE: a IACK Of accountability.

But what is accountability? Is it something we are born with or something we learn and cultivate? More importantly, why does it matter?

According to the Cambridge Dictionary, accountability is "the fact of being responsible for what you do and able to give a satisfactory reason for it, or

the degree to which this happens".

Put simply: if you are a restaurant manager whose job is to ensure that there is always 10kg of potatoes in the kitchen, then it is your job to make sure they

If the delivery van does not arrive, you don't shift the blame to the supplier or the kitchen staff. You find a solution – whether that means calling around, picking them up yourself or finding an alternative. You take ownership. You go the extra mile to ensure those potatoes are in the kitchen

are in the kitchen.

So what happens when we slip?

Of course, life happens. We get overwhelmed, distracted and things fall through the cracks. Do we get defensive, make excuses or blame others? Or do we own up to our mistakes and say, "That was my responsibility. I dropped the ball. I am sorry – and it won't happen again".

Is accountability inborn or taught?
The general consensus is that accountability is taught or learned - from the environment, society, culture, upbringing and personal experiences.

However, a lack of accountability is always just a character flaw laziness. In some cases, it can be a trauma response. Repeated developmental and relational trauma can significantly disrupt the normal development process needed for accountability.

Here are some ways trauma can apact a person's ability to be

- responsible:
  The brain may prioritise survival mechanisms over higher executive functions, like planning and followthrough.
- Deep breaches of trust may damage a person's ability to rely on others or be reliable themselves.

  Emotional regulation capabilities may
- be compromised, making it difficult to respond calmly and constructively to
- challenges.

  The ability to think long-term may be
- replaced by immediate self-protection.

  Tauma-related responses like hypervigilance or dissociation can interfere with focus, consistency and follow-through.

For many trauma survivors, what may appear as "irresponsibility" or a "lack of accountability" is actually an adaptive response to perceived threats.

Avoiding commitments, struggling with consistency or finding it difficult to acknowledge mistakes may not stem responses deeply rooted in past trauma.

This does not excuse harmful behaviour but it does offer important

context. Understanding the link between trauma and accountability can help us approach the issue with greater empathy and lead to more effective paths for healing and growth.

As someone who lives with C-PTSD

and struggles with ADD, I know firsthand the emotional weight of not meeting expectations. It is a genuine anguish and painful struggle. Learning accountability has been a lifelong lesson for me. It is not an excuse and has been a work in

If you are in a personal or professional relationship with someone who struggles with accountability, here are some constructive ways to support them:

- Practise patience and sensitivity: You may not know their full story. A lack of accountability could be a sign they are struggling with something deeper - and may not even be fully aware of their behaviour
- Prioritise psychological safety: Let them know that your relationship won't be threatened by mistakes or setbacks. People grow best in environments where they feel secure.
- Avoid shame-based approaches: Criticisms, lectures or disappointment can often backfire. These reactions can reinforce avoidance and defensiveness rather than inspire change.
- Separate behaviour from identity: Remind them that making a mistake does not make them a bad person. Accountability is about growth, not perfection.
- Recognise small steps: Acknowledge and appreciate even minor steps towards accountability. Progress is often incremental and encouragement can
- healthy accountability Model yourself: Be open about your own mistakes and how you take responsibility. This will create a culture of honesty and self-improvement.
- Self-improvement.

  Ask open, non-confrontational questions: Instead of saying, "Why did you do this?" try, "What do you think happened here?" This invites reflection without triggering defensiveness.

  Offer collaboration, not control:
- Frame solutions as a team effort "How can we work through this together?" rather than taking a top-down approach. Understand that defensiveness is often about pain, not defiance: What

looks like resistance may be a protective mechanism rooted in past hurt.

- © Gently highlight patterns without judgement: Pointing out recurring behaviours with care can help build
- behaviours with care can help build awareness and promote self-reflection.

   Encourage professional support when needed: Sometimes the most meaningful progress happens with the help of a coach or trauma-informed

Remember, your role is not to fix someone else but to help create conditions where healing and growth can become possible. Accountability skills take time to develop, especially when they are unfolding alongside the complex work of healing from trauma.

work of healing from trauma.

While certain predispositions may influence an individual's propensity for accountability, it is largely a learned behaviour cultivated through experience. This perspective will empower individuals and institutions to engage in

individuals and institutions to engage in practices that promote personal and collective responsibility.

Accountability is not about guilt or being caught and scolded. True accountability is about integrity - the quiet power of owning up to what is ours, even (and especially) when it is uncomfortable. uncomfortable.

In my work as a therapist, I have seen

the transformation when someone stops defending or avoiding and begins to take responsibility - not to punish themselves but to build trust, foster healing and grow in maturity

Accountability, in this light, is not a punishment; it is a practice of emotional courage.

# Young and broke: Symptom of Malaysia's deeper financial challenges



THE alarming rise in bankruptcy among Malaysian youths is a critical issue, with 877 cases reported in 2024 and over 5,000 since 2020.

Another major contributor to youth bankruptcy is the high housing and vehicle ownership cost. Malaysia's younger generation often aspires to achieve milestones such as owning a home or car, which can strain their finances. These aspirations are further compounded by the increasing cost of living, making it difficult for many to

inving, making it difficult for many to meet their loan obligations. Additionally, other types of debt, such as credit card liabilities and income tax, have contributed to the rising trend of bankruptcies. The failure to contribute to retirement savings, such as those required by the Employees Provident Fund, also adds to the financial instability many young Malaysians face.

# China shows sustained appetite for Malaysian durians

THE volume of China's durian imports from Malaysia is expected to increase by between 15% and 20% this year, driven by sustained consumer demand despite recent weather-related challenges in Malaysia, according to the Malaysia Chamber of Commerce and Industry in China.

Its chairman Loh Wee Keng said demand from Chinese consumers continues to outpace supply, particularly for premium varieties such as Musang King and D24.

"Although heavy rain in Malaysia caused some fruits to drop prematurely, I foresee the overall export volume this year to be 15% to

export volume this year to be 15% to 20% higher compared to last year," he said, adding that demand remains robust in the China market.

He explained that Malaysia's Musang King continues to command strong interest, especially among premium fruit consumers in China.

"Right now, it is impossible to get

A Musang King RM30 per kg at farm price. During the off-season like May, prices can go up to RM80 per kg. For D24, the lowest is about RM15 per kg," he said.

According to China's Agriculture Ministry, the country imported 19.25 million kg of durians from Malaysia worth US\$212.05 million (RM1 billion) between January and December

Fifteen years ago, Loh said the farm price for frozen Musang King was about RM25 per kg and could drop as low as RM12 per kg during peak season.

"While for frozen D24, the highest could be RM15 per kg, the lowest can come to RM3 per kg," he said. He also said Malaysia started to export durians to China since 2010.

"We are not competing with Thai durians because the prices and quality are completely separate matters. We are actually competing with kiwis and cherries as well as those products from Japan such as strawberries and grapes," he pointed out.

Loh, who had pioneered Malaysia's frozen durian exports to China following Beijing's approval in 2011, said industry players must protect the integrity of the Malaysian durian brands in China.

"Some traders mislabel kampung

durians and sell them as Musang King to get higher profits. This is damaging. Even kampung durians have a market if sold honestly. We have to educate Chinese consumers on the real characteristics of Musang King, D24 and others," he emphasised.

He also said the Chinese

government has been supportive and has shown leniency on Malaysian durian exports due to strong diplomatic ties. Hence, he said businesses must maintain the reputation and bilateral relations.

Commenting on attempts to cultivate Musang King on China's Hainan island, Loh said the results have not matched the standards of Malaysian-grown durians.
"There was initial excitement, but it

faded quickly. The taste is different due to the soil and climate. My friend also tried growing it here, but it was not successful. Hainan Musang King cannot replace the Malaysian original," he added. – Bernama

T a mountainside cafe in southwestern China, Liao Shihao brews handfuls of locally grown coffee beans, a modern twist on the region's traditional drink. For centuries, Pu'er

in Yunnan province has given its

Every year, Pu'er's plantations sell tens of thousands of tons of coffee to major Chinese cities, according to government data.

In metropolises such as Beijing and Shanghai, a thriving cafe scene has emerged in recent years, driven by people aged between 20 and 40.

To Liao, a trained roaster and

barista, coffee from his home region possesses "a creamy flavour with a silky, viscous mouthfeel".

Modern commercial plantations only sprang up in Pu'er in the 1980s, and the area is still better known for its centuries-old tea trade.

Liao's grandfather Liao Xiugui said "nobody knew anything about coffee" when he arrived in Pu'er a few decades ago

At the time, the older man was one of few people in China who had studied coffee cultivation. But the region's relatively high altitude and temperate climate were well-suited to the unfamiliar crop, said the now

83-year-old.
"The quality of the coffee we plant here is strong but not too bitter, floral but not too heady, and slightly fruity." he added.

Free from artificial pesticides and interspersed with other species for biodiversity, Little Hollow yields about 500 tons of raw coffee fruit per year.

Xiugui himself drinks two or three cups a day, and credits the caffeinated beverage for keeping him

spry in his advanced years.
"Drinking coffee can make you younger and healthier... and prevent ageing. Also, everyone is tired at work these days... and they want to give their brains a boost," he smiled.

#### Richer pickings

China's coffee output has risen dramatically in recent years, though it still lags far behind traditional powerhouses such as Brazil, Vietnam and Colombia.

Yunnan, near three borders with Southeast Asian nations, accounts for virtually all of China's coffee production, much of it concentrated in Pu'er.

On a visit to Yunnan last month, Chinese President Xi Jinping said the province's coffee "represents China", according to state media.

Keen to further expand the sector,

officials have rolled out policies to improve production, attract investment and boost exports, according to government statements.

They have also merged coffee

production with tourism, dovetailing with a central government push to

increase domestic consumption. Longtime farmer Yu Dun, 51, said she had opened new income streams with plantation tours, homestays and

ar restaurant fusing coffee with the cuisine of her native Dai ethnicity. Her prospects were bright, she said, adding that she also earned "10 times" more revenue from her beans since learning to process and roast them herself.

"We used to say only rich people could drink coffee, but that has all changed now," she said. - AFP

# French pastry chefs complete 'world's longest cake'

ARMED with 4,000 eggs and a truckload of sugar and cream, French pastry chefs recently completed a 121.8m-long strawberry cake which they have claimed is the world's longest ever made

Youssef El Gatou brought together 20 chefs to make the 1.2-tonne masterpiece that took a week to complete and was set out on tables in an ice rink in the Paris suburb town of Argenteuil for residents to inspect.

The effort overtook a 100.48m-long strawberry cake made in the Italian town of San Mauro Torinese

El Gatou's cake also used 350kg of strawberries, 150kg of sugar and 415kg of cream.

To claim the record in the Guinness book, the cake had to be at least 8cm wide and 8cm tall. The logistics were so difficult that the team blowtorches to heat the bowl" for the



# Wonders of chocolate's base ingredient

**CACAO** beans have uses that go beyond being the base ingredient of our hot chocolate mixes or the traditional Easter treats to hide in the garden. Today, cacao beans are processed in all sorts of ways to make the most of every part of the bean. Here are a few examples of how cacao beans are utilised:

#### Cacao water

Mucilage – a whitish pulp that surrounds fresh beans. South American workers who harvest the pods have long been used to sucking this white material-like candy. There are now several ways to make use of this raw material, including as cacao water.

A simple cold extraction process produces a juice with a tangy taste that is rich in antioxidants and theobromine, an energiser similar to caffeine. In late 2021, chocolate giant Barry Callebaut announced it

had spotted a new opportunity by launching its first functional beverage, made from cacaofruit.

#### Mucilage in fine dining dessert creations

In the world of pastry, mucilage is a novel ingredient that some top chefs are experimenting with. Its fruity flavour has serious potential for creating a new kind of chocolate dessert. At the Four Seasons George V hotel in Paris, the young prodigy Michael Bartocetti sources it from Vietnam. Michael

#### As building material

In Ecuador, an architectural project aims to build an eco-village made up of sustainable buildings constructed from recycled cacao bean waste.

This raw material gets fed into 3D printers to produce fibers capable of constructing buildings in an area traditionally used for cacao cultivation. Ecuadorian brand Muze Cacao is a partner for this vast project.

In Cote d'Ivoire, the leading cacao-producing country, an artisan chocolatier (Le Chocolatier Ivoirien), who launched his brand to demonstrate that the country also had the skills to transform the raw material into chocolate bars, recently initiated a project to recycle cacao beans into powder

for use in make-up foundation.

In fact, the entrepreneur is turning the technique of using cocoa powder as foundation for black skin into a commercial venture. It is a trick that legendary make-up artist Pat McGrath spoke about when discussing the beauty industry's long journey producing for diverse skin tones.

The teenager has played just four games in the IPL, but has wowed viewers with his fearless approach and bat strength.

Nicknamed "Boss Baby". Survayanshi has drawn instant comparisons with West Indies great Chris Gayle, who styled himself as the "Universe Boss".

But on Thursday, millions of fans who eagerly awaited Suryavanshi's turn at the crease saw the teenager fall swiftly without having troubled the scorer in a match against IPL heavyweights Mumbai Indians.

The money-spinning IPL has been a breeding ground for up-and-coming talent with the likes of Yashasvi Jaiswal, Suryakumar Yadav and Jasprit Bumrah making a name for themselves through the league.

But never has a 14-year-old garnered so much attention.

Cricketing veterans, however, have warned him of life in the spotlight.

"Conceptually, yes. But obviously we want to see these things put into action rather than saying 'we're considering things'. We

all consider a lot of things.
"We're clear, we want changes. And once they are implemented, then we'll comment on it. But for the time being it's being considered. The words don't mean anything until the change has been

"It'll be great if changes were made and the drivers were at least heard," said Russell. "And I think it's just in the best interest for the sport and ensuring that some common sense is sort of applied to situations," he added.

"But as I said, I think all of us can comment on it when we see the action being taken, rather than just the consideration." – Reuters

consecutive defeats for Inter, and saw the return of forward Marcus Thuram from injury, host lowly Hellas Verona tomorrow (2.45am Malaysian time).

Verona, 15th in the standings, are seven points above the relegation zone but with games against fellow strugglers Lecce and Empoli still to come, they cannot take any

Antonio Conte took over a Napoli side with no European football after a 10th-place finish last season, and an early exit from the Coppa Italia has seen them free of any other

commitments since early December. Napoli's Cup defeat by Lazio was followed by a league loss to the same opposition, but Conte's side then went on a 10-game unbeaten run which allowed them take back the top spot which Atalanta had briefly taken from them

Napoli visit Lecce tomorrow (12.01am), a side without a win in 11 games and who are one place and two points above the drop zone.

Atalanta are aiming to maintain their grip on third place when they travel to bottom club Monza and Juventus are at Bologna in a Champions League qualification showdown.

AS Roma, Lazio and Fiorentina are also in the hunt for a Champions League place. - Reuters

He added: "There are still four games to go, a lot of football to be played. We have to focus on ourselves and play better football."

Forest would have climbed to third with a win but despite the defeat they have 60 points, just two behind Newcastle, with Manchester City, Chelsea and Villa also in the mix. Defeat is a bitter disappointment

for Forest but a major boost for Brentford in their own drive to qualify

for European football next season. The three points lift the Bees just one point behind 10th-placed Bournemouth as they chase their highest Premier League finish.

### MFL extends club licence application deadline

THE Malaysian Football League (MFL) has explained the decision of the independent First Instance Body (FIB) to extend the National Licence application period in accordance with the provisions outlined in the MFL Club Licensing Regulations 2024/25 season.

In a statement yesterday, the MFL informed that the FIB committee appreciates the commitment of clubs that have completed the document submission process in the AFC CLAS (Club Licensing Administration System) licensing system before or on the original deadline of April

However, the governing body of the Malaysian League (M-League) clarified that, following written requests from several clubs, the FIB has granted an extension of the deadline to May 10.
"The decision for this extension was

made based on the authority granted to FIB under the MFL Club Licensing Regulations 2024, Article 7, 8(a).

"With this extension, MFL hopes that the clubs involved can upload their documents no later than the new deadline, which is before or by (or on) May 10, 2025,

the statement read.

According to MFL, Article 7, 8(a) of the 2024 MFL Club Licensing Regulations states that "The decision-making bodies must operate according to the principles of natural justice and must, at a minimum, regulate the following standards: deadlines (e.g. submission deadline, etc.);" while also considering the specific circumstances of each application and case submitted.

Last Wednesday, the FIB agreed to grant clubs additional time to complete all required documents for the 2024/2025 Club Licensing Cycle for the National Licence within the AFC CLAS licensing system. – Bernama

RUNO FERNANDES struck twice as Manchester United put one foot in the Europa League final with a clinical away performance to beat

10-man Athletic Bilbao 3-0 yesterday.
The fervent home fans were enraged when Athletic defender Daniel Vivian was sent off for pulling back Rasmus Hojlund and Fernandes slotted home the resulting penalty, after Casemiro had opened the scoring against the run of play in the semifinal first leg.

Fernandes rolled in a third before

halftime as Ruben Amorim's side moved a step closer to the final, to be held at Athletic's San Mames stadium.

The hosts have been dreaming of winning a first European trophy on their own soil but their hopes were demolished by United's professional display in the north of Spain - and Athletic's supporters argued, the refereeing.

"I think it's the best result (of my tenure) because nobody expected this result - but you saw two games today," Amorim told reporters.

"The first 25 mins, then (another one) after the goal and the sending-off."

Languishing in 14th in the Premier League, Champions League qualification for United is only possible with a Europa League triumph, as is access to the £100 million (RM568m) honeypot it entails.

Despite regularly crumbling under pressure this season, the Red Devils who produced a stunning comeback against Lyon in the quarterfinals first survived and then thrived in a hostile environment.

"We looked a little bit nervous at times in the first 20 minutes... we weathered the storm and we knew we'd get our chance," Man United's Harry Maguire told *TNT Sports*. "It was a clinical first half, professional

second half... It's a great victory in the end but there's another big game next week." With May 1 a bank holiday in Spain the streets of Bilbao were filled with red-and-white striped shirts from the morning onwards, in party mode.

The San Mames was rocking as fans greeted their heroes, all of them born or raised in the Basque country, as per the club's century-long policy.

Beyond an Alejandro Garnacho goal
