PM's Brazil visit aimed at strengthening bilateral ties

Anwar in largest South American country at invitation of Brazilian president and to attend G20 Summit

BIO DE JANEIRO: Prime Minister Datuk Seri Anwar Ibrahim arrived in Brazil yesterday from Lima, Peru, for an official visit and to attend the Group of 20 (G20) Summit 2024, at which Malaysia is

Summit 2024, at which Malaysia is a guest country. Sixteen other countries, including Chile, Qatar, Egypt, Singapore, Spain, United Arab Emirates and Vietnam, are also guest countries at the summit. The G20 consists of 19 countries and two unions, namely Argentina, Australia, Brazil, Canada, China, France, Germany.

Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, Mexico, Russia, Saudi Arabia, South Africa, South Korea, Turkey, the United Kingdom, United States, European Union and the African Union African Union.

Anwar is here on the invitation of Brazilian President Luiz Inacio Lula da Silva. His special flight touched down at the Rio De Janeiro Galeao Air Force Base at 9.24am Malaysian time.

He was received on arrival by Lt-Col Buch Itamaraty, a representative of Galeao Air Force deputy commander and Councillor Orlando Timponi, a representative of the Brazil foreign affairs ministry.

affars ministry. Other officials present included Malaysia's Ambassador to Brazil Gloria Tiwet, the Malaysian embassy first secretary Muhamad Muhaimin Azmi and

Anwar, who is also finance minister, is being accompanied by Foreign Minister Datuk Seri

Foreign Minister Datuk Seri Mohamad Hasan and Investment, Trade and Industry Minister Datuk Seri Tengku Zafrul Abdul Aziz. The Malaysian delegation also includes Natural Resources and Environmental Sustainability Deputy Minister Datuk Seri Huang Tiong Sii, Energy Transition and Water Transformation Deputy Minister Akmal Nasrullah Mohd Nasir and other senior Malaysian government officials.

At the summit, Anwar will deliver statements at the "Fight Against Hunger and Poverty" and "Reform of Global Governance Institutions" sessions.

He is also scheduled to meet leaders of G20 countries to discuss bilateral and multilateral issues of mutual concern, Bernama reported.

Anwar will meet Lula da Silva to discuss bilateral cooperation, including in areas of trade and investment as well as the semiconductor industry, and to renew friendship ties between the two countries

Border wall land acquisition to cost RM445m

KOTA BHARU: The Kelantan government has estimated that RM445.75 million would be needed for land acquisition in areas identified for the proposed construction of a border wall and buffer zone.

Kelantan Menteri Besar Datuk Mohd Nassuruddin Daud said the proposed security and flood control wall is crucial for the state's economy.

He said Kelantan is serious about combating smuggling activities and addressing flooding issues along the 99km stretch of Sungai Golok.

'The construction of a border wall "The construction of a border wall between Kelantan and Thailand, particularly for national border security, is essential to curb cross-border crimes," he said at an engagement session on the 13th Malaysia Plan at Kompleks Kota Darukapin werterdau Darulnaim yesterday. budget, a total of RM200 million has been allocated to extend the special needs student allowance of RM150 per month, which will benefit more than 100,000 PwD

students across Malaysia. "It was also announced that RM5 million will be allocated to develop an autism service centre. "Our apple in the service continuous"

No need to issue new maritime boundary map: Minister

JOHOR BAHRU: Malaysia sees no need to issue a new maritime boundary map and remains steadfast in defending the nation's sovereign territories, said Defence Minister Datuk Seri Mohamed Khaled Nordin.

Latuk Seri Mohamed Khaled Nordin. He said Malaysia prioritises diplomacy, engaging in discussions and negotiations to address challenges arising from overlapping claims.

"Following the Philippines' release of its new map, I believe Malaysia's decision to issue a new one depends on whether changes to the current map are warranted.

"Our map remains unchanged. It is not us altering boundaries – it is them (the Philippines) who periodically adjust theirs. We don't make changes, as doing so implies incorporating areas belonging to others. Our map

stays as it is, and we will continue to defend our territories and sovereignty," he said after the Wakalah Zakat handover ceremony by Boustead Petroleum Marketing Sdn Bhd at Masjid Al-Muhajirin in

Masai yesterday. He was responding to a question on whether Malaysia should issue a new maritime boundary map in light of the Philippines' two new maritime

laws, which infringe on Sabah's maritime borders. Mohamed Khaled said the navy,

air force and Malaysian Maritime Enforcement Agency continuously conduct integrated monitoring through a show of presence to assert and protect the nation's sovereignty.

He said protests under established international laws would be lodged if foreign vessels are detected entering Malaysia's territorial waters.

"We also implement maritime domain awareness, meaning we monitor and know when other vessels enter into our sovereign waters."

Foreign Deputy Minister Datuk Mohamad Alamin said a protest note has been sent to the Philippines on its new maritime laws. – Bernama

Data security concerns over petrol subsidy plan

Consumers risk making payments to unverified merchants and exposure of private details: Expert

PETALING JAYA: While the government plan to use MyKad and e-wallets for RON95 petrol subsidies aims to ease the public's burden and address subsidy leakage and smuggling, data security and hacking remain a serious concern. Universiti Teknologi Mara Institute of

Universiti Teknologi Mara Institute of Transport head of legal and quality Dr Siti Ayu Jalil said although the details and mechanism of the plan are unclear, worries have arisen over the potential risks to data security and privacy. "Consumers face heightened security and

"Consumers face heightened security and fraud risks, such as making payments to unverified merchants, exposure of private details or potential data breaches. Additionally, if a phone is stolen, a thief could gain access to the e-wallet."

On Nov 12, Deputy Finance Minister II Datuk Seri Amir Hamzah Azizan said the subsidy retargeting system, estimated at around RM12 billion for 85% of the population, is expected to be finalised before its rollout in mid-2025.

He solution in the targeted subsidy approach for RON95 would follow similar principles used for electricity and diesel subsidies, involving a tiered pricing system. "The main objective is not to burden the

"The main objective is not to burden the public but to curb subsidy leakage and smuggling, which have primarily benefited foreign nationals and businesses."

However, Siti Ayu said if robust cybersecurity measures are not implemented, data could be vulnerable to unauthorised access, leading to identity theft, financial fraud or misuse of personal information.

She said ensuring data encryption, regular system audits and secure authentication methods are critical to safeguarding user information. "The government and financial

The government and mnancial institutions must educate the public and promote safe digital payments. They must be transparent about how users' data are being used to guarantee the security and reliability of the subsidy distribution payment system."

She said using MyKad and e-wallets as the mechanism to distribute RON95 may seem handy for the younger generation who are more familiar with digital tools, but it may not be user-friendly for the elderly.

She added that this group may be cautious about using digital payment systems, given their unfamiliarity with such technology. "According to chief statistician Datuk Seri

Dr Mohd Uzir Mahidin, those aged 60 and above represent 11.6% or 3.9 million of the population. "Bear in mind that this vulnerable group often has the utmost need for subsidies and

the government should be sensitive and cater

to their needs, instead of putting obstacles in their way." Siti Ayu said the impact of fuel affordability

Siti Ayu said the impact of fuel affordability for rural populations with limited digital infrastructure is something to worry about.

She said it could hinder their ability to benefit from the proposed subsidy mechanism, potentially worsening inequalities between urban and rural areas.

"To address these issues, the government must prioritise enhancing digital infrastructure in underserved areas before rolling out the system.

"Creating awareness and being proactive in educating and providing information to rural folks is vital while transparency is equally crucial to building trust among rural populations."

She said the government should address issues about foreign nationals and businesses misusing subsidies meant for Malaysians

Issues about rolegn hadonais and obtainsses misusing subsidies meant for Malaysians. She also said the commercial sector, non-citizens and illegal petrol smuggling account for about 40% of petrol consumption, so it is best to suggest addressing these illegal issues before considering a subsidy redistribution system.

"It is unfair to target individual citizens to resolve the problem. A local study has proposed a flexible fuel subsidy distribution model known as FlexFuel, which could be tailored based on vehicle type, income group and tax residency.

and tax residency. "This approach would ensure that only eligible citizens benefit from the scheme, prevent foreigners from accessing subsidised petrol, minimise subsidy abuse, maintain the country's long-term financial stability and indirectly reduce fuel consumption."

She also said integrated collaboration with Asean and the international community is essential to ensure Malaysia and the region achieve net-zero carbon emissions by 2050, with the support of sustainable investment and green technology to reduce the impact of pollution.

She added that through the department, the government has taken several measures to mitigate and adapt to climate change for the well-being of the people and the country's sustainable progress. One of the department's key initiatives is the

One of the department's key initiatives is the enforcement of the Environmental Quality Act 1974, which covers several aspects, such as the control of air, water, noise and waste pollution.

She said the prohibition of open burning under Section 29A of the Act aims to prevent local haze while enforcement efforts have shown the effectiveness of this law as the number of fines issued has decreased.

At the international level, she said Malaysia is committed to implementing the Montreal Protocol, which phases out the use of ozone-depleting substances. – Bernama

Varsity student credits success to *Quran*

PUTRAJAYA: Memorising the *Quran* before working on assignments has been the key to success for Universiti Tenaga Nasional (Uniten) graduate Muhammad Hasif Zikry Mohd Ridzwan, who was honoured with the Chancellor's Gold Award on Saturday.

The award was presented by Penang Yang Dipertua Negeri Tun Ahmad Fuzi Abdul Razak, who is also the university chancellor, during Uniten's 26th convocation, which was held over two days.

After the ceremony, the 22-year-old said he made it a daily routine to memorise the *Quran* for about an hour, or two pages, before tackling tasks given by his lecturers.

"Typically, after memorising the Quran, I would work on the assignments. I have noticed that after doing so, everything seems to fall into place more easily," said the graduate of the Bachelor of Science in Computer Science (Software Engineering) (Honours) programme.

Japan trade organisation expresses trust in M'sia as Asean Chair

KUALA LUMPUR: Malaysia is in a position to demonstrate leadership in Asean as the country assumes its chairmanship role next year.

Japan External Trade Organisation (Jetro) Kuala Lumpur managing director Koichi Takano said there are expectations and trust in Malaysia's leadership.

Malaysia's leadership. "The Asean Community Vision 2045, which (outlines) the region's future direction, is expected to be adopted in Malaysia at the Asean Summit next year." He said the country is gaining attention as a hub for access to the region and third-country markets. He added that there is a recent

rend of increasing Japanese investments in Malaysia, especially in the retail sector. "Bookstores, drugstores, major

furniture companies and secondhand goods stores are expanding their store networks in Malaysia."

He added that several acquisition cases have also been reported in the digital transformation field. "Due to rising costs and stricter visa acquisition procedures in some other Asean countries, there is a movement to establish regional headquarters in Malaysia (as companies) evaluate the advantages of Malaysia's business environment." Takano said Japanese investments

Takano said Japanese investments would focus on carbon neutrality, health and medical care, digital, data centres and *halal* industry hubs.

Japan was the third leading source of foreign direct investment flows into Malaysia last year, with RM5.5 billion registered, a significant portion of which was in the manufacturing sector, according to the Statistics Department.

He said as an adviser to the Federation of Japanese Chambers of Commerce and Industry in Asean (FJCCIA), Jetro would work with the Japanese Chamber of Trade and Industry Malaysia (Jactim) to connect Asean and Japanese companies to Improve the business environment.

Jactim president Takero Sawamura said as a member of FJCCIA, Jactim would continue to work towards realising the Asean community vision, strengthening Japan-Asean relations and enhancing the business environment through dialogue with the Asean secretary-general and other means.

"I believe that a major theme going forward would be whether the private sector can promote more steady and sustainable growth, so it is necessary to strengthen the relationship between Japan and Asean." – Bernama

PETALING JAYA: When a Gen Z employee (born between 1997 and 2012) recently resigned via WhatsApp with a brief message saying: "Sorry and bye", it reignited a long-standing debate that individuals of the generation are rude and unprofessional.

However, Universiti Kebangsaan Malaysia sociology and anthropology professor Dr Novel Lyndon said the public should not be too quick to pass judgement as Gen Z employees "are technologically more advanced and wired differently"

"While they may show a lack of commitment and dedication to their jobs and might come across as selfish or even disrespectful, we must address these issues in light of the generational and societal influences on them."

He added that their behaviour results from attitudes shaped by the digital world and may also reflect the failure of the education system and parental roles.

"I believe that today's postmodern world, which emphasizes freedom and individualism, has had a significant impact on Gen Z's perspective on work. Their generation is very vulnerable and influenced by Individuals of age group have bona fide preference for fast, informal communication styles sometimes misconstrued as disrespectful

technology, which seems to dictate how they behave."

Lyndon also suggested that some Gen Z employees may face problems stemming from a lack of alignment between their jobs and personal identities, and that understanding the "soul" or interests of young employees will point to why some of them do not fully commit to their jobs. "Perhaps the work is incompatible

with their real interests or the salary offered isn't commensurate with their work. Whichever it may be, let me stress that employers should also play a part in bridging the

generational gap." He suggested that employers engage and communicate directly with Gen Z employees to understand their perspectives and address misunderstandings, as there needs to be worker engagement. Lyndon said understanding the

social identity and technological influences on Gen Z is key to fostering a more harmonious and

productive workplace.

Gen Z employee Kuvineshwaren Nedunjelian, 24, believes mutual transparency respect, accountability highlight

professionalism. "It's not about being rigid but respecting the role and people involved," he said.

He added that combining a formal esignation notice with a one-to-one conversation or through a video call is the ideal way to resign. "It is more professional and allows

for the personal touch, which shows respect for the employer."

However, Kuvineshwaren emphasised that Gen Z values efficiency over formality and views professionalism as being accountable and respecting another's time. While he is open to digital

communication methods, he believes the older generation might find it too casual.

Like many of his peers, he believes that Gen Z is often misunderstood by older colleagues, who interpret a direct approach to resignation via channels like WhatsApp as being disrespectful. "Our approach isn't about being

rude or disrespectful. We just prefer faster, sometimes less formal ways of communicating," he said.

Nur Izazi Mohd Isrook, 23, said the most comfortable way to resign is by informing the employer through the easiest and most direct method.

"We need to leave on a good note, but we don't feel that long, formal face-to-face meetings are necessary for resignations unless the job was really important to us."

She said professionalism is about respect, transparency and meeting expectations, and it is meaningless to follow rigid formalities if it is inefficient.

Thivines Pathmanaban, 22, sees value in traditional methods and ethics in submitting a resignation letter as it is the right approach. formal

"Employers need documentation to verify an employee's resignation and without it, the company could face legal challenges. "Maintaining

clear, formal documentation helps set boundaries between personal and professional relationships because people we work with are colleagues who deserve to be respected."

Appeals court to decide on Bung Moktar, wife's graft case

Three-judge panel to deliver verdict on prosecution's appeal against acquittal over bribery charges

KUALA LUMPUR: The Court of Appeal will announce its decision today on the prosecution's appeal against the acquittal of Kinabatangan MP Datuk Seri Bung Moktar Radin and his wife Datin Seri Zizie Izette Abdul Samad on three corruption charges involving RM2.8 million.

The decision is set to be delivered at 9am by a three-judge panel comprising Justices Datuk Ahmad Zaidi Ibrahim, Datuk Mohamed Zaini Mazlan and Datuk Noorin Badaruddin.

If the court rules in favour of the prosecution, the case will return to the sessions court for the couple to defend

themselves against the couple to deterin themselves against the charges. Alternatively, if the panel upholds the acquittal, the couple will remain cleared of the charges.

The prosecution filed its appeal on Sept 18, 2023, following High Court Judge Datuk Azhar Abdul Hamid's decision on Sept 7,

2023 to acquit the couple. The High Court had allowed a review of the Sessions Court's earlier ruling, made on Sept 2, 2022, which required them to defend themselves.

In the first charge, Bung Moktar, 65, was accused of accepting a RM2.2 million bribe from Public Mutual Berhad investment agent Madhi Abdul Hamid via his wife, Zizie Izette. The alleged bribe was said to secure

approval from the then finance minister II for Felcra Berhad to invest RM150 million in

Public Mutual's unit trust products. The offence allegedly occurred at Public Bank Berhad, Taman Melawati Branch, Jalan Bandar 12 in Taman Melawati, between 12.30pm and 5pm on June 12, 2015.

The second charge accuses Bung Moktar of accepting a RM262,500 bribe from the same agent through a Public Islamic Treasures Growth Fund account registered under Zizie Izette's name for the same purpose.

In the third charge, Bung Moktar is alleged to have accepted RM337,500 from another Public Mutual Berhad investment agent Norhaili Ahmad Mokhtar through a Public Ittikal Sequel Fund account registered under Zizie Izette's name. Bernama reported.

Both incidents allegedly occurred at the same location on June 19, 2015 at 12.16pm

and 12.28pm, respectively. The charges were filed under Subsection 17(a) of the Malaysian Anti-Corruption Commission Act 2009 and are punishable under Section 24(1) of the same Act upon conviction. The penalties include a jail term of up to 20

vears and a fine of either RM10.000 or five times the value of the bribe, whichever is higher.

Zizie Izette, 46, an actress, has pleaded not guilty to three counts of abetting her husband under Section 28(1)(c) of the MACC Act, which carries similar penalties.

RM374,000 in compounds for vehicle emission violations

BUTTERWORTH: The Penang Department of Environment has issued 187 compounds involving RM374,000 for various emission-related offences during statewide operations conducted between January and Saturday. Its director Norazizi Adinan said 57

operations were carried out during this period, focusing on emissions from diesel and petrolpowered vehicles, as well as noise and gas emissions from motorcycles.

"These operations aim to enhance enforcement and inspections of motor vehicles to ensure compliance with emission standards and prevent environmental pollution," he said during the national-level Motor Vehicle Operation (*Ops Gerak*) held in conjunction with World Ozone Day 2024 on Saturday night.

The operation, held in collaboration with the police, Road Transport Department (RTD), National Anti-Drug Agency (AADK), Immigration Department, PLUS Malaysia Berhad and the Seberang Perai City Council, took place at the Penang Bridge Toll Plaza involving 100 officers and enforcement personnel.

Norazizi said the operation, conducted at four key locations across the state since

Wednesday, focused on motorcycle noise levels and emissions from commercial vehicles.

"During *Ops Gerak*, 553 vehicles were inspected, leading to 17 fines totalling RM34,000, issuance of 35 Section 48A notices for vehicle retesting and four prohibition conters," he said, adding that most penalised commercial vehicles were factory buses emitting smoke above the permitted density. Additionally, police carried out 257 inspections and issued 28 summonses.

RTD issued 157 summonses and seized five

vehicles, while AADK detained nine individuals who tested positive for drugs. - Bernama

accumulated profit of RM8 million.

However, when the victim attempted to withdraw the earnings, he was told to pay a RM100,000 deposit. "The victim refused to pay the deposit and realised he had been scammed. He lodged a police report yesterday." – Bernama

Housewife in fatal UiTM crash still under mental health evaluation

DUNGUN: The Dungun Magistrates' Court was informed yesterday that a housewife accused of causing the deaths of three Universiti Teknologi Mara (UITM) Dungun campus students in a road crash last month remains under mental health evaluation at Hospital Permai, Johor Bahru.

State prosecution director Azizan Abdullah told the court that a full report on the mental health status of 49-year-old Norizan Ismail has not yet been finalised.

"The accused has no prior record of psychiatric treatment and the hospital has requested an extension under Section 342 of the Criminal Procedure Code," he said. Norizan's lawyer Norhabibah Norulalzahar of

ssrs Ghazali Ismail & Co confirmed the update. Magistrate Nur Amirah Fatihah Osman approved

an extension of detention under Section 342 for another month and set Dec 17 for the next mention. Norizan faces three charges of murder under

Section 302 of the Penal Code in connection with the deaths of Muhammad Akmal Md Tukirin, 25, Ku Adib Aizad Ku Azmi, 20, and Khairil Anuar Jamaluddin, 20.

The charges stem from an incident on Oct 9 when Norizan, driving a sports utility vehicle, allegedly crashed into four UiTM students.

The impact resulted in three fatalities and injuries to another student, Muhammad Ammar Danish Mohamad Ridhuan, 20.

Norizan also faces an attempted murder charge under Section 307(1) of the Penal Code in the Kuala Terengganu Sessions Court for causing injuries to Muhammad Ammar Danish. The case is also scheduled for mention today.

On Oct 15, during her arraignment, Magistrate Nur Amirah Fatihah ordered Norizan to undergo a

one-month mental health evaluation at Hospital Permai, with yesterday initially set for the case mention. - Bernama



Reluctance to wear life jackets raises risks

Public urged to discard 'inconvenience' mindset and acknowledge vital function of personal floatation devices

PETALING JAYA: Considering recent tragedies involving water activities, the Putrajaya Fire and Rescue Department has called on the public to be more cautious and always wear safety gear.

Its Fire Safety Division director Datuk Khirudin Drahman Hussain told *theSun* the public should give more thought to wearing personal flotation devices such as life jackets.

He was commenting on fatal incidents such as the drowning of five people during training for the Sarawak Regatta last month and a water rafting accident in Gopeng that claimed three lives after continuous rain caused the water level in Sungai Jahang to rise rapidly.

"In the regatta incident, the victims were not wearing life jackets. Wearing one is essential during any water activity. It's a simple precaution that can make the difference between life and death.

"While water may appear calm and inviting, its risks are always present and can escalate quickly due to changes in weather or tide. Safety isn't just about wearing a life jacket, it's also about being aware of your surroundings," he said.

Khirudin stressed that people need to be mindful, especially when near or in water.

"It's crucial to avoid water activities during bad weather or when tides are unusually high. The public must always remain alert and take responsibility for their safety.

"They also need to pay close attention to indicators, such as safety flags and warning signs, which can help avoid dangerous areas.

These indicators are there for a reason, and staying alert to them is crucial."

He advised the public to also be aware of changing weather conditions, as they can quickly turn calm waters into a dangerous situation.

"A sudden change in the weather or an unexpected current can be high-risk, even for those who are highly skilled swimmers or ardent fans of water activities," he said, adding that the reluctance to wear life jackets remains one of the biggest challenges in promoting water safety.

"When dealing with water safety." "When dealing with water-related risks, extra precautions must be taken. This must be a habit for anyone engaging in water activities. Even minor non-compliance can lead to tragedy.

"Even for our water rescue specialists, wearing the right safety gear, including life jackets, is a non-negotiable requirement under our SOP," he said.

Alliance for a Safe Community chairman Tan Sri Lee Lam Thye expressed concern that despite the emphasis on water safety, many individuals continue to neglect wearing

life jackets.

He urged everyone involved in water activities, from weekend boaters to daily fishermen, to always wear them, and stressed that they are an essential piece of safety equipment.

"People need to learn from past mistakes and take the necessary precautions. Whether you are on a fishing boat or just taking a river tour, a life jacket should be part of the experience."

Lee added that while some may see not wearing a life jacket as a minor infraction, the consequences can be devastating. Even a momentary lapse in judgement can lead to irreversible consequences, leaving families and communities grieving.

"Life jackets are not just accessories, they are life-saving items. A simple action like wearing a life jacket can make a huge difference in protecting lives.

"The public needs to be more prepared to learn, stay aware and not take water safety lightly, because any activity on water can turn deadly if the proper precautions are not taken," he said.

Traders lament poor sales at former shopping haven

NILAI: The Nilai 3 Business Centre, once considered a shopping haven for wedding items, home decor and textiles, is now facing significant economic challenges as the largest commercial hub in Negeri Sembilan appears to be losing its vibrancy.

be losing its vibrancy. Located about 30km from Seremban and 45km from Kuala Lumpur, the centre was once a popular destination for both local visitors and foreign tourists, attracted by its reasonably priced goods.

However, a recent check found that business activity in the area has sharply declined after decades of being in operation. While many shops remain open, the area appears deserted, with few visitors.

Hassan Khan, 32, a carpet and home decor trader, said the number of visitors to Nilai 3 has dropped by nearly 60%, especially on weekdays, with most traders now relying on weekends or holiday periods when customer traffic is higher.

"Before Covid-19, we were making over RM15,000 in profit a month, but now it's difficult to even earn RM5,000. I've been working here for the past seven years, and the business in Nilai 3 is no longer as lively as it used to be. Something needs to be done to breathe new life into this area," he said. "Customers come in droves to look but rarely

"Customers come in droves to look but rarely buy. Our prices are mostly still the same as before, and if there is any difference, it's only about RM2 to RM3. We can't raise prices just like that, or else people won't buy," he said.

about NM2 to NM3. We can't have prices just like that, or else people won't buy," he said. Hassan added that the area used to be vibrant with various events, such as karaoke competitions or weekend "happy hour" sales, but such activities have now disappeared due to a lack of public interest.

Ghani Rahman, 24, a worker at a carpet shop, said the decline in customers might be due to increased competition from online sales.

increased competition from online sales. He said many vendors now sell through online platforms such as TikTok and Shopee, offering prices that are cheaper than those in the physical market.

"They can afford to sell at lower prices because they don't have shops, don't pay rent and don't need to employ as many staff. That's why they can offer cheaper prices on TikTok or Shopee. We here in the shops have to compete with those prices," he said. – Bernama

Sixth storm to batter Philippines in a month

MANILA: Super Typhoon Man-yi uprooted

MANILA: Super Typhoon Man-yi uprooted trees, brought down power lines and smashed filmsy houses to pieces as it swept across the storm-weary Philippines yesterday, following an unusual streak of violent weather. Man-yi was still packing maximum sustained winds of 185kph and gusts of up to 230kph, after making landfall on lightly populated Catanduanes island late on Saturday Saturday.

More than 1.2 million people fled their homes ahead of *Man-yi* as the national weather service warned of a "life-threatening" impact from the storm.

No deaths have been reported, but there was "extensive" damage to structures on Catanduanes, civil defence chief Ariel Nepomuceno said.

Man-yi is expected to remain a super typhoon as it hits Luzon – the country's most populous island and economic engine – forecasters said, warning of a "potentially dangerous" situation in Aurora province.

Severe flooding and landslides were expected as *Man-yi* dumped "intense to torrential" rain over provinces in its path, with

more than 200mm forecast in the next 24 hours, the weather service said. Panganiban municipality in the northeast

of Catanduanes took a direct hit from *Man-yi*. Photos and a drone video shared on the Facebook page of Mayor Cesar Robles showed fallen power lines, damaged and destroyed buildings, and trees and corrugated iron sheets strewn on the roads.

"Pepito was so strong, I have never experienced a typhoon this strong," Robles said in a post, using the local name for *Man-yi*, as clean-up efforts got under way and people returned home.

"It is still a bit unsafe, there are still bursts of wind and there are many debris."

Mother-of-three Marissa Cueva Alejandro, 36, who grew up in Catanduanes and sheltered with a relative during Man-yi, said typhoons were getting stronger.

"Before, we would only experience (typhoon) signal number three to four, but now typhoons are getting as strong as signal number five," she said, referring to the weather service's five-tiered wind warning system.

Man-yi is the sixth storm in the past month to batter the archipelago nation. At least 163 people died in the previous storms, that also left thousands homeless and wiped out crops and livestock.

About 20 big storms and typhoons hit the Southeast Asian nation or its surrounding

waters each year, killing scores of people. The weather forecaster has hoisted its second-highest typhoon signal over several provinces stretching from Luzon's east coast, where *Man-yi* is expected to make its second landfall, across to the western side of the island where it will exit.

Around 2,000 people were in emergency vacuation shelters in Dipaculao municipality in Aurora province.

Others have stayed home to protect their property and livestock, or because they were sceptical of the warnings, said Geofry Parrocha, communications officer Dipaculao disaster agency. Tourists emptied out of coastal resorts

ahead of the typhoon. "Our facilities are deserted," said Irene

Padeo, reservation officer of the L'Sirene Boutique Resort in Baler town in Aurora, shortly before *Man-yi* was due to make landfall in neighbouring San Luis.

'Our outdoor items have all been packed and taken indoors. We tied down all the rest." Man-yi will cross north of Manila and

Xi ready for 'smooth transition' to Trump

LIMA: Chinese President Xi Jinping said on Saturday he was ready to work with Donald Trump's new administration for a "smooth transition" in bilateral ties, as he met outgoing President Joe Biden for the last time.

The leaders of the world's two largest economies met on the sidelines of an Asia-Pacific summit in Lima.

After shaking hands to begin their meeting at the Chinese leader's hotel in the Peruvian capital, Xi noted that Beijing's goals for stable ties with Washington remained unchanged.

"China is ready to work with the new US administration to maintain communication, expand cooperation and manage differences, so as to strive for a smooth transition of the China-US relationship," he said in translated comments

Xi and Biden have led efforts to ease tensions over issues from trade to Taiwan, and Saturday's face-to-face was their second meeting since a landmark ice-breaking summit in California last year - their third overall.

In California last year - their third overall. Biden said he was "very proud of the progress we both made together". "Our two countries cannot let any of this competition veer into conflict. That's our responsibility and over the last four years I think we've proven it's possible to have this relationship," Biden said.

Trump's impending return to the Oval Office, with several China hawks in his top team, has stirred fears that tensions could return. In his first White House term, Trump

engaged in a bruising trade war with China, imposing tariffs on imports that saw retaliation

from Beijing. Trump has once again signalled a confrontational approach, threatening during the campaign against Democrat Kamala Harris to impose tariffs of up to 60% on imports of Chinese goods.

But in pointed comments, Xi said that China and the United States should "inject more certainty and positive energy into the turbulent world".

The White House said Biden had raised Biden expressed "deep concern" over Beijing's support of Russia's defence industry as Moscow invades Ukraine, and condemned the deployment of thousands of troops to Russia by

China's ally North Korea, the White House said. But it was the transfer of power in Washington that hung heaviest over the meeting, with Biden and Xi both seeking to

calm potentially choppy waters. US National Security Adviser Jake Sullivan told reporters Biden had reinforced that it was a "time of transition" where "stability in the US-China relationship is essential"

Sullivan said however that Biden was "not a conduit" for any backchannel messages from Xi to Trump about the shape of future relations.

Sullivan said the president had also taken time for some informal chat with Xi. - AFP

UIMA: Lin Hsin-i, Taiwan's representative at the Asia-Pacific Economic Cooperation forum here, said on Saturday that he greeted China's President Xi Jinping with a wave, but there was no handshake or conversation. Speaking at a press conference, Lin, chairman of government-backed investment fund Taiwania Capital and a former economy minister, said that while Taiwan had bilateral talks with many Apec members, with Xi there was just a greeting gesture across the room where leaders were gathered. Taiwan takes part in Apec as "Chinese Taipei" and does not send its president to summits due to China's objections. – Reuters

JAPANESE TROOPS TO TRAIN **REGULARLY IN DARWIN**

SYDNEY: Japanese troops will begin regular deployments in northern Australia as part of deployments in northern Australia as part of military cooperation with Australia as part of Marles said yesterday. Around 2,000 US Marines are already hosted in Darwin, the capital of the Northern Territory, for six months of the year amid growing concern among Washington and its allies about China's growing military power in the Indo Pacific region. "Today we are announcing that there will be regular deployments of Japan's amphibious Rapid Deployment Brigade to Australia," Marles said at a televised press conference in Darwin, alongside US Defence Secretary Lloyd Austin and Japanese Defence Minister Gen Nakatani. – Reuters

S'pore offers to host 2030 Apec summit

SINGAPORE: The city-state has offered to host the Asia-Pacific Economic Cooperation (Apec) summit in 2030, The Straits Times reported.

Prime Minister Lawrence Wong said this is one way the country will contribute to ensuring more inclusive growth, against a backdrop of increasing geopolitical rivalry and weakening support for free trade.

Wong, who is also the finance minister, told reporters at the end of this year's summit in Peru that Singapore views Apec as a valuable platform and will do its part to support the

grouping, including hosting Apec summits. Singapore is one of the 12 founding member economies of Apec, which was established in 1989. It last held the Apec chairmanship in 2009. Wong highlighted concerns at this year's

summit regarding the weakening support for globalisation and free trade.

The prime minister said many people in Apec economies feel the benefits of free trade have not been equally shared. Meanwhile, geopolitics is resulting in more

things being seen through a security lens, rather than that of win-win cooperation. He welcomed the fact that, instead of

introducing more barriers, Apec members agree that the solution is to strengthen trade and investment links, ensuring that economic growth benefits everyone and becomes more inclusive

The Apec leaders in a joint statement at this year's summit, reaffirmed their support for the rules-based multilateral trading system, with the World Trade Organisation (WTO) at its core, and remain committed to working towards necessary WTO reform, to improve all of its functions.

Regarding US-China relations, Wong said he hopes China will be able to establish similar "guardrails" with the new Trump administration to reduce conflict between the two.

He noted that both countries have a mutual understanding not to escalate thorny issues such as those concerning Taiwan and the South China Sea.

"To the extent that Singapore can help, we will certainly do our part to facilitate," he was

quoted as saying. From Peru, Wong will be attending the Group of 20 summit in Rio de Janeiro, Brazil. Bernama



Eight killed in stabbing rampage at college

Second mass attack in China in a week

BEIIING: A former student went on a BEIJING: A former student went on a stabbing rampage at a vocational college in eastern China, killing eight people and injuring 17, police said yesterday, just days after the deadliest mass killing in the country in a decade shocked Chinese coexist. society.

Saturday evening's knife attack took place at the Wuxi Vocational College of Arts and Technology in Yixing, part of Wuxi city in the eastern province of Jiangsu. The suspect was apprehended at the scene and confessed. police said.

Also on Saturday, authorities in the southern Chinese city of Zhuhai said they

had charged a 62-year-old man after a driver last Monday rammed his car into a crowd killing 35 people and injuring 43. The Zhuhai incident touched off a rare

online discussion over the mental health of Chinese society and whether a string of recent high-profile attacks in other major cities could reflect deeper stresses as the world's second-largest economy slows.

At least six other high-profile knife attacks have been recorded this year across China. Police in Wuxi said the stabbing suspect was angry over not getting his graduation certificate and failing an exam. The Zhuhai suspect was reportedly angry at the terms of

a divorce settlement. "According to preliminary investigations, the suspect, surname Xu – male, 21 years old, a 2024 graduate of the college – attacked others after failing an exam and not receiving his graduation certificate, as well as being dissatisfied with his internship compensation," the Yixing Public Security Bureau said in a statement. The flare-up of violence has prompted a

heavily censored online discussion on the toll of the economic slowdown and whether young people will find themselves worse off than the generations before them that than the generations before them that benefited from China's rapid development.

One online commentator said the Wuxi attack appeared to reflect a sense of entitlement for a generation that had not expected hardship, a "giant baby mentality". "Always thinking that they are so aggrieved, everyone is persecuting me, I

study and struggle just to be a beast of burden," one person wrote on social media platform Weibo.

"I want to 'lie flat', I want to rot, but still want to have this and that. I want to have what others have," the post said. - Reuters

India joins elite hypersonic missile group

NEW DELHI: India has successfully tested a developed domestically long-range domestically developed iong-range hypersonic missile, it said yesterday, attaining a key milestone in military development that puts it in a small group of nations possessing

the advanced technology. The global push for hypersonic weapons figures in the efforts of some countries, such as India, which is striving to develop advanced long-range missiles, along with China, Russia North Korea and the United States.

The Indian missile, developed by the state-run Defence Research and Development Organisation (DRDO) and industry partners, is designed to carry payloads for ranges exceeding 1,500km for the armed forces, the government said in a statement. "The flight data ... confirmed the successful

terminal manoeuvres and impact with high

degree of accuracy," it said. The test-firing took place at Dr APJ Abdul Kalam island off the eastern coast of Odisha state on Saturday, it said.

Video images released by DRDO showed a slender missile blasting into the night sky followed by a surge of flames.

Defence Minister Rajnath Singh called the test a "historic achievement" in a post on X, adding that it placed India among a select group of nations possessing such critical and

advanced technologies. "This is a historic moment and this significant achievement has put our country in the group of select nations having capabilities of such critical and advanced military technologies," he said.

No further details were given about the missile

Hypersonics are the new frontier in missile technology, because they fly lower and are harder to detect than ballistic missiles, can reach targets more quickly, and can be ordered to change target in mid-flight.

The new proposal, which has not been previously reported, would replace the original plan to build a light-rail system connecting the base to the fifth hiking station of the popular Yoshida Trail, which goes to the top, after a local city and other parties voiced concern over its

environmental and cost impact. Yamanashi Prefecture, home of the most popular route used by climbers of the 3,776m volcano, is set to announce the plan soon, a source told Reuters, asking for anonymity because the information is not yet public. Mount Fuji, which straddles Yamanashi and

Shizuoka prefectures, is one of the most popular tourist destinations in Japan, whose numbers have surged in recent years. Pollution from the constant stream of tourist

buses and cars arriving at the fifth station, as well as overcrowding on the trails, have become headaches for authorities seeking to clean up headaches for authorities seeking to clean up the site, which Japanese people hold sacred. Mount Fuji was listed as a Unesco World Heritage site in 2013, further boosting its appeal.

But the distinction came on the condition that Japan reduce overcrowding, environmental harm from visitors, and fix the artificial landscape, such as the large parking lots built to accommodate tourists.

Modi holds talks in Nigeria en route to Rio

ABUJA: India's Prime Minister Narendra Modi met Nigeria's President Bola Tinubu yesterday as the giants of Asia and Africa push for a greater role in world affairs.

Nigeria's capital Abuja was the first stop in a tour that will take the Indian premier on to the G20 summit in Brazil, and to Guyana.

The visit was billed by New Delhi as a meeting of the largest democracy in the world and the

largest in Africa. "May this visit deepen the bilateral relationship between our nations," Modi posted on social media on arrival. Tinubu said that the visit would expand "the

strategic partnership between both countries". Photos posted on Modi's account showed

him arriving late on Saturday at Abuja airport to be welcomed by Nigerian officials and a cheering crowd from the country's 60,000strong Indian community. The visit comes amid a revived push by both

India and Nigeria for permanent representation

on the UN Security Council. The five permanent members of the top UN body – the United States, Russia, China, France and Britain – hold a powerful veto. Supporters of a more "multipolar" world have

pushed for more African, Asian and Latin American countries to be added to the group.

Nigeria's 220-million-strong population is comfortably the largest in Africa, but in diplomatic strength it is rivalled by South Africa. India is the world's most populous nation - its

1.4 billion people representing a sixth of

humanity – and is a nuclear-armed power. It has long sought a permanent UN Security Council seat. – AFP

Israel has escalated its bombing of Lebanon since Sept 23 and has since sent in ground troops, following almost a year of limited, cross-border exchanges of fire started by Hezbollah in support of Hamas in Gaza.

Security services in Israel said two flares landed near Prime

Minister Benjamin Netanyahu's residence in the town of Caesarea, south of Haifa, but he was not home. Hezbollah fired around 80 projectiles at Israel on Saturday.

Israeli forces also shelled the area along the Litani River, which flows

across southern Lebanon, NNA said yesterday.

The agency earlier reported strikes on the southern city of Tyre, including in a neighbourhood near Unesco-listed ancient ruins. Israel's willtore us contraduced it in the hit military on Saturday said it had hit Hezbollah facilities in the Tyre area. In Lebanon's east, the Health

Zelensky wants to end war via diplomacy

KYIV: Ukrainian President Volodymyr Zelensky said on Saturday that Kyiv would like to end the war with Russia next year through "diplomatic means", as both countries prepare for Donald Trump's return to the White House.

The prospect of Trump returning to power in the United States next year has raised questions about the future of the conflict, as the president-elect has been critical of US military aid to Kyiv. Zelensky said the war will end

"sooner" than it otherwise would have done once Trump becomes president. He also spoke a day after Russian President Vladimir Putin held his first phone call with a major Western leader in nearly two years, speaking to German Chancellor Olaf Scholz who initiated the call despite

Kyiv's objections. "For our part, we must do everything we can to ensure that this war ends next year. We have to end it by diplomatic means," Zelensky said in an interview with Ukrainian radio.

There have been no meaningful talks between Russia and Ukraine, but Trump's re-election has plunged the conflict's future into uncertainty, with Trump repeatedly promising to cut a quick deal to end the war. "We have to understand what the

Russians want." Zelensky said

Russian President Vladimir Putin has said he will only accept talks with Ukraine if Kyiv surrenders Ukrainian territory that Moscow occupies.

The Kremlin said he repeated that demand in the phone conversation

with Scholz on Friday. Zelensky has rejected Putin's conditions. – AFP

Brazil's first lady insults Musk

BRASILIA: Brazil's first lady Rosangela "Janja" da Silva on Saturday insulted Elon Musk at an saturaay insulted Elon Musk at an event ahead of the G20 summit in which she advocated tougher regulation of social media. Speaking on a panel about

disinformation, she appeared to be startled by a loud noise. She said: "I think it's Elon Musk. I'm

not afraid of you, you, Elon Musk." A video of the episode quickly spread on X, drawing a response from its outspoken owner.

"They are going to lose the next election," Musk wrote, adding a pair

of laughing emojis. The tyccon and soon-to-be member of US president-elect Donald Trump's administration has a

complicated history with Brazil. The country's supreme court suspended X for 40 days this year as part of a legal tussle over disinformation.

Leftist President Luiz Inacio Lula da Silva welcomed the suspension as legitimate measure. Musk is an ally of far-right former

president Jair Bolsonaro, who has signalled his intent to run again in 2026.

Bolsonaro posted a screen shot of

the first lady making her remark. "We now have another diplomatic problem," he wrote. – ÅFP

The march, she said, embraced a number of other leftist issues too, such as the fight against poverty and a demand to tax the super-rich, because the leaders at the summit "have economic control over nations they believe are subordinate in this globalised world."

One marcher, Giancarlo Pereira, a 43-year-old veterinarian, said the other issues converged with the Palestinian cause "because the big companies fuelling the war are the billionaires of the world". A short distance

along Copacabana Beach, another protest was being staged with activists placing rows of plates with red crosses on them in the sand.

The 733 plates laid out represented the 733 million people in the world the UN says suffered from hunger last year.

The various protests happened as activists, NGOs and civil society bodies took part in the final day of a

pre-summit G20 social event in Rio pre-summit G20 social event in Rio promoted by Brazilian President Luiz Inacio Lula da Silva. At that event, South Africa's foreign minister, Ronald Lamola, called "for accountability for the state of Israel and for the destate of Israel and for the deescalation of the conflict that is continuing in the Middle East". He said: "We stand with the

people of Palestine and we call on all members of society to do the same." South Africa has brought a case

to the International Court of Justice arguing that Israel is carrying out "genocide" in Gaza, an accusation that Israel denies.

that Israel denies. Several nations have added their weight to South Africa's proceedings, including Spain, Bolivia, Colombia, Mexico, Turkey, Chile and Libya. At the G20 Social event, Lula received a list of action points drawn

Trump's victory and economic discontent

HE recent US election results have sparked intense global reflection, with Donald Trump's unexpected victory prompting widespread debates about politics, morality and the economic anxieties underlying American society.

anxieties underlying American society. The world is watching this return with a mixture of surprise, curiosity and concern as Trump reclaims his role in an election where his distinct style and approach to governance triumphed over the Democrats' emphasis on progressive ideals. This outcome signals more than

This outcome signals more than a political win as it indicates a powerful shift in voter priorities and highlights the increasingly complex relationship between political power, public trust and morality.

Trump's campaign, marked by a blend of populist rhetoric and audacious self-assurance, captured a nation growing tired of conventional politics. His victory is particularly noteworthy given the legal challenges he faces, which include numerous charges involving financial misdeeds and alleged improprieties. Yet, he now stands at the helm of the country,

Yet, he now stands at the helm of the country, suggesting that the American electorate may be prioritising immediate, tangible concerns over issues of character and legality.

This dichotomy raises questions about the place of morality in modern politics, especially when economic struggles drive voters to seek decisive leaders over upstanding ones. The proverbial elephant in the room is the US

The proverbial elephant in the room is the US economy, a subject that became the cornerstone of Trump's appeal and an area where the Democrats may have faltered. The American middle class, long viewed as the bedrock of the nation's prosperity, has seen stagnating wages and rising living costs.

Concerns over inflation, healthcare costs, housing and education have intensified, with many families struggling to meet their basic needs. These economic hardships are not new but they have reached a boiling point where the electorate is seeking immediate solutions rather than abstract promises of progress.

Trump's campaign, with its straightforward focus on job creation, tax cuts and economic growth, struck a chord with voters who feel left behind by the current system.

The Democrats appeared more focused on social issues and progressive policies, which, though significant, failed to resonate with voters increasingly anxious about their economic well-being.

This disconnect arguably cost them the election as voters obviously

This disconnect arguably cost them the election as voters obviously prioritised economic stability over idealistic visions of social change. The Democrats' inability to address these bread-and-butter concerns may reflect a broader struggle

within the party to balance progressive values with the immediate needs of a diverse electorate.

For many voters, issues of inclusivity, though important, were secondary to the desire for a more robust economy.

robust economy. Internationally, Trump's re-election hyped as Trump 2.0 brings a renewed sense of unpredictability. Allies are likely reassessing their diplomatic strategies, particularly given Trump's previous stance on issues such as Nato (North Atlantic Treaty Organisation) funding, trade tariffs and foreign policy interventions.

Many European nations, for instance, have expressed unease at his unilateral approach to international relations, fearing that a lack of cooperation could strain alliances that have historically provided stability.

For countries such as China and Russia, however, Trump's win may signal a more predictable relationship as they understand and expect his pragmatic, sometimes isolationist stance. This could shift the balance of power globally, influencing trade agreements, security alliances and international treaties in ways that may reshape the geopolitical landscape.

Domestically, Trump's support has been bolstered by an electorate increasingly disillusioned with traditional politics and desperate for a change that directly impacts their lives. The middle-class experience has been one of economic contraction, with fewer opportunities for advancement and a declining quality of life.

Issues like stagnant wages, expensive healthcare and the high cost of education are immediate and pressing, and voters want politicians who promise real solutions rather than abstract ideals.

Trump, with his promises of lower taxes, job growth and infrastructure improvements, presents a straightforward, though controversial, alternative.

For many Americans, his policies seem to speak to their needs more directly than the

The electorate's willingness to overlook Trump's legal controversies suggests a shift in values, where the demand for immediate action on economic issues overshadows concerns about personal integrity. While some critics argue that this acceptance

While some critics argue that this acceptance undermines the democratic process by lowering standards of accountability, others contend that it reflects a deeper frustration with the political article fiburate address care incurs.

system's failure to address core issues. The growing emphasis on economic relief over character is indicative of an electorate willing to compromise on ethics for the promise of better living conditions.

Trump's victory reveals a transformation within American society and perhaps a wider, global trend: the prioritisation of tangible outcomes over moral expectations.

This election has shown that voters, when faced with economic hardship, may be more inclined to support a flawed leader who addresses their concerns than a morally upright one whose policies feel detached from their struggles. As we move forward, this dynamic raises

As we move forward, this dynamic raises critical questions about the future of democracy and the standards we hold for our leaders. What does it mean to prioritise economic stability over ethical integrity? At what point does the pursuit of economic progress justify overlooking legal and moral considerations?

These questions reflect a changing political landscape where morality is no longer the sole measure of a leader's worth. Trump's triumph, amid legal challenges and ethical doubts, may be a warning sign that democracy itself is evolving, but whether for better or for worse remains to be seen.

The world watches as America grapples with this complex reality, aware that the outcome of this new chapter will resonate far beyond its borders.

A quote from Plato's *The Republic* fits here: "The heaviest penalty for declining to rule is to be ruled by someone inferior to yourself."

This quote emphasizes the risk and consequences of disengagement from political responsibility, suggesting that when individuals or societies rank immediate concerns over moral leadership, they may end up being governed by those less virtuous.

Malaysia's education minister recently declared that the public needs to accept new Malay words because the Malay language is a "living language", one cannot help but wonder if this statement was made with due

consideration for linguistic reality. While no one denies that languages evolve, the approach to such evolution matters significantly, especially when the so-called "new" words already have widely accepted equivalents, or worse, when they border on absurdity. A living language thrives on

organic growth. It adapts to societal needs, borrowing words or coining new ones when there is a genuine linguistic gap. However, introducing words like

katimbang to replace the perfectly functional *daripada* or *peluncuran* instead of *pelancaran*, defies this principle. Such changes do not stem from societal demand or linguistic necessity but from an imposed topdown decree. Linguists like Noam Chomsky

argue that language is shaped by its users, not by arbitrary mandates. In this case, the minister's claim that the public is "beginning to accept" these words feels like an exaggerated claim, given that no evidence suggests any real grassroots acceptance. If anything, these terms are being shoved down the throats of officials

and the public alike, creating confusion and perhaps, resistance. Such words are not being "embraced" because they fill a void; they are being forced into public discourse during official events and government documents. government documents.

Officials, under pressure to adhere to the new terminology, scramble to use these words correctly, often resulting in embarrassing missteps and unnecessary confusion. Take for instance the introduction

of *mahsul* for "harvest" or *intiha* for "ending". The Malay language already has perfectly functional and familiar COMMENT by Prof Mohd Said Bani Che Mat Din

words for these concepts, such as hasil and penamat. Why complicate matters?

matters? Similarly, tatakelola (effective administration) and kebinekaan (diversity) are either redundant or already understood within their original context. Adding layers of unnecessary complexity undermines the accessibility of the language, eliancting the purche it toole to econo alienating the people it seeks to serve. Linguistic experts often emphasise

that language evolution must be driven by usage and practicality. Professor Emeritus Datuk Dr Teo Kok Seong, a respected linguist, has previously pointed out that introducing unfamiliar terms risks alienating speakers and causing them to abandon the language altogether.

If Malaysians already struggle to maintain fluency in Bahasa Malaysia in an increasingly English-dominated global environment, why add to the confusion with terms that feel forced and out of place?

Instead of fostering pride in our national language, this approach risks making Bahasa Malaysia a subject of ridicule. Imagine saying, "Walhasil, tiwikrama kebinekaan negara kita memerlukan tatakelola yang baik' during a speech.

While the statement may be linguistically correct, it is also unnecessarily convoluted, obscuring the intended message. Language is meant to communicate, not to confuse.

The minister's claim also reflects a troubling trend: the use of narratives that are not grounded in reality. Malaysians are not asking for new terms like *purbasangka* (prejudice) when *prasangka* is already understood. Nor are they eager to adopt *taakul* (reasoning) when contemporary rather than communication.

Forcing such terms into public use under the guise of progress is counterproductive. It alienates the

seeks to Malaysians from all walks of life who simply want a language they can understand and use effortlessly. Introducing unnecessary complications only widens the gap between the language and its users.

At its core, my concern is about ensuring Bahasa Malaysia remains relevant, accessible and functional for all Malaysians. The introduction of new words should serve a purpose filling linguistic gaps or adapting to modern realities, not complicating communication.

If the goal is to preserve and elevate Bahasa Malaysia, the focus should be on improving proficiency, encouraging its use in meaningful ways and ensuring that it remains a unifying force in a diverse nation.

Furthermore, language policy should consider the opinions of experts and the people who use the language daily. Linguists globally agree that language evolution should enhance communication, not hinder it

At its best, the minister's statement is right in that, Bahasa Malaysia (and all languages) is a living language but that does not justify unnecessary or forced changes that complicate its use and alienate its speakers.

Instead of celebrating the uniqueness of our national language, imposing such words risk making our language the subject of mockery and frustration.

The education minister must open her eyes to the real challenges faced by Malaysians in embracing faced by Malaysians in embracing Bahasa Malaysia. Do not add to these challenges with linguistic experiments that confuse rather than clarify. The focus should be on strengthening the language's relevance and accessibility, preserving its beauty and functionality, and menuing that all Malaysians not just a ensuring that all Malaysians, not just a select few, can use and appreciate it.

Let our language evolve naturally, driven by the needs of its people, not by artificial impositions. Otherwise, we risk turning this "living language" into a relic of bureaucratic misadventure.

While I may not be a language expert, I am a well-read person and an experienced communicator. In communication, the ultimate rule is to ensure people understand and

embrace your message. Confusing the public with unnecessary changes to language for the sake of novelty or to fulfil a "feel good" agenda serves no one and risks eroding the very foundation of our linguistic heritage.

HEALTHCARE, education and social infrastructure are usually universal benefits that we all automatically keeping a watch over you Many argue that the government has no place determining between the

benefit from However, it is rather strange that in our society there is resistance to the

idea of providing a basic income to all citizens universally.

Targeted benefits are the opposite of this. While it seems perfectly sensible to target very limited resources only to those that need them most, these tend to be unpopular policies.

Rooted in a mindset of scarcity. they sow suspicion, breed one-upmanship and are rife with criticism. Similarly, means-tested cash

Similarly, means-tested cash transfer programmes also tend to be unpopular, leading to envy and a sense of something for nothing. If cash transfers were made into a universal benefit, like a basic income,

this perception may be different. So how would this form of universality work its magic? With universality, we are no longer divided into two camps of

"deserving" and "undeserving". There is no social stigma against recipients, no political tension, no complex and intrusive applications to the government and no inspectors

deserving and the undeserving anyway.

If giving cash to the "rich" does not sit right with you yet, consider the administrative cost savings that come with universality. How many man hours would be saved from trying to discriminate between rich and poor people if we simply included people if everyone?

Instead of suspicion, basic income would efficiently disburse an agreed amount to all, directly to their bank accounts or MyKad, without any middlemen or room for wastage,

leakages and corruption. Targeted benefits can feel debilitating when you are paid for being poor and when that payment is reduced when you progress through hard work to a marginally higher income. Instead of disincentivising progress, basic income does away with all disincentives by being universal.

By boosting social mobility without tinkering with anyone's social status, there is no more one-upmanship everyone gets it. Universality is only one of five

tenets of basic income. It also must be

regular or monthly – paid in cash not tokens - vouchers or food parcels, paid to individuals not heads of households and above all it must be unconditional.

These ideas are quickly gaining ground in Malaysia. Under Budget 2025, the unity government announced a significant boost to the Sumbangan Tunai Rahmah (STR) and Sumbangan Asas Rahmah (Sara) initiatives next year.

Total allocations increased to RM13 billion from RM10 billion and will benefit nine million people or 60% of the adult population.

Financial assistance under the Social Welfare Department (JKM) will rise to RM2.9 billion from RM2.4 billion, enabling higher monthly welfare payments for the underprivileged.

A total of 4.1 million households will receive Sara cash transfers compared with 700,000 recipients this year, with a RM100 monthly benefit

credited directly to their MyKad. The maximum household assistance will increase to RM4,600, compared with RM3,700 previously. Combining all forms of assistance, no one in Malaysia needs to have an income of less than RM1,100 per month

Including STR, Sara and JKM, a poor household with three children is eligible to receive over RM13,000 annually, compared to RM11,000 last year. Senior citizens living in poverty, will be eligible for over RM10,000 in aid annually, compared to RM8,000 last year. This is before accounting for additional aid from state governments, *Zakat* or from foundations.

The progressive reforms of welfare assistance will still need to embed the basic principles of regular payments,

paid in cash to individuals on a universal and unconditional basis, but Malaysia has already begun this journey and has the chance to be a leader in the world, creating magic from a universal basic income.

Malaysia's economy on track for sustainable growth

KUALA LUMPUR: Economists believe Malaysia's economy is on track for sustainable growth for the full year, underpinned by robust investments and improving external demand.

University of Malaya senior lecturer Dr Aidil Rizal Shahrin expects the country's economy to grow by 5-6% in 2024. "This is higher than the forecast of the

global economy growth of 3.2% by World Economic Outlook," he told *SunBiz.* Aidil Rizal noted that the country's gross

domestic product (GDP) growth in the third quarter of 2024 (Q3'24) was slightly lower than that in the first and second quarters, when it was 5.6% and 5.9%, respectively.

wnen it was 5.9% and 5.9%, respectively. "Nevertheless, we might expect the 2024 growth to exceed the earlier forecast of around 4-5% growth," he said. Aidil said that private consumption, amounting to close to 60% of GDP, became the main contributor to growth at 4.8%. Besides consumption. Aidil Bizal poted

Besides consumption, Aidil Rizal noted that investments recorded growth of 15.3%.

"Since the pandemic, where in 2020 we recorded negative growth of 5.5%, our growth has been volatile. We recovered from the pandemic with a growth of 3.3% the following year and jumped to a very high growth of 8.9% in 2022," he said.

'Unfortunately, the global economic slowdown in 2023 weakened external demand and reduced our growth to around 3.6%. In 2023, our exports were 8% lower than in 2022," he said, adding that Malaysia being a small, open economy, external factors play an essential role in supporting economic growth.

"For 2024, we see an improvement already compared to 2023, where our trade surpassed the RM2 trillion threshold in just nine months, the KW2 trillion threshold in just nine months, as reported by Miti (Ministry of Investment, Trade and Industry)," Aidil Rizal said. Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid

said the economy should be able to settle at around 5% growth this year, which he said is decent growth.

"For now, I'm still maintaining my GDP projection of 4.9% for 2024. As for Q4, my sense is that the quarter could grow around 4.5% to 5%, taking cues from the moderation in consumer spending while investment and

the external sector will continue to provide

support to the economy," he said. Mohd Afzanizam said that at a rate of 5.3% during the September quarter, this out-turn was very much in line with the advance estimates. "The growth trajectory was decent as it continues to hover above 5%, albeit at a slower pace compared to the previous quarter."

He noted a deceleration in consumer spending from 6% growth in Q2 to 4.8% in Q3, while net exports contracted by 8.8% after a 3.4% expansion in the preceding quarter. "Despite that, overall growth was largely underpinned by investment activities among the private and public sectors, which saw their growth at a double-digit pace," he said. Mohd Afzanizam said this and growth in

public consumption indicate that consumers may have become guarded in their spending, despite the labour market remaining in full employment status.

Nonetheless, he said investment has really picked up pace and will continue to fuel the country's growth. Center for Market Education CEO Dr

Carmelo Ferlito told SunBiz that Malaysia is on track to achieve 5% annual growth by the end of the year. In relative terms, he said, growth will be

pulled by investments, which he said are

"Currently enjoying "very good momentum". "Q3 growth is slightly below expectations, and this is due to a gradual slowing down of growth if we look at the data month by month," he said.

Ferlito highlighted Malaysia's improved investment performance, noting that inflows had been sluggish for several years but are now had been suggish for several years but are now experiencing positive momentum in gross fixed capital formation (private and public investments). "These are good premises for long-term sustainable growth grounded on investments rather than consumption." Kenanga Investment Bank Bhd economist Muchammed Saifuddin Sanuan commonted

Muhammad Saifuddin Sapuan commented that Q'24 GDP growth met their projection and aligned with their expectation of moderate growth following a peak in Q2'24.

"This is partly because domestic demand has signalled a moderate expansion as the

economy returns to normalcy." Muhammad Saifuddin said his firm maintains a 2024 GDP growth forecast at 5% and expects it to moderate to 4.8% in 2025. "We anticipate a recovery in manu-

facturing, particularly the export-oriented sector, to continue supporting our growth outlook," he added.

AirAsia X's maiden flight to Nairobi achieves 90% passenger load factor

NAIROBI: Long-haul low-cost carrier AirAsia X Bhd (AAX) made its inaugural direct flight from Kuala Lumpur to Nairobi, Kenya on Friday with a passenger load factor of nearly 90%, marking its forav into East Africa.

toray into East Africa. Chief executive officer Benyamin Ismail said AAX's four-day weekly Kuala Lumpur-Nairobi service is currently the only direct flight connecting Malaysia and Africa.

He stated that 90% load factor equated to about 278 passengers on board. The return flight from Nairobi to Kuala Lumpur

experienced a passenger load of around 75%.

"The profile of the passenger load of around 75%. Lumpur to Nairobi saw Australians, Chinese, Malaysians and Kenyans who came back home. While for the 75% of passengers flying to Kuala Lumpur, up to 90% were Kenyans," he told a press conference here on Saturday. Benyamin said if the load factor is maintained

at around 85% per trip, he is confident that the target of carrying more than 156,000 travellers annually on this route can be achieved, or even exceeded.

On the acquisition of AAX's sister company Capital A Bhd's airline businesses, Capital A co founder and executive chairman Datuk Kamarudin Meranun said barring any unforeseen circumstances, the exercise is on track to be completed either by the end of this month or early December, as scheduled.

He said the company has gone through all the necessary processes, and it is now awaiting the court's approval of the proposed distribution to shareholders via capital reduction.

In October, 99.08% of AAX shareholders voted in favour of the proposed acquisition of Capital A's entire equity interest in the aviation business within AirAsia Aviation Group Ltd and AirAsia Bhd for RM6.8 billion.

Following the acquisition, Kamarudin said, the company will continue to explore and expand into more destinations moving forward, especially the underserved destinations. "We are

especially the underserved destinations. We are always on the lookout." Meanwhile, in his speech earlier, AAX chairman Datuk Fam Lee Ee said AAX operates flights to more than 20 destinations from Malaysia

"This new direct flight is more than just a connection between two cities, as it represents the strengthening of bilateral relations between Malaysia and Kenya, and we also see immense potential for mutually beneficial business collaborations for travellers in both nations. – Bernama

MSC reports RM14.3m net profit for Q3, proposes 17 sen special dividend

PETALING JAYA: Tin miner and metal producer Malaysia Smelting Corporation Bhd's (MSC) net profit for the third quarter ended Sept 30, 2024 (Q3'24) increased 20.88% to RM14.29 million from RM11.82 million in Q3'23.

Revenue for the quarter under review increased 29.14% to RM470.05 million from RM364.02 million in Q3'23. The growth was driven by higher average tin

prices of RM141,500 per tonne and increased sales of refined tin.

In line with favourable tin prices, the group's tin mining segment recorded a 26.1% year-on-year (y-o-y) increase in net profit to RN/22.5 million during the quarter from RN17.9 million a year ago. Meanwhile, the tin smelting arm was affected

by foreign exchange losses resulting from the

ringgit's appreciation against the US dollar between August and September 2024, compounded by lower smelting performance. This resulted in a net loss of RM10.3 million during the quarter, against a net loss of RM2.7 million in Q3'23.

For the nine months of FY24 (9M/24), MSC's revenue grew by 20.6% y-o-y to RM1.24 billion, from RM1.03 billion in 9M/23, fuelled by more favourable tin prices of RM140,100 per tonne and higher sales volume of refined tin. The tin mining segment posted a higher net profit of RM61.7 million on the back of higher tin

, prices Nonetheless, the tin smelting division

recorded a net profit of RM4.3 million, impacted by various factors, including lower incoming feed for smelting, reduced sales of refined tin

from processed tin intermediates, and foreign from processed in intermediates, and foreign exchange losses. As a result, the group's net profit contracted to RM49.2 million in 9M'24, against RM75.7 million in the prior year. MSC group CEO Datuk Dr Patrick Yong said that despite the challenges posed by the global composite only on the global sector of the global

economic environment, the company remains steadfast in building a more resilient business through operational improvements and strategic investments in mining and smelting businesses.


"For our tin smelting division, we are working to address these challenges and are confident in our long-term strategy. Moreover, the recent conclusion of the US 2024 presidential election and the strengthening of the US dollar against the ringgit provide a more stable backdrop for

our operations."

For the tin smelting business, Yong said, the group is on track to phase out the old smelting plant at Butterworth, Penang, which is on track for full closure by 2025.

"We expect to benefit from an approximate 30% in cost savings from the planned closure and from the efficient Top Submerged Lance furnace technology in the Pulau Indah smelting facility, which will lower operational and manpower costs and reduce our overall carbon footprint. For Q3'24, the MSC board has proposed a

second interim single-tier special dividend of 17 sen per share for a total dividend payout of RM71.4 million. This follows the first interim single-tier dividend of 7 sen per share declared on Sept 25, which amounts to RM29.4 million

Challenges in defending capital gains

HIGH profile case that was reported in the media in September which involved the Inland Revenue Board (IRB) and the disposal MATTER by DRB-Hicom Bhd of a

long-term investment in subsidiary Alam Flora Sdn Bhd, which was held for 24 years, is a very good example of the current climate where such sales are being challenged and brought

being challenged and brought to tax under income tax. A long holding period is becoming less significant in the eyes of the IRB.

The difference here is if the gain from such a sale was brought to tax under income tax, then the taxpayer has to pay 24% compared to capital gains tax (2% of sale proceeds or 10% on gains) or real property gains tax (RPGT, 0% to 30% on gains for individuals, 10% to 30% on gains for

companies).

Lately, there has been a noticeable increase in challenges by IRB on transactions the

involving real property where taxpayers have declared and paid their RPGT. Now they are facing additional income tax and penalties ranging up to 45%

Where is the challenge

coming from? The IRB is relying on the badges of trade to challenge taxpayers to bring such income as business income. The original six badges of trade are: the motive or the intention at the time of the purchase of the property, existence of similar trading transactions or interests, frequency of transactions, period of ownership, circumstances responsible for the realisation of the property, and the nature of the asset. Other badges of

trade include the way the sale was carried out, improvements to the asset, and method of financing. Taxpayers must be very clear they

can defend their position so that none of the above badges of trade will negatively impact them. The facts must be supportable with evidence. For example, circumstances responsible for the disposal of the asset can go either way. If the taxpayer if able to show that the sale occurred within a short period of time, but it was an unanticipated time, but it was an unanticipated offer which was too good to refuse or unsolicited, or a sale was made because there was an urgent need for cash within the group, the case for supporting the capital gains argument is strengthened. What is worrying now is that the UBB is frequently connecting

IRB is frequently connecting peripheral facts to support its challenge. Examples of such issues are where an individual has any

history of dealing in or developing properties. The IRB is of the view that disposals by such individuals will always be subject to income tax. There are sufficient case laws such as the Lim Foo Yong case which clearly stated that it is possible for individuals or companies to have both investments and trading assets.

Another argument put forward by the IRB is that a company's constitution allows both trading and investment holding. This condition is found in most companies' cons-titutions, and that should not be the basis for challenging such transactions.

Another common challenge is the location of the property. If a property is located in a prime area, the IRB seems to think the property is highly valuable and saleable and therefore becomes stock-in-trade. If such a notion exists, then all properties in this country located in prime areas will be all stock-in-trade. That should not be the basis for determining whether it is stock or investment.

The other common challenge is that if companies acquire properties through loan financing, then the chances of the asset being classified as stock-in-trade increase. The classification in the accounts is extremely important as it reflects the intention of the owners, thus it is important to look at the board minutes.

Any changes or modifications made to the asset to make it more marketable, and the method of the sale (e.g. using agents to solicit offers) will affect the case.

Selangor expects RM2.35b revenue next year

KUALA LUMPUR: Selangor is aiming to achieve revenue of RM2.35 billion next year. an increase of RM150 million compared to this ear's estimate, said Selangor Menteri Besa Datuk Seri Amirudin Shari.

He said revenue collection this year has reached RM2.43 billion as of November, surpassing the estimate of RM2.2 billion for

"For this year, we estimated RM2.2 billion. However, as of November 2024, we have already recorded RM2.4 billion," Amirudin told reporters at the Selangor International Business Summit 2024 Appreciation Dinner on Fridav.

He said the growth in 2025 will be driven by the state's newly introduced Zero Discharge Policies and Polluters Pay Principle.

"These initiatives are expected to contribute between RM72 million and RM80 million to the state's income."

When presenting the state budget earlier, Amirudin emphasised the importance of everyone in the Selangor government, businesses and society in understanding the potential, capacity and risks of artificial intelligence (AI).

"Rather than viewing artificial intelligence as a looming threat, we should approach it as a powerful force that we must harness. By doing so, we can ensure that Al's benefits work in humanity's favour, enhancing the quality of

life for every Selangorean," he said. "As industry practitioners, finding a way where workers are at the heart of your development philosophy is paramount.

"I am of suggesting that profits are unimportant; indeed, they are the cornerstone of the capitalist economy in which we live. However, we must be cautious not to fall into the pitfalls identified by economist Daron Acemoglu in his book Why Nations Fail, co-authored with James A Robinson, where he outlines the critical factors that lead to the failure of nations," he said.

Amirudin assured that the Selangor government is ready to work hand-in-hand to reap the benefits of new technology, increase

the productivity of each worker, and increase the government's efficiency through AI. "That was the guiding philosophy of why I launched the Speed Selangor Policy, which will kick off next year, to reduce the processing and wait times businesses currently face when

dealing with aspects like the planning permission or acquiring your business licence after receiving approval of your certificate for completion and compliance (CCC) " he said

Selangor aims for local authorities to provide business licences within 24 hours of ticking all the CCC boxes beginning next year.

Amirudin said Selangor also has ambitious targets in the field of semiconductors With a sizeable investment for 2025, it aims

to attract more companies from China and Taiwan to call Selangor their new home, especially in the design phase of integrated circuits.

"These two are just some of the areas we are looking to expand and should be given requisite focus in next year's Selangor International Business Summit (SIBS)."

One of the big components that will be fundamental to SIBS 2025 is Visit Selangor Year, which coincides with Malaysia's chairmanship of Asean.

'Now is the time to leverage our networks and strengthen existing relationships. If there is a company you have interacted with in the past but hesitated to invest in Selangor, reach out to them.

"Initiate a conversation, arrange a meeting, and identify a location that would be ideal for their operations.

"Remind them of our Soft Landing Incentive, which allows them to bring their team and take full advantage of the co-working spaces available," Amirudin said,

Looking ahead, he said SIBS's next focus will be on promoting high-growth sectors, embracing technological innovation, and cultivating a highly skilled international workforce capable of meeting the evolving demands of global industries.

SIBS 2025 will return to the all-in-one format and will be held in a single week, from Oct 8 to 11, at the Kuala Lumpur Convention Centre.

Labuan receives RM32.9m for seven development projects

It said it would aim to meet a return-on-equity target of around 9% this fiscal year, earlier than expected. Mizuho Financial Group, the No. 3

player, said its second quarter net income rose more than 60% and raised its full-year earnings forecast to a record \$820 billion.

Underscoring the bumper results, Mizuho announced a share buyback of up to \$100 billion – its first in 16 years – while lifting its previous dividend estimate by \$15 to \$130 for the year.

We have entered a new stage of growth investment and strengthening shareholder returns," CEO Masahiro Kihara told a media briefing. Japan's central bank raised its

policy rate to 0.25% in July after ending negative interest rates in March, pushing Mizuho's loan and deposit rate margin for its domestic lending business up for the second consecutive quarter.

Foxconn expects 2025 to be 'vear of Al'

TAIPEI: Taiwanese tech giant Foxconn reported a forecast-topping net profit for the third quarter on robust demand for artificial intelligence servers and said it expected 2025 to be the "year of Al". The firm, also known by its

official name Hon Hai Precision Industry, is the world's largest contract electronics manufacturer and assembles devices for major tech companies, including Apple's iPhones

It has been moving to diversify beyond electronics assembly, pushing into areas ranging from electric vehicles to semiconductors and servers.

Foxconn said net profit for the three months to September hit NT\$49.3 billion (RM6.7 billion), up 14% from a year ago and beating the NT\$45.9 billion expected by analysts surveyed by Bloomberg. Revenues for the period rose

20% on-year to NT\$1.9 trillion. The figures represent the fifth consecutive quarter of profit growth for the firm as it rides a wave of demand for generative AI – following the runaway popularity

of products such as ChatGPT since of products such as ChatGPT since it launched two years ago. Chairman Young Liu said Foxconn's revenue from Al servers more than doubled in the first three quarters of this year from the same period last year.

Servers now accounted for more than 40% of total revenue, Liu said during an earnings call with analysts.

"Regarding the full-year outlook, we maintain our previous forecast for substantial growth, with visibility further improved compared to August."

But Liu warned "heightened uncertainty in the economic environment and geopolitical factors" could hurt consumer smart products demand in the fourth quarter.

Foxconn has invested significantly to be part of the AI market.

In documents released ahead of the earnings call, the company said it expected "rapid growth" in its Al server business in 2025.

Al servers were expected to exceed 50% of total server revenue next year and become a "primary growth driver for the company", Liu said.

Liu said that "2025 will be the year of Al", adding Foxconn was set to "enter another growth phase". "We won't just be an AI supplier

but also an Al user. "With significant advancements in Al computing power, we are constructing supercomputing centres, positioning ourselves as a major manufacturer with Al supercomputing capabilities." – AFP

Crisis-era regulation has 'gone too far': Reeves

LONDON: Chancellor of the Exchequer Rachel Reeves promised a reboot of regulation governing Britain's "crown jewel" financial industry, which she said has shackled the City's prospects since the global financial crisis and stifled British economic growth.

In a speech at the City of London's ornate Mansion House last week, Reeves vowed not to take Britain's status as a global financial centre for granted and

pledged a raft of growth-focused reforms. Her speech came as leaders across the industry brace for a possible bonfire of regulation on Wall Street during President-elect Donald Trump's second term in office, with leaner taxes and lighter rules on capital likely to widen an earnings gap between US banks and their global competitors.

"While it was right that successive governments made regulatory changes after the global financial crisis, to ensure after the global infancial crisis, to ensure that regulation kept pace with the global economy of the time, it's important we learn the lessons of the past," Reeves said. "These changes have resulted in a system which sought to eliminate risk taking. That has gone too far and, in places, it has hed, wintended, concentrations

it has had unintended consequences which we must now address."

The former Bank of England economist proposed five areas to maximise growth in British financial services – capital markets, fintech, sustainable finance, asset management and wholesale services, and insurance and reinsurance. Reeves said the government would

publish a financial services strategy early next year as part of a broader 10-year

industrial plan. "The UK has been regulating for risk, "The UK has been regulating for risk, but not regulating for growth," the chancellor said, announcing that she had written to the Bank of England and Britain's Financial Conduct Authority to instruct them to put greater effort towards supporting government growth goals as well as financial stability. Reeves and Prime Minister Keir Starmer promised voters in July's election

Starmer promised voters in July selection that they would turn Britain into the fastest-growing Group of Seven economy after years of sluggishness. Her latest proposals were broadly

Her latest proposals were broadly backed by financiers. "It's crucial the UK's regulatory framework is effective and well-calibrated. We therefore welcome the chancellor's recognition of the need for a more balanced approach to risk," said Patrick Thomson, EMEA CEO of J.P. Morgan Asset Management and chairman of Britain's Investment Association trade body. - Agencies

Novo Nordisk phasing out human insulin pens

LONDON: Novo Nordisk is gradually ending production of human insulin pens, the drugmaker told Reuters, as it spends billions to ramp up manufacturing of its popular obesity and diabetes injections.

It declined to comment on the timeline. "Globally (human insulin pens) will be

phased out over time and human insulin will be available only in vials," a spokesman said.

In wealthy nations like the US, the majority of people with diabetes now use modern or analogue insulin, not human insulin, because the former enables better blood sugar control. In low and middle income countries, human insulin is more commonly used than analogue

insulin, which is more expensive and harder to make. Booming sales of the Danish drugmaker's

new obesity and diabetes medicines, delivered in injection pens, have propelled it to become Europe's most valuable company by market value, at about US\$572 billion.

Novo Nordisk said in a statement to Reuters that the pens it uses for human insulin are not the same as those for its GLP-1 agonists Wegovy – a weight-loss treatment – and Ozempic, a diabetes drug.

But the delivery devices are similar, and the company said last year it was shifting away from its century-long focus on making insulin to treat diabetes to making weight-loss drugs to combat obesity as a precursor to type 2 diabetes. Medical charity Medicins Sans Frontieres

and advocacy group T1 International criticise Novo Nordisk's focus on manufacturing pens for its new medicines – which are not yet available in poorer nations.

The groups see an emerging double standard in diabetes care – people with diabetes in high-income countries will not suffer from the halting of insulin pen production, because the company is continuing to make analogue insulin pens for those markets.

Pens are easier and more precise to use than syringes for injecting insulin. - Reuters

Burberry launches turnaround plan after posting loss

LONDON: Troubled British fashion house Burberry last week announced cost-cutting plans after posting a loss, with the global luxury sector pressured by weak Chinese demand.

Burberry reported a net loss of £74 million (RM420 million) in the six months to the end of September, down from profit after tax of £158 million in the same period last year. Revenue slid 22% to £1.09 billion, the group

famed for its trench coats and trademark red, camel and black check design said in a statement.

"Today, we are acting with urgency to ... stabilise the business and position Burberry for a return to sustainable, profitable growth," said recently-appointed chief executive Joshua Schulman.

Schulman said Burberry would refocus on outerwear, in-store productivity and reignite a "high-performance culture".

It came following reports that Italian fashion brand Moncler had shown interest in

buying the 168-year-old label. Burberry on Thursday added that it had halted dividend payments as it looks to save about £40 million. "Over the past several years, we moved too

far from our core with disappointing results, the group said.

Schulman was appointed CEO in July, replacing Jonathan Akeroyd.

In September, Burberry exited London's top-tier FTSE 100 stocks index after 15 years, with analysts citing strategic mistakes and weak demand from China.

"The company has a long way to go and is not through its annus horribillis yet," said Kathleen Brooks, research director at trading group XTB. She added that the brand needs to "focus

on new markets due to the continued slump in demand for luxury goods in China".

The Asia Pacific region saw Burberry's largest slump in sales, with mainland China store turnover sliding 24% in the first half of the year. – AFP

Russia cuts gas supplies to Austria

MOSCOW: Russia halted gas supplies to Austria on Saturday in a dispute over payments but was still pumping steady volumes to Europe via Ukraine after remaining buyers asked for more gas. Russia, which before the Ukraine war was

the biggest single supplier of natural gas to Europe, has lost almost all of its European customers as the EU tries to reduce its dependence and after the Nord Stream pipeline to Germany was blown up in 2022.

Now one of the last main Russian gas routes to Europe – the Soviet-era Urengoy-Pomary-Uzhgorod pipeline via Ukraine – is due to shut at the end of this year, as Kyiv does not want to extend a five-year transit agreement which brings northern Siberian gas to Slovakia, the

Czech Republic and Austria. Austria said on Friday that Moscow had Austria said on Friday that Moscow had informed it that the gas would be shut off following an arbitration award to OMV, Austria's biggest energy supplier, over unfulfilled supplies to its German unit by Russia's state firm Gazprom. On Saturday, Austria's energy regulator E-Control said Gazprom's deliveries to OMV had stopped, adding that prices and supplies to Austria support ware stack.

to Austrian customers were steady. OMV is seeking to recover the €230 million

(RM1.08 billion) damages, awarded during arbitration, from Gazprom by offsetting the claim against invoices for deliveries to Austria – essentially stopping some payments for gas supplied via Ukraine.

Cash-strapped US farmers switch to generic chemicals

Analysts say downgrading could hit bottom lines of big agrichemical companies

NEW YORK: US farmers struggling with slumping incomes and depressed grain prices have been switching to cheaper generic pesticides and fungicides as they plan for spring planting next year, which market analysts said could hit the bottom lines of creichemical commanies like Bayer agrichemical companies like Bayer.

Signs of these financial impacts are already emerging. Bayer shares fell sharply to a 20-year low

last week, after the chemical company warned that weak global agricultural markets and a slumping US farm economy are likely to pressure profits further.

Agrichemical competitors Syngenta, Corteva and the agriculture unit of Germany's BASF could also face challenges in the sector, analysts said.

Nearly one-third of all the pesticides and fungicides that Paul Butler uses on his Illinois soybean and corn farm are generic to help him cut costs in a tight year, he said. "It's like if you grew up eating Fruity Pebbles and now you go to Dollar General and get Fruity Bites," he said. Despite the cost savings, farmers say there

can be drawbacks to downgrading. Manufacturers of generic chemicals typically do not cover the cost of respraying if

the product does not work, said Caleb Hamer, an Iowa corn and soy farmer. Still, distributors and grain elevators say

they have seen customers cutting back their spring pesticide and herbicide budgets. Some farmers are shifting away from

branded products, said Matt Carstens, chief executive of farm cooperative Landus and agricultural financing company Conduit. Others are investing in equipment that

targets and treats weeds and pests in their fields - allowing them to buy less herbicides

and pesticides altogether, he said. "It comes down to this: What does the farmer really need? Do they need a name brand, with protection insurance and complaint policies backing it? Do they need to pay for all of that?" Carstens said.

Argentina's monthly inflation falls to three-year low

BUENOS AIRES: Argentina's monthly inflation rate fell to 2.7% in October, its lowest level in three years, the national statistics agency said, a development welcomed by cost-cutting President Javier Milei.

Annual inflation, however, remains among the highest in the world, at 193% in October, figures from the Indec statistics agency showed.

The government of self-described

"anarcho-capitalist" Milei has applied a drastic austerity programme aimed at erasing the budget deficit and taming the high inflation that has plagued Argentina for years. In December, when he took office,

'Deadpool හ Wolverine' helps **Disney beat** earnings forecasts

LOS ANGELES: Walt Disney reported earnings that topped Wall Street's estimates last week propelled by blockbuster ticket sales from the rude and irreverent summer Marvel film *Deadpool & Wolverine*, and provided an upbeat forecast for the coming year. The firm projected adjusted earnings-per-share

rcentage growth in the high single digits in fiscal 2025, even with capital expenditures of roughly US\$8 billion (RM36 billion).

It also said it expects to buy back US\$3 billion worth of stock.

The entertainment giant's recent success at movie theatres helped offset a decline in operating income at the company's Experiences and Sports divisions. Lower attendance at international locations

dragged on theme parks results, and higher programming and production costs hurt ESPN. Disney reported adjusted per-share earnings

of US\$1.14 for its fiscal fourth quarter that ended in September. That compares with consensus estimates of US\$1.10 per share, according to analysts polled by LSEG.

Revenue reached US\$22.6 billion, slightly ahead of Wall Street forecasts of US\$22.45 billion. Operating income rose 23% from a year earlier to nearly US\$3.7 billion.

CEO Bob Iger, who returned to the company from retirement in November 2022, undertook aggressive cost-cutting and worked to revitalise the film and TV units after a period of misfires.

"Thanks to the significant progress we've made, we have emerged from a period of considerable challenges and disruption well positioned for growth and optimistic about our future," Iger said in a statement.

Operating income at the entertainment unit, which includes film, television and streaming, more than doubled to US\$1.1 billion in the quarter, reflecting the return of Hulu's Emmy-nominated comedy Only Murders in the Building and summer movies including *Deadpool & Wolverine*, the first R-rated Marvel film, and *Alien: Romulus*.

The *Deadpool* movie brought in \$1.3 billion at global box offices.

Disney's flagship streaming video service, Disney+, boasted more than 122.7 million subscribers outside of India, a gain of 4.4 million from the prior guarter.

The company intensified efforts to crack down on password sharing in September.

Disney+, Hulu and ESPN+ produced operating profit of US\$321 million for the quarter, marking the streaming services' second straight quarter of profitability.

Disney's experiences segment, that includes parks and consumer products, declined 6% to US\$1.66 billion.

In addition to the fiscal 2025 projection Disney said it expected double-digit adjusted EPS growth in fiscal years 2026 and 2027. "If you add it all up, our strategies are working,

working very well, and we've got good visibility on where those strategies are likely to lead us," Disney CFO Hugh Johnston said. - Reuters

Rakuten Trade Sdn Bhd equity research vice-president Thong Pak Leng said strong selling in MR DIY and MISC as well as profit-taking in plantation stocks dragged the index lower. "The local benchmark index was influenced by global economic uncertainties, concerns over US policy impacts, and sector-specific selling pressure," he told Bernama. Among the heavyweights, MR DIY dived 28 sen to RM1.82, MISC trimmed 35 sen to RM7.60, Maxis slid eight sen to

Farm Price expands to Sabah via stake in The Fresh Story

KUALA LUMPUR: Farm Price Holdings Bhd (FPH) is expanding its distribution to Sabah, aiming to provide the state with affordable fresh produce.

This is facilitated through the signing of a subscription and shareholders agreement between FPH, Thian Chu Chin and Jong Nyuk Sheng, collectively referred to as the partners, and The Fresh Story (KK) Sdn Bhd (TFS).

Under the agreement, FPH will subscribe to 1.1 million sha in TFS at RM1 per share, for a total of RM1.1 million.

Meanwhile, the partners will increase their shareholding in TFS via share subscription to 450,000 shares each at RM1 per share.

Upon completion of the share subscriptions, TFS will have an enlarged share capital of RM2 million from the present RM50,000, giving FPH a 55.0% stake and each partner a 22.5% stake

Upon completion of the subscription, TFS will become a 55% owned subsidiary of FPH.

FPH managing director Dr Tiong Lee Chian said the company's expansion into Sabah represents a strategic opportunity driven by customer references, highlighting their capability to meet the growing demand for a diverse range of fresh vegetables. "As we extend our reach to Sabah, we are completing the

geographic expansion across East Malaysia, where we are already distributing in Sarawak.

"This move strengthens FPH's national foothold and enables us to leverage our partners' understanding of the local market to enhance our regional distribution capabilities. We look forward to the initiative contributing positively to the group earnings from 2025 onwards" he said

Ringgit ends losing streak against US dollar

THE ringgit staged a rebound last Friday after recent losses to finish the week higher against the American dollar despite a rising greenback buoyed by anticipation of slower US interest rate cuts, ar economist said

At 6pm, the local note rose by 125 basis points to 4.4715/4780 against the greenback compared with Thursday's close of 4,4840/4870.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid noted that the local currency bounced back on Friday after having endured a run of losses last week. "The markets could have become uneasy with the latest comments by US Federal Reserve

(Fed) chairman Jerome Powell last night that the central bank might not be easing its monetary policy hastily," he told Bernama. It was reported that in his remarks to business leaders in Dallas on Thursday, Powell said strong US economic growth will allow policymakers to take their time in deciding how far and how fast to ower interest rates

At the close, the ringgit traded mostly lower against a basket of ajor currencies.

It appreciated versus the British pound to 5.6573/6656 from 5.6750/6787 at Thursday's close but slid vis-a-vis the euro to 4.7224/7292 from 4.7172/7203.

The local unit traded mixed against its Asean peers. It strengthened against the Philippine peso to 7.61/7.63 from

7.63/7.63 and climbed versus the Indonesian rupiah to 281.6/282.2





Beauty content makes bigger impact on IG

BEAUTY content is always popular on social networks yet some platforms seem to stand out. Indeed, Instagram is the app on which this kind of content has the biggest impact, revealed the latest report from influencer marketing platform Traackr.

In just one year, views of beauty videos have skyrocketed on Instagram, according to Traackr's *State* of *Influence: Beauty* report 2024 based on research conducted in the US, UK and France.

While the Meta group's social network saw the number of active influencers fall by 10% between the first half of 2024 and the same period in 2023, with mentions also down by 14%, engagement rose by 5% while the number of views jumped by 68%.

The report said the improving performance of beauty content on instagram may see creators and brands turn increasingly to the platform, potentially driving a rebound in the number of beauty creators active on the apo.

Instagram's performance largely outstrips those of its competitors. Although TikTok performed well in terms of mentions (+22%) and number of active influencers and views (+6%), it saw no growth in terms of engagement. While YouTube has established itself

While YouTube has established itself as one of the world's most popular platforms, the video streaming giant suffered a decline in every category: -30% in mentions, -25% in active influencers, -24% in the number of

views and -21% for engagement. Influencers with fewer than one million followers benefited most from the overall increase in views.

Mid-influencers (between 50,000 and 250,000 subscribers) saw an increase of 46% in views, compared with 41% for micro-influencers (10,000 to 50,000 subscribers), 39% for nano-influencers (1,000 to 10,000 subscribers) 39% and 35% macro-influencers (between 250,000 and one million subscribers).

and one million subscribers). In France, Sephora has established itself as the most mentioned beauty brand. Its Brand Vitality Score (VIT), a measure used to evaluate influencer marketing performance on social networks in terms of visibility, impact and trust, has increased by 90% compared with 2023.

However, Huda Beauty beats all others with an exceptional 200% growth, moving up 16 places in the ranking of France's top brands to sixth place.

Sephora also leads the ranking in the US while the Skkn By Kim has moved up 30 places to seventh, with a 213% increase.

In the UK, French brands are on the up. L'Oreal Paris takes the lead with an 84% increase while YSL posts the second-highest rise with a 137% increase in one year. Armani leads on growth at 193%. – ETX Studio

Artificial intelligence to boost Windows Notepad, Paint


MICROSOFT has announced the arrival of new artificial intelligence(AI)-based functionalities in Notepad and Paint in Windows 11. Members of the Windows Insider programme, who preview and test new features of the operating system, will be the first to have access to these tools. However, they will need to have recent hardware, namely a Copilot+ PC, to try out all of these new features.

Notepad will benefit from Al-assisted writing enhancements via the "Rewrite" feature that lets you rephrase sentences, adjust tone or modify text length. By selecting any passage and choosing this option, the Al tool will be able to propose various alternative versions of the text, whether to achieve greater clarity or to change the writing style. For its part, Paint will offer new possibilities thanks to Al-enhanced creative tools. For example, the "Generative fill" feature will enable users to add or modify the elements of an image by entering a simple text description. To use it, simply select an area of the image, describe the desired addition and the Al will again generate several proposals from which to choose. It will also be possible to remove an element from the image by replacing it with a suitable background, ensuring the removal is not visible afterward.

All these innovations point towards to Microsoft's commitment to integrating AI into all its flagship applications, with the aim of enriching the user experience and boosting everyone's creative and editorial potential. – ETX studio

BERJAYA AIR SEAMLESS JOURNEYS, BOUNDLESS DISCOVERIES

WWV^{HILE} some people prefer romance or fantasy, others delight in the frights of horror movies. A study published in the journal *Scientific Reports* revealed why people enjoy these terrifying tales.

It may seem surprising but some people enjoy entering into the darkness of a movie theatre in order to scare themselves with all kinds of onscreen frights. For researchers at the University of Pecs in Hungary, this penchant may well be explained by the excitement of fear itself.

The study, titled *The Role of Excitement and Enjoyment through Subjective Evaluation of Horror Film Scenes*, explored how curiosity about morbid subjects plays a key role in driving people to watch horror movies as do the realism of the scenes and intensity of the fear felt.

felt. The study, led by University of Pecs's Institute of Psychology PhD student and research assistant Botond Kiss recruited 558 participants. They were asked to fill out online questionnaires about their movie-watching habits, emotional regulation, curiosity about morbid subjects, beliefs in the supernatural, sensitivity to disgust and sensation-seeking personality traits.

Participants then watched 10 short scenes from different horror movie sub-genres, ranging from supernatural to psychological and monster movies. After each scene, they rated their experiences in terms of excitement, pleasure, fear, disgust and realism. The results of the study are revealing.

The results of the study are revealing. Feelings of fear, the realism of scenes and curiosity about morbid subjects are all strong predictors of excitement and pleasure. In other words, for some viewers, the more realistic these films are, the more exciting and entertaining they are. Fear, especially, is particularly associated with excitement and pleasure.

On the other hand, scenes that evoke a strong sense of disgust tend to diminish the viewer's pleasure, without necessarily reducing excitement.

"Previous approaches did not distinguish "Previous approaches did not distinguish between enjoyment and excitement. In contrast, our current research suggests, although they are quite similar constructs, they are influenced by different factors. The former is more influenced by perceived disgust while the


Kiss. The study even dispelled a long-held cliche in suggesting horror movie fans are not necessarily thrill-seekers. And whatever their personal beliefs in the supernatural or their sensitivity to disgust, these parameters did not seem to influence viewers' reactions either. "As some horror consumers can be

As some horror consumers can be described as thrill-seekers, they experience the fear-induced adrenaline as rewarding. This seems to have an indirect effect through other factors," explained Kiss.

It is important to note the limitations of this study. Most of the participants were horror movie fans and therefore, already had a certain taste for this genre. "In this research, we looked at direct effects.

"In this research, we looked at direct effects. So, if one factor had an effect through another factor, we could not detect it. This would require more complex analyses. Moreover, the content of the different genres of horror films is quite different. Just think about how different the content of a psychological horror movie and a zombie horror movie is. So, in the future, it might be worth taking this into account.

"Our direct long-term plan is to identify certain motivations for why people consume such content. Indirectly, we have the opportunity to identify the factors that influence the perception of disgust and fear. This could be important in understanding specific phobias, (in which) fear and disgust are of particular importance (for example animal phobias or blood-injury-injection phobia)," said Kiss. - ETX Studio







More gothic in approach, Tribulation's early albums such as The Children of the Night and Down Below were a fine balancing act between tunefulness and crushing heaviness, a trait that the best of the Scandinavian bands seem to master. The epic Where the Gloom Becomes Sound in 2021 marked a band that had matured and was now straining at the seams to break out from the confines of the genre.

The result can now be heard on Tribulation's latest release – Sub Rosa In AEturnum. Released on Nov 1 on the Century Media imprint, the band goes all out with the clean singing element as it attempts to gain a wider following.

Does it work? The gothic atmospherics are very much still in place, colouring proceedings with a dark, shade of melancholy. But does it move listeners to go "wow"? It is solid but not quite

It is quite telling that the two tracks that feature death metal like growls are

the highlights on this album. *Time & Vivid Ore* absolutely rock but maybe it is just a natural response after the midtempo middling of the other tracks.

The cod-David Bowie vocal stylings will surely lead to many a debate on fan forums, just as Opeth's and In Flame's attempts at a "cleaner" sound divided opinions.

Opener Tainted Skies and Reaping Song are solid but not spectacular but things pick up with Poison Pages, offering fans a glimpse of what is possible.

Perhaps a darker, more haunting sound is required to offset the band moving away from its death metal roots. Symphonic stylings would also be a welcomed addition as the band seeks to enrich its sound and to let its songs truly soar.

sees to emint sound and to let its songs truly soar. Only time will tell if Tribulation made the right move. On the strength of this album, there is still some ways to go before it reaches In Flames's breakout appeal or even Opeth levels of fandom. Those past Sandinavian masters have shown it is possible.

In the meantime, listeners can judge for themselves by streaming the album online, which is available on all major platforms. If convinced, vinyl copies were spotted at Varmt Stal Records retailing at RM140.

Tyson says 'no regrets' over loss

FORMER world heavyweight champion Mike Tyson said Saturday he has no regrets over losing to Jake Paul in their heavyweight boxing matchup after climbing into the ring "one last time.

"This is one of those situations when you lost but still won," Tyson posted Saturday on X. "I'm grateful for last night. No regrets to get in ring one last time."

Tyson, who said he nearly died in June over health issues, had left open chances for another ring return in comments shortly after the defeat. He said it was a victory simply to

fight – detailing medical issues that forced the fight to be postponed from July after he had a medical scare on a flight from Miami to Los Angeles in May where he vomited blood.

68 and 54, respectively. "It was an excellent wicket and we got off to a great start with our openers putting them under plenty of pressure," Buttler said. "We thought we needed at least 220.

"Their openers then played exceptionally well too. We were trying to do some things differently, create some opportunities with fielders in other areas of the field." – Reuters

Another blow for India as Gill suffers injury

INDIA have suffered another injury blow as they prepare for this week's first Test against Australia, with batsman Shubman Gill fracturing his thumb in a training session in Perth on Saturday, according to multiple media reports.

India opted to prepare for the Perth Test, which starts on Friday, with squad sessions behind closed doors rather than take on a local side in a tour match.

Gill injured his left thumb while fielding and is a major doubt for the match, the *Times of India* and other media outlets reported, citing sources. The team did not provide immediate comment when contacted by *Reuters* about Gill's condition.

Germany hammered Bosnia and Hercegovina -0 while Netherlands outclassed Hungary with a 4-0 victory in their winner-takes-all Nations League encounter vesterday.

Germany cemented their spot at the top of the group with a 7-0 win over Bosnia - the heaviest in the six-year history of the Nations League.

"It was good fun tonight. After a couple of goals we did the work defensively and then everything came together offensively. The more that happens, the more fun we have on the pitch," German attacker Jamal Musiala told Uefa's website.

Musiala opened the floodgates after two minutes with a header from Joshua Kimmich's cross.

Tim Kleindienst scored his first goal for Germany in the 23rd minute and Kai Havertz made the game safe eight minutes before the break, slotting home after a slick one-two with Florian Wirtz

Wirtz then made it four on 50 minutes with a sublime swerving freekick from wide on the left, before doubling up seven minutes later.

"Seeing Flo (Wirtz's) freekick was kind of nice but just in general everyone played well, had good moments. We're just playing good football," added Musiala.

Substitute Leroy Sane scored Germany's sixth in the 66th minute and Kleindienst completed the rout just over 10 minutes from completed the rout just over 10 minutes from time as he guided home a pinpoint cross from centre-half Antonio Rudiger. The emphatic result leaves Germany five points ahead of Netherlands with only one match left to play.

match left to play. Meanwhile, Netherlands and Hungary

went into the match tied on five points each and with the winner set to join Germany in ensuring their progress from Group A3 to the

quarterfinals. First half penalties by Wout Weghorst and Cody Gakpo sent the *Oranje* on their way, before Denzel Dumfries and Teun Koopmeiners made the game safe in the second period.


