KUALA LUMPUR: Having led the nation for just two years, Prime Minister Datuk Seri Anwar Ibrahim's government might still be "green", but reforms are already visible, particularly in the governance, political, economic and social spheres, said political analyst Prof Dr Ahmad Martadha Mohamed.

Citing corruption, he said the government has prioritised the issue. "Regardless of whether they are

from the elite group or are civil servants or ordinary persons, if found to be involved (in corrupt activities), they will be brought to justice without double standards.

Ahmad Martadha said the fight against corruption boosts public trust in the government and enhances confidence among foreign investors.

According to the 2023 Corruption Perceptions Index released by Transparency International Malaysia in January, Malaysia scored 50 points in 2023, an improvement from 47 points the previous year.

He said another significant improvement was the reduction in political appointments within government agencies, boards and NGOs, which enhanced governance and minimised political interference

in administrative matters. He added that the government introduced various forms of assistance to alleviate the rising cost of living and ensure that only genuinely deserving groups, particularly the B40 segment, benefit from them.

"It is also reviewing the definition of the T15 income group, considering that the current threshold of approximately RM13,000, as set by the Statistics Department, is deemed too low."

Malaysia Cyber Consumers Association (MCCA) president Siraj Jalil said the government is actively implementing improvements to

address cybersecurity challenges. He said among these efforts is the amendment to the Personal Data Protection Act 2010 to strengthen the protection of Malaysians' data. He added that the *Jelajah Anti*

Scam Kebangsaan 2024 programme, spearheaded by CyberSecurity Malaysia and supported by NGOs such as MCCA and Yayasan Digital Malaysia, is being conducted in states like Johor and Kedah to raise public awareness about online scams and preventive measures.

Zubaidah Mukhtar, its deputy director-general (operations) Johan Cruyff@Mohd Johari Md Nordin and RCD Concept Sdn Bhd director Datuk Seri Rozaimi Che Di.

"The government has also enacted the Cybersecurity Act 2024 under the National Cyber Security Agency. This Act, which came into force on Aug 26, aims to enhance the nation's cybersecurity.

According to a MyCERT report,

there was a 13% rise in cybersecurity incidents in the first quarter of 2023, compared with the fourth quarter of 2022, Bernama reported. Global cybersecurity firm Kaspersky reported that in 2023, its tracking system blocked 26.85 million

"internet-borne" attacks in Malaysia,

averaging 74,000 attacks per day. Communications Minister Fahmi Fadzil had previously said the Online Security Bill was being introduced to address gaps or lacunae in the law, particularly the lack of a precise definition of crimes such as bullying, including cyberbullying.

National Organisation of Skilled Workers president Mohammad Rizan Hassan said technical and vocational education and training (TVET) in Malaysia has experienced positive growth over the past two years.

He said Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi, in his capacity as National TVET Council chairman, is committed to shaping the TVET landscape.

"Collaboration with industry partners has provided students with real-world experiences, ensuring they are well-prepared for the job market.

"The emphasis on practical skills and hands-on training has boosted the employability of TVET graduates, leading to greater demand for skilled workers across various sectors,' Mohammad Rizan said.

GE16 to see more young **BN** candidates

IPOH: Barisan Nasional (BN) will field many new faces, especially from among the youth, in the 16th general election (GE16), said its chairman Datuk Seri Dr Ahmad Zahid Hamidi.

Ahmad Zahid said this is one of five steps to strengthen BN component parties to gain the people's support, Bernama reported.

"I believe we have no choice but to field new candidates, particularly youths. The by-elections in Nenggiri and Mahkota recently proved that this hypothesis is true.

'The suitability of a candidate is not only based on his young age, but also on his strong grassroots exposure, which can lead to a decisive victory," he said yesterday after officiating at the Perak BN Convention.

Also present were BN secretarygeneral Datuk Seri Dr Zambry Abd Kadir, Perak Menteri Besar Datuk Seri Saarani Mohamad and other component party leaders.

Anwar on three-day official visit to South Korea

PUTRAJAYA: Prime Minister Datuk Seri Anwar Ibrahim is on an official visit to South Korea from yesterday until tomorrow to further strengthen bilateral ties as the two nations prepare to celebrate 65 years of diplomatic relations next year.

The Foreign Ministry said Anwar's first official visit to South Korea since assuming office in November 2022 is at the invitation of South Korean President Yoon Suk Yeol

It said Anwar is scheduled to hold a bilateral meeting with Yoon at the Yongsan Presidential Office.

"Both leaders will take stock of Malaysia-South Korea bilateral relations that have significantly bilateral progressed in scope and substance since the establishment of diplomatic ties in 1960.

"They are also expected to discuss regional and international issues of mutual concern and exchange views

on Malaysia's chairmanship of Asean and South Korea's chairmanship of the Asia-Pacific Economic Cooperation in 2025," the Foreign Ministry said in a statement.

Anwar and Yoon will witness the exchange of three MoUs on cooperation in higher education, carbon capture and storage, as well as cooperative approaches (under the Paris Agreement).

Anwar is also set to deliver a special

address titled "Strategic Partners in a Complex World: Malaysia, Korea and the Future of Asia" at the Seoul National University.

He will be accompanied by Foreign Minister Datuk Seri Mohamad Hasan, Investment, Trade and Industry Minister Datuk Seri Tengku Zafrul Abdul Aziz, Science, Technology and Innovation Minister Chang Li Kang, National Unity Minister Datuk Aaron Ago Dagang and senior government officials.

From January to September, Malaysia's trade with South Korea was valued at RM81.61 billion. From 1980 to June 2024, a total of 392 manufacturing projects with South Korean participation have been implemented.

South Korea was In 2023, Malaysia's eighth largest trading partner, with trade valued at RM111.07 billion. – Bernama



SPM students all set for 'pivotal' academic milestone

Candidates nationwide to sit for examination on Dec 2, aiming for best results that could further education opportunities and shape career paths

PETALING JAYA: The Sijil Pelajaran Malaysia (SPM) examination marks a pivotal milestone for Malaysian students, serving as an important chapter in their school years and a gateway to their future aspirations.

With the SPM set to begin on Dec 2, candidates across the country are making their final preparations for what is often seen as a defining moment in their academic journey.

For many, the stakes are high, as the results could shape their career paths and further education opportunities. As the clock ticks, students are putting in every effort to ensure they are ready for this crucial moment.

Farhan Adrees, 17, from Sekolah Dato Abdul Razak, an all-boys boarding school in Negeri Sembilan, has found the weeks leading up to the SPM intense. Aspiring to pursue accounting, he knows that achieving the best results is key to his future success.

He said studying in one of the most prestigious schools in Malaysia means he has to prepare a lot to get the best results.

"I feel a little nervous, but I'm eager to sit for the exam. I'm starting the first few weeks with the speaking test and the Science Practical Test, where I will demonstrate everything I've learned in the lab."

Farhan said the tight schedule at his boarding school is effective, saying it boosts his discipline and helps him to stay focused. "Staying busy keeps me from overthinking, and after a full day, I'm guaranteed a good

and after a full day, I'm guaranteed a good night's sleep." He credits much of his motivation to his

teachers and school, acknowledging that extra classes and mock exams have been helpful. He also said success ultimately depends on

each student's effort. However, for some students, maintaining

motivation and managing stress have been a challenge.

Nur Hayfaa Qistina, 17, admits that consistency is her biggest hurdle in preparing for the exam.

"There are days when I lack motivation or feel close to giving up, but I always remind myself to think of success.

"To manage stress, I talk to loved ones and seek advice from them. Having a strong support system, particularly from my family, is important for me. When my family sees me stressing out or staying up late, they comfort

me and occasionally treat me to something nice.

"They've fully supported me ever since the beginning, and I've set high expectations for myself to make them proud."

She also said her study methods are unique and also reflect her ability to adapt to modern tools. Unlike traditional approaches, she uses social media platforms like Telegram and TikTok to find effective notes and resources.

Often, she relies on technology, using an iPad to take notes and study on the go.

Nur Hayfaa said while technology can benefit studying, it must be used properly to avoid distractions.

Nur Iman Safia, 17, echoed similar sentiments, noting that the presence of gadgets and social media can sometimes be a distraction, causing her focus to be affected.

To counter this, she reverts to traditional methods, such as using pen and paper to take notes.

"I use my gadgets to study, but sometimes I just switch my study methods to stay focused."

All three students expressed wanting to make their families proud and achieve success.

Nur Iman wants to prove that her efforts have not been in vain.

"Making my family proud has always been my most important goal in life and I hope to get all As for my SPM."

The students will take their SPM examination over two months. It ends in Feb 6 next year.

'Four-and-half-day work plan hinges on rationale'

KOTA TINGGI: Johor's proposal to implement a four-and-a-half-day work week hinges on the state government's rationale, said Minister in the Prime Minister's Department (Law and Institutional Reform) Datuk Seri Azalina Othman Said.

She said the state government must have valid reasons for the proposal, but declined to elaborate further, citing a lack of details on the plan.

However, the Pengerang MP expressed her personal view that technological advancements and rapid development have transformed traditional working norms.

"Nowadays, no one strictly works eight hours a day. Many people work beyond that because of technology, like smartphones, enabling work outside standard hours," she said, adding that work hours often depend on the nature of a profession.

"Certain jobs demand more than eight to 10 hours a day, while some can be performed remotely. As we head into 2025, we must adopt a more open-minded approach, especially with technology evolving so rapidly," she said after a community dinner in Pengerang on Saturday night.

Last Thursday, Johor Menteri Besar Datuk Onn Hafiz Ghazi announced that the state is studying a four-and-a-half-day work week for the public sector, following the move to revert state weekend holidays to Saturday and

Sunday starting Jan 1, 2025.

Onn Hafiz said the government is actively improving productivity and service delivery, including standardising operating hours for service counters across state and federal government offices as well as local authorities. In 2022, a pilot study in the United Kingdom involving 61 organisations tested a four-day work week. Results showed significant benefits, including a 71% reduction in employee burnout.

According to the Chartered Management Institute, 89% of participating organisations continued with the shorter work week after the six-month trial, with some reporting revenue growth of up to 34%. – Bernama

11,000 UKM grads conferred degrees

KUALA LUMPUR: A total of 11,010 graduates received their degrees at the 52nd Universiti Kebangsaan Malaysia (UKM) Convocation, which began on Saturday. It ends on Dec 1.

The convocation ceremony at the Tun Abdul Razak Chancellor Hall will be held in 15 sessions, involving 4,409 Bachelor's Degree graduates, 2,549 Master's Degrees, 469 Doctor of Philosophy, 3,393 Postgraduate Diplomas and 190 Specialist Doctors. UKM vice-chancellor Prof Datuk Dr Mohd

UKM vice-chancellor Prof Datuk Dr Mohd Ekhwan Toriman said in a statement that this has brought the UKM alumni network to 240,462 as of this year. "The convocation ceremony began with an

"The convocation ceremony began with an opening ceremony conducted by the Yang di-Pertuan Besar of Negeri Sembilan Tuanku Muhriz Tuanku Munawir, who is also the Chancellor of UKM," he said.

He added that UKM's convocation ceremony also involved the first graduates of two Postgraduate Diploma programmes, namely the Postgraduate Diploma in Education programme and the Postgraduate Diploma in Clinical Embryology. Meanwhile, three UKM academicians,

Meanwhile, three UKM academicians, namely Dr Rahmah Ismail, Dr R. Wickneswari and Datuk Dr Wan Ramli Wan Daud, were awarded the title of professor emeritus in recognition of their excellent services in their respective fields of expertise. – Bernama

Syariah amendments to be tabled next year

KOTA BHARU: The Kelantan government is expected to table amendments to the Syariah Criminal Code (I) Enactment 2019 in the state legislative assembly in 2025.

Deputy Menteri Besar Datuk Dr Mohamed Fadzli Hassan said the amendments would be tabled after the Main Committee on Amendments to the Syariah Criminal Code (I) 2019, comprising 12 members, discusses the matter.

He said the committee's scope and responsibilities include examining the impact of the annulment of 16 provisions on the existing enactment and forming a technical committee to conduct the study.

"This committee will also propose a draft to reinstate the 16 annulled provisions, including any related provisions," he said when replying to Zuraidin Abdullah (PAS-Chetok) at the Kelantan state legislative assembly yesterday.

On March 6, the Kelantan state legislative assembly, in its sitting, approved a motion to relegislate the 16 offences in the Syariah Criminal Code Enactment (I) Kelantan 2019 which were declared null and void by the Federal Court on Feb 9. – Bernama

Hassan Abdul Karim (PH-Pasir Gudang) regarding the scarcity of locally produced white rice in the market, which was highlighted during the committee stage debate on the Supply Bill 2025 in the Dewan Rakyat recently. – Bernama

KUALA LUMPUR: For father and son Avub Abdul Ghani, 61, and Dr Mohamad Zulkifli, 28, Nov 19 will always remain in their minds as the day their bond transcended everything else and manifested in its truest form.

Their ordeal started years earlier when Mohamad Zulkifli was diagnosed with stage five kidney failure and had to spend the next four years on haemodialysis.

Seeing his son suffering, Ayub made the love driven decision to help. The act gave Mohamad Zulkifli a second chance to live a near-normal life and stands as a powerful example of parental sacrifice. Mohamad Zulkifli's journey with

kidney failure began when he

turned 24 years old. The next four years of his tertiary education at the International Islamic University of Malavsia in Kuantan, Pahang involved haemodialysis.

Eventually, the Sultan Haji Ahmad Shah Medical Centre in Kuantan changed this to peritoneal dialysis, which is done at home.

"I was diagnosed with stage five kidney failure while pursuing my medical degree. I felt a sense of despair upon learning that I needed to undergo haemodialysis. Soon, I was admitted to the hospital. When I first started on haemodialysis, I felt

lethargic and dizzy but the symptoms settled down in time," said Mohamad Zulkifli, adding that his late mother was also diagnosed with kidney failure and underwent haemodialysis for five years before her death.

So, it came as no surprise that Avub was devastated by his son's struggle and dependence on dialysis

"Seeing him suffering was heartbreaking. After doctors explained the risks and benefits of the transplant, I had no hesitation to donate a kidney to him."

"I am grateful to have been given a second chance at life," he said, reflecting on how the transplant has given him hope of living a normal life. For Ayub, his experience with the

transplant forced him to quit cigarettes and become a strong supporter of the anti-smoking lobby. "Quit smoking for your own sake

and the well-being of those around you. It is never too late to make a change. I feel far healthier today after quitting cigarettes than I have ever felt.

"I also feel a tinge of sadness that my son's kidney failure was what prompted me to decide to finally give up cigarettes.

Not everyone is blessed to have a transplant in Malaysia as the gap between supply and demand for organs is notably large.

Data from the Malaysian Society of Transplantation (MST) showed that 9,608 child and adult patients are on the waiting list, with the highest demand being for kidneys. Only 3,250 transplants have

been carried out since 1975. Over the past 10 years, Malaysia performed between 80 and 180 kidney transplants a year, with living donors making up between

70% and 80% of the transplants. MST vice-president and Hospital Kuala Lumpur transplant nephrologist Dr Mohamad Zaimi Abdul Wahab said about 382,020 individuals have pledged their organs, with the majority aged between 20 and 39.

Flood situation mostly unchanged in three states

Slight decrease in evacuees in Terengganu and Malacca while increase recorded in Kelantan

KUALA LUMPUR: The flood situation in Terengganu, Malacca and Johor remained largely unchanged while the number of affected residents in Kelantan had risen as of yesterday morning.

In Terengganu, the number of evacuees decreased from 250 on Saturday night to 228 as of 8am yesterday, with those affected placed at six temporary relief centres in Marang and Dungun districts.

The state Disaster Management Committee secretariat reported that 191 evacuees from 36 families were housed at four centres in Marang, namely Dewan Sivik Wakaf Tapai, SK Rawai, Dewan Sivik Mercang and SK Pengkalan Berangan, while 37 evacuees from seven families were at two centres in Dungun, namely SK Tok Kah and Balairaya Alor Mak Bah.

According to the *InfoBanjir* portal, water levels at Sungai Chalok at Jambatan Chalok (F2) and Sungai Nerus at Kampung Bukit in Setiu exceeded the warning level while Sungai Terengganu at Rumah Pam Pulau Bahagia (F1) surpassed the alert level.

In Malacca, the number of evacuees slightly decreased from 231 from 64 families on Saturday night to 220 people from 60 families as of 8am yesterday.

The state Disaster Management Committee secretariat reported that 185 people from 49 families were housed at SK Tanjung Minyak 2 and 35 people from 11 families were staying at the Pantai Kundur Japerun office.

The evacuees were residents of Taman Rambai Jaya, Taman Rambai Utama, Kampung Bukit Datuk A, Kampung Pantai Kundur and Taman Rambai Indah. Johor Disaster Management Committee

chairman Tan Sri Dr Azmi Rohani said the flood situation in Johor remained unchanged, with one centre still open at Balai Raya Batu Badak in Segamat and sheltering 11 evacuees from four families from Kampung Seberang Batu Badak yesterday.

He said five rivers in Johor were at warning levels, namely Sungai Kesang at Telok Rimba and Sungai Tangkak at Kampung Seri Ma'amor in Tangkak, Sungai Muar at Buloh Kasap in Segamat, Sungai Paya Dato' in Mersing and Sungai Pungai in Kota Tinggi.

Sungai Pungai in Kota Tinggi. In Kelantan, the number of evacuees increased to 76 yesterday morning, with a new centre at SK Gual To'Deh in Pasir Mas sheltering 32 victims from seven families.

sheltering 32 victims from seven families. According to the Social Welfare Department's Disaster Info portal, 44 evacuees from 12 families remained at SMK Beris Panchor in Bachok, Bernama reported. InfoBanjir reported that the level at Sungai

InfoBanjir reported that the level at Sungai Golok in Rantau Panjang remained above the warning level at 8.73m as of 9am while Sungai Golok in Kuala Jambu in Tumpat, Sungai Melor in Bachok and Sungai Semerak in Pasir Puteh were above the alert level, at 2.09m, 7.04m and 2.14m respectively.

Johor continues ban on sale of vape products, e-cigarettes

ISKANDAR PUTERI: Local authorities in Johor continue to enforce the ban on the sale of vape products and electronic cigarettes, and have not issued any licences for their cale.

and have not issued any licences for their sale. State Housing and Local Government Committee chairman Datuk Mohd Jafni Md Shukor said the decision to prohibit the sale of such products has remained in effect since 2016.

He said the ban remains in effect on the sale and purchase of vape products, as well as gel or liquid flavours, particularly those containing nicotine.

On Jan 1, 2016, the state government implemented a law banning the use of vape products, including taking action against traders involved in the sale of such devices, following a decree by Sultan of Johor Sultan Ibrahim Sultan Iskandar prohibiting such activities in the state.

On Nov 19, Health Minister Datuk Seri Dr Dzulkefly Ahmad announced that vape products would remain regulated under the Control of Smoking Products for Public Health Act 2024, which came into force on Oct 1.

He said while the federal government has opted not to ban the sale of vape products at the national level, state governments have the authority to set their own policies, including imposing sales bans through local authorities. – Bernama

Law on illegal border crossing to apply to students

PASIR MAS: The law permitting the detention of Malaysians using illegal routes along the Sungai Golok-Rantau Panjang crossing, set to take effect on Dec 1, applies to everyone, including students.

National Security Council (NSC) Security Management deputy director-general Hamzah Ishak said Malaysians are only allowed to cross the Malaysia-Thailand border via three gazetted checkpoints in Kelantan.

"All border-related issues, including school students (using illegal routes from Sungai Golok to attend school in Rantau Panjang) under the jurisdiction of the Education Ministry, have been addressed.

"The ministry has developed strategies and plans. We must enforce this law to protect Malaysia's sovereignty and territorial integrity." Hamzah was speaking at a press conference following a three-hour NSC meeting at the Rantau Panjang Immigration, Customs, Quarantine and Security Complex yesterday. He said a mechanism would be discussed

He said a mechanism would be discussed with the ministry to address the issue of students who live in Thailand but attend school in Malaysia. He noted that the law must be

He noted that the law must be implemented carefully, with the support of the parents of the students.

parents of the students. *"Insya-Allah*, if the parents are on board, there would be no issues and border openings would be coordinated with Thai authorities."

"Additional details on the matter will be shared by Kelantan police chief (Datuk Mohd Yusoff Mamat) as necessary."

Kelantan Education Department director Datuk Mohd Zamri Abdul Aziz said discussions are ongoing to address the issue of students using illegal routes.

He said the department has explored several proposals, which have been submitted to Education Minister Fadhlina Sidek for consideration.

It was reported that nearly 500 students from Thailand use illegal routes across Sungai Golok daily to attend school in Malaysia.

On Nov 6, Kelantan police announced that effective Dec 1, they would detain Malaysians crossing the Malaysia-Thailand border using illegal routes, particularly along Sungai Golok.

Mohd Yusoff said the authorities would invoke Section 5(2) of the Immigration Act 1959/1963 to detain Malaysians using nongazetted routes. – Bernama

Lorry driver arrested after fatal crash

The crash occurred when the lorry, which had been parked at a construction site to refill its brake fluid, suddenly rolled backward, breaking through a safety gate, entering the main road and striking a motorcyclist.

"A motorist was also hit by the lorry and sustained injuries to his forehead. We will apply for a remand order to continue the investigation," said Mohd Zamzuri.

RM64,000 watch stolen from shop

FIRE RIPS THROUGH

MANILA: Raging orange flames and thick black smoke billowed into the sky yesterday as fire ripped through hundreds of houses in a slum here. Fire department officials said around 1,000 houses were razed in Isla Puting Bato village. There were no reports of casualties. The structures housed around 2,000 families. Village resident Leonila Abiertas, 65, lost almost all her possessions, but managed to save her late husband's ashes. "I only got the urn with the ashes," Abiertas said. Fire and disaster services deployed 36 trucks and four fire boats while the airforce sent in two helicopters to help extinguish the fire. – AFP.

'BALI NINE'PRISONERS TO BE REPATRIATED

SYDNEY: The remaining members of the "Bali Nine" drug gang could be released from Indonesia and returned to Australia. Police arrested the nine Australians in 2005, convicting them of attempting to smuggle more than 8kg of heroin from Bali. Trade Minister Don Farrell said Australia was pushing to repatriate the five men. He said: "They would continue to serve their sentence in Australia." Andrew Chan and Myuran Sukumaran were executed in 2015. Tan Duc Thanh Nguyen died of cancer in 2018, months before Renae Lawrence was released after her sentence was commuted. Matthew Norman, Si Yi Chen, Michael Czugaj, Scott Rush and Martin Stephens are in jail. – AFP

LAOS 'SADDENED' BY ALCOHOL DEATHS

BANGKOK: The Laos government is "profoundly saddened" by the deaths of foreign tourists from drinking alcohol contaminated with methanol and pledged to prosecute those responsible. Two Danes, two Australians, a Briton and an American have died after visiting Vang Vieng, an idyllic town that is popular with foreign backpackers. The government has been "conducting investigations on the incident and bring the perpetrators to justice", it said in its official comments published on the Foreign Affairs Ministry website on Saturday. – Reuters

Wong warns of dangerous world amid global instability

Situation is now changing, says S'pore PM

SINGAPORE: "Everyone is worried because we are in a far more dangerous world today," Prime Minister Lawrence Wong said as he reflected on the evolving global landscape.

Speaking at the People's Action Party (PAP) Conference yesterday, Wong shared insights from highlevel meetings at the Asia-Pacific Economic Cooperation forum in Peru and the G20 Summit in Brazil.

His speech highlighted the precarious state of global geopolitics, marked by wars, strained superpower relations and rising instability.

"There are major wars raging in Europe and the Middle East. The US-China relationship is in a more challenging place, and there are many moving pieces geopolitically where things can easily go wrong," said Wong, who also serves as deputy secretary-general of the PAP. For decades, he said, "all of us

have benefited from an Americanled Global Order". "We say this is Pax Americana in Latin. It means a world with America as the dominant power supported by multilateral institutions, like the United Nations, the IMF, the World Bank, the International Court of Justice and so on ... shaping international norms and behaviours. "Now, the situation is changing.

"America is still pre-eminent but it no longer wants to be the world's policeman. Donald Trump has just been re-elected to office based on an America first (policy)."

Wong said Trump's mandate "reflects the growing sentiment among the American public that they are paying too high a price to uphold this Global Order ... too high a price and yet not enjoying the commensurate benefit."

At the same time, he said there are other rising powers like China and India.

"But they too are focused on their own domestic issues and they are not yet in a position to take on larger global responsibilities." Thus, he said, "the world is in flux."

"The established norms are fading, but a new order is not yet in place. Amid this vacuum of global leadership ... we can expect more conflict and instability in the world because state and non-state actors will be emboldened to test boundaries. Often with little or no consequence."

Wong said the world has already seen this in Ukraine, where there has been an egregious breach of the UN Charter and territorial sovereignty.

"Also in the Middle East where there has been a horrendous attack followed by a cataclysmic humanitarian tragedy," he said.

Wong suggested that the major powers of the world "should come together, coordinate their positions and work together for the larger good".

"Stop the conflicts. Stop the wars. Tackle shared challenges like nuclear proliferation. Otherwise, we can't look forward to a shared future," he said.

He added that unfortunately, there is deep suspicion and mistrust between America and China. "Each regards the other as a strategic threat and both are taking steps to enlarge their spheres of influence and to strengthen their own positions. So, it will get harder to find common ground. "These dynamics will be with us

for some time.

"We are not talking about one or two years, and then things will improve. I think we will have to grapple with this perhaps for the next decade or beyond.

"It means we will find it more difficult to make a living and keep ourselves safe.

"Other countries may test our limits and we must be ready to stand firm and defend our interests. At the same time, we must redouble our efforts to make friends with everyone. Big and small, near and far."

Wong also told party members that this would be the last PAP biennial conference before the general election.

"It will be next year," thus confirming for the first time that the election will be held in 2025.

Singapore's last general election was in July 2020. – Bernama

'Assassination threat a national security matter'

MANILA: The Philippine security council will verify an alleged assassination threat by Vice-President Sara Duterte against President Ferdinand Marcos Jr, a top official said yesterday, describing it as a "matter of national security".

a "matter of national security". Duterte, in a strongly-worded briefing on Saturday, said she had spoken with an assassin and instructed him to kill Marcos, his wife and the speaker of the Philippine House if she were to be killed.

"I have talked to a person. I said, if I get killed, go kill BBM (Marcos), (first Iady) Liza Araneta, and (speaker) Martin Romualdez. No joke. No joke. I said, do not stop until you kill them, and then he said yes," Duterte said in the profanity-laden briefing. She was responding to an online commentator urging her to stay safe, saying she was in enemy territory as she was at the lower chamber of Congress overnight with her chief of staff. Duterte did not cite any alleged threat against herself.

National Security Adviser Eduardo Ano said the government considers all threats to the president as "serious", vowing to closely work with law enforcement and intelligence communities to investigate the threat and possible perpetrators. "Any and all threats against the life

of the president shall be validated and considered a matter of national security," Ano said in a statement. In response to Duterte's threat,

Marcos' presidential security

command said it had tightened its protocols in guarding the Philippine leader and the national police chief had ordered an investigation.

Police chief Rommel Francisco Marbil said he had called for an immediate probe, adding that "any direct or indirect threat to his life must be addressed with the highest level of urgency".

level of urgency". The Presidential Communications Office said any threat to the life of the president must always be taken seriously.

However, Duterte told reporters later on Saturday: "Thinking and talking about it is different from actually doing it," adding that there was already a threat to her life.

"When that happens, there will be

an investigation on my death. The investigation on their deaths will be next."

Duterte and Marcos were once political partners who won an overwhelming mandate to lead the nation's top two offices in 2022. The alliance crumbled this year over policy differences, including foreign policy and former President Rodrigo Duterte's deadly war on drugs.

Marcos' congressional allies are separately investigating the elder Duterte's war against drugs that led to more than 6,000 killed in anti-drug operations and alleged corruption over the younger Duterte's use of public funds during her tenure as education secretary. Both have denied wrongdoing. – Reuters

Survivors and sniffer dogs join anti-mine march

SIEM REAP: Survivors and sniffer dogs joined hundreds of people at Angkor Wat yesterday for a march against landmines after the US decision to send anti-personnel mines to Ukraine.

anti-personnel mines to Ukraine. Participants, including landmine victims and deminers, repeatedly chanted for "a mine-free world" during the 4km walk around the famed temple complex in Siem Reap.

The march was held a day before an anti-landmine conference convenes in Cambodia, which is awash in unexploded ordnance.

Hundreds of delegates are expected in Siem Reap to assess progress on the 1997 Anti-Personnel Mine Ban Treaty, which neither Russia nor the United States are party to.

The march and conference come

after Washington announced this week that it would send anti-personnel landmines to Ukraine in a major policy shift that was criticised by human rights campaigners.

Landmine victims said they fear the casualties that could come of the decision.

"There will be more victims like me. I am sad and feel shocked," said Horl Pros, a former soldier who lost his right leg to a landmine in 1984.

When asked about the supply of US mines to Ukraine, Vice-President of the Cambodian Mine Action and Victim Assistance Authority Ly Thuch said: "We regret that any country, any people continue to use landmines. Anti-personnel mines are not good for our humanity." – AFP

Developing nations blast US\$300b climate deal

Trump pledges to remove US from pact

BAKU: Countries at the COP29 summit in Baku adopted a US\$300 billion (RM1.3 trillion) a year global finance target yesterday to help poorer nations cope with impacts of climate change, a deal its intended recipients criticised as woefully insufficient.

Some delegates gave the deal a standing ovation in the COP29 plenary hall. Others $lambasted \, we althy \, nations \, for \, not \, doing \, more$ and criticised the Azerbaijan host for hurriedly gavelling through the contentious plan

"I regret to say that this document is nothing more than an optical illusion," Indian delegation representative Chandni Raina told the closing session of the summit, minutes after the deal was gavelled in. "This will not address the enormity of the

challenge we all face. Therefore, we oppose the adoption of this document." UN climate chief S Stiell

Simon

acknowledged the difficult negotiations that led to the agreement but hailed the outcome as an insurance policy for humanity.

The agreement would provide US\$300 billion annually by 2035, boosting rich countries' previous commitment to provide US\$100 billion per year in climate finance by 2020. That earlier goal was met two years late, in 2022, and expires in 2025.

The summit cut to the heart of the debate over financial responsibility of industrialised countries - whose historic use of fossil fuels has caused the bulk of greenhouse gas emissions – to compensate others for worsening damage from climate change. It also laid bare divisions between wealthy

governments constrained by tight domestic budgets and developing nations reeling from corruption.

Yesterday's deal failed to set out detailed steps for how countries will act on last year's UN climate summit pledge to transition away from fossil fuels and triple renewable energy capacity this decade.

roster of countries required to contribute - about two dozen industrialised countries, including the US, European nations and Canada - dates back to a list decided during UN climate talks in 1992.

European governments have demanded others contribute, including China, the world's second-biggest economy, and oil-rich Gulf states.

The agreement includes a broader goal of raising US\$1.3 trillion in climate finance annually by 2035 – which would include funding from all public and private sources and which economists say matches the sum needed to address global warming.

Countries also agreed on rules for a global market to buy and sell carbon credits that proponents say could mobilise billions more dollars into new projects to fight global warming, from reforestation to deployment of clean energy technologies.

Securing the climate finance deal was a challenge from the start.

Donald Trump's US presidential election victory this month has raised doubts that the world's largest economy would pay into any climate finance goal. Trump has called climate change a hoax and promised to again remove the US from international climate cooperation. - Reuters



Protest forces coal ship to abort port call

SYDNEY: A climate change protest off the coast of New South Wales state forced an inbound ship to turn back from the country's largest terminal for coal exports yesterday, the port operator said.

New South Wales police said 170 protesters were arrested yesterday for refusing to move from the shipping channel near the Port of Newcastle.

The port, some 170km from the state capital Sydney, is the largest bulk shipping port on Australia's east coast.

A Port of Newcastle spokesperson said disruption due to the protest was "minimal" but that an inbound vessel "aborted due to people in the channel and has been rescheduled to come

Port operations would continue as normal if police were able to keep the shipping channel clear, he said. Police said the harbour remained open despite "some serious disruptions".

The climate activist group Rising Tide, which organised the 50-hour protest that started on Friday, said the vessel forced to turn around was a coal ship.

Three people were arrested on Saturday after being removed from the water.

Climate change is a divisive issue in Australia, the world's second-biggest exporter of thermal

coal and the largest exporter of coking coal. A similar protest in November last year disrupted operations at the Port of Newcastle, forcing all shipping movements to cease temporarily. – Reuters

Misinformation fine plan abandoned

SYDNEY: Australia's government said yesterday it had dropped plans to fine internet platforms up to 5% of their global revenue for failing to prevent the spread of misinformation online. The Bill was part of a wide-ranging regulatory crackdown by Australia, where leaders have complained that foreign-domiciled tech platforms are overriding the country's sovereignty, and comes ahead of a federal election due within a year.

"Based on public statements and engagements with Senators, it is clear that there is no pathway to legislate this proposal through the Senate," Communications Minister Michelle Rowland said in a statement.

Rowland said the Bill would have "ushered in an unprecedented level of transparency, holding big tech to account for their systems and processes to prevent and minimise the spread of harmful misinformation and disinformation online". Some four-fifths of Australians wanted the spread of misinformation addressed, said the minister, whose centre-left Labor government has fallen behind the conservative opposition coalition in recent polling.

The Liberal-National coalition, as well as the Australian Greens and crossbench senators, all opposed the legislation. - Reuters

US charges linked to only one contract, says Adani CFO

NEW DELHI: A US bribery indictment of Indian billionaire Gautam Adani is linked to one contract of Adani Green Energy that makes up some 10% of its business, and no other firms in the conglomerate are accused wrongdoing, the group's CFO said on

Saturday. On Wednesday, Gautam Adani, one of the world's richest men, and seven others were indicted for fraud by US prosecutors over their alleged róles in a US\$265 million (RM1.2 billion) scheme to bribe Indian officials to secure power-supply deals.

Adani has denied all allegations calling them "baseless".

Group CFO Jugeshinder Singh sought to defend the allegations on Saturday saying none of Adani's 11 public companies "are subject to indictment" or "are accused of any wrongdoing in the said legal filing". The allegations in the US

indictment relates to "one contract of Adani Green, which is roughly 10% of overall business of Adani Green", Jugeshinder said on X. The US prosecutor charges are the

biggest setback for India's US\$143

billion Adani Group, which was last year hit by Hindenburg Research's allegations of improper use of offshore tax havens, claims the company denied.

The US indictment has already had significant impact on the business. The group entity's shares have plummeted, some global banks are considering temporarily halting fresh credit to Adani and Kenya has cancelled two deals with Adani worth over US\$2.5 billion. Adani, which has several other global projects, is also charged with misleading US investors

about Adani Green's compliance with antibribery principles and laws. Jugeshinder said on Saturday they became aware of the "specificity" of the US charges only two days ago.

"We were aware that something is afoot," he said, adding the company disclosed as much to investors in its US\$750 million 2024 bond offering, about US\$175 million of which was raised from financial institutions in the United States.

The US indictment, however, says the bond offering "contained false and misleading assurance about, among other things, the Indian Energy Company's (Adani Green's) 'corporate governance' and touted maintaining transparency and compliance in every aspect.

The charges also put the spotlight on Sagar Adani, a director at Adani Green and millennial scion of the company who kept track of alleged bribes to Indian officials on his mobile phone.

Jugeshinder said the group would make a more detailed comment once it has legal approval as the matter is before the courts. - Reuters

55 killed in Beirut airstrikes

Saza offensive claims 19 more lives

BEIRUT: Lebanon said Israeli air strikes on Saturday killed more than 55 people, many of them in central Beirut, as Israel's defence minister vowed decisive action against Hezbollah in a call with his US counterpart.

On Israel's second front, the more than 13-month war with Hamas in Gaza, rescuers said pre-dawn Israeli air strikes and tank fire killed 19 people and wounded more than 40.

Hamas' armed wing said an Israeli hostage, captured during the group's attack in October last year which triggered the war, had been killed. Israel's military said it could neither "confirm nor refute" the claim.

After nearly a year of limited cross-border exchanges of fire, in which Lebanon's Hezbollah said it was acting in support of Hamas, Israel escalated airstrikes against Hezbollah targets in Lebanon on Sept 23.

A week later it sent in ground troops to southern Lebanon.

One strike on Saturday in the heart of Beirut brought down a residential building and jolted residents across the city.

The strike on the working-class Basta neighbourhood killed at least 20 people and wounded 66, Lebanon's Health Ministry said in a revised toll.

"We saw two dead people on the ground ... The children started crying and their mother cried even more," said Samir, 60, who lives in a building facing the one destroyed.

The attack in the capital was followed by others in the city's southern suburbs after calls by the Israeli military to evacuate.

Israel has not commented on the strike in central Beirut but said it had again hit Hezbollah targets in the city's southern suburbs, a stronghold of the group.

A military statement said that over the past week, the air force "struck dozens of Hezbollah command centres, weapons storage facilities, and terrorist infrastructure in the Dahieh area".

A Lebanese security source said the central Beirut strike had "targeted a leading Hezbollah figure", but a Hezbollah lawmaker, Amin Sherri, denied to Lebanese media that any official was present at the time of the attack.

carried out Similar strikes without warning outside of Hezbollah's traditional bastions, which include southern Beirut but not the centre, have tended to target senior figures.

The Health Ministry said Israeli airstrikes also hit eastern Lebanon, killing 24 people including 13 in the town of Shmostar overlooking the Bekaa Valley, another Hezbollah stronghold.

In Lebanon's south, at least 14 were killed including five in the oastal city of Tyre, the ministry said.

In a telephone call with Israeli Defence Minister Israel Katz on Saturday, Washington's Defence Secretary Lloyd Austin "reiterated US commitment to a diplomatic resolution in Lebanon that allows Israeli and Lebanese civilians to return safely to their homes on both sides of the border", a Pentagon spokesperson said.

A spokesman for Katz said he commended the US efforts towards "de-escalation in Lebanon" and underscored that Israel would continue to act decisively in

response to Hezbollah's attacks on civilian populations in Israel". United States envoy Amos

Hochstein was in Lebanon and Israel last week, meeting both countries' senior officials, to try to negotiate an end to the war.

After talks in Beirut he said a deal was "within our grasp" but as he headed to Israel both sides put out statements that dented hopes of rapid progress.

Lebanon says more than 3,670 people have been killed in the country since October 2023. Most of the deaths have been since September this year.

Israel's military offensive in Gaza has killed at least 44,176 people, most of them civilians, according to data from the territory's Health Ministry.

In the pre-dawn darkness of Gaza on Saturday, one strike killed seven people including children at a house in the Zeitun area of Gaza City, said civil defence agency spokesman Mahmud Bassal.

AFPTV footage showed victims being brought in to Al-Ahli Arab

Hospital including a bloody and dust-covered man, as a boy on a bed beside him struggled to reach the man and called for his father.

In southern Gaza, another strike killed six people, three of them children, Bassal said, and civil defence late on Saturday said six more were killed in an airstrike in Nuseirat refugee camp, central Gaza

The United Nations and others have decried humanitarian conditions, particularly in northern Gaza

The trickle of aid entering Gaza was the principal basis cited by the International Criminal Court in the arrest warrants it announced on Thursday for Prime Minister Benjamin Netanyahu and former defence minister Yoav Gallant, alleging starvation as a method of warfare and other crimes.

Abu Obeida, the spokesman for Hamas' armed wing, said on Saturday a female hostage had been

killed in north Gaza. Israel's military said it was examining the information. - AFP

Gunman shot dead, 3 hurt in Amman shooting

AMMAN: A gunman was dead and three Jordanian policemen injured after a shooting early yesterday near the heavily fortified Israeli embassy in the capital Amman, a security source and state media said.

Police shot a gunman who had fired at a police patrol in the affluent Rabiah neighbourhood of the Jordanian capital, the state news agency Petra reported, citing public security, adding investigations were ongoing.

The gunman, who was carrying an automatic weapon, was chased

for at least an hour before he was cornered and killed just before dawn, according to a security source.

Minister Communications Mohamed Momani described the shooting as a terrorist attack that

country. He said in a statement that investigations into the incident were under way.

targeted public security forces in the

"Tampering with the security of the nation and attacking security personnel will be met with a firm response," Mohamed said, adding

that the gunman had a criminal record in drug trafficking.

Jordanian police cordoned off an area near the heavily policed embassy after gunshots were heard, witnesses said. Two witnesses said police and ambulances rushed to the Rabiah district, where the embassy is located.

The area is a flashpoint for frequent demonstrations against Israel. The kingdom has been the scene of some of the biggest peaceful protests across the Middle East over Israel's war against

Palestinian group Hamas in Gaza. Many of Jordan's 12 million

citizens are of Palestinian origin, they or their parents having been expelled or fled to Jordan in the fighting that accompanied the creation of Israel in 1948. Many have family ties on the Israeli side of the Jordan River.

Jordan's 1994 peace treaty with Israel is unpopular among many citizens who regard the normalisation of relations as betraying the rights of their Palestinian compatriots. - Reuters

Putin signs law letting fighters write off debts

MOSCOW: President Vladimir Putin on Saturday signed a law that allows those who sign up to fight in Ukraine to write off unpaid debts worth almost US\$100,000 (RM446,793).

The new legislation will be a strong motivation for some to join up, experts said, as Russia seeks new ways to recruit fighters for the nearly three-year conflict. The new legislation will allow

those who sign a one-year contract to fight in Ukraine after Dec 1 to free themselves of existing bad debts. It also covers their spouses.

The law concerns debts where a court order for collection was issued and enforcement proceedings began before Dec 1, 2024.

The total amount of unpaid debt that can be covered is 10 million rubles, around RM428,921 at current rates.

Parliament approved the Bill earlier this month.

Russia has high interest rates for loans and many Russians have almost no cash savings, although the proportion of home owners is relatively high.

"Previously (for those fighting) there was only provision for taking repayment holidays on loans," said Sergei Krivenko of advocacy group

Citizen Army Law. The legislation applies to those who are conscripted for national service and those mobilised for the "special military operation". – AFP

MOSCOW: Russia has removed a senior general in Ukraine for giving misleading reports about the progress of the war. Russian media reported that Colonel General Gennady Anashkin, the commander of the Southern Grouping, had been removed from his been removed from his command, though there was no official confirmation. Bloggers have complained about the command around Siversk where they said poorly supported Russian units were thrown into deadly battles for little apparent tactical gain. An unidentified Defence Ministry source said Anashkin had been moved as part of a "planned rotation" – Reuters of personnel.

PAKISTAN LOCKS DOWN ISLAMABAD

DOWN ISLAMABAD ISLAMABAD: Pakistan's capital was put under a security lockdown yesterday ahead of protests by supporters of jailed former Prime Minister Imran Khan calling for his release. Highways leading to Islamabad through which supporters of through which supporters of Imran, led by members of his Pakistan Tehreek-e-Insaf party, are expected to approach the city and gather near the parliament, have been blocked. Most major city roads have also been blocked while mobile phone services have been suspended. Gatherings of any sort have been banned and messaging services restricted. - Reuters

ES. ever since the licensing of tour guides was introduced in 1975 when I was automatically granted a licence. In June 1973, I entered the travel

industry by joining a tour company, and my first day was spent observing a fullday sightseeing bus tour in and around Kuala Lumpur.

On my second day, I was the tour guide for the same sightseeing tour that runs daily, as most passengers were picked up from various hotels in the city, with many of them booked by receptionists who were paid handsome commissions for making reservations by phone.

Several months later, a tour guide training course was organised by the Kuala Lumpur Tourist Association (KLTA) which I attended and easily passed

It was the seventh course conducted by KLTA, with the first in 1964.

Decades later, I was the organising chairman of tour guide courses for the Malaysian Association of Tour and Travel Agents, or Matta, and organised the 23rd Kuala Lumpur tour guide Course in 1993 and the first tour guide courses in Langkawi and Ipoh in 1994.

From 1990 to 2000, I was a part-time lecturer and examiner for tour guide courses organised bv various companies, academies and associations.

During this period and earlier, tour guide courses were largely lecturebased and on average, half the candidates failed practical tests.

After practical training was incorporated and the course duration extended, most would obtain a tour guide licence

Even so, their quality can vary greatly as it is more than memorising and sharing facts.

Their character, interpretation and communication skills are far more important.

In 1992, I managed 15 tour guides, 15 tour bus drivers and 15 tour van drivers, all full-time employees, while parttimers were regularly hired.

We were so busy that most of them worked non-stop and often pleaded to be given a rest day or a break from outstation assignments.

But over the past three decades, inhouse tour guides were few as most of them prefer to work freelance with

popular ones always in demand while those troublesome are avoided. accept The weakest ones

assignments to work as a "sitting guide to earn a living, albeit miserably.

Hiring a sitting guide is just to comply with regulations that there must be a licensed tour guide on board a tour bus with passengers. He or she would just sit in the bus like

any other passenger and another person, usually the tour leader, would play the role of tour guide.

In such an arrangement, the tour leader not only delivers the running commentaries during the sightseeing tour, he also grabs the shopping commissions normally paid to the tour guide.

Incidentally, the bus driver and the tour company may also get a share of shopping commissions. While conducting training for travel

agents and tour operators, I often pointed out that a tour guide or tour leader may earn even more from handling a tour group than the tour company that organised the group tour or handled services such as airport transfers and sightseeing tours.

In the mid-1990s, I worked for a leading outbound tour company and their tour leaders doubled up as tour guides while the tour bus traversed several European countries.

These tour leaders cum tour guides received huge commissions from shopping and introducing various services

Recently, the Malaysian Tourism Federation questioned the requirement for tour buses to be accompanied by a licensed tour guide, even though hire and-drive passenger vans and multi-purpose vehicles used for e-hailing were exempted and their drivers often act as tour guides.

Meanwhile, Kota Kinabalu Warisan information chief Samuel Wong stirred

local sentiments by asking whether the RM5.62 billion in tourism revenue for the first nine months of 2024 in Sabah had benefited foreign industry players more than Sabahans.

He pointed out that there are numerous foreign-owned tour agencies, hotels, restaurants and tour guide services in the state and asked whether regular checks are conducted on illegal vans, Grab drivers and even Airbnb hosts offering unlicensed tour services

Now, back to the heading: Must there be a tour guide on board a tour bus with passengers?

It will be a resounding yes from the Malaysian Tourist Guides Council and all the respective state tour guide associations plus sympathisers in the Tourism, Arts and Culture Ministry.

It will be a big no from the Malaysian Tourism Federation and all the travel associations, as their members are from travel and tour companies. This argument has been ongoing for

many years and it is just a matter of time before the powers that be finally act to

change for the better. Ultimately, customers should have the biggest say regarding the compulsory use of tour guides.

If they want a knowledgeable tour guide conversant in their language, then they ought to be given the best available so that they enjoy the tour and have a great memory of their stay. But if they do not wish to pay a few

hundred ringgit a day for the service of a tour guide, then it is unfair to impose on them.

We hardly see Malaysians travelling on their own in tour buses on domestic tour packages as they are sensitive to extra costs such as paying for a tour guide.

There are also instances when a tour guide is not wanted. For example, privacy is needed when a group of corporate executives is on a field study trip and wishes to discuss freely on board without an outsider observing intently or eavesdropping on their plans and strategies.

Some years ago, I witnessed the Tourism Malaysia director-general flatly refusing to reconsider by hanging on to what he had picked up decades ago that tour guides can make or break a tour.

That was true before the new millennium when outbound tour operators held sway.

This was because they decided which destinations to be included in their thick tour catalogues and their customers could only visit countries that were included.

But in the new millennium, the majority of travellers do not join tour groups and can easily book airline tickets on their own.

The do-it-yourself arrangements can practically cover all other services such as airport transfers, accommodation at short-term hotels or rental accommodations, road, rail and ferry transport, food and beverage, entrance tickets and entertainment, and navigation using smartphones.

Soon, there will be apps for tourists to buy premium, standard or budget allinclusive travel packages, allowing customers the option to book services on the spot, as done in e-hailing, without the risk of incurring cancellation charges if booked in advance and then unutilised.

With continued advancement and adoption of artificial intelligence, the need for tour operators and tour guides will be further reduced.

With rapid changes taking place, it would be impossible to keep pace if the ministry and industry were to keep holding on to antiquated laws and mindsets.



A self-assessment system is much more onerous on the taxpayer because the burden of understanding tax laws and complying with regulations now lies totally with the taxpayer. Ignorance of the law cannot be used as an excuse, and it is expected that either the taxpayer understands the laws, rules and regulations, or obtains the necessary advice to guard against any misreporting. Self-assessment started

in Malaysia in the early 2000s, beginning with corporates and con-tinuing in 2024 for the 🛷 Capital Gains Tax. In 2025, this will be extended to Real Property Gains Tax (RPGT).

The Inland Revenue Board (IRB) has done a good job so far in supporting the self-assessment system by providing guidance to taxpayers and tax advisers on how the various laws should be interpreted. This has been done

through public rulings, guidelines, practice notes, etc.

Despite the IRB giving its views on how the laws should be interpreted, a taxpayer may not necessarily

agree with the positions taken by the board. The taxpayer would look at the law and pay only the minimum amount of tax that is required to be paid under the legislation. The IRB may take a different position to collect the tax. Both

parties may have merits to support their respective positions, but since the IRB has the power to issue the assessment, the winner in such battles is the IRB and this can only be resolved after paying the taxes and taking the matter to court.

With the introduction of the selfassessment system for RPGT filings, we anticipate many battles, and the biggest one will be whether the transaction will be subjected to RPGT or income tax. It is very common for taxpayers to argue that their property is of an investment nature, which should be taxed as a capital gain rather than income tax, while the IRB has a tendency to argue otherwise and bring it to income tax. The dispute is based on what are the characteristics of the transaction and, in technical terms, it comes under what we call "badges of trade'

The other common problem that will arise is when you are dealing with Real Property Company (RPC) shares. Although the legislation around RPC shares is contained in a single Paragraph 34A, the treatment

of this issue is very complex, and the disputes that will arise in an e-filing will increase since the interpretation of the law by the IRB and taxpayers will be very different, and an example will be the treatment of bonus shares, rights issues, the determination of an RPC, and the related complexities around this legislation.

Similar problems will also arise in determining the acquisition costs and disposal values. This is a complex piece of legislation that deals with exchanges of properties, how trustees and executors should be dealing with the properties, issues around leases, contingent liabilities and options, etc.

How to avoid the problems When taxpayers prepare their RPGT returns, they need to exercise

extreme vigilance in filling in the right information and understanding the law. Since taxpayers do not file these returns on an annual or regular basis, it is advisable for taxpayers to appoint professionals to file their RPGT returns.

In the event a taxpayer takes a position that is challenged by the tax authorities, the taxpayer must be prepared with the necessary evidence that will dovetail with the supporting law.

We anticipate a significant increase in the number of challenges from the IRB with the introduction of the self-assessment system for RPGT.

Embrace AI as tool for innovation and growth'

KUALA LUMPUR: Businesses need to embrace artificial intelligence (AI) as a tool for innovation and growth, despite ongoing concerns about the technology's potential risks, experts said.

Universiti Putra Malaysia Putra Business School Professor Dr Ida Md Yasin said AI can bring more benefit than harm if understood and managed properly.

She said humans cannot stop many of the changes happening around them, including AI.

"Since it's already part of our world through digitalisation, we need to embrace it, even if it scares us," she told SunBiz.

Ida acknowledged that people fear AI will take jobs, enable creation of fake content, as well as lead to fraud.

"But we can overcome these fears through knowledge and learning," she said, adding that "if we learn more about AI, we understand its dos and don'ts - what we should and shouldn't do".

This understanding, Ida said, makes us more comfortable with Al. "That's what I mean by embracing AI. We can't ignore it," she explained.

Ida drew a parallel to the initial fear surrounding globalisation. "People initially feared that globalisation would take away jobs and harm us," she said. "But ultimately, by embracing it, we learned what to do and not



do, and we benefited."

Al is no different, Ida said. "Although we're afraid, if we learn what AI is about, its limitations, and its advantages, we can see that it can bring more benefit than harm."

With any decision, there are always positive and negative implications, she stated. "There's rarely a straightforward answer. We need to weigh the outcomes - if the positives outweigh the negatives, pursue it; if not, reconsider."

Ida likened AI to a knife in the household. "A knife can be used for good or bad. You need it to prepare food, but it can also cause harm. It's how we handle it that matters."

Universiti Teknikal Malaysia Melaka senior lecturer Siti Nurul Mahfuzah Mohamad noted that AI has been around for a long time, although awareness among businesses about the technology is just catching up.

"We already use AI in many areas. Vehicles like Tesla, robotics in factories. manufacturing, and education. For business, healthcare, and other industries, AI is prevalent," she said.

In business, for example, companies use AI for trend prediction and strategic planning. 'They can use technology for predictions or social media, video editing, and marketing," she added.

Mahfuzah said AI supports rather than replaces human jobs. "Humans bring unique expertise and intelligence," she explained, referring to subject matter expertise. "Each person has their own strengths, whether visual, linguistic, or interpersonal. Students, for instance, might use generative AI tools to support different skill areas, like math or presentation.

Al, she said, is just a tool that assists based on the user's needs. "Each user's behaviour and interests shape their use of AI. Generative Al learns user preferences based on search history and interactions."

For journalists, educators and leaders, Mahfuzah noted, they all have specific platforms tailored to their fields that can support their work.

"Everyone needs to be aware of technology advancements. We can't reject technology; instead, we should use it ethically and responsibly. Content should be verified and, when needed, approved by management. Let's focus on positive uses rather than fearing the negatives."

Google, Microsoft applaud M'sian approach to building AI infrastructure

KUALA LUMPUR: Google has applauded Malaysia's approach to building artificial intelligence (AI) infrastructure under the leadership of Prime Minister Datuk Seri Anwar Ibrahim.

Google vice-president of government affairs and public policy Karan Bhatia said in the recent Apec Summit in Peru that the approach to building such infrastructure was the reason Google is investing US\$2 billion (RM8.9 billion) in a data centre in Malaysia.

In May 2024, Google announced the investment of US\$2 billion in Malaysia, including the development of its first data

centre in the country and a Google Cloud region to meet the growing demand for cloud services locally and around the world, as well as AI literacy programmes for students and educators. Google's investment is expected to generate over US\$3.2 billion in economic impact and create 26,500 jobs by 2030. Meanwhile, Microsoft vice-president of

data and AI Zia Mansoor praised Malaysia's efforts with the National Artificial Intelligence Roadmap that has been created. "It's very comprehensive. It's looking at the AI infrastructure. It's looking at skilling. How are vou skilling all Malaysians around Al

technology?" he said at the Apec CEO Summit Peru 2024 held recently.

He added that the roadmap creates an AI centre of excellence in the government, in which the government uses AI technology. "To me, those are such important conditions,

On Nov 15, Anwar held a discussion with Google in the capital of Peru, focusing on data centres and Al. He said that appropriate attention needs to be given to strengthening the AI and data centre ecosystem, especially in terms of the relevant rules and regulations to prevent data leakage and exploitation with malicious intent. - Bernama

Increase driven by food & beverages and personal care

PUTRAJAYA: Malaysia's inflation inclined to 1.9% in October 2024 with the index points standing at 133.4 as against 130.9 in the same month of the previous year.

The increase of inflation in October 2024 was driven by the higher increase in the main groups of food & beverages (2.3%) and personal care. social protection & miscellaneous goods & services (3.4%)

Meanwhile. restaurant & accommodation services (2.8%); recreation, sport & culture (2.0%); health (1.4%); transport (0.7%) and furnishings, household equipment & routine household maintenance (0.5%) increased at a slower rate.

Chief Statistician Malaysia, Datuk Sri Dr Mohd Uzir Mahidin informed that inflation for information & communication decreased to negative 1.7% in October 2024 (September 2024: 0.4%). This was due to the decline in inflation for main subgroup of information communication services at negative 1.8% (September 2024: 0.8%).

Clothing & footwear remained at a negative territory and posted negative 0.2%

Meanwhile, housing, water, electricity, gas & other fuels (3.1%); education (1.5%); alcoholic beverages & tobacco (0.8%) and insurance & financial services (0.5%) increased at the same rate as the previous month.

The food & beverages group which contributes 29.8% of the total CPI weight increased by 2.3% in October 2024 (September 2024: 1.6%). The main subgroup of food at home increased by 0.6% (September 2024:



0.4%) mainly due to the inflation in the expenditure class of meat which recorded an increase of 1.4% (September 2024: 0.7%).

Chicken as the largest component (32.6%) in the expenditure class of meat recorded an increase of 3.6% (September 2024: 1.3%). Based on data collected by Department of Statistics, Malaysia (DoSM), the average price of standard chicken in Malaysia for October 2024 was compared to kilogra kilogramme as RM10.02 per kilogramme in October 2023

(September 2024: RM10.47).

Meanwhile, the average price of standard chicken in Peninsular for October 2024 was Malaysia RM9.68 per kilogramme as compared to RM9.32 per kilogramme in October 2023 (September 2024: RM9.38).

Inflation for the expenditure class of vegetables recorded an increase of 2.7% in October 2024 (September 2024: 1.9%). Among the vegetables that recorded a significant year-on-year increase in October 2024 were french beans, 9.8% (September 2024:

-1.9%), long cabbage, 9.5% (September 2024: 6.1%) and green spinach, 9.0% (September 2024: 4.6%)

The weather uncertainties in the main planting areas are also affecting the current supply in the domestic market. This is due to the high rainfall since the end of September 2024, which resulted from the monsoon transition phase, impacting crops and also agricultural activities.

According to the Malaysian Meteorological Department, the monsoon transition phase will continue until early November 2024 and it is expected that the prices of certain vegetables will remain high.

Besides, the main subgroup of Food away from home edged up to 4.1% as compared to 2.8% in the previous month. Among the items that recorded a higher increase in October 2024 were pizza, cooked chicken and cooked fish.

inflation Furthermore, for transport eased to 0.7% in October 2024 as compared to 1.1% in September 2024. The increase was contributed by the main subgroup of operation of personal transport equipment which increased to 1.0% in October 2024 (September 2024: 1.4%).

Among the items that recorded a lower increase were diesel, 15.0% (September 2024: 16.7%). In October 2024, the average price for diesel in Peninsular Malaysia was RM2.95 per litre as compared to RM2.15 per litre in October 2023 (September 2024: RM3.04). However, the average price of diesel for Sabah, Sarawak and Wilavah Persekutuan Labuan remained at RM2.15 per litre.

In addition, the average price of Unleaded petrol RON97 in October 2024 decreased to RM3.19 per litre as against RM3.47 per litre in October 2023 (September 2024: RM3.28).

Mohd Uzir said that with regards to inflation at the state level, most of

the states recorded increases below the national inflation level of 1.9%. However, inflation for four states were above the national inflation level namely Penang (3.1%), Pahang (2.7%), Selangor (2.3%) and Sarawak (2.1%)

All states registered an increase in the inflation of food & beverages.

The highest rate was recorded by Selangor at 3.8%, followed by Wilayah Persekutuan Putrajaya (2.9%), Johor (2.4%), Penang (2.4%) and Pahang (2.3%).

Meanwhile, other states showed an increase below the national inflation of food & beverages of 2.3% in October 2024.

The overall monthly inflation for October 2024 increased to 0.2% as against in September 2024. This was driven by the increase in

the main groups of food & beverages (0.8%), followed by personal care, social protection & miscellaneous goods & services and education that recorded an increase of 0.2% in

October 2024 respectively. However, this was offset by a decline in the information & communication group (-2.1%); transport (-0.2%); furnishings, household equipment & routine household maintenance (-0.1%) and recreation, sport & culture (-0.1%).

Meanwhile, core inflation increased at the same rate at 1.8% in October 2024 as compared to September 2024.

The increase was due to personal protection social care, & miscellaneous goods & services (3.4%); food & beverages (3.2%) and restaurant & accommodation services (2.8%).

In comparison to inflation in other selected countries, inflation in Malaysia (1.9%) was lower than inflation in Vietnam (2.9%) and Philippines (2.3%). However, the rate was higher than Indonesia (1.7%), Republic of Korea (1.3%), Thailand (0.8%) and China (0.3%).

PKNS to launch 12 property projects in 2025

CYBERJAYA: The Selangor State Development Corporation (PKNS) is set to launch about 12 projects with a gross development value (GDV) of RM1.5 billion in 2025, reflecting its commitment to advancing Selangor's property market, said group CEO Datuk Mahmud Abbas.

Speaking at the PKNS Pilih Karnival at Selangor Cyber Valley (SCV) here on Saturday, he said six projects are slated for launch in the first half of 2025, followed by another six in the latter half.

affordable They include apartments priced between RM300,000 and RM400,000 each that cater to young buyers or smaller households, he said.

Meanwhile, the Aludra Residensi townhouses, priced at RM500,000, offer flexibility with a bundled option of a larger unit priced at RM1 million, providing 2,000 sq ft of living space. "For those seeking high-end

homes, we have Azhara, designed for larger families and offering upgraded features. We aim to accommodate people at different life stages - those who are single, families with one child, or even larger families," he added.

The ongoing PKNS Pilih Karnival serves as a platform to promote the corporation's projects and create awareness about its transformation in property development.

This carnival highlights how PKNS has transitioned into a developer of mid-tier and high-end housing while continuing to uphold its commitment to community needs," Mahmud said.

Moving forward, PKNS plans to

KUALA LUMPUR: Bumi Armada Bhd, reported group revenue of RM551.9 million for the third quarter (Q3) 2024 financial results, lower compared to the previous quarter mainly due to lower revenue from a variation order for Armada Olombendo FPSO and the weakening of the US dollar against the ringgit.

Group net profit of RM211.3 million for Q3 2024 was also solid, however, it decreased compared to Q2 2024 mainly due to foreign exchange losses translation from arising of intercompany balances and fixed deposits denominated in foreign currency and lower share of results of joint ventures and associates.

The group returned to a net current asset position of RM1,050.4 million as at Sept 30, 2024 following the successful refinancing of the sukuk murabahah loan of RM1.5 billion via syndicated facilities with a six-year tenor at an aggregate amount of up to US\$400 million (RM1.6 billion).

The proceeds from the facilities the were applied towards

redemption and settlement of the sukuk murabahah loan and all its related cross currency and interest rate hedge liabilities.

Huawei to mass-produce newest AI chip in early 2025

Telecoms conglomerate is a focus of bitter US-China trade and security tensions

BEIJING: China's Huawei plans to start mass-producing its most advanced artificial intelligence chip in the first quarter of 2025, even as it struggles to make enough chips due to US restrictions, said two people familiar with the matter.

The telecoms conglomerate has sent samples of the Ascend 910C – its newest chip, meant to rival those made by US AI chipmaker Nvidia – to some technology firms and started taking orders, the sources told Reuters. Huawei is at the heart of US-China friction

over trade and security.

Washington has imposed a series of curbs on Huawei and other Chinese companies, arguing that their technological progress poses a national security risk to the US.

Beijing, which is trying to make the world's second-biggest economy self-sufficient in advanced semiconductors, denies such claims. The restrictions have hampered Huawei's ability to get the yield - the proportion of chips that come off the manufacturing line fully functional – of its advanced AI chips high

enough for them to be commercially viable.

The 910C is being made by top Chinese contract chipmaker Semiconductor Manufacturing International Corp (SMIC) on its N+2 process, but a lack of advanced lithography equipment has limited the chip's yield to around 20%, said one source who was briefed on the results.

Advanced chips need yields of more than 70% to be commercially viable.

Even Huawei's current most advanced processor, the SMIC-made 910B, has a yield of only around 50%, forcing Huawei to slash production targets and delay filling orders for

that chip, the sources said. TikTok's Chinese parent, ByteDance, ordered more than 100,000 Ascend 910B chips this year but had received fewer than 30,000 as of July, a pace too slow to meet the company's needs, Reuters reported in September.

Other Chinese technology companies that have ordered from Huawei have complained of similar problems, sources have said.

US curbs include barring China since 2020 from obtaining extreme ultraviolet lithography (EUV) technology from Dutch manufacturer ASML, used to make the world's most sophisticated processors.

"Huawei knows there is no short-term solution, given the lack of EUVs, so it will give priority to strategic government and corporate orders," the source said.

ASML has also stopped shipping its most advanced deep ultraviolet lithography (DUV) machines to China due to rules imposed by US President Joe Biden's administration last year. Some fabs have also been restricted from

buying older ASML DUV models

SMIC demands a premium of up to 50% for chips made on its advanced nodes, which are less advanced than those of Taiwanese chip-making giant TSMC, and are made using enhanced ASML DUVs.

Huawei has supplemented its SMIC-made chips with ones made by rival TSMC, according

to analysts and sources. TSMC notified the US Commerce Department several weeks ago that one of its chips had been found in a Huawei 910B process. The US has placed Huawei on a trade list that

requires suppliers to obtain licenses to ship any goods or technology to the company.

Washington has since clamped down further, ordering TSMC to halt shipments of advanced AI chips to Chinese customers, in a move targeting the diversion of chips to

US authorities are planning export controls on the semiconductor industry that will further restrict shipments for Chinese firms.

Donald Trump, who was president from 2017 to 2021 and will return to the White House in January, has made tough-on-China trade policies core to his economic agenda. - Reuters

China EV maker Xpeng expected to break even later next year

SHANGHAI: Chinese electric car maker Xpeng is expected to break even sometime later in 2025, its president Brian Gu said, betting that strong demand for its new models and expanding into new overseas markets will improve its profitability.

Meeting the goal Xpeng first set in 2023 could make it the first China automaker to turn profitable mainly on EV sales.

Rivals BYD and Li Auto are profitable but they rely on hybrids for the majority of total car sales.

"I think we are indeed entering the super cycle," said Gu in an interview with Reuters by phone.

"I think sometime in next year. probably towards the later part or the end of next year, we will see as reaching the break even point.

"We are in a very confident position to see that becomes more likely.

Xpeng has forecast fourth-quarter revenue above Wall Street estimates, thanks to the introduction of new models Mona 03 and P7+.

It said the momentum will extend to the fourth guarter and 2025.

The company is also being helped by the roll-out of Chinese government subsidies of up to US\$2,800 (RM12,500) each for trading in older cars for EVs and more fuel-efficient cars.

Xpeng will launch four new models next year and will ramp up expansion in overseas markets apart from North America, where Chinese EVs face 100% tariffs, a de facto ban, said Gu.

Revenue from tech services, which nearly doubled in the third quarter from a year ago driven by its partnership with Volkswagen, accounted for more than 12% of Xpeng's total revenue.

The company is also working closely with Volkswagen and hopes to expand the technology service partnership with the German automaker to other areas in and outside China, Gu said. - Reuters

Thai Beverage's annual profit slips on rising marketing costs

SINGAPORE: Singapore-listed Thai Beverage reported a full-year profit last week that fell 1%, hurt by an increase in marketing costs at the company's spirits and food businesses.

Earlier this year, the company said it plans to divest its real estate assets and become a pure-play drinks and food firm.

ThaiBev, one of Southeast Asia's largest beverage makers, reported a profit attributable of 27.22 billion baht (RM4.5 billion) for the year ended Sept 30, compared with 27.43 billion baht a year earlier.

The company's spirits business reported a profit attributable of 20.77 billion baht for the year, down 6%, due to an increase in marketing costs and raw material prices.

ThaiBev's beer business reported a profit attributable that rose 10% to 2.74 billion baht.

The company, chaired by billionaire Charoen Sirivadhanabhakdi, also announced a final dividend of 0.47 baht per share for the year. - Reuters

Alibaba combines e-commerce arms

SHANGHAI: Alibaba Group will integrate its domestic Chinese and international e-commerce platforms into a single business unit run by one leader for the first time, the company said in a stock exchange filing last week.

The Alibaba E-commerce Business Group, as the unit will be called, brings together the Taobao and Tmall Group and the Alibaba International Digital Commerce (AIDC) Group.

AIDC groups cross-border player AliExpress, wholesale B2B site Alibaba.com and other regional platforms operating in different parts of the world, from Southeast Asia to Turkiye.

Its chief, Jiang Fan, a former head of Tmall demoted in 2020 after an online scandal, has

been tapped to lead the new unit, reporting to Alibaba group chief executive Eddie Wu. Wu announced the new business unit in a

letter to employees posted on Alibaba's intranet. "The e-commerce industry in China and

around the world is entering a new era, and the global supply chain capabilities, fulfillment capabilities and consumer service capabilities will determine the future competitive landscape," Wu wrote in the post, which was shown to Reuters.

Alibaba split into six business units in 2023, in the biggest revamp of its 24-year history. Prior to this latest amalgamation of two of

those groups, Wu had also been CEO of the Taobao

and Tmall Group and Alibaba's cloud division.

Alibaba's e-commerce platforms have been under pressure both at home and abroad as aggressive new players such as PDD Holdings' Chinese platform Pinduoduo and international site Temu, along with ByteDance's domestic Chinese Douyin and international TikTok, gain market share selling low-cost goods. In April, co-founder Jack Ma expressed

support for the internet giant's restructuring efforts, and acknowledged past mistakes in a

lengthy memo to employees. The turnaround efforts have seen some success, with the international division growing rapidly under Jiang's leadership. - Reuters

Uncertainty clouds US holiday shopping season

Consumers keep big spending on tight leash and vigilantly compare prices

NEW YORK: Retailers are in for a mixed holiday season this year ahead of Black Friday and Christmas, marked by watchful consumers keeping big spending on a tight leash and vigilantly comparing prices on their mobile phones to look for the best deals on apparel, electronics and toys.

Against this backdrop, bellwether Walmart lifted annual sales and profit targets last week, and said a majority of its customers were maintaining holiday plans year over year.

Walmart has managed to gain market share as its ultra-low prices on groceries and a wide range of discretionary goods attract upper-income households to its superstores. On the other hand, rival Target's forecasts

for the holiday quarter were significantly subdued, with executives saying demand remains weak for higher-margin items such as home goods and electronics.

Despite a rate cut from the US Federal Reserve, the first in four years, consumer spending on non-essential items has remained uninspiring, and industry analysts expect a deal-heavy holiday shopping season yet again.

Overall holiday shopping is expected to grow at its slowest pace in six years, according to separate reports from the National Retail Federation and Deloitte.

This year, there are just 26 days between Black Friday – which has traditionally marked the beginning of the holiday shopping period, and Christmas, compared with 31 days last year.

"The fourth quarter will be fun to watch. And the calendar is not our favourite with fewer days between Thanksgiving and Christmas. And I suspect when all that's said and done, it will be similar to the kind of momentum that we've seen in the first three quarters," said Walmart CEO Doug McMillon on a post-earnings call.

The shorter calendar prompted retailers to try and pull forward some demand earlier in the year, offering heavier discounts as early as July, around the back-to-school shopping season. Gen-Z consumers, more comfortable

shopping on phones, are driving a shift towards mobile spending, and are likely to influence families to do the same over the holidays, said Minkyung Kim, assistant professor of marketing at Carnegie Mellon University.

Mobile phones are expected to account for 53% share of online spending from November through December, reaching a total of US\$128.1 billion (RM572 billion), according to a forecast from Adobe Analytics which measures online consumer transactions from 5,000 shoppers.

Online spending growth is expected to jump to 8.4% from 4.9% last year, according to Adobe's forecast, with mobile spending growth expected to jump a "staggering" 12%. Influencers promoting brands on social

media have played a critical role in shaping consumer sentiment and shopping patterns. "I expect that trend to continue, particularly with the advancement of artificial

intelligence," Kim added. "These younger consumers are growing in their spending power and they're early in their career development, so to get them as loyalty members and familiar and comfortable regularly shopping with your brand is very important to growing revenue over time," said Wedbush analyst Seth Basham.

In fact, spruced-up loyalty programmes with perks such as same-day or free delivery, personalised marketing and quicker check-outs at stores allowed Target and Walmart to induce an early splurge during back-to-school shopping, and the retailers plan to continue to make these programmes more appealing as holidays approach.

Target's 20% growth in same-day delivery, driven by its refurbished rewards programme, contributed to double-digit growth in digital comparable third-quarter sales – one of the only bright spots for Target this year.

Walmart also began offering its US\$98 Walmart Plus membership at about half price from Oct 28 through Dec 2, and reported a fourth straight quarter of double-digit growth in global membership income.

"The big change that we'll concentrate on this holiday is how much fight there will be for that new incremental customer. I think because of that you'll see increased targeted promotions just try to get new customers at an accelerated rate," said M Science analyst John Tomlinson. – Reuters

Enriching Lives The Smarter Way UK antitrust regulator to rethink remedies in growth drive

LONDON: Britain's antitrust regulator said last week it would focus on "truly problematic mergers" and rethink its approach to agreeing remedies that could allow more deals to go ahead to support the government's growth mission.

The Competition and Markets Authority (CMA) was singled out by Prime Minister Keir Starmer last month when he promised to scrap regulation that was holding back economic growth. Speaking to investors, he said: "We will make

Speaking to investors, he said: "We will make sure that every regulator in this country – especially our economic and competition regulators – takes growth as seriously as this room does."

CMA CEO Sarah Cardell said the regulator must "evolve" while staying true to its mandate to promote competition for the benefit of consumers.

"We must deliver a regime that leaves no one in any doubt that the UK is open to business," she said at the Chatham House Competition Policy 2024 Conference.

She said the goal was simple – every deal that was capable of being cleared either unconditionally or with effective remedies should be.

"Only a truly problematic merger, where the harm to businesses and consumers cannot be effectively addressed through remedies, should not proceed," she said.

The CMA has played a bigger role in merger control since Britain left the European Union. It blocked Microsoft's US\$69 billion (RM308 billion) acquisition of Activision Blizzard in 2023 before it reversed its decision after the companies offered concessions.

After facing criticism over the case, the CMA announced an overhaul of its merger assessment. – Reuters

Deere forecasts weak annual profit as farm incomes sag

NEW YORK: Deere & Co forecast lower-than-expected 2025 profit last week, as slumping farm incomes and inflationary pressures affect demand for the company's tractors and other agricultural equipment.

A decline in farm incomes, high interest rates and an uncertain economy have compelled farmers to reassess large expenses on agricultural machinery and forced dealers to limit inventory restocking.

US farm income is expected to fall for a second consecutive year in 2024, as farmers grapple with corn and soybean prices hovering near four-year lows.

"Amid significant market challenges this year, we proactively adjusted our business operations to better align with the current environment," CEO John May said.

For 2025, Deere expects net sales to fall about 10% to 15% across all its machinery segments.

A slump in equipment volumes has also forced smaller rivals CNH Industrial and AGCO to trim their profit expectations for the rest of 2024.

The world's largest farm-equipment maker expects profit for fiscal year 2025 in the range of US\$5 billion (RM22 billion) to US\$5.5 billion, compared with analysts' average estimate of US\$5.93 billion, according to data compiled by LSEG.

The company reported a profit of US\$4.55 per share for the fourth quarter ended Oct 27, above Wall Street expectations of US\$3.87, aided by lower production expenses and cost controls.

Net sales from equipment operations fell nearly 33% to US\$9.28 billion, missing analysts' estimate of US\$9.34 billion. – Reuters

Bessent is credible, safe pick for Treasury: Experts

WASHINGTON: Hedge fund manager Scott Bessent (*pic*) is a credible, safe choice for US Treasury secretary – and one that is

likely positive for markets – observers said on Saturday following President-elect Donald Trump's highly anticipated nomination.

His selection came after competition for the top economic job spilled into the open last week, with the world's richest man Elon Musk throwing his support instead behind Trump's transition team co-chair Howard Lutnick.

Lutnick has since been named commerce secretary to lead Trump's tariff and trade agenda, and Bessent's nomination days later appears to be uncontroversial for now.

"Scott Bessent is a credible, mainstream pick for Treasury secretary," said Jason Furman, a professor at Harvard University and former top White House economic adviser.

"I could see previous administrations as having chosen him," Furman, a former chairman of the Council of Economic Advisers, told AFP.

But a key difference is that Bessent, 62, has had to adopt and defend views on topics like tariffs, in a way "he never would have in pursuit of the job for a previous Republican administration".

Tariffs are a key part of Trump's economic agenda, with the Republican president-elect vowing sweeping duties on allies and adversaries alike.

In an opinion piece published earlier this month on Fox News, Bessent defended the potential use of tariffs as a means to raise revenue for the government, protect strategic US industries and negotiate with trading partners.

Jens Nordvig, CEO of data and analytics firm Exante Data who has worked with Bessent, drew a contrast between his demeanour and that of other Trump supporters.

While some Trump allies have a tendency

towards "general sweeping statements," Bessent is an "analytical thinker, and he communicates accordingly", Nordvig told AFP.

He counts Bessent among his early clients. "I would expect his messaging to be very focused, to get his key points across, without any unnecessary flamboyance or gusto," Nordvig added of the Wall Street veteran.

Calling Bessent a "safe choice", Brookings senior fellow in economic studies David Wessel told AFP: "He will be an adult in the room for the Trump administration."

Besides Bessent, others seen as top contenders for Treasury chief in recent days included former Federal Reserve governor Kevin Warsh, Apollo Global Management chief executive Marc Rowan, and Tennessee Senator Bill Hagerty.

It remains to be seen if Bessent will be a big influence "moderating some of the Trump administration's more aggressive trade policy" or simply be a spokesman, Wessel said. – AFP

FBM KLCI seen trading in tight range of 1,600 to 1,610 points

BURSA Malaysia's benchmark FBM KLCI is anticipated to trade within a tight range of 1,600 to 1,610 points this week, with 1,600 remaining a key psychological and technical threshold, reflecting Malaysia's resilient economic backdrop. UOB Kay Hian Wealth Advisors head of investment research

Mohd Sedek Jantan said while the index had briefly fallen below the 1,600 level in recent weeks, consistent efforts to reclaim it reflect cautious optimism among market participants.

"However, momentum remained subdued, with upward movements likely to hinge on external catalysts," he told Bernama. He said Malaysia's economic fundamentals remain robust,

underpinned by steady gross domestic product growth, manageable inflation, low unemployment and resilient trade performance.

"These strengths provide a solid foundation for market stability, but they have yet to translate into significant upward momentum for the domestic equity market. As a result, the FBM KLCI's near-term trajectory continues to be influenced by global factors."

Among the global factors, the uncertainties surrounding President-elect Donald Trump's potential protectionist trade policies and the lingering impact of US-China trade tensions stand out, Mohd Sedek said.

He added that discussions at the Global Financial Leaders' Investment Summit in Hong Kong suggest a less than 60% probability of extreme tariff measures, which has somewhat alleviated fears. "However, the lack of clear policy direction and incomplete cabinet appointments in the US weigh on investor confidence. Until these issues are resolved, equity markets are likely to remain susceptible to short-term volatility," he said.

Last week, on a Friday-to-Friday basis, the FBM KLCI fell 2.66 points to 1,589.78.

Ibraco reports 24.9% y-o-y growth in PAT for third quarter

KUCHING: Ibraco Bhd, a property and construction developer in Sarawak, reported a 28.8% increase in revenue to RM 151.78 million in the third quarter ended Sept 30, 2024 (Q3'24) compared to RM117.85 million in the third quarter ended Sept 30, 2023 (Q3'23). This growth was primarily driven by the group's construction

This growth was primarily driven by the group's construction segment, which experienced a significant revenue increase of 145.5% on a y-o-y basis from RM28.95 million in Q3'23 to RM71.07 million in Q3'24 albeit lower revenue contribution from its property segment.

This notable improvement in revenue was attributable to higher revenue recognition from the government construction contracts for the current quarter. Correspondingly, the group's construction segment is now the main contributor attributing 46.8% of the group's revenue followed by property segment at 46.3% for the quarter under review.

Similarly, the group reported profit after tax (PAT) of RM16.03 million in Q3'24, reflecting a 24.9% increase compared to RM12.84 million in Q3'23.

On a q-o-q basis, the group registered a 60.7% increase in its revenue and a 146.3% increase in its PAT compared to its second quarter ended June 30, 2024 (Q2'24).

The management of Ibraco commented: "We are pleased with our performance in Q3 2024 and we expect our construction segment to grow further in line with our current outstanding order book. In addition to our upcoming property development launches for the remainder of the year, we are positively optimistic of the group's prospects."

The group declared an interim dividend of 2.0 sen per share in respect of the financial year ending Dec 31, 2024.

Ringgit expected to trade at RM4.46-4.48 against US dollar

THE ringgit is expected to remain within a tight trading range this week, moving between RM4.46 and RM4.48 against the US dollar, said Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid.

He noted that traders will closely monitor US personal consumption expenditure (PCE) data to be released this week, the Federal Reserve's preferred inflation gauge, for October.

"At the current juncture, markets anticipate the Fed will adopt a cautious monetary easing approach, factoring in possible inflationary policies from US President-elect Donald Trump next year."

Mohd Afzanizam highlighted that the 10-year US Treasury yield has risen from 4.27% during the US presidential election to 4.41%-4.42%, an increase of 14 basis points, reflecting market expectations of a more inflationary environment ahead.

For the week just ended, the ringgit was traded mostly higher against the US dollar despite ongoing concern over geopolitical tensions in Ukraine.

On a Friday-to-Friday basis, the ringgit appreciated against the US dollar to 4.4660/4720 from 4.4715/4770 a week ago. It also gained against most other major currencies. The local

It also gained against most other major currencies. The local note increased versus the euro, closing at 4.6455/6507 against 4.7224/7292 a week earlier and strengthened vis-a-vis the British pound to 5.5870/5932 versus 5.6573/6656, but it fell against the Japanese yen to 2.8906/8942 from 2.8774/8818.

The ringgit gained versus the Philippines' peso to 7.58/7.59 from 7.61/7.63, improved against the Singapore dollar to 3.3101/3141 from 3.3330/3381 on Friday last week, and edged up vis-a-vis the Indonesian rupiah to 281.2/281.7 compared to 281.6/282.2 previously. – Bernama

FOCUS Point's 9M24 results met expectations, driven by strong performance in the optical segment and improvements in the F&B wing. We expect the former to continue delivering robust performances despite soft consumer sentiment, supported by effective marketing initiatives. Concurrently, we think the F&B unit's turnaround should sustain, driven by higher orders and potential new business wins.

9M24 core earnings of MYR24m (+22.5% YoY) met 65- 66% of our and Street's full-year forecasts. Focus Point's results are in line with expectations, and we expect a seasonally strong 4Q24. YoY, 9M24 sales rose 11.7% to MYR209.1m – contributed by

YoY, 9M24 sales rose 11.7% to MYR209.1m – contributed by growth in both the optical (+13.4%) and F&B (+5.4%) segments. The former's performance was fuelled by network expansion – with four new owned stores and two franchised outlets (totalling 198 stores) – alongside >10% SSSG. The F&B segment benefitted from increased corporate customer orders.

4Q24F net profit should pick up, in our view, due to better seasonality from year-end festivities and school holidays. Beyond the immediate term, the optical segment is poised for continued strong topline growth, supported by effective marketing strategies, a growing myopic population, and expanding store network. In the F&B segment, the group has increased stock keeping unit or SKU offerings to Family Mart to 20 items from 13 since June, which we think will help boost central kitchen utilisation – this is given Family Mart's extensive store network. Focus Point is also testing products at one ZUS Coffee outlet, and is awaiting feedback for a potential broader rollout.

AEON Co's 9M24 results were in line with expectations, with a stronger 4Q24 anticipated. Property management segment (PMS) should continue to be the key growth driver, supported by above-industry rental reversions following mall refurbishments, tenant mix optimisation, and ongoing mall expansions. Current valuation is attractive, with AEON well-positioned to capitalise on positive sector developments and on track to achieve a record year.

9M24 core profit of MYR104m (+26.5% YoY) came in at 66-69% of ours and Street's full-year estimates. The results are deemed within expectations, as 4Q24F should see seasonally stronger results.

YoY, 9M24 sales rose 3.1% to MYR3.2bn thanks to better results from both the retailing (+4.1% YoY) and property management (+9% YoY) segments. PMS benefitted from an improvement in occupancy rates and effective rental renewals, while the retailing business saw higher spending likely boosted by the restructuring of Employees Provident Fund (EPF) accounts to facilitate flexible withdrawal. 9M24 EBIT margin expanded by 0.4ppts to 7.3%, likely due to higher sales which led to operating leverage. QoQ, 3Q24 revenue fell 1.8% due to unfavourable seasonality with the absence of major festivals and lengthy holidays. 3Q24 EBIT margin shrank 1.7ppts QoQ, dragged by the retailing segment, which incurred an EBIT loss of MYR8.2m. Correspondingly, core profit dipped 32.1% QoQ to MYR18.8m.

Sales are expected to pick up in the seasonally stronger 4Q, driven by the year-end festive season, school holidays, and the earlier Lunar New Year (2024: Feb 10 vs 2025: Jan 29).

SUNWAY Construction's 9M24 core net profit of MYR98.3m (+2.3% YoY) accounts for 61% and 56% of our and Street full-year projections. However, we view results as in line as we envisage a stronger 4Q24, backed by greater progress of its jobs for data centres (DC) and Sunway. While SCGB may record lower earnings in FY24, we believe FY25F will likely be a supercharged year (53% growth) – underpinned by stronger revenue recognition from a mix of DC jobs (c.50% of outstanding orderbook).

The construction arm's PBT surged by 65% YoY in 3Q24, with a stronger margin of 8.2% (3Q23: 7%) amid accelerated progress of ongoing projects (particularly DCs).

Meanwhile, its precast segment recorded a 3Q24 PBT of MYR2m vs MYR6.5m in 3Q23, due to higher contributions from projects nearing completion a year ago.

SCGB's construction orderbook as of end-3Q24 stood at c.MYR7.1bn (end-3Q23: MYR5.8bn), with MYR4bn orders secured (vs our FY24 target of MYR4.5bn). The company has MYR10.6bn worth of active tenders comprising DC, warehousing and semiconductor facilities.

We make no changes to our earnings estimates as we deem results to be in line. This is premised on better progress in 4Q24 for its first package for the JHB1X0 DC job in Johor worth MYR1.7bn.

SCGB's ROE is significantly higher than its peers', and it is set to benefit from catalysts such as securing semiconductor-related jobs (it has yet to clinch any) and infrastructure contract wins, eg the Penang International Airport expansion and Segment 2 of the Penang LRT Mutiara Line.

"The process was challenging as I had no formal background in art or design. Instead, I dedicated countless hours to self-learning through YouTube, Google and a lot of trial and error. Once I gained some confidence in my work, I started sharing it on Instagram," said the 29year-old.

Although it took him a while, he gained traction for his 3D animations, accumulating over 22,600 followers on the platform.

Local visual development artist and illustrator Rachel Ho shares the same sentiment. The Sabah native who pursued art professionally upon graduating, grew a following after posting her drawings on Instagram and Behance.

Ho has over 13.300 followers who

shared Ho. While technology spurs the careers of rising artists such as Chris and Ho, established artists such as Syahbandi Samat have also benefited from social media exposure. His career may have started after working for the News Straits Times in 2010 but his online presence has brought more eyes to his work.

As a traditional artist, Syah utilises social media to showcase his existing works from exhibitions and gallery shows, attracting new enthusiasts who may have missed them.

"Social media is a platform where vou can showcase whatever you want without filtering from your gallery. It makes it easier for people to view your work by just sitting on their couch at home," expressed the ballpoint artist.

Bringing in clients

Having a high viewership and social following is one thing. While regular users utilise this metric for egoboosting, these criteria are necessary ingredients for content creators,

"Social media has been instrumental in unlocking countless doors for me as an artist. It has allowed me to share my artworks with a global audience, transforming my creative visions into experiences others can appreciate and engage with.

Things started to turn around for Ho too. She was quickly able to out her dreams live of **Turn to** producing illustrations for

animated films. The animation page 23 enthusiast, who was inspired by Disney's *Tangled*, got to work

with the company on two projects. "The highlight of my career so far has been my work with Disney. I was commissioned to illustrate a promotional poster for Disney's Raya and the Last Dragon and a poster for the live-action movie The Little Mermaid.'

Online troubles

The perks, however, come with a price. Once an artist starts receiving recognition, they are expected to constantly churn out content. This process, according to Chris, can take a toll on an artist's love for their craft.

This pressure can make it hard to take breaks or try new ideas without worrying about losing your audience. Ultimately, the need to stay visible can overshadow the joy of creating, making it difficult to maintain a healthy balance between sharing your work and nurturing your creativity."

Ho echoes this concern, noting how difficult it is to keep up with the pressure, especially with social media's algorithm. Ho adds on, citing plagiarism and cyberbullying as the other downsides.

"Plagiarism may come with being too visible. People online may emulate your work and style without your permission.

They also may act or comment without thinking about how their

words and actions can affect you." As for Syah, he feels social media takes out the aspect of reality or firsthand experience. Considering the nature of the medium, he said audiences are not able to interact with the art, resulting in artistic injustice or disconnect.

"There is a lack of real life interaction with the audience. You cannot view the work in real life too. The experience of viewing art on screen and in reality are two different traditional artists." for



Judging from its current influence, Ho believes it will be impossible for artists to navigate the industry without social media.

Syah, on the other hand, still believes social media is not a necessity. The 33-year-old said traditional artists who utilise physical galleries and exhibitions can draw in audiences without the help of social media.

"Some artists do not use social media as a platform to showcase their art. Yet, they still manage to gain audiences and interest. In my opinion, it is because not all art deserves to be viewed on screen.'



Consistency pays off When asked for words of wisdom, consistency and persistence emerge as the main takeaway for aspiring artists looking to be more visible online.

"Share your art regularly, even when it feels tough. Do not give up! Persistence is key to building an audience," concluded Chris.

"Keep doing your art and never stop. Build your portfolio and post your work online. Post it even if it is Syah utilises ballpoint for his drawings.

pretty. Others may find it beautiful when they view it. Art is subjective anyway," Syah expressed.

Ho, however, emphasises consistency with caution. While she preaches for it, she also hopes for artists to be mindful of their postings.


"Share your art regularly at your own pace but do not share everything online, especially (if it is) something you want to be protected. You never ٌknow how it will be used against you," Ho cautioned.

ompetition heats up

Telcos in tight race to be top network, U Mobile leads in 5G availability

Mobile continues to lead in 5G availability and its users have the best experience when playing multiplayer mobile games over 5G connections, revealed a study by independent analytics company Opensignal. "U Mobile wins the 5G Availability

award as our U Mobile 5G users spend 37.7% of the time with an active 5G connection. This is up from U Mobile's winning score of 31.9% in our last report. Digi comes in second with 36.3% and Maxis in third with a score of 35.2%," Opensignal said in *Malaysia Mobile Network Experience* – November 2024.

It added that U Mobile also wins the 5G Games Experience award with a score of 88.1 on a 100-point scale. U Mobile's score has increased by more than three points compared with that seen in the last report. Digi and Unifi share second place with statistically tied scores of 87-87.2 on a 100-point scale. U Mobile was also the 5G Global Winner for 5G Games Experience in the large land mass group in Opensignal's recent 5G Global Mobile Network Experience Awards

The government has recently given approval to U Mobile to deploy the country's second 5G network as national wholesale provider Digital Nasional Bhd now covers more than 80% of the population with 5G.

Biggest mobile players

Opensignal said as was the case in its last report, no single operator dominates Opensignal's Mobile Experience Award.

"Once again Digi and Unifi come closest, each winning five awards in total – either outright or jointly. U Mobile wins four. Maxis wins three including Consistent Quality and Reliability Experience. Celcom wins three and Yes wins two."

With speeds of up to 290.3Mbps Unifi handily won the 5G Download Speed Award, along with the 5G Video Experience Award with a score of 77.7 on a 100-point scale. This is more than two points higher than the second place finish for Digi. Maxis also became the first

Malaysian operator Opensignal's new to win Opensignal's new Reliability Experience award, along with the Consistent Quality award

In terms of overall experience,

Digi won the Voice App Experience, Download Speed Experience and Upload Speed Experience awards, beating out Celcom, Unifi and U Mobile from Opensignal's previous report.

Overall experience

Digi leads the pack by winning three key awards: Voice App Experience, Download Speed Experience and Upload Speed Experience. The operator achieved a 79.9-point score in voice quality, provided the fastest download speeds at 66.6 Mbps and delivered the highest upload speeds at 14.2 Mbps. This represents substantial improvements, particularly in download speeds in which Digi has increased by over 30 Mbps from the previous report.

Unifi has also claimed victory in the Video Experience and Games Experience categories. With a Video Experience score of 67.8 points, Unifi enables users to stream high-quality 720p videos with minimal stalling. In the Games Experience category, Unifi scored 76.6 points, indicating a highly responsive and enjoyable gaming experience with near-immediate action feedback.

Most operators fall within the "Good" or "Acceptable" performance ranges across categories. The report highlights that users can expect satisfactory streaming, gaming and communication experiences. Notable improvements were seen across the board, with operators such as U Mobile showing significant score increases, particularly in the Games Experience category.

5G experience

Unifi leads the 5G Video Experience with a 77.7-point score, narrowly beating Digi's 75.5 points. All operators fall within the "Very Good" category, enabling users to stream high-quality 1080p videos with minimal stalling. The report highlights the use of adaptive bitrate streaming technology, accurately represents re which real-world video experiences up to 4K quality. In the 5G Games Experience, U



responsiveness and minimal action delays. Meanwhile, Yes falls into the Good" category.

U Mobile also dominates the 5G Voice App Experience with 83.9

points, replacing Digi from its previous first-place position. All operators are categorised as "Good", suggesting generally satisfactory call quality with occasional minor

impairments. The 5G Download Speed category sees Unifi triumph with 290.3 Mbps, outpacing Maxis, Digi and U Mobile by 15 Mbps. Yes showed notable improvement, increasing its download speeds by 16 Mbps from

the previous report. In the 5G Upload Speed arena, Digi and Celcom share the top spot with statistically tied scores of 34.1-34.3 Mbps, followed closely by Notably, Maxis. U Mobile experienced a significant 20 Mbps drop in upload speeds.

Coverage and consistency

In terms of coverage, Celcom continues its dominance in the Coverage Experience category, securing the top spot with 8.3 points on a 10-point scale. The operator maintains a lead of two points over Maxis and Digi, which are statistically tied at 6.7–6.8 points. U Mobile, Unifi, and Yes trail behind, with Yes

occupying the last spot at 3.6 points. Interestingly, all operators share an identical 5G Coverage Experience score of 2.88 points, suggesting relatively uniform 5G coverage across

the network providers.

On which operator is the most consistent with its network, Maxis clinched the Consistent Quality award with a razor-thin margin of 67.3%, narrowly edging out Digi at 67.1%. Unifi follows in third place with 64.7% while Celcom, U Mobile and Yes complete the ranking. The most improvement comes from Celcom, which saw an impressive 18 percentage point increase from the previous report.

The Consistent Quality metric is a comprehensive assessment of network performance, evaluating the ability to support mobile application requirements across multiple download indicators including download speed, upload speed, latency, jitter, packet loss and time to first byte. Essentially, it measures whether networks can reliably support users typical demanding tasks.

Highlighting key achievements by the country's biggest mobile network players and along with evolving trends, the report showcased how operators are competing and novating connectivity.

For the methodology, Opensignal examined the mobile network experience of six main mobile operators in Malaysia over a period of 90 days from Aug 10 to Oct 29.

VER two years ago, Matt Reeves figuratively flew down from the heavens to save Warner Bros from self-cannibalising its DC Comics properties with *The Batman*. Introducing Robert Pattinson as a different, moodier take on Bruce Wayne and Batman, the film was a success and it paved the way to the upcoming *The Batman – Part II* being greenlit.

Before Pattinson returns in the sequel though, the world of *The Batman* has grown just a little bit bigger with HBO's *The Penguin*, a spinoff focusing on the titular character that was introduced in the 2022 film.

Set not very long after the climactic events of the film, *The Penguin* is an eight-episode television series that chronicles the aftermath of *The Batman*, leading into the next film set to release in 2026.

The assassination of mob boss Carmine Falcone at the hands of The Riddler leaves a power vacuum in the Gotham City crime world, with various gangs seeking to carve more than a slice of the city for themselves.

For aspiring crime boss Oswald "Oz" Cobb (Colin Farrell), or The Penguin, he dreams of nothing more than seizing control and making his mother Francis (Deirdre O'Connell) proud. However, Oz's plans are threatened when Falcone's daughter Sofia (Cristin Milioti) is released from Arkham Asylum.

Crime-fed drama

There is no doubt DC Comics's Gotham City is a festering wound. As such, there are no "good guys" in *The Penguin.* Without mincing words, it is the illegitimate comic book television-movie child of *The Sopranos* and *Breaking Bad.* Like those shows, a big part of this series's charm is its characters who are all alarmingly deplorable in their own ways.

Showrunner and creator Lauren LeFranc understands that Gotham City's criminals are at their best when they embody the duality of their city. This is how she keeps the audience perpetually engaged in a love-hate relationship with The Penguin's characters.

Oz is the best example of how LeFranc does this. Abhorrent in more ways than one, Oz is also shown to have a soft side to him whenever his mother is involved or with his protege of sorts Victor Aguilar (Rhenzy Feliz).

Even when he repeatedly gets himself into situations with no easy escape and then throws others under the bus to save his own skin, it is hard not to like Oz as Farrell's charisma naturally oozes through the fat suit, makeup and prosthetics. The same goes with Milioti's Sofia as she

The same goes with Milioti's Sofia as she flexes her acting in *The Penguin*, bringing the vulnerability of someone wrongfully thrown into an asylum, being broken psychologically and being released to carry out her menacing brand of twisted vengeance.

LeFranc's choice to go bigger with Falcone's "relationship" with women that was briefly seen in *The Batman* by weaving it into the greater tapestry of Gotham City's exploitation of them and the abetment of it by corrupt men also brings a side of storytelling to the city that has not been seen in previous DC Comics films and TV shows.

The Penguin is the right tightrope balance between uniform, stellar writing, directing and

acting across the board. Every piece of this mean machine roars and grinds together in unison to deliver the best television series of the year.

Vengeful future

For a spinoff to *The Batman*, there is almost no allusion the series makes to acknowledge the caped crusader's existence. Sure, the series features one of the antagonists from the film, brings back another in flashbacks, has a fleeting cameo of a certain police figure and *The Penguin* is certainly a continuation of the 2022 film's story but despite the connective tissues, neither Robert Pattinson's Bruce Wayne nor Batman make an appearance.

There are no news reports or fleeting images of newspaper clippings on Batman stopping The Riddler. No passing mentions of the vigilante aiding Gotham City during the floods caused by the former. It was almost as though the crimefighter and his billionaire alter ego suddenly ceased to exist after *The Batman*'s credits finished rolling.

However, by the end of the eighth and final episode, once the full extent of Oz's evil and depravity have been laid bare, turning the viewer's love-hate relationship of the character into one purely fuelled by hate, LeFranc reminds us Batman exists and that he will return to make the Penguin's burn leg the only leg that works.



After an impressive season in which he claimed his first two Grand Slam titles, Sinner is eager to cap the year by leading Italy to their second successive

"It will be tough. It's a final and especially in the Davis Cup anything can happen as we saw this week. We are not surprised, we will do our best and we have to choose wisely who will play tomorrow," Sinner told a press conference.

"This competition is very unpredictable, so we can only be happy to be back in the final... Tomorrow will be an intense day, and we are going to enjoy it.

goals for the upcoming year." Djokovic posted a video on X of him and Murray during the Scotsman's playing career, jokingly titled: "He never liked retirement anyway."

The 37-year-old Serb has won the Australian Open a record 10 times, defeating Murray in four Melbourne finals.

Djokovic failed to win a Grand Slam in 2024 and has slipped to seventh in the world, although he did land the Olympic singles title in Paris, a victory he described as his "greatest achievement".

Djokovic and Murray faced each other 36 times in their careers with the Serb winning 25 times.

"We played each other since we were boys - 25 years of being rivals, of pushing each other beyond our limits. We had some of the most epic battles in our sport,"

added Djokovic on Saturday.

"They called us gamechangers, risk takers, history makers. I thought our story may be over. Turns out, it has one final chapter. It's time for one of my toughest opponents to step into

my corner." Djokovic ended his coaching partnership with Goran Ivanisevic March ning 12 in despite winning 12 together. – AFP Slams

Max wins fourth F1 title, can Verstappen now make it five in a row?

AX VERSTAPPEN joined a select group of Formula One greats with his fourth title in Las Vegas yesterday but stretching the run to five in a row next year could be an even bigger, and more thrilling, battle.

Just six drivers have won four championships and only Michael Schumacher managed five in succession with Ferrari from 2000 to 2004.

Only two of them – Verstappen and Red Bull's Sebastian Vettel from 2010-2013 – have won their first four consecutively.

Verstappen has led the standings since May 2022, this month smashing Schumacher's record of 896 days on top, and the Red Bull driver will stay there until at least March 16 when the 2025 season starts in Australia.

That campaign will be eagerly awaited with former champions McLaren, Ferrari and Mercedes already scrapping for wins on a regular basis and seven-times world champion Lewis Hamilton soon to switch from Mercedes to Ferrari.

Formula One chief executive Stefano Domenicali congratulated Verstappen as fireworks exploded over the Vegas Strip.

"He is a true great of this sport and has so much more to look forward to in his impressive career," he said.

'This season has been thrilling and 2025 looks set to be even closer." Verstappen started 2024 with pole position in the first seven races, winning seven of the opening 10, but then went 10 races without a win as Red Bull's dominance disappeared.

"If we win the title again this year, it will be mainly down to Max," Red Bull's motorsport consultant Helmut Marko said after Verstappen ended the drought by sweeping from 17th to first in a rainswept and chaotic Brazilian race this month.

"With his exceptional driving skills, he covered up the phases in which the car really wasn't good."

The 27-year-old has 62 wins, still far behind Hamilton's 105, but the 2024 points gap – 63 after Vegas – reflected consistency more than any speed advantage.

Seven different drivers have each won more than once this season but Verstappen banked the points early and then defended his lead. Ultimately, numbers and statistics are

not what drives him and how much longer he stays is an open question, but Verstappen has a contract to the end of 2028.

"Now that I've won championships and races, for me, my goals are completed in Formula One," he told *Reuters* in a recent interview.

"I don't care about winning eight titles or beating the win record. I know that I can do that but you need in a way luck as well, for a long time that you are at the right team. 'Yes, I can continue until I'm 40-yearsold, but I don't want to.

"When I'm 80-years-old I want to look back and say, 'Yes, I had a good time in racing, I did everything I needed to do, and I loved my life and I lived my life?

That's what I want to do." In 2021, Verstappen and Hamilton went down to the wire in Abu Dhabi, the Dutch driver coming out on top after then-race director Michael Masi controversially changed the usual safety car procedure.

The following year saw Red Bull take both titles, with Ferrari's Charles Leclerc unable to sustain a challenge that started strongly.

"I think the most special will always be 2023," said Verstappen, who won 19 of 22 races in that record season.

Verstappen produced plenty of debate about his driving style this year but Red Bull's Christian Horner has denied and dismissed allegations amid all the team turmoil, Verstappen showed his resilience.

"He's been in a class of his own this year. He's been absolutely outstanding," said Horner as he donned a sweatshirt with the A in Max replaced by a 4. "He kept overdelivering, kept getting the results and performances. He

deserves this fourth world championship. It puts him among the elite of the sport." Reuters
