Islamic preachers must be proficient in English: PM

PUTRAJAYA: Prime Minister Datuk Seri Anwar Ibrahim has called for improved English proficiency among Islamic preachers to enable them to debate better with thinkers in Europe and abroad.

He said a good command of the language would enable Islamic teachings to be presented more systematically so that they could be understood in depth.

"In Europe (for example) a strong grasp of the English language (is required) to debate

with them (thinkers)," he said when speaking at

the *limu Madani* event on Wednesday. Also present were Cambridge Muslim College founder and Board of Trustees chair Syeikh Dr Abdal Hakim Murad and Minister in the Prime Minister's Department (Religious Affairs) Datuk Dr Mohd Na'im Mokhtar.

Anwar hailed the strength and wisdom of Syeikh Abdal Hakim, who used intellectual language to debate and captivate the interest of people in Europe regarding Islam. "Your strength is your ability to articulate brilliantly in English."

brilliantly in English." Anwar said Syeikh Abdal Hakim is a prominent public intellectual renowned for addressing challenges in the contemporary Islamic world, Bernama reported.

"He can engage with Islamic tradition and Western philosophy and culture." He urged university students and youths to

read books or scriptures together with lecturers so that the analysis could be understood clearly.

No plans to introduce new taxes in near future: Ministry

Present focus on increasing compliance, improving existing tax system, implementing tax measures already announced in Budget 2025'

KUALA LUMPUR: The government has no intention of introducing any new tax in the near future, said the Finance Ministry.

It said the present focus is on increasing compliance and improving the existing tax system as well as implementing tax measures that have already been announced in Budget 2025

"The government will consider first the revenue requirement, current economic situation, the national tax system's overall structure, limits and challenges, possible room for improvement, and most importantly, the impact on and preparedness of the people," it said in a written reply on the Dewan Negara website.

The ministry was replying to a question from Senator Datuk Seri S. Vell Paari who wanted to know whether the government has plans to introduce any new tax in the near term and, if so, what measures would be taken to ensure it would not burden the people amid

the rising cost of living. The ministry said among the taxes to be implemented are the global minimum tax,

effective Jan 1, 2025, on multinational companies with a global annual revenue of at least 750 euros and the 2% tax on dividend income starting from the year of assessment 2025.

Also to be implemented are e-invoicing in stages which started on Aug 1, 2024, for taxpayers with more than RM100 million turnover as well as the self-assessment stamp duty system in phases based on type of instruments or agreements. In addition, there will be a review of the

sales tax and broadening of the service tax's scope from May 1, 2025, and a review of the excise duty on sugary drinks from Jan 1. The ministry said the government would

ensure the tax measures announced are progressive and easily administered, do not have a negative impact on the cost of living or economic growth, and can generate a sustainable revenue for the government.

The ministry also said the government is conducting a detailed study on the best implementation mechanism for foreign workers' contribution to the Employees

Provident Fund. It said engagement sessions with various

stakeholders are being carried out to ensure that policies made are holistic.

This initiative aims to improve fairness in the labour market by ensuring that social protection for all workers is in line with international standards under the provisions of Article 68, Convention 102 of the International Labour Organisation, which is the equal right of social protection to non-citizens.

"This step is also seen to increase the competitiveness of local businesses at the global level through encouraging the transition of businesses towards automation while also reducing dependence on foreign labour," it said in a written reply on the Dewan Negara website to Senator Datuk Koh Nai Kwong's question on mandatory EPF contributions for foreign workers, which would burden MSMEs.

The ministry said the move is also in line with the EPF's efforts to ensure that all workers in Malaysia, regardless of nationality, have retirement savings to deal with the risk of insufficient retirement savings in old age as well as access to social protection, Bernama reported.

Prime Minister Datuk Seri Anwar Ibrahim had said during the presentation of Budget 2025 that the government planned to obligate all foreign workers to contribute to the EPF and that the proposal would be implemented in nhases

Earlier, Anwar, while presenting the second reading of the Supply Bill 2025 in the Dewan Negara, said the signing of the Johor-Singapore Special Economic Zone agreement, originally scheduled for Dec 9, has been postponed to January due to Wong's Covid-19 diagnosis.



Expanded scope of SST to be known early next year

KUALA LUMPUR: The list of services subject to the expanded scope of the Sales and Service Tax (SST) will be announced in early 2025, said Deputy Finance Minister Lim Hui Ying.

She said the list would depend on engagement sessions with stakeholders being conducted by the Finance Ministry.

The government also does not intend to re-implement the intend to re-implement the Goods and Services Tax (GST), said Lim when winding up the debate on the Measures for the Collection, Administration and Enforcement of Tax Bill 2024 in the Dewan Rakyat on Wednesday. She said the new SST to be

implemented from May 1 would be easier to understand by businesses and the public as it has been in force for over 40 years. She added that it could still be

improved compared with reintroducing the GST, which requires a longer preparation

period on the part of government and industry. part of the will

Users urged to be wary of oversharing online

Experts warn against digital overexposure amid rising cybersecurity and psychological risks

PETALING IAYA: Commercial Crime Investigation Department director Datuk Seri Ramli Mohamed Yoosuf has warned against oversharing personal details online, especially on social media, as doing so can have serious consequences. He said while he is aware that data has

become one of the most valuable assets in today's ICT-driven era, the ease with which personal information is "blindly shared" poses significant security threats.

"The more you share your data with the public through social media, the more information you are giving to viewers, including individuals with malicious intent who may misuse this data for criminal purposes," he said. Ramli said a major risk in sharing too much information is the fact that AI programmes can

now mimic voices, accents and intonations. The technology can even be used to translate

different languages, amplifying the potential for misuse. Bamli added that the stakes are higher where

child pornography can now be "deepfakes" and sharing pictures of children on social media significantly increases the risk of such content being misused and falling into the wrong hands,

including predators on the dark web.

He said such data can be used for blackmail or other criminal purposes, and urged the public to be mindful of their online conduct.

"Avoid sharing pictures of your minor children in their bathing suits at a swimming pool as they could end up on paedophile site and always be aware of who your social media ewers are," he said. Universiti Teknologi Malaysia (UTM) centre

for psychological and counselling services senior psychology officer and director Dr Zulfikar Ahmad said oversharing on social media can have adverse consequences despite its positive elements, such as fostering friendships, sharing experiences and advocating for causes. "Sharing on social media should be balanced

with maintaining offline privacy. This is where the importance of educating users about digital boundaries and the long-term impact of their online presence comes in.

"We seem to be looking for social media validation in terms of likes and comments from our followers. These provide a sense of support, even if temporary, and help users connect to others However, he said sharing emotions online,

although therapeutic for some, can leave individuals vulnerable to cyberbullying, scams or negative comments.

Zulfikar said the public should be more aware of the long-term implications of sharing personal information online, such as privacy risks and reputational damage. He also emphasised that what a person posts

in cyberspace will remain there indefinitely, so they should always think before posting. UTM psychology professor Dr Siti Aisyah Panatik said several psychological factors drive individue several psychological factors drive

individuals to overshare on social media, such as the need for peer validation, emotional catharsis, fear of missing out and even social media addiction

"Oversharing often stems from a need for validation, where the dopamine released by likes, comments and shares reinforces this behaviour, creating a cycle of dependency," she said.

She added that feelings of loneliness and isolation can aggravate the compulsion to share personal details as individuals seek connections in a digital space.

Siti Aisvah also warned that the superficial support received online may not address underlying emotional issues.

"While online interaction may provide temporary comfort, it often lacks the depth needed to truly support an individual's mental well-being," she said.

She noted that parents and educators play a pivotal role in instilling digital boundaries to

address oversharing among younger users. "For instance, setting screen time limits, fostering open conversations about online behaviour, and teaching critical thinking about social media content is crucial.

Senator proposes localised wages

KUALA LUMPUR: A member of the Senate has proposed that the government implement a minimum wage based on locality rather than the blanket approach applied nationwide, as announced during the tabling of Budget 2025 on 0 = 12 Oct 18.

Senator Datuk Seri Dr Zurainah Musa used Indonesia as an example, where minimum wages have been successfully set according to locality. "Try implementing a minimum wage by district

and state, as each locality has different living costs. We need to align this, as a minimum wage of RM1,700 in Kuala Lumpur may be insufficient, but it could be enough in rural areas.

could be enough in rural areas. "I urge the government to consider this, just as we account for living costs and family expenses when targeting subsidies. Why can't we do the same to determine minimum wages?" she said during the debate on the Supply Bill 2025 in the Deuron Nerse on Wednerder. Dewan Negara on Wednesday. Similarly, Senator Datuk A. Kesavadas suggested

that Malaysia adopt an approach similar to that used in New Jersey in the US, where the minimum wage rate has been gradually increased every year since 2011.

"Malaysia could consider starting by raising the minimum wage to RM1,600 next year and then increasing it by 6.6% annually for the next five years. "By 2026, it will rise to RM1,696, followed by RM1,797 in 2027, RM1,904 in 2028, and eventually

RM2,018 in the fifth year. This approach will be more manageable for employers," he said, explaining that the proposed 6.6% annual increase was based on double the current inflation rate.

Kesavadas also suggested that the government grant exemptions to micro businesses with an annual income below RM500,000. – Bernama

History being reviewed for 2027 curriculum

KUALA LUMPUR: The Education Ministry (MOE) is in the process of developing the 2027 school curriculum for Year 1 and Form 1 students, which includes a review of the History subject. Deputy Minister Wong Kah Woh said the review

process involves a detailed examination of the current curriculum and discussions with various stakeholders, including educators, researchers, and the general public. "Any new findings or facts to be included in the

History syllabus will be reviewed and endorsed by the MOE History Curriculum and Textbook Reference Panel, comprising public university lecturers with proven expertise and credibility, appointed after undergoing stringent security screening.

"Outstanding teachers and authoritative agencies, including state secretariats, state archives, state museums, teacher training institutes (IPGs), and credible local non-governmental organisations involved in history, culture, and social studies, are also participating in drafting and reviewing the curriculum," he said during the question-and-answer session in the Dewan Rakyat yesterday. - Bernama

RON97, RON95, diesel prices unchanged

KUALA LUMPUR: The retail prices for RON97 and RON95 petrol will remain unchanged at RM3.19 and RM2.05 per litre, respectively, from

Dec 5 to 11. The Finance Ministry, in a statement, said the retail price of diesel in Peninsula Malaysia will also remain at RM2.95 per litte, while in Sabah, Sarawak, and Labuan, the price will remain at RM2.15 per litre during the same period.

It said the prices were fixed based on the weekly retail prices of petroleum products, using the Automatic Pricing Mechanism formula. "The government will continue to monitor

global crude oil price trends and take appropriate measures to ensure the continued welfare and well-being of the people," it added. Bernama

RM392b required to implement flood mitigation projects RM1.97 billion. financial capacity is limited, which is why we are

KUALA LUMPUR: The government would require an estimated RM392 billion to implement 365 flood mitigation plan (FMP) projects in flood-prone areas across the country from 2023 to 2100, according to Deputy Prime Minister Datuk Seri Fadillah Yusof. Fadillah, who is also Energy Transition and

Water Transformation Minister, said the figure was identified by the ministry through research by the Department of Irrigation and Drainage (DID) on major river basins as part of a nonstructural approach aimed at providing comprehensive flood planning and solutions. "If we were to have that amount, there

would be a year of no allocation for all ministries to resolve this issue.

"But the reality is that the government's

implementing FMP projects based on the priorities of the states and areas identified in the studies," he said during the minister's question time at the Dewan Rakyat yesterday.

Fadillah was responding to a question from V. Ganabatirau (PH-Klang), who asked whether the government was satisfied with the development of flood mitigation infrastructure and related investments over the years, and what measures were being taken to improve the country's preparedness and response efficiency for flood disasters.

Fadillah said the government was satisfied with the projects completed so far, citing the SMART Tunnel project in Kuala Lumpur, which was completed in 2007 at a total cost of

He noted that over its 17 years of operation the tunnel had been activated more than 600 times to divert floodwaters, significantly reducing the risk of flooding in the city. A 2012 study by the DID revealed that the diversion system had prevented damages

amounting to over RM4.3 billion, he added. "The department has also updated and

identified 4,619 flood hotspots across the country and initial actions have been taken to carry out mitigation works such as drainage system maintenance, repairs and retrofitting.

"It also ensures that the early warning system, involving 534 flood warning sirens along major rivers, is functioning properly," he said. – Bernama





Floodwater carries serious health risks, says specialist

Contact may cause exposure to harmful pathogens from sewage leaks or dangerous wildlife'

PETALING JAYA: Floodwater might look harmless but it carries serious health risks beyond drowning and physical injuries, warned Universiti Kebangsaan Malaysia public health medicine specialist Prof Dr Sharifa Ezat Wan Puteh.

She was commenting on recent statements from health officials on a rise in infectious diseases.

On Dec 3, Kelantan Health Department director Datuk Dr Zaini Hussin reported 4,894 cases of infectious diseases at temporary relief centres across the state.

He said respiratory infections were the most common at 2,923 cases, followed by 1,367 cases of skin infections.

Other cases included 116

instances of gastroenteritis, 99 of conjunctivitis and 376 of viral fever. In Terengganu, state Health Department director Datuk Dr Kasemani Embong reported on Dec 5 that 1,245 cases of infectious diseases were detected in several temporary relief centres across the state since flooding began at the end of November. She said respiratory infections

also topped the list in Terengganu at 969 cases, followed by skin infections at 166.

Other cases included 63 instances of fever and 47 individuals inflammation Sharifah Ezat said with such cases

on the rise, the public must exercise caution, especially when dealing with floodwater.

"Floodwater is not just dirty water as it often becomes contaminated as it often becomes contaminated when sewage leaks, which introduces harmful pathogens such as salmonella, *vibrio cholerae*, *shigella*, and hepatitis A. "Floodwater could also push wildlife such as snakes and centipedes into human habitats,

creating a danger for those wading through floodwater."

She said stagnant water left behind by floods serves as a breeding ground for mosquitoes,

increasing the risk of dengue, while accumulated rubbish attracts rats, which could lead to leptospirosis outbreaks.

She also urged parents to be more aware, especially as videos have been circulating online showing children playing in floodwater.

"Parents in flood-prone areas must remain vigilant, ensuring their children stay away from floodwater and educating them about the dangers. While many may be unaware of the risks, those in the know must take responsibility and educate others." Prince Court Medical Centre

consultant dermatologist and internal medicine specialist Dr Rani Manohari Kuppusamy said the damp conditions caused by floods could worsen skin health.

"These waters are often heavily contaminated with bacteria and viruses, making contact potentially harmful. The damp conditions from floods damage the skin's natural barrier, allowing bacteria and fungi to thrive

"Exposure to floodwater could lead to immediate skin issues, such as rashes and skin softening. Prolonged contact increases the risk of chronic problems, such as fungal infections and eczema flare-ups."

Central Dermatology Specialist

Clinic consultant dermatologist Dr Teeba Raja said individuals with pre-existing skin conditions need to be more cautious as they are more vulnerable to complications than others. She said those with existing skin

conditions or weakened immune systems face a higher risk as damaged skin provides a pathway contaminants for to cause secondary infections. "Immediate care after contact

with floodwater is crucial to minimise risks. Thoroughly wash

minimise risks. Thoroughly wash your skin with soap and clean water but avoid scrubbing open wounds. "Use antiseptic for small cuts or scrapes, and ensure the skin is completely dry before applying moisturiser to restore and protect it." She advised those affected to seek medical extension if they notice

medical attention if they notice redness, swelling, pain, or signs of infection, such as pus, warmth, fever or spreading wounds.

She also said in the aftermath of flooding, taking care of one's health,

skin and belongings is a priority. "Wash contaminated clothing thoroughly before reusing it and disinfect furniture to prevent germ spread. Even after floodwater recedes, bacteria may remain, so practise good hand hygiene and stay hydrated.

Suggestions outlined to boost hybrid cattle industry

KUALA LUMPUR: The parliamentary special select committee on domestic trade, entrepreneurship, cost of living and agriculture has outlined seven key recommendations aimed at boosting the development of Malaysia's hybrid cattle industry,

which holds significant potential. Committee chairman Cha Kee Chin highlighted the need for a major shift in approach by the Agriculture shift in approach by the Agriculture and Food Security Ministry and the Veterinary Services Department to ensure that the industry receives adequate government attention and is not treated as a part-time initiative.

He emphasised that cooperation from other agencies is essential to

avoid overburdening the ministry. "If we place this responsibility solely on the ministry or its agencies, it will not be sufficient. "For instance, the Rubber Industry

Smallholders Development Authority and the Federal Land Development Authority manage large oil palm plantations, and experts have suggested that these areas are well suited for cattle farming."

He shared these insights during a briefing, titled "Potential of the Hybrid Cattle Industry in Malaysia", at Dewan

Rakyat here on Wednesday. The Rasah MP said committee recommended government-linked com said the that companies provide capital injections to small-scale hybrid cattle breeders to

help them scale up their operations. Cha proposed forming a coalition of cooperatives that would unite private breeders, enabling a comprehensive and coordinated effort to develop the industry.

"The ministry and department must ensure the availability of necessary technical expertise, including the deployment of experienced artificial insemination technicians across the country." He emphasised the need for strict

enforcement to curb cattle smuggling at the borders as it undermines loca efforts and negatively impacts the interests of domestic breeders.

He called on state governments to cooperate, noting that land falls under their jurisdiction, and urged them to

RM50m allocated to help villagers pay electricity bills

KOTA KINABALU: The Sabah government has set aside RM50 million to assist villagers who struggle to pay their electricity bill. Chief Minister Datuk Seri Hajiji Noor said the allocation would

be distributed next year as a government initiative.

"The initiative is taken to lighten the burden of eligible villagers," he said when officiating at the Sabah Education Assistance Presentation Ceremony at Menara Kinabalu here on Wednesday.

He said starting next year, the state government would give RM300 aid to hardcore poor families in Sabah for a period of one year.

He also said the state government, He also said the state government, through its departments and agencies, has taken the initiative of providing various educational assistance and contributions to students and graduates to ease the burden of parents.

Hajjij said the assistance includes the Sabah Foundation Scholarship and the Bursary and Study Loan

Programme, which has allocated RM57 million for 4,500 students next year. The

Sabah Government Scholarship, with an allocation of RM127 million, aims to sponsor 3,850 new students studying at local and overseas universities, and finance existing sponsored students next year.

"This amount has increased compared with the RM113 million allocated by the government this year.

He said new and existing education assistance amounting to RM79.5 million would be provided in a lump sum, including religious, language and literature assistance for next year.

At the ceremony, Hajiji presented the Sabah Government Scholarship to 100 students studying at Universiti Malaysia Sabah while 100 students received assistance from the Sabah Education Fund.

Also provided was the Bantuan Ihsan Sekolah Sabah for this year with an allocation of RM10 million, involving all schools in Sabah, Bantuan Ihsan Komputer and Bantuan Khas Program Pendidikan.

He said the Sabah Islamic Religious Council, through *zakat* funds, has mobilised various education initiatives by allocating RM47.3 million for the education sector next year.

"As of November, there has been an increase of RM4.9 million from the previous year, with a total expenditure of RM37.4 million." – Bernama

Be involved in active ageing activities, seniors urged

Holistic approach improves quality of life, reduces healthcare costs and supports long-term well-being, says expert

PETALING JAYA: An expert in ageing has urged senior citizens to become more active to improve their physical and psychosocial well-being, rather than focusing on the absence of illness.

Universiti Kebangsaan Malaysia Centre for Healthy Ageing and Wellness lecturer Prof Dr Devinder Kaur Ajit Singh said 3.5 million Malaysians are aged over 60. "Projections indicate that older adults will

make up over 15% of our 34.1 million population by 2030. This means active ageing has become increasingly important in our society."

She defined active ageing as a holistic approach that focuses on optimising health, staying involved in meaningful activities and

feeling secure as people age. "It aims to help older adults stay healthy, engaged and secure, while recognising their ongoing contributions to society. By addressing their physical, social and economic needs, active ageing improves their quality of life, reduces healthcare costs and supports long-term well-being."

Supports long-term wen-being. She said active ageing challenges stereotypes that view older adults as unproductive or unable to grow, highlighting their ability to learn, grow and maintain a healthy body and mind, and emphasising their unique skills and experiences. University Malaya Medical Centre and

Specialist Centre consultant geriatrician Prof Dr Shahrul Bahyah Kamaruzzaman said older Malaysians often face barriers such as limited access to affordable healthcare, social isolation and inadequate mobility-friendly infrastructure.

He said chronic health conditions such as He said chronic health conditions such as diabetes and arthritis restrict physical activity and impact overall well-being, making maintaining an active and healthy lifestyle difficult as they hinder the potential of older adults to live fulfilling lives. "Programmes such as *Pusat Aktiviti Warga*



Devinder Kaur said starting an exercise routine later in life could lead to significant health benefits as "any physical activity is better than none". - MASRY CHE ANI/THESUN

Emas run by the Women, Family and Community Development Ministry offer essential support, including spaces for social interaction, health checkups and recreational activities.

Pay RM750,000 to DAP trio, MP told

GEORGE TOWN: The Penang High Court ordered Kepala Batas MP Dr Siti Mastura Muhammad to pay RM750,000 in total to three DAP stalwarts – Tan Sri Lim Kit Siang, Lim Guan Eng and Teresa Kok – over her claims that they were related to Communist Party of Malaya Jeader Chin Pang leader Chin Peng.

The High Court Judge Quay Chew Soon ordered Siti Mastura to pay RM300,000, RM250,000 and RM200,000 respectively to Kit

Siang, Guan Eng and Kok. In delivering his decision, Quay said Siti Mastura acted with malice, while on the balance of probabilities, the Kepala Batas MP has not succeeded in proving her defence of justification, fair command, privilege and innocent dissemination.

"The defendant has made inflammatory remarks, linking the plaintiffs to a prohibited political party and one of its infamous leaders. She has made unsavoury insinuations about the plaintiff's connection with communism. "By linking the plaintiffs to a communist

leader, the insinuation is that they are affiliated with and support communism. In our country, that is considered taboo," the judge said in the online proceeding on Wednesday. Quay said Siti Mastura had even used former Singapore prime minister Lee Kuan Yew's name to make be allocations com merce scrollable but

to make her allegations seem more credible, but the claims were baseless.

The judge also imposed a 5% annual interest if Siti Mastura fails to pay the amount and also ordered her to pay costs of RM25,000 each to the trio. – Bernama

'No reports on MyKad data sold via dark web'

KUALA LUMPUR: Police have not received any reports regarding the allegation that MyKad data of Malaysian citizens is being sold via the

dark web. Bukit Aman Commercial Crime Investigation Department (CCID) deputy director (Investigation) Datuk Rohaimi Md Isa said the investigation conducted by CCID Cyber and Multimedia Crime Investigation Division has so far not found any evidence regarding the allegation. "CCID will continue to monitor to determine

the validity of the information. Appropriate investigations will be carried out together with other relevant agencies if a police report regarding the issue is received," he said.

regarding the issue is received, he said. Earlier, Home Minister Datuk Seri Saifuddin Nasution Ismail stressed that a thorough inspection carried out by security agencies including the National Registration Department regarding the allegation found that it was completely untrue.

Ex-Sabah water dept director told to enter defence in corruption case

KOTA KINABALU: The Sessions Court here ordered former Sabah Water Department director Ag Mohd Tahir Mohd Talib, 62, his wife Fauziah Piut, 59, and former deputy director Lim Lam Beng, 70, to enter their defence on 37 charges of money laundering after the prosecution successfully established a *prima facie* case against them.

Judge Abu Bakar Manat scheduled the defence proceedings for Feb 26 to Feb 28 and April 28 to April 30 next year.

Delivering his decision at the end of the prosecution's case on Wednesday, Abu Bakar said witness testimony revealed RM23.69 million in cash was found and confiscated from Ag Mohd Tahir's office at Wisma Majlis

Ugama Islam Sabah. Additionally, RM8.56 million was discovered at the couple's home; RM9.19 million from a Mazda vehicle: and RM4.13 million from a Mercedes-Benz.

Foreign currencies such US dollars, pound sterling, euros, UAE dirhams, Thai baht, Chinese yuan, Hong Kong dollars, Japanese yen, Vietnamese dong, South Korean won, Saudi riyals, Singapore dollars, and Indonesian rupiah were also confiscated.

Another RM4.15 million held in Ag Mohd Tahir's bank accounts was also seized.

"Throughout the trial, based on witness testimonies and the discovery of substantial cash sums at various

locations, the court is satisfied that the prosecution has proven that the first accused abused his position as the director of the Sabah Water Department.

"(Ag Mohd Tahir) was involved in illegal activities, specifically corruption through a centralised collection scheme, which operated from 2005 to 2016," the judge said.

He also said based on witness testimony, it is evident that the centralised collection scheme could not have been executed without Aa Mohd Tahir's knowledge, direction, approval, and involvement.

Abu Bakar also noted that during investigations and cross-examinations of prosecution witnesses, the accused failed to

explain the source of the confiscated

"The same applies to the luxury cars and watches, all of which were in the possession of the first accused at the time of the raids," he said.

Abu Bakar said Fauziah had over RM2.22 million in her personal bank accounts and owned 921pieces of jewellery and 93 luxury handbags.

"The total value of the charges against her (Fauziah) exceeds RM6 million. The second accused also failed to explain the source of these

Index during the investigation." The judge said based on the discoveries, witness testimonies, documents, and circumstantial evidence, the court is satisfied that the accused, through her husband,

Ag Mohd Tahir, was involved in possessing illegal proceeds. He added that while Fauziah was

not directly involved, her possession of proceeds from unlawful activities constitutes an offence under Section 4(1)(b) of the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 (Amla).

Ag Mohd Tahir faces one charge under Section 4(1)(a) of the Amla 2001 and 11 charges under Section 4(1)(b) of the same Act. Ag Mohd Tahir and Fauziah are

jointly charged with two offences under Section 4(1)(b) of the Amla, while Fauziah and Lim face 19 and four charges, respectively, under the same section and Act. - Bernama

'Register 5 Perak products as intellectual property'

IPOH: The Intellectual Property Corporation of Malaysia (MyIPO) said at least five popular products in Perak have the potential to be registered as heritage intellectual property, protected under Geographical Indications (GI).

MyIPO chairman Dr Mohd Zuhan Mohd Zain said among the products are milk corn, Kuala Sepetang mangrove charcoal, Perak onions, Batu Kurau durian, Sungai Perak catfish and Teluk Intan giant river prawn.

"We are worried that if these products, which are synonymous with Perak, are not protected under GI, they will lose the rights to the names," he said.

If these products are registered under GI, they would become an attraction and would help increase the state government revenue, Mohd Zuhan said after officiating at the MyIPO satellite office at Menara Suruhanjaya Syarikat Malaysia on Wednesday. Mohd Zuhan said the opening of the first MyIPO satellite office in Perak would make it easier for entrepreneurs, designers, innovators and professionals to protect their creations and product branding. He said previously, intellectual

He said previously, intellectual property owners in Perak would go to the MyIPO branch office in Seberang Perai Tengah, Penang, which also caters for customers from Kedah and Perlis.

"The opening of this office will also continue to encourage more individuals and businesses to protect their innovations and work, thus contributing to the state's economic development." He said MyIPO had received 52.466

He said MyIPO had received 53,456 intellectual property applications from January to October, compared with 50,570 applications during the same period last year. Of the total, 34,479 applications

Of the total, 34,479 applications were from foreigners, while 18,977 were from locals. – Bernama

Sabah needs 'tailored solutions' to fight poverty

KOTA KINABALU: According to the Economy Ministry, eight out of the 10 poorest districts in Malaysia are located in Sabah, with Tongod recording the highest rate of extreme poverty at 5.9%, followed by Beluran 5%, Pitas 4.8%, Kinabatangan 4.6%, Kota Marudu 4%, Tuaran 2.6%, Ranau 2.4%, and Lahad Datu 2.4%.

All eight districts are located in the rural and interior regions of Sabah, far from Kota Kinabalu, the primary economic growth hub of the Land Below the Wind. Based on the 2022 Household

Based on the 2022 Household Income Survey, the national extreme poverty rate in urban areas is 0.1%, whereas rural areas see a significantly higher rate of 0.7%.

Sabah records the highest extreme poverty rate in the country at 1.2%, compared with Kelantan at 0.8%, which has only one interior district, Lojing, followed by Pusa in Sarawak at 0.4%.

at 0.4%. Institute for Development Studies Sabah CEO Datuk Dr Ramzah Dambul said the poverty and extreme poverty data in Sabah "speaks volumes" about the rural and interior poverty situation in the state, which is markedly different from that of Peninsular Malaysia.

This, he emphasised, necessitates a distinct approach to addressing the challenges to ensure that initiatives can effectively transform the harsh realities faced by the affected communities.

"The 1.2% extreme poverty rate (in Sabah) is significantly high compared with the national average of 0.2%. Hence, Sabah requires its own solutions, not a 'copy-and-paste' approach from Peninsular Malaysia.

"There is no one-size-fits-all solution for this issue. We often overlook this fact and apply blanket measures to resolve it, but there is a significant difference between Peninsular Malaysia and Sabah. Therefore, we need tailored solutions Using one-size-fits-all approach does not resolve issue due to significant difference between Peninsular Malaysia and state, says institute CEO

specifically for Sabah," he told Bernama in a recent interview.

The Sabah Budget 2025, unveiled by State Finance Minister Datuk Seri Masidi Manjun during the Sabah State Assembly session last month, highlighted the state government's steadfast commitment to tackling poverty.

To provide "fish" for those in need, for the first time, a monthly aid of RM300 for a year will be allocated to the poor and hardcore poor in the state through this budget, involving an allocation of RM358.5 million.

an allocation of RM358.5 million. As part of its "teaching to fish" approach, the Sabah government has allocated RM488.5 million to implement various poverty eradication programmes, ensuring no groups are left behind in terms of development, living standards, and economic opportunities.

Among these initiatives, according to Masidi, is a one-time RM5,000 grant designed to help street vendors with valid business licences enhance their businesses – a first-of-its-kind programme in the state.

The Sabah government has also allocated RM2.6 billion to enhance infrastructure and utilities, focusing on resolving long-standing challenges related to road networks, water and electricity supply, and other public facilities.

These efforts aim to improve access for Sabah residents to economic "pools" in Kota Kinabalu, while accelerating the development of additional economic hubs, particularly in Tawau and Sandakan. Meanwhile, Kuamut state assemblyman Datuk Masiung Banah, commenting on the poverty in Tongod – a constituency under his administration – said he has long raised the issue in state assembly sessions and other platforms, albeit with limited impact.

with limited impact. However, Tongod began to gain national attention after being named the poorest district in Malaysia. "As a representative of the people,

"As a representative of the people, I have fought for the development of Tongod for a long time. When it was declared the poorest district, I took it positively as it drew national attention to our struggle. This recognition ensures that more initiatives will be implemented for us. What matters most is that the people of Tongod receive the support they need," he said.

Tongod, located 255km southeast of Kota Kinabalu, is accessible via hilly roads and some severely damaged routes, crossing varying elevations around Mount Kinabalu and the Ranau district. Covering an area of 10,052sq km,

Covering an area of 10,052sq km, Tongod is larger than several states in Peninsular Malaysia, including Kedah, which spans 9,447sq km. "The town of Tongod is also or demoised avalent stated disc

"The town of Tongod is also undergoing development, including plans for a RM7 million commercial centre with shop lots along with other major development projects in the area.

area. "With initiatives ranging from commercial development to large factories and rice cultivation, Tongod is now on a path of transformation."



South Korean president clings to power

Ruling party to fight impeachment

SEOUL: South Korean opposition lawmakers said yesterday they would vote this weekend to impeach President Yoon Suk Yeol over a botched attempt to impose martial law, while the defence minister blamed for advising the move resigned.

Yoon's declaration of martial law late on Tuesday attempted to ban political activity and censor the media in Asia's fourth-largest economy and a key US ally. It sparked outrage in the streets and concern among its international allies.

Lawmakers from the opposition Democratic Party planned to put up a vote in parliament to impeach Yoon on Saturday, a party spokesperson told reporters. "The Yoon Suk Yeol regime's declaration of

emergency martial law caused great confusion and fear among our people," Democratic Party lawmaker Kim Seung-won told the National Assembly in an early morning session.

Yoon's ruling People Power Party is divided over the crisis but said it would oppose impeachment with two years left in Yoon's five-year term.

The Democratic Party needs at least eight of the 108 ruling-party lawmakers to back the Bill for it to pass with a two-thirds majority of the

300-seat parliament. Fighting for his political future, Yoon accepted the resignation of Defence Minister Kim Yong-hyun yesterday and nominated his ambassador to Saudi Arabia, Choi Byung-hyuk, as a replacement, Yoon's office said.

Kim had recommended Yoon declare martial law on Tuesday, according to the interior minister, a senior military official and the filing to impeach Yoon by opposition members

Kim also ordered the deployment of troops to the parliament, Vice-Defence Minister Kim Seon-ho said, adding he was unaware of the martial law order until Yoon declared it.

"I have fundamentally opposed the mobilisation of military forces under martial law and have expressed negative opinions about it," he told a parliament hearing yesterday, apologising and taking

about it, he told a parhametic hearing yesterday, apologising and taking responsibility for failing to prevent it. Japanese Prime Minister Shigeru Ishiba said Japan's "security situation may be fundamentally changed" in light of the instability in Seoul and North Korea's rising military assertiveness military assertiveness.

"What will happen to South Korea? There appears to be a great deal of domestic criticism and opposition," he told parliament yesterday, adding that Yoon's efforts to improve relations with Tokyo "must never be undermined". There has been no reaction yet from North

Secretary of State Antony Blinken said on Wednesday the United States had not been made aware in advance of Yoon's declaration. while his deputy, Kurt Campbell, said Yoon

had badly misjudged it. The US has 28,500 troops stationed in South Korea as a legacy of the 1950-1953 Korean War. The commander of US Forces-Korea, General Paul LaCamera, warned American troops to exercise vigilance, avoid areas with protests, and to communicate travel plans to their supervisors in case unexpected" occurs. "something

Yoon had been embraced by leaders in the West as a partner in the US-led effort to unify democracies against growing authoritarianism in China, Russia and elsewhere.

But he caused unease among South Koreans by branding his critics as "communist totalitarian and anti-state forces". In November. totantarian and anu-state forces. In November, he denied wrongdoing in response to influence-peddling allegations against him and his wife and he has taken a hard line against labour unions.

The impeachment follows a night of chaos after Yoon declared martial law and armed troops attempted to force their way into the National Assembly building in Seoul, only to stand back when parliamentary aides sprayed them with fire extinguishers. The commander of the martial law troops

said he had no intention of wielding firearms against the public, and Kim, the vice-defence minister. said no live ammunition had been provided to those troops.

"The people and the aides who protected parliament protected us with their bodies. The people won, and it's now time for us to protect the people," the Democratic Party's Kim said. "We need to immediately suspend the

authority of President Yoon. He has committed an indelible, historic crime against the people, whose anxiety needs to be soothed so that they

can return to their daily lives." The martial law crisis rattled global financial markets and South Korea's benchmark KOSPI index. Currency dealers reported suspected state intervention on Wednesday to keep the won stable.

Finance Minister Choi Sang-mok sent an emergency note to global financial chiefs and credit rating agencies late on Wednesday to say the ministry was working to alleviate any adverse impact from political turmoil.

If the impeachment bill passes, South Korea's Constitutional Court will then decide whether to uphold the motion - a process that

could take up to 180 days. If Yoon were to be suspended from exercising power, Prime Minister Han Duck-soo would fill in as leader.

If the embattled president resigned or was removed from office, a new election would be held within 60 days. Yoon squeezed out a victory in the tightest

presidential election in South Korean history in 2022, riding a wave of discontent .

But his support ratings have been at around 20% for months and the opposition captured nearly two-thirds of seats in parliament in an April election. - Reuters

Japan grant to **boost Philippines** naval capabilities

MANILA: Japan yesterday granted the Philippines ¥1.6 billion (RM47 million) to improve its naval capabilities.

The funds, part of a Japanese regional security assistance programme, will provide more rigid-hulled inflatable boats, coastal radar systems and automatic identification systems to the Philippine Navy, the two sides said.

The package will "contribute to maintaining and strengthening regional security" and "enhance the security of vital sea lanes", Japan's embassy said after a meeting between Ambassador Kazuya Endo and Philippine

Ambassador Kazuya Endo and Philippine Foreign Minister Enrique Manalo. The amount more than doubled the ¥600 million Manila received when the Official Security Assistance (OSA) programme was launched in 2023. The Philippines has been upgrading its

maritime security assets and boosting ties with allies to counteract Beijing's aggressive assertion of its claims in the South China Sea.

The Foreign Ministry said the OSA deal would improve Manila's ability "to deter threats to

Improve Manila's ability "to deter threats to peace, stability and security". China claims almost the entire South China Sea, brushing off rival claims from other countries and an international ruling that its assertion has no legal basis. On Wednesday, Manila said the China Coast

Guard fired water cannon and "sideswiped" a government vessel near a disputed shoal.

government vessel near a disputed shoal. On the same day, another Chinese vessel "intentionally rammed" a fisheries department vessel near Sabina Shoal in the Spratly Islands. Manalo said the Philippines would be submitting a diplomatic protest. "We were within our legal rights," Manalo told reporters after the signing of the security aid agreement with Japan.

FIRST AUSTRALIAN DAIRY COWS ARRIVE IN INDONESIA

JAKARTA: About 50 Australian dairy cows have arrived in Indonesia as the first cattle imports under a plan to boost milk production needed for President Prabowo Subianto's flagship free meals programme. Subianto's flagship free meals programme. Indonesia plans to import one million dairy cows from next year to support the scheme, which will launch early next year and aims to offer free meals to more than 80 million schoolchildren. The heifers, which are between three and seven months pregnant, were flown from Australia and arrived in Jakarta on Tuesday, and will be moved to Lampung province in southern Sumatra. "Hopefully these dairy cows would start producing milk for local needs by mid next year," said Agung Suganda, director-general of Livestock and Animal Health at the Agriculture Ministry. – Reuters

ASEAN MINISTERS TO DISCUSS **MYANMAR CRISIS**

MYANMAR CRISIS JAKARTA: Asean is planning to hold a ministerial meeting in Thailand later this month to discuss the crisis in Myanmar, Indonesia Foreign Ministry spokesperson Roy Soemirat said yesterday. The meeting vill work out ways to approach the crisis which has gripped Myanmar since a 2021 coup, including on the implementation of Asean's five-point plan, he said. The plan has made scant progress since its unveiling in April 2021, just months after Myanmar's military unseated the elected government. The military government has been battling a rebellion since then and has largely ignored calls by its neighbours to cease hostilities and enter into dialogue with its opponents. – Reuters Reuters

Southeast Asia celebrates kebaya's Unesco recognition

SINGAPORE: The successful inscription of the kebaya onto the Unesco Representative List of Intangible Cultural Heritage of Humanity – a joint nomination by five Southeast Asian nations – is a milestone to be celebrated, said Singapore Culture, Community and Youth

Minister Edwin Tong. Tong, who also serves as chairman of the Singapore National Commission for Unesco, said *kebaya's* inscription highlights its cultural significance and promotes cross-cultural unity in Singapore and the region. "It marks Singapore's first multinational

nomination and is the largest for Southeast

Asia, in terms of the number of nominating countries, involving a collaborative effort between Brunei Darussalam, Indonesia, Malaysia, Singapore and Thailand.

"For the first time, these five nations have joined forces to recognise the *kebaya* as a symbol of our shared history and cultural identity," he said.

In a Facebook post, Tong noted that the *kebaya* represents Southeast As multiculturalism and regional connections. Asia's

"The *kebaya* is more than clothing; it is a living tradition reflecting history, identity, and artistry. Each *kebaya*-wearing community's

China slaps sanctions on 13US military firms

TAIPEI: Taiwan will not bow down to totalitarianism, President Lai Ching-te said yesterday in the US territory of Guam, calling Taiwan and the United States "brothers".

Lai arrived in Guam, a major US military base, late on Wednesday on what is officially only a one-night stopover as part of a tour of three Pacific island countries which maintain formal diplomatic ties with Chinese-claimed Taiwan.

China has decided to impose sanctions on 13 US military firms from yesterday, in response to the sale of US arms to Taiwan, the Foreign Ministry said after the United States arranged for Taiwan's president to transit through its territory.

Lai addressed members of the overseas Taiwan community as well as Guam Governor Lou Leon Guerrero and Northern Mariana Islands Governor Arnold Palacios at a lunch.

He said Taiwan's path from the "darkness of dictatorship" to democracy was hard

fought. "I hope that all of our compatriots, no will make a joint

commitment to continue to deepen our democracy and protect it, and that we will never bow down to totalitarianism," Lai said. Mentioning the victory of Taiwan's baseball team at an international championship in Japan last month, Lai said he wanted to be "humble" and say that Taiwan beat the US team on its way to the finals

"Although we are brothers, when it comes to baseball you have to rely on strength." Lai also thanked the United States for

arranging his transits through both Guam and Hawaii.

Earlier in the day Lai had a breakfast meeting at the Guam governor's residence.

"In the face of authoritarian expansionism all like-minded countries and regions must unite and collaborate to safeguard democracy, peace and prosperity in the Indo Pacific region," Lai told reporters at the residence, with a Taiwan flag behind him.

"Taiwan and Guam are both situated in the First Island Chain. Moving forward we must work closer together and stand side by side to safeguard peace and stability in the Indo Pacific region.

The First Island Chain is a collection of archipelagos running roughly from Indonesia in an arc northeast to Japan, encompassing the South China Sea and East China Sea. Guerrero thanked Taiwan for the

resumption of direct flights from Taipei to Guam and other areas of cooperation. China's sanctions move follows its strong

objection to the United States authorising a potential US\$385 million (RM1.7 billion) sale of spare parts and support for F-16 jets and radars to Taiwan, which Beijing says undermines its sovereignty. China, which considers Taiwan its own

territory and Lai a dangerous separatist, opposes any foreign interactions or visits by the island's leaders.

Companies targeted by the sanctions include Teledyne Brown Engineering Inc, BRINC Drones Inc and Shield AI Inc, the Foreign Ministry said in yesterday's statement.

Other companies facing sanctions are Rapid Flight LLC, Red Six Solutions, SYNEXXUS Inc, Firestorm Labs Inc, Kratos Unmanned Aerial Systems Inc, HavocAI, Neros Technologies, Cyberlux Corporation, Domo Tactical Communications and Group W.

In addition, Beijing will freeze the assets of six executives from five companies including Raytheon, BAE Systems and United Technologies, in China, and bar their entry to the country.

Yunus urges unity to counter 'Indian aggression'

DHAKA: Bangladesh's interim leader Muhammad Yunus has urged the country's politicians to keep differences at bay and put up a united front to counter "Indian aggression".

A student-led uprising in August toppled elected Prime Minister Sheikh Hasina and ended her 15-year rule. India – the destination of Hasina's exile -

has accused Yunus' administration of failing to protect minority Hindus, straining ties between the neighbours.

"They are undermining our efforts to build

a new Bangladesh and are spreading fictitious stories," Yunus told a gathering of political parties.

"They have spread these rumours in particular countries and among influential players." Yunus urged the politicians to unite against

what he characterised as a disinformation campaign, describing the matter as "a question of our existence".

A caretaker administration headed by Yunus has been tasked with enacting democratic reforms ahead of fresh elections.

The chaotic aftermath of Hasina's ouster saw reprisal attacks against Hindus and other minorities, based in part on their perceived support for her government. Yunus' administration has acknowledged

and condemned attacks on Hindus but said in many cases they were motivated by politics rather than religion.

It has accused India of exaggerating the scale of the violence and running a "propaganda campaign". Yunus' media team said the meeting was

part of an initiative to promote unity. - AFP

French PM meets president to resign

PARIS: French Prime Minister Michel Barnier submit his resignation after losing a vote of no confidence in parliament, with the president urgently seeking ways to halt growing political and financial chaos. Poised to be contemporary France's shortest-

serving premier, Barnier arrived at the Elysee Palace just after 0900 GMT (5pm in Malaysia) for the resignation formality, with the outgoing premier and government constitutionally obliged to step down after the defeat in parliament.

A majority of lawmakers on Wednesday supported the no-confidence vote proposed by the hard left and backed by the far right headed by Marine Le Pen.

Barnier's record-quick ejection comes after snap parliamentary elections this summer, which resulted in a hung parliament with no political force able to form an overall majority and the far right holding the key to the government's survival.

The trigger for Barnier's ouster was his Budget for next year including austerity measures that were unacceptable to a majority in parliament, but that he argued were necessary to stabilise France's finances. On Monday he had forced through a Social

Security Financing Bill without a vote. The successful no-confidence motion cancelled the government's entire financing plan, leading to an automatic renewal of the current budget into next year, unless any new government can somehow rush through approval of a new budget by Christmas – an unlikely scenario.

"France probably won't have a 2025 budget." said ING Economics in a note, predicting that the country "is entering a new era of political instability". National Assembly Speaker Yael Braun-Pivet

urged Macron to waste no time in choosing a new premier. – AFP

Cathay removes video with Tiananmen joke

HONG KONG: Cathay Pacific said on Wednesday that it removed an inflight entertainment programme following a complaint about an episode from American TV show Family Guy that mentioned China's Tiananmen Square crackdown.

A Cathay passenger lodged a complaint after viewing a scene from the animated sitcom that

included a joke about Tiananmen. The airline said in a statement that it was aware of the incident and apologised to affected "We emphasise that the content of the

programme does not represent Cathay Pacific's standpoint, and have immediately arranged to have the programme removed as soon as possible," Cathay said.

Cathay said its inflight entertainment content was managed by a third-party provider, without naming the company. "We have promptly informed the service

provider of the seriousness of the incident, and have instructed them to thoroughly investigate the cause and strengthen oversight to ensure that similar incidents do not occur in the future."

Family Guy's pilot episode, aired in 1999 featured a throwaway gag where main character Peter Griffin said he had lied about "(standing) up to that tank in Tiananmen Square". Hong Kong's candlelight vigil to mark the

Tiananmen anniversary on June 4 has been halted since 2020, and its organisers are facing charges of subversion under a security law.

2021, Hong Kong passed censorship laws forbidding broadcasts that are contrary to the interests of national security though the rules do not explicitly cover content shown on flights - AFP

Amnesty accuses Israel of genocide

Group calls for ICC investigation

THE HAGUE: Amnesty International accused Israel of committing genocide against Palestinians in the Gaza war in a report published yesterday. The London-based human rights group

said it reached the conclusion after months of analysing incidents and statements of Israeli officials.

Amnesty said the legal threshold for the crime had been met, in its first such determination during an active armed conflict.

The 1948 Genocide Convention, enacted in the wake of the mass murder by Germany, defines genocide as "acts committed with intent to destroy, in whole or in part, a

Children's agency sets US\$9.9b fund goal

NEW YORK: The UN children's agency on Wednesday launched a US\$9.9 billion (RM44 billion) fundraising appeal to provide aid next year for millions of young people impacted by wars and other crises.

"The scale of children's humanitarian needs is at a historically high level, with more children impacted every day," said Unicef executive director Catherine Russell

The money will target 109 million children and will support access to primary healthcare facilities, mental health services, drinking water and education, malnutrition screening and genderbased violence mitigation.

"Looking ahead to next year, we estimate that 213 million children in 146 countries and territories will need humanitarian assistance over the course of the year - a staggeringly high number," Russell said.

Unicef's appeal comes at a time when humanitarian operations face a chronic funding crisis.

Last year, the agency appealed for US\$9.3

billion in its fundraising call. The largest appeal for funds – at over US\$1 billion – is for Afghanistan, followed by Sudan, the Democratic Republic of Congo, the Palestinian territories and Lebanon. – AFP

BODY OF HOSTAGE RECOVERED

TEL AVIV: Israeli Prime Minister Benjamin Netanyahu announced that the body of a Netanyahu announced that the body of a hostage had been recovered from the Gaza Strip. "In a special operation, the body of hostage Itay Svirsky, who was kidnapped on Oct 7 (2023) from *kibbutz* Beeri and murdered in captivity in January 2024, was brought back," Netanyahu said in a statement. The body of Svirsky, who was 38 when he was kidnapped during the attack, was recovered in an operation by the Shin Bet internal security agency, aided by the military. The Hostages and Missing Families Forum welcomed the return of Svirsky's body while demanding the release of the remaining hostages. – AFP

SYRIAN REBELS PUSH INTO HAMA

AMMAN: Syrian rebels said they had started pushing into Hama, a major city where progovernment forces backed by intense Russian airstrikes are trying to stave off a new rebel victory and halt the insurgents' new rebel victory and halt the insurgents' lightning advance. Rebel commander Hassan Abdul Ghany said they had begun to penetrate Hama. State media had earlier reported that pro-government forces had repelled an attack. Insurgents have been battling to try to enter Hama since Tuesday and there was heavy fighting with the Syrian army and allied groups supported by a Russian bombardment. – Reuters national, ethnical, racial or religious group". Israel has consistently rejected any accusation of genocide, saying it has respected international law and has a right to defend itself after the attack on Oct 7, 2023.

Israeli officials could not immediately be reached for comment on the report.

Israel launched its air and ground war in Gaza after gunmen attacked Israeli communities across the border 14 months ago, killing 1,200 people and taking over 250

hostages. Israel's military offensive since then has killed more than 44,400 Palestinians and injured many others. Palestinian and UN officials say there are no

Palestinian and UN officials say there are no safe areas left in Gaza, a tiny, densely populated and heavily built-up coastal territory. Most of Gaza's 2.3 million people have been internally displaced, some as many or 10 times. as 10 times

At hearings earlier this year before the UN's

International Court of Justice (ICJ) in The Hague, where Israel faces accusations of genocide brought by South Africa, lawyers for the country denied the charge.

They argued that there was no genocidal intent and no genocide in Israel's conduct of the war, whose stated objective is the eradication of Hamas. Presenting the report to journalists in The

Hague, Amnesty International Secretary-General Agnes Callamard said the conclusion had not been taken "lightly, politically, or preferentially".

"There is a genocide being committed. There is no doubt, not one doubt in our mind after six months of in-depth, focused research." Amnesty said it concluded that Israel and

the Israeli military committed at least three of the five acts banned by the 1948 Genocide Convention, namely killings, causing serious bodily or mental harm, and deliberately

inflicting conditions of life calculated to bring about a protected group's physical destruction.

Callamard said Amnesty had not set out to prove genocide but after reviewing the evidence and statements collectively, she said the only conclusion was that "Israel is intending and has intended to commit genocide

She said: "The assertion that Israel's war in Gaza aims solely to dismantle Hamas and not to physically destroy Palestinians as a national and ethnic group, that assertion simply does not stand up to scrutiny."

Amnesty urged the prosecutor of the International Criminal Court (ICC) to

The office of the prosecutor said in a statement that it is continuing investigations into alleged crimes committed in the Palestinian territories and is unable to provide further comment. – Reuters



Tanks roll into Khan Younis, 47 killed across Gaza

CAIRO: Israeli tanks pushed into northern parts of the Khan Younis area in the south of the Gaza Strip on Wednesday and Palestinian medics said further Israeli airstrikes had killed

at least 47 people across the enclave Residents said tanks advanced one day after the Israeli military issued new evacuation

orders, saying there had been rocket launches by Palestinian gunmen from the area. With shells crashing near residential areas, families left their homes and headed

westward toward the nearby humanitarian-designated area of Al-Mawasi.

Palestinian and UN officials said there were no safe areas left in Gaza and most of its 2.3 million people have been displaced multiple times.

An Israeli airstrike at a tent encampment in Al-Mawasi killed at least 17 people and wounded several, medics said. The Civil Emergency Service said the attack sparked fires in tents housing displaced families.

The Israeli military said the strike targeted gunmen operating from the humanitarian zone in Khan Younis.

"Following the strike, secondary explosions were identified, suggesting the presence of weaponry in the area," it said in a . statement

Another Israeli airstrike hit three houses in Gaza City, killing at least 10 people and wounding many others, the territory's emergency service said. Many victims remained trapped under the

rubble with rescue operations underway. There was no immediate army comment on this incident.

Medics said 11 people were killed in three airstrikes on areas in central Gaza, including six children and a medic. Five of the dead had been queuing outside a bakery, they said.

A further nine Palestinians were killed by

tank fire in Rafah, near the border with Egypt, medics said.

Israeli forces also fired on Kamal Adwan Hospital in Beit Lahiya in north Gaza for the fifth straight day, hospital director Hussam Abu Safiya said. Three of his medical staff had been wounded, one critically, on Tuesday night, he said.

"Drones are dropping bombs filled with shrapnel that injure anyone that dares to move," said Abu Safiya. "This situation is extremely urgent." Residents in three towns – Jabalia, Beit

Lahiya and Beit Hanoun – said Israeli forces had blown up dozens of houses.

Palestinians say Israel's army is trying to drive people out of the northern edge of Gaza with forced evacuations and bombardments to create a buffer zone. The Israeli army denies this and says it has returned to prevent Hamas fighters from regrouping. - Reuters

are wise.

However, they will be paid for tasks like managing a group of employees, making a delivery on time or successfully selling a pair of shoes to a demanding customer.

With that in mind, here is our suggestion. Children should do certain tasks around the house simply because they are part of the family. This can include responsibilities, such as taking care of their rooms, picking up their toys, helping to prepare meals, washing their own clothes, and yes, even taking out

On the other hand, it is fine to pay children household tasks that "go beyond the call of duty". This may include activities like mowing the lawn, washing the car, or, in the case of a responsible teenager, babysitting a younger brother or sister for an entire Saturday afternoon.

One final note: helping children learn how to give, save and spend their money is just as important as teaching them how to earn it.

Upholding human rights key to better public health

AS a trained HIV physician, it has been inspiring to witness the steady development of effective treatments for HIV.

The continual expansion of proven HIV-prevention tools has resulted in

Hir-prevention tools have resulted in life-saving benefits for so many people. However, it has also been heartbreaking to witness the obstruction of scientifically proven methods from reaching their full potential.

When I started my service in Malaysia in 1997, my HIV practice was overwhelmed with individuals who had overwheimed with individuals who have contracted the virus through injecting drugs. This starkly contrasted with my experience in Australia, where I received my medical education and training. While I saw many patients living with HIV, nearly none had acquired the virus through drug acquired the virus through drug injection. The reason quickly became clear.

Australia treated drug use as a public health issue, offering harm reduction services that allowed people who used drugs to protect themselves from HIV.

In contrast, Malaysia adopted a punitive and highly stigmatising approach to drug use, preventing people who used drugs from accessing harm reduction services or protecting themselves from HIV.

Drug use is prevalent in Australia and Malaysia, but the contrasting human rights environments led to vastly different public health consequences. This experience had a profound impact on my professional career and my personal perspective.

The Hippocratic Oath taken by all physicians mandates that we focus on helping people who are sick, and that we do no harm by our actions or inactions.

I realised that improving health outcomes for my clients required more than just a biomedical approach; I also had to become a strong advocate for their human rights.

Providing HIV prevention and treatment services to individuals who inject drugs, including those in prisons and other closed settings, led me to become deeply involved in drug policy reform. It became clear that aligning drug policy with human rights principles is essential for advancing public health. critics argued that Some

implementing harm reduction services in our country would be impossible. However, after years of overcoming resistance, we successfully introduced the programme – and it worked.

Since its implementation, needle-sharing has ceased to be the primary mode of HIV transmission in Malaysia, preventing thousands of new preventing thousands of infections.

Some critics claimed harm reduction would be too expensive, yet it ended up saving the country significant amounts of money. The global HIV response has shown that, as health workers, we cannot leave the responsibility of advocating for human rights to others. Human rights violations are keeping

our scientifically proven tools from being effective. Too many people are still being denied life-saving care simply because they belong to communities whose rights are being violated.

Many individuals who seek treatment for HIV at a late stage report that they delayed care out of fear of being ostracised, losing their jobs or facing mistreatment.

When we fail to address discrimination, HIV wins and humanity loses. The evidence is clear: without protecting everyone's human rights, we will not be able to end AIDS as a public health threat.

Rights, which I co-chaired, issued a recommendation urging that "practitioners and stakeholders across the health field ensure that all aspects of their work reflect and promote a commitment to human rights".

To protect public health by safeguarding human rights, the commission further recommended that those working in the health field collaborate with other sectors and communities, including human rights organisations, scientists and advocates focused on issues like climate justice, women's rights, LGBTQ+ rights, and racial and migrant justice.

We are at a critical juncture where human rights are under attack worldwide. Those attempting to strip away human rights often claim to be defending religious values but these claims are false.

I believe that protecting everyone's health by safeguarding their human rights honours Islamic teachings, fulfils its commitment to compassion and prioritises the preservation of life.

Upholding human rights means recognising the inherent value of every individual's life and understanding that our societies are stronger when everyone is treated with respect, dignity and inclusion.

Similarly, protecting public health requires ensuring that no one is left behind, recognising that none of us is truly safe until all of us are.

It is not for us to judge others but to take care of each other. Human rights belong to everyone, and upholding them is essential for allowing us all to be healthy and to thrive.

"By reducing bureaucratic barriers and investing in infrastructure, we aim to create an ecosystem where businesses can thrive." Despite global uncertainties, Rajan said,

Balancing subsidy rationalisation and market stability

PETALING JAYA: Malaysia is embarking on a pivotal journey towards economic resilience as the government reduces subsidies to alleviate cal pressure while ensuring market stability. MARC Ratings Bhd chief economist Dr Ray

Choy (*pic*) said the move has been the focus of policy discussions, reflecting the need for a balanced approach. "Subsidy rationalisation is not just about

reducing the fiscal burden but also about ensuring long-term economic sustainability," he said at the MARC360 Overview webinar yesterday.

Choy said the sentiment underscores the delicate balance between fiscal responsibility and shielding lower-income groups from adverse impacts. He added that the government's efforts have

been complemented by Bank Negara Malaysia's decision to maintain the Overnight Policy Rate at 3%, a move designed to foster economic growth while keeping inflation in check. "The central bank's cautious stance is vital in preventing unnecessary shocks to the financial system." In addition, the ringgit, which faced heightened volatility earlier this year, has seen signs of stabilisation amid these reforms, Choy said. "Investor confidence is gradually

"Investor confidence is gradually returning as Malaysia positions itself as a stable economy in the region," Choy said, adding that the country's trade dynamics are supporting the positive outlook.

"Malaysia has benefitted from shifts in global supply chains, particularly in key sectors like palm oil and semiconductors. Trade continues to play a crucial role, but sustaining

this momentum requires strategic long-term policies," he highlighted.

However, Choy said, despite the positive outlook, structural challenges persist. "High household debt and uneven wage

growth remain critical issues, with experts urging the government to prioritise workforce productivity and skills development. Pro-ductivity enhancement and workforce upskilling are essential if Malaysia is to meet its high-income nation targets."

Choy said the government's initiatives in Budget 2025, including investments in green energy, digital infrastructure and innovation, reflect a commitment to addressing these challenges. "These measures are aligned with global trends and the nation's aspiration to be a high-tech economy by 2030."

No official proposal from BRICS nations on dedollarisation: Tengku Zafrul

KUALA LUMPUR: There has been no official proposal agreed upon by BRICS member countries regarding dedollar-isation in trade matters, said Investment, Trade, and Industry Minister Tengku Datuk Seri Zafrul Abdul Aziz.

He said Malaysia, as a partner country in BRICS, is aware of the current situation, particularly about the threat made by US President-elect Donald Trump, who has proposed imposing 100% tariff on BRICS countries if they pursued the use of a new currency.

"Although one of the topics that were discussed during BRICS meetings in the past was related to reducing dependence on traditional trade currencies such as the US dollar, there has been no official proposal agreed upon for dedollarisation as of now," Tengku Zafrul said during Minister's Question Time in the Dewan Rakyat yesterday.

He was responding to a question from Young Syefura Othman (PH-Bentong) about Malaysia's stance as a BRICS partner regarding the potential 100% tariff increase by Trump.

Tengku Zafrul said Malaysia views BRICS as an increasingly important platform for presenting views and positions on regional economic issues through dialogue, forums, or discussions that are non-binding. At the same time, he acknowledged that

there is a high level of interdependence in the trade and economic relations between Malaysia and the US, especially in the semiconductor supply chain, where US companies are key investors in Malaysia. This complementary trade relationship

can be seen in statistics, where in 2023, the US was Malaysia's third largest trading partner, while Malaysia was the 19th largest trading partner of the US.

Therefore, any move to impose a 100% tariff would only harm both parties, who are mutually dependent on efforts to prevent disruptions in the global supply chain," said Tengku Zafrul.

He added that Malaysia, which is still not an official member of BRICS, would continue to closely monitor developments that could impact the country, considering that the US dollar still plays a significant role in the global financial system. "The use of other currencies by Malaysia

in trade and investment matters needs to be carefully examined by the government, and any decision on this matter should be based on the national interest and aligned with the country's current policies," he added. – Bernama

UOB: Asean-6 economic growth to hit 4.8% in 2025, outpace global average

KUALA LUMPUR: United Overseas Bank (UOB) forecasts that Asean-6 economic growth will reach 4.8% in 2025, surpassing the projected global average gross domestic product (GDP) growth of 3.2%.

UOB Asean economist Enrico Tanuwidjaja said Indonesia's GDP is expected to grow by 4.8%, Malaysia 5.3%, the Philippines 6.5%, Singapore 2.5%, Thailand 2.9% and Vietnam 6.8%

"Countries with large customer bases are likely to cushion the impact of global trade tensions," he said, adding that the trade and foreign direct investment outlook for these countries remains positive.

Tanuwidjaja was speaking at UOB Global Economics and Market Research's

Global Economics and Market Research's 2025 Macroeconomic Outlook Virtual Media Briefing yesterday. He elaborated that the ongoing shift in the global supply chain towards Asean, driven by the China Plus One Strategy, could further accelerate Asean-6 economic growth as trade tensions between the United

States and China intensify. Citing Donald Trump's first term as US President, Tanuwidjaja observed a trend of supply chain rerouting and rebalancing

across Asean, with Singapore emerging as a key destination. "Singapore is often the initial landing point for investors before they expand into the broader region. Sub-sequently, countries like Indonesia, Vietnam, Malaysia and Thailand could be beneficiaries out of Singapore," he

said Tanuwidiaia emphasised that Asean

will continue to attract quality investments, especially those related to the global diversification strategies in manufacturing and technology, as well as sectors targeting young and rising middle-income class markets with high consumption potential. "To capitalise on these opportunities,

Asean economies must prioritise steady structural transformation including human capital enhancement, creating investment-friendly regulations, and attracting investments in emerging sectors," he said.

Tanuwidjaja also highlighted Asean's untapped potential in consumption markets, as many of these areas are less affected by tariffs

these areas are less affected by tariffs dominating high-value and tech sectors, global investments are expected to flow into the region. On segmental beneficiaries, he said the finance and insurance sector received the highest share of investment, with over 40%, followed by manufacturing, professional and technical services, retail, transport and storage. – Bernama

"Malaysians are increasingly viewing digital assets like cryptocurrencies as a means of diversifying their investment portfolio. This is across all age and income groups, with the average investor aged 34.8 and a median deposit of RM100.

"Our customers also came from diverse industries – manufacturing, construction, engineering and education sectors. In an encouraging development for gender parity in the industry, we also saw a 17% increase in female customers this year, compared with a 14% increase in male customers," Chai said.

Luno is the world's first regulated digital asset exchange to offer syariah-compliant Ethereum staking, highlighting its commitment to customer needs. Deleum sets sights on Southeast Asia expansion

KUALA LUMPUR: Deleum Bhd is setting its sights on expansion in Southeast Asia after completing the acquisition of a 70% stake in PT OSA Industries Indonesia, group CEO Rao Abdullah said.

The US\$7 million (RM31 million) PT OSA Industries deal is expected to be completed in the first half of 2025.

"Our ambition is to go beyond Malaysia and Indonesia for now. We have the aspirations," Rao told a press conference yesterday after signing of a share purchase agreement with OSA Industries Pte Ltd for the acquisition of the majority stake in PT OSA Industries

After Indonesia, Deleum is looking at Thailand and Vietnam.

Rao stressed that Deleum is in a strong financial position with a solid balance sheet and a leading role in the gas industry. "So, as set by the chairman and board, we have

to put our cash to work and not just let it sit in the bank and earn 3% interest. We have to, yes, in

short, we are looking at many opportunities. "But we've got to make sure that at the same time, we don't want to bite more than what we can chew. We're mindful of that. And also, the industry has gone through a lot of ... it's a volatile industry let's face it. So, we don't want to get caught in that

either," he said

Rao said Deleum has undertaken a balanced approach to growth via organic and inorganic means

"Our financial position has enabled us to earnestly explore inorganic means of business expansion to catapult our growth, increase our presence, and enhance our suite of solutions to

better serve the energy majors." Organically, Deleum enlarged its revenue base from RM587 million to RM792 million from the financial years ended Dec 31, 2020 to 2023. Operating profits increased from RM27 million

to nearly RM80 million in the same time frame. The Deleum group, through its subsidiaries,

provides supporting specialised products and services to the oil and gas industry. Currently, Deleum's expansion into Indonesia focuses on control valves and pressure relief valves

as the core product line. In Malaysia, it has a market share of 36% for control valves, compared to 11% in Indonesia (for PT OSA Industries).For pressure relief valves, its market share in Malaysia is about 22%, compared

to 5% in Indonesia. "In terms of market size in Indonesia from opex, it's about US\$52 million, compared to Malaysia's approximately US\$25 million. So, there's a lot of opportunity in terms of the market size to tap into," Rao said.

He added that the expansion will also allow them to set the foundation to expand other product lines, particularly chemical.

"We have been working on chemicals but without a presence there, we couldn't move forward with it. This acquisition will allow us to expand our product line, which is the main focus for us. We are also very successful in the chemicals sector in Malaysia." Rao said.

PT OSA Industries is a supplier of valves and valve maintenance services in Indonesia, including for the oil and gas industry. Since 2017, it has been the sole channel partner for Baker Hughes valves such as safety and control valves, ball valves and actuators. PT OSA Industries serves energy majors supported by its service facility in Cikarang Indonesia.

Deleum said the acquisition will complement and fortify the existing technical expertise and capabilities of its valve management segment through Deleum Services Sdn Bhd's subsidiary, Penaga Dresser Sdn Bhd.

"It is the sole channel partner for Baker Hughes valves for the oil and gas, and energy industries in Malaysia. The location of service facilities in Terengganu, Johor, Sabah and Sarawak positions Penaga Dresser favourably to provide on-to-offshore services to international customers and principals," it said.

The purchase consideration of US\$7 million will be fulfilled via internally-generated funds and bank borrowings.

As part of the exercise, PT OSA Industries will provide a profit guarantee of US\$2.7 million cumulatively across the financial years ending Dec 31, 2024 and 2025.



Govt urged to enhance digital adoption, strengthen regulations and logistics for smoother cross-border trade

KUALA LUMPUR: Malaysia can leverage its mature digital infrastructure and skilled workforce to become the focal point for regional headquarters of multinational companies (MNC) and high-skilled services and manufacturing.

Strategic advisory firm Bower Group Asia associate director Darryl Tan said that Malaysia – as chairman of Asean in 2025 – and each Southeast Asian country, has a niche in the global value chain that they can leverage.

He cited how Singapore serves as the regional headquarters for many MNCs, while Malaysia serves as a high-skilled service and manu-facturing hub for these companies, and Indonesia and Vietnam focus more on the manufacturing side of the value chain.

As Malaysia assumes the chairmanship of Asean, Tan said, many of the strategies outlined by Prime Minister Datuk Seri Anwar Ibrahim support the vision of leveraging each member country's advantages.

"Together, they can make Asean a competitive hub," he said in response to questions raised during the Bernama Global news programme on Dec 4 by host Jessy Chahal regarding the topic "Southeast Asia's



markets. Navigating Challenges and Opportunities in 2025"

This includes fostering digital adoption at every level of the supply chain, increasing regulatory cooperation as well as increasing logistical linkages to enable smoother transactions of goods and expertise across borders. Tan said Putrajaya should also leverage its

significant investments in renewable energy to attract companies that want to set up environmentally sustainable manufacturing plants in the region.

He highlighted that Malaysia should take advantage of its regulatory and policymaking experience – for example, in the digital and energy sectors - and share this knowledge to foster stronger regulatory cohesiveness across the region.

"Deeper economic integration within the region will allow Asean to position itself as a hub

for businesses at every level of the supply chain," he said.

Asked about Malaysia's economic outlook, Tan said the country would benefit from the overall tech boost, as "we are a major exporter of semiconductors and electrical and electronics (E&E) products".

There will be stable growth next year, with the economy expanding by 4.5-5.5% supported by the continued demand for E&E goods, as multinational companies invest heavily in new technologies, particularly artificial intelligence Contributing to Malaysia's stability will also

Miti: No proposal for Malaysia to join New Development Bank so far

KUALA LUMPUR: There has been no proposal so far for Malaysia to join the New Development Bank (NDB), according to the Ministry of Investment, Trade and Industry (Miti) Miti said if there is a necessity to join the NDB,

Malaysia needs to be ready to contribute to this financial institution and this step will add to the country's existing financial commitments.

"The country needs to take into account the government's policy to limit the national debt to 65% of the gross domestic product (GDP) and only rely on local financial agencies, given that Malaysia has achieved the status of a graduate country among other multilateral development banks," it said in a written reply on the Dewan Negara website to a question by Senator Ros Suryati Alang who wanted to know if Malaysia would apply to become a member of the China-based NDB following the announcement of Malaysia becoming a partner country of BRICS.

The prospect of Malaysia's membership in the NDB was discussed by the Economy Minister with NDB president Dilma Rousseff during their meeting on the sidelines of the Heads of State and Government in the BRICS Outreach/BRICS Plus

Conference held in Kazan, Russia. Miti said NDB membership is open to all members of the United Nations regardless of whether the country is a BRICS member country or otherwise.

To determine whether Malaysia will enjoy the benefits of membership in the NDB, а comprehensive cost and benefit analysis needs to be carried out

"This analysis will consider the membership requirements, financial commitment and voting power of Malaysia in the NDB," it said.

Miti said the government needs to hold engagement sessions with relevant stakeholders, including economic and development agencies to get feedback to ensure membership in the NDB is in line with the country's development priorities. "As an initial preparation, Malaysia can apply to

be an observer in the NDB board meetings. "This step will give Malaysia the opportunity to get a clear picture of the NDB's operations and governance before joining it officially," it said. --Bernama

"We have not yet achieved our full capacity While our current capacity is about 220,000 tonnes, we are producing slightly over 100,000 tonnes. So, we still have extra capacity to cater to future demand," Leong said. "We will allocate part of the IPO proceeds to

R&D to enhance quality and explore future environmental, social, and governance compliant fertilisers'

The IPO entails the issuance of 210 million new shares and the sale of 50 million existing shares.

Nvidia signs deal to help build Thai 'sovereign cloud'

BANGKOK: US chip giant Nvidia signed a partnership with Thai tech company SIAM.AI on Wednesday to build the country's first 'sovereign cloud".

The deal was announced during a visit to Bangkok by Nvidia's Jensen Huang, CEO and founder of the leading semiconductor design business, during which he agreed to support the development of artificial intelligence in Thailand.

A "sovereign cloud" is the idea that a country, region or community will have control over its data - where it is stored, how it is

accessed, who oversees it. Huang said that the data stored on Thailand's sovereign cloud server could be used to power a local "Al ecosystem", such as a generative Al chatbot fed by Thai data.

It came after Huang said on Tuesday that it would work with the Thai government to develop "world-class Al infrastructure" in the kingdom.

On Wednesday, Huang added that Nvidia would partner with 40 Thai universities and over 50 startups so that local schools and enterprises "will have access to Thai AI".

"The data of Thailand ... it belongs to the Thai people. It is your natural resource.

According to data company OpenDataSoft, the sovereignty of the digital cloud "does a better job of protecting national interests by limiting third-party access to sensitive information".

Huang said the sovereign cloud could also be applied in Thailand's healthcare, agriculture, energy, digital and telecom sectors

Nvidia, which makes specialised computer chips used for training AI models, has surpassed Apple to become the highest-valued company in the world.

SIAM.AI is a cloud platform that offers virtual servers and data storage. Its CEO, Ratanaphon Wongnapachant, is

reportedly related to former prime minister Thaksin Shinawatra, who made an appe at the event.

Last year, then-prime minister Srettha Thavisin made a major push for investment from US tech giants during a trip to New York. Thailand is Southeast Asia's second-largest

economy, but its tech sector has lagged behind Singapore and Indonesia. – AFP

Bitcoin surges past US\$100,000 for first time

Traders cheer Trump pick of crypto proponent as SEC chairman

HONG KONG: Bitcoin burst past US\$100,000 (RM442,000) for the first time yesterday, while Seoul stocks slipped as South Korea's president faced impeachment after his brief imposition of martial law this week.

After hovering around the mid-US\$90,000 mark in recent weeks, the popular cryptocurrency finally shattered the historic level in Asia after incoming US president Donald Trump picked crypto proponent Paul Atkins to take over as chairman of the Securities and Exchange Commission (SEC). Atkins is founder of risk consultancy firm

Patomak Global Partners, whose clients include companies in the banking, trading and

cryptocurrency industries. Trump's transition team noted he had co-chaired the Digital Chamber of Commerce, which promotes the use of digital assets, since 2017.

Atkins "recognises that digital assets and other innovations are crucial to Making America Greater than Ever Before", Trump said. Stephen Innes at SPI Asset Management said

Atkins has "a track record of critiquing the SEC's tough stance on cryptocurrency firms". "This strategic move has electrified the crypto

community, fuelling investor optimism about a potentially more accommodating regulatory landscape under Atkins' watch."

After breaking the key level, bitcoin continued to push higher and hit a peak of US\$103,800 yesterday.

It has jumped more than 50% since Trump's victory – and around 140% since the turn of the year - on hopes the American president-elect will push through measures to deregulate

cryptocurrencies. On the election campaign trail, he pledged to make the United States the "bitcoin and cryptocurrency capital of the world".

The rally in bitcoin came as traders keep track of events in South Korea, after President Yoon Suk Yeol's dramatic declaration of martial law which was lifted within hours. The nation's opposition has now pushed for

his impeachment, while the defence minister has resigned over the crisis.

The upheaval comes as Asia's number-four economy struggles to gain traction, while worries build on the possible impact of Trump's presidency as he prepares to reignite his hardball trade policy when he takes power next month. But analysts saw some optimism. "The silver lining we think is that the swift

reversal of the martial law underscores the resilience of South Korea's institutions," said

analysts at BMI, a unit of Fitch Solutions. "For now, we expect limited implications for

the economy and financial markets as the Bank of Korea and the Ministry of Finance have responded swiftly by reassuring investors.

Trinh Nguyen, senior economist for emerging Asia at Natixis CIB, said the turmoil represented 'a growth shock rather than a sovereign risk".

Seoul's Kospi fell 0.9%, having finished more

than 1% down on Wednesday. And the won – which initially hit a two-year low when the crisis erupted - remained at around 1,415 per US dollar, slightly up from its levels before the martial law declaration on Tuesday.

Investors are also keeping tabs on France after the three-month-old government of Prime Minister Michel Barnier was brought down in a no-confidence vote linked to a controversial budget proposal. The news

news out of the eurozone's second-largest economy had been expected and the euro saw no major impact, but the move injected fresh uncertainty into an already fraught political situation in France after divisive elections earlier this year.

In early European exchanges, the euro was trading at US\$1.0544, a little stonger than recent days. Paris stocks opened marginally higher.

Most other markets in Asia rose, tracking a record for all three main indexes on Wall Street, where soft data on jobs and services boosted hopes for a Federal Reserve interest rate cut this month.

Tokyo, Shanghai, Sydney, Singapore, Wellington, Mumbai and Taipei advanced but Hong Kong, Jakarta and Manila slipped. London was flat at the open while Frankfurt was down. – AFP

Bharti Airtel seals 'multi-billion' dollar 4G, 5G agreement with Ericsson

MUMBAI: India's Bharti Airtel on Wednesday signed a "multi-billion" dollar deal with Swedish telecom equipment maker Ericsson to boost its 4G and 5G coverage in the world's second-largest smartphone market.

Under the deal, which Reuters reported in October, Bharti Airtel will buy and deploy equipment from Ericsson, likely in 2025. The companies did not disclose exact financial terms of the deal.

Demand from India's 5G market started to skyrocket last year, as Bharti Airtel and Jio,

telecommunications unit of Reliance

Industries, started to scale up 5G services.

Ericsson, Bharti Airtel's partner of more than two decades, will deploy centralised radio access network (RAN) and Open RAN-ready solutions, Bharti Airtel said in a press release.

Open RAN allows mobile operators to mix and match equipment from various suppliers, potentially increasing flexibility. Ericsson will also upgrade the software of

its deployed 4G radios, it said.

"This deployment will enable us to further improve the speed, reliability, and coverage of our network," Bharti Airtel's chief technology

officer Randeep Sekhon said in the release. The company did not immediately respond to Reuters' request for comment.

The deal comes after Ericsson won part of a US\$3.6 billion (RM15.9 billion) contract to sell 5G equipment to Vodafone Idea earlier this year. It shared the contract with Nokia and Samsung. The new deals are expected to boost

Ericsson's revenue next year, after a big fall in contracts from India in the first half of the year. Nokia also signed a "multi-billion" dollar deal with Bharti Airtel last month. - Reuters

France's Ubisoft to close San Francisco and Osaka studios

PARIS: France's largest video game maker Ubisoft has decided to As a result, Ubisoft will close its

San Francisco and Osaka production studios and ramp down production in Sydney, leading to a loss of 143 jobs in San Francisco and a likely reduction of 134 people in Osaka and Sydney.

Ubisoft said half of the XDefiant team worldwide would transition to other roles within the company.

"The decision follows a thorough review of the game's performance, profitability, and market conditions, and aligns with the company's increased selectivity in its R&D investments," the company said in a statement.

"Season 3 of XDefiant will still launch and servers will remain active until June 3, 2025."

It said that although *XDefiant* generated initial excitement, it did not retain a large enough player base to establish it as a viable competitor to other free-to-play first-person shooter titles or to support Ubisoft's continued investment in it.

"The cancellation of the project shows how tough the shooter market is, where it is difficult to break through among strong IPs that have dominated the segment for years," Erste Group analyst Piotr Bogusz said. Ubisoft said it would apply the lessons learned from *XDefiant* to its

lessons learned from *XDentant* to its future free-to-play titles. The French group has been plagued by delays and the underperformance of some key titles, including *Star Wars Outlaws* which lagged sales expectations after its August launch.

Its shares have lost half of their value so far this year. The company added that the Games-as-a-Service (GAAS) category remains its key strength and a central pillar of its strategy, with notable successes such as *Rainbow Six*, *The* Crew and For Honor. - Reuters





Passengers set to face higher fares from March despite transition to public ownership

LONDON: Britain's Labour government will carry out the first renationalisation of a private train operator in May, Transport Secretary Heidi Alexander announced on Wednesday.

Returning all of the country's rail operators into public ownership is among the key policies launched by Prime Minister Keir Starmer since his party's re-election five months ago. Train passengers in Britain suffer from frequent cancellations to their journeys in addition to high ticket prices.

"For too long, the British public has had to put up with rail services that simply don't work," Alexander said in a statement.

"A complex system of private train

operators has too often failed its users." Alexander said South Western

Railway, offering journeys between London and towns in southern England, will be the first to transfer into public ownership in May. This will be followed by two more

operators serving English towns and cities by late 2025. Despite the transition, passengers

are set to face higher fares from March, based on an annual government calculation. Alexander has been in the job just

a few days, replacing Louise Haigh

who resigned as transport secretary last Friday. That followed revelations that she

Staff at UK's Guardian strike over sister paper's planned sale

LONDON: Staff at Britain's The Guardian newspaper went on strike on Wednesday for the first time in more than 50 years over the proposed sale of its weekend sister paper *The Observer*.

Unionised staff members last month voted 93% in favour of the action, accusing the Scott Trust – the ultimate owner of Guardian Media Group (GMG) – of "betrayal" over the potential sale of The Observer, the world's oldest Sunday newspaper.

Around 500 journalists at both papers began the 48-hour strike against the sale to the online news group Tortoise Media. Tortoise said it had approached GMG with

an offer to buy the publication and invest more than £25 million (RM146 million) over the next five years in the "editorial and commercial renewal of the title".

"While we respect the right to strike, we do not believe a strike is the best course of action in this case and our talks with the National Union of Journalists continue," a *Guardian* spokesman said.

"We have a plan in place to minimise the impact of strike action on staff, readers and subscribers and we will continue to publish online and produce the print edition as usual," Tortoise, which is run by former BBC News director James Harding, says it will continue publishing The Observer and combine it with its own podcasts and live events.

More than 70 UK cultural figures, including Homeland star Damian Lewis, actors Mark Rylance, Hugh Grant, Sienna Miller and Ralph Fiennes, and Man Booker Prize winning author Julian Barnes called in an open letter for the Scott

Trust "to reject this ill-considered offer at once". "While Tortoise is a respected media outlet, we believe that the move would be disastrous for the world's oldest Sunday newspaper and its journalists, for *The Guardian* and for liberal journalism," the letter said.

GMG acquired The Observer, which was first published in 1791, in 1993. – AFP



JetBlue forecasts smaller 2024 revenue dip

NEW YORK: JetBlue Airways said on Wednesday it expects a smaller-than-expected drop in its 2024 revenue as domestic travel demand rebounded following the US presidential election.

JetBlue now expects annual revenue to decline between 3.5% and 4.5%, compared with the 4% to 5% fall projected earlier.

The airline had in October forecast a bigger-than-expected fall in 2024 revenue amid a moderation in domestic travel demand ahead of the US elections.

JetBlue said on Wednesday improved bookings closer to departure dates over the Thanksgiving week boosted revenue during the November holiday peak.

The New York-based airline also said bookings for December travel exceeded its previous expectations. JetBlue said it now expects its 2024 revenue

per available seat mile, a proxy for pricing power, to drop between 3% and 4%, compared with the 2.5% to 4.5% decline it estimated earlier. – Reuters

Zepbound tops Wegovy in weight loss trial

NEW YORK: Eli Lilly said on Wednesday patients on obesity drug Zepbound lost 47% more weight than those who were given Novo Nordisk's Wegovy in the first large, head-to-head trial of the highly in-demand rival medicines.

In the 751-person trial sponsored by Lilly, Zepbound helped patients lose an average of 20.2% of their weight after 72 weeks compared to 13.7% for the group treated with Wegovy, Lilly said. The data comparing the wildly popular

medicines shows for the first time that when trial parameters are the same, Lilly's drug is more effective for weight loss.

Participants were either obese or overweight and had an additional related health issue such as obstructive sleep apnea or heart disease. None of the trial subjects had diabetes.

Before the data was published, BMO Capital Markets analyst Evan Seigerman said in a note the market expects Lilly's drug to show superior efficacy.

A confirmation, however, "could be a A continuation, nowever, could be a differentiator when the market matures in the long-term and physicians are not capacity constrained, but can select... (a drug) more easily by efficacy alone – not availability", he wrote. US approvals for the medicines were based on separate trials in which Zepbound helped patient: lose more than 23% of their weight

patients lose more than 22% of their weight after 72 weeks, while Wegovy led to a 15% weight loss after 68 weeks.

Lilly said it would publish the results in a peer-reviewed journal and present it at a medical meeting next year. Novo Nordisk said it will wait for the

complete data, including the distribution of treatment doses in the two groups, after the trial

is peer-reviewed and published. It said Wegovy is the only obesity drug to reduce the risk of heart attack or stroke. The companies have been racing to get the

drugs approved to treat other ailments to help improve acceptance by insurers and governments.

American authorities approved Wegovy as a treatment for heart disease in March, while Zepbound is expected to get the green light as a treatment for obstructive sleep apnea.

Doctors had been prescribing the obesity drugs based on whichever was available to patients at the pharmacy given intermittent supply shortages.

The results may persuade insurers in the US and cost-conscious health authorities in Europe to give preferential coverage to Zepbound over

Both drugs are sold in the United States under different brand names – Novo's Ozempic and Lilly's Mounjaro – to treat type 2 diabetes. - Reuters

UOB forecasts 4.7% GDP growth for Malaysia next year

KUALA LUMPUR: United Overseas Bank (UOB) forecasts Malaysia's economy to grow 4.7% for 2025, reflecting normalisation from a high base effect, strong trade diversification and supportive domestic drivers. UOB senior economist (Malaysia) Julia Goh said Malaysia

continues to have strong domestic levers supported by its stable labour market conditions, ongoing investments, energy transition efforts, implementation of national masterplans and regional development despite higher external risks.

development despite higher external risks. "With a total expenditure budget of RM421 billion or 20.2% of GDP for next year, the fiscal engine remains expansionary despite a narrower fiscal deficit target of 3.8% of GDP. "Potential investments in the pipeline include RM25 billion by

government linked-investment companies (GLICs) alongside several public-private partnership projects, and more than RM40 billion worth of government construction projects to commence in 2025," she said at UOB Global Economics and Market Research's

2025 Macroeconomic Outlook virtual media briefing yesterday. Goh said that despite sound economic and financial fundamentals, the ringgit is vulnerable to external developments, especially the potential upcoming Trump tariffs which is expected to weigh on Asian foreign exchange.

She also expected the Qualified Resident Investor programme to offer flexibility for resident corporates to reinvest abroad after repatriation of foreign funds, and the liberalisation of foreign exchange policies for multilateral development banks and nonresident development financial institutions to issue ringgit-denominated debt securities for use in Malaysia and provide ringgit financing to resident entities. – Bernama

TO add to our previous report on the REIT's strategic roadmap, management highlighted that the RM1 billion in external acquisitions since mid-2023 exceeded the cumulative amount reached previously. We think these purchases have been productive, securing high-yielding assets with strong positioning in their respective subsegments. For example, the six giant hypermarkets (RMS20 million) immediately recorded a

six giant hypermarkets (RM520 million) immediately recorded a fair value gain of RM73 million, providing a yield of 8%, and enhancing the REIT's long-term earnings with a WALE of nine years vs SREIT's FY23 WALE of four years. Management expects to purchase more third-party assets, to reach its RM14 billion asset value target (currently at RM10 billion), as the pipeline from its sponsor could range RM1-2 billion. Sunway Resort Hotel's refurbishment has led to its average room rate doubling, while Sunway Carnival Mall post-renovation has enjoyed 50% higher retail sales psf. Looking ahead to FY25, near-term earnings growth should be driven by the AEIs for Sunway Carnival Mall's existing wing (to be completed in Q3'25) and Sunway Pyramid's Oasis segment which opened on Nov 1. The latter now records more than double the average rental rate from >100 smaller tenants, double the average rental rate from >100 smaller tenants, compared to its lower-yielding anchor tenant previously. These

include a wide variety of options, from the largest Muji in Malaysia to Caudalie Spa. Sunway REIT has had a long journey in sustainability, beginning with the establishment of its sustainability working group in 2015. Ringgit extends gains amid rising confidence of US rate cut

THE ringgit extended gains to close higher against the greenback yesterday on rising confidence that there will be another US interest rate cut in the middle of the month. At 6pm, the local currency bounced to 4.4250/4305 against the

US dollar, compared to Wednesday's close of 4.4505/4550. Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid said the ringgit was well supported with it rising as high

as RM4.4173 against the US dollar in the morning session but head lower to around RM4.4275 towards the end of the day. "(The) trend was in tandem with the decline in the US Dollar Index (DXY) to 106.206 points. It seems that the US Federal Reserve (Fed) is on track to reduce the Fed funds rate by (another) 25 basis points in the upcoming Federal Open Market Committee

(FOMC) meeting on Dec 17-18 as the US monetary policy remains restrictive and has affected the growth momentum. "The latest print on the ISM Index for the non-manufacturing sector at 52.1 points in November from 56 points previously

suggests that the US services sector is softening although it is still generally expansionary," he told Bernama. The ringgit also traded higher against other major currencies.

It strengthened versus the British pound to 5.6286/6356 from 5.6415/6472, appreciated against the euro to 4.6586/6644 from 4.6735/6782 and climbed against the Japanese yen to 2.9439/9478 from 2.9546/9580 at Wednesday's close.

The local unit traded mostly higher against Asean currencies. It improved against the Singapore dollar to 3.2985/3029 versus 3.3057/3093 on Wednesday, gained against the Indonesian rupiah to 278.9/279.4 from 279.2/279.6 and went up versus the Thai baht to 12.9462/9710 from 12.9563/9751 previously.



FROM its recent reporting, AMBANK had grown its loan books by only 2.4% CY24-YTD as opposed to the industry's 4.1%. This is attributed by the group's renewed focus to acquire better quality yet higher margin loans in the retail SME and mid corporation segments. To ensure a steady pipeline, AMBANK is building presence outside of Klang Valley which is largely untapped by the group, namely Penang and East Malaysia which are slated to see growth in their economic supply chain. Meanwhile, retail strategies entails being much less aggressive

in the mortgage markets, preferring to target higher value accounts (>RM750k homes) typically undertaken by more affluent customers with a better propensity to be cross sold other products (i.e. wealth management, insurance).

On the liabilities front, the group is recalibrating its funding sources to see a higher retail deposits mix, which was previously dominated by higher costing corporate wholesale accounts. Other considerations for funding also include debt instruments which also attract lower interest cost to the group. These efforts have translated to a healthier NIMs in Q2'25 at 1.96% (Q1'25: 1.89%, Q2'24: 1.82%) of which the group anticipates

sustaining throughout FY25. While AMBANK's cost-to-income ratio of 44% is below the

industry's average of 50%, it holds an aspired 40% level in its 2029 Strategy. This would elevate the group to being in the Top 3 in terms of cost efficiency while pumping up its return on assets. However, given continued investments into building its business banking unit as well as IT spends into big data and AI-related infrastructure, its cost-to-income ratio will not be expected to trail down in the near term

New chapter in The Cure's history

Songs of a Lost World is prime goth served with extra helpings of gloom

ELL, what do you know, there is FLL, what do you know, there is still a market for slow burn gothic gloom in a world seemingly dominated by K-pop and massive pop starlets such as Taylor Swift, Sabrina

Carpenter and Olivia Rodrigo. Songs of a Lost World is The Cure's first new music in 16 years and, lo and behold, it hit number one on the UK Album Charts shortly after its Nov 1 release. But, is it a mere exercise in nostalgia or can it be compared with the band's significant back catalogue. It was also one of the fastest selling albums of 2024, having

at one point outsold the entire top 10 of the week combined in the UK. It also reached number one in Austria, Belgium, Denmark, France, Germany, Netherlands, Poland. Sweden and Switzerland.

Switzerland. Is it a dark introspective work that recalls *Disintegration* and *Wish*, or does it have the radio-friendly pop sound that established the band as steady chart staple in the 1980s?

Make no mistake, this long player is very much the dark, brooding variety with songs constantly pushing past six minutes, with album closer *End Song* hitting the 10-minute mark.

10-minute mark. This alone gives a clear indication where the band is at with its approach, favouring long passages of atmospheric gloom washing over listeners with its deep introspection. Teaser single *Alone* is suitably dark and

atmospheric, shrouding the listener with a thick blanket of gloom-like dark, heavy drapes that

cut out the sunlight. Far from being a depressive listen, it envelopes the listener in the comforts of solitude with Robert Smith's vocals hitting all the right bittersweet notes. Taking inspiration from a poem by Ernest Dawson titled *Dregs*, the tune is full of references to mortality and the fragility of life.

Deep sense of melancholy continues on And *Nothing Is Forever* made all the grander with the introduction of a string section that elevates the tune beyond the ordinary. A song about ties that withstand the passage of time, Smith sings it the e appropriate vigour of statesman. No *Lovecats*-style with elder

playfulness here.

A Fragile Thing was also released as a single which sees the band revisiting the soundscapes of its epic *Disintegration* album while *Drone: Nodrone* sees it dipping its collective toe in heavier

waters with a gargantuan riff. Waters with a gargantuan riff. Completely written, conceived and produced by Smith, this album obviously carries his deep sense of pathos and grief, best exemplified by *I Can Never Say Goodbye* that was written about his brother's passing. While this is not a classic album, it does hold its own and is a worthy addition to the band's

discography. Maybe music fans just need a dollop of darkness to balance the multi-colour day glo of today's pop stars. This is a very welcome return for Smith and co, underlining this veteran outfit still has logs in it legs in it.

Songs of a Lost World is available to stream on all major platforms. Vinyl editions have been spotted with price tags upwards of RM180.

Hits and misses in music department One of the most anticipated aspects of any One of the most anticipated aspects of any Disney movie is its music and Moana 2 does not shy away from ambitious numbers. With contributions from Abigail Barlow, Emily Bear, Opetaia Foa'i and Mark Mancina, the soundtrack offers a mix of uplifting anthems and soulful ballads. However, the results are uneven. A few songs, such as Moana's stirring solo chart determination bit all the right notes

about determination, hit all the right notes and evoke the same magic as *How Far I'll Go*. Others, particularly some of the comedic numbers, fall flat or feel too forced. Maui's big song moment does not quite recapture the charm of *You're Welcome* but Dwayne Johnson's charismatic delivery helps elevate it. Jaecoo J7 has everything you need in an SUV, no wonder it is so popular


T IS said that there are over 150 car brands currently active in China. So, it should not come as a surprise Lethat we are hearing of a new Chinese brand launched here on a near monthly basis.

Some brands we are familiar with, and some we are not. Take Jaecoo for example, just about a year ago, the Chinese brand was largely

unheard of in Malaysia. But today, it is leading the charge to solidify the position of Chinese brands in Malaysia, particularly those under the Chery umbrolle umbrella.

As far as brands go, Jaecoo is still in its infancy in the grand scale of global automotive brands. While some brands have been at it for over a century, Jaecoo was only established in 2023, together with Omoda.

Both Jaecoo and Omoda, collectively known as the O&J, were established by the Chery Group in the early part of 2023 to cater for export markets, and as such are only available



in markets outside of China

According to online literature, the Jaecoo name is based on the German word Jager which stands for hunter, and the English word - cool.

The brand was introduced to Malaysia earlier this year to much fanfare with the J7 being the first model to fly the Jaecoo flag. The J7 was an immediate hit and is







loved for its good looks and features with some saying that it is the best value for money SUV currently in the Malaysian market.

In fact, according to the official registration figures from JPJ, the Jaecoo J7 was the best-selling non-national SUV for the month of October.

And after spending a few days with the J7 All-Wheel-Drive (AWD) variant, we understand what makes it so popular

Dashing good looks

Simply put, the J7 does not have an

ugly side to it. No matter which way you look, the J7 is a good-looking SUV.

The vertical louvred front grille is quite imposing on the road and when quite imposing on the road and when paired with that pixelated daytime running light, it makes the front end of the car look quite unique and unlike any other car in the market.

Compare the design of the I7 to the usual suspects from Honda and Toyota, the I7 seems a lot more outlandish, and in this instance, that's a good thing. Even those 19-inch wheels that it

rolls on look great out of the box. Also, some say that the design of the

J7 looks like it was inspired by Range Rover, but this writer struggled to find the similarity. I squinted, bent down, looked at it

through my fingers and tried every angle to find an element from Range Rover but found none.

I'll say that it is good-looking and unique, but a Range Rover it is not. But then I stepped inside and found what I was looking for.

Simplistic yet modern interior

When you first step inside, the then you instrate information interior seems minimalistic yet futuristic. The dash is utterly dominated by a massive 14.8-inch infotainment screen that looks like it may rotate, but it does not.

It is through that screen that you access all of the car's controls, including air-conditioning, entertainment, select one of the seven drive modes and even access safety systems such as lane departure warning and window locks.

You also must dive deep into the layers of menu to open or close the shade for the panoramic roof.

At first this may seem like an inconvenience because you constantly must take your eyes off the road, much to the detriment of the eye movement radar placed behind the steering wheel, that in turn scolds you for taking your eyes off the road by emitting constant But the good thing here is that

because the screen is gigantic and you soon memorise where all the controls are, it becomes easier to navigate the controls hidden behind the layers of software.

And then, there is the Range Rover inspiration, and that lays with the steering wheel as well as the seats. Now these do look like they came off


the iconic British marque, but they don't only look great but feel good too.

The steering wheel feels chunky though those haptic buttons require some getting used to and are not very friendly for sweaty palms. But they work better than those on a Mercedes Benz or a Volkswagen. Then there are the seats - big,

comfortable and ventilated as well. And that makes them perfect for daily life on Malaysian roads. There is also some inspiration from

Volvo as well, namely the vertical air-conditioning vents up front.

The instrument cluster on the other hand is also digital and measures in at 10.25 inches. And in typical Chinese fashion, it tries to feed you too much information than is necessary, and that makes it difficult to read sometimes.





Decent 412-litres of boot space.

But just like the infotainment screen, you get used to it after you figure out where everything is.

Fantastic, but how does it drive?

Better than you would imagine, and when compared to its Japanese competitors, it has to be said that its

refinement levels is quite impressive. At highway speeds, the interior is hushed while the suspension does a stellar job at isolating the cabin from the road, absorbing dips, ruts and everything the road can throw at it.

Wind noise too is down to a level that is barely audible except at some seriously illegal speeds. And this is achieved through the use of double panel windows, which is not something you usually get at this price range. Handling is impressive as well with

the suspension working to minimise body roll when the roads get interesting.

And the Jaecoo team deserves some credit for this because finding the sweet spot between comfort and control is something not all car makers are capable of.

In fact, Chinese car makers are notorious for putting out overly soft suspension that sometimes nauseates passengers. So, we tip our hat to the



team at Jaecoo for how the J7 handles and feels.

What about the powertrain?

Powering the J7 All-Wheel-Drive model is a 1.6-litre, four-cylinder, turbocharged engine putting out 194hp and 290Nm of torque.

It is not exactly the final word in power for its segment and there are times when you wish there was more power on tap.

This is further accentuated by the obvious turbo lag particularly in

Normal drive mode. To counter this, you are better off driving in Sport mode, but that makes the accelerator feel a little too choppy and difficult to modulate.

Steering mounted pedal shifters would have been brilliant but you can also shift gears manually using the You must adjust your driving style to the J7 as there are things about it that takes some getting used to. Speaking of drive modes, there are a

total of seven different driving modes for this variant (the two-wheel-drive model gets three driving modes), and those are just way too many driving modes.

Just to sate your curiosity, the seven modes are – Eco, Normal, Sport, Sand, Mud, Snowfield and Off Road. Jaecoo markets the J7 as an urban

off-roader and even when it was first launched, the Malaysian Jaecoo team was keen to show off its

off-roading prowess by getting members of the Malaysian automotive media to drive the J7 on an off-road course in Semenvih.

The I7 handled the course like a champ, and it is comforting to know the SUV has a water wadding capability of 600mm with a ground clearance of 200mm.

That is great to have particularly during the monsoon season, but we doubt many owners will be taking the J7 off-roading.

However, should you decide to visit a durian plantation, selecting one of those drive modes is just a turn of a knob away, making it incredibly easy to

switch modes. The one thing about the AWD variant is that it can be quite thirsty, with the official fuel consumption figure putting it at 7.7-litres per 100km, while we saw a real-world figure of 8.5-litres per 100km.

But that is to be expected of an AWD car since all four wheels are constantly CX-5 2.5T has an AWD powertrain, and the fuel needle drops like an anchor on highways

So, what gives?

There is no such thing as perfection

and there is bound to be something or other that has to be sacrificed. For the Jaecoo J7, the handling of the car is something to look out for.

We felt a disconnection between the steering wheel and the wheels up ahead with dull spot in the middle where the steering simply did not respond. Next is the spaciousness, taller

drivers and passengers may find the seats up ahead to be a little cramped, but the rear seats are fine if you are about six foot tall. Any taller and you may find your knees rubbing against the front seats.

Then there is the single airconditioning vent at the back, which is quite odd for a people-moving SUV. If you have kids, they are surely going to be arguing over who gets the

A/C vent, but there are two USB ports at the back so they might be distracted with their noses in their devices

Should you buy one then?

At RM148,000, the simple answer is yes, the Jaecoo J7 AWD variant is a nice SUV that seemingly checks all the boxes in our list. It is not a perfect package, but most cars fall short of that accolade as well. It also comes with the best warranty

package in its segment, with a seven-year or 150,000km warranty on the car, and a 10-year or one-million-kilometre warranty on the powertrain.

And as we explained in our video review of the Jaecoo J7, that is the icing on a very nice cake and should put to rest any negative perceptions about Chinese brands.



downforce. A larger diffuser enhances stability, while carbon fibre aerodisc wheel

covers reduce air resistance. These combined modifications enable the car to generate over 1,000kg of downforce at speeds of 284kph.

Beyond its aerodynamic tweaks, the Manthey kit also includes mechanical upgrades. The package also features aesthetic touches.

Manthey's engineers spent two years developing the kit, subjecting it to extensive

testing across European racetracks. The company has hinted at plans to showcase its performance with a timed lap at the Nurburgring. For GT3 RS owners eager to upgrade, the

Tough transition for ageing Aussies

INCOMING Cricket Australia (CA) boss Todd Greenberg said Australia will need tough conversations about regenerating an ageing team amid concerns of a coming exodus of senior players.

Australia fielded only one player under 30 in debutant opener Nathan McSweeney in the first Test against India in Perth where Pat Cummins' side were thrashed by 295 runs.

Greenberg, who will take over from Chief Executive Nick Hockley at the end of the year, acknowledged the challenge facing Australia, while noting players are enjoying longer careers due to better management.

"We do have a more ageing side, particularly in red-ball cricket, and that won't be easy," Greenberg told Australian media in Adelaide yesterday. "There have to be hard and

honest conversations between players and staff, and I think those are happening, to be

fair. "In saying that, though, the professionalism of modern athletes are tending to take them longer in their careers; the way we take care of them, the way we rehab them, the way they take care of themselves

"I think it's a very fine balance."

Windies duo fined for behaviour

WEST INDIES cricketers Jayden Seales and Kevin Sinclair were both fined yesterday for breaching the International Cricket Council's code of conduct during the second Test defeat by Bangladesh.

Fast bowler Seales was fined 25% of his match fee "for making aggressive gestures" towards the Bangladesh team after taking a wicket. He also received one demerit point for the offence.

All-rounder Sinclair, who was not in the original XI but came on as a substitute fielder, was docked 15% of his match fee for sledging. The ICC said he "ignored

warnings" from the umpires and "continued using aggressive language" towa Bangladesh players. towards the

Seales recorded outstanding figures of 4-5 in 15.5 overs in Bangladesh's first innings in Jamaica, but the tourists won the match by 101 runs to level the two-match series.







LPGA bars players who have gone through male pubertv

THE Ladies Professional Golf Association (LPGA) updated its gender policy yesterday, and players assigned male at birth and who have gone through male puberty will not be eligible to compete.

The new policy comes into effect in the 2025 season, and covers the LPGA Tour, Epson Tour, Ladies European Tour, and all other elite LPGA all other elite LPGA competitions, where athletes who are assigned female at birth are eligible to compete. "Our policy is reflective of an

extensive, science-based and inclusive approach," LPGA Commissioner Mollie Marcoux Samaan said in a statement.

"The policy represents our continued commitment to ensuring that all feel welcome within our organization, while preserving the fairness and competitive equity of our elite competitions."

The policy was informed by a working group of top experts in medicine, science, sport physiology, golf performance and gender policy law, the LPGA said

This working group advised that the effects of male puberty give competitive advantages in golf performance compared to players who have not undergone male puberty. A player whose sex assigned

at birth is male must satisfy an expert panel that they have not experienced any part of male puberty, and since receiving gender reassignment treatment concentration testosterone in their serum

must remain below a set limit. Trans golfer Hailey Davidson, who came up short in an LPGA qualifying event in October, had hoped to get into a few Epson Tour events next year but said on social media yesterday that she was "banned" from both circuits

circuits. "All the silence and people wanting to stay 'neutral' thanks for absolutely nothing," she wrote on *Instagram*. "This happened because of all your silence." – Reuters

Perez replacement to be named after Abu Dhabi race

RED BULL chiefs will reportedly meet on Monday, hours after the Abu Dhabi Grand Prix, to finalise Max Verstappen's teammate for the 2025 season.

Sergio Perez is set to finish nearly 300 points behind his teammate in the Drivers' Championship and speculation has persisted for months over his future.

Autosport claim that Perez is heading for the exit and will be replaced by Liam Lawson, who would step up from VCARB after taking over from Daniel Ricciardo mid-season.

Lawson, Yuki Tsunoda and Franco Colapinto were all thought to be in the running for a position at Red Bull, but the New Zealander is expected to be given the nod over his rivals.

Red Bull shareholders are meeting on Monday to discuss the second seat, amongst other end-ofseason matters, with patience running out for the 34-year-old.

The Mexican driver has consistently reiterated that he would be in place at Red Bull for the 2025 season, as per his contract, but has finished on the podium just four times this season - all of them coming in the first five races of the campaign.

"I'm going to let Checo (Perez) come to his own conclusions; nobody's forcing him one way or another," team principal Christian Horner said after another DNF in Oatar last time out. "It's not a nice situation for him to obviously be in." Colapinto's emergence at Williams had

appeared to be the ideal solution, with James Vowles' side already committing to Carlos Sainz and Alex Albon moving forward, before the Argentine made an impressive start to life on the F1 grid.

With Colapinto's future unclear, he began picking up points for the team having replaced Logan Sargeant.

But recent expensive crashes in Brazil and Las

Vegas, coupled with an expected eight-figure fee for Williams to release their reserve driver, has since put Red Bull off the prospect of hiring an external candidate

Since Lawson replaced Ricciardo at VCARB. many felt that he was in a straight shoot-out with

teammate Tsunoda for a promotion. After the 22-year-old stepped in at the United States Grand Prix, Tsunoda has finished higher than Lawson on three occasions, with the Kiwi doing so twice, proving an incredibly difficult decision to make for the Red Bull hierarchy. For Perez, there is no obvious route back to the

grid next season and it remains to be seen what terms he will leave Red Bull on.

He could become the team's reserve driver after Hadjar's promotion, or wait until 2026 when new team General Motors-Cadillac enters the fray. -Express Newspapers

ATALANTA take on AC Milan tomorrow (3.45am Malaysian time) with Serie A's top spot in their sights and a growing belief that this could be their year for unprecedented *Scudetto* glory.

A point behind current leaders Napoli, Atalanta are gunning for a club record-equalling ninth straight win in Italy's top flight and are for the first time in their history, genuine title challengers.

Atalanta have never finished higher than third in Serie A, which they did three seasons in a row between 2019 and 2021 with a thrilling team featuring an all-action attack of Josip Ilicic, Duvan Zapata and Papu Gomez.

However the current line-up, still on a high from last year's historic Europa League triumph and the division's top scorers with 36 goals, looks capable of going even further in Gian Piero Gasperini's ninth season as coach.

Atalanta have won 11 of 12 matches in all competitions drawing the other - since the start of October and after Monday night's 2-0 success at Roma, Claudio Ranieri said they were

"ready, really ready" to fight for the league crown.

Winning the Europa League really helped those who took part in it grow as players, and a lot of new faces have arrived who are also developing. That's the reason for these results," said Gasperini after his team hit Young Boys for six last month.

A win over Milan would put Atalanta top at least for two days as Napoli host Lazio on Monday and equal a Serie A wins record established in 2020 when Bergamo was the European

Former Harimau Malaya manager says Hamidin made right move not to defend post

HE decision by Football Association of Malaysia (FAM) president Tan Sri Hamidin Mohd Amin not to defend his

position at next year's election is the right move, according to former national team manager Datuk Kamarul Ariffin Mohd Shahar. He said it reflects Hamidin's sense of accountability in the wake of recent issues and controversies surrounding the national team and

his leadership. "Knowing him, I believe he is taking full responsibility by not defending the position, especially since all sorts of rumours have emerged lately

"Given all the speculation, the national team's Asian Cup by now and the sudden departure of Kim Pan Gon, which disrupted the team's progress, I think his decision is timely.

"It gives opportunities for new faces to step forward and contest," said Kamarul, who managed the Harimau Malaya squad during the 2023 Asian Cup, when contacted by Bernama Yesterday, Hamidin, who has held the top

position in FAM since July 2018, announced he would not defend his presidency at the 2025-29 term FAM Election Congress, scheduled for Feb 15

. He said the decision was made to give way to new leadership capable of bringing FAM to greater heights.

greater heights. Meanwhile, FAM deputy president Datuk Mohd Yusoff Mahadi said Hamidin's departure would be a big loss, as he has contributed to the growth of Malaysian football, including "We will feel the loss of someone who has

brought change to our football. Over his approximately six years in FAM, he has positioned the association in a better place than before.

"Whoever steps forward to replace him must take on this responsibility. In my opinion, this is a high-stakes role that will determine FAM's future. Affiliates need to carefully consider and choose the right person to ensure continuity," he said.

Hamidin's appointent as the FAM chief to replace Johor Regent Tunku Mahkota Ismail was announced at the 54th FAM Congress.

Hamidin then retained the post unopposed for the 2021-25 term at the 57th FAM Congress.

He is a member of the FIFA Council for the 2023-27 term and serves on the Executive Committee of the Asian Football Confederation (AFC), where he has been appointed as the chairman of the AFC Finance Committee. – Bernama
