PUTRAJAYA: The of practice excessive "sharenting" by a few parents has opened up opportunities for online crimes, especially involving children, said Communications Minister Fahmi Fadzil. He said there are parents who

"over share" their children's school information, including uniforms and badges, allowing irresponsible

parties to misuse the information. Speaking at the ministry's monthly assembly for December vesterday. Fahmi reminded parents not to allow children aged under 13 to have social media accounts and to be careful when sharing information online.

## 'Medication vending machines could ease healthcare strain'

Experts highlight benefits but call for stronger security and regulatory frameworks to prevent abuse

**PETALING JAYA:** As Malaysia continues to grapple with long queues in public hospitals and clinics, the idea of vending machines dispensing medication and medical certificates (MC) has sparked interest among health professionals.

Singapore has already implemented such machines as a convenient way to access basic healthcare.

However, concerns have been raised regarding potential data breaches and the need tighten regulatory frameworks to uphold healthcare standards.

Universiti Kebangsaan Malaysia public health medicine specialist Prof Dr Sharifa Ezat Wan Puteh said: "Vending machines could be viable in urban areas due to greater IT and health literacy, but they may present a challenge in rural areas, even though one of the objectives of vending machines is to cater to objectives of vending machines is to cater to such settings."

Sharifa Ezat noted that while such technology could enhance convenience, there are risks of hacking or database interception, which could increase the cost of treatment due to the expensive security investments required for implementation.

She also expressed concerns about the ability of vending machines to manage patients with complex medical histories, as a doctor would still need to examine the patient first.

However, she added that the model might work for those with fewer comorbidities.

Sharifa Ezat stressed the importance of strict regulatory frameworks to ensure vending machines comply with healthcare standards. "Malaysia needs to invest in 'health Al' and strengthen the averian Data Detection A to the

strengthen the existing Data Protection Act to ensure data is not leaked, hacked or sold elsewhere?

In terms of ethical considerations, she said vending machines would not entirely replace human interaction as consultations – whether in-person or online – would still involve a doctor.

Despite this, she acknowledged the potential for abuse as online consultations could lead to illegitimate MC claims.

"If implemented, vending machines could significantly impact the healthcare landscape by reducing the need for general practitioners and clinics. It would also reduce congestion, waiting times, and improve treatment access and compliance."

and compliance." Federation of Malaysian Consumers Associations vice-president Datuk Indrani Thuraisingham highlighted successful implementations of medication vending machines in Japan, Australia and the Uk where consumer safety, accessibility and robust regulatory oversight are prioritised.

She noted that vending machines can improve healthcare access, particularly in underserved areas.

"India has introduced mobile medical vans equipped with vending machines in rural areas, connecting patients with teleconsultations and medication dispensation."

Indrani pointed to Japan's highly regulated

approach, where vending machines dispense only over-the-counter drugs, while prescription medications require pharmacist involvement and integration with monitoring systems to track expiry dates and inventory. "In China and Singapore, telemedicine kiosks integrated with vending machines have

helped build consumer trust. These systems combine remote doctor consultations with medication dispensing to ensure a balance between automation and human oversight. "The UK and South Korea have centralised

databases and periodic audits to prevent misuse. Such measures are essential for maintaining accountability and ensuring compliance with healthcare standards."

Indrani also referenced Canada's telemedicine practices, where diagnoses are cross-verified by licensed professionals to "Privacy must be a priority, especially when

ensitive medical information is involved," she added.

On the economic front, Indrani noted that vending machines could complement existing healthcare providers.

In China and Australia, vending machine operators partner with pharmacies and clinics to share revenue.

"This reduces competition and enhances accessibility. Malaysia should consider a similar collaborative approach." Indrani believes Malaysia could significantly benefit from medication vending

machines, particularly given the current strain on the public healthcare system.

"With careful planning and the adaptation of global best practices, Malaysia has the potential to revolutionise its healthcare system through innovative solutions like vending machines.

## Be responsible in managing fire hazards, public urged

Houseowners need to be prepared by having at least one fire extinguisher and installing smoke detectors: Fire safety chief

PETALING JAYA: With fire outbreaks in the country remaining high, Putrajaya Fire and Rescue Department Fire Safety Division director Datuk Khirudin Drahman Hussain has called on the public to be more responsible in managing fire hazards.

"There were 34,389 fire-related calls in 2023, with 4,573 incidents involving properties such as factories and homes. The losses caused by these fires are estimated to be around RM2.6 billion."

On Dec 15, three premises believed to house a furniture and cardboard factory were completely razed at Taman Perindustrian Alam Jaya in Bandar Puncak Alam, Selangor.

On Nov 15, an elderly woman died when a fire broke out, affecting two houses in Kampung Muhibbah in Ranau, Sabah. One was razed while the other sustained 50% damage

Khirudin said household fires are often caused by improper use of electrical appliances, unattended flames and poor housekeeping.

"Many house fires begin as small incidents but escalate due to negligence. Most homeowners lack fire detection devices or fire fire detection devices or fire extinguishers, and panic when a fire breaks out. "Households need to have at

least one fire extinguisher and if possible, instal smoke detectors in bedrooms for early warning. Having fire insurance is equally important." He said public education, community-driven initiatives,

awareness programmes and on-ground leadership are vital to fostering a culture of fire prevention.

Insurance company Zurich Malaysia reported in 2021 that 59%

of Malaysian homeowners do not have fire coverage, and 43% are unaware that basic home insurance does not automatically cover assets and fixtures inside their homes.

On Dec 10, Advokasi Perusahaan dan Industri managing director Datuk Fazli Nordin urged immediate action to address weak enforcement and apathetic attitudes toward fire safety in Malaysia's industrial zones. "Lives are at stake. Major fires or

industrial accidents can harm Malaysia's reputation as a Malaysia's reputation as a manufacturing and investment hub. Greater oversight is needed in conducting safety checks and issuing permits, with agencies like the Malaysian Anti-Corruption Commission playing a critical role." Khirudin said fires involving factories mostly resulted from non-compliance with standard operating procedures. "Industrial fires often occur during production, material transfers or manufacturing processes. Poor supervision and inadequate prevention measures

inadequate prevention measures contribute to the problem.

"Poor maintenance and housekeeping of machinery are significant factors, with factories that are improperly maintained being more prone to fires," he said.

He urged companies to prioritise e upkeep of their firefighting the equipment, warning that "in manufacturing facilities, this isn't optional but essential".

Khirudin said trained personnel should also be available to address

minor fire incidents before they escalate, and emphasised the importance of equipping Malaysians with basic fire safety knowledge to handle fire outbreaks. "In case of a fire, ensure everyone is evacuated, and

immediately call the fire department. department." He said early fire prevention is key, and one must always be prepared, even when there is no fire. "Identify the nearest emergency with income home and discuss for

exit in your home and discuss a fire

evacuation plan with your family. "Ensure everyone understands what to do in case of a fire and hold practical drills regularly to keep it

fresh in their memory," he said. "Empowering communities to safeguard their environments not only prevents fires but also strengthens resilience.

"Simple yet consistent efforts can make a difference."

## Private prosecution appeal dismissed

PUTRAJAYA: The Court of Appeal yesterday dismissed a final appeal Global Human Rights Federation president S. Shashi Kumar to initiate president S. Shashi Kumar to initiate private prosecution against preachers Muhammad Zamri Vinoth Kalimuthu and Firdaus Wong Wan Hung, who have been charged with insulting beliefs and religious practices of non-Muslims.

In a unanimous decision, Judge Datuk Ahmad Zaidi Ibrahim, leading a three-judge panel, said Shashi failed to convince the panel of the error committed by Shah Alam High Court Judicial Commissioner Dr Wendy Ooi Su Ghee and Magistrate Mohamad Redza Azhar Rezali in the case.

"The magistrate's decision to dismiss the appellant's application and not continue the appellant's examination in this case is correct

and not a mistake. "This court finds that both appeals are without merit, so the appellant's appeal is dismissed and the decision of the Magistrate's Court, confirmed by the High Court, is upheld," said Ahmad Zaidi.

The other two judges on the panel were Datuk Mohd Nazlan Mohd Ghazali and Datuk Mohamed Zaini Mazlan. In 2020, police investigated the

two preachers under Section 298A of the Penal Code for allegedly inciting enmity between different groups on religious or racial grounds.

On Jan 8, 2021, Shashi applied to conduct private prosecution at the Shah Alam Magistrate's Court.

On Sept 3, 2021, Magistrate

Mohamad Redza dismissed the application on the grounds that police investigation against Zamri was rendered "No Further Action", while the probe against Firdaus was

still in progress at the time. Following the decision, Shashi filed an appeal at the Shah Alam High Court, and in March 2023, the court upheld the decision by the magistrate, Bernama reported. A private prosecution is

prosecution conducted by a private individual or entity, rather than a prosecuting authority with statutory power to prosecute.

Prior to this, during a proceeding at the Court of Appeal, the court was informed by the prosecution that the Attorney-General's Chambers decided not to pursue the charges against the two preachers.

Local craftswoman inspiring netizens with creations made from discarded wood and tyres

KUALA PILAH: What began as a simple hobby has transformed into a thriving business for Norpadila Afandi, 42, a housewife from Kampung Temaris in Negeri Sembilan.

Who would have thought that crafting items from discarded materials could generate an income of thousands of ringgit? Norpadila never imagined repurposing old

and used materials, particularly wood, would gain such popularity. Today, she is inundated with orders and even has a loyal fan base.

The mother of four shared that, with a creative touch, discarded wood which is often considered worthless can be transformed into beautiful decorative items with monetary and sentimental value. "It all started from having a house with a

'farmhouse' concept, blending English-style elegance with traditional Malay elements. I began by crafting furniture for my home, including chairs, tables, cupboards and wall decorations, using repurposed materials.

"From there, I expanded into creating home decorations from old wood sourced from various places. These items require minimal investment yet offer high aesthetic value, exuding a vintage charm," she said.

Norpadila, who was born in the district, said she never expected her seemingly ordinary creations to become so popular, providing a steady income and significantly boosting her family finances.

Among her most sought-after products are egg holders, key racks, wooden tables, decorative plates, wooden trays and coffee tables made from used tyres. These items are sold at reasonable prices, starting at RM40, Bernama reported.

Norpadila added that while most of her orders come from local customers, her unique decorative pieces have also captured the interest of international buyers from countries

"I now earn a five-figure income from crafting items like old wood, used tyres and small wooden scraps collected in our workshop," she said, adding that each order takes between two and five days to complete, denending on the desim and size depending on the design and size.

Known as NorpadilaDiyCrafter on TikTok, she has also gained recognition as a content affordable home decorations continues to attract a growing number of followers on

She said she prefers creating her own home decorations, wardrobe cabinets and furniture using second-hand materials, aligning with her commitment to environmental sustainability.

"Beautiful home decor doesn't necessarily have to be expensive. My ideas are practical, easy to follow and perfect for anyone looking to beautify their home affordably with just a bit of

creativity," she said, adding that many of her followers enthusiastically respond by sharing photos of their creativity, proving that her methods are accessible to anyone.

"When my followers tag me on social media and share photos of what they've made using my ideas, it's incredibly rewarding. It shows that I'm not the only one doing it. There are people out there who are following my approach and achieving success."

She said her aim is to inspire young people to explore their creativity, demonstrating that it does not take a large budget to create beautiful decorative products

## Career switch brings 'fizzy' success

MANJUNG: Rosniza Saaiddin, 47, who owns a profitable carbonated drink business, has never regretted her decision to leave her 15-year

career in the oil and gas industry. The decision in 2013 unexpectedly opened up opportunities for the Maman Trading manager to dabble in her husband's family business while also managing the household and children.

Rosniza said after leaving her job, she started the soft drink business under the "Alif" brand, with a capital of RM30,000, on June 1 that year.

She took over her husband's small-scale enterprise and changed the original brand to "Zeeper" to be more commercial. "For three years, we slowly moved forward. I

used my savings and sold other assets, including cars, to expand our business. "During that time, more than RM300,000 was

spent, and to this day, we still have not taken any bank loans."

Rosniza said her husband Abdul Rahman Basri, 49, helped her immensely in the first year of starting the business, from brewing to packaging the drinks.

She said her initial experience in the food and beverage field helped her run the business, especially since she attended additional classes and courses to improve her skills. She added that government agencies such as

the Malaysian Agricultural Research and Development Institute assisted her with

analytical services, with the Federal Agricultural Marketing Authority providing marketing assistance.

Although many carbonated drinks are on the market with various brands, colours and attractive packaging, she was confident that her products were unique.

"Zeeper carbonated water is produced using nine types of filtered water, with alkaline water at a pH level of 9.5 and lower sugar and gas content compared with others available on the market.

"We have 11 products, including orange, strawberry, sarsaparilla, cola, apple, grape, cream soda, blue soda and fruits, with soursop and agarwood cola as the latest. We are also in the process of producing tamarind water and isotonic drinks," she said. Her company can produce more than 30,000

litres of drinks a month, including meeting orders for special events. Rosniza said her drinks come in two sizes -

1.25 litres priced at RM2.80 and a 320mm size priced at RM1.50, which are available at selected supermarkets.

"Apart from walk-in customers, we supply to supermarkets, cooperatives, petrol stations and entrepreneurs who are interested in becoming Zeeper agents or distributors," she said, adding that she intends to sell her products at 14 petrol stations throughout Peninsular Malaysia next year. – Bernama

**Anti-graft body raids Indonesia central bank HQ** 

#### Investigators confirm governor's office searched

JAKARTA: Indonesian anti-graft investigators raided the headquarters of the central bank here on Monday in relation to an investigation into alleged mishandling of a corporate social responsibility programme, the central bank said

The office of central bank Governor Perry Wariyo was among those raided, two sources familiar with the matter told Reuters. They declined to be named because they were not

authorised to speak on the issue. Bank Indonesia's spokesperson did not immediately respond to a request for confirmation that Warjiyo's office was raided.

A spokesperson for the anti-graft body confirmed the search took place but did not provide further details.

The central bank said it respected the investigation and would cooperate with the anti-graft agency. The agency in September had said it was

The agency in September had said it was investigating CSR programmes run by financial regulators in 2023, including the central bank, for potential misuse of funds for personal gain, according to local media. Warjiyo in September said BI had cooperated with the probe, but defended the governance of its CSR funds. "We can ensure that CSP or BP's social

"We can ensure that CSR or BI's social programmes have strong regulatory governance and their decision-making process is through stages," Warjiyo told a press conference at the time. BI typically donates to education, social

empowerment or religious foundations instead of individuals. The beneficiaries are selected following a

survey and must meet a set of requirements, Warjiyo said at the time, adding the board of

warjyo sala at the time, adding the board of governors decides on the size of donations. The central bank allocated 1.6 trillion rupiah (RM443.5 million) in 2023 for social programmes and projects supporting micro. small and medium enterprises, as well as price stabilisation measures, according to BI budget documents provided to parliament. There was no breakdown of or details about

the use of the funds.

The raid happened a day before the central bank began its two-day policy meeting yesterday, with its decision due to be announced today. It is expected to keep policy rates unchanged, according to a narrow majority of economists polled by Reuters.



## Yoon to fight insurrection charge in court

SEOUL: South Korea's impeached President Yoon Suk Yeol did not commit insurrection by declaring martial law and will fight the charge in court, his defence team said yesterday. Yoon, who has been stripped of his duties by

parliament, is under investigation for his Dec 3 declaration, which plunged the country into political turmoil and led to an impeachment

vote on Saturday. Yoon's imposition of martial law "does not meet the requirements to constitute insurrection ... (we) will contest it in court", said Seok Dong-hyeon, a lawyer in Yoon's legal team

"While we do not consider the insurrection charges to be legally valid, we will comply with the investigation, he said. The comments came hours after Yonhap

news agency reported investigators had notified Yoon he faced possible arrest if he did not appear by Saturday for questioning over his attempt to suspend civilian rule.

Yoon is being investigated by South Korean prosecutors as well as a joint team of police,

Ministry and anti-corruption Defence investigators.

The president and some of his inner circle face possible life imprisonment, or even the death penalty, if found guilty. He remains under a travel ban

investigation unit earlier yesterday launched a raid on Yoon's security service in an attempt to obtain phone records, Yonhap said. The same unit had previously asked that the

suspended president appear today to answer questions but was rebuffed by his office, an

official told reporters. Investigators requested Yoon to appear at the office for questioning on charges of insurrection and abuse of power, they said.

But the summons was returned as "undelivered" by the presidential office, they said in a statement.

"The identity of the person who refused to

accept it is unknown," they said. South Korea's Constitutional Court, which began proceedings against Yoon on Monday, now has around six months to determine if it

will uphold his impeachment.

A spokeswoman for the court said judges had pencilled in a preliminary hearing for Dec

27, which Yoon is not required to attend. Fresh elections must be held within two months if his removal is upheld by the Constitutional Court. Prime Minister Han Ducksoo is serving as interim leader in Yoon's stead.

Huge protests against the ousted leader, with smaller rallies supporting him, have rocked the South Korean capital since his short-lived Dec 3 martial law decree.

Demonstrators in both camps have vowed to keep up the pressure as the Constitutional Court considers Yoon's fate.

On Monday night, hundreds of South Koreans held a vigil in central Seoul calling for his formal removal.

"I came here again, hoping that we will never have a president like this again," Kim Chan-suk, 67, said at the rally.

"I am coming out every day to continue the fight until the Constitutional Court makes its ruling," protester Han Myung-hak, 52, told AFP.

### Taipei mayor calls for reduced tensions

TAIPEI: The mayor of Taiwan's capital told visiting Chinese officials yesterday he hoped for peace and wanted less of the "howls of ships and aircraft" around the island, saying dialogue trumps confrontation.

Addressing the annual Taipei-Shanghai City Forum with Shanghai Vice-Mayor Hua Yuan in attendance, Taipei Mayor Chiang Wan-an used poetic language to say he wished for peace across the Taiwan Strait.

"More dialogue and less confrontation; more olive branches of peace and less sour grapes of conflict. More lights from fishing boats to adorn the sunset; less of the howls of ships and aircraft," Chiang said. "I always say that the more tense and difficult

the moment, the more we need to communicate," he said.

China has continued to send warplanes and warships into the strait even with the forum taking place, with Taiwan's Defence Ministry saying yesterday that in the past 24 hours it had detected 10 military aircraft and seven warships.

Chiang is from Taiwan's main opposition party, the Kuomintang, which favours close ties across the Taiwan Strait although it denies being pro-Beijing. He is widely considered a future presidential contender. The forum, first held in 2010, is one of the few high lawel uppure for tally between Chinese and

high-level venues for talks between Chinese and Taiwanese officials after China cut off a regular dialogue mechanism with Taiwan's central government in 2016 following the election of Tsai Ing-wen as president.

Tsai ing-wen as president. Tsai, and her successor Lai Ching-te, refuse to acknowledge Beijing's position that both China and Taiwan are part of "one China". Lai, like Tsai, says only Taiwan's people can decide their future, rejecting Beijing's sovereignty claims. Hua told the forum he hoped for closer

practical cooperation. "Compatriots on both sides of the Taiwan

Strait have always been one family," he said.

Shanghai tour group trips to Taiwan will restart, Hua said, offering his own olive branch given China has yet to allow a full resumption of tourism to the island.

Taiwan's Mainland Affairs Council said on Monday the government was showing goodwill by allowing the forum to take place in the face of the "still serious situation". – Reuters

## China visa-free transit extended to 10 days

HONG KONG: China announced yesterday a relaxation of its visa-free transit policy, extending the permitted stay for eligible foreign travellers to 240 hours, or 10 days, from the original 72-144 hours, as authorities aim to lure more foreign visitors.

The measure, which is effective immediately, was announced by the National Immigration Administration (NIA) on its official WeChat account.

People from 54 countries including Russia, Brazil, the United Kingdom, the United States, Canada, "who transit from China to a third country (region), can enter China without a visa from any of the 60 open ports in 24 provinces and stay in the specified area for no more than 240 hours," it said.

China, since reopening its borders in 2023, has waived visa requirements for travellers to encourage visits to the world's second largest economy. In November, China's Foreign Ministry said

China had extended its visa-free policy to a total of 38 countries. People from these countries, including Spain,

Singapore and the Netherlands, do not need a visa to enter China and can stay for up to 30 days for business, tourism, family visits, exchange and transit purposes.

Foreigners made 8.2 million inbound trips to China, up 48.8% year-on-year in the third quarter of this year. More than half of these were facilitated by the visa-free policy, up 78.6% yearon-year, the NIA said in October. - Reuters

## Meta agrees to A\$50m settlement

SYDNEY: Meta Platforms has agreed to a ASSO million settlement (RM141 million), Australia's privacy watchdog said yesterday, closing long-drawn, expensive legal proceedings for the Facebook parent over the Cambridge Analytica scandal.

Office of the The Australian Information Commissioner had alleged that personal information of some users was being disclosed to Facebook's personality quiz app, This is Your Digital

Life, as part of the broader scandal. The breaches were first reported by the *Guardian* in early 2018, and Facebook received fines from regulators in the United States and the UK in 2019.

Australia's privacy regulator has been caught up in the legal battle with Meta since 2020. The personal data of 311,127 Australian Facebook users was "exposed to the risk of being disclosed" to consulting firm Cambridge Analytica and used for profiling purposes, according to the 2020 statement.

It convinced the High Court in March 2023 to not hear an appeal, which is considered to be a win that allowed the watchdog to continue its prosecution. In June 2023, the country's federal

court ordered Meta and the privacy commissioner to enter mediation.

A Meta spokesperson said the company had settled the lawsuit in Australia on a no admission basis, closing a chapter on allegations regarding past practices of the firm. – Reuters

## China denies new spying claims

BEIJING: China said claims that a businessman had used his links with Prince Andrew to spy for Beijing were "preposterous", after the UK government voiced mounting concerns over the allegations.

Details emerged last week about Andrew's relationship with Yang Tengbo, a businessman and alleged spy, who had been banned from Britain.

Asked about the case while on a visit to Norway, Prime Minister Keir Starmer said Britain was "concerned about the challenge that China poses" but defended his approach of "engagement" with Beijing.

A spokesman for Beijing's Foreign Ministry said yesterday the "accusations

of Chinese espionage are preposterous". "The development of China-UK relations is in the common interests of both countries and is also conducive to promoting world economic growth and responding to global challenges," Lin Jian said.

Yang, who was reportedly once invited to Andrew's birthday party, said in a statement on Monday that he had "done nothing wrong or unlawful," and had "fallen victim" to a changing "political climate". - AFP

## Trump muses about drones, wars and TikTok

PALM BEACH: In his first news conference since his election victory six weeks ago, President-elect Donald Trump covered the Ukraine war, mysterious drones flying over New Jersey, the future of TikTok and lawsuits aimed at the media he often loves to hate. 'The first term, everybody was

fighting me. In this term, everybody wants to be my friend. I don't know - my personality changed or something," he said. He said his administration will "take a look" at whether the Chinese-owned social media app TikTok should be banned in the US and encouraged the US military to tell the American public more about the nature of the drone sightings that have plagued the East Coast

over the last several weeks. Trump also veered into personal grievances, vowing to file lawsuits against media companies that he felt have abused him.

"Now you need fair elections, you need borders, and you need a fair press," Trump said.

Of the world's two biggest hotspots, he was blunt: "Hamas needs to reach a deal with Israel releasing the remaining hostages it is holding in Gaza, or face the consequences."

If no ceasefire deal is reached by the time he takes office, Trump said, "it's not going to be pleasant."

He also said Ukraine President Volodymyr Zelenskiy should be prepared to make a deal with Russian President Vladimir Putin to bring an end to the nearly three-year-old Ukraine war. "Gotta make a deal," Trump

said. - Reuters

## **Major earthquake crushes buildings** in Vanuatu capital

#### ♦ US embassy staff safely evacuated

SYDNEY: A powerful earthquake hit the Pacific island of Vanuatu hit the Pacific island of Vanuatu yesterday, smashing buildings in the capital Port Vila including one housing the US and other embassies, with a witness telling of bodies seen in the city.

The 7.3-magnitude quake struck at a depth of 57km, some 30km off the coast of Efate, Vanuatu's main island, according to the Geological Survey. US

The ground floor of a building

housing the US, French and other embassies had been crushed under higher floors, resident Michael Thompson said by satellite phone after posting images of the destruction on social media. "That no longer exists. It is just

completely flat. The top three floors are still holding but they have dropped," Thompson said. All staff in Vanuatu are "safe and

accounted for" the US embassy in Papua New Guinea said yesterday.

"All personnel were able to safely evacuate the building," it said in a statement.


The United States said it was closing the mission until further notice because of the destruction.

The Zealand High New Commission, housed in the same building, suffered "significant building, suffered "significant damage", a statement from Foreign Minister Winston Peters' office said. "New Zealand is deeply concerned about the significant

earthquake in Vanuatu, and the damage it has caused."

damage it has caused. Thompson, who runs a zipline adventure business in Vanuatu, said: "There's people in the buildings in town. There were bodies there when we walked past." A landslide on one road had covered a bus, he said, "so there's

obviously some deaths there". The quake also collapsed at least two bridges, and most mobile



rescue operation. The support we need from overseas is medical evacuation and skilled rescue, kind of people that can operate in

earthquakes," he said. Video footage posted by Thompson and verified by AFP showed uniformed rescuers and emergency vehicles working on a building where an external roof had collapsed onto a number of parked cars and trucks.

## Two students, teacher shot dead in US school

**MADISON:** A 15-year-old female student was identified by police as the assailant who opened fire on Monday at a school in the US state of Wisconsin, where a fellow student and teacher were killed and the suspected shooter was found dead.

Shon Barnes, police chief in the state capital Madison, told a press briefing that three people had died and seven others were wounded at the Abundant Life Christian School, a

400 students. "The shooter has now been identified as a 15-year-old," Barnes told reporters, identifying the minor by name.

"She was a student at the school. and evidence suggests she died from a self-inflicted gunshot wound."

Barnes said a second-grade student called emergency services to report the shooting.

Of the six wounded victims who were hospitalised, two students remain in critical condition, two people are in stable condition, and two have been discharged from hospital, the police chief said.

The shooting happened in the final week of classes before students head to Christmas holidays, said Barbara Wiers, the school's director of elementary and school relations.

This year, there have been at least 487 mass shooting – defined as a shooting involving at least four victims, dead or wounded – across the United States, according to the Gun Violence Archive. – AFP



**MOSCOW:** A top Russian general accused by Ukraine of being responsible for the use of chemical weapons against Ukrainian troops was assassinated here by Ukraine's SBU intelligence service yesterday in the most high-profile killing of its kind.

kind. Lieutenant General Igor Kirillov (*pic*), who was chief of Russia's Nuclear, Biological and Chemical Protection Troops, was killed outside an apartment building along with his assistant when a bomb hidden in an electric scooter went off, said Russia's Investigative Committee.

An SBU source confirmed to Reuters that the Ukrainian intelligence agency had been behind the hit. "The liquidation of the chief of

the radiation and chemical protection troops of the Russian Federation is the work of the SBU," the source said.

The source said. The source said that a scooter containing explosives was detonated, killing both Kirillov and his aide, as they stepped into the entrance of a house on Ryazansky Prospekt in Moscow.

Kirillov, 54, is the most senior Russian military officer to be assassinated inside Russia by Ukraine and his murder is likely to prompt the Russian authorities to review security protocols for the army's top brass and to find a way

to avenge his killing. Former president Dmitry Medvedev, now a senior Russian security official, was cited by the state RIA news agency as saying that Ukraine's military and political leadership now faced imminent revenge for Kirillov's murder.

Moscow holds Ukraine responsible for a string of high-Ukraine profile assassinations on its soil designed to weaken morale and punish those Kyiv regards guilty of war crimes.

Ukraine, which says Russia's war against it poses an existential threat to the Ukrainian state, has made clear it regards such targeted killings as a legitimate tool.

Reuters photographs and video from the scene showed a shattered entrance to an apartment building with bomb-blackened bricks and

the doors hanging off their hinges and what looked like two bodies lying beneath black plastic sheets on the snow.

Investigators said they had opened a criminal case into the murder of two servicemen. Law enforcement sources told Russian media a terrorism case was likely to be opened.

## Israeli airstrikes kill 14 Palestinians

**CAIRO:** Israeli military strikes across the Gaza Strip killed at least 14 Palestinians yesterday, 10 of them in one house in Gaza City, medics said as tanks pushed deeper towards the western area of Rafah in the south.

Medics said the Israeli airstrike on the house in the Daraj suburb of Gaza City destroyed the building and damaged nearby houses. Four other people were killed in two separate airstrikes in the city and the town of Beit Lahiya north of the enclave.

In Rafah, near the border with

Egypt, Israeli tanks pushed deeper towards the western area of Mawasi, known as a humanitarian-designated area, residents said.

area, residents said. Heavy fire from tanks rolling into the area forced dozens of families sheltering there to flee northwards towards Khan Younis. Israel's air and land offensive has

killed more than 45,000 people and has displaced nearly the entire population and left much of the enclave in ruins. On the ceasefire front, an Israel

working-level talks with Qatari mediators on "remaining issues" in a Gaza truce and hostage release deal, an official with knowledge of the talks told Reuters on Monday. The talks are focused on bridging

gaps between Israel and Hamas on the deal US President Joe Biden outlined on May 31, the official said.

Efforts by Egypt, Qatar, and the United States to reach a truce in Gaza and a release of hostages have gained momentum in recent weeks, though there has been no breakthrough.

The three countries have, for more than a year, led rounds of fruitless talks to broker an end to the 14-month-long war in Gaza.

In previous rounds, disagreements over new demands that Israel introduced about its future military presence in Gaza obstructed a deal, even after Hamas accepted a version of the proposal Biden introduced in May. A round of talks in mid-October

failed to produce a deal, with Hamas rejecting a short-term ceasefire proposal. – Reuters

### US hits N. Korea, Russia with new sanctions

**WASHINGTON:** The United States slapped new sanctions on North Korea

stapped new sanctions on North Korea and Russia on Monday. The sanctions, which list North Korean banks, generals and other officials, as well as Russian oil shipping companies, are the latest US measure aimed at disrupting North Korea's support for Russia. The North Korean banks targeted

The North Korean banks targeted include Golden Triangle Bank, one of the biggest banks in the northeastern Rason Special Economic Zone, and Pyongyangbased Korea Mandal Credit Bank, which has representatives throughout China, the Treasury Department said.

South Korea's Foreign Ministry said it has blacklisted 11 individuals and 15 entities linked to military cooperation between North Korea and Russia.

The responses came as 10 countries, including the US, South Korea, Australia, Britain, France and Japan, as well as the European Union, issued a joint statement

Condemning the military ties. The officials sanctioned by both Washington and Seoul include North Korean generals, including Kim Yong Bok, who has appeared at seven events with North Korean leader Kim Jong Un this year.

The Treasury sanctions freeze the US assets of the entities, ban their trade with Americans and block them from transactions with the US financial system.

The Treasury blacklisted Russia-based companies that it said were shipping oil and gas to North Korea. The companies and gas to North Korea. Ine companies include Vostok Trading, DV Ink and Novosibirskoblgaz. The sanctions also targeted Sibregiongaz, AO, the parent company and 100% owner of company and 100% Novosibirskoblgaz. – Reuters

### Tighter rules for foreign aviation repair stations

WASHINGTON: The Federal Aviation Administration said it has finalised rules requiring repair stations in foreign countries to conduct drug and alcohol testing for employees performing maintenance functions for US airlines.

The rule, which requires compliance by December 2027, will affect 977 repair stations in 65 countries. The agency said foreign governments or repair stations can obtain a waiver.

"This rule will ensure these employees are held to high level of safety standards, regardless of where they are located," said FAA Administrator Mike Whitaker.

The rule, which requires repair stations to send their testing data electronically to USDOT, was proposed in December 2023 by the FAA, and Congress required the agency to implement its provisions. The FAA has been considering the issue

for decades. Aviation unions for years have called for testing for maintenance functions that are outsourced to repair stations outside the United States. Airlines, which previously said privacy

and employment laws in foreign countries could conflict with US drug and alcohol testing requirements, raised concerns the government may not be able to manage waivers and exemptions submitted. They said the rule could conflict with laws in the United Kingdom, Ireland, Germany, the European Union, China, Singapore, Peru,

European Union, Clinia, Singapore, Feio, Japan, Chile, Brazil and others. Chinese repair stations noted that China forbids use of prohibited drugs. However, drug testing is not commonly requested by companies in China. - Reuters

## The brain behind depression

MAGINE waking up every day feeling down, struggling with constant anhedonia (the inability to experience pleasure), facing difficulty in social interactions, and having your memory fail you when you need it the most. These symptoms are just a glimpse into the reality of depression, making it difficult to thrive in

your personal, social and professional life. ccording to the World Health Organisation According to the world mean organization (WHO), major depressive disorder (MDD) is the leading global cause of disease burden, affecting the subscription and ranking as

one of the top causes of global disability. The burden of depression is now equally prevalent among adolescents and young adults, indicating an increase in the number of individuals relying on long-term prescribed medication to manage its symptoms.

When discussing mental health disorders, it is crucial to recognise the brain as the organ of the mind. The challenge lies not in seeking professional help, but in accurately diagnosing the disorder.

Mental health practitioners often utilise thorough assessments and clinical judgements to diagnose mental health disorders. While medical doctors can directly examine the physical organs they treat, they lack the ability to directly assess the organ that controls mental disorders – the brain.

However, with the advancements of technologies, neuroimaging studies are providing us an opportunity to understand depression alongside other severe mental health disorders from multimodal perspectives.

#### The brain matters

Neuroimaging research has been instrumental in advancing our understanding of depression, offering profound insights into the intricate workings of the brain.

By employing advanced neuroimaging techniques, such as structural and functional magnetic resonance imaging, and electroencephalography, brain scientists have delved deep into neural mechanisms at play.

The technology has allowed us to explore brain pattern activities and structural changes in key regions linked to mood regulations, such as the amygdala and prefrontal cortex.

Let us explore the findings from two non-invasive brain imaging methods: magnetic



resonance imaging (MRI), both structural and functional, and electroencephalography (EEG), which can detect brain activity without the need for invasive probes.

The brain's grey matter, the outermost layer composed of densely packed neurons, serves as the hub for processing and relaying information to other brain regions via interconnected neural pathways.

Structural MRI studies have revealed notable changes in grey matter structure, with reduced thickness observed in individuals with depression compared with their non-depressed counterparts.

Additionally, evidence suggests a correlation between depression and memory impairments, with structural MRI indicating a diminished volume in the hippocampus, a key area responsible for memory storage and retrieval. Beyond structural differences, functional MRI

has shed light on distinct patterns of brain activity in regions such as the anterior cingulate cortex and prefrontal cortex, implicated in functions like planning and decision-making.

Notably, depressed individuals exhibit heightened activity in the amygdala, the brain's emotions processing centre, when exposed to facial expressions conveying emotions, coupled with decreased activity in the dorsolateral prefrontal cortex, associated with higher-order decision-making processes.



EEG, on the other hand, measures the brain's electrical activities. These electrical activities are generated at the gaps (synapses) between neurons as a result of the exchange of neurotransmitters and other ions.

Miniscule voltage fluctuations that happen at the neuronal level can then be detected by the electrodes placed on the scalp. EEG distinguishes different frequency bands, each associated with specific brain states.

With regards to depression, high alpha power during sleep is a consistent finding, particularly with those with suicidal ideation.

Additionally, alpha asymmetry, which reflects the difference in alpha band activity between the left and right frontal hemispheres, offers insights into the approach-withdrawal modal – left hemisphere activity is related to approach motivational behaviour while right hemisphere

activation suggests withdrawal tendencies. Although this is an oversimplification of the neurobiological basis of approach motivation behaviours, there are promising findings.

Left alpha activity was found to be prominent among the depressed compared to the non-depressed, suggesting reduced approach motivation, potentially serving as a prognostic indicator for specific symptoms.

Despite the complexity, understanding these neural patterns offers promising avenues for

identifying and treating depression.

#### Promising, but not there yet

So, can neuroimaging reliably detect depression? Yes and No. Why? Because its widespread adoption faces significant barriers.

Firstly, sophisticated neuroimaging tools are rather expensive equipment, which can be costly to purchase and maintain. This means not every hospital and private clinic can afford such equipment.

Furthermore, understanding brain scans and test results is complex and requires specialised trained personnel to make sense of the data. Without proper expertise, there is a risk of misinterpretation, leading to inaccurate diagnoses. Lastly, there are ethical issues and concerns

about privacy, which could lead to potential misuse of sensitive brain data. Compliance with

regulations and ethical guidelines adds another layer of complexity, often hindering the widespread use of these methods. Neuroimaging studies have deepened our understanding of depression. Exploring biomarkers, which are measurable indicators of biological programs and the protocol of the start of the biological programs and the start of th biological processes, has the potential to transform depression monitoring, diagnosis and treatment.

The future of neuroimaging technology in diagnosing depression holds a remarkable promise. Despite its challenges, the potential benefits cannot be overstated.


I am hopeful that ongoing technological advancements will overcome existing challenges, making these diagnostic tools more widely accessible and affordable to the public, and enabling the development of more tailored and effective treatment strategies.

Academic institutions should prioritise funding and resources for studies that explore the efficacy and applications of neuroimaging tools, and establish strong partnerships with the healthcare sector in the country to facilitate the translation of research findings into clinical practice.

I look forward to a future where neuroimaging technology complements existing diagnostic methods. where we can achieve a more comprehensive understanding of depression.

## Huawei Learning Centre to enhance Malaysian talent in advanced tech

KUALA LUMPUR: In a move to bolster Malaysia's technological capabilities, the Manpower Department (JTM) under the Ministry of Human Resources (MoHR) is partnering with Huawei Malaysia to set up the country's first Huawei Learning Centre within the Industrial Training Institute in Kuala Lumpur.

Human Resources Minister Sim Chee Keong said the collaboration is the result of their recent discussion with Huawei during Prime Minister Datuk Seri Anwar Ibrahim's visit to China.

Sim said the new learning centre

aims to train 2,000 participants, including industry engineers, new employees, technical and vocational education and training (TVET) trainers and students, in emerging technologies such as 5G telecommunications, artificial intelligence (Al), Internet of Things (IoT), cloud computing and data centres.

"Central to this collaboration is the equipping of our TVET institutions with cutting-edge technology and

industry-relevant curricular content. This will serve as a pilot project for integrating hands-on training in these advanced fields."

The trainees will undergo assess-ments and receive joint certifications from both the government and Huawei. "This is a key pillar of our collaboration, the synergistic inte-gration between our institutions and the industry," Sim said. He highlighted that the MoHR-Huawei partnership is part of the

Huawei partnership is part of the government's broader efforts to address the country's shortage of skilled technical workers. "We are short of at least 60,000 engineers in Malaysia, and this is a phenomenon

seen across the world," he noted.

The establishment of Huawei Learning Centre in Kuala Lumpur is expected to be the first of many such collaborations nationwide. "I hope to see this collaboration expanded to include the establishment of addi-tional Huawei learning centers in other TVET campuses, such as in Johor

other IVE1 campuses, such as in Johor and Penang," Sim said. Huawei Malaysia CEO Simon Sun emphasised the importance of fostering a culture of continuous learning, underscoring their commitment to upskilling, reskilling and cross-skilling talent to meet the demands of the digital economy.

"The partnership will leverage

established ICT modules from the Huawei ICT Academy, covering key areas such as 5G, Al, IoT, and cloud computing to equip participants with essential competencies for the modern job market," he said.

Talent, he added, should be nurtured with the same intensity as product development, describing this collaboration as a powerful example of public-private synergy. "This initiative aims to empower

Meanwhile, BNM also expressed its appreciation to Tan Sri Mohd Zawawi Salleh and Zainal Abidin Jamal for their invaluable contributions throughout their tenure. It noted that Mohd Zawawi will complete his term of service on the SAC on Dec 31, 2024, while Zainal Abidin has completed his term of service on Oct 31, 2024.

Both Mohd Zawawi and Zainal Abidin contributed immensely to the deliberations of the SAC and towards the overall development of Islamic finance in

Malaysia, it noted. The SAC is the highest authority for ascertaining Islamic law for purposes of Islamic financial business in Malaysia and the council also advises BNM on syariah issues relating to Islamic financial businesses, activities or transactions. – Rernama

## **Bumper** year for local cargo ports, 2025 will be even better

Their operations are driving economic growth and activity in the real estate sector, says expert

KUALA LUMPUR: Malaysia cargo ports have had a record year in 2024, and 2025 promises to be even better, with major implications for the economy and real estate markets.

markets. That's according to new data released yesterday by Member of the Royal Institute of Chartered Surveyors (MRICS) Irhamy Ahmad. Ahmad is a chartered valuation surveyor and CEO/founder of Irhamy Valuers International. In Malaysia, it collaborates with consulting firm Andersen Global.

"In total, we estimate that Malaysian cargo ports will have moved some 778 million metric tons of goods by the end of the year and delivered economic benefits worth RM657 billion," said Ahmad.

"In 2025, those numbers could increase by 3% to 5%, meaning the ports could handle 817 million metric tonnes of goods next year and add some RM690 billion to our GDP. Many in Singapore's shipping industry are shocked that Malaysia's Tanjung Pelepas port ranks as the fifth most efficient in the world on the World Bank's Container Port Performance Index ranks. On the same index, Singapore only ranks 17th. That shows how far Malaysia's ports have come," he added.

In terms of the amount of cargo moved, he said the efficiency with

which it was moved, and the resulting contribution to Malaysia's economy, 2024 was the best year yet for Malaysian cargo ports and a sector in which we are one of the world's best. One development that has helped Malaysian ports increase their throughput this year are increasing shipping links to India.

"The only limitation in the outlook is that the absence of a cruise terminal capable of handling large cruise ships prevents the ports from delivering even more for the economy," said Ahmad, adding that the cargo ports achieved 2024's unprecedented outcomes while being more efficient than ever.

As just one example, he said Port of Tanjung Pelepas (PTP) this year ranks as the most efficient container port in Southeast Asia. It is the fifth most officient is the weat most efficient in the world

"PTP in 2024 also became the first Malaysian port recorded as handling over 1 million TEUs in a single month. It is likely that Port Klang moves even more cargo than that, but I don't have hard data confirming it for any single month. "By handling 1.1 million TEUs

per month, both PTP and Port Klang rank in the global top 10. Malaysia is the fifth most connected country in the world, and has virtually the same level of



fifth globally .-- BERNAMAPIX

connectivity as the US, which just edges pass Malaysia for fourth place," said Ahmad.

"Port operations, shipping, and marine transport contribute a staggering 40% to Malaysia's GDP, about RM657 billion of or economic activity every year. Malaysia's ports serve as ports transshipment hubs in Southeast Asia, meaning that trade going between other countries are first shipped to Malaysia before being shipped on to their final destinations. This earns our ports revenue and creates good jobs in Malaysia," he added.

Just as our ports drive economic growth, they also drive activity in the real estate market. PTP and Port Klang now handle record cargo flows and serve as global transshipment hubs, which means we are already seeing increased demand for warehousing, distribution centres, industrial parks, and cold storage facilities nearby," he said.

"As the ports continue to grow in 2025 and beyond, expect more demand in these asset classes especially in Selangor, Johor, and Penang. Higher demand means higher prices for land and facilities.

"We already see the impact on We already see the impact on the ground. Land prices at Johor's Sedenak Tech Park, which is about a 50-minute drive from Port of Tanjung Pelepas, have nearly doubled from about RM40 per sq ft to as much as RM80 in just two years," said Ahmad, adding that Malaysia's cargo ports are a fundamental driver of its economy and of its real estate market.

## Global uncertainties could temper Malaysia's GDP growth

KUALA LUMPUR: Malaysia's GDP is projected to grow 4.9% in 2025, driven by domestic tailwinds and tempered by global economic uncertainties, according to research houses.

Maybank Investment Bank (Maybank IB) noted that the forecast marks a moderation from the 5.2% expansion recorded in the first nine months of 2024, attributed to the interplay of strong domestic factors and external challenges tied to global developments, including potential trade policy changes under a second Trump presidency.

Two key domestic factors are driving Malaysia's economy. First, the country's investment upcycle remains strong, reflected in the consistent gross fixed capital formation growth. The sustained momentum in The sustained momentum in approved investments since 2021 is now translating into increased actual and realised investments.

This aligns with the uptrends in the implementation rate of approved manufacturing investment, rising imports of capital goods, higher banking system loans for industrial

buildings and corporate earnings, it said in a note yesterday. Secondly, Maybank IB anticipates that income-boosting measures in Budget 2025 will drive consumer spending such as civil service salary and pension reviews involving an additional RM12.3 billion allocation for emolument and retirement charges in the federal government's operating expenditure.

There are also higher cash handouts


to lower-income groups, increases, extensions, and enhancements in personal income tax reliefs, and a monthly minimum wage hike to

In a separate note, Hong Leong Investment Bank Bhd (HLIB) said the forecast, a tad softer than 2024's 5% is amid a challenging global environment but still within the government's target

range of 4.5% to 5.5%. This growth will be driven by a stronger job market, income measures, tourism recovery, and approved

investments, it said. HLIB said inflation is expected to rise to 2.7% year-on-year in 2025 from an estimated 1.9% in 2024, with potential upward pressure hinging on the timing of RON95 subsidy reforms, likely to be introduced in the second half of 2025. As the inflation pressure is supply

driven, alongside rising external risks from Trump's tariff plans, we expect Bank Negara Malaysia will maintain the overnight policy rate at 3% for 2025, it said. – Bernama



## **Europe's carmakers brace** for tougher emissions rules

Companies offer discounts on EVs, raise prices of petrol models

PARIS/GDANSK: European automakers are raising prices of petrol cars and readying discounts on electric vehicles as they brace for yet another challenge - tougher emissions rules that threaten to further shrink profits across the struggling industry. The European Union (EU) will drastically

lower its cap on automotive carbon dioxide emissions from Jan 1, meaning at least onefifth of all sales by most car companies must be EVs to avoid heavy fines.

But so far this year only 13% of all vehicles sold in the region have been electric, data from the European Automobile Manufacturers' Association (ACEA) lobby group shows "The gap is really big," said said Marc

Mortureux, director of French car lobby PFA. The tighter rules come as the sector is already

dealing with excess capacity due to lacklustre sales and growing Chinese competition, prompting profit warnings from Volkswagen, Stellantis and others in recent months.

Now the companies will need to sell more EVs, which cost more to make than traditional vehicles, at a time when political and economic uncertainties and declining EV subsidies are deterring consumption, said Mortureux.

In a sign of the growing concern over the rules, Stellantis CEO Carlos Tavares abruptly resigned this month, partly due to disagreement with the board over how to deal with the issue.

With just weeks to go, Europe's politicians are urging Brussels to rethink the targets. But carmakers are getting to work, aiming above all to avoid fines that could reach €15 billion (RM70,3 billion) based on current sales, ACEA chairman Luca de Meo has said.

VW, Stellantis and Renault have raised the prices of petrol engine models by several hundred euros in the last two months, in what analysts say is an attempt to curb demand for heavier emitters and make pricier electric models appealing.

"Carmakers have started with their pricing strategy to steer demand towards battery EV in order to reach the CO2 targets and avoid potential fines," said Beatrix Keim of the Center for Automotive Research.

Last month, Stellantis's Peugeot hiked prices in France of all of its models apart from fully electric ones by as much as €500

Renault Group increased prices on some pure petrol models, for instance adding €300 or 1.6% to the Clio SCE 65, but kept prices of hybrid versions unchanged. Peugeot described the new pricing as an

"economic rise", while Renault said a rise was "normal" over a car's lifetime.

The strategy could backfire, however. Increasing petrol car prices should help close the gap with more expensive EVs, but given weak market growth, may not generate enough EV sales, said a source close to a major European automaker.

Sales in the region are around a fifth lower than pre-Covid.

"In reality, increasing the price of thermal engine cars means cutting production (...) and all the value chain and suppliers will suffer from this," the source added. The price rises will help fund future

discounts on EVs, said Denis Schemoul, auto analyst at S&P Global, acting as "an indirect subsidy" for electric car buyers by combustion engine buyers, but very likely hurting margins.

Alastar Bedwell, head of powertrain forecasting at GlobalData, predicts EV sales in Europe, including the EU as well as Britain,

Iceland, Liechtenstein, Norway and Swit-zerland, will jump 41% from this year to 3.1 million units in 2025.

Discounting to push sales comes at a cost, however. In the UK, the sector has warned that EV targets will cost automakers £6 billion (\$7.6 billion) this year, including about £4 billion in discounts.

"Pooling" emissions, or buying credits from those who have a large share of the EV market

to lower emission averages, could be less costly, say Barclays analysts. Japan's Suzuki agreed in October to pool with Geely-owned Volvo in 2025, a spokeswoman said.

That arrangement will almost completely remove any threat of fines for Suzuki, said Charles Lester, data manager at battery consultancy Rho Motion, given Volvo's large number of EVs on offer. All options will eat into meagre industry

profits, however, and the industry is still hoping Brussels will ease targets.

"At some point, enough is enough," PFA president Luc Chatel told reporters in October ahead of the Paris auto show

"I can't sell enough electric vehicles and I'm going to be penalised on my thermal vehicles. What do they want me to make, horse-drawn carriages?" – Reuters

The survey of around 9,000 company managers found an improvement in the assessment of current conditions, but the expectations index posted a surprise fall to 84.4 in December from 87.0 in November. ## US finalises US\$406m govt grants for Taiwan's GlobalWafers

WASHINGTON: The US Commerce Department said yesterday it has finalised US\$406 million (RM1.8 billion) in government grants to Taiwan's GlobalWafers to significantly increase states. The funds for projects in Texas and Missouri

will establish the first high-volume US production of 300mm wafers for advanced semiconductors and expand production of silicon-on-insulator wafers, the Commerce Department said.

The wafers are a crucial component of advanced semiconductors and part of the Biden administration's efforts to boost the domestic chips supply chain.

The subsidy will support nearly US\$4 billion in investments by GlobalWafers in both states to construct new wafer manufacturing facilities and create 1,700 construction and 880 manufacturing jobs. "We look forward to innovating with our US-

based chip customers for decades to come," GlobalWafers CEO Doris Hsu. GlobalWafers said in 2022 it would build a

US\$5 billion plant in Texas to make 300mm silicon wafers used in semiconductors, switching

from a defunct plan to invest in Germany. Currently, five major companies including GlobalWafers control more than 80% of the global 300mm silicon wafer manufacturing market and about 90% of silicon wafers are produced in east Asia.

GlobalWafers plans to build and expand facilities in Sherman, Texas, to produce wafers used to manufacture leading-edge, mature-node, and memory chips and a new facility in St Peters, Missouri, for wafers used for defence and aerospace chips. - Reuters

## Alibaba to sell department store unit at US\$1.3b loss

SHANGHAI: Alibaba Group said yesterday it would sell its Chinese department store unit Intime and book a US\$1.3 billion (RM5.8 billion) loss from the deal, as the retail giant reshuffles its business portfolio to focus on its core ecommerce operation.

The sale marks a further acceleration in Alibaba's restructuring after the group split into six business units last year in its biggest-ever revamp and announced a series of top management reshuffles afterwards.

The company last month unveiled a plan to integrate its domestic Chinese and international e-commerce platforms into a single business unit run by one leader for the first time, as it faces growing competition from discount-heavy retailers at home and abroad.

Rival platforms such as PDD Holdings' Pinduoduo and Temu, along with ByteDance's Douyin and TikTok, have stepped up competition with Alibaba by targeting costconscious shoppers with rock-bottom prices on everything from headphones to sweaters.

China's challenging consumer environment has put pressure on all retailers and ecommerce platforms.

"I think in the short term Alibaba just doesn't have the attention to actually do offline retail and do it well," said Jianggan Li, founder and CEO of Momentum Works, a venture and insights firm, though "finding the right buyer at right price" for offline assets remains a challenge. Alibaba said yesterday it would sell Intime to

a consortium comprising Youngor Fashion and members of Intime's management team for 7.4 billion yuan (RM4.5 billion), subject to customary regulatory approvals. Alibaba purchased Intime in 2017 in a

US\$2.6 billion deal to expand into the bricks-

and-mortar retail segment and currently holds a 99% stake in the business.

The e-commerce giant has been looking to sell a number of consumer sector assets, including Intime, grocery business Freshippo and retailer RT-Mart to focus on its core business, Reuters reported in February. Alibaba, under former boss Daniel Zhang,

had expanded its presence in the retail sector by taking over several brick-and-mortar chains, including electronics retailer Suning and hypermarket operator Sun Art Retail, which runs RT-Mart

In April, Alibaba co-founder Jack Ma expressed support for the internet giant's restructuring efforts, and acknowledged past mistakes in a lengthy memo to employees. - Reuters



### Vietnam's bold bureaucratic reform stirs investors' hopes, worries

HANOI: Vietnam is planning its boldest bureaucratic reform in decades, slashing ministries, agencies and broadcasters in a bid to reduce bottlenecks and red tape, but risking short-term "paralysis", officials and investors said. Under the plan, five ministries, four

Under the plan, five ministries, four government agencies and five state TV channels would be among the bodies that will cease to exist, according to ruling Communist Party documents reviewed by Reuters and reports in state media. The proposal is still in its preliminary stages and is subject to changes by the time is set to be voted in parliament in February.

No figure has been circulated about the number of jobs that could be cut, but thousands of state employees are likely to be affected, based on the magnitude of the cuts envisaged in the documents.

of the cuts envisaged in the documents. Vietnam, a Southeast Asian industrial hub, relies heavily on foreign investment in manufacturing, which fuels a booming export-oriented economy. However, in recent years investors' discontent has grown louder over delays in project approvals and regulatory reforms compounded by a sweeping anticorruption campaign.

corruption campaign. Responding to that criticism, Vietnam's new Communist Party leader To Lam this month launched a massive overhaul of state bodies, soon after he was appointed to the country's most powerful job.

Vietnam's home and foreign affairs ministries did not reply to requests for comment.

The bold move comes about a year before the Communist Party congress, which in early 2026 will decide whether to confirm Lam in his job. It also coincides with similar post-pandemic government cost-cutting measures being implemented or pledged across the world, including by Argentina's libertarian President Javier Milei and US Presidentelect Donald Trumo.

Among the planned measures, the investment ministry, which is responsible for approving industrial projects, will be merged with the finance ministry.

For a while "investors may experience delays or uncertainty as the new structures are established and the dust of this top-level governance merger settles", said Leif Schneider, head of international law firm Luther in Vietnam.

But "the long-term outlook is more optimistic", he added, saying Vietnam could become a more investor-friendly destination if the reform is executed effectively.

Nine investors, diplomats and officials interviewed by Reuters shared the same mixed assessment with many anticipating new administrative delays in the short term.

Two foreign investors, who declined to be identified, expected the reform would bring about long-awaited simplified procedures for businesses, although it was likely to slow project approvals for some months. – Reuters

## China capital market outflow hits new high in November

SHANGHAI: China's capital markets outflow reached a record high of US\$45.7 billion (RM203.2 billion) in November, according to official data tracking cross-border payments, as Donald Trump's US presidential election win roiled global portfolio flows.

Cross-border receipts from portfolio investments were US\$188.9 billion, while payments totalled US\$234.6 billion, resulting in the biggest monthly deficit on record, according to data from China's foreign exchange regulator.

The data release comes as China's policy-driven stock market rally that started in late September is losing steam, while the yuan has slumped against the dollar in the face of tariff threats from Trump. The massive deficit, which

widened from a US\$25.8 billion outflow in October, also reflects weakening investor confidence, despite a slew of policies announced by Beijing since late September to stimulate an economy mired in a property crisis, weak consumption and persistent deflation. "Whether the recovery momen-

"Whether the recovery momentum can be sustained into Ql 2025 depends on the speed and magnitude of implementation of the stimulus mapped out at the CEWC, as well as the timing of the potential US tariffs," BNP Paribas said in a note to clients.

During last week's Central Economic Work Conference (CEWC), China's leadership pledged to increase the budget deficit, issue more debt and loosen monetary policy. The portfolio data, released by the State Administration of Foreign Exchange, follows other Chinese capital statistics that showed a similar trend.

China's central bank on Monday said that foreign institutions cut holdings in Chinese onshore bonds for the third consecutive month in November.

Separately, the Institute of International Finance (IIF), which tracks global portfolio flows, also recorded outflows last month in both China's bond and stock markets.

The strengthening of the US dollar in the wake of Trump's

victory helped shape portfolio flows in emerging markets including China, the IIF said. Goldman Sachs said that its

Goldman Sachs said that its preferred measure showed notable China foreign exchange outflows of US\$39 billion in November, a jump from US\$5 billion in October.

"The sizeable FX outflows were mainly from cross-border RMB outflows, likely due to RMB outflows via portfolio investment channel," Goldman said in a note to clients.

China's Stock Connect scheme – the key channel for foreign investors to buy mainland shares – is a big contributor to cross-border yuan flows as forex transactions under the programme take place in Hong Kong.

Hong Kong. China no longer publishes daily foreign investment data under Connect, but the flow is reflected in China's cross-border receipts and payments data. - Reuters

## Beijing said to be planning record budget deficit in 2025

**BEIJING:** Chinese leaders agreed last week to raise the budget deficit to 4% of gross domestic product (GDP) next year, its highest on record, while maintaining an economic growth target of around 5%, two sources with knowledge of the matter said.

The new deficit plan compares with an initial target of 3% of GDP for 2024, and is in line with a "more proactive" fiscal policy outlined by leading officials after December's Politburo meeting and last week's Central Economic Work Conference (CEWC), where the targets were agreed but not officially announced. The additional one percentage point of GDP in spending amounts to about 1.3 trillion yuan (RM797 billion). More stimulus will be funded through issuing off-budget special bonds, said the two sources, who requested anonymity as they were not authorised to speak to the media. These targets are usually not

announced officially until an annual parliament meeting in March. They could still change before the legislative session.

The State Council Information Office, which handles media queries on behalf of the government, and the finance ministry did not immediately respond to a Reuters request for comment.

The stronger fiscal impulse planned for next year forms part of China's preparations to counter the impact of an expected increase in US tariffs on Chinese imports as Donald Trump returns to the White House in January

January. The two sources said China will maintain an unchanged GDP growth target of around 5% in 2025. A state media summary of the closed-door CEWC said it was

closed-door cewe sald it v

"necessary to maintain steady economic growth", raise the fiscal deficit ratio and issue more government debt next year, but did not mention specific numbers. Reuters reported last month that

Reuters reported last month that government advisers had recommended Beijing not to lower its growth target. The world's second-largest

The world's second-largest economy has stuttered this year due to a severe property crisis, high local government debt and weak consumer demand. Exports, one of the few bright spots, could soon face US tariffs in excess of 60% if Trump delivers on his campaign pledges.

delivers on his campaign pledges. The US president-elect's threats have rattled China's industrial complex, which sells goods worth more than US\$400 billion annually to the United States. Many manufacturers have been shifting production abroad to escape tariffs.

Exporters say the levies will further shrink profits, hurting jobs, investment and economic growth in the process. They would also exacerbate China's industrial overcapacity and deflationary pressures, analysts said.

The summaries of the CEWC and the Politburo meetings also flagged that China's central bank would switch to an "appropriately loose" monetary policy stance, raising expectations of more interest rate cuts and liquidity injections.

China is likely to rely heavily on fiscal stimulus next year, analysts say, but could also use other tools to cushion the impact of tariffs. – Reuters

## UK pay increases by more than expected in three months to October

LONDON: British pay rose by more than expected in the three months to October, official data showed yesterday, potentially adding to the Bank of England's (BoE) caution about how quickly to cut interest rates.

Average weekly earnings, excluding bonuses, were 5.2% higher in the three months to the end of October than a year earlier, the Office for National Statistics (ONS) said. A Reuters poll of economists had mostly forecast regular wage growth

The increase in the pace of wage growth ended a steady deceleration that began in mid-2023.

In the private sector alone – watched closely by the BoE – earnings excluding bonuses rose by 5.4% in the August-to-October period, the fastest growth since the three months to May this year, the ONS figures showed. Recent business surveys have suggested a fall in demand for staff after finance minister Rachel Reeves announced an increase in social security contributions paid by employers in her Oct 30 budget

security contributions pain employers in her Oct 30 budget. The ONS said provisional data from Britain's tax office showed employers cut 35,000 staff from their payrolls in November.

It also said job vacancies decreased by 31,000 in the three months to November to 818,000 compared to the previous quarter, but remained 22,000 above their prepandemic level in January-March 2020. – Reuters

NEW YORK: Bitcoin's (BTC) record rally topped US\$107,000 (RM476,261) on Monday after President-elect Donald Trump reiterated that he plans to create a US bitcoin strategic reserve similar to its strategic oil reserve, stoking the enthusiasm of crypto bulls.

Investor sentiment also got a lift from the inclusion of MicroStrategy into the tech-heavy Nasdaq 100 index that will likely lead to more inflows for the software firm turned bitcoin huver

Bitcoin, the world's biggest and best known cryptocurrency, extended gains to a session high of US\$107,148 and was most recently at type or US\$107,148 and was most recently at US\$106,877, up 5.43% from late Friday. The No. 2 digital currency ether was up 1.85% at US\$3,975.70.

"We're in blue sky territory here," said Tony Sycamore, an analyst at IG. "The next figure the market will be looking for is US\$110,000. The pullback that a lot of people were waiting for just didn't happen, because now we've got this new

Bitcoin and crypto have been catapulted into the spotlight as investors wager the incoming Trump administration will usher in a friendlier regulatory environment, boosting sentiment around the alternative currency. Bitcoin is up about 150% in 2024. "We're gonna do something great with

crypto because we don't want China or anybody else – not just China but others embracing it – and we want to be the head," Trump told CNBC late last week.

When asked if he plans to build a crypto reserve similar to oil reserves, Trump said: "Yeah, I think so." He advocated the same thing earlier this year.

'The inclusion seems a bit unexpected, but that hasn't stopped the excitement of what many believe to be the start of a looping cycle of capital that could potentially drive up the spot bitcoin price," he said.

## TikTok turns to US Supreme Court in last-ditch bid to halt divest-or-ban law

WASHINGTON: TikTok made a last-ditch effort on Monday to continue operating in the US, asking the Supreme Court to temporarily block a law intended to force ByteDance, its Chinabased parent company, to divest the short-video app by Jan 19 or face a ban.

TikTok and ByteDance filed an emergency request to the justices for an injunction to halt the looming ban on the social media app used by about 170 million Americans while they appeal a lower court's ruling that upheld the law. A group of US users of the app filed a similar request on Monday as well.

Congress passed the law in April. The Justice Department has said that as a Chinese company, TikTok poses "a national-security threat of immense depth and scale" because of its access to vast amounts of data on American users, from locations to private messages, and

its ability to secretly manipulate content that Americans view on the app. The US Court of Appeals for the District of Columbia Circuit in Washington on Dec 6 rejected TikTok's arguments that the law violates free speech protections under the US Constitution's First Amendment.

In their filing to the Supreme Court, TikTok and ByteDance said that "if Americans, duly informed of the alleged risks of 'covert' content manipulation, choose to continue viewing content on TikTok with their eyes wide open, the First Amendment entrusts them with making that choice, free from the government's censorship."

"And if the D.C. Circuit's contrary holding stands, then Congress will have free rein to ban any American from speaking simply by identifying some risk that the speech is influenced by a foreign entity," they added.

The companies said that being shuttered for even one month would cause TikTok to lose about a third of its US users and undermine its ability to attract advertisers and recruit content creators and employee talent.

Calling itself one of the "most important speech platforms" used in the US, TikTok has said that there is no imminent threat to US national security and that delaying enforcement of the law would allow the Supreme Court to consider the legality of the ban, and the incoming administration of President-elect Donald Trump to evaluate the law as well.

Trump, who unsuccessfully tried to ban TikTok during his first term in 2020, has reversed his stance and promised during the presidential race this year that he would try to save TikTok. Trump takes office on Jan 20, the day after the TikTok deadline under the law. The law would "shutter one of America's

most popular speech platforms the day before a presidential inauguration," the companies said in their filing. "A federal law singling out and banning a speech platform used by half of Americans is extraordinary." Asked on Monday at a press conference

what he would do to stop a ban on TikTok, Trump said that he has "a warm spot in my heart for TikTok" and that he would "take a look" at the matter.

Trump was meeting with TikTok CEO Shou Zi Chew in Florida on Monday, a source familiar with the plans told Reuters, speaking on condition of anonymity. TikTok did not immediately respond to a request for comment

on the meeting. The companies asked the Supreme Court to issue a decision on its request by Jan 6 to allow, in the event it is rejected, for the "complex task of shutting down TikTok" in the US and to coordinate with service providers by the deadline set under the law.

The dispute comes amid growing trade tensions between China and the US, the world's two biggest economies.

AS global financial hubs braced for this week's series of central As global marcial rubs braced of this week's series of central bank decisions, Bursa Malaysia closed lower yesterday, caught in the crossfire of mounting uncertainties stemming from the US Federal Reserve (Fed), according to an analyst. At 5pm, the FBM KLCI declined 0.59% or 9.52 points to 1,597.33

At 5pm, the FBM KLCI declined 0.59% or 9.52 points to 1,597.33 from Monday's close of 1,606.85. The index opened 1.59 points lower at 1,605.26 and moved between 1,594.51 and 1,606.81 throughout the day. Market breadth was also negative as losers overwhelmed gainers 704 to 346, while 529 counters were unchanged, 892 untraded and 11 suspended. Turnover decreased to 2.99 billion units worth RM2.43 billion versus 3.16 billion with valued as PM2.46 billion on Manday.

urnover decreased to 2.99 billion units worth RM2.45 billion versus 3.16 billion units valued at RM2.45 billion on Monday. SPI Asset Management managing director Stephen Innes said the Fed is in a tough spot: the US job market is strong, and inflation isn't slowing down as expected. This makes it challenging for the central bank to decide whether to continue lowering interest rates or pause.

"Fed officials are split. Some worry that cutting rates too soon could backfire, while others question whether past rate cuts have worked at all. Investors had hoped for more rate cuts, but now they're uncertain, causing market instability," he told Bernama.

Among heavyweights, Press Metal Aluminium was 17 sen lower at RM4.86, Petronas Chemicals fell 20 sen to RM4.78, Hong Leong Bank shed 32 sen to RM20.12, Sime Darby slid 9 sen to RM2.34, and Public Bank eased 2 sen to RM4.52.

ACE Market debutant Vanzo Holdings topped the most active stocks, gaining 1.5 sen to 16.5 sen, followed by Zen Tech, which was flat at 1 sen. MYEG was 1 sen lower at 95 sen, Pestech rose 2.5 sen to 17 sen and Bumi Armada increased 3 sen to 66.5 sen.

### Ringgit slips ahead of Fed meeting amid weak sentiment

THE ringgit ended slightly lower against the US dollar yesterday, marking its seventh consecutive trading day of losses amid subdued investor sentiment ahead of the two-day US Federal

Open Market Committee (FOMC) meeting. At 6pm, the local currency eased to 4.4645/4690 versus the greenback from Monday's close of 4.4500/4550.

SPI Asset Management managing partner Stephen Innes said the ringgit fluctuated throughout the day but ended slightly weaker as markets braced for a pivotal week of central bank meetings, particularly the US Federal Reserve (Fed).

'The focal point of global attention remains on the Fed, enveloped in a cloud of uncertainty. "Within the Fed, opinions are split: some policymakers question

the wisdom of further rate cuts, while others remain skeptical about the benefits of the rate reductions undertaken so far," he told Bernama

Given the market's expectations, Innes said a conservative 25 basis point cut seems the most straightforward path for the Fed. "The forthcoming economic projections are expected to paint a

picture of caution, potentially indicating a slowdown in the pace of future rate reductions," he added. The ringgit traded lower against other major currencies.

It receded versus the British pound to 5.6646/6703 from 5.6301/6365, but fell against the euro to 4.6815/6862 from 4 6743/6795 The ringgit was traded mixed against Asean currencies.

It decreased against the Singapore dollar to 3.3048/3087 versus 3.2992/3032, but went up versus the Thai baht to 13.0236/0440

TO RECAP, the past few quarters have been very challenging for CORAZA as the group faced the downturn of the global semiconductor sector in 2023. Amid this challenging period, the group also experienced persistent deferrals of orders from semiconductor customers. The loss of economies of scale, coupled with additional fixed costs for capacity expansion, caused CORAZA to slip into a loss in Q3'23. Since then, the group continued to report losses until the recent quarter, Q3'24, when it managed to return to profitability by recording a core profit of RM2.3 million. This turnaround was driven by a recovery in demand as the global semiconductor sector returned to an upcycle, as well as higher contributions from the introduction of new products. The encouraging results in Q3'24 mark the third consecutive quarter of QoQ earnings improvement.

The group has recently seen an increase in orders, with its order book standing at around RM70 million, approximately 50% of which comes from the semiconductor sector and 32% from instrumentation. Growth will continue to be largely driven by its key end-user markets, including semiconductor, instrumentation, and life sciences and medical devices.

Overall, management is confident that the order book will continue to grow, underpinned by the strong upcycle in the global semiconductor sector. The global semiconductor market is expected to close in 2024 on a high note, driven by robust demand fueled by investments in AI data centres.





## Lord of the Rings gets anime makeover with War of the Rohirrim film

**NO** elves, no dwarves and not a hobbit in sight: Lord of the Rings returns to the big screen this month with a new *anime* movie about the warring men of J.R.R. Tolkien's fictional universe.

Released last Friday, The War of the Rohirrim is a prequel that takes place nearly two centuries before Peter Jackson's original Oscar-winning films, which were adaptations of Tolkien's fantasy books. But unlike the first Lord of the Rings movies,

or The Hobbit films that followed, there are no magical rings or all-powerful Dark Lords this time around.

#### Human drama

You look at the original trilogy, you are talking hobbits elves dwarves and monsters" director Kenji Kamiyama told a recent press conference.


The new film is rooted in human drama and emotion, greed and power, said the Japanese artist who has previously worked on animated versions of Star Wars and Blade Runner. Hollywood studio Warner Bros announced

in 2021 the next *Rings* film would be an *anime* – a distinctively Japanese visual style and genre.

Filmmakers scoured the vast, invented histories that Tolkien wrote as footnotes for his beloved novels.

They soon homed in on a brief description of a civil war between a king and a rebe nobleman.

"It was not a case of, 'we have got the story, what form of animation are we going to tell it in?'

"It was actually the opposite way around. There was something about this particular story that felt intrinsically right for that great tradition of Japanese filmmaking that is anime," said producer Philippa Boyens who also cowrote the scripts for Lord of the Rings and Hobbit trilogies.

That tradition means themes such as honour, loyalty, hubris – and a fearsome female protagonist, in the ilk of Studio Ghibli's famous Princess Mononoke.

Boss girl The War of the Rohirrim is set in Rohan, the kingdom of horse-riding, Viking-looking warriors that featured prominently in Jackson's 2002 movie The Lord of the Rings: The Two Towers.

The animated movie revisits key locations from that film, such as the battleground fortress of Helm's Deep, and is narrated by Miranda Otto who played a heroic female Rohan warrior Eowyn in Jackson's trilogy.

The plot begins with ambitious Lord Freca plotting to marry his son to Hera, the daughter of the king of Rohan. When the offer is contemptuously spurned

by the proud monarch, Freca mounts a mutinous challenge to the throne but is fatally struck down.

Sent into exile, his son cultivates a massive rebellion that will unleash catastrophic war on

Although she is central to the conflict, Tolkien did not even bother to give the princess a name in his lengthy historical footnotes

But Boyens was fascinated by the idea of expanding this mysterious character, who witnesses and links the new film's various heroes, villains and battles

"We did not want her to be some warrior princess, superhero, boss girl. We wanted her to feel real. She is full of curiosity, she makes mistakes," said Boyens.

Jackson himself served as an executive producer for the new film but stepped back from day-to-day involvement, encouraging Kamiyama to put his own anime stamp on the film, according to Boyens. "Elements of the live-action (films) creep

into the world" she said

But they crept in very beautifully around the edge.

"Storywise, we obviously wanted to stay true to the Tolkien universe but at the same time, staying true to what we do best, which was just to make *anime*," agreed Kamiyama. – AFF



NEW ZEALAND tore through England's batting yesterday to crush the visitors by 423 runs in the third Test and send Tim Southee into retirement on a triumphant note. The hosts sealed a dominant

The hosts sealed a dominant performance in Hamilton by claiming seven wickets in 41.2 overs on day four as England crumbled for 234. It was New Zealand's equal

It was New Zealand's equal highest victory by runs and a complete reversal from the first two Tests, which England won easily to clinch the three-match series.

Playing on his home ground at Seddon Park, seamer Southee finished with 2-34 in his 107th and final Test, ending the career of one of New Zealand's finest players.

He finishes with 391 Test wickets, second only to Richard Hadlee among New Zealanders. "I want to thank New Zealand

cricket for everything you have done. My family, who are there for the ride and see the ups and downs," said the 36-year-old Southee.

"And my teammates. These guys have made the ride so much more enjoyable, I have loved every minute.

"And finally the fans. It is always great to turn out in front of numbers. This week has been pretty special to play at Seddon Park in front of a great crowd."

#### Stokes won't cut back on bowling

ENGLAND captain Ben Stokes admitted yesterday he became "emotional" after suffering another injury setback during the third Test defeat to New Zealand, but he would not be reducing his bowling workload. Stokes is still to learn the

severity of the "incredibly disappointing" hamstring injury recurrence which forced him from the field mid-spell on Monday's third day in Hamilton. He suffered the same affliction while bowling in August, sidelining him from four

August, sidelining him from four Tests during a two-month recovery. Stokes did not bat in

Stokes did not bat in England's second innings, with the risk of further damage not deemed worth it as the tourists crashed to 234 all out and a 423run defeat.

"I worked my a\*\*e off to get

to where I was in this game, in particular, with my body," he said.

"It's just sod's law that the first time in a while when I feel like I'm young again, something happens."

However, Stokes said a night's sleep had worked wonders mentally, aided by the realisation England's next Test isn't until May. "When you take the emotion

"When you take the emotion out of it, you realise that when you're walking out there, you're always putting yourself at risk of an injury," he said.

"I worked really hard to get myself into position to play the role that I did this game, and it's just one of those unfortunate things. So no, I ain't holding back."

In a post on Instagram yesterday, Kyrgios shared a picture of their meeting at Wimbledon, writing: "Doubles at Brisbane. See y'all there"

#### US Ryder Cup team to get paid

US Ryder Cup players will be paid to play in the biennial match play competition for the first time starting with next year's edition at Bethpage Black in New York The PGA of America said in a statement yesterday that US. team members will each get US\$500,000 (RM2.25m), with US\$300,000 (RM1.35m) of that going to charity and the remaining US\$200,000 (RM900,000) serving as a stipend. The pay is an increase from the US\$200.000 that was designated only for charity and had been in place since 1999 The PGA of America said no golfers asked to be compensated, and credited past and present players and captains for making the Ryder Cup one of the top sporting events in the world. Players on the European Ryder Cup Team do not get paid for participating in the event.

## Maresca keeps playing the Blues

"It's obviously natural because everyone that has played football (knows) you go running to block a shot, a cross, you finish with one hand down, one up, it's like this always.
