#### Pahang Sultan launches palace fire safety team

KUANTAN: The Sultan of Pahang Al-Sultan Abdullah Ri'ayatuddin Al-Mustafa Billah Shah launched the Pahang Royal Palace Fire Safety Team on Saturday, the first of its kind in the

country. He said he has a deep connection to the establishment of the team as it was an idea by the Pahang Palace, which was realised in collaboration

with the Fire and Rescue Department.
Al-Sultan Abdullah expressed
hope that the team would train palace
staff and their families to be prepared

for emergencies and extend assistance to those affected in times of need.

"I hope all palace staff would play their roles by assisting neighbours and family members whenever a tragedy such as a fire or flood occurs.

"I am truly impressed by the dedication of firefighters, who are always present during crises to save lives. In every sense, they are the true frontliners," Al-Sultan Abdullah said during the launch at the Pahang Fire and Rescue Department

headquarters here. Its director-general Datuk Nor Hisham Mohammad and state director Datuk Dr Wan Mohamad Zaidi Wan Isa were also present.

Al-Sultan Abdullah also unveiled a "Menghapus Bahaya" (Eradicating Danger) plaque and witnessed a demonstration conducted by the fire safety team.

Currently, the Pahang Royal Palace Fire Safety Team, which has 48 members, is overseen by Senior Assistant Fire Commissioner

(Honorary) Tok Aria Rakna Ahmad Norbadelin Abdul Murad, the Sultan's special private secretary.

Nor Hisham said the initiative was inspired by Al-Sultan Abdullah's directive to enhance fire preparedness within the palace, ensuring a swift and effective response to any fire incident.

"We are aware that palaces house numerous irreplaceable historical

#### Industrial park gets RM30b in investments

**SIPITANG:** The Sipitang Oil and Gas Industrial Park has secured Industrial Park has secured investments totalling about RM29.87 billion, said Chief Minister

Datuk Seri Hajiji Noor. He said the investments include those from Esteel for a green steel plant with a phased investment value of RM20 billion, and Petronas for the development of a floating liquefied natural gas facility with an investment value of RM8.8

Other investments include RM1 billion from E-Concern Sdn Bhd for waste management and RM70 million from Tex Evolosi Waste Management Sdn Bhd.

"All the companies I mentioned will start operations in 2026 and 2027. These investments will create job opportunities, starting with the construction phase and during operations.

#### No reports of M'sian passengers on ill-fated S. Korean plane

**PUTRAJAYA:** The Malaysian Embassy in Seoul is actively gathering information from official sources and is closely monitoring the situation following a crash of a South Korean passenger plane carrying 181 people at an airport in the country's southwest vesterday.

A statement from the Foreign Ministry said there has been no confirmation that any Malaysian was among the passengers.

Yonhap News Agency reported that the accident happened at 9,07am, when the aircraft veered off the runway while landing, and collided with a wall at the Musan International Airport, in the Muan county, about 288km southwest of

### Call to amend legislation to reflect rights of single fathers

While law stipulates that male parent can seek custody in court cases, process usually favours maternal care for young children, says association president

PETALING JAYA: The Father's Rights Association of Malaysia is calling for the Law Reform (Marriage and Divorce) Act 1976 to be amended to reflect present-day norms, and the evolving roles of

fathers in the family unit.

Its president Malcolm Fernandez said while the law outlines the rights of single fathers in custody and child support cases, it is often seen as favouring mothers in custody decisions

"While fathers can seek custody, while lattices can seek custory, the process often favours maternal care for younger children. Child support is legally required, but enforcement is difficult when former partners are uncooperative.

Fernandez added that bias extends beyond the law into societal perceptions, with single fathers facing assumptions that men are less capable caregivers.
"This stigma leads to our exclusion

from parenting networks, the reluctance of school heads to engage us as primary caregivers, and even judgement from extended families."

He said such biases isolate single

fathers and discourage them from seeking help or joining parenting programmes, affecting their ability to support their children emotionally.

Fernandez said up to 40% of single arent families, including those led by fathers, face financial challenges as they often earn less than the median income.

He said single fathers also face limited childcare options and have to

deal with workplaces that lack family friendly policies.

He added that they frequently

encounter difficulties in navigating educational and healthcare systems, which are often designed with mothers

as the primary caregivers.

Despite challenges, single fathers like Linus Liau, 52, remain committed. Liau, a financial consultant, focuses

on his responsibilities rather than the biases or societal perceptions.

"I'm not affected by what people say. I was raised to believe a father must be involved in his children's upbringing.

"It was tough at first. After the breakup, I couldn't see my son, and everything seemed chaotic. But over time, things improved. I reconciled with my ex-wife, and now I see my son more often and without issues." Liau, who has two sons aged 18 and

seven, expressed concern about not being able to monitor his younger child's upbringing. "My older son lives with me and my seven-year-old lives with his mother. I

see him every Monday and Thursday for two hours and he stays with me

very other weekend.
"When my ex-wife is at work, her

parents care for him, but they struggle with his education. That's why I spend as much time as I can to help him.

"At his age, learning is crucial, and I worry he's missing out on this important phase of his life. Fathers are meant to be there for their children. Without a father figure, children can

feel lost and lack guidance." However, for Alexander Joseph, 51, societal perceptions significantly impacted his life.

Joseph, who separated in 2020 and recently finalised his divorce, said his breakup affected his work and relationships, causing him to lose

clients, respect and family support.

"The toughest part was being alienated from my child. For nearly two years, I couldn't see him or share everyday moments."

He added that despite a difficult custody battle, things are improving, and he now treasures every moment with his son.

"Balancing work and parenting is tough, but time with my child makes it all worthwhile. I've learnt to forgive and let go because anger only causes harm. Above all, I have to put my son first, even if it means making compromises."

### Concern over decline of cockles due to pollution

Targeted strategies crucial to address contamination issues as seafood from tainted waters could cause food poisoning and liver damage, says expert

PETALING JAYA: Pollution has killed Sabak Bernam's cockle seed production, which has fallen from 555,048 metric tonnes in 2019 to zero in 2023, causing concern among academics, especially since Malaysia's cockle

industry is Southeast Asia's largest.
"Sabak Bernam was one of the largest cockle seed production areas in Selangor and Peninsular Malaysia's western coast, (but) other important seed production areas such as Muar-Rengit in Johor, Kuala Kedah in Kedah and Lekir-Bagan Datuk in Perak still exist," said Universiti Putra Malaysia Department of Aquaculture Fisheries Biology lecturer Prof Dr Aziz Arshad.

However Universiti Putra Malaysia Food

However, Universiti Putra Malaysia Food Science Department food toxicologist Assoc Prof Dr Ahmad Faizal Abdull Razis said Assoc Prof. Di Ailliad Falzai Abduli hazis salu the concern is growing over the safety of seafood harvested from polluted waters. Hence, targeted strategies are crucial to tackle contamination and protect public health.

"Toxins from harmful algal blooms, vibrio bacteria, pesticides and industrial chemicals in polluted waters can contaminate cockles, causing food poisoning, gastrointestinal issues, liver damage, neurological problems and long-term risk of cancer," he said. Ahmad Faizal warned that consuming

even small quantities of cockles exposed to pollutants can be dangerous, with the risk largely depending on the type of toxins present and their concentration.

Aziz added that the death of cockle production in Sabak Bernam has affected farmers there and in Selangor, especially those who depend on seeds produced from spatfall areas (breeding grounds).
"Improving farm management, protecting

water quality and preserving habitats for seeds and growth is critical to sustaining the industry.'

He said environmental disturbances and seed smuggling activities have also contributed to reduced production, which impacts the supply chain and consumers,

causing prices to rise.

In case of low production, importing cockles from neighbouring countries is not an option as Malaysia is the sole major producer.

Aziz said environmental conservation remains a long-standing issue, with measures required to mitigate its impact.

However, greater public and industry awareness is needed to prevent the illegal dumping of toxins, organic pollutants and agricultural waste into aquatic ecosystems.

He said cockle beds near estuaries are particularly vulnerable, and greater coordination between the Fisheries and Environment departments is needed to protect them and other aquaculture ventures

Ahmad Faizal urged the government to implement regular testing of water quality and seafood products, especially in known polluted areas, including setting up monitoring stations to track heavy metals, bacteria and toxins in shellfish.

He said several areas in Malaysia,

particularly in Selangor and around the Klang Valley, are known to be polluted due to industrial activities and agricultural runoff.

"Coastal areas near industrial zones such as Port Klang and densely populated urban centres where untreated sewage and chemical discharge are common are more prone to contamination.

"Fishing in areas near rivers that carry polluted waters is also dangerous, especially those with poor water management or where pollution control measures are inadequate."

Ahmad Faizal said monitoring and regulating seafood safety in affected areas should be part of a National Seafood Safety Programme, which requires a coordinated effort across multiple agencies.
"Seafood, including cockles, must be safe

for human consumption. Monitoring contaminants effectively and transparently would be a step in the right direction.

"Local authorities and fishermen should o establish regular monitoring programmes to ensure water quality and seafood safety."

#### Pardon applications must follow procedures: AGC

KUALA LUMPUR: All applications for pardons related to offences committed in the Federal Territories of Kuala Lumpur, Labuan and Putrajaya must be submitted to the Pardons Board, which is chaired by the King, said the Attorney-General's Chambers (AGC).

In a statement on Saturday, the AGC said it had been instructed by the King to inform the public that such applications must follow the procedures and channels prescribed by law and regulations in force, and not through any

"Therefore, if any party wishes to propose that any prisoner, including former prime minister Datuk Seri Najib Abdul Razak, serve the remainder of their sentence under house arrest, the application for such a matter must be submitted for consideration by the Pardons Board chaired by the King," the statement said.

The AGC stated that under Article 42(1) of the Federal Constitution, the King has the authority to grant pardons, reprieves and respites for offences committed in the Federal Territories of Kuala Lumpur, Labuan and

Putrajaya.

Article 42(2) of the Constitution further provides that the King may remit, suspend or commute any sentence imposed by the

"In this matter, decisions made by the King based on the advice of the Pardons Board subject to applicable legal provisions to prevent such actions from being challenged in court for being unlawful," the statement

Najib, 71, is serving a six-year prison sentence after being found guilty of misappropriating RM42 million belonging to SRC International Sdn Bhd.
The High Court initially sentenced Najib to

12 years in prison and imposed a RM210

However, the sentence was shortened to six years in prison and the fine reduced to RM50 million following a royal pardon petition filed on Sept 2, 2022. – Bernama



### Warning on heart health risks after menopause

Statistics show rate of cardiovascular issues doubles within 10 years after cessation of regular menstrual cycle

PETALING IAYA: A cardiovascular and thoracic surgeon has urged menopausal women in their 50s and older to be vigilant about their heart health due to the increased risks they face.

Dr David Khoo Sin Keat of IHeal Medical Centre highlighted that in 2021, the average life expectancy of Malaysian women was 78.3

Inte expectancy of Malaysian women was 78.3 years, while the average age for the onset of menopause was 50.7 years.

"Women are expected to spend one-third or more of their lives in post-menopause, a state of oestrogen deficiency. While commonly associated with symptoms like hot for the company of the com flushes, fatigue and emotional changes, the impact of menopause on cardiovascular

health is often overlooked," he said.

Khoo explained that statistics show the rate of heart attacks in women doubles within 10 years of menopause. Lifestyle factors such as nhysical inactivity, stress, smoking and unhealthy diets further contribute to an earlier onset of menopause-related cardiovascular

"Oestrogen protects the heart and with menopause, the risk of cardiovascular disease increases as its level decreases. By the age of 55, the incidence of cardiovascular disease in Malaysian men and women is equal, with coronary heart disease (CHD) being the leading cause of death in both sexes."

He also noted that women often exhibit atypical symptoms of CHD, which are commonly linked to microvascular heart

Their symptoms tend to worsen due to mental and emotional stress, unlike men, for whom physical exertion is the usual trigger. "Oestrogen helps maintain blood vessel

regulates cholesterol by increasing 'good' high-density lipoprotein cholesterol while lowering 'bad' low-density lipoprotein cholesterol," he said.

The loss of oestrogen during menopause leads to elevated levels of bad cholesterol, higher blood pressure and reduced blood vessel elasticity.

These changes significantly increase the risk of atherosclerosis (plaque buildup in the arteries), coronary artery disease, stroke and heart failure with "preserved ejection fraction", a condition more common in women, in which the heart pumps normally but is too stiff to fill properly.

"Many women mistakenly view heart disease as a predominantly male issue. They

ignore symptoms such as fatigue, shortness of breath and palpitations, which could indicate underlying cardiovascular indicate underlying problems," Khoo said.

Menopause symptoms such as severe hot flushes and night sweats can strain blood vessels, while persistent fatigue may signal heart-related concerns.

Palpitation or irregular heartbeat are also warning signs that require medical attention.

Khoo emphasised that heart disease is largely preventable.

"Women can take proactive steps during perimenopause - the period shortly before menopause - and early menopause to reduce risk. A heart-healthy lifestyle is key,

He recommended regular exercise such as brisk walking or swimming, combined with a balanced diet rich in fruits, vegetables, whole grains and lean proteins to significantly lower

Avoiding smoking, limiting alcohol intake and managing stress through mindfulness or yoga are equally important.

Routine health check-ups to monitor blood pressure, cholesterol and glucose levels are critical for early detection. In some cases hormone replacement therapy under medical supervision may help alleviate menopause related symptoms and reduce cardiovascular

"During menopause-related healthcare providers should discuss the impact of declining oestrogen on heart health and provide tailored informational materials for perimenopausal and postmenopausal women," he said.

Khoo also stressed the importance of community outreach through health talks, workshops and online campaigns, especially in collaboration with NGOs and women's health organisations.

"Culturally sensitive communication plays a crucial role in Malaysia, where taboos around menopause may exist. By adapting messages to resonate with diverse cultural contexts and using relatable examples, healthcare providers can empower women to prioritise their heart health.'

## Female-only parking sparks debate on long-term impact

➤ Experts call for better enforcement, infrastructure and cultural change to enhance women's safety

PETALING JAYA: Female-only car parks are designed to enhance women's safety but their long-term effectiveness remains uncertain, according to All Women's Action Society deputy president Khairiah Abdul Malik.

She noted that while such designated spaces may provide immediate reassurance for women, they do little to address broader public safety concerns.

"The introduction of female-only car parks in Malaysia aims to address women's safety concerns in urban areas, particularly following incidents like the tragic 2003 case of Canny Ong, who was abducted from a basement car park and later found murdered."

Khairiah said female-only facilities, such as parking spaces, show mixed results in reducing crime

She referenced a 2020 nationwide survey by Engender Consultancy, an organisation promoting women's empowerment and gender equality, which found that 58.6% of respondents had experienced sexual harassment in public spaces, with 70.4% of incidents occurring during the daytime.

"These findings demonstrate that while women-only zones offer a temporary buffer against certain crimes, they do not address the underlying systemic issues contributing to gender-based violence."

Khairiah said female-only parking spaces are often strategically located near mall entrances and should be made mandatory in all multi-storey buildings for safety. Essential features include better

Essential features include better lighting, surveillance cameras, panic buttons and security personnel to enhance protection.

"Female-only parking spaces promote security, empowering women to engage in public life more freely. However, misuse by men or couples undermines their purpose. This issue persists due to insufficient legal enforcement as there are no penalties for rule-breakers," she said.

Lee Ming Hui, a 24-year-old banker from Damansara, expressed frustration over the frequent misuse

of female-only parking spaces by

"I usually shop alone and always park in the female-only section. Many times, I've seen men parking there despite clear signs indicating it's reserved for women. It's infuriating and I always confront them, but they just brush it off, claiming there's no difference in where anyone parks.

"I'm sure there are CCTV cameras

"I'm sure there are CCIV cameras or security personnel around but every time this happens it feels like nothing is being done to address it," she said.

Women's Aid Organisation acting executive director Nazreen Nizam stressed that stricter enforcement and penalties are necessary to prevent the misuse of female-only parking spaces.

"The effectiveness of these spaces depends on rigorous enforcement and public respect. While they contribute positively to women's safety, continuous efforts are crucial to ensure their impact," she said.

Nazreen suggested penalties, such as fines or towing vehicles, to determine

Additionally, constant surveillance through CCTV, regular security patrols and clear signage would support enforcement efforts and increase the likelihood of detection and punishment.

"These measures not only reinforce the rules but also underscore the importance of these spaces in protecting women's safety in public areas," she said.

Khairiah highlighted that several factors still need to be addressed to improve the safety of female-only parking areas, including better infrastructure and, more importantly, changing societal attitudes towards

vomen's safety

"Many malls in Malaysia offer good security for female-only car parks, but poor lighting, inadequate surveillance and unclear signage can undermine their effectiveness, increasing fear. Well-maintained areas with good lighting and visible security are essential for safety," she said.

While female-only car parks provide temporary relief, Khairiah stressed the need for a broader approach encompassing better urban design, stricter rules and cultural education to create inclusive and safe public spaces for everyone. "Safety in female-only car parks is

"Safety in female-only car parks is a shared responsibility among women, facility management and the public. Women should also remain vigilant and use available security systems.

"Through cooperation, awareness, and consistent use of safety resources, female-only parking spaces can achieve their intended purpose of providing a secure and accessible environment for women."

#### Siblings in crash coping well after surgeries

However, he noted that Muhammad Uwais Al-Qarni Khairul Ikhwan, seven, and Nur Sofea Humaira Khairul Ikhwan, four, remain in a state of grief after learning about the deaths of their parents and youngest sibling in the crash on Dec 23.

The accident also involved a tour

bus and three other vehicles.

"Their schooling will resume once they are fully recovered as confirmed by the doctors and I will handle all their schooling arrangements," he added.

On Wednesday, Muhammad Uwais
underwent surgery for an injured right
thigh, while Nur Sofea Humaira had
surgery for a broken left thigh at
Malacca Hospital. Both children were
allowed to return home that evening.

The two siblings are the only

survivors from their immediate family, who tragically lost five members in the accident. The deceased include their parents, Khairul Ikhwan Mazupi, 32, and Fadzlenna Ramli, 32, their youngest brother, Muhammad Umar, two and their maternal grandparents, Ramli Ab Wahab, 66, and Fauziah Jaafar, 69.

The crash also claimed the lives of the tour bus driver, Noorisnien Khamid, 56, and a Singaporean passenger, Lamrah Asid Ali, 66. – Bernama

"After training for eight years, I can now balance the flagpole using several parts of my body, including my back and chest."


A Chinese tourist who gave his name only as Lin, 29, said it was the first time he witnessed the vibrant *Chingay* celebrations.

has just been weaned and is learning to eat solid food, while Atan was born in 2016.

Muhammad Shahrul, who has been caring for the animals for eight years, said while managing them is not difficult, all tasks must be done carefully, especially when cleaning the area around the pond, as hippos are aggressive and fast animals.

"When they see us entering their enclosure, they will run quickly toward us. What we do is have another worker feed them to distract them while I clean the pen."

He said the hippopotamus family consumes about 50kg of vegetables and fruits during each meal, four times a day.

Zoo director Dr Muhamad Ridhwan Affendi said June has become a popular attraction.

"Hippopotamuses spend 90% of their time in the water, including mating, giving birth and nursing their young.

"June was also born and raised in the water. We only saw her follow her mother onto land after a few weeks," he said.

He also said the zoo has also introduced African catfish into the hippopotamus pool, and they act as "dentists" for the animals.

"The catfish swim into the hippopotamus's wide-open mouth, cleaning any food residue around its mouth and teeth," he said. – Bernama

### All but two feared dead in fiery South Korea plane crash

#### Aircraft carrying 181 from Bangkok

MUAN: A Jeju Air plane carrying 181 people from Thailand to South Korea crashed on arrival yesterday, smashing into a barrier and bursting into flames, leaving all but two feared dead.

A bird strike and adverse weather conditions were cited by authorities as likely causes of the crash that flung passengers out of the plane and left it "almost completely destroyed", according to fire officials.

Video showed the twin-engine

Video showed the twin-engine boeing 737-800 from Bangkok landing on its belly at Muan International Airport, skidding off the runway as smoke streamed out from the engines, before crashing into a wall and exploding in flames.

"Passengers were ejected from

the aircraft after it collided with the wall, leaving little chance of survival," a fire official told families at a briefing.

at a briefing.

"The plane is almost completely destroyed, and identifying the deceased is proving difficult. The process is taking time as we locate and recover the remains," he said.

Only two people were rescued, both flight attendants, and 167 people were confirmed dead by early evening, the fire department

Flight 7C2216 was attempting to land shortly after 9am (8am in Malaysia) at the airport.

"Only the tail part retains a little bit of shape, and the rest of (the plane) looks almost impossible to recognise." Muan fire chief Lee Jung-hyun said.

Authorities have switched from rescue to recovery operations and because of the force of the impact, are searching nearby areas for bodies, Lee said. at hospitals with medium to severe injuries, said the head of the local public health centre. Hours after the crash, mortuary

vehicles were lined up to take bodies away, and authorities said a temporary morgue had been established.

The crash site smelled of aviation fuel and blood, according to witnesses, and workers in protective suits and masks combed the area while soldiers searched through bushes.

rescue people in the tail section, an airport official said shortly after the

The crash is the worst by any South Korean airline since a 1997 South Korean airline since a 1997 Korean Air crash in Guam that killed more than 200 people. Investigators are looking into bird strikes and weather conditions

strike warning and shortly afterward the pilots declared mayday, a Transport Ministry official said.

About one minute after the

mayday call the aircraft made its illfated attempt to land, the official

A passenger texted a relative to say a bird was stuck in the wing, the Newsl agency reported. The person's final message was, "Should I say my last words?"

Ministry.

The Boeing 737-800
operated by Jeju Air,
manufactured in 2009.

Jeju Air CEO Kim E-bae apologised for the accident, bowing deeply during a televised bytofing briefing.

He said the cause of the crash was still unknown, that the aircraft had no record of accidents and there were no early signs of malfunction. The airline will cooperate with investigators and make supporting the bereaved its top priority, Kim said.
No abnormal conditions were

reported when the aircraft left Bangkok's Suvarnabhumi Airport, said Kerati

Kijmanawat, president of Airports of Thailand.

Founded in 2005, Jeju Air is a low-cost airline that operates international routes to Japan, Thailand, and the Philippines, in addition to domestic flights.

Boeing said in a emailed statement, "We are in contact with Jeju Air regarding flight 2216 and stand ready to support them. We extend our deepest condolences to the families who lost loved ones, and our thoughts remain with the passengers and crew."

#### Cambodia pardons jailed surrogate Philippine mothers

MANILA: Cambodia has pardoned and sent home 13 Philippine women who were jailed over a scheme to become surrogate mothers, an outlawed practice, the Philippine

outlawed practice, the Philippine government said yesterday.

They were among 24 foreign women detained by Cambodian police in September and convicted and sentenced to four years in prison on Dec 2 for attempted cross-border

human trafficking.

The women "and three of their babies" were sent home to Manila yesterday and taken to a

government shelter for trafficking victims, the Social Welfare Ministry said in a statement.

"All 13 (women) departed Phnom Penh and arrived safely in Manila following the royal pardon by His Majesty Preah Bat Samdech Preah Boromneath Norodom Sihamoni' the Philippine Foreign Ministry said.

The Cambodian court said it had strong evidence showing that the 13 had "the intention ... to have babies to sell to a third person in exchange for money, which is an act of human

The court did not give details on what would happen to the babies of the 13 when they were born.

The Foreign Ministry said "surrogacy is banned in Cambodia and any violation thereof is punishable under Cambodian laws".

The Social Welfare Ministry said "there is no law prohibiting or allowing surrogacy in the Philippines. providing a legal grey area prone to

In 2016, Cambodia issued a snap ban on commercial surrogacy after Thailand pulled the plug on the trade the previous year – putting an abrupt end to a thriving industry for hopeful parents, many from Australia and the United States.

But demand for commercial

surrogacy remains high after China eased its one-child policy and agencies in Cambodia continue to offer the service.

Sources in Cambodia said foreign couples are willing to pay between US\$40,000 and US\$100,000 (RM178,879 and RM447,196) to surrogacy agents to find a woman who can carry their child. – AFP

#### France appeals to transfer prisoner from Jakarta death row

JAKARTA: France has sent Indonesia an official request for the transfer of a French death row inmate who has spent nearly 20

years in prison.

Indonesia has in recent weeks released half a dozen high-profile detainees, including a Filipina woman on death row and the last five members of a drug ring.

have French diplomats acknowledged that talks were under way for the transfer of Serge Atlaoui. a 61-year-old Frenchman arrested in 2005 at a drugs factory outside the capital Jakarta

The Indonesian government has now confirmed it received the official transfer request, which will

be discussed next month.
"We have received a formal letter requesting the transfer of Serge Atlaoui," said senior Law and Human Rights Minister Yusril Ihza Mahendra

The French embassy in Jakarta declined to comment.

Atlaoui's lawyer, Richard Sedillot, said that France's intervention brought "immense hope".

"It would be the culmination of a

long battle that has often been discreet, but which has always been carried out throughout these years,

"It's been tireless work and we're happy with an outcome which could be favourable."

Father-of-four Atlaoui maintained his innocence, claiming that he was installing machinery in what he thought was an acrylics plant.
He was initially sentenced to life

in prison, but the Supreme Court in 2007 increased the sentence to

death on appeal.

Atlaoui was held on the island of Nusakambangan in Central Java, known as Indonesia's "Alcatraz", following the death sentence, but he rollowing the death sentence, but he was transferred to the city of Tangerang, west of Jakarta, in 2015 ahead of his appeal.

That year, he was due to be executed alongside eight other drug offenders but won a reprieve after Paris tropped up progress.

Paris stepped up pressure, with Indonesian authorities agreeing to let an outstanding appeal run its course.

In the appeal, Atlaoui's lawyers

argued that then-president Joko Widodo did not properly consider his case as he rejected Atlaoui's plea for clemency – typically a death row convict's last chance to avoid the firing squad.

The court, however, upheld its previous decision that it did not have the jurisdiction to hear a challenge over the clemency plea.

Together Against the Death Penalty said the official request is the "penultimate step in a long fight" for those at the organisation who have campaigned for years to prevent Atlaoui's execution. – AFP

#### North Korea party meeting adopts tougher strategy to counter US

SEOUL: North Korea will launch its "toughest" ever strategy to counter the United States, state media said, reporting on a key year-end party meeting overseen by leader Kim Jong

The five-day party meeting last

week was held to chart the country's course for next year, the Korean Central News Agency reported.

"The US is the most reactionary

state that regards anti-communism as its invariable state policy," the lengthy report in English said.

It slammed growing ties between South Korea, the US and Japan, saying it had "expanded into a nuclear military bloc for aggression".

It also said South Korea had "turned into an out-and-out anti-communist outpost of the US".

"This reality clearly shows to which direction we should advance and what e should do and how," KCNA said.

Against this backdrop, Kim's speech to top officials "clarified the strategy for the toughest anti-US counteraction to be launched aggressively".

The meeting reviewed the response to widespread flooding earlier this year, and also included a vow to boost ties with "friendly" countries.

Such meetings and Kim's speeches are used by Pyongyang to make key policy announcements. – AFP

#### Yoon defies summons third time in a row

SEOUL: South Korea's suspended President Yoon Suk Yeol refused a summons to appear fo questioning yesterday, the third time he has defied investigators' demands in two weeks.

Investigators had ordered Yoon to appear for

questioning yesterday, a demand he rejected.
Yoon, a former prosecutor, also failed to attend a hearing he was summoned to last Wednesday, giving no explanation for his

The conservative leader was stripped of his duties by parliament on Dec 14, following a short-lived martial law declaration that plunged the country into its worst political crisis in

Yoon faces impeachment and criminal charges of insurrection, which could result in life imprisonment or even the death penalty, in a drama that has shocked democratic South Korea's allies around the world.

"President Yoon Suk Yeol did not appear at the Corruption Investigation Office for High-ranking Officials (CIO)," said the office in a

"The Joint Investigation Headquarters will review and decide on future measures."

The CIO is expected to decide whether to

issue a fourth summons or ask a court to grant an arrest warrant to compel Yoon to appear for questioning.

He is being investigated by prosecutors as

well as a joint team comprising police, Defence Ministry and anti-corruption officials, while the Constitutional Court deliberates on the impeachment motion passed by parliament.

If upheld by the court, which is required to deliver its ruling within six months of the impeachment, a by-election must be held within 60 days of the court's decision.

Former president Park Geun-hye was impeached under similar circumstances, but she was investigated only after the Constitutional Court removed her from power.

### AT&T, Verizon fend off cyberespionage attack

#### Hackers linked to China, says spokesperson

BENGALURU: The Chinese-linked Salt Typhoon cyberespionage operation targeted AT&T and Verizon's systems, but the wireless carriers' US networks are now secure as they work with law enforcement and government officials, the companies said on Saturday in

their first acknowledgment of the attacks.
"We detect no activity by nation-state

actors in our networks at this time. Based on our current investigation of this attack, the People's Republic of China targeted a small number of individuals of foreign intelligence

interest," an AT&T spokesperson said.

While only a few cases of compromised information were identified, AT&T was monitoring and remediating its networks to protect customers data, and continues to work with authorities to assess and mitigate

the threat, the spokesperson said.
"We have not detected threat actor activity in Verizon's network for some time, and after considerable work addressing this incident, we can report that Verizon has contained the activities associated with this particular incident," Verizon's chief legal

particular incident, Verizon's chief legal officer said in a statement.

An independent and highly respected cyber security firm has confirmed the containment, Verizon said.

On Friday, US officials added a ninth unnamed telecom company to the list of entities compromised by the *Salt Typhoon* hackers and said the Chinese involved gained access to networks and essentially had broad and full access, giving them the capability to "geolocate millions individuals, to record phone calls at will".

The US Department of Defence and the Federal Communications Commission did not immediately respond to requests for comment on the company statements. China's Foreign Ministry could not

chimas rottegin winnistry count not immediately be contacted for comment. Chinese officials have previously described the allegations as disinformation and said Beijing "firmly opposes and comparts cyber attacks and cyber theft in all

Officials previously alleged hackers targeted Verizon, AT&T, Lumen and other telecom companies, and stole telephone audio intercepts along with a large amount of call record data.

In response to that cyberattack, the US Cybersecurity and Infrastructure Security Agency on Dec 18 urged senior government and political figures to move mobile communications to end-to-end encrypted

Targets of Salt Typhoon reportedly included officials connected to Democrat Kamala Harris and Republican Donald Trump's presidential campaigns.

There is growing concern about the size and scope of the reported hacking into US telecommunications networks and questions about when companies and the government will be able to assure Americans about the issue. – Reuters

#### Trump sides with Musk in worker visas row

**WASHINGTON:** Donald Trump weighed in on Saturday in a bitter debate dividing his traditional supporters and tech barrons like Elon Musk, saying that he backs a special visa programme that helps highly skilled workers

"I've always liked the (H1-B) visas, I have always been in favour of the visas, that's why we have them" at Trump-owned facilities, the president-elect told the New York Post in his first public comments on the matter since it flared up last week.

An angry back-and-forth, largely between Silicon Valley's Musk and traditional antiimmigration Trump backers, has erupted in fiery fashion, with Musk even vowing to "go to

war" over the issue.

Trump's insistent calls for sharp curbs on immigration were central to his election victory in November over President Joe Biden. He has vowed to deport all undocumented immigrants and limit legal immigration.

But tech entrepreneurs like Tesla's Musk -

as well as Vivek Ramaswamy, who with Musk is to co-chair a government cost-cutting panel under Trump - say the United States produces

too few highly skilled graduates, and they fervently champion the H1-B programme.

Musk, who himself migrated from South

Africa on an H1-B, said luring elite engineering talent from abroad was "essential for America

to keep winning". Adding acrimony to the debate was a post from Ramaswamy, the son of immigrants from India, who deplored an "American culture" that he said venerates mediocrity, adding that the United States risks having "our asses handed to us by China".

angered several conservatives who were backing Trump long before Musk noisily joined their cause this year, going on to pump more than US\$250 million (RM1.1 billion) into the Republican's

In a striking jab at Trump's close friend Musk, Bannon called the Tesla CEO a "toddler".

Some of Trump's original backers say they fear he is falling under the sway of big donors from the tech world like Musk and drifting away from his campaign promises.

It was not clear whether Trump's remarks might soothe the intraparty strife, which has exposed just how contentious changing the immigration system might be. - AFP

### Putin apologises for tragic downing of airliner

#### Air defences were firing on drones, Azerbaijan told

MOSCOW: President Vladimir Putin on Saturday apologised to Azerbaijan's leader for what the Kremlin called a "tragic incident" over Russia in which an Azerbaijan Airlines plane crashed after Russian air defences fired against Ukrainian drones.

The extremely rare publicised apology from Putin was the closest Moscow had come to accepting some blame for Wednesday's disaster, although the Kremlin statement did not say Russia had shot down the plane, only noting that a criminal case had been opened.

Flight 12-8243, en route from Baku to the Chechen capital Grozny, crash-landed on Wednesday near Aktau in Kazakhstan after diverting from southern Russia, where Ukrainian drones were reported to be attacking several cities. At least 38 people were killed.

Four sources with knowledge of the preliminary findings of Azerbaijan's investigation said Russian air defences had mistakenly shot the airliner down. Passengers said they heard a loud bang outside the plane.

Putin called President Ilham Alivev and "apologised for the tragic incident that occurred in Russian airspace and once again expressed his deep and sincere condolences to the families of the victims and wished a speedy recovery to the injured," the Kremlin

"At that time, Grozny, Mozdok and Vladikavkaz were being attacked by Ukrainian unmanned aerial vehicles, and Russian air defence systems repelled these attacks."

The Kremlin said civilian and military specialists were being questioned.

Putin also phoned Kassym-Jomart Tokayev, his counterpart in Kazakhstan, to express his condolences over the loss of life in the crash, the Kremlin said.

Azerbaijan said Aliyev had told Putin that the plane had been "subjected to external physical and technical interference in Russian airspace, resulting in a complete loss of control and redirection to the Kazakh city of

Until Saturday, Russia's last working day before a long New Year holiday, the Kremlin had said it was improper to comment on the incident before official investigations were concluded.

The Embraer jet had flown from Azerbaijan's capital Baku to Grozny, where

the incident occurred, and then travelled, badly damaged, another 450km across the Caspian Sea.

Footage shot by passengers showed oxygen masks down and people wearing life jackets. Later videos showed bloodied and bruised passengers climbing out of the wreckage. There were 29 survivors

Baku cited injuries from objects that had penetrated the aircraft's fuselage from outside and testimonies from survivors as evidence of "external physical and technical interference

The crash underscored the risks to civil aviation even when aircraft are flying hundreds of miles from a war zone, especially when Ukraine has deployed drones to try to hit back at Russia behind the front lines.
Russia uses electronic jamming to confuse

the geolocation and communication systems of Ukrainian drones, which it also targets with

air defence systems.
In 2020, Iranian Revolutionary Guards mistakenly shot down a Ukrainian airliner, killing all 176 on board.

And in 2014, Malaysian Airlines Flight

MH17 was shot down over eastern Ukraine, with the loss of 298 passengers and crew, by what Dutch investigators said was a Russian BUK missile system. involvement. - Reuters Russia



#### Syrian new intelligence chief pledges reforms

DAMASCUS: The new head of Syria's intelligence services announced on Saturday a plan to dissolve the institutions that were so feared under the rule of ousted dictator Bashar al-Assad.
"The security establishment will be

reformed after dissolving all services and restructuring them in a way that honours our people," Anas Khattab said, two days after being appointed to his post by the country's new leadership that overthrew Assad in early

In a statement carried by the official Sana news agency, he stressed the suffering of Syrians "under the oppression and tyranny of the old regime, through its various security apparatuses that sowed corruption and inflicted torture on the people".

Prisons were emptied after Assad's fall as officials and agents of the deposed regime

fled.

Most of these installations are now guarded by fighters of Hayat Tahrir al-Sham, the group that led the coalition that seized power.

Numerous Syrians have rushed to former detention centres in the hope of finding traces of relatives and friends who went missing during the 13 years of a devastating civil was that left more than a half million dead.

"The security services of the old regime were many and varied, with different names and affiliations, but all had in common that they had been imposed on the oppressed people for more than five decades," Khattab

According to the Syrian Observatory for Human Rights, more than 100,000 people died in Syrian prisons and detention centres during the conflict.

On Thursday, a general who ran military justice under the former regime was arrested in the west of country, accused of being responsible for sentencing to death thousands of people held in Saydnaya prison. And in Europe, several former senior Syrian

intelligence officers accused of torture and other abuses have been convicted and jailed since 2022. – AFP

#### **Israel detains** 240 in Gaza hospital raid

**CAIRO:** Israeli forces detained more than 240 Palestinians, including dozens of medical staff from a north Gaza hospital they raided on Friday, including its director, according to the Health Ministry in the enclave and Israel's military.

The Health Ministry said it was concerned for

the wellbeing of Hussam Abu Safiya, director of the Kamal Adwan Hospital, as some staff freed

by the Israeli military late on Friday said he had been beaten up by soldiers.

The Israeli military said the hospital was being used as a command centre for military operations and those arrested were suspected gunmen. It said Abu Safiya had been taken for questioning as he was suspected of being a Hamas operative.

On Friday, Hamas dismissed Israel's assertion

that its fighters had operated from the hospital throughout the 15-month-old Gaza war, saying no fighters had been in the hospital. The group had not yet commented on the arrests.

Hamas on Saturday urged the UN and international agencies to intervene urgently to protect the remaining hospitals and medical facilities in northern Gaza and supply them. It also called for UN observers to be sent to

medical facilities to refute the Israeli allegations that they were being used for military purposes.

The raid on the hospital, one of three medical facilities on the northern edge of Gaza, put the last major health facility in the area out of service, said the World Health Organisation.

Some patients were evacuated from Kamal Adwan to the Indonesian Hospital, which is not in service, and medics were prevented from joining them, the Health Ministry said. Other patients and staff were taken to other medical facilities.

The Israeli military said 350 patients and medical personnel had been evacuated before the raid, while another 95 had been evacuated

to the Indonesian Hospital during the operation. Separately, the Gaza Health Ministry said Israeli strikes across the enclave had killed 18 Palestinians on Saturday, at least nine of them in

a house in Maghazi camp in central Gaza. In the past few months, Israeli forces have pushed people out and razed much of the area around the northern Gaza towns of Jabalia, Beit Hanoun and Beit Lahiya. – Reuters



S the year comes to an end, it is a good time to reflect on the momentous and sometimes turbulent chaffecting the media landscape.

Firstly, let me express my conviction that freedom of the press is an important pillar of a functioning democracy. Our nation's press has been suppressed in the past during times like Ops Lalang, Reformasi, Bersih and the 1MDB financial scandal.

Therefore, it is commendable that press

bodies and related NGOs are vigilant over any changes in regulations that may impinge upon

this.

However, over 90% of complaints made to the Malaysian Communications and Multimedia Commission (MCMC) concern scams, internet trafficking, sexual abuse material, grooming, illegal drug sales, access to weapons and the spread of terrorist ideology and hate speech.

Early last week, we were informed of the

Early last week, we were informed of the shocking news that the police and MCMC launched a series of raids on individuals suspected of possessing and distributing child sexual abuse material (CSAM).

The figures were astounding. Over 40,000 CSAM and adult pornographic content from various devices including computers, cell phones and hard disks were seized.

After the raids in six states, some 13 individuals aged between 20 and 74 were arrested. This illustrates the importance of intelligence provided by MCMC, with some suspects even admitting to finding and buying explicit content via social media and messaging platforms, such as X and Telegram.

The suspects operated online under false identities and were flagged for

actively accessing and sharing CSAM content on messaging and social media platforms.

Aside from these horrific revelations, there are many other avenues for illegal operations to thrive unless

operations to thrive unless they are checked by legislation. According to a report in a newspaper, imitation gel-blaster guns are widely available online through e-commerce and social media platforms. Last year, nearly 150 crimes were committed using these imitation weapons.

Hence the need to introduce measures, such as the "Regulatory framework for internet messaging service and social media service providers", which was released on Aug 1 and is set to take effect on Jan

The regulatory framework requires that all social media and internet messaging services with at least eight million registered users in Malaysia must apply for an applications service provider class licence

under the Communications and Multimedia Act by Jan 1, 2025. One of the requirements to obtain this licence is using locally incorporated

This also illustrates why it should not reach

the stage where every initiative by the communications ministry and regulatory bodies, like MCMC, is greeted with alarm and

As the digital media As the digital media industry evolves, it becomes necessary to put in new safeguards. This is imperative as traditional print and even "While remaining vigilant, the public and the media online media reach is in decline and being replaced by social media as the primary information source. automatically

Some governance is required, yet at the same time, we do not want it to be too heavy handed. A situation that must be avoided is giving too much power to the authorities to clamp down on dissent and

satire.

Prime Minister Datuk Seri Anwar Ibrahim himself recently spoke out against any possible action against graphic artist Fahmi Reza, was reportedly summoned by Bukit Aman

summoned by Bukit Aman over a satirical piece.

"Frankly, I think for the purpose of this matter, I want to tell agencies like MCMC and the police that on the criticisms towards the prime minister, let it be," he said last week.

What is clear is that the landscape is shifting.

What is clear is that the landscape is shifting and that there will be hiccups and obstacles. Transparency is required, and in attempting to prepare a governing code of conduct, MCMC has begun consultations with

Communications Minister Fahmi Fadzil has also said that the government has no plans to block users' access to social media platforms that fail to register for the annual licence.

Based on what we have seen this year, there have been overreactions to the update of the

press accreditation card and the codification of the Malaysian Journalist Code of Ethics.

There was also uproar over an initial plan requiring all internet service providers to implement public domain name system redirection last September.

Furthermore, on Nov 1, when MCMC announced U Mobile's selection as Malaysia's second 5G network operator, with the goal of ensuring that the full benefits of 5G technology reach the general public, industries and the nation, this too was greeted with complaints. The selection was based on a combination

of factors, such as business and technical plans, customer complaint rates, satisfaction records and the company's track record in executing other infrastructure projects.

Thus, we can see the need to strike the right balance. While remaining vigilant, the public and the media should not automatically assume a suspicious attitude towards initiatives which are key towards updating and upgrading our laws to prepare for a digital

Disinformation and misplaced frustration have been factors, and it is hoped that with the new year, a fresh, open-hearted and cooperative attitude can develop as the country proceeds with transformative reforms.

KUALA LUMPUR: Malaysia's role as the Asean Chair in 2025 positions the nation as a critical starting point within the regional bloc in promoting tourism.

#### CPO futures seen bullish on weaker output, lower stocks

**KUALA LUMPUR:** The crude palm oil (CPO) futures contract on Bursa Malaysia Derivatives is expected to trade with a bullish bias this week due to weaker output and lower stock levels, according to palm oil trader David Ng.

according to paim oil trader David Ng.

Speaking to Bernama, he projected that
CPO would trade between RM4,580 and
RM4,750 per tonne during that period.

Meanwhile, Interband Group of Companies

senior palm oil trader Jim Teh said the market is expected to remain quiet due to a holidayshortened week ahead, with most inter-national traders on year-end and Christmas holiday leave.

He said CPO futures are likely to trade at

between RM4,400 and RM4,500 per tonne.
On a Friday-to-Friday basis, the spot-month January 2025 contract rose by RM213 to RM4,975 per tonne, February 2025 jumped by RM210 to RM4,781, and March 2025 added RM191 to RM4,624.

The April 2025 contract went up RM156 to

RM4,459 per tonne, May 2025 gained RM124 to RM4,331 and June 2025 improved RM112 to RM4.253.

The physical CPO price for January South increased by RM150 to RM5,050 per tonne.

Meanwhile, the rubber market is expected to be trading range-bound with a downside bias this week as demand seems to be sluggish during the holiday season, said industry expert Denis Low.
Continuous rains in the rubber-producing

regions are affecting the production of rubber and disrupting rubber-apping activities, he said.

Speaking to Bernama, Low said Thailand's rubber output in December had decreased by nearly 30% due to floods and heavy rainfall. "With the lack of supply, the rubber market has somehow equalised itself with the lack of

demand," he said.

demand, he said.

Meanwhile, a dealer said local rubber prices
will continue to track the performance of
regional rubber futures markets, the ringgit's
performance versus the United States dollar,
and benchmark crude oil prices amid ongoing concerns about the shortage of global natural rubber (NR) stocks due to rainy weather in major

NR-producing countries.
"Market operators are also keeping an eye on further cues on China's stimulus and the latest developments surrounding global geopolitical tensions and economic indicators," she added.

On a Friday-to-Friday basis, the Malaysian Rubber Board's reference price for Standard Malaysian Rubber 20 rose by 6.5 sen to 869 sen per kg while latex in bulk decreased by 22 sen to 699.5 sen per kg.

#### Strategic investments to drive F&N's long-term growth

a broader effort to optimise assets and strengthen
the group's competitive positioning across key markets.
Despite challenges such as
higher startup costs for the dairy

farm and the removal of tax rebates in Thailand, he noted that

F&N remains optimistic.

"The group's ability to adapt through operational efficiencies, automation and digitalisation initiatives positions it well to mitigate

rising costs and sustain profitability," he said.
Lim noted that its growth strategy is the company's adoption of artificial intelligence and automation technologies under the "Future

Now" initiative.

"This digital transformation aims to streamline operations across the command chain, supply chain, and value chain, fostering agility in response to market changes," he added. F&N sustained growth in FY24 with revenue increasing by 4.9% to RM5.25 billion, driven by

strong domestic sales in Malaysia and Thailand, along with exports to Cambodia.

Operating profit rose 10.4% to RM709.5 million, while profit before tax improved by 11.6%, despite higher restructuring and startup

F&N food and beverages division operating in Malaysia reported a 3.5% rise in revenue to RM2.95 billion, buoyed by successful marketing campaigns and festive demand.

### **Expect significant changes** to stamp duty from 2025

TAXPAYERS usually do not pay attention to stamp duty unless there is a transfer of stamp duty unless there is a transfer of property that requires the title to be transferred, or transactions undertaken between third parties which may have to be litigated in the courts. Unless the document is stamped, it will not be accepted in the courts.

At the moment, there is no compulsion for taxpayers to stamp their documents. Generally, intercompany agreements between e MATTERS

related parties are not stamped because they do not anticipate any disputes that will go to court. However, this will stop from 2026 with proposed amendments in the Finance Bill 2024 whereby the Inland Revenue Ready (IRR) has the right the Inland Revenue Board (IRB) has the right to review all agreements and collect stamp

#### How stamp duty is applied

This is a unique tax that is applied on agreements that fall within the definition of an instrument, and an instrument is defined to include any document which is handwritten, typewritten, printed, or documents electronically recorded or transmitted in an electronically readable form. This will include agreements, letters, memorandums, emails,

The stamp duty liability will only arise if the instrument is listed in the First Schedule of the Stamp Act 1949 (Stamp Act) and the rate of tax

is outlined for every item in the schedule.

The common mistake made by taxpayers is applying the wrong duty because of the incorrect classification of the instrument. Many taxpayers do not know how to

interpret this legislation because it was enacted during the pre-independence period written in a legalistic manner.

#### Significant changes

The most significant change is the introduction of self-assessment in stages from Jan 1 2026 for instruments or agreements related to rental or lease,

general stamping and securities; Phase 2 from 2027 will be applied on instruments for transfer of property ownership; Phase 3 from January 2028 will be for all other instruments.

Under the self-assessment regime, the burden of determining the correct duty will be entirely on the taxpayer. If it is incorrect, there will be additional duties and penalties that can range up to 100% of the additional duty if there is no prosecution. However, if the matter goes to court, the fines can range from RM1,000 to RM10,000, and may have to pay a special penalty equivalent to the underpaid duty.

It is important to remind taxpayers that all instruments under the Stamp Act will have to be stamped and this will include intercompany transactions such as provision of services and financing, sale of business, sale of goods, etc. unless it is specifically exempted by the Act. From 2026, the IRB has the power to audit, and it can go back for five years after the date the duty is paid or would have been paid.

It is extremely important for taxpayers to avoid this problem and review all their documents and ensure that they get it appropriately stamped now to avoid the above penalties. However, many of these documents will also be orbit to let a trace in the company of the second to the control of the company of the second of the control of t will also be subject to late stamping penalty. The late stamping penalty rates are increased from Jan 1 2025 to a maximum of 10% if is stamped within three months after the time for stamping and 20% thereafter. All documents must be stamped within 30 days from the date

of execution.

Currently, under the official assessment system, all documents must be sent for adjudication, and the duty is only payable thereafter. Upon the introduction of the self-assessment system, the adjudication will only be done after the taxpayer has filed a self-assessed return which will be deemed to be an assessment on the day the return is filed. In the event the adjudication gives rise to additional duty, there will be additional assessments

The changes to the Stamp Act in 2025 and 2026 are very significant because the imposition of stamp duty is now mandatory.

#### 'Halal certification should not be made mandatory'

PETALING JAYA: Halal certification should not be made mandatory as it adds an additional layer of burden and cost to businesses

especially to SMEs and small trade Small and Medium Enterprises Association of Malaysia (Samenta) national president Datuk William Ng (pic) said obtaining a halal certification is not just a matter of not serving nonhalal food items but also requires extensive documentation on the part of the applicant. "The requirement is understandably stringent and extends to business premises, processes, suppliers, packaging and labelling, transportation, and others," he said in a statement.

requirement to businesses. He was responding to the recent decision by the Kelantan government to mandate halal certification among food and beverage (F&B) operators in the state, beginning with Kota Bharu, prior to

noted that halal certification promotes better food safety and promotes better food safety and traceability, and allows F&B businesses operated by both Muslims and non-Muslims, to be better promoted to Muslim consumers. This is especially relevant in Kelantan, where about 96% of the population are Muslims.

rolling out the initiative across the state.

Ng said F&B operators are also required to provide periodic training to employees, which require time-off and constant training as staff turnovers.

He said the cost of halal certification is not just the fee paid to Jakim. Applying for halal certification could mean up to RM200,000 if modifications to the premises are required, and up to RM50,000 more a year if a halal coordinator is required on top of the training costs of new and existing employees, he added.

Ng said larger chain stores may be able to afford to follow these stringent regulations, especially given the benefits of being halal certified. However, for small traders, both Muslim and non-Muslim, the process and costs of having halal certification add another layer of the process and burden in an already bride process. expenses and burden, in an already high-cost, low margin business environment.

"Mandating halal certification at both application and renewal of business licensing will work against us as an economy – as it adds time and costs to starting a business – a key parameter in almost every 'ease of doing business' and competitiveness ranking.

"We urge the Kelantan government to reconsider this decision, and instead work with F&B operators to promote halal certification and with the certification authority to further streamline and reduce the burden and costs of obtaining such certification," Ng said.

#### Engie: Well-designed approach will create robust carbon trade system

KUALA LUMPUR: A well-designed approach can be transformative for Malaysia's carbon markets as it incentivises industries to reduce emissions while creating a foundation for a robust carbon trading ecosystem, said Engie Services Malaysia

Managing director Wong Yin Kee said the Malagnia director work fill kee sala the carbon tax complements initiatives like Bursa Malaysia's carbon exchange, providing a transparent price signal and enabling businesses to earn and trade carbon credits by cutting emissions.

This not only drives decarbonisation but also positions the country as a key player in global carbon markets, aligning with mechanisms like Article 6.4 of the Paris Agreement, he said.

The Article 6.4 mechanism allows countries

to trade reductions in carbon emissions, going beyond zero-sum offsetting, to fulfil their commitments under the Paris Agreement.

"In my view, tying financial incentives to emission reductions is an inevitable move to complement Malaysia's broader decarbonisation efforts.
"With the right design and implementation,

this will be a crucial step in ensuring Malaysia achieves its net zero ambition," he told Bernama in an interview.

In Budget 2025, the government announced plans to implement a carbon tax for the iron, steel and energy industry by 2026, emphasising the country's commitment to its emission reduction goals

Wong pointed out that collaboration among government, industries, and stakeholders will be essential to align the tax with Malaysia's nationally determined contributions and energy transition plans.

Moreover, he added that support for affected industries and communities, such as subsidies or incentives, will ensure an inclusive transition while maintaining economic growth.

Wong said the carbon tax can be a powerful catalyst for Malaysia's carbon market.

He noted that the government sends a strong message to industries to prioritise decarbonisation by pricing emissions, creating strong incentives to adopt low-carbon technologies and energy-efficient practices. Among the main advantages of imple-menting a carbon tax is ensuring Malaysian

exports remain competitive.

#### FMM opposes base electricity tariff hike, says industries already face challenges

**PETALING JAYA:** The Federation of Malaysian Manufacturers (FMM) strongly opposes the increase in the base electricity tariff for 2025-2027, its president, Tan Sri Soh

He said the 14.5% increase will have a big impact on industries especially when the manufacturing sector is facing its toughest time with escalating costs and uncertainties.

"Not only will there be an

impending increase in operational costs expected in 2025, such as the higher minimum wage and other compliance costs imposed by evolving regulatory requirements, the sector is also bracing for global uncertainties such as geopolitical tensions, persistent supply chain vulnerabilities and shifting trade policies including potential new or higher tariffs enforced by the US administration," Soh said in a statement.

Last week, Tenaga Nasional Bhd Last week, Tenaga Nasional Bhd announced a new tariff schedule with a base tariff of 45.62 sen per kilowatt-hour for Peninsular Malaysia under Regulatory Period 4 (RP4), which will be implemented starting July 1, 2025. The base tariff under RP3 was set at 39.95 sen/kWh between 2022 and 2024.
"The current electricity tariff

"The current electricity tariff schedule, which has been in place since 2014, will continue to be in effect, with no change in the electricity tariff rate and tariff structure until June 30, 2025, TNB said in a filing with Bursa Malaysia on Thursday, Bernama reported.

The following day Prime

The following day, Prime Minister Datuk Seri Anwar Ibrahim said the government would not allow an increase in electricity tariffs that could adversely affect the majority of Malaysians. He said that although tariffs need to rise, this should not affect a significant portion of the population.

"We do not allow electricity tariff increases that affect the general public. Any increase, as before, will only involve the upper-income group ... what I refer to as the ultrarich or profit-making industries," Anwar was quoted saying.

Soh said it is imperative to note that in the last few years, the industrial sector has seen several significant

operational cost increases. These include the natural gas price increase to above RM40/mmBtu since the third quarter of 2022, the increase in water tariff for the non-domestic sector from August 2022 to January 2023, with tariff review every 3 years including electricity charge. years, including electricity charge, which is reviewed annually.

Further, since January 2023, there have been double-digit Imbalance Cost Pass-Through surcharges for medium and high-voltage users, which have impacted domestic industries. Soh said local industries are

seeing the continued impact of amendments to the Employment Act, which came into effect on Jan 1, 2023, that expands the scope to overtime entitlement for those earning up to RM4,000, increase in maternity leave to 98 days, re-duction in weekly working hours to 45 hours from 48 hours previously, among others.

And in 2024, Soh said, domestic businesses faced significant cost increases, including a 300%-400% rise in Department of Occupational Safety and Health inspection fees (e.g., RM3,435 to RM14,750), an 8%-12% hike in logistics costs due to a 6% service tax increase, additional expenses for e-invoicing IT systems, and higher penalties under the Environmental Quality Act and Occupational Safety and Health

Act.
Further cost pressures are anticipated in 2025, with the minimum wage rising to RM1,700 on Feb 1, adding RM10.8 billion to annual payrolls. The implementation of a multitier levy system and mandatory Employee Provident Fund contributions for non-citizen employees are estimated to employees are estimated to increase payroll costs by RM6.6 billion annually.
"With the overall significant cost

increases highlighted above, FMM reiterates its call for the government to keep the industrial tariff rates unchanged so that Malaysia continues to be competitive as well as attractive to foreign investors.

"The government also needs to hold an immediate dialogue with stakeholders on this matter," Soh said.

#### Ringgit pursues stability amid firm US dollar, upbeat domestic outlook

**PETALING JAYA:** The ringgit has outperformed expectations last week, reversing course to strengthen below the 4.50 threshold as the US Dollar Index (DXY) softened last Friday after a lower-than-expected core personal consumption expenditures reading.

Kenanga Investment Bank Bhd (Kenanga IB) said the DXY rebounded last Monday, stabilising above 108.0 after the US averted a government shutdown.

The research firm said the US dollar's strength was further supported by the euro's continued weakness, which was driven by weak eurozone economic prospects and the European Central Bank's dovish stance.

"Despite these pressures, the ringgit held steady within the 4.47-Malaysia's uptrend from year-end window-dressing and domestic economy optimism," Kenanga IB said

in a report.

The firm said market sentiment wavers between expectations of two US Federal Reserve rate cuts and a single cut next year, with a small faction now considering the prospect of an increase.

"Persistent inflation concerns under Trump 2.0 could dominate 2025 monetary policy uncertainty, keeping the USD strong and pressuring the ringgit through Q1 of 2025. While the ringgit may close 2024 slightly stronger than anticipated, it is projected to trade around 4.50– 4.60/USD in early 2025, contingent on Trump's policy decisions," Kenanga IB noted.

Although domestic factors might lend support to the ringgit, robust US dollar demand is expected to outweigh these research firm said. influences, the

### **Political turmoil shakes** South Korea's economy

Business and consumer confidence take biggest hit since start of Covid pandemic, central bank figures show

SEOUL: After South Korea's president and his replacement were both deposed over a failed bid to impose martial law, deepening political turmoil is threatening the country's currency and shaking confidence in its economy.

The won, which plunged last Friday to its lowest level against the dollar since 2009, has been in near-constant decline since President Yoon Suk Yeol's attempt to scrap civilian rule in early December.

Business and consumer confidence in Asia's fourth-largest economy have also taken their biggest hit since the start of the Covid-19 pandemic, according to figures released by the Bank of Korea.

Lawmakers impeached Yoon in mid-December on charges of insurrection, and on Friday they impeached his successor, acting president and prime minister Han Duck-soo, arguing that he refused demands to complete Yoon's removal from office and bring him to justice.

bring him to justice.

That thrust Finance Minister Choi

Sang-mok into the additional roles of acting president and prime minister.

Choi has pledged to do all he can to end "this period of turmoil" and resolve the political crisis

gripping the country.

At the heart of the stalemate is the Constitutional Court, which will decide whether to uphold parliament's decision to impeach

It must do so by a two-thirds majority,

And because three of the court's nine seats are currently vacant, a unanimous vote is required to

confirm the suspended president's removal.

Otherwise, Yoon will be automatically returned to office.

Lawmakers last Thursday nominated three judges to fill the vacant seats, but acting president Han refused to approve them, precipitating his own impeachment

After an acrimonious day in which lawmakers from Yoon's party erupted in protest, the country's newest acting president sought to project calm.

"Although we are facing unexpected challenges once again, we are confident that our

robust and resilient economic system will ensure rapid stabilisation," Choi said Friday.

The 61-year-old career civil servant has inherited a 2025 budget – adopted by the opposition alone – which is 4.1 trillion won (RM12.5 billion) less than the government had

hoped for.
"There are already signs the crisis is having an

impact on the economy," Gareth Leather of apital Economics wrote in a note to clients, citing the dip in consumer and business confidence.

"The crisis is unfolding against a backdrop of a struggling economy," he added, with GDP growth expected to be just two percent this year, weighed down by a global slowdown in demand

for semiconductors.
"Longer term, political polarisation and resulting uncertainty could hold back investment in Korea," Leather wrote, citing the example of Thailand, another ultra-polarised country whose economy has stagnated since a coup in 2014.

But other economists noted that the South Korean economy has so far weathered the chaos

As early as Dec 4, the day after Yoon declared martial law following a budget tussle with the opposition, the central bank promised to inject sufficient liquidity to stabilise the markets, and the Kospi Index has lost less than four percent

since the start of the crisis.

"Like everyone, I was surprised when Yoon took those crazy measures," Park Sang-in, a professor of economics at Seoul National University, told AFP.

"But there was a resilience of democracy."

The joint venture will be formed partly by Shinsegae investing its 100% stake in South Korean e-commerce platform Gmarket, it said in a regulatory filing.

AliExpress Korea and Gmarket will

be incorporated into the joint venture, which will be set up in 2025.

But the two platforms will continue be operated independently, Shinsegae said in a separate statement.

#### Toyota global production down for 10th month

**TOKYO:** Toyota Motor's global production decreased for a 10th straight month in November, the Japanese carmaker said, although its worldwide sales grew for the second consecutive month on solid demand in

The world's biggest automaker manufactured 869,230 vehicles globally in November, down 6.2% from the same month

last year, a larger fall than October's 0.8% dip.
Toyota's US output was down 11.8%, making a slow recovery although the production of Grand Highlander and Lexus TX SUV models resumed in late October after a four-month stoppage.

China production dropped 1.6%, which was however better than a 9% decline in the previous month, as Toyota saw higher local sales of its Granvia and Sienna minivan models and the electric sedan bZ3 jointly developed

Amid the rise of BYD and other Chinese brands, Toyota has decided to build an independent plant in Shanghai and start manufacturing electric cars for its Lexus luxury brand from around 2027, the *Nikkei* newspaper reported.

In Japan, which accounts for about a third of Toyota's global output, production was down 9.3% in November, due in part to a

two-day production halt at its Fuilmatsu and

Toyota saw its worldwide sales rising for a second straight month, by 1.7% to 920,569 vehicles, setting a new record for the month of November. In the

January-to-November Toyota's global output was 5.2% lower than the same period last year at around 8.75 million vehicles, while global sales were down

The production and sales figures include vehicles of Toyota's Lexus brand but exclude those of group companies Hino and Daihatsu.

### India considers cutting personal income tax

#### Move will provide relief to middle class and boost consumption

NEW DELHI: India is considering cutting income tax for individuals making up to 1.5 million rupees (RM78,000) a year in million rupees (RM78,000) a year in February's budget to provide relief to the middle class and boost consumption as the economy slows, two government sources said.

The move could benefit tens of millions of

taxpayers, especially city dwellers burdened by high living costs, if they opt for a 2020 tax system that strips exemptions like housing rentals. Under that system, annual income of 300,000 rupees to 1.5 million rupees is taxed at between 5% to 20%

Higher income draws 30%.

Indian taxpayers can choose between two tax systems - a legacy plan that allows exemptions on housing rentals and insurance, and a newer one introduced in 2020 that offers slightly lower rates, but does not allow major exemptions.

The sources, who did not want to be named because they were not authorised to talk to the media, said they had not decided

on the size of any cuts.

A decision would be taken closer to the budget on Feb 1, they said.

The Finance Ministry did not immediately

spond to an e-mail seeking comment.

The sources declined to share revenue

loss of any tax cut but one said reducing tax rates would make more people choose the

new system that is less complicated.

India gets a bulk of its income tax from persons earning at least 10 million rupees, the rate for which is 30%.

#### Thai economy slows in November

BANGKOK: Thailand's economy slowed in November from the previous month as private consumption and investment contracted but activity remained supported by tourism and exports, the central bank said.

Growth in Southeast Asia's second-largest

economy has lagged regional peers since the pandemic, hobbled by high household debt and borrowing costs as well as declining manufacturing.

The central bank said private consumption

dropped 0.4% in November from October, when the government made cash transfers to some households under its digital wallet stimulus scheme, and private investment fell 1.8% on the month, mainly in machinery and construction categories

Exports rose 9.1% in November from a year earlier, while foreign tourist numbers increased 19.5% annually, the Bank of Thailand said in a statement.
Earlier this month, the central bank

maintained its economic growth forecasts at 2.7% this year and 2.9% in 2025. Last year's growth was 1.9%.

The current account surplus widened to

US\$2 billion in November from a surplus of

US\$0.7 billion in November from a surplus of US\$0.7 billion in October. Industrial Ministry data earlier on Friday showed manufacturing output dropped by a larger-than-expected 3.58% in November from a year earlier due to a slump in auto production

Figures showed car production in Thailand fell 28.2% in November from a year earlier, down for the 16th straight month, due to weak sales and exports, according to the Federation

of Thai Industries.
Poonpong Naiyanapakorn, head of the Trade Policy and Strategy Office, told a news conference that the Commerce Ministry is maintaining its export growth target of 2% to 3% for 2025

"We are not worried about exports next ear," he said, adding the ministry was preparing for US trade policies.

Commerce Minister Pichai Naripthaphan said this month the government was aiming to beat the 2025 export goal. - Reuters

#### Indian banks' balance sheets remain robust

MUMBAI: Indian banks' financial position has stayed robust, marked by the sustained expansion in loans and deposits, while their gross bad loan ratio has dropped to multi-year lows, a central bank report showed last week.

Banks' gross non-performing assets ratio (NPA), or the proportion of bad assets to total loans, slipped to an over-13-year low of 2.5% at end-March, the Reserve Bank of India (RBI) said in its *Trend and Propostal Control* Progress of Banking'report.

Net bad loans of banks fell to 0.57% of total

loans at September-end, from 0.62% at end-March, driven by stronger loan-loss buffers, the RBI report said.

The asset quality of non-bank finance companies (NBFCs) also improved further in 2023-24 amid a sustained double-digit balance sheet growth, the central bank said.

Over the past year, the RBI has warned the financial sector against "all forms of exuberance", tightened rules for credit card and personal loans, made it more expensive for non-banking finance companies to borrow from banks and imposed restrictions on non-compliant lenders.

Banks have also cleaned up their balance sheets in recent years by selling bad loans to asset reconstruction companies or by writing

Their capital and liquidity buffers stayed well above the regulatory needs while profitability improved for the sixth consecutive year in fiscal year 2023-24, the RBI report said.

Going forward, banks need to strengthen

their risk management and IT governance standards, and focus on checking unscrupulous activities, including suspicious and unusual transactions, the RBI said.

Meanwhile for NRECs an imprudent "growth at any cost" approach would be counterproductive, the RBI said, highlighting the need for robust risk management frameworks.

Non-bank lenders need to strengthen customer grievance practices and avoid recourse to usurious interest rates, it said. – Reuters

#### 'Nippon-US Steel deal has support in steelmaking areas'

**TOKYO:** Japan's Nippon Steel is seeing support for its proposal to acquire US Steel in the regions of the United States where steel mills are located, Nippon Steel's President Tadashi Imai told reporters.

Last week, a US foreign investment committee referred the decision whether to approve or block the US\$15 billion deal to President Joe Biden, who has 15 days to decide. Biden and his incoming successor, Donald

Trump, have both expressed opposition to the purchase.
Imai reiterated that Nippon Steel has made a

number of commitments to address national security concerns of the Committee on Foreign Investment in the United States, adding he believed there was "progress in understanding".

"In the communities of the various regions where the steel mills are located, there is a considerable amount of support for this acquisition. I hope that President Biden will

acquisitori. They that president block will understand ... the value of this acquisition to the US economy."

Both companies have previously said they had planned to close the deal, which has also faced opposition from a powerful the United Steelworkers labour union (USW), before the end of 2024.

On Wednesday, Nippon Steel shared a letter to Biden dated Dec 23 and signed by two dozen US municipality officials in areas where US Steel mills are located, asking the American president to approve the takeover deal.

"We respectfully urge you to listen to the voices of the steelworkers and everyone else whose economic security is tied to US Steel – they are speaking loudly in unison that this deal must be approved," the letter said. - Reuters

### Trump return will not stop clean energy boom

▶ Biden-era law providing subsidies for solar and wind projects near-impossible to repeal

WASHINGTON: Donald Trump's return to the White House will refocus the nation's energy policy onto maximising oil and gas production and away from fighting climate change, but the Republican's presidency is unlikely to dramatically slow the US renewable energy boom. That is because a Joe Biden-era

law providing a decade of lucrative subsidies for new solar, wind and other clean energy projects would be near-impossible to repeal, thanks to support from Republican states, while other levers available to the next president would only have

marginal impact, analysts say.
"I don't think a Trump president
can slow the transition," said Ed
Hirs, energy fellow at the University of Houston. "This is well underway."

Renewable energy sources like solar and wind are the fastest growing segments on the power grid, according to the Department of Energy, driven by federal tax credits, state renewable energy mandates, and technology advancements that have lowered their costs. President Biden in 2022 signed

into law the Inflation Reduction Act (IRA) guaranteeing billions of dollars of solar and wind subsidies for another decade as part of his

broader effort to decarbonise the power sector by 2035 to fight climate change.

Before the election. Trump slammed the IRA as being too expensive and promised to rescind all unspent funds allocated by the law – a threat that, if accomplished, could pour cold water over the US clean energy boom.

But doing so would require lawnakers, including those whose states have benefited from IRA-related investments like solar panel factories, wind farms and other projects, to vote to repeal it.

"The jobs and the economic benefits have been so heavy in red states, it's hard to see an administration come in that says we don't like this, said Carl Fleming, a partner at law firm McDermott Will & Emery, who advised the Biden White

House on renewable energy policy.

Many of Trump's allies also benefit from the IRA through their investments in clean energy technologies, Reuters has

technologies, Reuters has previously reported. Fleming said Trump could, however, slow things down around the margins by hindering federal agencies that deliver IRA grants and loans, or by reducing federal leasing

for things like offshore wind. "You could see a

administration come in and they can very quickly begin to cut budgets or restrict budgets or restrict the freedom of agencies to do certain things that are tied to

"But I think that's a smaller subset of the larger renewables market that's really relying on those, so I don't think it would have a shocking effect."

The Biden administration has The Biden administration has rushed to ensure it spends the majority of available grant funding under the IRA before a new president arrives, Reuters has previously reported.

One way Trump could slow the

transition is through executive action by changing public lands leasing, analysts said.

The Biden administration had

sought to expand lease auctions for offshore wind in federal waters, along with solar and wind on land.

"I think you would see more preference given to fossil fuel extraction on public lands and waters," said Tony Dutzik, associate director and senior policy analyst at Frontier Group, a non-profit sustainability think tank.

That could have an outsized impact on the offshore wind industry, which aims to site projects in federal waters. Most onshore solar and wind projects are located on private property, as is the vast majority of oil and gas drilling.

Trump has said he intends to end

the offshore wind industry "on day one", arguing it is too expensive and

poses a threat to whales and seabirds dramatic policy reversal after his rst administration supported offshore wind development.

Bernstein Research said Trump

is likely to enact a moratorium on new offshore wind lease sales.

Meanwhile, US fossil fuel production is likely to look much the same under Trump, experts said

The US has already become the world's largest oil and gas producer, under the watch of Biden, thanks to a drilling boom in fields like the Permian Basin under Texas and New Mexico.

New Mexico.
Trump paved the way for the boom by slashing red tape during his term in the White House and he could expand US fossil fuel production in a second term by rolling back Biden's climate

initiatives, his campaign said.

Trump could, for example, push for drilling in Alaska's Arctic National Wildlife Refuge. Biden blocked ANWR drilling

leases, but even if Trump opens up the pristine area prized by environmentalists, it is uncertain whether companies would be willing to pump in the rugged north.

"Presidents can make a lot of noise about plans for US oil and gas, but ultimately it's individuals and companies responding to prices of a global commodity that make the decisions on when to drill," said Jesse Jones, head of North American Upstream at Energy Aspects.

#### **EU universal** charger rules come into force

BRUSSELS: EU rules requiring all new smartphones, tablets and cameras to use the same charger came into force on Saturday, in a change Brussels said will cut costs and waste.

Manufacturers are now obliged to fit devices sold in the 27-nation bloc with a USB-C, the port chosen by the European Union as the common standard for charging electronic

"Starting today, all new mobile phones, tablets, digital cameras, headphones, speakers, keyboards and many other electronics sold in the EU will have to be equipped with a USB Type-C charging port," the EU Parliament wrote on X.

The EU has said the single charger rule will simplify the life of Europeans

and slash costs for consumers.

By allowing consumers to purchase a new device without a new charger, it will also reduce the mountain of obsolete chargers, the bloc has argued.

The law was first approved in 2022

following a tussle with US tech giant Apple. It allowed companies until Dec

28 this year to adapt.

Makers of laptops will have extra time, from early 2026, to also follow

Most devices already use these cables, but Apple was more than a little reluctant.

The firm said in 2021 that such regulation "stifles innovation", but by September last year it had begun shipping phones with the new port.

Makers of electronic consumer items in Europe had agreed on a single charging norm from dozens on the market a decade ago under a voluntary agreement with the European Commission. But Apple, the world's biggest seller

of smartphones, refused to abide by it and ditch its Lightning ports.

Other manufacturers kept their alternative cables going, meaning there were about half a dozen types knocking around, creating a jumble of

cables for consumers.

USB-C ports can charge at up to 100 Watts, transfer data up to 40 gigabits per second, and can serve to hook up to external displays.

At the time of its approval, the commission said the law was expected to save at least €200 million (RM/929 million) per year and cut more than a thousand tonnes of EU electronic waste every year.

"It's time for THE charger," the European Commission wrote on X.

#### Turkiye central bank lowers key interest rate to 47.5%

ANKARA: Turkiye's central bank lowered its key interest rate last week, the first cut in nearly two years as it

battles with double-digit inflation.
The bank's monetary policy committee decided to reduce the policy rate from 50% to 47.5%, with a statement citing improvement in "inflation expectations and pricing

The last cut was in February 2023.

The central bank began to raise interest rates last year to battle soaring prices, after President Recep Tayyip Erdogan dropped his opposition to orthodox monetary

It has kept the main rate stable at 50% since March.

The decision signals the start of an easing cycle after eight months of steady policy.

central bank decisiveness over its tight monetary stance "is bringing down the underlying trend of monthly inflation and strengthening the disinflation

November, Turkiye's annual inflation rate slowed for the sixth

month in a row, at 47.1%.

The central bank now expects inflation to reach 44% at the end of 2024, up from a previous estimate in August of 38%.

The bank said the level of the

policy rate would be determined in a way to ensure the tightness required by the projected disinflation path, taking into account both realised and expected inflation.

This week, the central bank announced that it would hold fewer policy meetings next year.

"The committee will make its decisions prudently on a meeting-by-meeting basis with a focus on the inflation outlook," the bank said, adding it would "decisively use all the tools at its disposal in line with its main objective of price

stability".
The bank "will make its decisions in a data-driven predictable, transparent framework", it added. – AFP

#### Bursa set to continue uptrend on window-dressing activities

**YEAR-END** window-dressing activities are expected to continue to drive Bursa Malaysia's uptrend this week, fuelled by positive sentiment, according to UOB Kay Hian Wealth Advisors Sdn Bhd.

Its head of investment research, Mohd Sedek Jantan, remained optimistic that the benchmark FTSE Bursa Malaysia KLCI (FBM KLCI) could edge closer to the company's in-house 2024 target of 1,650 points, following the index's rally last week to close above the 1,620 resistance level.

This expectation is underpinned by the anticipated return of "This expectation is underpinned by the anticipated return of foreign investors after the Christmas holidays, alongside positive factors such as an improving global economic outlook and potential easing of monetary policy," he told Bernama. Mohd Sedek noted the recent strong performance was primarily driven by power and utility stocks, likely bolstered by year-end window-dressing activities by portfolio managers. "Motably the rally occurred without significant foreign investor."

"Notably, the rally occurred without significant foreign investor participation, underscoring the resilience of domestic market drivers," he said.

For the holiday-shortened week just ended, the FBM KLCI was higher amid continuous buying interest, taking cues from the

upbeat performance on Wall Street and regional markets. On a Friday-to-Friday basis, the key index was up by 36.73 points to 1,628.14 compared to 1,591.41 in the previous week. Turnover tumbled to 9.72 billion units worth RM7.52 billion compared with 15.30 billion units worth RM13.97 billion in the previous week. Main Market volume slipped to 5.01 billion units valued at RM6.71 billion compared to 8.10 billion units valued at RM12.79 billion previously. ACE Market volume narrowed to 2.10 billion units valued at RM565.86 million versus 2.22 billion units valued at RM731.38 million in the week before.

#### MGS, GII yields set for modest rise amid global uncertainty

KUALA LUMPUR: US President-elect Donald Trump's policies are expected to heighten global economic uncertainty, potentially strengthening the greenback and exerting upward pressure on local bond yields.

In a note, Kenanga Investment Bank Bhd said expectations of a higher inflationary environment in the US, supported by the Fed's recent less dovish tone, add to the likelihood of rising local yields.

"Nonetheless, optimism surrounding the domestic economy remains intact, with the upcoming PMI data serving as a key indicator. A stronger reading could attract foreign inflows offering some offset to the upward yield trajectory."

The Malaysian Government Securities (MGS) and Government Investment Issues (GII) yields displayed mixed movements last

week, ranging from -1.6 to 1.5 basis points (bps). The 10-year MGS declined by 1.6 bps, to settle at 3.82%, while

the 10-year GII saw a slight drop of 0.4 bps, closing at 3.84%. Kenanga said the 10-year MGS experienced a decline, largely attributed to a softer-than-expected US core PCE reading, which introduced uncertainty around US inflation conditions.

Domestically, a stable inflation rate of 1.8% maintained

investor confidence, providing support to local yields. However, foreign outflows totalling RM1.4 billion in the

domestic debt market highlighted persistent global uncertainty, likely stemming from Trump's geopolitical manoeuvres.

Market experts noted that Trump's policy agenda presents both opportunities and challenges for various investment sectors. While some industries may benefit from reducing regulatory constraints, others could face significant risks, including market volatility and disrupted global supply chains. volatility and disrupted global supply chains.

#### Ringgit set to exhibit softness in thin trading this week

**THE** ringgit is set to exhibit softness this week during the last period of trading in 2024 and the start of 2025, with movements

iskely ranging between 4.47 and 4.50 against the US dollar.

SPI Asset Management managing partner Stephen Innes expects Asian currencies, including the ringgit, to face a cautious period as market participants navigate mixed signals

and geopolitical concerns during the thin trading week. He said the US dollar tends to weaken seasonally at this time, but with President-elect Donald Trump's tariffs on the horizon. there is an added layer of uncertainty.

"Locally, investors are also maintaining a cautious stance due

to concerns over China's economic issues, particularly the record US\$411 billion special bond issuance slated for next year and its

potential impact on consumer demand.

"This uncertainty has cast a shadow over the ringgit," he told

Similarly, UOB Kay Hian Wealth Advisors head of investment research Mohd Sedek Jantan anticipated a lower ringgit movement this week following a cautious approach expected from the Federal Reserve.

He said market expectations of only two US rate cuts in 2025 will support the greenback.

"Entering 2025, Asian currencies are expected to weaken against the US dollar in the first six months, driven by market reactions to Trump's re-election and anticipated trade tariffs.

"Since Trump's victory in early November, the US Dollar Index

has rallied about 4% to 107.6, the highest level in two years, reflecting expectations of potential tariffs on US trade partners,"

MALAYSIA'S economy has experienced its strongest growth since 2018. This momentum is expected to continue, fuelled by substantial FDI inflows, which also generate positive spillovers of domestic direct investment (DDI). Malaysia has achieved a record level of approved investments in 2023, with strong investment activity projected to persist into 2024.

Private investment is anticipated to remain a key driver of

economic growth in the coming years with the further realisation of the approved investment. We forecast GDP growth of 5.1% in 2025, following an estimated 5.3% in 2024, marking the first time since 2014 that the economy has expanded by over 5% for two consecutive years. This commendable economic performance is likely to support the country's equity market.

The global economy was on track for steady growth in 2025, buoyed by monetary easing in advanced economies. However, the outlook has grown increasingly uncertain due to policy ambiguities under newly elected US President Trump. On several occasions, Trump has proposed imposing tariffs as high as 60% of Chinese goods and a blanket 10% tariff on all US imports. Such measures could reshape the global trade landscape, with Malaysia

not spared from these potential economic repercussions.

Since the onset of the US-China trade war in July 2018, Malaysia's monthly total exports have risen by c.53%. Exports to the US have surged by nearly 150%, far outpacing the 34% growth in exports to China.

This trend underscores Malaysia's ability to seize on heightened US-China trade tensions, particularly in its trade with the United States, supported by trade-friendly policies and its strategic position in the global semiconductor supply chain. – Philip Capital Research, Dec 27

#### Coastal Contracts Bhd Buy. Target price: RM1.67

THE group's wholly-owned subsidiaries, Coastal Solar and Pleasant Engineering, together with Bina HT as part of a consortium, have secured a letter of notification on acceptance of offer (LON) from the Energy Commission of Sabah. The consortium will develop a large-scale solar photovoltaic (PV) plant with a capacity of 15MWac on the east coast of Sabah, with COCO having an effective stake of 95%. The solar power purchase agreement (PPA) with Sabah Electricity will span 25 years, with the commercial operation date (COD) scheduled between 1 Apr 2027 and 30 Jun 2027.

While details of the PPA are yet to be finalised, management estimates the project's internal rate of return (IRR) to be around 10-12%. The higher IRR could be attributed to potentially better tariffs, as Sabah historically offered higher rates under the Large Scale Solar 2 (LSS2). The


general solar capex requirement is around MYR2-2.5m/MWdc. translating to a total investment of c.MYR45-56m for the 15MWac plant and funding is expected to be structured with an 80:20 debt-to-equity ratio. Based on these parameters, we estimate the project to generate earnings of MYR2-3m pa.

The group has been proactively building a dedicated team to support its transition into the RE sector, ensuring it has the

expertise to capitalise on emerging opportunities.
Currently, its main income contributor is Petroleos Mexicanos (Pemex), which poses concentration risks should there be any adverse developments. This timely entry into the RE sector aligns well with the industry's growth trajectory, supported by robust initiatives introduced by the government. Additionally, the general >15-year PPAs also provide long-term income visibility.

#### Tune Protect Group Bhd Buy. Target price: RMO.48

TUNE Protect achieved a performance turnaround with a net profit of RM5.9mn in 3Q24, compared to a net loss of RM9.8mn in 2Q24. This improvement was driven by i) a 5.0% QoQ increase in insurance revenue to RM100.2mn, primarily from the travel segment, particularly AirAsia and the Middle East, ii) better claims experience in the fire, engineering, cargo and PA segments, and iii) a lower expense ratio due to enhanced cost efficiency.

Overall, the group recorded a positive underwriting result of RM6.1mn in 3Q24, compared to an underwriting loss of RM4.9mn in 2Q24. As a result, the combined ratio improved to 93.9% (vs. 105.2% in 2Q24).
According to the General Insurance Association of Malaysia,

the total net claims incurred ratio for the motor insurance class increased to 66.7% in 2023, up from 65.3% in 2022. Currently, we understand that Tune's motor loss ratio is higher than the industry average. As such, the group aims to rebalance its motor portfolio by focusing on more profitable sub-segments, such as mid-to high-sum-insured motor and motorcycles. This strategy would allow Tune to raise its average premium level to align more closely with the industry average.

In tandem with the review of Tune's business portfolio, the

group will place greater focus on the travel business, which is its key competency. Thus far, the group has observed that tickets from its airline partners are increasingly being sold through indirect channels (39% pre-pandemic vs. 56% post-pandemic),

corresponding with a relatively lower take-up rate (TUR).

Moving forward, Tune Protect plans to increase TUR through price optimisation in selected markets and the launch of new products. We expect TUR for international short-haul flight direct channels to increase to approximately 20% (up from 15%) Currently) in FY25, driven by new product launches such as the Tune Protect Travel Gadget and bundled ancillaries.

### **Ambitious but** flawed film

This movie is Marvel's latest guilty pleasure

IRECTED by I.C. Chandor. raven the Hunter attempts to dive deep into the origin story of Sergei Kravinoff (Kraven), one of Marvel's most iconic antiheroes. The film has all the ingredients for a stellar entry into Sony's Spider-Man Universe (SSU): a star cast, breathtaking cinematography and a promising start. But like a hunter who loses his prey, the movie gradually veers off course, becoming an over the top spectacle that is as perplexing as it is entertaining.

#### Promising start with high-quality execution

The film begins with a bang, introducing viewers to Sergei, portrayed masterfully by Aaron Taylor-Johnson. The opening scenes establish a visceral, gritty tone that promises an intense character study. Taylor-Johnson's performance is magnetic, he brings a primal energy to Kraven that balances his inner turmoil and predatory instincts.

The cinematography by Ben

Davis is equally impressive. Sweeping landscapes, shadowy interiors and action sequences are captured with finesse, creating a

visually stunning experience.

The first act sets up a compelling story, exploring themes of familial conflict and personal vengeance.

Russell Crowe delivers a deliciously menacing performance as Nikolai Kravinoff, Sergei's ruthless father while Ariana DeBose's Calypso adds intrigue and mysticism to the mix.

For a brief moment, *Kraven the Hunter* might deliver the dark, morally complex story fans have been craving.

#### Gradual descent into chaos

But then, the wheels come off. By the second act, the film begins to buckle under the weight of its ambitions.



The film had all the ingredients for a stellar entry in SSU.

What starts as a taut thriller devolves into a mishmash of clunky dialogues, absurd plot twists and a questionable focus on secondary characters. Alessandro Nivola's Rhino is underutilised despite being hyped as a major villain and Fred Hechinger's Dmitri (aka Chameleon) oscillates between compelling and cartoonish.

The script struggles to balance the multiple subplots and the pacing becomes erratic. Scenes that should build tension feel rushed while others drag unnecessarily. The action, occasionally thrilling, starts to rely heavily on CGI-laden sequences that undermine the gritty realism established early on.

#### Unintended comedy and baffling

choices
What truly sets Kraven the Hunter apart, perhaps unintentionally, is how hilariously absurd it becomes. The film's script occasionally dips into melodrama, with characters

delivering dramatic lines that feel ripped from a soap opera. Crowe's thick accent adds an unexpected comedic layer to his otherwise intimidating presence and some of the action scenes cross the line from thrilling to outright ridiculous.

A standout moment involves a buffalo stampede that feels more suited to a nature documentary than Marvel movie. These moments, while unintentional, inject the film with a campy charm that makes it

hard to look away. Here is where *Kraven the Hunter* unexpectedly edges out *Joker: Folie* à Deux. While both films aim for grit and emotional complexity, Kraven does not drown itself in its self-importance. Where Joker: Folie à Deux meanders with art-house pretensions, Kraven embraces its chaos, providing a fun, if not messy, ride.

Flawed yet entertaining
Despite its many flaws, Kraven the Despite its many laws, *Krauen the Hunter* manages to hold your attention. Taylor-Johnson's commitment to the role keeps the film grounded even as the plot spirals out of control. The action sequences, while over the ton are sequences, while over the top, are engaging enough to keep viewers on the edge of their seats.

The film's R-rating allows for a level of brutality not often seen in Marvel adaptations, adding an extra layer of intensity to the fight scenes. While the gore occasionally feels gratuitous, it does set the film apart from its PG-13 counterparts. For all its narrative missteps, the

movie retains a certain energy that makes it enjoyable in a "so bad it is good" kind of way. It is the sort of film where you can laugh at its absurdity while still appreciating the effort that went into making it.

The third act descends into complete chaos, with a climax that feels rushed and overly convoluted. Plot threads are hastily tied up, leaving audiences with more questions than answers. However, the ambiguous ending provides plenty of fodder for fan theories, making it a conversation starter long

after the credits roll.

At least Kraven the Hunter keeps its audience engaged until the end, unlike Joker: Folie à Deux, which spends its final moments wallowing in despair. If you are choosing between these two, go with the former's chaotic energy - you might former's chaotic energy – you might leave confused but at least you will not leave bored.

#### Lower your expectations

To fully enjoy *Kraven the Hunter*, it is essential to approach it with the right mindset. This is not a film to take seriously. Instead embrace its flaws, revel in its unintentional humour and appreciate the moments where it delivers on its potential.

Kraven the Hunter is a film that teeters on the edge of brilliance before

tumbling headfirst into absurdity. A disjointed plot, outrageous action and unintentional comedy undermine its strong performances, stunning cinematography and promising premise.

Yet for all its flaws, it remains a fascinating watch that keeps viewers glued to the screen, if only to see what outrageous twist will come next.

If Joker: Folie à Deux is a film that

drowns in its own misery, Kraven the Hunter is the wild, unhinged cousin who does not know when to quit. Come for Taylor-Johnson's magnetic performance, stay for the sheer spectacle of it all and leave wondering how such a chaotic film managed to be so entertaining.

Kraven the Hunter may not be the

superhero movie we needed but it is certainly one we will remember - that alone is worth the admission fee.

#### Japanese ace says 'deep love' of tennis keeps her going

OUR-TIME Grand Slam champion Naomi Osaka said yesterday she still had a "deep love" for tennis and was excited for the coming season, believing she can revisit her former glories.

The Japanese 27-year-old has struggled for

consistency since returning to the court in January this year after the birth of her daughter Shai in July 2023.

Her best results since then have been two quarterfinal appearances, which Osaka called "very painful".
"I think 2024 humbled me, but I think I also

grew a lot," she said at the Auckland Classic, which she is using as a springboard to the Australian Open Grand Slam - a tournament she won in 2019 and 2021.

I worked way harder than I ever have before and it was very painful to not get the results I wanted, but I feel like I am growing and learning.

"And I'm really excited for this year. I played

some really good matches (in 2024)." Her season was cut short by injury in October,

after just one tournament under Patrick Mouratoglou, the Frenchman best known for being the long-time coach of Serena Williams.

Osaka, now ranked 58, said there was plenty to look forward to and the fire to succeed was still burning inside her.

"What keeps me going in tennis is, I guess, stepping on the court and learning something

v every day," she said. "And obviously I'm really competitive, I love to win tournaments, to win matches, to play the best players in the world and see what I can achieve."

Asked if she still had the drive to get back to the top, Osaka replied: "Yeah, definitely.
"A year to two back I didn't know whether I

wanted to play again, I feel like for me, since the first time people knew about me, it was such a fast

whirlwind I didn't really have time to breathe.

"And I think having time with my family and having my daughter gave me the space to understand that I have a deep love for tennis and that I would love to see where that could go." -

#### Bumrah gives India shot at victory

INDIAN seamer Jasprit Bumrah unleashed more destructive bowling but Australia stubbornly battled back to reach 228-9 yesterday, leading by 333 runs in an absorbing fourth Test.

Bumrah scythed through the middle order on day four in Melbourne to record figures of 4-56 off 24 overs and hand India an outside chance of victory in a match the home side have mostly dominated.

However, India's hopes were diminished by a stubborn, unbeaten final-wicket stand of 55 from 17.5 overs.
Nathan Lyon was at the crease on 41 while No. 11

Scott Boland had seen off 65 balls to be 10 not out at the close.

Up by 105 runs on the first innings, Australia were rocked by losing four wickets for 11 midway

through the second session to slump to 91-6.

Marnus Labuschagne and Pat Cummins responded with a vital partnership of 57, taking the steam out of Bumrah's assault.

A charmed Labuschagne scored 70, to back up his first-innings 72, while Cummins produced a captain's knock of 41 – Iving him a career-high combined 90 runs for the Test.

Both teams are seeking to go 2-1 up in the series heading into the fifth and final Test in Sydney.

Australia remain in the stronger position on a

pitch showing signs of variable bounce.



"Their middle to lower order batting has been exceptional for the last four or five series we've played against them, so never comfortable with any amount of runs," said Labuschagne after play ended.
"At one stage we probably would have taken a

270 lead, and now the lower order has just put us in an amazing position with 333." India were earlier dismissed for 369 in reply to

Australia's first innings Nitish Kumar Reddy the last man out, caught in the deep for 114.

Reddy, playing just his fourth Test, finished with the highest Test score in Melbourne for any player batting at number eight or lower.

He believed India could successfully chase a "big

total" if they apply themselves.
"If you ask me, everyone is capable of playing on

this pitch," he said. - AFP

#### Ronaldo opens door to stunning City transfer

RISTIANO RONALDO has risked the wrath of Manchester United fans by opening the door to a blockbuster move to Manchester City, backing under-fire boss Pep Guardiola to turn their season around.

When asked at the Globe Soccer Awards if he would give City a "helping hand" to turn around their season, the Portuguese superstar refused to rule out a sensational move to the Etihad.

"The football is like... you never know what is going to happen," Ronaldo said.

When the presenter pressed him for a

clear answer, telling him "that's not a not", Ronaldo laughed and refused to elaborate.

Guardiola previously turned down the chance to sign Ronaldo in 2021 when Ronaldo announced he would be leaving

Instead, he returned to Old Trafford for a second stint and scored 27 goals in 54 games before his acrimonious exit in December 2022.

The Premier League champions are one of a few European clubs – along with Chelsea, PSG and his former club United –

that could feasibly afford Ronaldo's wages. However, there is nothing to suggest that they would entertain bringing in the Al-Nassr striker, who turns 40 in February. The absence of Rodri in midfield has

seen the champions unravel and with an ageing squad, Guardiola is in need for reinforcements and could make several moves in the market when the transfer

window reopens on Jan 1.

Despite being snubbed in the past, it hasn't stopped Ronaldo from giving his support to Guardiola, who is in the midst of his worst run since taking over as City coach in 2016.

"I think the big teams, the big players they are smart enough to understand what is the problem, where is the problem," Ronaldo added

"The teams have moments, good times difficult times... and for example, City will pass through this moment. I'm sure 100 per cent they will be back.

"Guardiola is a very smart coach. He knows where the problem is coming from. They will be there like always."
Ronaldo and Guardiola

checkered past from their time in Spain, with the former starring for Real Madrid as Lionel Messi's main rival and Guardiola coaching Barcelona until 2012.

But their relationship has improved over time, with Guardiola once labelling Ronaldo as "irreplaceable", before later expressing regret for not having more players of his calibre at the Ethad Stadium.

Ronaldo reciprocated not long after, hailing the Treble-winning manager as "a great coach" and admitted: "His teams are always at the top, and his football speaks for itself.

Ronaldo also Ruben Amorim to turn around Manchester United's fortunes by insisting the "storm will finish" at Old Trafford under his fellow Portuguese.

"He (Amorim) did a fantastic job in Portugal with my (former club) Sporting," said Ronaldo. "But the Premier League is a different beast, the most competitive league in the world.

I knew that it would be tough and they will continue the storm. But the storm will finish and the sun will rise.

#### Atalanta draw but keep Serie A lead



**ATALANTA** kept hold of top spot in Serie A yesterday after escaping Lazio with a 1-1 draw which kept Inter Milan at bay but ended their club-record league winning streak at 11 matches.

Marco Brescianini tapped home into an open goal with two minutes remaining to snatch a point from the Stadio Olimpico in Rome, where a passionate crowd thought a big win was coming their way.

Instead Atalanta will end a historic year a point ahead of Inter, who have a game in hand, after the champions briefly drew level on points with a 3-0 win earlier at Cagliari.

Europa League holders Atalanta will lead the league even if Napoli beat Venezia overnight and draw level on 41 points with Gian Piero Gasperini's side who have a significantly better goal difference than the 2023 champions.

Should two teams finish level at the top of Serie A come the end of the season they will face off in a single match to decide the destination of the Scudetto, which Atalanta have never won

"We struggled for long periods in the first half, but we were much better in the second," said Atalanta coach Gasperini.

"This year has been the best year in Atalanta's history, let's hope we can make 2025 the same."

Lautaro Martinez ended an eight-match scoring drought at Cagliari, netting the second in an engaging contest in Sardinia which Inter won with second half goals from the Argentina striker, Alessandro Bastoni and Hakan Calhanoglu.

Inter have won their last five in Italy's top flight, scoring 19 and conceding just once, a burst in form which has re-established Inter as favourites to retain the Scudetto.

"The most important thing is that Inter win. If I get a goal too, then that's a bonus," said Martinez.

"We work hard every day to win trophies and anyone who sets foot on the pitch will give their all for the team. We've just got to keep going and make 2025 like this year." – AFP

Newcastle and he plays his part."





#### **OCM** wants centralised venues for 2027 SEA Games

THE Olympic Council of Malaysia (OCM) wants competition venues to be centralised around Kuching when Sarawak co-hosts the 2027 SEA

OCM secretary-general Datuk Mohd Nazifuddin Najib (pic) said they do not want scattered venues like the recent Malaysia Games (Sukma) held across nine divisions in Sarawak in August.

'Sarawak has requested to host the SEA Games opening ceremony and some sports like diving. However, we want events to be centralised in the same location because it would be challenging for other countries if the venues are too spread out," he told reporters.

"We will prioritise what Kuching can host. Some sports, like sailing and track cycling, have limited venue options, so we will discuss further once the Malaysia SEA Games Organising

Committee (Masoc) is established." he added.

Masoc is expected to be formed by mid-2025 to ensure Malaysia is ready to take over leadership of the Southeast Asian Games Federation (SEAGF) after the SEA Games in Thailand from Dec.

9-20 next year.

Mohd Nazifuddin said OCM has also asked national sports associations (NSAs) to submit proposals regarding plans for the SEA Games in Thailand and Malaysia to determine the list of sports and

additional events for the biennial games.
"Only then can we decide whether to host those sports or not. Additionally, if the opening ceremony is held in Sarawak, we want the closing ceremony to be in Kuala Lumpur," he

Apart from Sarawak, Penand has also expressed interest in hosting snooker and billiards, while Johor is keen to host football.

According to the SEAGF Charter and Rules, organisers can include additional sports besides the mandatory ones like aquatics and athletics, provided at least four countries participate.

The final list of sports and events must be communicated to participating nations at least 15 months before the SEA Games begin.

The dates for the 2027 SEA Games have not

has confirmed that he will not defend the post.

Previously, the media reported that among the prominent names expected to vie for the coveted position are FAM vice-president Datuk Mohd Joehari Mohd Ayub and former FAM deputy president Datuk Seri Afandi Hamzah.

will not protect him from the sack.

The Portuguese said: "The manager of Manchester United cannot, no matter what, be comfortable and I know the business I am in

know the business I am in.

"I know that if we don't win, regardless of if they pay the buyout or not, every manager is in danger and I like that.

"I like that because that is our job so I understand the question. You can say I am here a month, we have four trainings (sessions), but I am not winning. The reality is that and I am comfortable with that."

United host Newcastle tomorrow (4am Malaysian time) with Amorim admitting that the Old Trafford crowd could be worried because of their form. He said: "We have to fight against

He said: "We have to fight against everything because our supporters are always there but they are tired of this moment. Any play from Newcastle near our box is going to make the stadium nervous."

Amorim has to find a new captain with Bruno Fernandes suspended after his red card at Molineux, and while he did not confirm who will wear the armband, he paid tribute to former skipper Harry Maguire.

"He works really well," Amorim said.
"He is focused on the job and he has no excuses, even if he has some tough moments, so in that department he is an example."

an example."
Despite these difficulties, Red Devils chiefs are expected to be patient with the young tactician as he remains committed to implementing his 3-4-2-

1 formation.

This isn't the first time Amorim has faced such adversity, either. In 2018, he took charge of then-third-tier Portuguese side Casa Pia and threatened to resign after a poor start.

However, a switch to his now-favoured back-three formation turned his fortunes around.

European football expert Guillem Balague told *BBC Sport:* "His coaching career actually began with Casa Pia, then a third-tier club, where it almost

ended as soon as it had begun.

"He lost his first two games and, with his pride hurt and doubts setting in, he announced if he lost the third game he would quit.

"In the next match he changed the system and played a back three for the first time.

"The system worked and from then on he remained unbeaten at the club. He also felt he had found the formation that allowed him to produce the football he wanted – one invariably linked to the spectacle for the fans. From there, he never looked back as he went to Bragg and then Sporting."

went to Braga and then Sporting."

His innovative approach led Sporting to their first league title in nearly two decades in 2021, followed by another title win last season.

It is, therefore, unlikely that he will deviate from his footballing

philosophy, no matter how difficult things get at United.

After United's latest defeat, Amorim hit back at a reporter who compared his record to new Wolves boss Vito Pereira's, who has enjoyed instant success since taking over from Gary O'Neil this month with two victories.

The journalist probed Amorim by saying: "I know you said you don't know how long it will take but Wolves have just had a new manager in for a week with a new system – with your players what do you think is missing?"

players, what do you think is missing?"
Amorim sharply responded: "New system? Wolves are playing a new system? They play the same system.

"Vitor Pereira worked the same system in Saudi Arabia. It was the same system, the same position. This squad was built for that system." – The Independent
