Kedah targets six million tourists in 2025

BUKIT KAYU HITAM: More than 150 tourism events have been planned throughout the year to boost tourist arrivals in Kedah as part of the 2025 Visit Kedah Year.

M'sia-Uzbek MoU beneficial for both countries: Envoy

KUALA LUMPUR: Malaysia and Uzbekistan are following up on an MoU resulting from Prime Minister Datuk Seri Anwar Ibrahim's visit to the country in May, said Malaysian ambassador to Uzbekistan, Kyrgyzstan and Tajikistan Ilham Tuah Illias.

He said among the matters listed

He said among the matters listed in the MoU were the Islamic financial system, *halal* ecosystem, industry and trade.

industry and trade.
"Through the MoU, it is hoped that more Malaysian goods and services can be brought into Uzbekistan.

"In terms of expertise, Uzbekistan is interested in learning from Malaysia the skills to produce various patterns of gold products for personal adornment."

Ilham Tuah said Anwar's threeday official visit to Uzbekistan has opened up many areas for cooperation, especially economy, education, tourism and culture.

He said the premier's visit was followed by an official visit by Uzbekistan's Foreign Minister Bakhtiyor Saidov to Malaysia in July.

Bakhtiyor Saidov to Malaysia in July.

He added that the industrial sector in Uzbekistan, which is growing rapidly after 31 years of independence from the Soviet Socialist Republic, could use Malaysian palm oil to produce various products such as food and cosmetics.

On bilateral relations between Malaysia and Uzbekistan, Ilham Tuah said they were at their best and this could be seen when the Malaysian delegation was invited as an international observer for the Uzbekistan elections on Oct 27.

He said Malaysia, as the chairman of Asean in 2025, would also catalyse cooperation between Central Asia and Southeast Asia.

Uzbekistan was Malaysia's second largest trading partner among Central Asian countries in 2023, with total Malaysia-Uzbekistan trade reaching RM451.1 million.

On people-to-people relations, Ilham Tuah said there were currently 200 Uzbek students in Malaysia while 2,000 Uzbeks visited Malaysia in 2023.

A source from the Uzbekistan embassy in Malaysia said the number of Uzbeks visiting Malaysia increased to 13,000 from January to October 2024. Most of them visited the islands in Malaysia, especially Langkawi, since Uzbekistan has no coastline.

He added that Malaysians' interest in visiting Uzbekistan is also increasing, especially in destinations related to Islamic history such as the tombs of Imam Bukhari in Samarkand and Imam Tarmizi near the Uzbekistan-Afghanistan border. – Bernama

Ministry to make cultural tourism national priority

SIBU: The Tourism, Arts and Culture Ministry is preparing to introduce various cultural tourism programmes and activities in 2025, in line with the government's focus on making cultural tourism a national priority. Its minister Datuk Seri Tiong

Its minister Datuk Seri Tiong King Sing said the cultural tourism industry has significant potential to stimulate economic growth and improve livelihoods by attracting more domestic and international visitors.

"Tourism Malaysia and its agencies have been entrusted with spearheading these programmes and activities," he said at the Motac Bersama Komuniti @ Sibu event held at the Azman Hashim Community Sports Complex in Sibu Jaya on

Tuesday.

He said domestic tourism recorded 193.3 million visitors in the first nine months of 2024, a 21.8% increase from 158.7 million in 2022

During the same period, domestic tourism spending rose to RM77.8 billion, a 27.2% increase from RM61.2 billion in 2023.

"International tourist arrivals from January to November 2024 reached 32.2 million, a 31.8% increase from 25.9 million in 2023."

increase from 25.9 million in 2023."
Tiong said the ministry would launch a nationwide "Midnight Sales" initiative in collaboration with shopping malls.

"Special food promotions will also be introduced to showcase Malaysia's local delicacies at malls and other outlets."

As the ministry prepares to launch the Visit Malaysia Year 2026 campaign, Tiong called on all stakeholders to collaborate to ensure its success. – Bernama

Bus and lorry companies facing shortage of drivers

Issue causing operational challenges and disciplinary problems among existing workers

PETALING JAYA: Bus and lorry services companies are grappling with a critical shortage of drivers, threatening their viability and sustainability, said Pan Malaysia Bus Operators Association president Datuk Mohamad Ashfar Ali.

He said the affected sector, which includes cargo lorries, express buses and transport vehicles for factory workers, students and tourists, is facing a shortage of about 5,000 drivers.

"For buses, many companies are struggling to provide a second driver for long-distance journeys."

On Dec 26 last year, the Road Transport Department (RTD) issued summonses to operators of 25 express and tour buses for failing to comply with the rule requiring a second driver. The summonses were issued during a special operation conducted at three

toll plazas in Penang. On April 5, Penang RTD director Zulkifly Ismail emphasised the importance of the second driver requirement for express buses covering distances of over 300km or journeys exceeding four hours.

"This rule ensures drivers have adequate rest and reduces the risk of crashes. Companies that fail to adhere to this regulation will face action."

Mohamad Ashfar said the driver shortage has been a persistent problem and worsened

due to several challenges.
"Most bus and lorry drivers in Malaysia are nearing retirement age or have left the service. Many are leaving for other sectors or migrating to Singapore, where better salaries are offered," he said, adding that high entry costs for aspiring drivers were also a barrier.

"Obtaining an e-licence, Public Service Vehicle Licence or Goods Driving Licence for operating heavy vehicles costs between RM4,000 and RM5,000. Potential drivers are deterred by these costs, making it harder to attract new talent to the profession."

He said the shortage has created operational challenges and disciplinary issues among existing drivers, who are aware of the difficulties employers face in replacing them. replacing them.

They often disregard employer directives and some even refuse to pay fines for offences, such as speeding, illegal parking and running red lights."

He urged the government and relevant authorities to provide financial assistance or introduce free training programmes for aspiring drivers, particularly those from the B40 group.

Transport Ministry programmes to sponsor a limited number of individuals to obtain their licences. However, the efforts were insufficient.
"The government should consider

offering free training for drivers to ease their financial burden, help produce more licensed professionals and create job opportunities."

He said such measures are crucial, given the critical role bus drivers play in ensuring passenger and road safety, as well as the contributions of lorry drivers to the economy. Peninsular Malaysia Malay Express Bus

Operators Association president Laili Ismail said: "Government support would resolve the driver shortage and allow for a selection of higher quality drivers who meet safety and

of ingler quality drivers wino fried safety and performance standards."

He urged the government to assist bus operators struggling with rising costs, including fuel prices, maintenance and operating expenses.

He said uncontrolled cost increases have created unhealthy competition among bus operators, with many forced to lower ticket prices to attract passengers.

"They do this often without considering the long-term sustainability of their business. So, if the government does not step in to assist, many express bus operators would have to close. This would lead to thousands of employees and drivers losing their livelihood, while depriving the public of the convenience and connectivity that bus services provide.

160 illegal crossings detected at Thai border

PASIR MAS: A total of 169 illegal crossings along the Malaysia-Thai border have been identified as requiring attention, said Chief Secretary to the Government Tan Sri Shamsul Azri Abu Bakar.

He said the government aims to reduce and eventually close such illegal crossings or entry points.

"Border control measures need to be enhanced. It is important to reduce cross-border crime and smuggling activities.
"I urge that the installation of CCTV at the

entry points be expedited and the use of artificial intelligence (AI) technology be implemented, as recommended by Prime Minister Datuk Seri Anwar Ibrahim."

He was speaking during the launch of the Malaysian Border Control and Protection

Agency pilot operation at the Immigration, Customs, Quarantine and Security (ICQS) Complex in Rantau Panjang yesterday.

He said the use of Al technology in border control strategy is critical.

"The use of Al technology, through the

appropriate and optimal mechanisms, would help our officers monitor, assess, plan and enforce responses to any threat or challenges

"For example, the coordination and analyses of data from CCTV and goods scanning machines at entry points equipped with Al technology would enhance the capability of officers in developing

risk analysis."

Shamsul Azri said the proactive approach could assist border agencies in intercepting potential threats before they

improving overall security at entry points.

He added that data driven by advanced Al algorithms, such as facial recognition and intelligent document processing, would streamline the process of inspecting individuals and goods.

"This scenario would indirectly ensure the

clearance process for low-risk goods could be expedited.

"This is crucial for improving the competitiveness of ports and cargo terminals."

Earlier, he inspected the operations of the border agencies at the Rantau Panjang ICQS Complex and the level of Sungai Golok at the Malaysia-Thai border.

MCMC receives four licensing applications

PUTRAJAYA: The Malaysian Communications and Multimedia Commission (MCMC) has announced that four major internet messaging and social media service providers have taken steps towards regulatory compliance by applying for licences to operate in Malaysia.

It said Tencent (WeChat) has been granted the Applications Service Provider Class licence making it the first service provider to be licensed under the country's new regulatory framework.

"Following WeChat, ByteDance (TikTok) has obtained its licence. Telegram is in the final stages of the licensing process and is expected to secure its licence soon.

"Meta, which oversees Facebook,

"Meta, which oversees Facebook, Instagram and WhatsApp, has initiated the process of obtaining licences to operate these platforms in the country, which is also expected to be completed soon," MCMC said in a statement yesterday.

X and Google, which operates YouTube, have

yet to submit an application.

The statement said according to X, its user

base in Malaysia has not reached the required threshold of eight million users.

MCMC is reviewing the user base as stated by X and will continue engagement sessions to assess its position.

On Google, it said issues were raised regarding YouTube's video-sharing features and its classification under the licensing framework.

It also said the commission will ensure YouTube and relevant platform providers that meet the licensing criteria are bound by their duties and responsibilities to adhere to the framework. – Bernama

MALACCA: The success of attracting 15 million visitors and generating RM12.68 billion in revenue during Visit Malacca 2024 must be sustained this year, said Chief Minister Datuk Seri Ab Rauf Yusoh.

He said maintaining the momentum is crucial, especially as Malacca has been chosen to host several international events.

"Various programmes will continue to be planned to promote Malacca as a preferred tourism destination, particularly leading up to World Tourism Day and the World Tourism Conference this year, followed by Visit Malaysia 2026.

"The momentum from 2024 must be sustained and enhanced to accommodate larger events this year and subsequently in 2026."

He said more than 200 tourism-related events were organised at national and international levels last year, covering cultural, artistic heritage, sports and religious sectors. - Bernama

Mhd Mohib Khouli Nazem teachings declared deviant

KUALA LUMPUR: The teachings of Mhd Mohib Khouli Nazem have been declared deviant and in direct conflict with Islamic faith, law and ethics, as well as the beliefs of Ahli Sunnah Wal Jamaah.
The National Council for Islamic Religious

Affairs Muzakarah Committee chairman Datuk Dr Nooh Gadut said the decision was based on evidence and research findings that examined the content of his lectures, teachings, speeches, and digital media dialogues.

and digital media dialogues.

He said the deviations include claims that Allah must have a child, attributing human-like characteristics and forms to Allah, rejecting Ahli Sunnah Wal Jamaah beliefs, and alleging that its prominent scholars, including Imam Abu al-Hasan al-Ash'ari, Imam al-Shahrastani and Imam al-Ghazali share doctrinal similarities with the deviant Jahmiyyah sect.

"All individuals must avoid these teachings, beliefs, and interpretations. It is strictly prohibited to follow, believe, teach, propagate, practise or act as a supporter or agent of such ideologies,"

"Those involved are urged to sincerely repent," he said in a statement posted on the Malaysian Islamic Development Department (Jakim) Facebook page.

Nooh added that the decision was reached during a committee meeting held from Sept 24 to 26 last year, specifically addressing the teachings of Mhd Mohib Khouli Nazem.

He also emphasised that Muslims must adhere to the Ahli Sunnah Wal Jamaah principles in creed, based on the methodologies of Asy'ari and Maturidi in *syariah*, guided by the *Shafi'i* school of thought, as well as other recognised schools such as *Hanafi, Maliki* and *Hanbali*.

"In terms of Sufism or ethics, they should

follow the methodologies of Imam al-Junaid, Imam al-Ghazali, and other authentic and

recognised Sufi practices."

He also urged state Islamic authorities and related agencies to take measures to prohibit the teachings of Mhd Mohib Khouli Nazem as these teachings threaten the faith of Muslims and

disrupt societal unity and harmony.

He said Jakim, as the coordinating body, has submitted a legal opinion on the matter to the Sultan of Perak Sultan Nazrin Shah in his capacity as the National Council for Islamic Religious Affairs chairman.

The matter was subsequently presented at the 267th Conference of Rulers on Oct 23 and 24

last year.
"The Conference of Rulers has acknowledged the legal opinion, and state authorities may consider this decision to gazette *fatwa* in their respective states," Nooh said. – Bernama

Taxation activity search service launched

PUTRAJAYA: The Inland Revenue Board (IRB) has launched a Tax Identification Number (TIN) search service for taxation activities provided under the Income Tax Act 1967.

The move is is in line with an announcement

The move is in line with an announcement by the government through Budget 2025.

The TIN search platform can be accessed through the MyTax Portal at https://mytax.hasil.gov.my.

In a statement yesterday, the IRB said individual taxpayers can conduct the TIN search by entering their identity card or passport number, while taxpayers in other categories can search by entering their business registration

number or their names.

To facilitate the implementation of e-Invoices, the TIN search function is also provided through the Mylnvois portal and Mylnvois Application Programming Interface.



Defend and support Palestinian rights, Muslims urged

KUALA LUMPUR: Muslims are obligated to defend and uphold the rights of the Palestinian people and nation against all forms of oppression, aggression and occupation by the Israeli Zionist regime, said the Muzakarah Committee of the National Council for Islamic Religious Affairs Malaysia.

The decision was reached during its meeting held from Sept 24 to 26 last year to discuss the duty of defending Palestine against Israeli

Muzakarah Committee chairman Datuk Dr Nooh Gadut said Muslims must also support the recognition of an independent and sovereign Palestinian state, in line with United Nations Security Council resolutions and human rights

He emphasised the need for Muslims to unite in defending and liberating Masjid al-Aqsa.

"Boycotting is sanctioned in Islam, especially to defend and uphold the objectives of *maqasid* syariah. Such actions align with the demands of jihad, particularly in the context of wealth," he said in a statement posted on the Malaysian Islamic Development Department Facebook

Nooh said boycotting companies or entities with interests linked to the Zionist regime should adhere to specific guidelines, including the goal of pressuring these companies to change their policies, visions, missions and strategies regarding Palestine, and halting Israel's oppression.

He added that the boycott should target companies involved in colonial activities and aiding the Zionist regime, such as providing financial support or supplying computer equipment, machinery or tools used to destroy Palestinian property and lives. – Bernama

'Know own blood type to avoid potential life threat'

Many remain unaware, which could lead to significant challenges during medical emergencies: Haematologist

PETALING IAVA: A lack of awareness about one's blood type is emerging as a critical issue in the country, with a haematologist warning of potential risks during emergencies and life-saving procedures.

Universiti Putra Malaysia Sultan Abdul Aziz Shah Hospital Internal Medicine and

Haemotologist senior consultant Assoc Prof Dr Bahariah Khalid said despite its importance, many Malaysians remain unaware of their blood type, which can lead to significant challenges during medical emergencies and patient blood management.

She said understanding blood type is vital, as it plays a critical role in patient blood management guidelines, particularly in cases of blood loss, regardless of the cause.

"The lack of awareness among Malaysians about their blood type is primarily attributed to existing medical practices, in which blood typing is not a routine procedure in clinics or hospital wards unless there is a specific need for a blood transfusion."

Bahariah said blood transfusions are required to be as compatible as possible with the patient's blood type or group in order to prevent the side effects of transfusion-related grouping are largely for blood donation campaigns, during which donors are classified for auditing purposes and proper patient blood

ior autum purposes and proper patient blood management practices.

"Blood typing is also crucial to identify suitable donors because blood banks sometimes announce shortages of specific blood types through direct communication or the mass media.

"Individuals with matching blood types can step forward to donate, provided they meet the eligibility criteria," she said.

Health Ministry Medical Development Division director Datuk Dr Mohd Azman Yacob said on average, the National Blood Centre requires 15,000 to 17,000 bags of blood each month to meet the needs of over 80 government and private hospitals in the Klang Valley.

Additionally, to treat 1,000 patients nationwide, an average of 2,000 to 2,200 bags of blood are needed daily.

According to the Health Ministry portal, as of December 2024, 42.1% of Malaysians have blood type O, while blood type A accounts for 25.4%, blood type B accounts for 26.8% and AB makes up 5.7%

Bahariah said it is also important to note that alongside blood grouping, testing is also conducted to screen for harmful viruses, such as Hepatitis B and C, and retroviral infections, which include HIV and venereal diseases.

whose blood type is unknown, the most compatible donor red cells are used to ensure safety to prevent the potentially fatal consequences of receiving the wrong blood type," she said.

Bahariah stressed that the potential risks in emergencies when a person's blood type is unknown are severe and life-threatening, and that transfusing blood without knowing the recipient's type is never practised, as it can result in fatal outcomes.

"In emergencies, dealing with an unknown blood type is a nightmare. Besides, the antigenantibody can react, causing clumping of the blood in vessels and vital organs, and leading to multi-organ failure and death.

"In the long run, the patient's body can start producing antibodies that attack the antigens on the donor blood cells that were incompatible, causing reaction and rejection using red blood cell destruction."

Bahariah said to address the lack of

awareness, incorporating blood typing as part of routine health checks on individuals' 12th birthdays, and printing the information on their identification cards should be considered.

She urged hospitals, blood banks and the government to bridge the knowledge gap through expanded media campaigns, particularly on social media platforms, to reach particularly on social media platforms, to reach
the younger population.

PETALING JAYA: In today's digital age, the term "social media influencer" has been abused to the point that even those with just a few hundred followers are claiming to be

Universiti Kebangsaan Malaysia Anthropology and Sociology senior lecturer Dr Velan Kunjuraman said claiming to be an

influencer depends on several factors.

"It involves not just follower count but engagement rate, content quality, niche authority and platform activity, with genuine influencers being classified into four categories based on their follower numbers."

He said nano-influencers have between 1,000 and 10,000 followers, micro-influencers between 10,000 and macro-influencers have between 100,000 and one million, and mega-influencers have over

"Having such numbers is not enough either because the specific social media platform they are on plays a role in determining the requirements for genuine influencer status."

Citing Canadian-born American sociologist, social psychologist and writer Erving Goffman, who is considered by some as the most influential American sociologist of the 20th century, Velan expounded on the

the 20th century, Veian expounded on the definition of an influencer.

He said Goffman's dramaturgical perspective defines influencers as front-stage performers who craft their public personas to resonate with audiences.

"Many social media influencers equate

success with wealth, misleading younger audiences to devalue education and moral principles. This contributes to a form of false consciousness, and diverts individuals from

deeper societal values and aspirations."

He said the aspirational lifestyles portrayed by some influencers drive their popularity, particularly with younger demographics, and cautioned that such



portrayals often misrepresent reality or universal ideals.

"While some influencers participate in meaningful charitable initiatives, their numbers are limited. Decision-making should be anchored by personal values and critical reasoning rather

external influences."

He warned that excessive reliance on influencers could diminish the public's ability to think independently and make informed choices.

Velan said despite their large following, some influencers face trust deficits due to unmet audience expectations or a lack of transparency.

"Food reviewers might lose credibility if their endorsements fail to reflect the actual quality of the dishes they highlighted," he said, adding that trust relies on maintaining integrity and authenticity.

He said many individuals seek approval

from influencers, often at the cost of personal growth and critical reflection, and cautioned that such dependency fosters brain rot, in which the relentless consumption of curated

content stifles independent thinking. He acknowledged that influencers could inspire innovation and support social causes but warned that over-reliance on them might strain interpersonal connections and erode individuality.

"Public opinions revealed concerns about the ethics and authenticity of influencers, sparking discussions about their roles and responsibilities in society."
Student Amirul Zain, 23, said many

influencers promote products they do not use or believe in, which makes them come across as dishonest.

"Sometimes, influencers do not make it clear that they are being paid to promote something, or exaggerate how good a product is. This kind of conduct is deceitful, damaging their credibility and harming the reputation of the brands they represent."

Marketing executive Sankari Vijayakumar, 24, said some influencers use manipulative strategies, such as staging photos or making exaggerated claims, to mislead their followers.

"This kind of behaviour not only sparks ethical concerns but also undermines the trust people have in them. For example, skincare products are promoted with highly edited or filtered 'before and after' pictures.

"The claimed results are dramatic but in truth, the images are digitally enhanced, staged under specific lighting or show effects achieved through unrelated treatments."

She said such misleading content erodes confidence when followers realise the reality does not match the claims.

Man held over alleged threats on singer

SIBU: Police have arrested a man who is believed to be responsible for sending threatening messages via a social media platform to popular singer Nor Ashima Ramli, also known as Baby Shima.

Sibu district police chief ACP Zulkipli Suhaili said the 35-year-old truck driver was arrested at 9.15pm on Tuesday in Kota Sentosa, Kuching.

He said the suspect's phone was confiscated to facilitate the investigation and police applied for an order to remand him yesterday. He also said police received a report on the

alleged death threat at 11.31pm on Monday from Baby Shima, who is in Sibu for work-related

Baby Shima, known for her hit song *Bujang Sarawak*, filed the report after encountering threatening comments on social media from an unknown individual.

"The case is being investigated under Section 507 of the Penal Code and Section 233 of the

Communications and Multimedia Act 1998," said Zulkipli in a media statement yesterday. He asked the public to be responsible when making comments or uploading statements on social media platforms so as to not go beyond the limits and break the law.

Baby Shima lodged the report at the Sibu police station accompanied by Tourism, Arts and Culture Minister Datuk Seri Tiong King Sing.

Illegally anchored ship detained

SHAH ALAM: The Malaysian Maritime Enforcement Agency (MMEA) detained a cargo ship for anchoring without permission about 26 nautical miles southwest of Sekinchan at 1.40pm on Tuesday. Its Selangor director Kapt Abdul Muhaimin

Muhammad Salleh said the ship was detained by an MMEA patrol boat conducting operations in Selangor waters after its presence was detected on its sea surveillance system.
"The ship is believed to have been travelling

from Singapore to India with 22 male crew members, including the captain. All are Chinese nationals aged between 28 and 63 years, and possess valid identification documents.

"Inspections found that the captain failed to submit authorisation documents to moor (in Malaysian waters) and is suspected of having committed an offence under Section 491B(1)(I) of the Merchant Shipping Ordinance 1952." He advised shipping operators to apply for

permission from the Marine Department before anchoring in Malaysian waters. – Bernama

Two nabbed, drugs seized after car chase

Police instructed the suspects to stop the vehicle but the driver sped towards the Pasir Gudang Highway, he said in a statement yesterday.

The pursuit continued along the Iskandar Coastal Highway and the Second Link Expressway, with the suspects crashing through a toll gate at the Senai Utara Toll Plaza before entering the northbound

North-South Expressway.

Patrol cars from district headquarters in Kulai and Kluang were mobilised to assist, intercepting the vehicle in Simpang Renggam at about 1.30am.

A search of the vehicle uncovered several packages believed to contain drugs.

He said acting on information from the arrests, police conducted two additional raids in Johor Bahru, seizing various drugs.

"In this operation, police seized an assortment of drugs, including *ganja*, *syabu*, ecstasy powder, heroin and nitrazenam pills, with an estimated value of RM54.831.

Korea ramps up air crash probe SEOUL: The investigation into the crash of a

South Korea passenger jet gathered pace yesterday as bereaved families began to prepare funerals after authorities formally identified the 179 victims of the country's worst air disaster.

The Transport Ministry said investigators had extracted the data from the plane's cockpit voice recorder and would convert it into an audio file critical information to try to explain the few minutes that led up to the crash.

The investigation team is still working to extract the contents of the flight data recorder, which was found missing a key connector, the ministry said.

All 175 passengers and four of the six crew

members were killed on Sunday when the Jeju Air jet belly-landed at Muan International Airport and slammed into an embankment at the end of the runway, where it burst into flames.

Two crew members, located near the tail of the Boeing 737-800, survived the disaster.

The government has declared a national mourning period until Saturday and the country scaled back New Year's celebrations.

The ministry said two more US officials arrived

late on Tuesday to join a team of around two dozen investigators including from the US National Transportation Safety Board, Federal Aviation Administration and Boeing.

"They're also planning to start a visual investigation into the wreckage," said Deputy Civil Aviation Minister Joo Jong-wan.

Officials have said investigators were expected to examine whether a bird strike, landing gear failure or problems with control systems played a role in the disaster. – Reuters

Myanmar population at 51.3 million

YANGON: Myanmar said its 2024 census found a population of 51.3 million, slightly lower than 10 years ago, as the government prepares for promised elections amid unrest.

The census, which was held in October, will be used to compile voter lists for the elections

planned for this year.

"I am striving to successfully organise a free and fair election, which is the ultimate goal of the State Administration Council," said council

chairman Min Aung Hlaing.

Myanmar has been in turmoil since early 2021, when the military overthrew an elected civilian government and suppressed prodemocracy protests, sparking a rebellion.

Last month, Myanmar's foreign minister

Last month, Myanmar's foreign minister briefed neighbouring countries on the progress towards holding an election.

The population of 51.3 million for last year was down from a 51.5 million figure in the previous census in 2014, the reports said. The country's Rohingya minority was not included in either census.

The population figure was made up of 32.2

million people counted in the census and an estimate of 19.1 million people in areas that were inaccessible due to security and transport issues, the reports said. – Reuters

People from Cambodia, Laos, Myanmar to Vietnam kept to the tradition of welcoming the

Although their traditional New Year celebrations fall in April, many did not miss the parties wishing for a promising 2025.

There were grounds for jubilation in these countries as economies thrived and farmers enjoyed hourtful harpets and pational unity.

enjoyed bountiful harvests and national unity

Vietnam set a powerful tone as it entered the new year with all the hallmarks of a rising

economic powerhouse in Asean, thanks to its 1986 *Doi Moi* modernisation policy that catapulted the state-controlled centralised economy to an industrialised nation.

"The top priority in this new era is to successfully achieve the strategic goals, turning Vietnam into a developing nation with a modern industrial base," said Communist Party General Secretary To Lam. In Cambodia, people filled the streets on New

Year's Eve to "Celebrate Cambodia", to showcase the kingdom's unity, peace and stability.

Three days ago, Cambodians honoured the 26th anniversary of the "Win-Win Policy" initiated by former prime minister Hun Sen that ended the civil war in the 1990s and brought peace and national unification.

Laos' capital, Vientiane, hosted its welcoming party. The nation continues to bask in pride after successfully hosting the 44th Asean Summit last

Myanmar did not miss out on the celebrations either. People gathered for the New Year countdown at Yangon's Secretariat landmark

heritage site.

"Let us all work together so that 2025 becomes a year of victory for the people, reaching the democratic goal all citizens aspire to and make this a testament to our collective efforts," said State Administration Council chairman Min Aung Hlaing in his New Year

Feng shui grandmaster Han (known by only one name), who has been applying the art for over 20 years, said 2025 is under the influence of the Fire Element and it could be considered a "hot

"2025 will be a continuation of 2024. Fire also brings light and there can be a big shift in people's vision and consciousness.

Investigators vow to execute Yoon arrest warrant

SEOUL: South Korean investigators said yesterday they would execute an arrest warrant for Yoon Suk Yeol over his declaration of martial law by the deadline of Jan 6, as the impeached leader's supporters rallied outside his residence

Supporters and opponents of Yoon, who was suspended from office by lawmakers over his attempt to subvert civilian rule last month, have been camped outside the compound where he has been holed up for weeks, fending off investigators' efforts to question him.

The Corruption Investigation Office (CIO) requested the warrant after Yoon failed to report for questioning a third time, but it has been unclear whether they could execute it as the Presidential Security Service have previously refused to comply with search warrants.

CIO chief Oh Dong-woon said

CIO chief Oh Dong-woon said yesterday the warrant would be executed "within the deadline", which is on Monday. "We aim for a smooth process

"We aim for a smooth process without major disturbances, but we are also coordinating to mobilise police and personnel in preparation," he told reporters.

He also warned that anyone trying to block authorities from arresting Yoon could themselves face prosecution.

"We consider actions such as setting up barricades and locking iron gates to resist the execution of our arrest warrant as obstruction of official duties," he said.

Anyone doing this "could be prosecuted under charges of abuse of authority interfering with the exercise of rights and obstruction of official duties by special means", he said.

Yoon's legal team described the arrest order as "illegal and invalid" and applied for an injunction to nullify it, with Yoon's supporters rushing to defend him.

Outside the presidential compound

Outside the presidential compound in central Seoul yesterday, dozens of Yoon supporters hurled vitriol at police.

At one point, some attempted to break through a cordon and block a police bus from parking near the entrance, apparently mistaking it for the mobile force that may be dispatched to detain Yoon.

Police were sent to the area in large numbers and could be seen yelling at protesters to keep in line, but a route in and out of Yoon's residence remained

Taiwan president wants exchanges with China

▶ Lai laments lack of goodwill from Beijing

TAIPEI: Taiwan President Lai Ching-te said yesterday that he welcomed equal, dignified, healthy and orderly exchanges with China, but wondered whether there was goodwill from Beijing given what he said was their blocking of simple things like tourism.

Lai, who took office in May, has regularly offered talks with China but been rebuffed. China views democratically governed Taiwan as its own territory and detests Lai as a "separatist". He says only Taiwan's people can decide their future.

Speaking at a New Year's day news conference, Lai said China was blocking normal interactions with restrictions on Chinese tourists visiting or students studying on the island, while similar bans do not apply to Taiwanese going to China.
"But I still want to stress this:

"But I still want to stress this: Tawan hopes to have healthy and orderly exchanges with China under the principles of reciprocity and dignity,' he said. Journalists should ask China

Journalists should ask China why its citizens can freely travel to countries like the United States and Japan, but has all these controls when it comes to Taiwan, Lai said.

when it comes to Taiwan, Lai said.

"Is this really showing goodwill towards Taiwan? Can't they treat everyone equally?"

Taiwan and China have repeatedly traded accusations about tourism and travel restrictions.

In June, Taiwan told its citizens

In June, Taiwan told its citizens not to go to China unless absolutely necessary, following a threat from Beijing to execute those deemed Taiwan independence supporters. Chinese President Xi Jinping said in his New Year's speech that no one can stop China's "reunification" with Taiwan.

Lai said that the greater the threat from authoritarian countries the more democracies should unite, and pointed to China and Russia's militaries operating together in the Indo-Pacific.

The cooperation between democracies needed to be on defence and security and strengthening the "democratic supply chain", he said.

"If that is not done properly, it

will impact economies and industries for all countries, and the lives of people in democracies," Lai said.

"I really hope that in the New Year, democratic countries can be even more united, and achieve the aims of peace, democracy and prosperity." Beijing claims the self-ruled island as part of its territory, and has said it will not renounce the use of force to bring it under its control.

force to bring it under its control.

China has intensified pressure on the democratic island in recent years, and has staged three rounds of major military drills since Lai came to power in May.

"Chinese people on both sides of

"Chinese people on both sides of the Taiwan Strait are one family. No one can sever our blood ties, and no one can stop the historical trend of the reunification of the motherland," Xi said.

Xi's comments come just weeks before Donald Trump takes office in the United States.

the United States.

Taiwan is a key point of contention between Beijing and Washington, which does not officially recognise Taiwan diplomatically but is its strategic ally and largest supplier of weapons.

Tintin, Hemingway among copyrights expiring this year

NEW YORK: From A Farewell to Arms to the cartoon character Popeye the Sailor, thousands of artistic works entered the public domain in the United States yesterday.

US copyright law expires after 95

US copyright law expires after 95 years for books, films and other works of art, while sound recordings from 1924 will also be copyright-free.

1924 will also be copyright-free.

By entering the public domain, the pieces can be copied, shared, reproduced or adapted by anyone without paying the rights owner.

without paying the rights owner.
This year's crop includes internationally recognised figures such as the comic character Tintin,

who made his debut in a Belgian newspaper in 1929, and Popeye the Sailor, created by cartoonist Elzie Crisler Segar.

Every December, the Centre for the Study of the Public Domain publishes a list of the cultural works that lose their copyright in the new

The centre, part of the Duke University School of Law in the southeastern US state of North Carolina, makes the list available on its website for anyone to peruse.

"In past years we have celebrated an exciting cast of public domain characters: the original Mickey Mouse and Winnie-the-Pooh, and the final iterations of Sherlock Holmes from Arthur Conan Doyle's stories," centre director Jennifer Jenkins wrote on its website.

"In 2025 copyright expires over more aspects of Mickey from his 1929 incarnations, along with the initial versions of Popeye and Tintin."

Among the literary works entering the US public domain are the novels The Sound and the Fury by William Faulkner, A Farewell to Arms by Ernest Hemingway, A Room of One's Own by Virginia Woolf and the first English translation of All Quiet on the Western Front by the German author Erich Maria Remarque.

Maria Remarque.
Films that will be in the public domain include Blackmail, directed by Alfred Hitchcock, and The Black Watch, the first sound film by Oscarwinning director John Ford.

Musical compositions published in 1929, such as *Bolero* by French composer Maurice Ravel and *An American in Paris* by George Gershwin, will lose their copyrights, though only recordings from 1924 or earlier will be in the public domain.

5 DEAD IN GERMANY FIREWORKS MISHAPS

BERLIN: Five people died across Germany and a police officer was seriously injured from accidents linked to the powerful fireworks Germans traditionally set off to celebrate the New Year. Germans celebrate the New Year with a particularly intense usage of fireworks, which spurs a recurrent debate about outlawing the most powerful devices, given the high number of injuries each year, as well as the pollution and noise they cause. Some 13 law enforcement officers were injured as a result of the accidents this year, including one seriously, police spokesman Florian Nath said. Some 330 people were detained in Berlin, police said, adding that contrary to previous years, "there were no major violence or incidents". – AFP

37,000 MIGRANTS CROSS CHANNEL

LONDON: The number of irregular migrants crossing the Channel to Britain in small boats in 2024 soared by a quarter compared with the previous year. Some 36,816 people made the dangerous journey last year, a 25% jump from the 29,437 who arrived in 2023, provisional figures from the Interior Ministry showed. The total, however, was still well below the record 45,774 arrivals in 2022. Last year's steep rise highlights the challenge facing. Prime Minister Keir Starmer, who has pledged to crack down on the arrivals. He scrapped the previous government's scheme to send the irregular migrants to Rwanda. He has pledged to smash the gangs of traffickers running the crossings and has signed agreements with foreign countries to co-operate on law enforcement. – AFP

Israel destroying Gaza healthcare: UN report

Concerns over compliance with international law

ZURICH: Israeli attacks on hospitals in Gaza have devastated the Palestinian enclave's health system and raised serious concerns about Israel's compliance with international law, the UN Human Rights Office said in a

The 23-page report, documenting attacks between Oct 12, 2023, and June 30, 2024, concluded that since the attacks on Oct 7, 2023, the conduct of hostilities in Gaza had had severe consequences on Palestinians' access to medical attention.

The destruction of the healthcare system in Gaza, and the extent of killing of patients, staff and other civilians in these attacks, is a

direct consequence of the disregard for international humanitarian and human rights law," it said.

Daniel Meron, Israel's permanent representative to the UN in Geneva, described representative to the UNIN Techeva, described the report's data as fabricated. He said on X that Israel operates in accordance with international law, would never target innocent civilians, and accused Hamas of using Gaza hospitals for what he called "terror" activity".

The Israeli military has accused Hamas of

using hospitals as command centres for military operations and said that people Israel has detained at the facilities were suspected gunmen.

The UN report alluded to such arguments but said not enough information had been made public to substantiate them.

Israel has in the past few days conducted operations against hospitals in Gaza that drew criticism from the head of the World Health Organisation among others.

The report said deliberately directing attacks against hospitals and places where the sick and wounded are, provided they are not

It also warned that a systemic pattern of rights abuses against civilians could constitute crimes against humanity.

Israel has consistently rejected such

The UN said that responding to its report, the Israeli government said its military had taken extensive measures to mitigate civilian harm and minimise disruption, including providing aid and evacuation routes, and setting up field hospitals.

UN High Commissioner for Human Rights

Volker Türk said: "As if the relentless bombing and the dire humanitarian situation in Gaza were not enough, the one sanctuary where Palestinians should have felt safe in fact

Airstrikes kill at least 17 Palestinians

TEL AVIV: Israeli airstrikes on al-Bureij refugee camp and Jabalia town in central and northern Gaza killed at least 17 Palestinians yesterday, the Palestinian news agency WAFA reported.

The Israeli military had no immediate comment although in a post on X, its Arabic spokesperson warned residents of al-Bureij earlier to evacuate ahead of an imminent strike

against gunmen firing rockets from the area. It also said that it killed Abd al-Hadi Sabah, who it accused of helping to lead the infiltration into Kibbutz Nir Oz on Oct 7, 2023.

The instruction to clear the al-Bureii camp has caused a new wave of displacement, although it was not immediately clear how many people were affected.

Israel says its almost three-month-old campaign in northern Gaza is aimed at preventing Hamas gunmen from regrouping. Its instructions to civilians to evacuate are meant to keep them out of harm's way, the military says.

Palestinian and United Nations officials say no place is safe in Gaza and that evacuations worsen the humanitarian conditions of the

According to the Palestinian civil defence, more than 1,500 tents sheltering displaced people across Gaza were flooded by heavy rains over the past two days, leaving people exposed to the cold, their belongings

Hundreds more tents experienced less severe flooding that still left displaced people

Much of the area around the northern towns of Beit Hanoun, Jabalia and Beit Lahiya has been cleared of people and razed, fuelling speculation Israel intends to keep the area as a closed buffer zone after the fighting in Gaza

WAFA said the military blew up residential blocks in Beit Lahiya and in and around Jabalia, while tanks shelled parts of Gaza City and the al-Bureii camp.

Most of Gaza's 2.3 million people have been displaced and much of the tiny coastal strip is in ruins. – Reuters

Russian gas exports via Ukraine halted

MOSCOW: Russian natural gas exports via MOSCOW: Russian natural gas exports via Soviet-era pipelines running through Ukraine to Europe were halted early yesterday as a transit deal expired and warring Moscow and Kyiv have failed to reach an agreement to continue the

The shutdown of Russia's oldest gas route to Europe ends a decade of fraught relations sparked by Russia's seizure of Crimea in 2014. Urraine stopped buying Russian gas the following year.
"We stopped the transit of Russian gas. This is

a historic event. Russia is losing its markets, it will suffer financial losses. Europe has already made the decision to abandon Russian gas," said Energy Minister Galushchenko.

Galushchenko.

The stoppage of gas flows was expected amid the war, which started in February 2022.

Ukraine has been adamant it would not extend the deal amid the military conflict.

Russia still exports gas via the TurkStream pipeline on the bed of the Black Sea.

TurkStream has two lines – one for the Turkish domestic market and the other supplying central European customers including Hungary

The European Union redoubled its efforts to reduce its dependence on Russian energy after the outbreak of the military conflict in Ukraine in

2022 by seeking alternative sources.

The remaining buyers of Russian gas via Ukraine such as Slovakia and Austria have also arranged alternative supply.

Moldova, once part of the Soviet Union, is among the countries worst affected. It says it will be a source of the source of the

now need to introduce measures to reduce its gas use by a third.

Russia and the former Soviet Union spent half a century building up a major share of the European gas market, which at its peak stood at around 35%, but the war has all but destroyed that business for Gazprom.

The Yamal-Europe pipeline via Belarus has also shut and the Nord Stream route across the Baltic Sea to Germany was blown up in 2022.

GENEVA: The World Health Organisation said 55 patients and 72 caregivers were evacuated from the Gaza Strip to the United Arab Emirates on Tuesday for specialised medical treatment. "Patients included those suffering from autoimmune and blood diseases, cancer, cardiovascular diseases, eye and renal issues, trauma injuries, neurological disorder and skin diseases. More than 12,000 patients still need medical evacuation outside Gaza," the WHO said. – AFP

SOUTH AFRICA DEMANDS END TO HOSTILITIES

NEW YORK: South African President Cyril Ramaphosa called for the cessation of hostilities in Gaza and the release of hostages. He said his country has stood firm in support of the Palestinian people. "Just as we attained our freedom through the support and solidarity of many people and nations, we continue to stand in solidarity with the victims of injustice in other parts of the world," Ramaphosa said. – Bernama

HEAVY vehicle accidents have increasingly dominated media headlines, with incidents involving buses and trailers crashing into barriers or colliding with oncoming vehicles becoming alarmingly common on highways.

These accidents are more likely to result in

fatalities compared to those occurring on federal, state, or municipal roads.

One of the key factors contributing to this trend is the higher speeds at which trailers, buses, and lorries travel on highways.

The danger is compounded when these vehicles carry heavy loads, generating significant momentum that worsens the impact of collisions.

Alarmingly, many trailers and lorries are

overloaded, exceeding the recommended weight limits.

Despite speed limit signs displayed on the back of these vehicles, such restrictions are often ignored, creating a dangerous combination of weight and speed that

frequently results in tragedy.

Although some have called for stricter maintenance protocols for heavy vehicles, this alone does not address the severity of the issue.

A lorry or trailer may be serviced, inspected. and certified roadworthy, yet it can still pose a significant risk if overloaded and driven

The root cause lies in the behaviour of drivers who are inconsiderate, impulsive, and dismissive of traffic regulations.

Incidents of speeding heavy vehicles on highways are far too common. It is not unusual to witness such vehicles

overtaking others on the fast lane, tailgating smaller cars, honking, or flashing lights to force their way through.

Many are seen exceeding the speed limit of

110km/h or driving in lanes that are explicitly out of bounds for heavy vehicles.

Stricter enforcement measures are urgently needed to tackle this issue.

Heavy vehicles that exceed speed limits should be promptly fined and the installation of additional speed cameras on highways could help deter such behaviour.

Reintroducing flashlights on heavy vehicles, which activate when the vehicle exceeds its speed limit, would also serve as an effective deterrent.

Furthermore, speedometers in these vehicles could be adjusted to physically prevent them from surpassing their prescribed

It is imperative to act swiftly to prevent further loss of innocent lives on our highways. Without decisive action, these "monsters"

will continue to pose a grave threat to road

Article 19 of the UDHR states: "Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive, and impart information and ideas through any media and regardless of frontiers."

In addition to international conventions, freedom of speech and expression is also protected under the Federal Constitution.

of Article 10(1)(a) of the Constitution affirms: "Every citizen has the right to freedom of speech and expression."

These protections demonstrate that freedom of speech and expression is safeguarded by both international conventions national laws.

No one should be denied these fundamental rights. Every individual is unique in their

thoughts, ideas, opinions, and perspectives.

These differences should be

celebrated as they contribute to societal and national progress.

Instead of perceiving freedom of speech as a threat, we should recognise its positive impact.
Freedom of speech empowers

individuals to protect their rights and interests, as well as those of

It acts as a shield against mistreatment and oppression. Suppressing this fundamental right makes it difficult for individuals to stand up for themselves or others, potentially stifling the development of innovative ideas crucial for societal and national advancement.

While freedom of speech and expression is a basic human right, it

is not absolute.

Article 19 of the UDHR acknowledges that the exercise of such freedoms carries "special duties and responsibilities" and may be subject to restrictions "for respect of the rights or reputation of others" or "for the protection of national security, public order, public health or morals'

Similarly, imposes Constitution certain

10(2)(a) states: Article "Parliament may by law impose on

the rights conferred by paragraph (a) of Clause (1), such restrictions as it deems necessary or expedient in the interest of the security of the Federation or any part thereof, friendly relations with other countries, public order or morality, and restrictions designed to protect the privileges of Parliament or any Legislative Assembly or to provide against contempt of court, defamation, or incitement to any offence."

While such limitations exist, they should not be used as a pretext to discourage individuals from speaking or expressing their views.

Authorities should refrain from enacting excessive laws or excessively enforcing existing ones to suppress freedom of speech.

Differences in views should be resolved through discussions and debates, not through legal actions, arrests, prosecutions, fines or imprisonment.

Freedom of speech and expression is an invaluable right must be upheld encouraged.

Embracing diverse opinions and ideas fosters growth and innovation while protecting individuals from oppression.

While it is essential to recognise

the limitations of this right, such restrictions should be applied judiciously and not as a tool to silence dissent.

By nurturing an environment where individuals feel free to express themselves, society and the nation can truly thrive.

Even many top international athletes have been severely affected, sometimes to the extent of withdrawing from competition to seek therapeutic help.

In recent years, the involvement of medical professionals in sports organisations has provided critical therapy for athletes' mental health needs.

This support is increasingly recognised and valued.

Athletes across various sports frequently experience symptoms such as paralysing anxiety attacks and excessive fears.

Additionally, they often suffer from deeper depression than the general population

Athletes face a unique culture of stressors and disorders, which can be exacerbated by the injuries they endure.

A 2019 study found that approximately 35% of elite athletes

experience mental health concerns. Key issues reported by athletes include feelings of burnout from constant competition, debilitating depression, and anxiety.

Malaysia's elite athletes operate intense pressure, facing unrealistic expectations from coaches, sports associations, teammates and even themselves

The relentless pursuit of perfection often takes a considerable toll on their mental and physical well-being.

Athletes require both physical and mental resilience to withstand the scrutiny of aggressive sports reporters and online "keyboard warriors". Many coaches and mental trainers

Modernising old buildings key to safety, sustainability

WITH urbanisation accelerating globally, the need to modernise ageing buildings has become increasingly critical.

According to the World Bank's projection, around 56% of the global population – approximately 4.4 billion people currently reside in cities. Notably, about 80% of the buildings that will exist in 2050 are already in place today

will exist in 2050 are already in place today. This underscores the importance for building owners to establish long-term strategies that prioritise retrofitting and modernising existing buildings. This is key to enhancing occupant comfort and safety while reducing the building's environmental footprint. Exchange Listing explores opportunities in Malaysia

> Firm keen to facilitate dual listings on US capital market

KUALA LUMPUR: Exchange Listing LLC, an advisory firm based in Florida in the United States, is eyeing opportunities to facilitate dual listings on the US capital market for Malaysian companies.

CEO and founder Peter Goldstein (*pic*) said the firm is in discussions with

potential partners and investors to establish cooperation for dual

"One of the things that we're exploring is how to work with listed companies here for cross-listing or dual listing, so we don't take them away from the local market. This is a very underserved area, we're very interested in pursuing this," Goldstein told SunBiz in an exclusive interview while he was

in Kuala Lumpur for a visit recently.

He said dual listing offers companies greater visibility and access to a global investor base while still supporting their local markets. "As an example, the SGX (Singapore Exchange) has a relationship with Nasdaq because there's less liquidity on the SGX, so they want the extra outside liquidity. Everyone wins in such collaborations."

Goldstein said the US capital market provides transformational growth funding opportunities for companies at pivotal stages in their development.

"Rapidly growing companies often require additional capital to sustain and accelerate their growth. At these inflection points, where businesses have already proven their models and established a strong foundation, external resources become crucial to strengthening and extending their growth trajectory," he

He added, "Just as humans evolve, companies need the right support at the right

stage."

Goldstein stressed that capital is only one part of the equation. "Beyond capital, midance expertise, and they seek guidance, expertise, and knowledge to navigate the next phase of their journey. This includes bringing in experienced advisors, directors, and other professionals to add value beyond funding."

Goldstein said they are looking for companies with proven business models needing capital to sustain

Technology-related sectors hold great potential. Fintech is particularly interesting, and Malaysia has strong capabilities in areas like AI and data centres, which align with the global growth trends," he said.

However, he added that industries with strong fundamentals – revenue growth, profitability and robust business metrics – are eligible for listing too.

Preparing companies for listing is a year-long process, focusing on financial metrics, governance and compliance. "But listing in the US boosts recognition, credibility, and governance standards, which are assets globally," Goldstein said.

He shared that more than 60% of new

listings in the US in 2024 were foreign companies, with the majority from Southeast Asia. He expects the trend to grow, particularly in Malaysia and the Asia-Pacific

Goldstein said, "Transparency and education are key to ensuring companies are well-prepared for the process."

He highlighted benefits for foreign private issuers in the US, such as less frequent financial reporting compared to domestic companies. This regulatory flexibility attracts foreign companies to US markets.

Micro-cap companies, with market capitalisations of US\$50 million to US\$300 million (RM223.7 million to RM1.3 billion), and small-cap companies, ranging from US\$300

million to US\$1 billion, can qualify for listing. Key requirements include shareholder equity of at least US\$5 million and a public pat value exceeding US\$15 million.

More than 20 Malaysian companies have

listed as American Depositary Receipts on Nasdaq and the over-the-counter (OTC) Nasuaq and the over-the-counter (OTC) exchange. Among them are Boustead Holdings Bhd (OTCPink), Genting Bhd (OTCPink), Energem Corp (Nasdaq), Top Glove Corporation Bhd (OTCPink), Tenaga Nasional Bhd (OTCPink) and Malayan Banking Bhd (OTCPink).

Data loss emerges as top cloud threat to Malaysian SMEs: ECloudvalley

KUALA LUMPUR: Malaysian small and medium enterprises continue to grapple with rising cybersecurity concerns as data loss emerges as the most critical cloud threat.

ECloudvalley country manager Sandy Woo (pic) said SMEs, which account for nearly 97% of businesses in Malaysia, remain highly vulnerable to this risk due to insufficient investments in

cybersecurity infrastructure and expertise.

"According to recent insights, misconfigurations in cloud systems, ransomware attacks and account hijacking closely follow data loss as the top

threats to SMEs. As businesses increasingly adopt cloud solutions to boost operational efficiency, these risks underscore the urgent need for enhanced cybersecurity strategies," she told *SunBiz*. She said data loss can

cripple businesses, leading to financial losses, reputational

damage, and customer distrust, "For SMEs, which often operate with tighter margins and limited resources, recovering from such incidents can be particularly challenging," she added.

Many SMEs still underestimate the complexity

of securing cloud environments, leaving them exposed to sophisticated cyberattacks, Woo said.

exposed to sophisticated cyperatacks, woo said.

This is where cloud consulting companies such as eCloudvalley come in. Woo said misconfigurations in cloud systems are another critical issue.

"Incorrectly set permissions or unsecured databases can provide cybercriminals with easy access to sensitive information. This highlights the importance of proper training and ongoing audits to minimise human errors, which remain a common entry point for breaches."

Ransomware attacks, while not new, continue to evolve and target SMEs disproportionately, Woo said. "Cybercriminals view smaller businesses as low-hanging fruit due to their typically weaker defences. A ransomware incident can paralyse operations, forcing businesses to either pay hefty ransoms or lose critical data altogether

Account hijacking, driven by poor password hygiene and the absence of multifactor authentication, is also on the rise, Woo said. "This threat allows attackers to infiltrate systems and potentially compromise an entire network. SMEs are encouraged to adopt zero-trust policies, which limit access to critical resources based on verification, to mitigate such risks."

Despite the challenges, she said, there are viable solutions for SMEs to strengthen their cybersecurity posture. "Investing in affordable, scalable security tools tailored to cloud environments is important. Regular system updates, vulnerability assessments and employee defence against emerging threats."

Woo noted that collaboration with cybersecurity service providers can also help

SMEs bridge resource gaps.

Prioritising cloud security is no longer optional as Malaysian SMEs navigate their digital ransformation journeys, she stressed.

KUALA LUMPUR: LYC Healthcare Bhd (LYC) plans to list its subsidiary, LYC Healthcare (Cayman) Ltd (LYC Cayman), on the New York-

In a Bursa Malaysia filing, the healthcare company said LYC Cayman plans to undertake an initial public offering (IPO) of

new ordinary shares on Nasdaq.
"The offering size is expected to range between US\$5 million and US\$15 million (RM22.3 million and RM67 million) subject to the full exercise of the overallotment option by underwriters. The IPO price will be at least US\$4 per share, with shares offered to third-party investors," it said.

The company also said that following the completion of an internal reorganisation, LYC Cayman would become the ultimate holding company for LYC's operating subsidiaries, HC Orthopaedic Surgery Pte Ltd (HCOS) and T&T

Medical Group Pte Ltd (T&T).
Post-listing, LYC's stake in its operating subsidiaries, HCOS and T&T will dilute from

64.50% but remain above 50%.

"The proceeds from the IPO will be allocated as follows: approximately 50% for potential mergers and acquisitions, 20% for business expansion, and 30% for daily operations and working capital," it said.

The company said the rationale for the listing includes enabling the efficient allocation of resources to drive business growth in medical and surgical advisory services. It would also unlock the value of LYC's investment in the operating subsidiaries.

"Barring any unforeseen circumstances, the proposed listing is expected to be completed by the first half of 2025," it said.

Bursa tipped to onboard 50 new listings this year, FBM KLCI to reach 1,800 points

KUALA LUMPUR: Malaysia's equity market delivered a commendable performance in 2024, earning a solid grade close to an 'A', with several key milestones achieved during the year, laying the foundation for the main index to reach 1,800 points this year, with 50 new

listings anticipated.
The benchmark FTSE Bursa Malaysia KLCI

(FBM KLCI) ended 2024 with a 12.9% increase over the 52 weeks, making Bursa Malaysia the secondbest performer in Southeast Asia, after



In addition, the exchange recorded its highest-ever issuance of initial public offerings (IPO) and saw its market capitalisation exceed the RM2 trillion mark for the first time in May.

Focusing on individual stocks, 99 Speed Mart Retail Holdings Bhd surged 14% in its market debut, marking the largest IPO in seven years since Lotte Chemical Titan's listing in 2017. This was Bursa Malaysia's 34th IPO of the year, solidifying Malaysia's position as Southeast Asia's most active IPO market in

The most-traded stocks on Bursa Malaysia for the past 12 months include My EG Services,

Velesto Energy, Hong Seng Consolidated, Top Glove Corporation, and TWL Holdings, according to data from Bloomberg.

Year-to-date in 2024, 53.04 million of MvEG shares were transacted, followed by Velesto Energy (43.74 million), Hong Seng Consolidated (37.62 million), Top Glove Corporation (35.98 million) and TWL Holdings (35.46 million).

Bursa achieved a significant milestone in 2024, with 55 IPO listed on

with 55 IPO listed on the exchange – the highest number of listings recorded in the past 19 years, exceeding the initial target of 42 IPO.

Impact of bird's nest export halt to China not known yet: MYMBN

KUALA LUMPUR: Bird's nest processor MYMBN Bhd has yet to fully quantify the financial impact of the suspension of bird's nest exports to China.

In a filing with Bursa Malaysia, the company acknowledged that the suspension has disrupted operations, supply chains, and revenue streams tied to the China market, one of its major export

destinations.

To date, MYMBN is unable to fulfil orders worth approximately RM2.5 million due to the suspension.

"Regardless, the company continues to

"Regardless, the company continues to incur monthly overhead costs of approximately RM92,000 despite the suspension," it noted.

The company added that it has taken immediate steps to address the situation, including collaborating with regulatory bodies to resolve the issues behind the suspension and expedite its resolution.

Apart from that, MYMBN is exploring strategies to strengthen its presence in alternative markets to reduce dependency

The group's operational workflows are also being optimised to manage inventory and production levels efficiently while

maintaining product quality," it said.
On Dec 26, MYMBN disclosed in a filing with Bursa Malaysia that it had received a

notice from Malaysia's Department of Veterinary Services (DVS) regarding the temporary suspension of bird's nest product exports to China, effective Dec 25.

The suspension was prompted by outbreaks of Newcastle Disease (ND) in Malaysia, as reported to the World

Organisation for Animal Health (WOAH).

However, the DVS in a separate statement, confirmed that no cases of ND have been detected on the premises or bird's nest products monitored by the department.

"Due to this export suspension, a total of 22 consignments weighing 1.769 tonnes and valued at RM7.23 million, involving 13 export companies have faced clearance issues at China's entry points, the DVS said.

The suspension was initiated at the request of China's General Administration of Customs (GACC), following reports of ND outbreaks in chickens and ducks in Malaysia between March and June 2024,

as reported to WOAH, it said.

To address the issue, the DVS added it has submitted a comprehensive report to the GACC detailing the outbreak status and the measures taken to manage ND in Malaysia, of which the report also assures that bird's nest products exported to China are free from the disease. - Bernama

CPO futures fall over Indonesia's biofuel scheme

KUALA LUMPUR: The crude palm oil (CPO) futures contract on Bursa Malaysia Derivatives closed lower on the last trading day of 2024, due to the upcoming implementation of Indonesia's biofuel programme in January, following the recent rally in CPO prices, a dealer said.
Indonesia's biofuel programme

is a nationwide mandate to blend palm oil-based biodiesel with diesel fuel, aimed at reducing fuel imports, increasing domestic demand for palm oil, and cutting emissions.

Palm oil dealer David Ng said

that the slower pace of Indonesia's biofuel programme could hurt demand for CPO, which in turn, we pressure on its prices. would exert

"Lower export estimates are also seen weighing on CPO

"We see support at RM4,400 and resistance at RM4,600 per tonne," he told Bernama.

According to reports, Indonesia's

plan to expand its biodiesel mandate looks likely to be implemented gradually. At the close, the January 2025 contract dropped by RM64 to

Singapore Post names new CFO in executive overhaul

SINGAPORE: Singapore Post has appointed the CFO of its Australia business as group finance chief, the company said, a week after dismissing its CFO and two senior executives for mishandling a whistleblower report.

Isaac Mah, who joined Singapore Post in 2019, most recently oversaw the sale of the company's Australia business to private equity firm Pacific Equity Partners.

The Temasek-backed company has said it

will name a new group CEO in due course.
Singapore Post fired group CFO Vincent
Yik last week, along with CEO Vincent Phang
and its international business unit chief Li
Yu, after they were found to be "negligent" in handling a whistleblower report.

The alleged misconduct reported by the whistleblower related to several employees who worked in the company's international e-commerce logistics parcels business

Shares of Singapore Post have dropped 5.4% since the company announced the dismissals last week.

Temasek is the largest shareholder of Singapore Post with a 21,75% stake in the company, followed by Alibaba Investment with a 11.21% stake, LSEG data showed.

Phang and Yik have indicated they will 'vigorously contest" the termination of their

employment.
They said in a joint statement on Tuesday that after the whistleblowing report was submitted, Singapore Post management did not take part in the investigation as set down

not take part in the investigation as set down in the company's whistleblowing policy. Phang and Yik were asked for their views on the incident on March 11 and April 3 and responded accordingly based on

the facts provided to them at that time.

But they only became aware of the full facts on April 27 following investigations by

the external forensics team, they added.
"A significant majority of the shipments in question were linked to destinations where there were known issues - such as conflict

"It was therefore important to establish the financial impact prior to communicating with the customer as well as determining any wrong doing by junior staff members."

Phang and Yik added that the management was briefed on the external forensic team's

"conclusive" findings.

The duo then agreed with and followed

the instructions of the board.
"A settlement with the customer was then concluded that did not have a material financial impact," they said, adding that details of their full responses were submitted

to the board on Nov 22.

Phang and Yik's statement did not disclose the identity of the customer.

Montenegro extradites crypto mogul to US

PODGORICA: Montenegro on Tuesday extradited to the United States the South Korean cryptocurrency specialist Do Kwon, who is also wanted by Seoul over his firm's multi-billion-dollar bankruptcy, officials said.

Do Kwon was "handed over to the competent law enforcement authorities of the United States of America and agents of the Federal Bureau of Investigation (FBI)", Montenegro's Interior Ministry said in a statement.

He was extradited upon the decision of Montenegro Justice Ministry to face "criminal

to commit fraud", the statement added.

For months, Seoul and Washington have been seeking the South Korean's extradition for his suspected role in a fraud linked to his company's failure, which wiped out about US\$40 billion (RM179 billion) of investors' money and shook global crypto markets.

Last week, Justice Minister Bojan Bozovic issued a decision approving the extradition after a year and a half of court rulings and subsequent reversals over it.

Kwon's Montenegrin lawyers denounced the decision as contrary to European conventions on extradition, and said they will appeal to the country's constitutional court and to the European Court of Human Rights.
The crypto tycoon was arrested in March 2023

at the airport in Podgorica, the Montenegrin capital, while preparing to board a flight to Dubai, in possession of a fake Costa Rican passport. Before his arrest in the tiny Balkan nation, he

had been on the run for months, fleeing South Korea and later Singapore, before his company went bankrupt in 2022.

Montenegro had already deported Kwon's business partner – identified only by his initials J.C.H. – to South Korea in early Fébrúary.

Terraform Labs created a cryptocurrency called Terral ISD that was marketed as a "stablecoin" a token that is pegged to stable assets such as the US dollar to prevent drastic fluctuations.

Do Kwon successfully marketed them as the

next big thing in crypto, attracting billions in investments and global hype.

Media reports in South Korea described him

a "genius". But despite billions in investments, TerraUSD

and its sister token Luna went into a death spiral in May 2022.

Experts said Kwon had set up a glorified pyramid scheme, in which many investors lost

their life savings.

He left South Korea before the crash and spent months on the run.

In January, Terraform Labs officially sought bankruptcy protection in the United States.

China's net gold imports via HK hit seven-month high

HONG KONG: China's net gold imports via Hong Kong in November more than doubled from October, marking the highest level in Kong seven months, Hong Kong Cer Statistics Department data showed.

The world's top gold consumer imported a net 33.074 metric tons in November, up 115% from 15.414 tons in October, its highest level since April 2024.

Total gold imports via Hong Kong were up 60% at 45.22 metric tons from October, posting its highest level in eight months.

China is the world's leading consumer of gold, and its purchasing activities can significantly influence global gold prices. China's central bank resumed buying gold

for its reserves in November after a six-month pause, according to official data. "The People's Bank has started reporting fresh purchases and it could be that there has been some import for official sector purchases," said StoneX analyst Rhona O'Connell

"More likely it is continued interest in bars and coins, and some improvement in jewellery demand."

Last week, gold dealers in China also started charging premiums for the first time in more than a month as consumers began stocking up for the upcoming Lunar New Year celebrations.

Gold exports from Switzerland rose in November due to a jump in supplies to India and some revival of deliveries to China and Hong Kong compared with October, Swiss customs data showed.

customs data snowed.

Spot gold has gained around 27% last year, hitting a record high of U\$\$2,790.15 on Oct 31 on the back of U\$ Federal Reserve's interest rate easing and escalated tensions around the globe.

Indonesia's president says VAT hike only on luxury goods, services

JAKARTA: Indonesia's President Prabowo Subianto said an increase in value-added tax (VAT) rate by one percentage point to 12% from yesterday will apply only to luxury goods and services.

Prabowo said the decision should end speculation over which items and services would be affected by the VAT increase.

The government's decision also reversed

announcement by Finance Ministry officials last month.

Authorities at the time had said the VAT Authorities at the time had said the val-hike would apply across the board except for cooking oil sold under a government programme, sugar for industry and wheat flour, which would still be subject to an 11%

"Today, the government has decided that the increase of VAT rate from 11% to 12% will apply only to luxury goods and services that are the subject of luxury sales tax and are consumed by those with higher income, such as private jets, yachts and luxury homes," the president said.

president said.

Prabowo said the government will still move forward with planned support measures intended to soften the blow from the VAT hike, worth 38.6 trillion rupiah (RM10.7 billion), which include electricity discounts and other tax breaks. - Reuters

Japan selects two groups for third offshore wind power round

TOKYO: Japan's Industry and Land Ministries selected two consortiums, one including energy major BP, as operators for two offshore wind blocks in a third major round of public auctions.

The results of this round of auctions, held under a law promoting development of wind power, were closely watched by domestic and international energy companies weighing the advantages of renewable exposure, industry

Japan aims to accelerate offshore wind development as part of its decarbonisation strategy, targeting 10 gigawatts (GW) of offshore wind farm deals by 2030,

and up to 45 GW by 2040.

A consortium of JERA, Green
Power Investment, and Tohoku Electric Power won the 615 megawatts (MW) wind farm on the southern side of the Japan Sea off Aomori prefecture, near Tsugaru

city and the town of Ajigasawa.

Another consortium, including Marubeni, Kansai Electric Power BP's unit BP IOTA, Tokyo Gas and local firm Marutaka secured the 450 MW wind farm off the coast of Yamagata prefecture near the Yuza

Both bottom-fixed projects are scheduled to begin operations in June 2030, with turbines supplied by Spain's Siemens Gamesa, a government statement said.

In a previous auction round, Spanish utility Iberdrola and Germany's RWE were among the winning consortiums of a separate offshore block.

Earlier this month, BP and JERA agreed to join forces to form one of dagreed by Join Forces to offshore wind operators, highlighting a trend of Japanese firms partnering with western players for expertise and growth, while foreign companies seek entry into Japan's expanding renewable energy market.

its third round of offshore wind tenders from mid-January to mid-July, as it strives to meet its

2050 carbon-neutral target.

Al learning apps marketed to schools across the world

PARIS: Apps infused with AI are being marketed to schools across the world and governments are rushing to embrace the technology, despite experts raising serious doubts.

The sector known as Ed Tech exploded during the Covid pandemic as schools closed to stop the spread of infection and millions of children were forced to learn in front of screens at home.

As demand dried up after schools reopened, Ed Tech startups tried to win back investment by adding AI to their products and marketing.

Tech titans like Microsoft, Meta and OpenAI have also spied an opportunity, promoting their AI products to schools or partnering with startups.

While many education ministries have announced plans to deploy AI apps, there are plenty of

dissenting voices.
The UN's education body Unesco eviscerated the record of online learning during Covid, saying the rapid rollout of tech solutions was a that had increased inequality and worsened learning outcomes

Unesco's Manos Antoninis told AFP that AI might have some utility in education but right now it "seems

Governments rush to embrace the technology despite experts' doubts

to be creating more problems than it is solving". He cited

concerns that He cited concerns that companies were using data for commercial purposes, deployed biased algorithms and overall were less concerned with educational outcomes than with their bottom

line.
"I think the unfortunate thing is that education has been used as a bit of a Trojan horse to access future consumers," he said.

During the pandemic boom in 2021, venture capitalists pumped more than US\$17 billion (RM76 billion) into Ed Tech.

But that has slumped to US\$3

billion this year, about the same as last year, according to analysts PitchBook.

But from North Carolina to South Korea it is a different story, where education officials have been encouraging teachers to use generative AI.

Britain has already rolled out a homework app called Sparx Maths that uses algorithms to tailor children's learning.

It recently announced a further multimillion-dollar outlay on AI programmes to "ease the pressure" on hard-working teachers by helping with lesson plans, marking and assessment.

The European Union supports

several learning apps, and several EU countries have experimented

with them.
China is a huge booster of AI in the classroom and has a national strategy for digitising education - its centrepiece being a national education platform of tools and online courses

Yet the on-the-ground reality is often messy.

India boasted one of the liveliest startup scenes in the sector during the pandemic, including a firm called BYJU's which was once the world's most valuable Ed Tech startup.

Yet when schools in New Delhi were forced to close because of smog in November, there were no flashy apps to help.

"It is not feasible for them to take

online classes," 29-year-old teacher

Vandana Pandey told AFP, saying many of her pupils had no smartphones or connectivity at

BYJU's has faced allegations of financial misconduct and only narrowly avoided bankruptcy in a recent court hearing.
In richer countries, the arrival of

In richer countries, the arrival of AI has received a tepid reception. Only 6% of US secondary school teachers polled by Pew Research Center in May thought using AI in education would do more good than harm.

France announced it would roll out an AI-powered homework app called MIA in secondary schools last year, but quietly dropped the project as a political crisis rumbled on.

. Many British parents are also not keen on Sparx Maths.
"Don't know a single child that

likes it," said one user on the popular Mumsnet forum.
Another said the app "ruins any enjoyment of the subject" while a flood of other parents said their children "hated" the app.

Aside from grigarness over

Aside from grievances over individual apps, educators doubt whether many of these firms are aiming at the right target.

Almost all Ed Tech products promise to "personalise" education, often deploying AI to monitor a child's work and tailor workplans to suit their needs.

Officials from Britain to Beijing

Officials from Britain to Beijing have lauded this goal. But Antoninis said the rhetoric around personalisation "risks making us forget that a lot of learning is actually social, and children learn from interaction with each other".

Leon Furze, a former teacher who now works as a consultant focusing on generative AI in education, was also wary about personalisation.

"AI is touted as a solution to "Al is touted as a solution to personalised learning, but it's a very specific kind of 'personal' which I think seems more like isolation." Both Antoninis and Furze warned

that technology was no panacea, rather it was a tool that could help in some limited situations.

The hard work, as ever, would be done by humans.

"Tech solutions aren't going to solve the bigger socio-economic, cultural, and political challenges being faced by teachers and students," said Furze. – AFP

Indian banks to stick with certificates of deposit

MUMBAI: Indian banks will continue to rely on certificates of deposit for meeting short-term cash needs in the next quarter amid tight liquidity conditions, after fundraising through these instruments year-on-year in 2024.

Certificates of deposit (CDs) are debt instruments with maturities of less than one year issued by banks, and are efficient tools for short-term funding.

Fundraising through CDs has

become crucial for banks as deposit mobilisation has slowed, with several lenders lowering their

deposit growth forecasts. Rising competition for so-called bulk deposits has also pushed more lenders towards CDs. Credit growth has outpaced

deposit growth for most of the last three years, which could lead to an asset-liability mismatch, forcing banks to issue more CDs.

Banks issued CDs worth 12.23

trillion rupees (RM639 billion) in 2024 till Dec 27, data from information provider Prime

Database showed.
The issuance is about 50%

higher than in 2023, and over 80% higher versus 2022.

Average banking system liquidity turned to neutral last year, as the Reserve Bank of India focused on inflation management and kept a tight leash on cash conditions

Average liquidity was in surplus during the previous two years.

The increase in CD issuances is

primarily driven by the ongoing liquidity tightness.

Banks are rolling over CDs to manage redemption pressures and also leveraging them as a quicker funding tool to supplement deposit growth for supporting economic

"If liquidity deficit persists, it may elevate certificates of deposit yields further," said Venkatakrishnan Srinivasan, founder and managing partner at debt advisory firm

Rockfort Fincap.

The banks' reliance on CDs may continue in the last quarter of the fiscal year, as liquidity is expected to be tighter due to factors such as increased lending, asset-liability mismatches and higher statutory outflows, said Mataprasad Pandey, vice-president at financial advisory firm Arete Capital. - Reuters

Drugmakers to raise US prices on 250 medicines

NEW YORK: Drugmakers plan to raise US prices on at least 250 branded medications including Pfizer Covid-19 treatment Paxlovid, Bristol Myers Squibb's cancer cell therapies and vaccines from France's Sanofi in 2025, according to data analysed by healthcare research firm 3 Axis Advisors.

Nearly all of the drug price increases are below 10% – most well below.

The median price increase of the drugs being hiked is 4.5%, which is in line with the median for

all price increases last year.

The increases are to list prices, which do not include rebates to pharmacy benefit managers

and other discounts.

Larger drug price increases were once far more common in the US but in recent years drugmakers have scaled them back after price hikes drew sharp criticism in the middle of the last decade.

"Drugmakers don't have much real estate any

longer to increase prices over time, which means taking greater liberties on launch prices is really the only option they have in the face of expanded penalties for year-over-year price increases," 3 Axis president Antonio Claccia said.
A Reuters analysis of prices for new drugs found that pharmaceutical firms launched new US

drugs in 2023 at prices 35% higher than in 2022. The over 250 drug hikes represent an increase from Dec 29 in 2023 when drugmakers unveiled plans to raise prices on 140 brands of drugs.

Drug firms are also reducing some prices. Merck & Co plans to cut the list price of its

diabetes drugs Januvia and Janumet "to align the list price more closely to the net price".

The US pays more for prescription medicines than any other country, and incoming President Donald Trump has vowed to lower drug costs by focusing on middlemen in the healthcare system

More drug price increases are likely to be announced by other drugmakers over the course of January – historically the biggest

month for drugmakers to raise prices.

Pfizer raised prices of the most drugs on the

latest list – more than 60 drugs. As well as a 3% hike on Paxlovid, the company

raised prices on medicines including migraine treatment Nurtec and cancer drugs Adcetris, Ibrance and Xelianz between 3% and 5%.

Bristol Myers raised the price of its cancer cell therapies Abecma and Breyanzi by 6% and 9%, respectively.

The personalised blood cancer treatments can already cost close to US\$500,000.

Sanofi raised prices on around a dozen of its vaccines between 2.9% and 9%. - Reuters

Roche has no plans for job cuts: CEO

ZURICH: Swiss pharmaceutical company Roche is not planning job cuts and its business is healthy, CEO Thomas Schinecker was quoted as

saying by a Swiss newspaper.

Roche's share price has fallen far below peaks it scaled in April 2022 and the CEO was questioned about the company's staffing plans in the context of recent setbacks in its development of drugs to treat cancer, among other illnesses.

"The number of workers is constant to slightly increasing," Schinecker told the NZZ am Sonntag when asked if the company was planning layoffs.

"I can say with certainty that we have a very healthy business. And we don't have a growth problem either," he said, while noting that Roche's budget for research and development

was stable and not growing.

Asked when Roche's planned anti-obesity

drug would hit the market, Schinecker said it could be around 2029 or sooner.
Addressing the outlook more broadly for next year, particularly in light of the German economy's recent struggles, the Roche CEO said Europe still faced challenges.

American farmers fret over Trump's deportation plans

Sudden disappearance of workers could cause food shortages, stoke inflation

FIREBAUGH: Lifelong farmer Joe Del Bosque knows that America cannot live without immigrants, but he worries that many of his countrymen think it cannot live with them either.

"When they're needed, they welcome them. When they don't need them, they want to kick them out," the 75-year-old told AFP.
"Well, right now the country doesn't know

well, fight now the country doesn't know that they do need some of these workers."

Farmers like Del Bosque, who grows cantaloupes and almonds in California, fear they could be at the sharp end of President-elect Donald Trump's promise to

deport millions of non-citizens.

Economists agree that a mass expulsion could leave him and others like him without enough workers to harvest food - causing

shortages and sending prices skyrocketing.
"He's talked about deportations. We don't

know yet what that means," said Del Bosque.
"Does that mean everyone? We certainly hope that doesn't mean he's going to raid our farms, because without our people, our farms will come to a stop."

And it is not just arable farmers who are

worried.

Rick Naerebout, executive director of the Idaho Dairy Producers Association, warns the sudden disappearance of skilled labourers could be "devastating" to the dairy industry. 'It would only take a couple days of disruption and not being able to feed or milk our cows to where you would damage our

our cows to where you would damage our industry beyond repair," he told AFP.

Around 2.4 million people work in farming in the United States, 44% of whom are undocumented, according to a survey by the Department of Labour.

Department of Labour.

University of Michigan economist David Ortega said - despite what some politicians say publicly - it is widely acknowledged in official circles that the entire system is heavily dependent on illegal workers.

"These are individuals that perform

essential, very labour-intensive tasks like planting and harvesting.

"Many of them fill critical roles that many US-born workers are either unable or unwilling to perform."

Farm work is hard, and often done in a

difficult environment - summer temperatures in California can top 40°C, while winters in places like Idaho are routinely below freezing.

This reality stands in stark contrast to claims by nationalist politicians like Trump that these

immigrants are "stealing" American jobs.

Naerebout said it is a common - and frustrating - fallacy.

He says one contractor last year advertised

to fill thousands of roles.
"They had fewer than 30 domestic applications for 6,000 jobs.

"Only 12 of those individuals resulted in an interview, and only two resulted in a hire, and those two that got hired didn't make it to harvest.
"Americans don't want these jobs."

Such details were absent on the campaign trail, where Trump rallies painted migrants

only as a problem for the United States, a source of crime and overcrowding that need

immigration as a key reason for supporting Trump.

California dairy farmer Tom Barcellos says he is convinced that - despite Trump's promise to carry out the largest deportation in US history - common sense will prevail when the Republican takes office on Jan 20.

"I've been to (Washington) DC many times. I've been to (California state capital)

Sacramento many times.

"Those that have the power know we're not going to go raid agriculture, because that's the food source for Americans, and they don't want

to raise the cost any more than it needs to be."

For Naerebout there is a desperate – and long overdue – need to move past the political posturing and work out a way forward.

"We've been frustrated for, you know, 20 years trying to find a pathway forward to reforms at a national level, and both (Democrats and Republicans) are at fault.

"We as an industry wonder if there's lack of

"We as an industry wonder if there's lack of political will to solve the problem because the problem presents itself as a great political fundraiser and stump speech."

Del Bosque says he hires around 200 workers during harvest season and finds the process frustrating.

Migrants who try to do things legally get bogged down in a bureaucracy that have no understanding of the needs of the workers or the industries that need to employ them.

"A lot of our fresh fruits and vegetables

need to be picked by hand.

"If Americans value that kind of food in their diet, they need to consider that we have to have a reliable workforce to have a reliable food supply." - AFP

In fact, back in 2011, we have objected the government's move to increase coal energy use in our energy mix as the demand for coal has risen at that time due to high natural gas price and increase on new coal power plants' up globally. Such increased reliance will not bode well for price stability and sustainability in the long run. These concerns that we have raised were not looked into seriously and few years after that, it started to give negative impacts to Malaysia in terms of cost and sustainability. The underlying

issues for coal are generation efficiency and its high green house gas (GHG)

According to news reports, it is also reported that Indonesian coal mining sector under reported its coal mine methane (CMM) emissions in the overall emission data. Methane has about 30 times the global warming potential over 100 years. Peninsular Malaysia's reliance on Indonesian coal for its energy mix has also risen from

50% to around 70%.

A lot of approaches were introduced by the coal sector especially power generation for the past few decades. This includes moving away from conventional power generation and increasing generation efficiency by deploying super critical and ultra super critical coal power plants that pushed generation efficiency above 50% which also means lower fuel cost and lesser pollution.

These growths in coal sector did not manage to portray a positive image and more ludicrous ideas were also floated. A decade ago, there was proposal from the government to use Carbon Capture and Storage (CCS) and Carbon Capture, Utilisation and Storage (CCUS) to reduce coal power plants' GHG emissions. We objected to this approach as there was nothing scientific about it and it was not an actual solution. In simple terms, CCS and CCUS is like storing GHG in used empty bottles and place them in boxes and hid away from people – where it is not solving any GHG emission or climate change problems. Hence, why should we pay high price for something that is not an actual

Lately, with the Net Zero gung-ho, coal sector will face difficulties to get borrowing from financial market and eventually making it a sunset industry. At the same time, while there are not many options being put on the table baseload replacement, many nations are still scrambling to manage the sudden shift away from coal to meet their development targets and protecting their economic interests.

Here in Malaysia, we still lack of proper roadmap to meet the baseload replacement and failed to address intermittency risk posed by renewable energy (RE). The RE sector is passing the intermittency risk management cost to tariff for consumers to shoulder

Finding new technological solutions that are reliable is a vital move as global risks for energy resources, technology adoption as well as final energy utilisation are very fluid. We are lucky not to deploy CCS or CCUS for coal power plants a decade ago as the long term cost impacts of "a not real solution" will haunt us when we exit the coal power generation mix

in coming decade.

Recently, there have been news reports on CCS and CCUS having a comeback mission to Malaysia. Science is very clear. CCS and CCUS are mainly storage and it does not solve the GHG emission or climate change problems. The fundamental question that we all must ponder is, if CCS and CCUS become a certified "not real solution" for climate change in near future like what happened to coal sector, who will bear the cost for wrong investments? Where do we draw the line?



FUELLED in part by the success of TV hit Shogun, foreign studies are hungry for quality Japanese content and local creators are adapting to meet demand.

Fans of Japanese manga and anime cartoons have often criticised foreign adaptations that unfaithful to the original material.

But Shogun, based on the 1975 novel by Australian-British writer James Clavell, broke the mould when the period drama series (mostly in Japanese and hailed for its authenticity) won 18 Emmy

awards September last year. Other recent Japanese works have also become worldwide hits.

Franco-US-Japanese Drops of God, based on a manga of the same name, won best drama series at the International Emmy Awards in November last year. Netflix's 2023 adaptation of the

manga superhit One Piece, starring Mexican actor Inaki Godoy as the lead, was hailed by viewers and critics alike and will return for a second season.

More adaptations of major manga and anime hits are in the works, including

Academia and Naruto.

"Demand from Western markets is clearly increasing," said Tiffcom managing director Kaori

Tiffcom is the content trade fair affiliated with the Tokyo International Film Festival. But Japanese companies lack "know-how" when it comes to

things such as negotiating rights, she said.

So Tiffcome has organised Tokyo Story Market, a space to facilitate networking and

meetings between international producers publishers.

Avoid problem of whitewashing Foreign studios are also getting better at avoiding some of the pitfalls of the past, such as the 2017 film version of the manga Ghost in the Shell starring Scarlett Johansson.

Critics accused the movie, whose main actors except Takeshi Kitano were all non-Japanese, of

whitewashing.
Similarly, the 2017 supernatural thriller *Death Note* was panned for veering too far from the original

manga.

"Manga authors are highly respected and fan communities are very vigilant," said *Drops of God* producer Klaus Zimmermann.

His adaptation takes some liberties, such as starring a French actor as one of the main characters, but Zimmermann insisted it was developed in collaboration with the authors of

the original manga.
"It was about finding the spirit of the manga so as not to distort

The manaa's publishing house Kodansha rights negotiator Yuki Takamatsu said the process of adapting *Drops of God* was amazing.

"Everyone was open to tackling those challenges together. At every step, everyone was understanding about how we should do it," he said.

Past failures were in part down to publishers struggling to communicate their wishes to foreign producers, who in turn lacked a proper understanding of

manga and anime, Takamatsu said.

"Just 15, 20 years ago, most of the enquiries we received from those big studios were like, 'hey, I know *Dragon Ball*, do you have *Dragon Ball IP?*"

But nowadays especially since Covid, the producers in their 30s, 40s, watch anime with their kids on Netflix or Amazon and then reach out," Takamatsu said.

Japanese broadcasters have long had success selling show concepts abroad, such as America's Funniest Home Videos, known in Britain as You've Been

Now, some Japanese dramas are also finding a wider echo abroad.

Nippon TV's original drama Mother became a hit thanks in part to its Turkish remake and has been broadcast in around 50 countries.

Western viewers have overcome their initial reluctance to watch series with Asian actors, chief executive Masaru Akiyama believes.

"They have got used to it, they do not care anymore. They want to see, they want to feel the stories." He added that *Shogun* was a

game changer for Japan. Ikeda echoed the same sentiment and said a samurai story with such attention to historical detail can become mainstream entertainment is proof of the

potential of Japanese content.

Schauffele not giving up

American world No. 2 still vying to supplant Scheffler for No. 1

ANDER knows how difficult the climb will be

Schauffele has said in the past that he wants to earn the No. 1 spot in the Official World Golf Ranking someday, but even with World No. 1 Scottie Scheffler out of the field this week at The Sentry, it's not as simple as Schauffele winning a few more tournaments.

The 2025 season begins with Scheffler leading No. 2 Schauffele by 6.3727 average points in the OWGR's ranking system, which utilizes a two-year rolling period, emphasizes players' most recent performances and factors in tournaments' strength of field.

When speaking with reporters yesterday ahead of The Sentry in Kapalua, Hawaii, Schauffele nodded

ANDER SCHAUFFELE hasn't to the dominant year Scheffler had to build such forgotten nor given up on one of his biggest career goals, though he a massive lead in the OWGR. He agreed that he feels "under the radar" – ironic after a year in which he won his first

two major championships. "Yeah, just kind of cruising where I cruising around right where I want to be," Schauffele said. "It's a wild time. Winning two majors and being further away, or closer to the 30th-ranked player than the first is – hat's off to Scottie. He's a beast."

It's not exactly accurate to say Schauffele is closer to No. 30 in the rankings to No. 1, but the margin is similar to the gap between Schauffele and World No. 22 Aaron Rai of England. "He just kept winning. Even in sort

of his downtime, he won another event, which pushed him even further away." Schauffele said. "So it's one of my goals that will just have to stay on the calendar for a

Schauffele was referencing

Scheffler's victory at the Hero World Challenge in early December, which is not an official PGA Tour event but still counted for ranking points. It capped a historic year for Scheffler, who also won the Masters, the Players Championship and the Olympic gold medal.

But Scheffler is not in Hawaii this week as he recovers from surgery on his right hand. He was injured by a broken glass while preparing Christmas dinner and had shards of glass

Christmas dinner and nad shards of glass embedded in his palm.

"It's a huge bummer. I hope he's OK," Schauffele said. "Iheard he was going to be back for American Express (the tournament in the California desert Jan 16-19), then you hear he has surgery. I didn't feel, like, too comfortable texting him. It's weird, because we're competitors, but at the same time he's such a nice guy, him and (wife Meredith)."

Saying he tries to focus on the process rather than the results, Schauffele admitted it will "take some time and some patience" to track down the No. 1 ranking. The PGA Championship and Open Championship winner was asked what area of his game he wants to improve to catch up to Scheffler. – Field Level Media

Ex-India coach wants two-tier Test system

FORMER India coach Ravi Shastri called yester for a two-tier structure in Test cricket with relegation and promotion to ensure the survival of the red-ball game.

His comments follow the blockbuster fourth Test between India and Australia that drew a record 373,691 spectators to the Melbourne Cricket Ground over five enthralling days.

That beat the previous record of 350,534 at the same ground during the 1936-37 Ashes series against England, when Donald Bradman ruled the sport and Tests were played over six days. Shastri, now a commentator, said he

could not remember "a bigger advertisement for Test cricket" and said it proved the five-day game continued to hold its own in the face of ever-increasing T20 franchise cricket.

But the 62-year-old said it also reinforced his view that for Test cricket to survive, the biggest teams needed to be playing each other more often.

To break crowd records that have stood for nearly a century... is testimony to the fact that when the best teams play. the toughest and best format of the game is still alive and thriving," he said in a column for *The Australian* newspaper.

"It was also a sound reminder to the

ICC (International Cricket Council) that the best should play the best for Test

cricket to survive

"I will say that there's too much of a

clutter otherwise.

"This match further emphasises why we need a two-tier system with the top 6 8 teams and then include promotion and demotion. You will not get these kinds of

demotion. Tou will not get these kinds of crowds if you don't have two proper teams playing."

The ICC has been contemplating a two-tier system for years to keep the format competitive but the plans have never got off the ground. While India stand to gain from plaving

more matches against teams such as England and Australia, the BCCI said at the time the cost to smaller cricketing nations was too great.

Shastri also said the Melbourne game proved that Tests should remain five days, amid chatter that they should be reduced to four to help streamline schedules.

"The theatre in the end on (day five) Monday was further proof of why we need five days for a classic Test match," he

"However, if you don't create a two-tier system, you'll continue to have unmatched teams up against each other and then it's very unlikely they'll be able to take a game into the fifth day. Then there'll always be talk of four-day Tests." -

Carey backs Starc to win fitness race

AUSTRALIA wicketkeeper Alex Carey has backed Mitchell Starc to be ready for the decisive fifth and final Test of the series against India when it starts in Sydney tomorrow despite doubts over the fast

bowler's fitness.
Starc was sent for back scans after clutching his ribs and side in the latter stages of Australia's thrilling 184-run victory in the fourth Test in Melbourne, which earned Pat Cummins' side a 2-1 series lead.

"He'll be fine, he'll push through," Carey said. "I have played with Starcy for a long time now and he is one of the toughest cricketers I have played with.

"So he'll grimace, he'll grab his rib, no doubt, but he'll be ready for the contest."

Despite seeing Starc claim only one wicket during the fourth test, the vital scalp of Virat Kolhi during India's second innings run chase, Carey was impressed with the 34-year-old's performance at the MCG.

"I thought that first spell (on the last day in Melbourne) without the reward was, you know, some of the best bowling I've seen this series from him," he said.

"He's got an opportunity now to help this team in a Test match. He'll be up for the contest. And I think his bowling just got better throughout the series."

The win in Melbourne means the Australians can claim the series, and with it the Border-Gavaskar Trophy, with a draw in Sydney. – Reuters

The club managed to register Olmo and forward Victor after long-term injuries kept first-team players out of the squad for months, allowing them to allocate a portion of their

Efforts to extend both registrations have hit repeated road blocks, with Barcelona's appeals dismissed by La Liga and various judicial authorities.

While Olmo and Victor will be free agents after the deadline, Barcelona could meet the economic requirements to sign them before the

"There are two ways to look at results," the former Manchester United striker said. "You can look purely at results: when you win, you're great, when you lose,

Boss in League One

Rooney has harmed his reputation as a manager during ill-fated spells with Birmingham and Plymouth over the last 14 months and may not be given the oppor-tunity to manage in the Championship again until he can prove himself at a lower level. He may therefore have to accept a role in League One, where he will be under slightly less scrutiny.

Boss in Saudi Pro League

Rooney may decide to get away from England and experience life in another country for a few years. There will surely be a club in the Saudi Pro League who would be willing to offer him a huge pay packet to get him to the Middle East. Liverpool icon Steven Gerrard is currently out there managing El-Ettifaq and could put his former international teammate in contact with the right people to start the ball rolling.

England coaching role

If Rooney wants to step away from the demands of club football, he could attempt to get a role as an England coach. The former striker bagged 53 goals in 120 appearances for the Three Lions during his playing days and has plenty of knowledge to offer England's current crop of players.

Pundit for Sky Sports/BBC

Plenty of ex-players have turned their back on management to work as pundits, with the likes of Alan Shearer and Gary Neville opting to swap the touchline for the television studio. Rooney appeared on Sky Sport and the BBC to offer his expert thoughts in the past and would be welcomed back with open arms if he wanted to return to either

Reality TV star

Rooney may want to take a break from football altogether for the time being and could decide to follow his wife Coleen into reality TV. Mrs Rooney finished second on I'm a Celebrity last month and her husband revealed he would also consider featuring on the show if he isn't working.



BAM to **finalise Bin Shen's** replacement

THE Badminton Association of Malaysia (BAM) is expected to conclude the search for a new men's doubles head coach in two weeks' time.

Its acting president Datuk V. Subramaniam said they are scrutinising a few candidates, including a local coach, to replace Tan Bin Shen, who will end his service after the Malaysia Open 2025, which will be held from Jan 7-12.

"Our team is looking at it very carefully before we can finalise the new men's doubles head coach. We are trying to do it as early as possible.

"If everything goes well, even during the Malaysia Open next week we will announce," he said when contacted vesterday.

Last month, BAM announced that Bin Shen would step down on Jan 13 to end his four-year

The former national player played a key role in raising the standards of several national men's doubles pairs, including helping Aaron-Wooi Yik win Malaysia's first world title in 2022.

The 40-year-old coach will be serving the Hong Kong national team under former world No. 1 men's singles player Choong Hann startii Choong Hann starting in February, alongside two other Malaysian coaches, Jeremy Gan and Loh Wei Sheng.

Subramaniam was tight-lipped when asked whether veteran Indonesian coach Herry Iman Pierngadi, better known as Herry IP, could be BAM's choice to spearhead the men's doubles

"Nothing is finalised yet. It is not on me but it will be a collective decision by our team. We want to hire a coach who not only clicks with the players but also builds strong ties with the BAM management," he added.

A comment by Indonesian men's doubles player Mohammad Ahsan on Herry IP's New Year post on *Instagram* sparked speculation on Tuesday, that the latter could be heading to Malaysia.

Ahsan wrote, "Remember to

invite me if you are going to eat Musang King (durians)," to which Herry IP replied, "Sure, Bro Aman." – Bernama

Effendi urges fans to give Canadian time to elevate Harimau Malaya's performance

OCAL football fans have been urged to give former Canadian national player Robert Douglas Friend the opportunity to prove his credibility as the chief executive officer (CEO)

of the Harimau Malaya squad.

Local football observer Effendi Jagan Abdullah said he was somewhat disheartened by the reactions of some fans who seem to question the appropriateness of appointing the individual also known as Rob Friend.

"We must be patient and cannot immediately push the button. Remember, Rome wasn't built in a

day, so give him time.

"His CV is quite impressive, but people are questioning it on social media, especially by stating that Canadian football is not the best. We need to give him a chance and support him; there's no need to think negatively all the time; otherwise, we'll never succeed," he told *Bernama*.

Effendi acknowledged that despite Rob Friend's extensive experience in Canadian football, he faces the challenge of adapting to the local football scene to elevate the national team's performance.

He said the first hurdle Rob Friend might encounter upon starting his duties at Wisma FAM in Kelana Iava is adjusting to the mentality and work methods here, which differ from his experiences in Western countries.

He also hopes that the former Borussia Monchengladbach player can play a role in boosting Harimau Malaya's performance over the next three

Grim reality

Amorim's critical error has accelerated Man Utd's relegation battle

T normally takes two years for a Manchester United manager's reign to descend into crisis. It has only taken two months for Ruben Amorim to reach that point.

A fifth defeat in six League games prompted the head coach who left Sporting CP second in the Champions League to warn that United are at risk of dropping into the

dropping into the Championship.

This might be a relegation battle. "It is one of the worst moments in the history of our club, and we have to accept that," he said

he said.

"I think our club needs a shock." Which they are getting. This may be the worst kind of shock therapy.

Since Amorim arrived, only Leicester and Southampton have taken fewer points. But for the Amad-inspired comeback in the Manchester derby, it would be six straight League losses.

Newcastle only won 2-0 at Old Trafford but it might have been many more. The gulf between teams who finished side by side in the table in the last two seasons is now wider than the gap between Casemiro and Eriksen. Perhaps it falls upon Amorim to prick United's bubble of delusion. When he was lured from Sporting, they had a 100% record in the Portuguese league for one. Now United have lost five Premier League matches in December alone. Amorim is not trying to dodge

Amorim is not trying to dodge the blame. "I am responsible," he said.

And yet it may not have been an exercise in false modesty. "It's also my fault in this moment because I think the

team is not improving," added. They are getting worse.
"We don't have a lot of time to train the base of the way

we want to play," he said.
But that, in turn, reflects on his attempt to remodel the team. He has introduced a system that leaves United undermanned in the middle of the pitch, which was glaringly apparent when the i m m o b i l e Casemiro and Christian Eriksen

United have still conceded 11 goals in their last four games.

included. The Mancunian has not played a minute in United's last four games, not been in the squad for three of them. They have lost all four, failing to score in the three League matches.

If there has been a need to rotate, to get to know the players, Amorim erred with his weakened team at Tottenham as United exited the Carabao Cup, when it might have been a route back into Europe. There probably won't be one via

There probably won't be one via the FA Cup, with United away at Arsenal, or the Premier League. But then, if Amorim's grim warnings are correct, they have greater concerns.

Arsenia, of the Feliner League. But then, if Amorim's grim warnings are correct, they have greater concerns. They thought they were hiring one of the best managers in Europe. They have now suffered six defeats in a month for the first time since 1930.

Which is an indictment of Amorim. He has the smile and the style. He came with plenty of confidence but seems to have underestimated the Premier League and overestimated his ability to turn these players into his team. The job risks being too big for him.
