M'sia, UK to benefit from **CPTPP** accord: PM

Agreement facilitates trade and investments. allows tariffs for products by member countries to be reduced to zero

LONDON: The Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) trade agreement will be a critical vehicle to expand and facilitate trade and investment between Malaysia and the United Kingdom (UK), said Prime Minister Datuk Seri Anwar Ibrahim.

"I expressed my appreciation to the UK premier for successfully entering the CPTPP agreement. It takes serious political commitment on the part of the UK and Malaysia, focusing on economic fundamentals in the interest of both nations to promote free trade," he said on Wednesday.

Malaysia ratified the CPTPP in October 2024, joining Peru, Japan, Singapore, Chile,

New Zealand and Vietnam in doing so, while the UK formally joined last December. Under this framework, tariffs for products by member countries will be reduced to zero.

Anwar was speaking at the launch of the YTL Group's Brabazon New Town development in Bristol, the largest city in the Southwest of England.

The Bristol Brabazon development is set to transform the historic Filton Airfield site into a Copenhagen-inspired project that will allow people to access the essential services they need, which are workplaces, schools, shops, public transport, healthcare and green spaces, within a 15-minute radius of their

Besides the 6,500 high-quality sustainable homes, it will also house three new schools and an urban park, the largest to be built in the Southwest in over 50 years.

He said by participating in overseas ventures, Malaysian businesses could deepen their global market ties, contributing to Malaysia's aspirations of expanding its trade footprint through international frameworks such as the CPTPP.

Anwar, who is here on a five-day working visit, is accompanied by Investment, Trade

and Industry Minister Datuk Seri Tengku Zafrul Abdul Aziz, Higher Education Minister Datuk Seri Dr Zambry Abdul Kadir and Plantation and Commodities Minister Datuk Seri Johari Abdul Ghani.

Meanwhile, Malaysia and the UK are quite optimistic about securing a settlement on the issue of Palestine and Gaza as soon as possible.

Anwar said the matter was discussed during his meeting with his counterpart, Sir Keir Starmer, at No. 10 Downing Street on Wednesday, Bernama reported.

"We discussed the resolution of the Palestine and Gaza issue, with the final (resolution) of them achieving the two-state solution. But prior to that, an immediate ceasefire," he told the media after the meeting.

Anwar's criticism of Western countries' lack of action against Israel's atrocities in Gaza has garnered support from prominent figures across various fields globally.

The governent led by Starmer, which came

to power six months ago, has suspended the sale of certain weapons to Israel and called for accelerated humanitarian aid to Gaza and the

RM12b allocated for beefing up defence assets

KUALA LUMPUR: A total of RM12 billion has been allocated to the Malaysian Armed Forces for the acquisition of assets to enhance the country's defence capabilities this year, said Defence Minister Datuk Seri Mohamed Khaled

He said among the major asset acquisitions approved this year are 105-millimetre cannons, surface-to-surface missiles for the KD Jebat frigate and three units of Medium Altitude Long Endurance Unmanned Aerial

He said the ministry would ensure that the construction of other important assets, such as the Littoral Combat Ship (LCS) 1, which is now 96.52% complete and has commenced Harbour Acceptance Test and Sea Acceptance

Test, would progress as scheduled. "LCS2 has also been launched and is undergoing work requirements, while LCS3 is in final preparations for its planned launch in

January 2026.

"As for the construction of the second batch of littoral mission ships, work progress for all three ships is expected to reach 13.8% overall by June 2025," he said when delivering the minister's 2025 New Year Message at Wisma Perwira yesterday.

Also present were Armed Forces Chief Jen Tan Sri Mohammad Ab Rahman, Deputy Defence Minister Adly Zahari and the ministry's Secretary-General Datuk Lokman Hakim Ali.

Mohamed Khaled said the construction of

FA-50M (Block 20) light fighter aircraft acquired from Korea Aerospace Industries has reached 48% progress, with the first two aircraft to be received by the country in October 2026.

The ministry signed a contract to procure 18 FA-50M light fighter aircraft worth approximately RM4 billion in 2023.

Mohamed Khaled added that the ministry would receive two maritime patrol aircraft in June and September 2026 for monitoring the country's maritime areas.

He said the plan to increase the capabilities of the armed forces assets is among the 10 main focuses outlined in the ministry's 2025 plan to ensure that the country's defence system meets current needs and challenges.

Harmony parade to celebrate unity

KUALA LUMPUR: A harmony parade to celebrate the ethnic diversity and unity in this country will be held on Feb 15 and 16, said National Unity Minister Datuk Aaron Ago Dagang.

He said the parade would be held at night at Dataran Merdeka in conjunction with Federal Territories Day and the World Interfaith Harmony Week (annually held in the first week of February).

"I hope this programme will have a comprehensive and significant impact on our society with the involvement of various agencies and followers of different religions," he said on Bernama TV's Ruang Bicara programme on Wednesday.

He said among the main initiatives of the National Unity Ministry are the Unity Ecosystem, the Madani Harmony Initiative, the Exploration of the Rukun Negara and the Socio-Cultural Community.

Meanwhile, commenting on the Kanowit fire

on Wednesday afternoon that destroyed the Paulus Yan Longhouse in Sungai Buan, Aaron, who is also Kanowit MP, said he sympathised with the 88 residents of the longhouse.

He said he would channel assistance through the Student Volunteer Foundation and the Kanowit MP's office. – Bernama

'Investors free to invest in any state'

Fewer M'sian couples marrying in Thailand

NARATHIWAT: The number of Malaysian couples getting married in southern Thailand has dropped following stricter border controls, including the closure of illegal crossing points

along Sungai Golok since last December.

Narathiwat Islamic Religious Council deputy
president Abdul Aziz Che Mamat said the
number of Malaysian couples coming to marry
had fallen from four or five couples a day to just

one or two, Bernama reported.

He said previously, around 50 Malaysian couples married there each month, but this has now decreased by 40%.

"Although couples can cross legally at the Muhibbah Bridge with complete passport documents, many still choose illegal crossings. "Despite the passport requirement, some Malaysian couples are willing to face fines

imposed by their home states' Islamic councils."

Plans to boost public confidence in government

KUALA LUMPUR: Five key plans under the National Anti-Corruption Strategy (NACS) 2024-2028 are expected to boost public confidence in the government's commitment to establish Malaysia as a

prosperous, corruption-free nation.
The Malaysian Anti-Corruption
Commission (MACC) said these
sub-strategies are instrumental in driving Malaysia towards achieving a top 25 ranking in the Corruption Perception Index by 2033.

The sub-strategies include enhancing governance and internal audit functions within the public service; introducing the Border Control and Protection Agency Act 2024; improving the Integrity and Anti-Corruption Course; implementing the Governance, Integrity and Anti-Corruption Strengthening Module; and fostering education on integrity and ethical practices.

On Wednesday, Chief Secretary to the Government Tan Sri Shamsul Azri Abu Bakar chaired a discussion in Putrajaya focusing on planning and media strategies to enhance public awareness on governance and anti-corruption initiatives under NACS 2024-2028.

The session reviewed policies adopted during National Governance Special Cabinet Committee meetings last year, Bernama reported.

The five key agencies spearheading the implementation of the initiatives are the Public Service Department, the National Audit Department, the Higher Characteristics of the Public Service Department, the Higher Department of the Public Service Department Education Ministry, the Education Ministry and the Home Ministry.

East Coast Rail Link track installed ahead of schedule

KOTA BHARU: The installation of the 400km East Coast Rail Link (ECRL) track from Maran in Pahang to Kota Bharu in Kelantan has been completed two and a half months ahead of schedule, according to Malaysia Rail Link CEO Datuk Seri Darwis Abdul Razak. "This will speed up the construction of

This will speed up the construction of the electrification system, signalling and telecommunications for the 43.86km stretch in Kelantan," he told reporters after inspecting the work on Wednesday.

On ticket prices, he confirmed that the Transport Ministry would announce the fares at the appropriate time.

"Transport Minister Anthony Loke has said ticket prices would be reasonable."

The 665km ECRL project would connect the east coast states of Kelantan, Terengganu and Pahang to Selangor on the west coast.

The line from Kota Bharu to Gombak Terminal is set to be completed in December 2026 and operational by January 2027. – Bernama

Retail prices of RON97 and diesel increase by five sen

KUALA LUMPUR: The retail price of RON95 will remain at RM2.05 per litre while the price of RON97 will increase from RM3.33 to RM3.38 per litre from Jan 16 to 22.

The Finance Ministry said the retail price of diesel in Sabah, Sarawak and Labuan will remain at

RM2.15 per litre while in Peninsular Malaysia, it will rise from RM3.03 to RM3.08 per litre for the same period. It said the increase in global oil

market prices has prompted the government to increase the retail prices of RON97 and diesel.

"The retail price of diesel in Peninsular Malaysia remains lower than the floating price set on June 10, 2024, which was RM3.35 per litre."

The prices are determined using the Automatic Pricing Mechanism formula based on the weekly retail price of petroleum products.

The ministry said the government would continue to monitor global oil price movements and adjust the retail prices of RON97 and diesel accordingly while maintaining price stability.

Calls to address growing food insecurity in Malaysia

PETALING JAYA: As Malaysia grapples with the aftermath of floods that have destroyed over 100ha of farmland in December. experts are calling for measures to address growing food insecurity.

Federation of Vegetable Farmers Association president Lim Ser Kwee said vegetable farms in Johor, Malacca, Perak, Kelantan and Terengganu were damaged by the floods, resulting in a shortage of supply and increased prices of between 50% and 80%.

He said the crops affected included sawi, spinach, cucumber,

tomatoes and lady's fingers. Universiti Utara Malaysia School of International Studies Assoc Prof Dr Bakri Mat said the floods are a

reminder of how climate-related disasters could disrupt food security.

"In the short term, the destruction of farmland has led to a sharp drop in domestic agricultural supply, particularly vegetables. "Such supply chain disruptions

create immediate food insecurity, particularly for low-income particularly for low-income communities that struggle to afford inflated prices."

He said such a situation is concerning when viewed from a national security perspective as Malaysia imports a significant proportion of its vegetables, and over-reliance on global markets amplifies vulnerability to price volatility and supply shocks

"The challenge is compounded by the risk of losing skilled farmers, who might abandon agriculture due to recurring losses.

"Malaysia must focus on building resilience by diversifying food production, investing in research to develop climate-adaptive crops and strengthening policies that protect

sueinguishing pointes that protect smallholder farmers."

Bakri said climate-related incidents highlight the need for proactive disaster preparedness in Malaysia's agricultural sector.

He urged the government to focus on improving early warning

focus on improving early warning systems, localised disaster response and infrastructure development.

Malaysia needs to enhance its

meteorological capabilities and develop digital platforms that provide real-time alerts to farmers through apps or SMS. This could raise awareness among farmers and help them prepare mentally and physically to reduce the overall impact of disasters."

He said financial relief is a critical viscition and implementing critical viscition and implementing critical viscition.

ritical priority and implementing accessible climate insurance schemes, such as index-based insurance, could provide farmers with immediate assistance.

"Providing micro-loans designed for disaster-hit farmers could empower them to rebuild and reinvest in their livelihoods, helping them to recover from losses and adapt to climatic conditions."

He said the rising frequency of extreme weather calls for a complete overhaul in agricultural practice, including better water management and agro-ecological zoning to ensure the crops that are planted suit each region's climate and soil.

Taylor's University Faculty of Social Sciences and Leisure Management senior lecturer Dr Salini Devi Rajendran said food security challenges are intertwined with climate change and systemic inefficiencies.

"The urgency of addressing food security is highlighted by Malaysia's 2.6% year-on-year increase in food prices as of November 2024, the highest

November 2024, the highest increase since December 2023."
She said long-term solutions to prepare agricultural supplies remain inadequate.
She also said farmers remain vulnerable to extreme weather events, leading to frequent yield losses and supply disruptions.

No cuts to Early Schooling Aid, says ministry

KUANTAN: The Education Ministry has said no cuts would be made to the Early Schooling Aid distributed to primary and secondary school students by any party, including the Parent-Teacher Association.

Its deputy secretary-general (management) Datuk Ahmad Suhaimi Endut said the ministry was aware of parental concern regarding the matter, following several submitted complaints.

"The main objective of this government aid is to assist parents and guardians in making early school preparations for their children. Some parents have raised concerns that the aid could be reduced by the school or association.

"With the assurance of the

ministry, we have instructed that the aid not be cut and be fully utilised."

He was speaking at a press conference after the mock cheque presentation ceremony for the cash aid at the State Education Department auditorium

here yesterday, Bernama reported. He said RM39.13 million has been allocated under the programme by

the government to be distributed to 260,904 primary and secondary school students in Pahang.
"The estimated number of recipients in 2025, including from schools under and not under the ministry, is over 5.2 million students, with the students and all sections to the students." with approved allocations totalling RM791.25 million.

"Additionally, RM723.16 million has

been allocated for schools under the been allocated for schools under the ministry nationwide, benefitting 4.82 million students, with Pahang receiving RM39.13 million." The programme, which was first

introduced in 2012 as a one-off cash aid, has been extended to Form Six students, benefitting more than 100,000 students, with a financial implication of about RM15 million.



Search intensifies for mother bear, cub in villages

JERTIH: The Terengganu Department of Wildlife and National Parks is intensifying efforts to capture a mother bear and its cub, which have been spotted roaming around Kampung Beting Lintang in recent days.

Lintang in recent days.

Its director, Loo Kean Seong, said the department has received three complaints from villagers since Nov 3 last year.

"Previously, we set traps twice in the village,

"Previously, we set traps twice in the village, but to no avail. We then moved the traps to Kampung Gong Batu, about 1km from this village, believing the two bears had strayed

"On Wednesday afternoon, we set the traps again in Kampung Beting Lintang after being informed about the presence of the bears, which were detected wandering in the area a few days ago," he said when contacted by Bernama.

Loo said the same bears are believed to have ravaged a stingless bee (kelulut) farming project at Sultan Zainal Abidin University last year. Earlier, the wildlife game of hide-and-seek

Earlier, the wildlife game of hide-and-seek intensified after pictures of an adult black bear and its cub wandering in the village were shared in a Facebook post.

Meanwhile, Kampung Beting Lintang Village Development and Security Committee chairman Abd Wahab Ab Rahman said the bears' presence in recent days has caused unease among villagers.

"The villagers are worried because the animals appear during the day and could pose a threat as they go about their daily routines or while children are playing," he said.

PUTRAJAYA: The Agriculture and Food Security Ministry will organise a mini Malaysia Agricultural, Horticulture and Agrotourism Exhibition (Mini Maha) in conjunction with the 47th Asean Summit.

Agriculture and Food Security Minister Datuk Seri Mohamad Sabu said the event would be held at the Malaysian Agriculture Exposition Park (Maeps) in Serdang, serving as a strategic platform to enhance agro-sector cooperation and relationships among Asean member states.

"This event aims to attract foreign investments, boost exports of local agricultural products and reinforce Malaysia's leadership in food security within the Asean region," he said during a media briefing at the ministry vesterday.

Plea to expedite pension adjustments allowed

▶ High Court judge orders the PSD and government to pay arrears to retired civil servants within three months

KUALA LUMPUR: The High Court here allowed a pension increase for retirees based on their final salary according to the 2016 Public Service Department (PSD) Circular,

Public Service Department (PSD) Circular, effective January 2022. In allowing a judicial review by retired civil servant Aminah Ahmad, Judge Datuk Amarjeet Singh ordered the PSD and the

government to pay the arrears within three months from yesterday.

Federal counsel M. Kogilambigai, representing the respondents, applied orally

for a stay of the ruling but was dismissed.

The judge, however, ordered her to file a formal written application for a stay, so the court could fix a date for a hearing.

Aminah, who retired as a civil servant with the Foreign Affairs Ministry, filed the judicial review application on Jan 12 last year in her capacity and on behalf of 56 retired members of the public service.

She was seeking a mandamus order to compel the respondents to expedite the pension adjustments to the qualifying amount following the formula contained in Sections 3 and 6 of the Pensions Adjustment Act 1980 (PAA 1980) before amendments were made under Sections 3 and 7 of the Pensions Adjustment Act (Amendment) 2013

Aminah also sought an order for the respondents to pay the pension arrears within 14 days, in addition to a declaratory order stating that the failure to pay violates the

Federal Constitution.

Under the old scheme, the retiree's pension is revised based on the prevailing salary of incumbent civil servants in that grade. However, the 2013 amendment was introduced based on a flat rate of 2% annual

Aminah initially lost her case at the High Court in 2020. She then appealed to the Court of Appeal, which decided in her favour. The government and the PSD director-general obtained leave to appeal in 2022, Bernama

On June 27, 2023, the Federal Court affirmed the Court of Appeal's decision that declared the amended pension null and void, and the five-member bench also dismissed the appeal by the government and PSD

director-general to overturn the appellate

court's decision.
On Feb 29 last year, the court allowed Aminah to proceed with the judicial review after the Attorney-General's Chambers did

mot object to the application.

Meanwhile, Amarjeet in his judgment yesterday ruled that the circular had the effect of making salary revisions for government servants, and under the Pensions Adjustment Act 1980, government pensioners are entitled to pensions corresponding to the revision of

their salary.

"An order of mandamus is granted compelling the (PSD) director-general to make corresponding adjustments for the purpose of computing the pensions in favour of the entitled pensioners.

"In view of the decision of the Federal Court (that dismissed the government and PSD's appeal) the backdate pension is to be paid beginning January 2022 (the date of the Court of Appeal's decision that allowed Aminah's appeal) until the next salary

"The backdated payment is to be paid to the entitled pensioners within three months from today (Thursday). No order as to costs," said Amarjeet.

Aminah is represented by counsel Datuk Shukor Ahmad, Datuk Baljit Singh Sidhu and Gurpreet Singh.

Man held for hurting, threatening wife with knife

He was charged with committing the offence at the Prime Minister's Office, Bangunan Perdana Putra, Federal Government Administration Centre in Putrajaya between March 1, 2020 and Aug 20, 2021.

He also faced two charges of receiving money from illegal activities amounting to RM195 million from Bukhary Equity Sdn Bhd, which was

deposited into Bersatu's CIMB Bank account.

M'sian probed over drug smuggling

SINGAPORE: A 21-year-old Malaysian man is under investigation in Singapore for attempting to smuggle drugs worth over \$\$169,000 (RM556,570) into the country, including over 4.6kg of cannabis, on Tuesday, authorities said

yesterday.

The Immigration & Checkpoints Authority (ICA) and Central Narcotics Bureau (CNB) said a total of about 4,648g of cannabis, 542g of "Ice" and 250 Erimin-5 tablets were found concealed in various parts of the man's motorcycle during a stop at the Woodlands checkpoint.

ICA officers discovered a black bundle in the front fairing of the motorcycle before alerting the CNB for further checks on the Malaysia-registered vehicle.

Malaysia-registered vehicle.

"The drugs could potentially sustain about 970 addicts for a week. Investigations are ongoing," they said in a joint statement.

Under Section 7 of the Misuse of Drugs Act

1973, individuals who import or export more than 500g of cannabis or 250g of methamphetamine into or from Singapore may face the death penalty. - Bernama

Police hunt for escaped detainee

TANGKAK: Police are searching for a detained local man who escaped custody at about 1.30pm on Wednesday.

IPOH: At just 20 years of age, Khairin Qisstina Mohamad Syakirin is challenging stereotypes as a mechanic in a male-dominated industry.

industry.

Armed with a Malaysian Skills
Diploma in automotive technology,
she confronts scepticism head-on.

"Can you really fix my car?" is a question she hears often but instead of letting it deter her, it fuels her determination to prove her skill and expertise.

"I've learnt that being a mechanic requires resilience and the ability to remain calm when dealing with customers," she told Bernama in a recent interview.

Khairin Qisstina is the sole female mechanic at MTH Autohaus & Accessories in Taman Pengkalan Jaya.

Standing 165cm tall with a slim build, she understands why customers might question her capabilities.

"It's true my physical strength doesn't match that of men, but I don't let that be an excuse to give up. Beyond my passion for this field, I'm also fulfilling the wish of my late elder brother, who was deeply interested in the automotive industry," she said.

Fondly known as Khai, she credits her late brother Muhammad Aqil Khairin for sparking her interest

in the field.

"My passion began when I was nine years old, as I was often exposed to information about luxury cars and models by my late brother. He aspired to pursue a career in the automotive industry," she said, adding that her brother died over five years ago at the age of 18 due to penjuditie.

meningitis.

A year after his passing, Khairin Qisstina continued her education at Kolej Vokasional Lebuh Cator, earning the Malaysian Vocational Certificate (Sijil Pelajaran Malaysia Vokasional) before pursuing diploma-level studies.

The second of five siblings, she underwent industrial training at her current workplace before being offered a permanent position by her employer.

"It's challenging to prove we are on par with the strength and agility of men. However, I'm grateful for colleagues who are supportive and always willing to guide me," said Khairin Qisstina, who has been a full-time employee at the workshop for just two months.

Born in Ipoh, Perak, Khairin Qisstina said one of the toughest tasks she faces is removing gearboxes from vehicles, particularly Proton models, as the process can take three to four hours due to the weight of the components.

"My colleagues are a great help in this regard," she added, noting that her expertise lies in engine repairs for imported cars, especially Volkswagen and BMW models.

Meanwhile, MTH Autohaus & Accessories owner Mohamad Zaini Ashari, 53, said Khairin's attitude and discipline were key factors in her being hired as a permanent employee.

"From April to October last year, Khai underwent industrial training at our workshop. During that time, I observed that she was not only diligent but also frequently sought advice from other mechanics when facing issues with vehicles under repair.

repair.

"That's what makes Khai stand out. Perhaps through this opportunity, I can give her the career experience she needs to excel further," he said.

Mohamad Zaini also said

Mohamad Zaini also said negative perceptions of women in this field are unwarranted and that support is vital for their success.

"Nowadays, many jobs don't differentiate between men and women. What matters most is passion, diligence and a willingness to learn. These traits ultimately determine a person's success," he said.

Japan 'Megaquake' **PROBABILITY UP TO 82%**

TOKYO: A Japanese government panel said it has raised its estimated panel said it has raised its estimated probability of a "megaquake" to 82% in the next 30 years. Such a jolt could potentially have a devastating 8-9 magnitude, trigger colossal tsunamis and kill several hundred thousand people. The Earthquake Research Committee said it has increased its estimate of the probability to 75-82% from 74-81%. It concerns what is known as a subduction megathrust quake along the Nankai Trough, an 800km undersea gully running parallel to undersea gully running parallel to Japan's Pacific coast. Over the past 1,400 years, megaquakes in the trough have occurred every 100 to 200 years. The last recorded one happened in 1946. – AFP

TAIWAN TIGHTENS PROTECTION OF CABLES

TAIPEI: Taiwan's navy will be on standby to help protect the island's undersea telecoms cables and deal with suspicious vessels. "If there are any suspicious vessel movements in any suspicious vessel movements in the area where undersea cables are distributed, we will coordinate with the coast guard to monitor them," Defence Minister Wellington Koo said. "Once such a situation is discovered, the coast guard will go out first. If the coast guard needs the navy's support, I think we will also go out and coordinate immediately." – AFP

Yoon avoids fresh questioning

SEOUL: South Korea's impeached President Yoon Suk Yeol refused to appear for fresh questioning by investigators yesterday, a day after his dramatic arrest over a failed martial law declaration

The Constitutional Court also opened its second hearing in a trial that will decide whether to uphold Yoon's impeachment, following the dawn raid that made him the country's first-ever sitting president to be detained.

The former star prosecutor, who faces charges of insurrection, was questioned for hours on Wednesday but exercised his right to remain silent before being moved to a detention centre.

Investigators from the Corruption Investigation Office (CIO) were to resume Yoon's questioning yesterday, but his legal team told them he would not

"President Yoon's representatives informed the CIO through his legal counsel that there is 'no change in his position', indicating his intent not to appear," the CIO said in a statement.

Lawyer Yoon confirmed to AFP the embattled leader would not attend, without specifying the reason, but said it was for health reasons.

"President Yoon is not well and fully explained his position yesterday so there is nothing more to be interrogated about," Yoon Kab-keun said.

Officials were trying to secure a new warrant that could hold him for longer than 48 hours.

If investigators successfully obtain that warrant, they are expected to be given a 20-day extension to the leader's detention to allow time to formalise an

indictment against him.
South Korea's opposition Democratic
Party celebrated Yoon's detention, while the parliament speaker said it was time to stabilise the country after weeks of

But Yoon's lawyers have filed for a review of the arrest warrant. - AFP

Rescuers evacuate thousands after Mount Ibu erupts

Maluku volcano triggers highest alert

TERNATE: Hundreds of islanders have been evacuated, with thousands more awaiting their turn following increased volce eruptions in eastern Indonesia. volcanic

Mount Ibu on the remote island of Halmahera in North Maluku province erupted on Wednesday, sending a column of smoke up to 4km into the sky.

The volcano's alert status was raised to the highest level by

Indonesia's Geological Agency, prompting local authorities to call for the evacuation of 3,000 people living nearby.
As of yesterday morning, 517

residents from the village closest to the volcano had been evacuated, with the remaining residents scheduled to be moved later in the afternoon.

"The evacuation shelters have been prepared by the local administration, and today a thorough evacuation will be conducted for all residents in six villages," said a spokesman of local disaster management agency, Irfan

He said evacuations began on Wednesday but were delayed due to administrative and logistical issues.

Rainfall since yesterday morning further hampered the process, he

According to an AFP reporter, residents were still carrying out their daily activities in their villages

as lorries prepared for evacuation.
"Of course, there is some fear
and concern, but we are used to the eruptions," 32-year-old resident Rista Tuyu said.

"In a week, eruptions could happen three to four times, but the biggest ones occurred this week," she said.

She said she hoped the volcano would calm down soon so the village community could resume their daily lives.

Mount Ibu has shown a

significant increase in volcanic activity since last June, following a

series of earthquakes.

In the first weeks of January, the

volcano erupted nine times. Residents living near Mount Ibu and tourists have been advised to avoid a 5-6km exclusion zone around the volcano's peak and to wear face masks.
As of 2022, around 700,000

people were living on Halmahera island. - AFP



Bollywood star Saif out of danger after surgery

MUMBAI: Bollywood star Saif Ali Khan was stabbed repeatedly by an intruder at his home here yesterday, but doctors treating him said he was

out of danger after surgery.

Khan, 54, was "on the path to complete recovery" after receiving stab wounds on his spine, neck and

hand, the doctors told reporters.

"He sustained a major injury to the thoracic spinal chord due to a lodged knife in the spine. Surgery was performed to remove the knife and also repair the leaking spinal fluid," said Nitin Dange, one of the doctors operating on Khan.

Khan was attacked just after midnight when he tried to stop the intruder, believed to be a burglar, from entering his apartment in the upscale neighbourhood of Bandra, police said.

A female employee at the apartment was also attacked and

was being treated. Khan is the son of India's former cricket captain Mansur Ali Khan Pataudi and actress Sharmila Tagore. He is married to actor Kareena Kapoor, and his daughter from a previous marriage, Sara, is also a Bollywood actor.

Police have identified the perpetrator and launched a search for him, senior police official Dikshit Gedam said. "The accused attempted to enter through a fire escape. It appears to be a robbery attempt."

Khan, who has featured in more than 70 films and television series, is a regular on the red carpet. He and Kapoor have two young sons and are one of Bollywood's most wellknown couples.

Khan has acted in several notable films and series, including Sacred Games, Netflix's first Indian

production, which released in 2018. Film stars and opposition leaders called for police to beef up security

measures in the city.

"If such high-profile people with
... security can be attacked in their

... security can be attacked in their homes, what could happen to common citizens?" said Congress Party spokesperson Clyde Crasto. Actor and filmmaker Pooja Bhatt also called for a greater police presence in the suburb.

"The city, and the queen of the suburbs, have never felt so unsafe, she said, using a popular description for the trendy Bandra area. - Reuters



Biden warns of 'oligarchy' in dark farewell speech

Now it's your turn to stand guard, Americans told

WASHINGTON: US President Joe Biden urged Americans on Wednesday to stand guard against a "dangerous" oligarchy forming under Donald Trump as he delivered a dark farewell

address before stepping down next week.
In a primetime speech from the Oval Office at the end of his single term in office, he warned of an ultra-wealthy "tech industrial complex" that he said could gain unchecked power over the American people.
"Today, an oligarchy is taking shape in

America of extreme wealth, power and influence that literally threatens our entire democracy, our basic rights and freedoms,

democracy, our basic rights and freedoms, the 82-year-old Democrat said.

Biden began his speech by touting the legacy of his four years in office, saying it may take time to feel the benefits but that the "seeds were planted" for Americans in the future.

But he soon turned to painting a series of dangers that he said were facing the United States, which clearly referred to billionaire Trump's close ties to the world's richest man,

Elon Musk, and other tech tycoons.

Biden warned there was a "dangerous concentration of power in the hands of a very few ultra-wealthy people" with "dangerous consequences if their abuse of power is left unchecked".

He then lashed out at social media firms,

with Musk having turned X into a right-wing megaphone and Meta boss Mark Zuckerberg ending fact-checking operations in the US as he courts Trump.

"Americans are being buried under an avalanche of misinformation and disinformation," said Biden.

disinformation," said Biden.

"The free press is crumbling. Editors are disappearing. Social media is giving up on fact checking. The truth is smothered by lies told for power and for profit."

He recalled a stark warning issued by president Dwight Eisenhower in his own farewell address in 1961 about the dangers of an out-of-control military industrial complex.

"I'm equally concerned about the potential

"I'm equally concerned about the potential rise of a tech industrial complex."

He also cautioned over the rise of AI, saving that America must take the lead over China on

the transformative technology.

Biden finished by sounding a valedictory tone at the end of a 50-year political career that has seen the former senator mount several failed presidential bids before becoming Barack Obama's vice-president, and finally rising to the top himself.

"It's been the highest honour of my life to lead you as commander in chief," said Biden.

Signing off as Trump returns for a second term on Monday, Biden told Americans: "Now

it's your turn to stand guard."
In emotional scenes, First Lady Jill Biden,

son Hunter and Vice-President Kamala Harris were in the Oval Office as Biden delivered his

political swansong.

After the speech, Biden kissed and hugged members including his young grandson Beau.

But the dark address was a stunning shift in tone from Biden, who had largely toned down his criticisms of his rival after the election in pursuit of what he called a smooth transition.

Instead, America's oldest ever president has spent much of his final months in office trying to burnish his legacy. - AFP

China cheated its way to power, says Trump nominee

WASHINGTON: Marco Rubio, Donald Trump's nominee for secretary of state, charged on Wednesday that China cheated its way to superpower status and vowed to cast aside the "liberal world order" long promoted by the United States.

Rubio faced fellow senators at confirmation hearing that, other than expected interruptions by protesters, was set to be among the least contentious appearances for Trump's motley array of nominees.

The longtime hawk opened by taking aim at China, which President Joe Biden called a competitor but nevertheless sought to engage. Rubio rejected a key tenet of Biden's foreign

policy – prioritising a rules-based, US-led "liberal world order" – in favour of Trump's belief in "America First".

"The postwar global order is not just obsolete; it is now a weapon being used against us," Rubio said.

"We welcomed the Chinese Communist Party into this global order. And they took advantage of all its benefits. But they ignored all its obligations and responsibilities.

"Instead, they have lied, cheated, hacked and stolen their way to global superpower status, at our expense.

While highlighting China, Rubio's remarks said that in "Moscow, Tehran and Pyongyang, dictators sow chaos and instability".

He also said that the next US administration

would seek "bold diplomacy" with a goal of ending Russia's invasion of Ukraine.

Rubio called for a foreign policy driven solely by whether decisions make the United States safer, stronger and more prosperous.

"While America often continued to prioritise the 'global order' above our core national interests, other nations continued to act the way countries always have and always will, in what they perceive to be in their best interest."

Rubio, the son of working-class Cuban immigrants, would become the first Hispanic and first fluent Spanish speaker to be the top US

Little controversy surrounds Rubio, a three-term senator generally well-liked by his colleagues and known for his ease in public

He clashed bitterly with Trump when he challenged him for the 2016 nomination – with the future president mocking him as "Little Marco" - but he has come back into good

He is expected to get to work quickly, with sources saying preparations are under way for an immediate four-way meeting on Tuesday in Washington with Rubio's counterparts from the Ouad: Australia, India and Japan.

The Quad has long been seen by China as a US-led platform for the four democracies to encircle it, despite Quad leaders' denials. - AFP

Delhi spook faces legal action

NEW DELHI: A panel investigating Washington's accusations of Indian involvement in a foiled murder plot on US soil against an activist had recommended legal action against an unnamed person.

The US has been pushing India to look into the Justice Department's claim that an unnamed Indian intelligence official directed plans to assassinate dual Canadian-American

citizen Gurpatwant Singh Pannun in 2023.

The Home Ministry said on Wednesday that the committee had looked into activities of "some organised criminal groups, terrorist organisations, drug peddlers, etc, who undermined the security interests of both India and the US".

India and the US".

India has said little publicly since announcing in November 2023 it would investigate the claims, and has separately continued a diplomatic dispute with Canada over the June 2023 assassination of another

The committee has "recommended legal action against an individual, whose earlier criminal links and antecedents also came to notice during the inquiry", the ministry said in a statement.

It did not elaborate further on the identity of the person, but said the committee also asked for legal action to "be completed expeditiously'

The US welcomes "this constructive first step and looks forward to seeing legal action taken in the Indian system", White House National Security Council spokesperson Sean Savett said

The US Department of Justice had charged Vikash Yadav, an ex-Indian intelligence official, with leading the 2023 plot to murder Pannun. The US indictment was unsealed in October.

A lawyer representing Yadav declined to comment on the report. - Reuters

Red flag wildfire warnings expire

LOS ANGELES: Red flag warnings advising of extreme wildfire danger expired across the Los Angeles area late on Wednesday, but forecasters warned that dry and windy conditions persist, and that the threat of blazes remained.

The National Weather Service said the respite for fire-ravaged Los Angeles will be short, with high chances for renewed Red Flag warnings – when ideal fire conditions of high winds and low humidity dominate –

starting again on Sunday.
Some 6.5 million people remained under a critical fire threat, after the fires consumed an area nearly the size of Washington, DC resulting in at least 25 deaths so far.

Firefighters on Wednesday confronted persistently strong and dry winds fuelling two giant wildfires that have terrified Los Angeles for eight days, testing the resolve of a city upended by the worst disaster in its

Officials urged residents to remain vigilant and be prepared to evacuate at a moment's notice. "Be prepared to leave," County

Supervisor Lindsey Horvath said.

The fires have damaged or destroyed more than 12,000 homes and other structures, and forced as many as 200,000 people from their homes. Some 82,400 people were under evacuation orders and another 90,400 faced evacuation warnings as of Wednesday, County Sheriff Robert Luna

neighbourhoods have

levelled, leaving smoldering ash and rubble. Some 8,500 firefighters from the western United States, Canada and Mexico have kept the fires in check for three days. - Reuters

DOHA: Israel intensified strikes on Gaza hours after a ceasefire and hostage release deal was announced, residents and authorities in the Palestinian enclave said, and mediators sought to quell fighting ahead of the truce's start on

The complex ceasefire accord between Ine complex ceasetire accord between Israel and Hamas, which controls Gaza, emerged on Wednesday after months of mediation by Qatar, Egypt and the US and 15 months of bloodshed that devastated the coastal territory and inflamed the Middle East.

The deal outlines a six-week initial ceasefire with the gradual withdrawal of Israeli forces from the Gaza Strip, where tens of thousands have been killed. Hostages taken by Hamas would be freed in exchange for Palestinian

prisoners held by Israel.
At a news conference in Doha, Qatari Prime Minister Sheikh Mohammed bin Abdulrahman Al Thani said the ceasefire would take effect on Sunday. Negotiators are working with Israel and Hamas on steps to implement the agreement, he said.

"This deal will halt the fighting in Gaza, surge much-needed humanitarian assistance to Palestinian civilians, and reunite the hostages with their families after more than 15 months in captivity," US President Joe Biden

His successor, Donald Trump, takes office on Monday and claimed credit for the breakthrough in Gaza.

breakthrough in Gaza.

Israel's acceptance of the deal will not be official until it is approved by its security Cabinet and government.

The accord was expected to win approval

despite opposition from some hardliners in Israeli Prime Minister Benjamin Netanyahu's

Coalition government.

While people celebrated the pact in Gaza and Israel, Israel's military escalated attacks after the announcement, the civil emergency service and residents said

Heavy Israeli bombardment, especially in Gaza City, killed 32 people late on Wednesday, medics said. The strikes continued early yesterday and destroyed houses in Rafah in southern Gaza, Nuseirat in central Gaza and in northern Gaza, residents said.

There were no reports of Hamas attacks on

A Palestinian official close to the ceasefire negotiations said mediators were seeking to persuade both sides to suspend hostilities ahead of the ceasefire going into effect.

In social media posts, some Gaza residents urged Palestinians to exercise extra caution in the belief Israel could step up attacks in the next few days to maximise gains before the ceasefire starts.

humanitarian assistance to Gaza, and the UN and the International Committee of the Red Cross said they were preparing to scale up their aid operations.
"A ceasefire is the start - not the end. We have

food lined up at the borders to Gaza – and need to be able to bring it in at scale," said World Food Programme executive director Cindy McCain.

Biden and Trump both claimed credit for the deal that was months in the making but was

deal that was months in the making but was helped across the line by a Trump emissary. Trump's Middle East envoy Steve Witkoff was in Qatar along with White House envoys for the talks, and a senior Biden administration official said Witkoff's presence was critical to reaching a deal after 96 hours of intense negotiations. Biden said that the two teams had "been

speaking as one".

Negotiations on implementing the second phase of the deal will begin by the 16th day of phase one, and this stage was expected to include the release of all remaining hostages, a permanent ceasefire and the complete

withdrawal of Israeli forces from Gaza.

The third stage is to address the return of all remaining dead bodies and the start of Gaza's reconstruction. - Reuters



US issues fresh round of sanctions against Russia

WASHINGTON: The United States on Wednesday imposed hundreds of sanctions targeting Russia, seeking to increase pressure on Moscow in the Biden administration's final days and protect some sanctions previously imposed.

The US State and Treasury departments

imposed sanctions on over 250 targets, including some based in China, taking aim at Russia's evasion of US sanctions and its military industrial

As part of the action, the Treasury imposed new curbs on almost 100 entities that were already under sanctions, potentially complicating any future efforts to remove the

Russia's embassy in Washington did not immediately respond to requests for comment.

The Treasury said Washington was imposing fresh sanctions on almost 100 critical Russian entities – including Russian banks and companies operating in Russia's energy sector – that were previously sanctioned. It said the move increases secondary sanctions risk for them.

The new sanctions are issued under an executive order that a senior Treasury official said requires Congress to be notified before any of the actions can be reversed. It was unclear how Donald Trump, who

succeeds President Joe Biden on Monday, will approach the issue of sanctions on Russia. Trump has been friendly towards Russian President Vladimir Putin in the past and said on Monday that he would aim to meet quickly with him to discuss Ukraine.

discuss Ukraine.

When asked about his strategy to end the war,
Trump told Newsmax: "Well, there's only one
strategy and it's up to Putin and I can't imagine
he's too thrilled about the way it's gone because it hasn't gone exactly well for him either."

Washington also took action against a

sanctions evasion scheme established between actors in Russia and China, targeting regional clearing platforms in the two countries that it said have been working to allow cross-border payments for sensitive goods

The Treasury said several Russian banks under

US sanctions were participants.
"China firmly opposes any illegal unilateral sanctions and long-arm jurisdiction," said Liu Pengyu, spokesperson for the Chinese embassy in Washington.

"The normal economic and trade exchanges between China and Russia should not be interfered with or disrupted, and should not be used as a tool to smear and contain China.

Also hit with sanctions on Wednesday was Keremet Bank, a Kyrgyzstan-based financial institution the Treasury accused of coordinating with Russian officials and a bank identified by the

United States as circumventing sanctions.

The US State Department also imposed sanctions on Russian-held Zaporizhzhia nuclear power plant, the largest in Europe.

It is shut down but needs external power to eep its nuclear material cool and prevent a meltdown.

The sanctions will not affect its operations, Russian news agencies reported on Wednesday.

Glimmer of hope amid dire humanitarian crisis

KUALA LUMPUR: The ceasefire between Israel and Hamas has been hailed by israei and Hamas has been halled by some as a step towards ending the bloodshed and offering a glimmer of hope for Gaza, while others remain sceptical, warning that it may not lead to

lasting peace.
Senior Researcher at the Hashim Sani Centre for Palestine Studies at Universiti Malaya, Prof Dr Mohammed H. Alaqad, said the ceasefire was a temporary pause rather than a solution to the conflict.

According to Alaqad, a Palestinian himself, Hamas' decision to agree to the ceasefire was not a sign of weakness but rather a step to protect the people of Gaza, who have endured relentless bombings, destruction and hardship. "Hamas made this decision to protect

the people, not because they're pressured by anyone. Our people in Gaza

have suffered enough.

"This ceasefire is a moment to breathe and to let our people heal. This is not surrender, it's a calculated move," he said.

Hospitals are overwhelmed and the blockade continues to suffocate the

population.

"As long as the blockade remains, our people are still suffocating."

"Rebuilding Gaza's infrastructure requires more than a few days of quiet."

"Homes, schools, and hospitals are in ruins. Electricity is scarce, clean water is limited and every day of this siege makes

survival harder."

He called for the urgent lifting of the

"Our people deserve more than temporary aid, they deserve justice, freedom and a future without

He said that while countries like Egypt and Qatar may have played a role in brokering the ceasefire, Hamas makes decisions based on the needs of the people, independent of foreign influence.

"Resistance is rooted in the right to liberate our land and preserve our dignity," he said, noting that Qatar's support is aimed at rebuilding Gaza rather than dictating Hamas' actions.

"Every time we've agreed to a ceasefire, hoping the world would finally step in and force real change, we've been

met with lies and broken promises.

"If they think this ceasefire means we've given up, they're wrong. We are more determined than ever." – Bernama

Internet's Wild West reality

THE idea of rules and regulations may not necessarily sit well with all of us. After all, they involve a degree of restriction of freedom.

At the same time, how can a society function without regulations? They are needed to ensure health and safety standards, quality control in many technical fields and even safeguard liberty.

Without regulations, the internet is like the Wild West – an environment where outlaws can prosper. That is why it is important to adopt social media licensing laws and hold tech giants accountable when they provide an avenue for the unscrupulous to rip away a

pensioner's lifetime savings.
I urge Malaysia to take a leaf from Australia's playbook. On Jan 3, Financial Services Minister Stephen Jones drafted a law that would impose massive fines and compensation of up to A\$50 million (RM130.30 million) on tech giants, banks and telcos for failing to protect scam victims

This is part of Australia's Scam Prevention Framework designed to hold them accountable.

One trigger for this was that Australians were losing more than AS2.7 billion a year to scammers, with losses originating from social media platforms increasing substantially. Under this proposed law, the

companies will have to show that they introduced additional checks and balances to prevent funds from being transferred as part of the scam.

This is also relevant in the local context, with the implementation of the Social Media Licensing Framework, which saw four major media and messaging

platforms come on board with the licensing, effective from Jan 1. In supporting its implementation,

Petaling Jaya MP Lee Chean Chung highlighted that he had assisted many scam victims and that it was a widespread problem that needed to be addressed.

'Total financial losses under #ScamVictimSupport has exceeded RM10 million while some still suffer post-scam traumas after years. Simply put, we need the platforms to take more accountability and responsibility to improve safety and security in the digital world," he said earlier this month.

It is encouraging to see the participation of WeChat, Telegram, TikTok and Meta in this initiative although there remain two notable companies that have yet to comply with the licensing applications and requirements.

Kota Malacca MP Khoo Poay

Tiong also backed the move by the Malaysian Communications and Multimedia Commission (MCMC), saying that the framework addressed pressing challenges, including online safety, content regulation and the ethical use of social media platforms while safeguarding users' freedom of expression.

He called on Google, as the parent company of YouTube, to engage constructively with the MCMC to resolve any outstanding concerns.

Meanwhile, Segamat wieariwinie, segamat MP Yuneswaran Ramaraj, a third backbencher, urged social media platform X to apply for the mandatory licensing based on goodwill, after the platform stated it had not met the minimum threshold of eight million users.

In 2023 alone, over 34,000 online

scam cases in Malaysia resulted in financial losses exceeding RM1.2 billion.

Senior citizens and pensioners are particularly vulnerable as they are a group that often have large savings and are not familiar with

technology.
The Malaysian Anti-Corruption
Commission (MACC) also pointed out recently that as cryptocurrencies gain prominence as an alternative to traditional currencies, they have also become a new tool for criminals to

decinite a new tool for criminals to facilitate illegal activities.

On Jan 4, MACC Chief Commissioner Tan Sri Azam Baki said corruption is evolving from traditional methods to more sophisticated operations, including the use of digital technologies and cryptocurrencies like Bitcoin and Ethereum, to conceal financial trails.

As such, several MACC officers have undergone specialised training in cryptocurrency investigations, in addition to the commission establishing close collaboration with the Digital Forensic Working Group and Interpol to bolster its

The truth is that if the relevant authorities do not move to clamp down on the many unchecked digital avenues that facilitate cybercrimes, they will continue to thrive in our country. Like it or not, rules and

regulations are needed to safeguard Malaysians from criminals who use the online world as a vehicle for

Aerotrain delay highlights urgency for MAHB privatisation

I REFER to recent reports on the indefinite delay of the Kuala Lumpur International Airport's (KLIA) Aerotrain services, which were initially set to resume by the end of the month. This delay has drawn criticism from Transport Minister Anthony Loke

The delay comes in the context of plans to privatise Malaysia Airports Holdings Berhad (MAHB), which operates 39 airports in the country. MAHB is nearing a 90% acceptance threshold for its takeover by the Alliance Gateway Development Allian (GDA), a move I hope will proceed.

KLIA, once a national pride, has seen its global ranking drop from the second-best airport in 2001 to 71st

The delay in the Aerotrain's return. alongside deteriorating facilities like washrooms and long immigration queues, highlights the urgent need for change.

Competing airports, such as

Singapore's Changi and Bangkok's Suvarnabhumi, have invested heavily in modernisation, leaving KLIA and others behind.

The RM11-per-share offer by GDA

is fair to shareholders and provides an opportunity to rebuild MAHB without burdening taxpavers

The consortium, including the Employees Provident Fund, Abu Investment Authority and Global Infrastructure Partners, has the financial and technical expertise to turn things around.

Privatisation is crucial to restoring KLIA's global standing, especially

with Malaysia chairing Asean. World-class airports will enhance tourism, business and investment. The challenges facing MAHB are longstanding, and I hope this deal provides the much-needed solution for Malaysia's airports to once again lead the region.

Simplified R&D tax incentive system in the works

PUTRAJAYA: A significant simplification of the nation's research and development (R&D) tax incentives, alongside reformation of the grant system, will be included in the 13th Malaysia Plan (13MP), according to Economy Minister Datuk Seri Rafizi

He said the changes aim to address long-standing concerns about the complexity and accessibility of existing mechanisms supporting innovation and business growth.
"The new R&D tax incentive

framework will streamline processes, removing unnecessary bureaucratic hurdles that have deterred businesses, particularly small and medium enterprises, from fully benefiting from such schemes.

The focus is on making the system user-friendly, ensuring that businesses can easily understand and claim these incentives," Rafizi said at a 13MP engagement session

with industry players yesterday.
In addition to the tax incentive reforms, a comprehensive overhaul of the grant system will be included Grant framework will also be overhauled under 13th Malaysia Plan to ensure businesses fully benefit from such schemes: Rafizi

in the plan, Rafizi disclosed. "This initiative seeks to reduce the layers of complexity that cur-rently hinder businesses from accessing critical funding. By simplifying application processes and eligibility criteria, the government aims to foster a more inclusive and efficient allocation of re-

Rafizi said the reforms are part of a broader strategy to enhance the nation's competitiveness in the global market while ensuring that public resources are effectively utilised.

"The new measures will include clearer guidelines and improved communication with stakeholders, ensuring businesses understand how to navigate the updated systems. The goal is to build trust and confidence among businesses that these incentives and grants can

deliver meaningful support," he

Rafizi said businesses and industry groups have long advocated for such reforms, pointing to the barriers posed by overly com-plicated processes. "These updates are expected to alleviate frustrations and encourage broader participation across sectors."

The government will release further details on the implementation timelines and specific changes to the R&D tax incentives and grants soon.

Despite allocating more than RM1 billion annually for R&D, Rafizi noted, there remain significant gaps in translating research into market-ready innovations.

He shared that his ministry, alongside the Ministry of Investment, Trade and Industry, is working on a comprehensive plan

also enhance R&D commercialisation, and foster collabora-tion among academia, public institutions and the private sector. "This initiative, expected to be presented to the Cabinet within the

next few months, will play a crucial role in positioning Malaysia as a leader in high-value industries and global competitiveness," he added.

Furthermore, Rafizi said, the 13MP will not only focus on reforming R&D tax incentives and the grant system but also address broader systemic challenges to strengthen the country's economic structure.

"We are taking a sector-specific approach to economic reform, including energy transition plans under the National Energy Policy. These reforms aim to create a robust foundation for Malaysia's economic growth and its ability to adapt to global changes."

The minister said one key focus is optimising Malaysia's supply chain and logistics system, pointing out that inefficiencies in the supply chain, such as the high logistical costs of moving goods across regions unnecessarily, have hindered economic efficiency.
"By investing in infrastructure,

data systems, and regulatory frame-works, the government plans to enable regional distribution systems that minimise costs and improve transparency in pricing. These efforts are part of a broader strategy to streamline the movement of goods and ensure consistency in the supply chain," he

Rafizi also said SMEs face

Ralizi also salu Sivilis lace challenges in scaling up and integrating into larger value chains. "Efforts to strengthen the SME sector will focus on addressing structural barriers and creating opportunities for growth, ensuring that SMEs continue to drive innovation and economic resilience," he added.

Liew: US's Tier 2 designation of M'sia unlikely to impact existing data centres

KUALA LUMPUR: Malaysia's position as a Tier 2 nation under the United States' new artificial intelligence (AI) chip export restrictions is unlikely to impact existing data centres, said

Deputy Investment, Trade Industry Minister Liew Chin Tong. He also said Malaysia will engage with the incoming Trump 2.0 admini-stration in the US to understand the

and

extent of the regulation. "As far as we understand, it has no impact on the existing data centres.

But what sort of impact you will have on future arrangements, we will wait and see," he told reporters at the CEO Series 2025 Rehda's Annual Property Developers Conference yesterday.

Besides waiting to engage with the

incoming US administration, Liew said, the government will engage

with internal stakeholders.
"Noting that Malaysia is together with many other countries in Tier 2, there are ways to deal with it," he said.

The outgoing Biden administration has introduced a directive aimed at maintaining the United States' leadership in Al technology by enforcing restrictions on AI chip exports.

Under the regulation, countries are categorised into three tiers: Tier 1 nations, such as Japan and the United Kingdom, enjoy unrestricted chip access; Tier 2 nations, including Malaysia and Singapore, face certain limitations; and Tier 3 nations, like China and Russia, are completely barred from accessing US chip tech-

nology.

The directive aims to prevent Tier 3 nations from circumventing re-strictions by using cloud computing services in other regions. To address this, US companies are restricted to

50% computing power abroad, with tight

caps on allocations to Tier 2 countries.
In his address, Liew said Malaysia's industrial parks have become too much of a real estate play, which is not helpful for the nation.

With the cost of hiring foreign

workers rising, he stressed the need to retain local talent. "Instead of building CLQs (com-pany-leased quarters) for foreign workers, we want to see more decent housing for young Malaysian engi-

Liew said industrial parks can play

a constructive role to bridge the pay

gap between Malaysia and Singapore.
"Say we pay Malaysians 50% of Singapore pay but housing in industrial parks is very affordable, it is almost equal to two-thirds of Singapore pay too," he added.

It said CRESS represents the government's initiative to provide ontions for and broaden

initiative to provide options for and broaden access to green electricity supply to interested consumers of electricity, enabling corporate companies in Peninsular Malaysia to meet their environmental, social, and governance (ESG) commitments via the electricity supply aspect. The ministry said several improvements will be made to the current CRESS programme

starting March 1, 2025, to strengthen its implementation and enhance access to green electricity supply.

"This includes opening the scheme to existing electricity consumers who wish to obtain green electricity supply directly from renewable energy generators and maintaining the set System Access Charge for three years based on the regulatory period of the Incentive Based Regulation," it said. – Bernama

Jetro: Sentiment among Japanese businesses in M'sia continues to improve

KUALA LUMPUR: Business sentiment among Japanese companies in Malaysia has improved for the fourth consecutive year, even as competition intensifies, according to the Financial Year 2024 Survey by the Japan External Trade Organisation Kuala Lumpur (Jetro).

that the percentage of companies expecting an improvement has increased in all countries compared to 2024, with Malaysia's forecast showing a slight increase to 41.9%

The survey also revealed that the percentage of companies considering business expansions in the next one to two years remains at 48.9%. -

HDC aims to increase Malaysia's halal exporters to 2,443 in 2025

KUALA LUMPUR: Halal Development Corporation Bhd (HDC) targets 2,443 halal exporters from Malaysia this year, compared

to 1,600 as of December 2024.

HDC is a central agency advancing Malaysia's halal ecosystem under the Ministry of

Investment, Trade and Industry. Its CEO Hairol Ariffein Sahari said HDC will continue to intensify efforts to identify potential local companies in the halal sector.

He said that Malaysian companies face challenges in becoming halal exporters, including the lack of a "halal compliance manager" responsible for developing halal operational the

frameworks, the ability to identify potential halal markets, and wait-and-see

attitude.
"Such companies must also have market intelligence to ensure they have a clear direction and strategy in the halal economy, as well as guidance

exporting their products internationally," Hairol Ariffein told reporters after hosting an exclusive media briefing to the editors, focusing on the halal economy and its significance to Malaysia yesterday.

He noted that over 200,000

local companies are now engaged in halal-related business activities. As of December last year, only 9,162 companies across various segments held halal certification from the Department of Islamic Development Malaysia (Jakim).

Of these 9,162 companies, only 1,600 are halal exporters, which is still considered low compared to the global halal market demand, which now exceeds US\$3 trillion (RM1.3 trillion), said Hairol Ariffien.

Touching on Malaysia's Asean chairmanship this year, HDC

chairman Khairul Azwan Harun said Malaysia would assist other member countries in developing halal ecosystems in their countries, in addition to improving bilateral trade between Malaysia and Asean counterparts.
"In Asean, we have more than

650 million people. We must grab this opportunity for the 10 Asean member countries to benefit from the halal economy. We should not let other countries outside Asean profit exponentially from the halal market," he said.

Khairul Azwan added that in line with Malaysia's chairmanship of Asean this year, HDC would collaborate with agencies such as the



Malaysia External Trade Development Corporation and Jakim to continue promoting Malaysia's halal products to other countries.

The agency stated that it is committed to focusing on halal innovation excellence this year, crucial for making Malaysia a global leader in the halal economy.

This commitment is part of the Halal Industry Master Plan 2030, which outlines strategic initiatives to enhance growth and competitiveness in the halal sector.

HIMP 2030 emphasises the importance of promoting six key halal sectors including food, cosmetics and personal care, pharmaceuticals, medical devices, tourism, and modest fashion, to strengthen Malay economy. – Bernama Malaysia's

Secure AI by Design: Building AI systems with security from the ground up ensures protection from the design phase to deployment, minimises data exposure, and enhances compliance with regulations.

Simplify and Optimise with GenAI: Generative AI 'Copilots' can empower security teams with enhanced threat detections, enhanced threat detections, automating security measures, actionable insights, and guided actions, improving efficiency and response times response times

By adopting these strategies, Lee said organisations can safeguard their operations and contribute to a

more secure and resilient digital ecosystem, further enhancing Malaysia's appeal as a trusted hub for data centre investments

"As Malaysia cements its position as a regional data hub, the imperative for robust cybersecurity measures grows in tandem with the sector's expansion. The recently passed cybersecurity bill represents a crucial step towards creating a safer digital ecosystem, setting the stage for Malaysia's data centres to power the digital economy securely and sustainably.

"However, legislation alone is insufficient; organisations must adopt a proactive stance, leveraging cutting-edge technologies like AI and machine learning to fortify their defences.

"As the data centre sector continues to grow. driven by investments in AI, cloud computing, and digital transformation, the synergy between technological advancement and security will be critical," said Lee.

By embracing a holistic approach to cybersecurity, she said Malaysia not only protects its blooming data centre industry but also enhances its reputation as a trusted digital hub on the global stage.

the growth opportunities from the JS-SEZ in 2025," he said at the CEO Series 2025 of Rehda's Annual Property Developers Conference yesterday. Ng said Johor's infrastructure investments

and the influx of FDI will benefit not just Johor

but the broader Malaysian economy.

"The SEZ is anticipated to create 20,000 high-value jobs by 2027, positioning Johor as a

gateway for global investment into Asean. which will have a positive spillover effect on the overall economic development."

In addition, he said Johor Forest City's designation as a Special Financial Zone (SFZ) brings additional tax incentives, including a reduced corporate tax rate of 15% for qualified

investors and businesses.

STOXX 50 futures and UK FTSE futures were 0.3% higher.

Investor focus in Europe will be on luxury firms and chipmakers following strong earning from Cartier jewellery owner Richemont and Al chipmaker Taiwan Semiconductor Manufacturing

On Wall Street on Wednesday, all three major indexes registered their biggest daily percentage gains since Nov 6 – the day after the US presidential election.

Asian stocks followed suit vesterday, with MSCI's broadest index of Asia-Pacific shares outside Japan

The relief rally in risk assets stemmed from a benign US inflation report that showed the consume price index rose in line with expectations at an annual rate of 2.9% in December, while core inflation, which excludes food and energy prices, rose by 3.2%, below forecasts for 3.3%

Investors were encouraged by the inflation reading, particularly since data released on Tuesday showed that US producer prices had increased moderately in December.

'We anticipate a shallow FOMC easing cycle, although we think short-term hawkishness is overdone," Eric Robertsen, Standard Chartered's global head of research and chief strategist at a media

roundtable in Singapore.
"We see a higher USD, though the path is expected to be volatile," said Robertsen, noting that US economic strength will be tested if tariffs imposed by the incoming administration lead to weaker growth in other regions.

Japan's yen remained on the charge, hitting its highest in nearly a month after comments from Governor Kazuo Ueda as traders priced in a more than 70% chance the Bank of Japan will raise interest rates next week.

"While we expect the normally cautious Ueda to wait for clarity on US trade policy and confirmation of strong wage growth until the BOJ's March meeting, we acknowledge a hike is possible next week," said Joseph Capurso, head of international economics at the Commonwealth Bank of Australia.

The yen was last slightly stronger at 156.22 per dollar while the euro was steady at US\$1.0285. - Reuters

Philippine minister says no need to hike rice imports

MANILA: The Philippines sees no need to increase rice imports for now although there are concerns now although there are concerns about the prices businesses are charging consumers for the national staple, the agriculture minister said yesterday.

Francisco Tiu Laurel said the government would consider a recommendation from the national

price council to declare a "food emergency" and release buffer stocks to help bring down retail

prices.
"The current level of prices is extraordinary," Tiu Laurel told a briefing, adding it was due to profiteering.
"There's no need to increase rice imports. We just have to towner the buringerment to make

temper the businessmen to make their prices reasonable while still

maintaining profitability."

The Philippines is expecting to import around 4.3 to 4.5 million metric tons of rice this year, lower than 2024's 4.7 million metric tons.

The annual rate of increase in rice prices in the Philippines hit a 15-year high of 24.4% in March last year, but has since moderated to 0.8% in December, helping keep overall inflation for 2024 within the

government's 2% to 4% target. Last year, the Philippines lowered tariffs on rice and extended existing tariff cuts on some other commodities to combat inflation and ensure ample supply. - Reuters

Pakistan lowers EV charging tariff by 45%

ISLAMABAD: Pakistan will cut the power tariff for operators of electric vehicle (EV) charging stations by 45% as part of the ongoing reform of the energy sector designed to boost demand, Energy Minister Awais Leghari said on Wednesday.

A sustained economic crisis has

slashed power consumption, leaving the South Asian nation with excess capacity that it still needs to pay for under decade-old contracts with independent power producers.

"The success of the new policy depends on how the international community lives up to its commitment to catalysing adoption through green financing for such initiatives," the minister told Reuters, referring to up to US\$10 billion (RM45 billion) worth of commitments made after 2022's devastating floods that are yet to be fully realised.
The govern

The government is also planning to introduce financing schemes for e-bikes and the conversion of two- and three-

wheeled petrol vehicles, he said. The Cabinet on Wednesday approved a reduced tariff of 39.70 rupees (RM0.63) per unit, down from 71.10 rupees previously, which will be in place within a month.

The minister said the government expects an internal rate of return of more than 20% for investors in the sector. - Reuters

Meta to lay off 3,600 'low performers'

SAN FRANCISCO: Meta plans to dismiss approximately 3,600 employees identified as low performers and replace them with new hires, according to an internal memo

reported by Bloomberg. The company, which owns Facebook, Instagram and WhatsApp, confirmed to AFP that CEO Mark Zuckerberg's decision will affect 5% of its workforce.

Meta had approximately 72,400 employees as of September.
"I've decided to raise the bar on

performance management and move out low-performers faster," Zuckerberg said.

The CEO said the performance-based cuts are intended to ensure that the company has the "strongest talent" and is

able to "bring new people in".

Performance-based dismissals are a common practice among major US

corporations.

Microsoft announced similar cuts last week affecting less than 1% of its workforce, *Business Insider* reported.

The layoffs come amid broader changes at Meta, in advance of Donald Trump returning to the White House on Jan 20.

Zuckerberg has recently aligned more closely with conservative ideas and political figures, including having dinner meetings with Trump and nominating a Republican as Meta's head of public affairs.

Last week, Zuckerberg announced the end of the company's US fact-checking programme that aimed to combat misinformation on its platforms.

The programme had faced criticism from conservative voices who viewed it as censorship. – AFP

Dutch govt to expand export controls on semicon equipment

AMSTERDAM: The Dutch government on Wednesday said it would expand its export controls on advanced semiconductor equipment from April 1, which chip

equipment from April 1, which Chip equipment company ASML said it did not expect to impact its business. Dutch national export licence requirements for semiconductor equipment were first introduced in 2023 under pressure from the US to limit shipments to China, and they have since

The latest measures will require companies to seek export licences for a "very limited" number of technologies such as measuring and inspection equipment, the Dutch Trade Ministry said in a statement announcing the changes. ASML said in response it did not see

them having any additional impact on the guidance the company issued in December, when the US government announced new restrictions on semiconductor exports to China affecting chip equipment firms.

Details of the rule changes published in

the country's state legal newspaper on Wednesday showed the licensing requirements now include technologies used to find tiny defects in wafers, and systems that improve measurements after deposition and etching – steps that are repeated frequently in the chipmaking

A spokesman for the Trade Ministry said minor changes to the rules due to technical developments will happen occasionally. - Reuters

TikTok prepares for **US shutdown from Sunday**

US operations of its social media app used by 170 million Americans on Sunday, when a federal ban is set to take effect, barring a last-minute reprieve, people familiar with the matter said on Wednesday.

The Washington Post reported President-elect Donald Trump, whose term begins a day after a ban would start, is considering issuing an executive order to suspend enforcement of a shutdown for 60 to 90 days. The report did not say how

90 days. The report did not say how Trump could legally do so. The law signed in April mandates a ban on new TikTok downloads on Apple or Google app stores if Chinese parent ByteDance fails to divest the site. Users who have downloaded

Users who have downloaded TikTok would theoretically still be able to use the app, except that the law also bars US companies starting Sunday from providing services to enable the distribution, maintenance, or updating of it.

Users in many other countries may find app unavailable, court filing states

Trump has said he should have time after taking office to pursue a "political resolution" of the issue. "TikTok itself is a fantastic platform," Trump's incoming national security adviser Mike Woltz tale Jeen New 2019 of 1889. Waltz told Fox News on Wednesday. "We're going to find a way to

see TikTok suddenly banned on Sunday," an administration official told the broadcast network.

If it is banned, TikTok plans that users attempting to open the app will see a pop-up message directing them to a website with information about the ban, the people said.

The company also plans to give users an option to download all their data so that they can take a

The US Supreme Court is currently deciding whether to uphold the law and allow TikTok to be banned on Sunday, overturn the law, or pause the law to give the court more time to make a decision.

Shutting down TikTok in the US could make it unavailable for users in many other countries, the company said in a court filing last month, because hundreds of service providers in the US help make the platform available to TikTok users around the world - and could no longer do so starting Sunday. TikTok said in the court filing an

order was needed to "avoid interruption of services for tens of millions of users outside the US."
TikTok had said the prohibitions

would eventually make the app unusable, noting in the filing that "data centres would almost certainly conclude that they can no longer store" TikTok code, content or data. - Reuters



CBH Engineering fetches 17.9% premium in ACE Market debut

KUALA LUMPUR: Mechanical and electrical engineering service provider, CBH Engineering Holding Bhd, debuted on the ACE Market of Bursa Malaysia Securities Bhd.

At the opening bell, the CBH's share price opened at 33 sen, with a premium of 17.9% over the issue price of 28 sen, with an opening volume of 48.2 million shares. This debut followed an initial public offering (IPO) oversubscription of 34.2 times, reflecting strong investor confidence in CBH's business operations and potential for growth

Managing director Cheah Boon Hwa said that their modest beginnings three decades ago have evolved into a leading name in mechanical and electrical engineering, driving progress and

innovation across Malaysia's key industries.
"With RM83.4 million raised from the IPO, alongside an unbilled order book of RM203.7 million and a tender book of RM559.7 million, we have a solid foundation. Combined with our proven track record, this gives us the confidence to secure even more high-value projects in the future, especially from global clients," he added.

On the financial front, CBH's revenue grew from RM67.6 million in the financial year ended Dec 31 (FY) 2021 to RM208 million in FY 2023, representing a 2-year compound annual growth rate (CAGR) of 75.4% Meanwhile, net profit grew from RM3.6 million to RM33 million from FY 2021 to FY 2023, reflecting a 2-year CAGR of 203.8%.

CBH recently announced its unaudited third quarter (Q3'24) and nine months financial performance for the financial year ended Dec

In Q3'24, CBH registered a revenue of RM42.2 million and net profit of RM8.7 million. For 9MFY 2024, revenue stood at RM187.8 million, with net profit at RM31.1 million, reflecting a net profit margin of

Ringgit weakens against dollar on lack of buying momentum

THE ringgit eased against the US dollar at the close yesterday on lack of buying momentum.

At 6pm, the ringgit depreciated to 4.5005/5050 against the greenback from Wednesday's close of 4.4970/5010.

SPI Asset Management managing partner Stephen Innes said after opening stronger due to the milder US' Consumer Price Index print, the 3% headline inflation has forex traders debating whether the US Federal Reserve (Fed) could even consider rate cuts this year

"Although bond and stock markets have recovered, the spillover to the forex market has been relatively weak.
"This muted response is likely tied directly to the ongoing

Donald Trump tariffs threat on China, keeping forex traders in a state of flux," he told Bernama.

Innes said the overarching question casting a shadow over the markets is whether Trump would embody the "Deal Maker in Chief"

or revert to his "Tariff Man" persona.
"This uncertainty keeps traders vigilant, constantly assessing

shifts in the policy landscape," he added.

At the close, the ringgit was mostly higher against other major currencies.

It advanced vis-a-vis the euro to 4.6283/6329 from Wednesday's close of 4.6364/6405, appreciated against the British pound to 5.4888/4943 against 5.4949/4998 on Wednesday, but fell versus the Japanese yen to 2.8914/8945 from 2.8656/8685.

SECURITIES average daily value (SADV) traded fell to RM2.9 billion (-24% QoQ, +6% YoY) in Q4'24. We think the weakness stemmed from uncertainties surrounding the US economy and profit-taking, particularly from foreign investors. We also observed some diversion in trade flows towards China, following the country's announcement of expansionary policies to stimulate the economy. On the other hand, the derivatives market enjoyed elevated trades of CPO futures, thanks to the strong rally in the underlying commodity's prices.

Derivatives average daily contracts (DADC) traded stood at 107k for the quarter – the highest quarterly level ever achieved for BURSA.

For the year, SADV amounted to RM3.44 billion, up 50% YoY on

strong investor confidence and a resilient local economy. Save the exceptionally strong Covid-19 years of 2020 and 2021, the 2024 SADV was the highest on record. Elsewhere, DADC surged 26% YoY to 92k, another record high for BURSA. The exchange also saw 55 new listings in 2024, surpassing the previous high of 40 IPOs in 2006. The new listings accounted for over RM30 billion in total market capitalisation, beating the bourse's target of RM13 billion for the

Given the above items, we think BURSA could post total income of RM200-210 million in Q4'24. Assuming opex for the quarter amounts to RM100 million (48-50% CIR) and a 26% effective tax rate (as at 9M'24), this translates to a quarterly PAT of RM75-85 million, or up 26-43% YoY (QoQ: -4 – +9%).

We believe Bursa Malaysia could post a Q4'24 net profit of RM75-85 million when it announces results on Jan 27 – which would place the exchange comfortably ahead of its FY24 targets. However, we expect the recent market weakness to persist in 2025, leading to negative earnings growth for the year.

WE came away from Cloudpoint Technology meeting last week with management guiding an exciting outlook as it aims to maintain the strong growth momentum this year, driven by i) a strong orderbook (RM133.6 million), ii) diversification of customer base through ServiceNow software, and iii) the availability of more data centre jobs.

Riding on the Johor's data centre boom, the group has

managed to bag contracts ranging from RM4-10 million from hyperscalers for various job scopes such as power installation, liquid cooling, cabling and containers. We understand that the group is currently in talks with 2 new data centre operators on the uninterrupted power supply and Generative Al Assist platform solutions. It has also received an invitation from an automotive player to participate in a data centre project. Meanwhile, the results of the first Elmina data centre cabling tender will be known by the end of 10 2025 as it is required to be completed by Sept 2026. We believe the group stands a good chance as it has received positive feedback with regards to its technical submission, and there are only 3 shortlisted participants in this cabling project. Based on our estimates, this RM100 million contract could potentially contribute additional 20-25% to our FY25-26 earnings forecasts.

Following a contract win from a local bank last month, the

group has now become the largest System Integrator in Malaysia for ServiceNow software, which is a specialist in internal workload automation. Currently, there are three banks adopting the ServiceNow software, and it plans to promote the Al agent ServiceNow platform to other industries, namely, oil and gas, telco and utilities sectors.

CONCERNS on the environment over plastics are shifting the focus towards managing plastic waste rather than eliminating plastics altogether, given their essential role during the Covid-19 pandemic which had reinforced the usefulness of plastic in personal which had reinforced the usefulness of plastic in personal protective equipment (e.g. safety overalls, face covers or syringes), packaging/storing essentials such as medicine or food economically yet safe from contamination and facilitating deliveries of online shopping. This has led to increased circular economy initiatives and sustainable packaging solutions. Investments in innovative packaging are crucial for reduced waste collection sorting and recepting.



Companies like BPPLAS and TGUAN have been gaining traction with their nano stretch films, while SLP is seeing increased customer interest in its machine direction-oriented PE mono films. SLP is also actively promoting its sustainable packaging solutions in Asean countries, capitalising on the demand for recyclable materials by SE Asian manufacturers from customers in Europe or the US. In aggregate, these firms are growing at a pace of 7% CAGR profit growth over the next two years, outstripping the industry growth outlook. The global packaging market is also set to grow at around 4% CAGR to reach US\$1.4 trillion by 2028 with flexible plastics likely to grow faster at 5% CAGR, outpacing metal, glass and even slightly ahead of paper-based packaging. The demand for flexible packaging is driven mainly by its durability, flexibility, and cost-effectiveness. The OECD Environmental Directorate projects that plastic packaging usage will triple by 2060 from current levels.

Our sector top pick is TGUAN, whose share price, we believe, has been adversely affected by the knee-jerk reaction to forex. Under our coverage, we have two more stretch film players, namely BPPLAS and SCIENTX (MP; TP: RM4.15), which are also developing innovative packaging solutions. - Kenanga Research, Jan 16

From waste to wonderful taste

> French chef shows every part of plant ingredient can be utilised

NE of the ways to reduce food waste is to creatively use every part of an ingredient.

As we all know, fruits, vegetables and nuts are packed with nutrients. They are often used in cooking, but their unwanted bits – skin, shell, stem, leaves, seeds and roots – end up in the rubbish bin.

However, with a bit of clever thinking, these underappreciated parts can be used to make sauces, broth or even chips.

Te Cordon Bleu

Sunway Le Cordon Bleu executive chef and cuisine chef instructor Stephane Frelon, who has 35 years of culinary experience and worked in restaurants in France and Canada, uses every part of an ingredient, ensuring it does not go to waste

waste.
"I use everything from A to Z from a vegetable. For example, from soybeans, we extract soy milk, tofu, and tempeh, while the dry leftover parts, we can cook or transform into meat substitutes," said Frelon.

From hazelnut, oil is extracted, whereas skin and crumble can be

turned into something edible.

The chef, who hails from Tours,
France, held a cooking
demonstration during a plant-based
culinary workshop at Sunway's Le
Cordon Bleu last Saturday to
showcase and share creative ideas.
He cooked a vegan version of the

French dish beef bourguignon, made instead with lion's mane mushroom.

The result was an exquisite dish with wonderfully curated textures.

The lion's mane mushroom, a substitute for beef, was complemented with smoky beetroot, soft potato and a rich red sauce.

soft potato and a rich red sauce.

"As a chef, we need to educate the students. We can create seven items on a plate from one ingredient, such as beets or pumpkins," he said.

as beets or pumpkins," he said.
But these items – whether broth,
sauce, or crispy crackers – need not
be "super fancy".

be "super fancy".

According to Frelon, by educating culinary students about the need to

reduce wastage, he hopes to spread the message to the public.

Beyond cooking, the chef is an advocate of reducing food wastage. He openly pondered about how grocery stores handled leftover fruits and vegetables.

"What do they do with their waste? We don't know," he said.

Frelon suggested that unwanted or unsold produce be sent back to farmers as food for pets or farm animals, thus reducing food wastage.

Malaysia does not lack in options when it comes to vegan and vegetarian ingredients. Frelon said Malaysians as well as other Southeast Asians have access to a huge variety of plant-based food.

The chef, who has lived in Malaysia for some time, loves *laksa*, *rendang* and, surprisingly, durian.



Streaming success

After raking it in theatres, Wicked triumphs on VOD

INCE its theatrical release. Wicked has captured the hearts of audiences worldwide. But the movie has also gone down a storm on video-on-demand (VOD) platforms, raking in an impressive sum in its first week of availability

According to figures revealed by Universal, Wicked earned US\$26 million (RM117 million) on its first day of VOD availability in the US and Canada. In one week, this figure climbed to US\$70 million. This is a new record for a Universal film, even surpassing the US\$44 million earned by *The Super* Mario Bros Movie in its first week on VOD in 2023.

The success of Wicked on VOD is due in part to

the movie's distribution model. Available for purchase (US\$30) and rental (US\$20), the film attracted a large audience on Dec 31 last year while it was still playing in theatres. Universal has succeeded in maximising its revenues thanks to this hybrid strategy.

Studios reportedly retain around 80% of revenues generated by digital platforms, compared with 50% of box-office returns. According to *Variety*, Universal retained around 65% of ticket sales for Wicked in theatres.

New strategy involving theatres and streaming

Universal has been a pioneer in experimenting with streaming releases of its movies. In March 2020, the studio broke convention by releasing Trolls World Tour simultaneously in theatres and on VOD, raking in around US\$100 million in just a few weeks

Since then, Universal has adopted a strategy of 17 days of theatrical exclusivity for smaller films and five weekends for blockbusters, before making them available on VOD. To date, this approach has generated more than US\$1.5 billion in VOD sales, Variety revealed.

Wicked has already grossed more than US\$680 million at the global box office since its theatrical release in November. The film, directed by Jon M. Chu and starring Ariana Grande, Cynthia Erivo, Jeff Goldblum, Michelle Yeoh and Jonathan Bailey, recounts the origins of the characters from *The* Wizard of Oz. It became the sixth-biggest hit of 2024 worldwide and achieved the best launch for a Broadway adaptation in box office history.

With two more months of exclusivity on VOD platforms before its arrival on NBCUniversal's streaming service Peacock, Wicked promises to

continue enchanting audiences.

And there is more to come, since the movie's sequel Wicked: For Good, which continues the story recounted in the musical, is slated for release in theatres on Nov 21. – ETX Studio

Movies becoming more violent: Study

ACCORDING to a US study, violence is increasingly present in movies, even in films where crime is not

the main theme.
A study entitled *Trends of Violence in Movies During* the Past Half Century, published in the scientific journal Jama Paediatrics, investigated the presence of violence in movie productions over the past 50 years by analysing movie subtitles.

The researchers examined dialogue from over 160,000 English-language films produced between 1970 and 2020, focusing on the use of verbs such as "kill" or "murder" in screenplays.

"Our findings suggest references to killing and murder in movie dialogue not only occur far more frequently than in real life but are also increasing over time. This is more evidence that violence is a bigger part of the movies we watch than ever before," explained the study's lead author Babak Fotouhi.

Far from being confined to action films and thrillers, "murderous verbs" are also present in all film genres, the study pointed out.

"Characters in non-crime movies are also talking more about killing and murdering today than they did 50 years ago. Not as much as characters in crime movies and the increase has not been as steep. But it is still happening. We found increases in violence (across) all genres," said study co-author Brad Bushman.

While these "murderous" terms are mostly used by male characters, female characters are increasingly

beginning to adopt this language.
On social networks, "female rage" content is captivating internet users for its representation of female anger in movies and TV shows. On TikTok, #femalerage has accumulated more than 100,000 posts and there are also thousands on Instagram. These messages are often praised for their authenticity. – ĔTX Studio

HEN thinking of an angle for this review, there was one song that kept coming to mind, the classic Anything you can do (I can do better), that was composed by Irving Berlin for the 1946 Broadway Musical *Annie Get Your Gun*.

If you have never heard of it, try searching for it

on YouTube and that should set the tone for the rest of this article.

Over the years, there have been many iterations of the song, and it was popularised in car culture nearly two decades ago in a Mercedes-Benz video advertisement.

The video featuring Lewis Hamilton, Fernando Alonso and Mika Hakkinen showcased the three Fernando Popularient each other.

Formula One legends duelling against each other in a series of challenges.

Fast forward to today and the song once again

comes to mind to describe the current automotive scenario, particularly the electric vehicle (EV)

US president-elect Donald Trump himself would not deny that the segment is dominated by Chinese marques.

And while the world argues over how the Americans, Japanese and Europeans are going to keep up, the South Koreans have been silently churning out cars that not only impress with their

technology but also offer stunning designs.

The KIA EV9 you see sprawled on these pages is one such stunner from South Korea. It may not look like it when seen in photos, but it is a massive car, about the size of the latest generation Range

And it is quite imposing as well, with a neck cramming presence everywhere it goes since not many have seen one on our roads.

We love It, sort of

In terms of design, it will not look out of place in a *Star Wars* movie. In fact, while Chinese cars and Tesla have started to look the same with their front and rear lightbars and gigantic infotainment

systems inside, there is nothing else quite like the KIA EV9.

But you have to wonder why it has not become an instant sensation among the wealthy.

Yes, the wealthy. Because the EV9 is priced at RM370,000 for the seven-seater variant and RM375,000 for the six-seater. So, you can't expect the following to it.

regular folks to be flocking to it.

The price is one of the few thorns on its side because when it comes to spending that amount of money, most Malaysians would still pick a of money, most Malaysians would still pick a statement at the next family gathering that you have "arrived in life". Nothing makes a statement better than a European marque.

So, this means then that the EV9 sits in a very peculiar spot. It is way too expensive for the regular loe, and for those who can afford it well.

regular loe, and for those who can afford it, well

they either do not want to spend that much on a KIA or would rather spend it on a luxury marque.

Except for a few oddballs to whom I am grateful to because if it wasn't for them we

wouldn't have such cars in Malaysia.

So, what is it about the EV9 that we love?

Apologies for getting distracted, but the EV9 is a stylish machine and that's the first thing we like



he EV9 manages 11kW of AC and 350kW of DC charging.



21-inch wheels look really good.



Digital side view monitors take some getting used to

about it. It makes you go wow the first time you see it. It makes the cooks in a Chinese restaurant come out just to look at it. I can personally testify to that.

There's a saying that goes, "if you don't look back at your car after you have parked it, you bought the wrong car," and I just could not stop staring at it though I am far from buying one.

How KIA has made seemingly straight lines and vast empty spaces look this good may be beyond most of us non-designers, but we can collectively breathe a sigh of relief that the automotive world can still churn out such good-

Then there is the interior, KIA has again shown that they are not followers of the herd. There are no gargantuan infotainment screens inside, just one that measures in at a regular 12.3-inch and another of equal proportions for the instrument

And thankfully there are still physical controls for everything from the air-conditioning to the radio. You can even adjust the air-conditioner blowers manually, just as you always could before some brands started over engineering them. The rear passengers get a set of air-conditioning controls and their own sunroof as well.

The interior space and seats deserve their own special mention
Considering the size of the car, it should come

as no surprise that interior living space is vast.

It is also comfortable for the kids and shorter

adults in the third row, which positions the EV9 as a capable option for large families.

The seats themselves could put more expensive cars to shame in terms of comfort. They are so good that there's an entire section dedicated to the seats in the EV9's specification sheet.

The driver's side seat gets a massage function which turns on after an hour of driving while the

Both driver and passenger seats also have a feature called Premium Relaxation, this is where the seat can recline in such a way that it almost feels like you're in a hammock.

So, what are the other thorns you may ask?

After raving about the seats, I must say that the mesh headrests for the front two seats are unbecoming for a car of this price range, like they were taken from the office chairs of KIA's design centre.

The other thing that I am particularly concerned about are the digital side view monitors. Instead of using regular mirrors, KIA has chosen to use cameras instead. They protrude out awkwardly and look weird

On top of that, monitoring the sides of the car can take some getting used to as well because you can never gauge the distance. It is already difficult to tell the distance with a mirror, what more a

And what more, we have thousands of motorcyclists to share the road with daily and the occasional swipe with a handlebar does happen. One must wonder how much it would cost to replace the camera.

But what about the powertrain?

That responsibility falls on dual motors, one for each axle, which effectively makes the EV9 an allwheel-drive SUV.

Providing juice to the motors is a 99.8kWh battery pack that gives the car 380hp, 700Nm of









torque as well as a WLTP range of 505km.

But after spending a couple of days with the EV9, we returned the car with an average energy usage of 21.4kWh, that gave the car a real-world

range of 466km.

Energy usage gets higher on the highway and that drops the range like an anchor, which is typical of EV's. So, to sustain a decent range, driving between 90-100kph was the only way, which is a shame.

As for charging, the EV9 supports an 800V electrical architecture which allows for ultra-fast

charging. To recharge, the car can take 350kW of DC charging which lets the car hit 80% state of charge from 10% in just 24 minutes.

While that may be impressive, the EV9 is only capable of 11kW of AC charging, and that is the real stick in an otherwise great show because it will need 10 hours and 30 minutes to hit 100%

So why do we like it so much?

While the car may not be able to go very far and

in all honesty would have greatly benefited from 22kW AC charging, it is still a great car to drive. Refinement levels are arguably at near Rolls-

Royce levels at regular speeds. The car does not come with adaptive suspension which is available in some other markets, but the MacPherson struts and Multi-Links do a fantastic job nonetheless.

The fact that it does not come with the more expensive adaptive suspensions means that long term ownership may be easier on the pocket, so

that may just be a good thing.

We also like its versatility as a family car,

offering space and comfort for all three rows.

And ensuring the car remains safe in all situations are multiple levels of technologies ranging from Forward Collision-Avoidance Assist systems to Smart Cruise Control.

But the real star is of course the one thing that we have been harping about all along, its design, which particularly stands out in the colour you see here, Ocean Blue.

is it worth it?

Well, that would depend on which side of the divide you stand on. If you like nice cars and don't mind the badge they come with then for sure the EV9 is worth it.

But if you are the type that is concerned about making a statement, just keep in mind that the KIA badge has come a long way from its Spectra days


